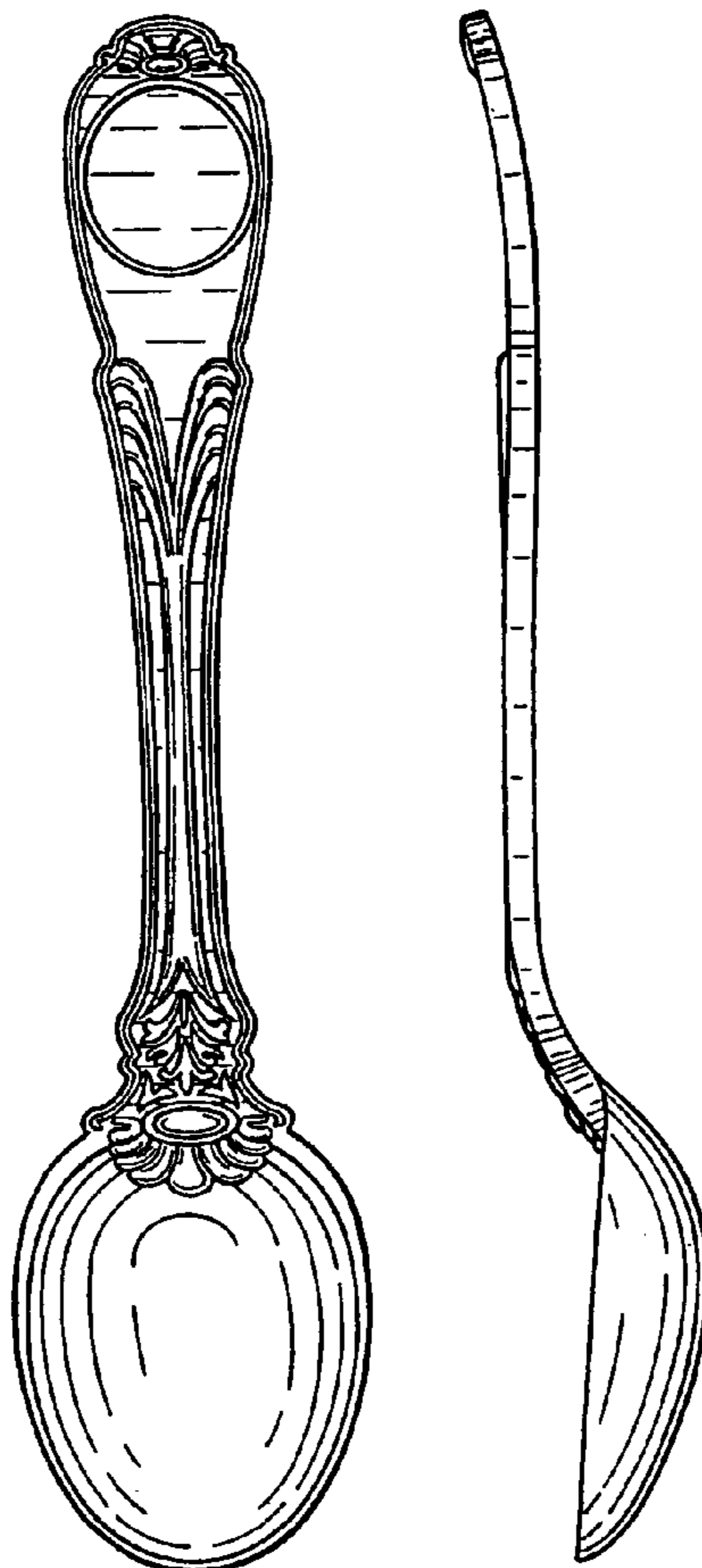

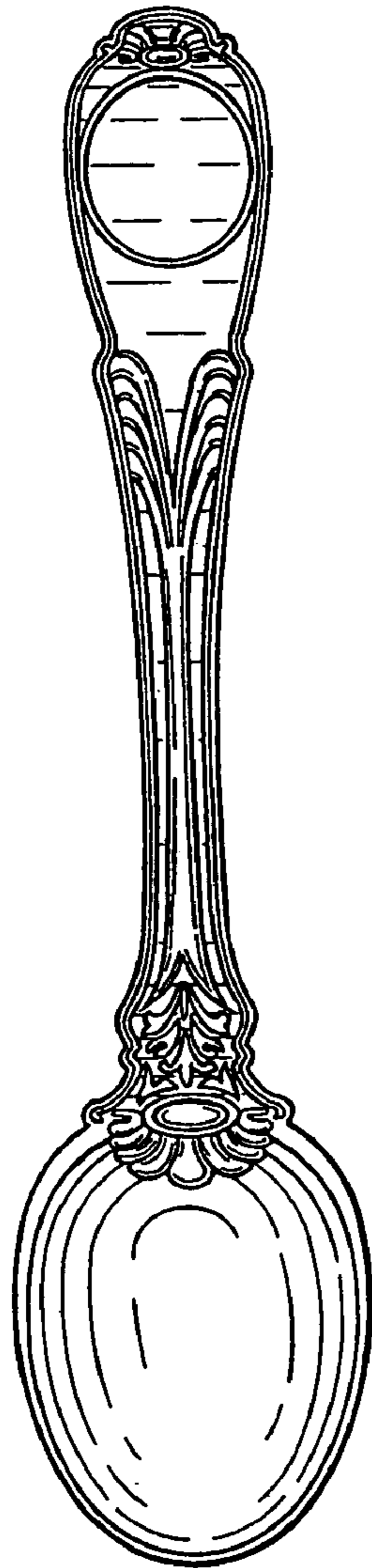
The ornamental design for a spoon, as shown and described.

**DESCRIPTION**

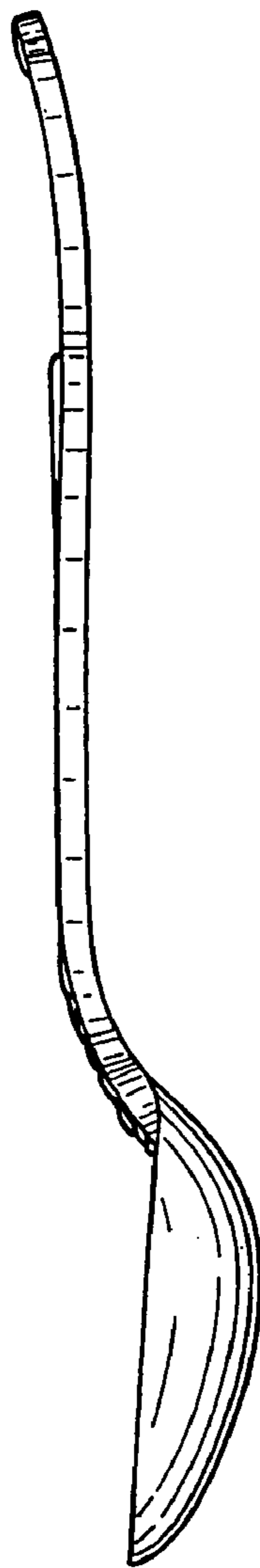

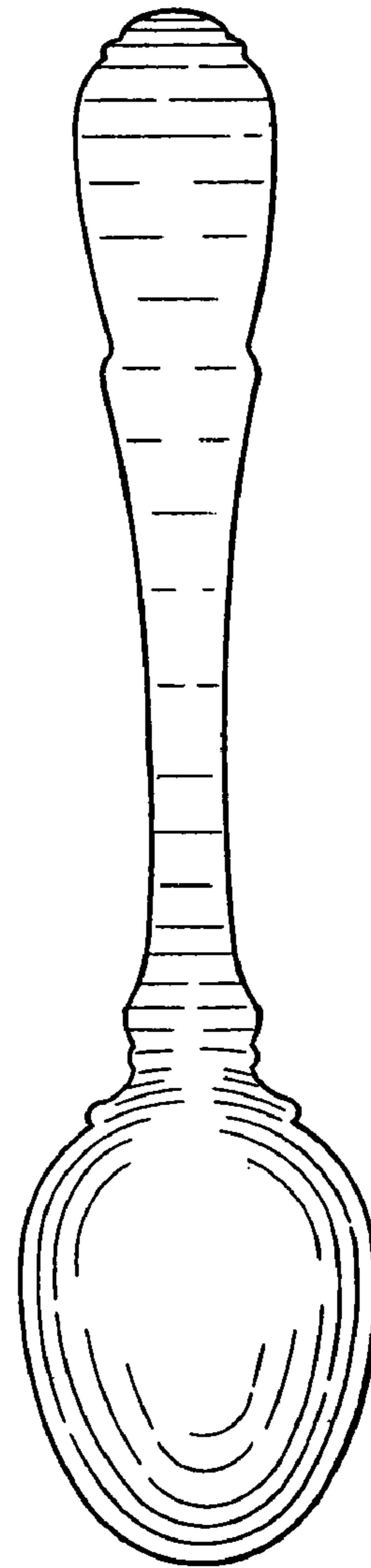
