(57) **CLAIM**

The ornamental design for a product dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the present product dispenser.

FIG. 2 is a top view of FIG. 1.

FIG. 3 is a front view of FIG. 1.

FIG. 4 is a right side view of FIG. 1, wherein the left side view is an identical image of this view.

FIG. 5 is a bottom view of FIG. 1.

FIG. 6 is rear view of FIG. 1.

FIG. 7 is a perspective view of FIG. 1, wherein a portion of the cover is in an open position.

FIG. 8 is a perspective view of FIG. 1, wherein the cover is in an open position.

FIG. 9 is a perspective view of a second embodiment of the present product dispenser, as shown in FIGS. 2 through 6, wherein the portions of the product dispenser shown in broken lines are not part of the claimed design and are provided for illustrative purposes only; and,

FIG. 10 is a perspective view of a third embodiment of the present product dispenser, as shown in FIGS. 2 through 6, wherein the portions of the product dispenser shown in broken lines are not part of the claimed design and are provided for illustrative purposes only.

The broken line showing of the product dispenser is included for the purpose of illustrating environment only and forms no part of the claimed design.

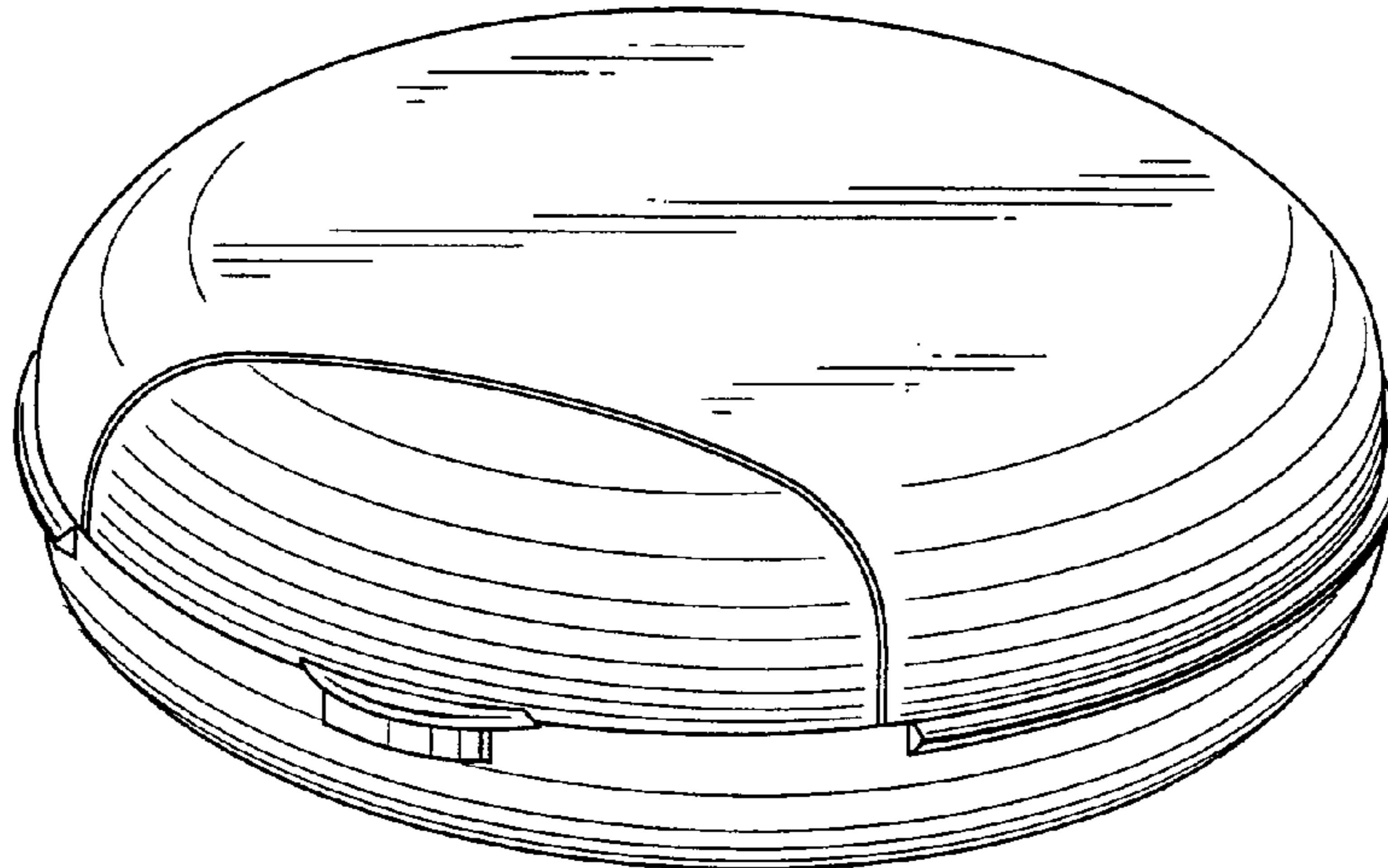

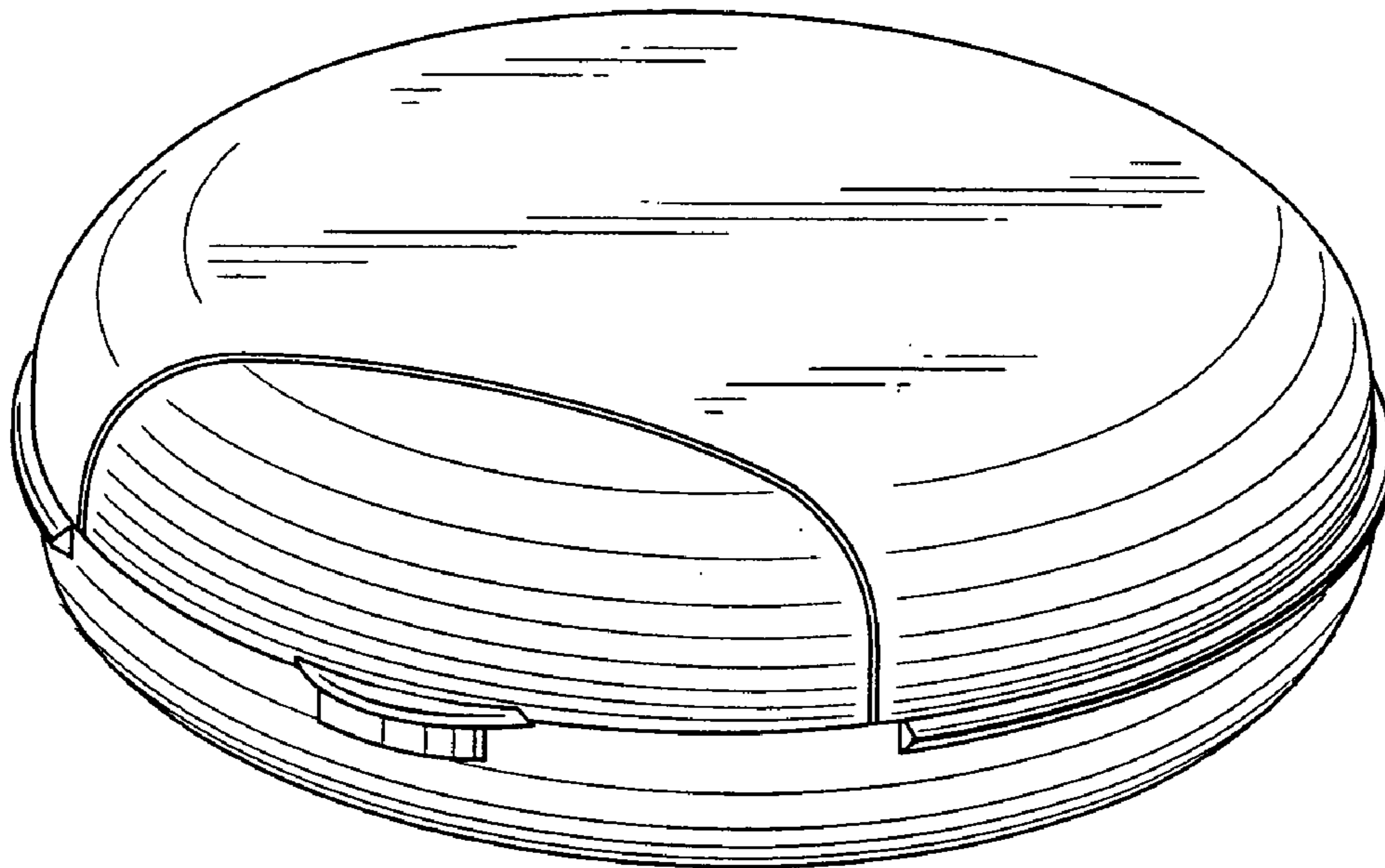

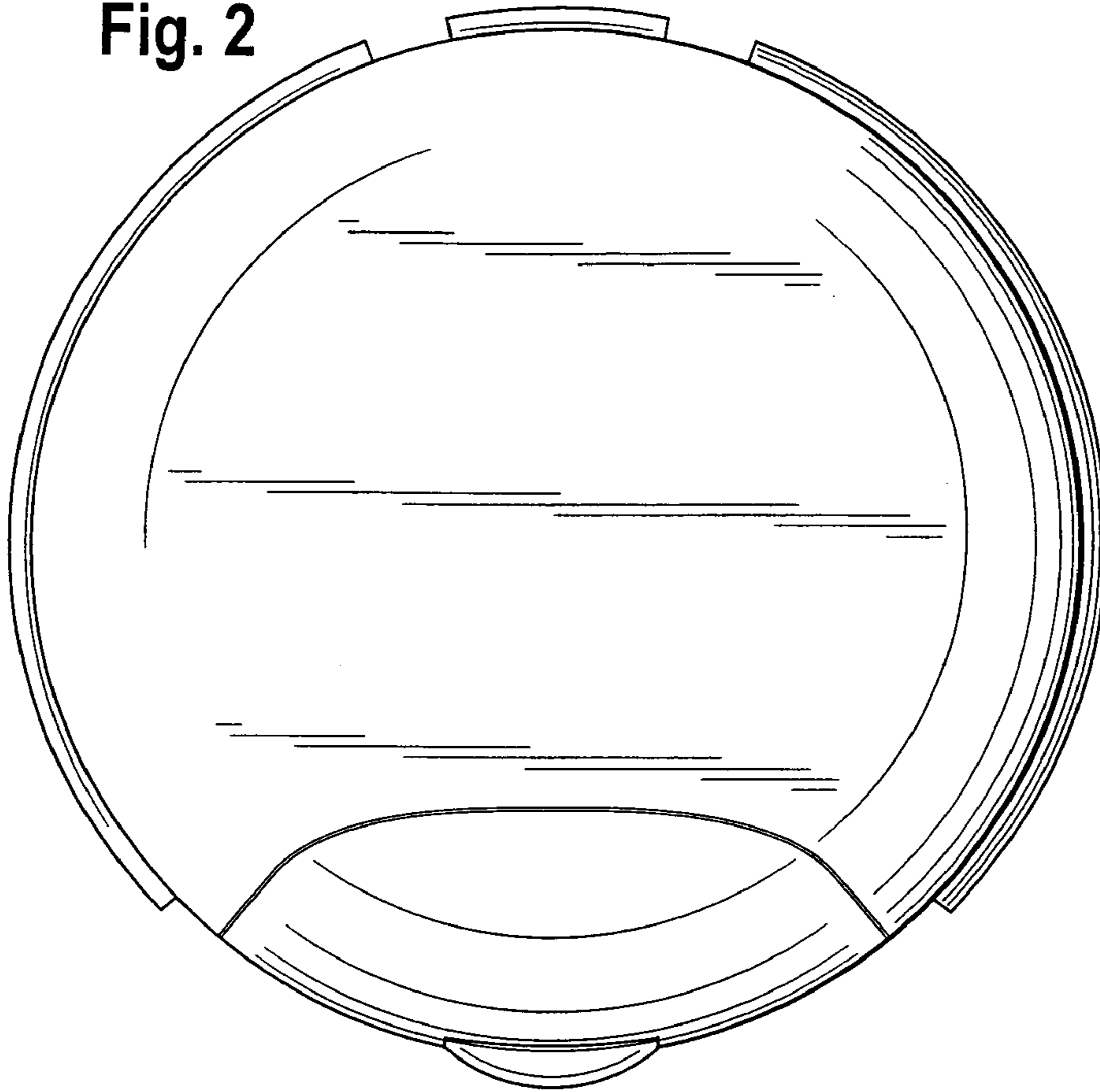

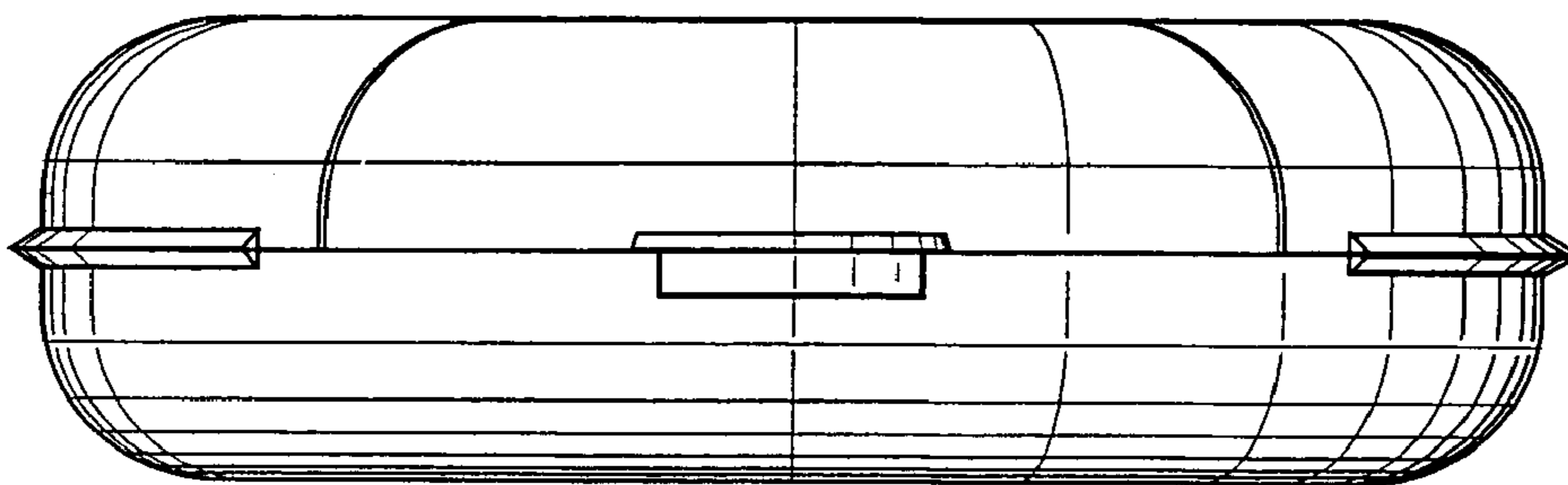

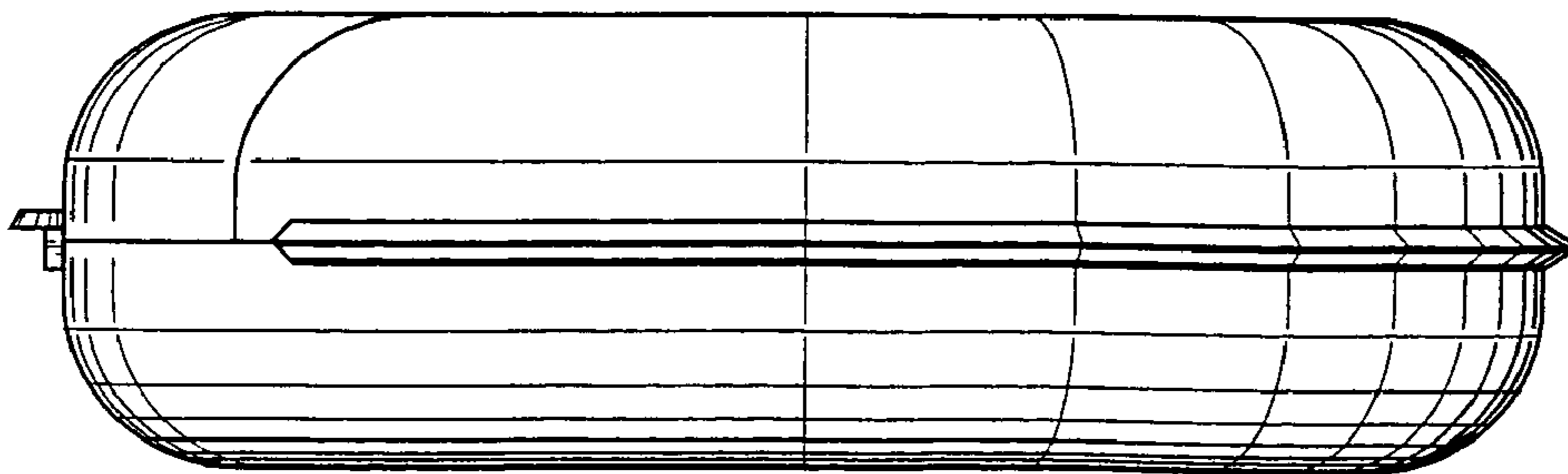

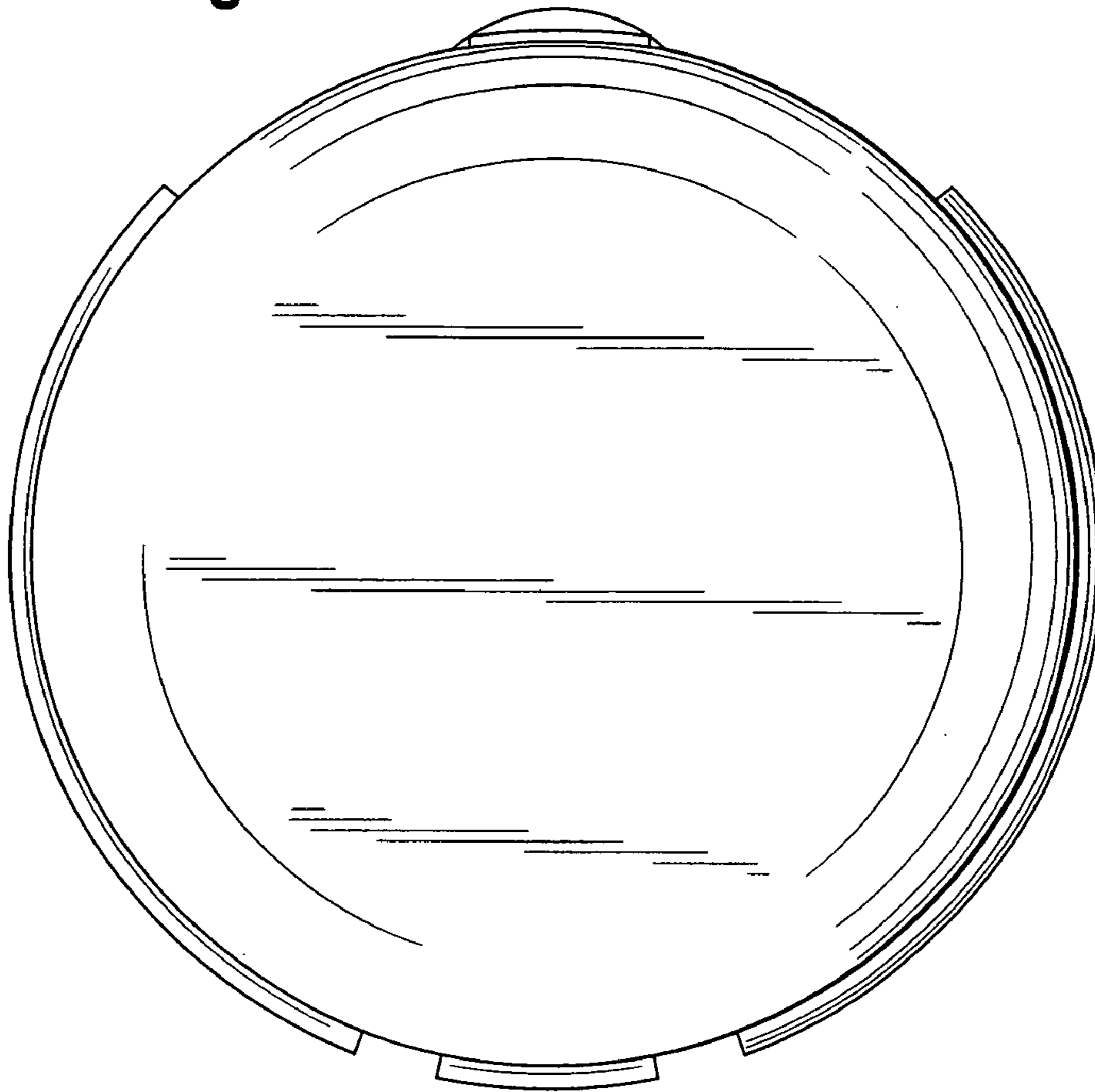

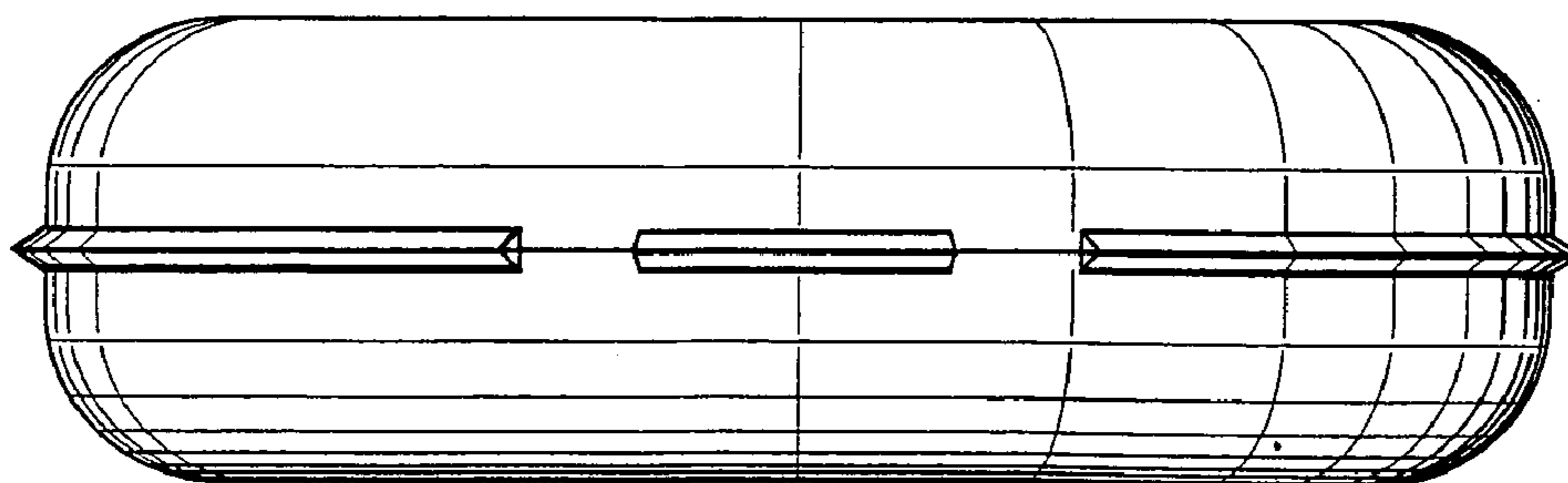

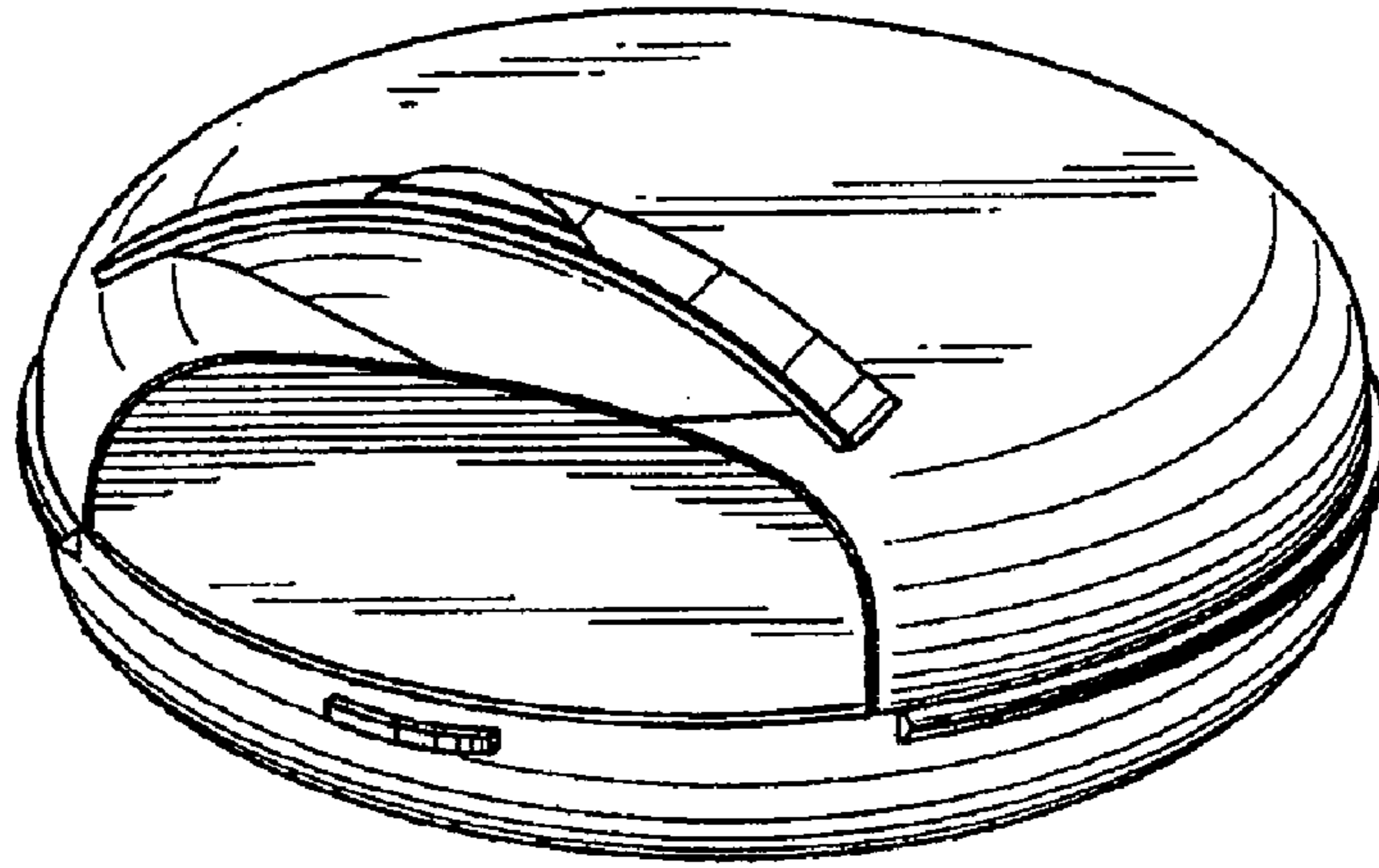

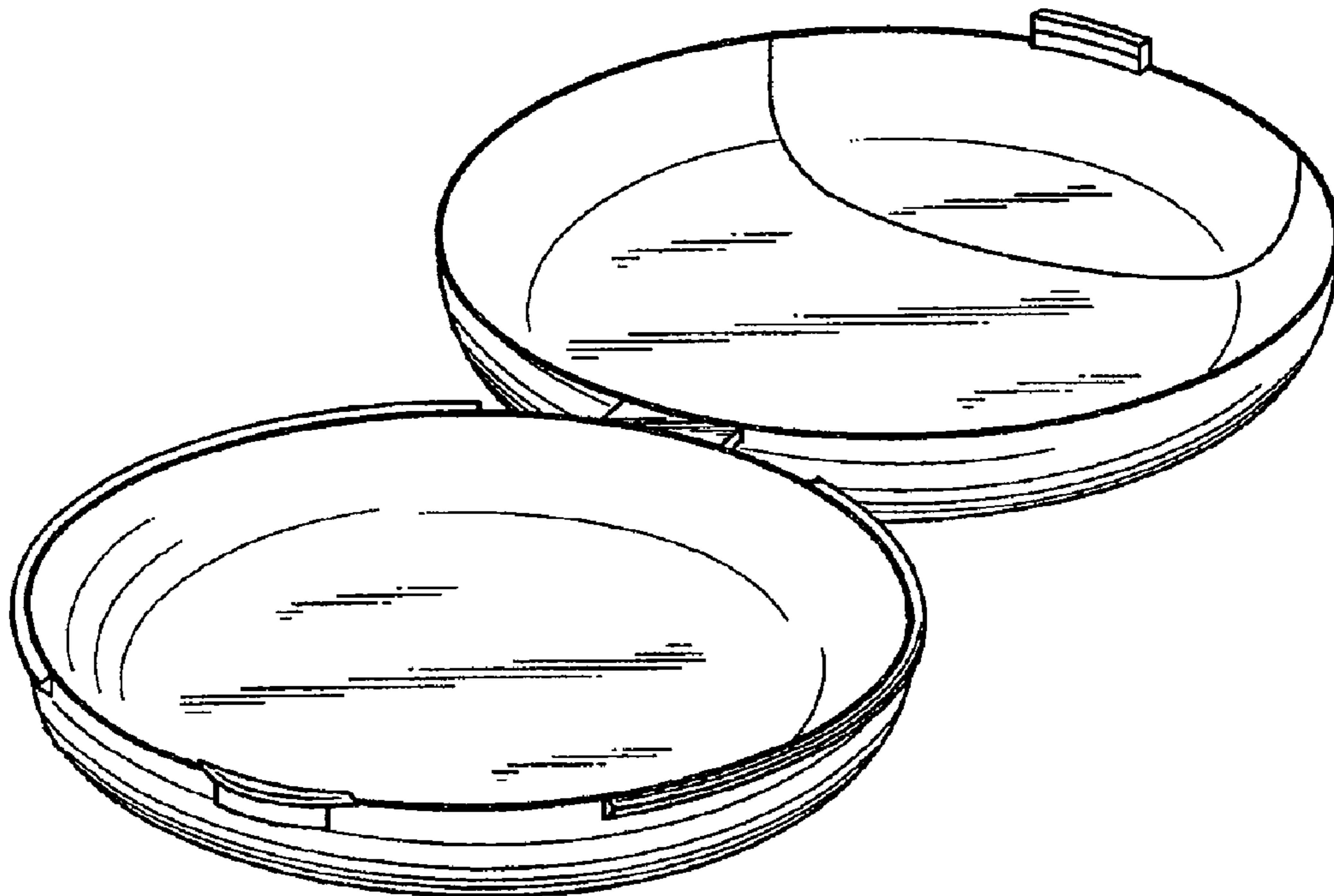

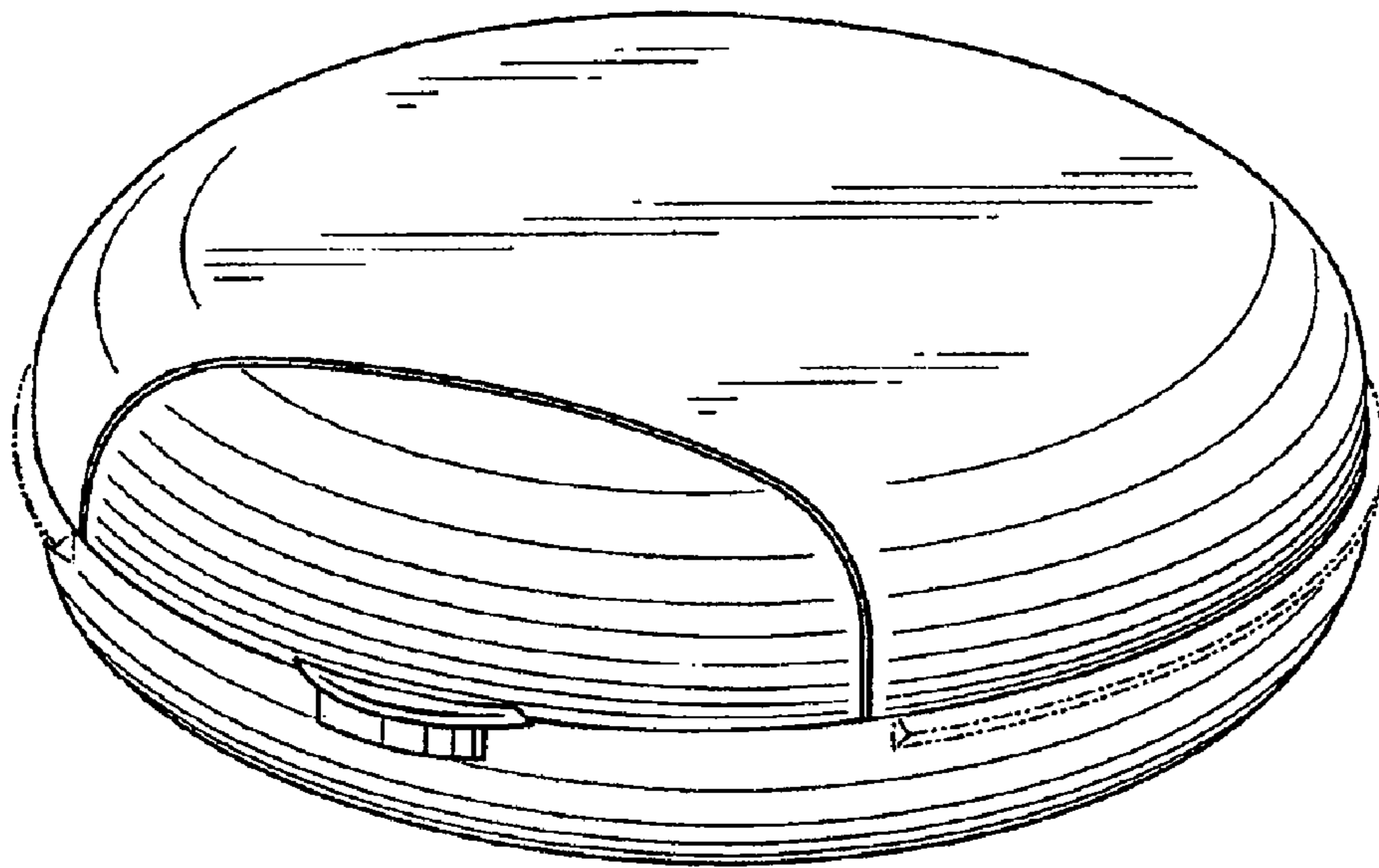
