FIG. 2 is a front view of a cup sleeve in accordance with our new design,

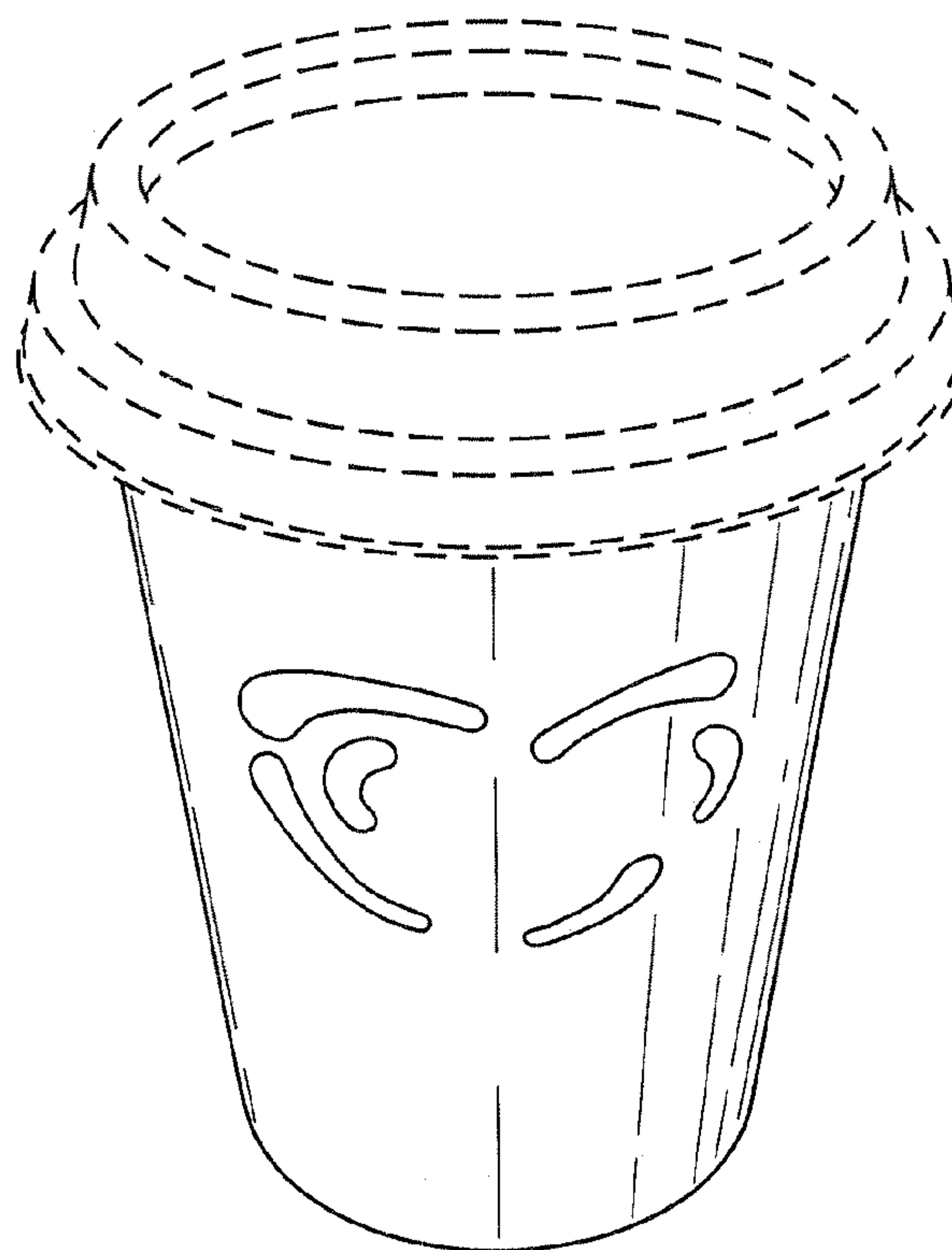
FIG. 3 is a rear view of a cup sleeve in accordance with our new design,

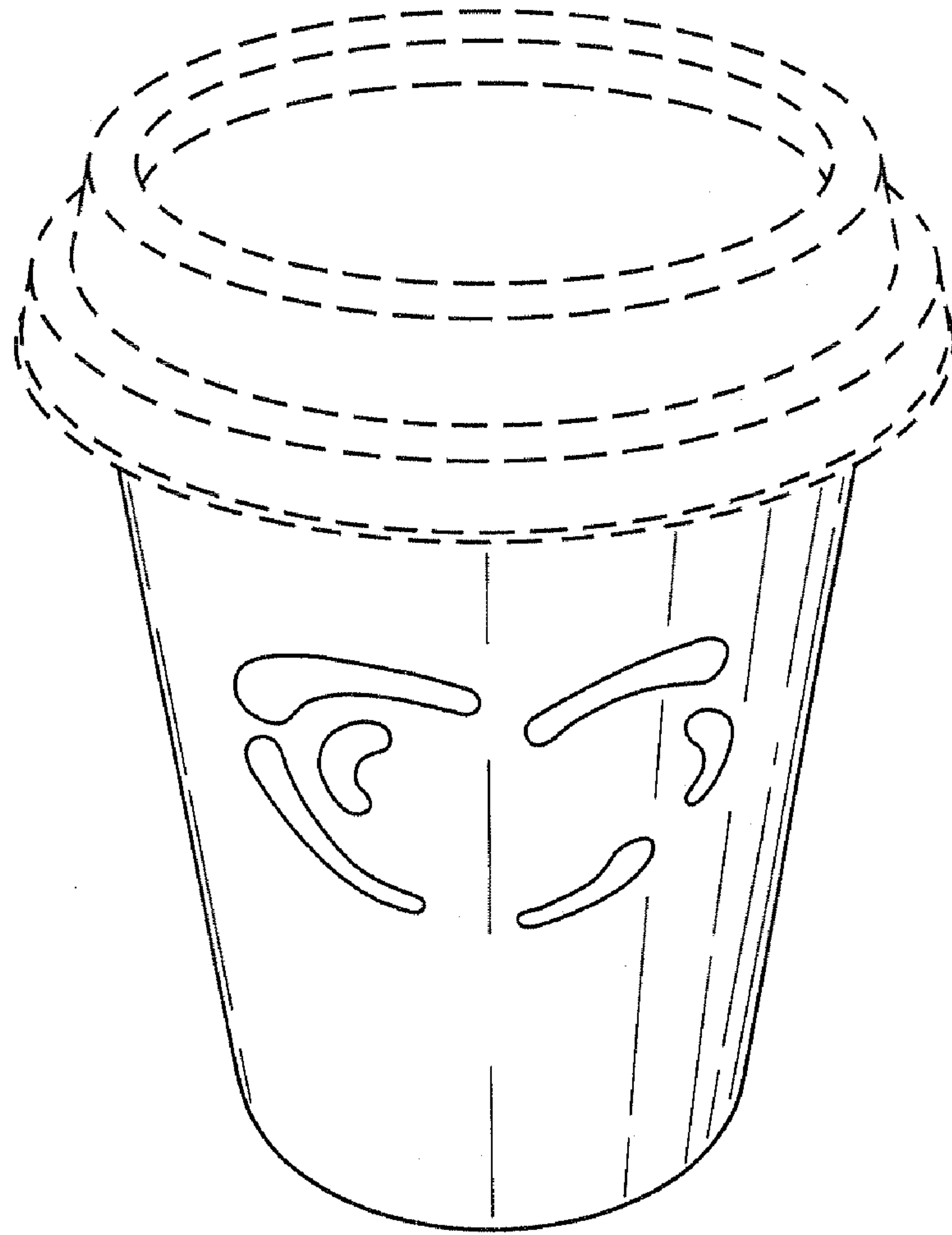

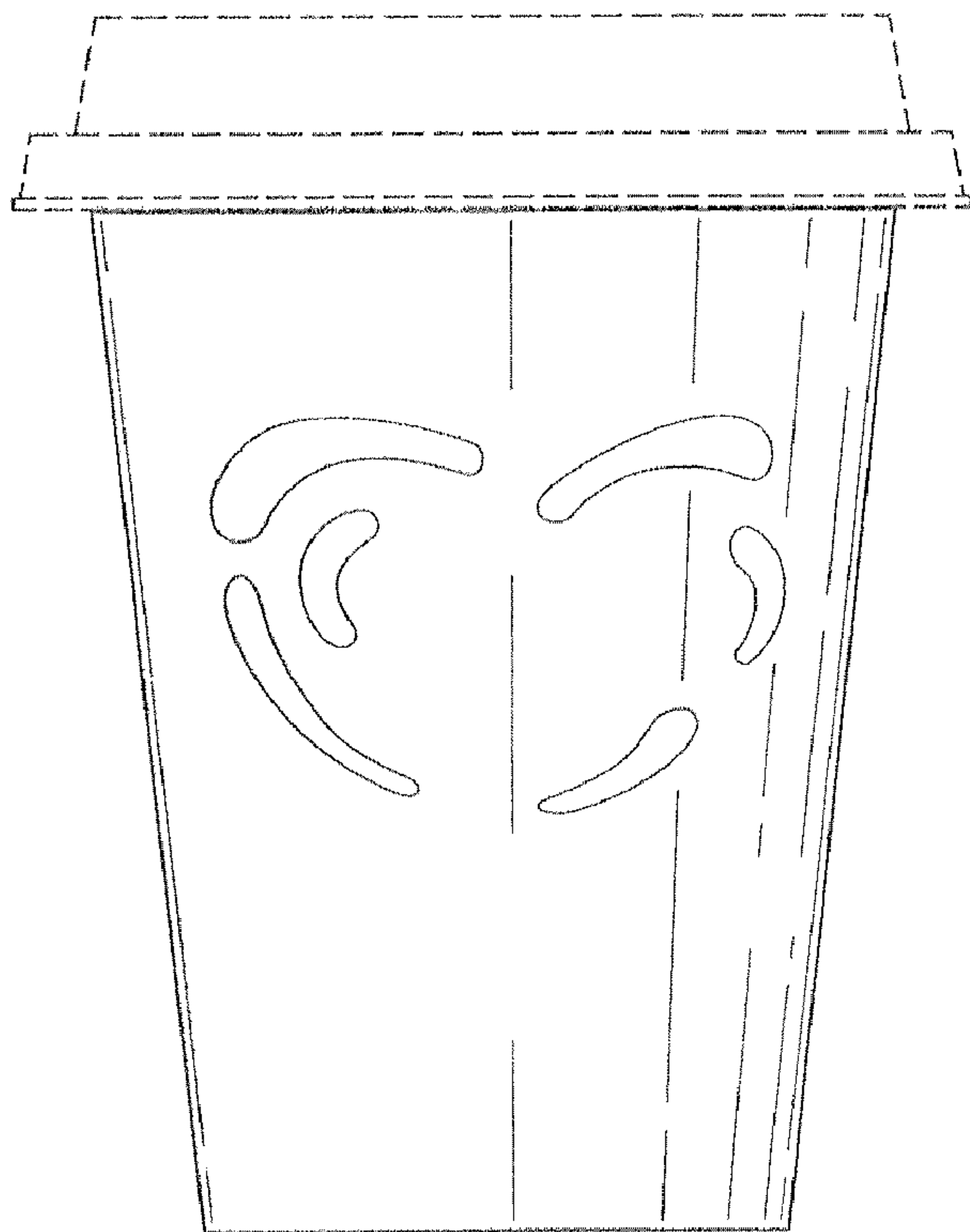

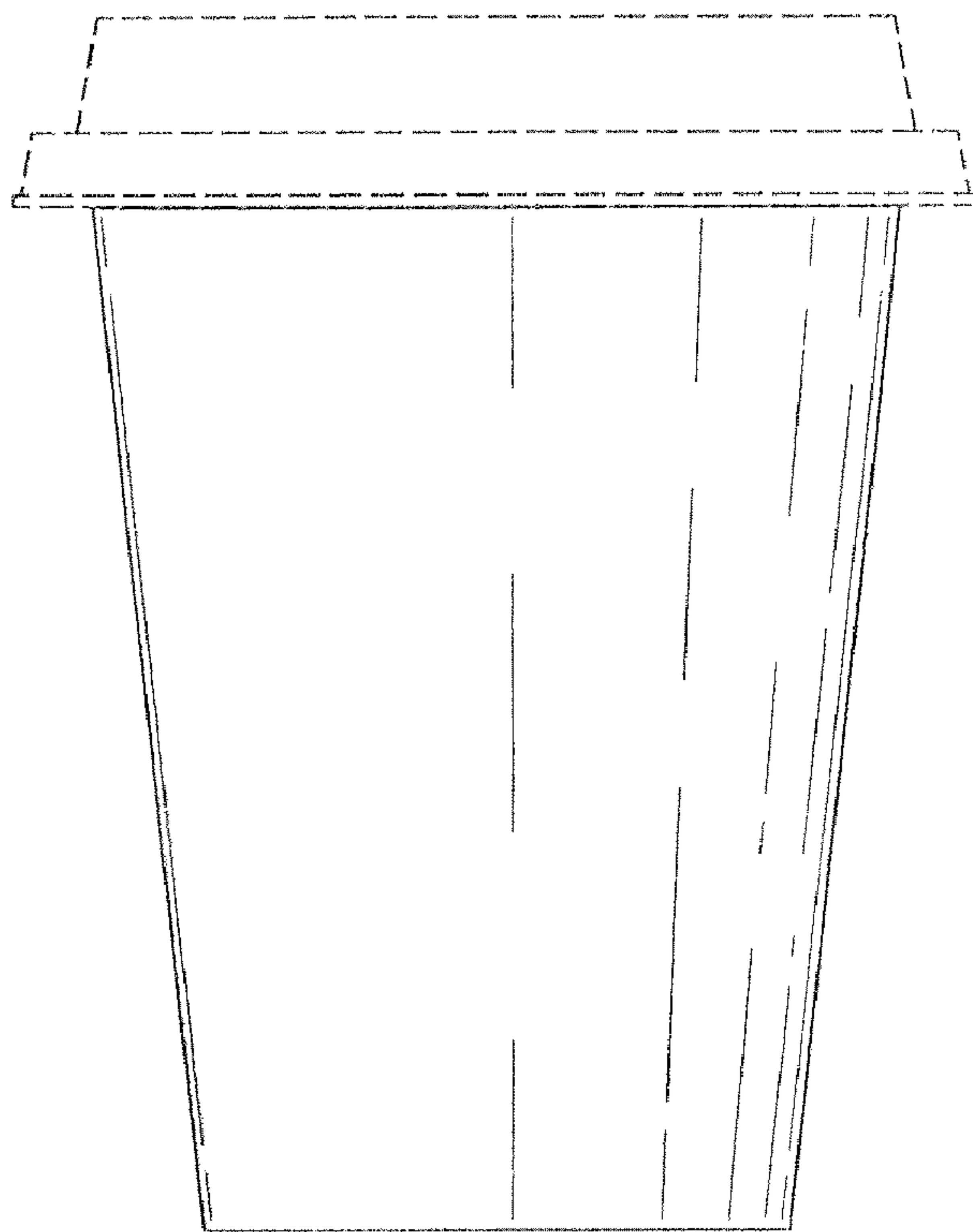

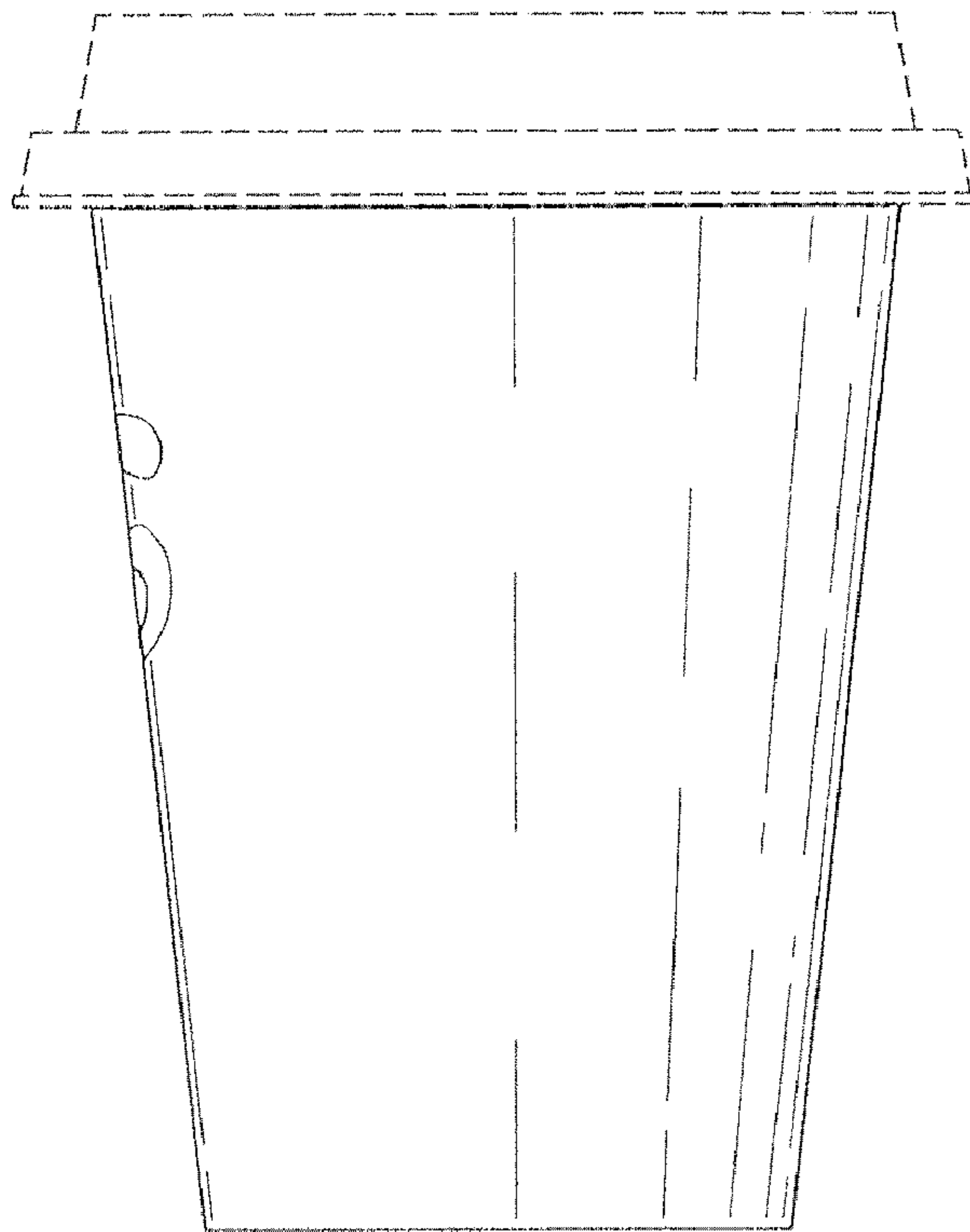

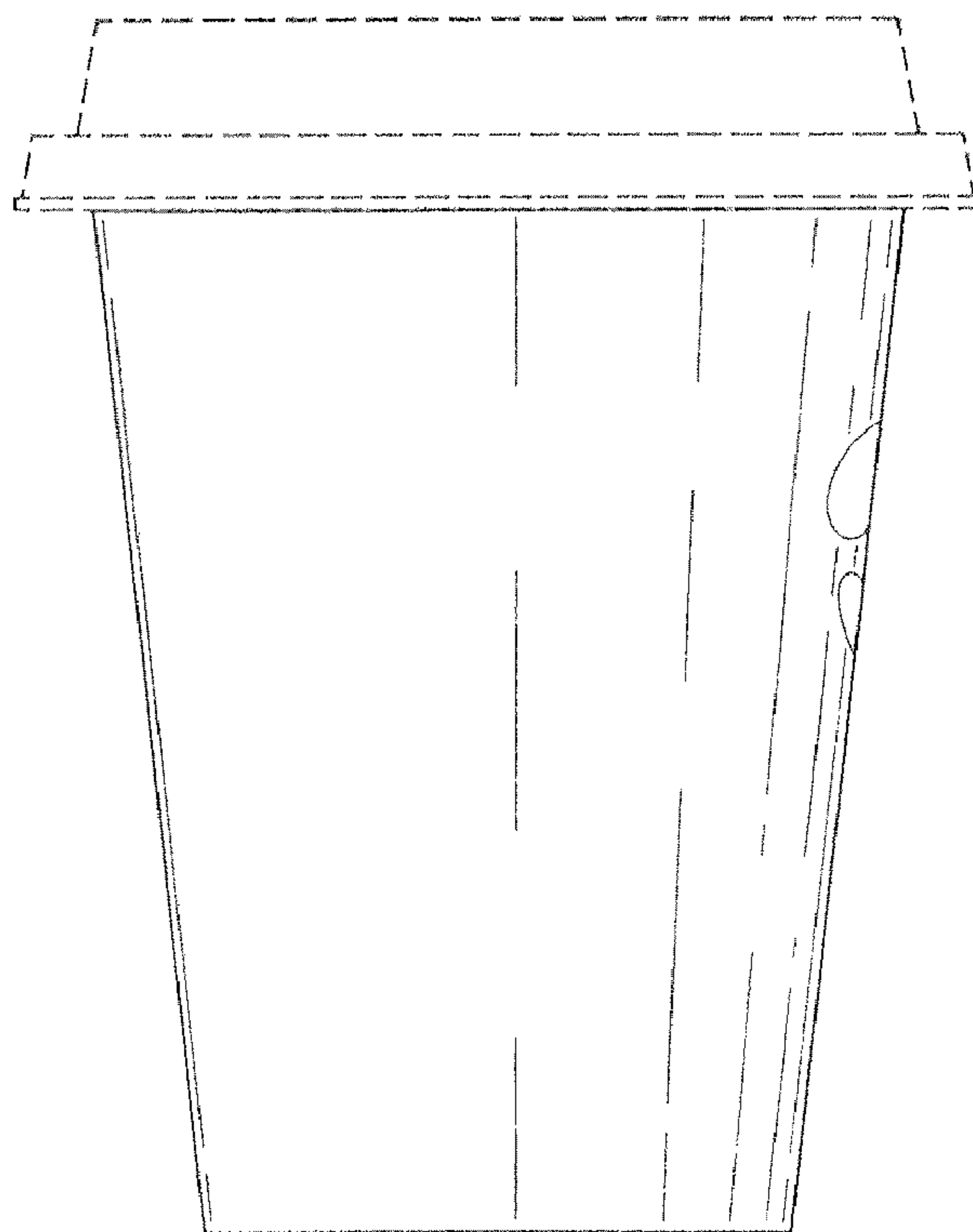

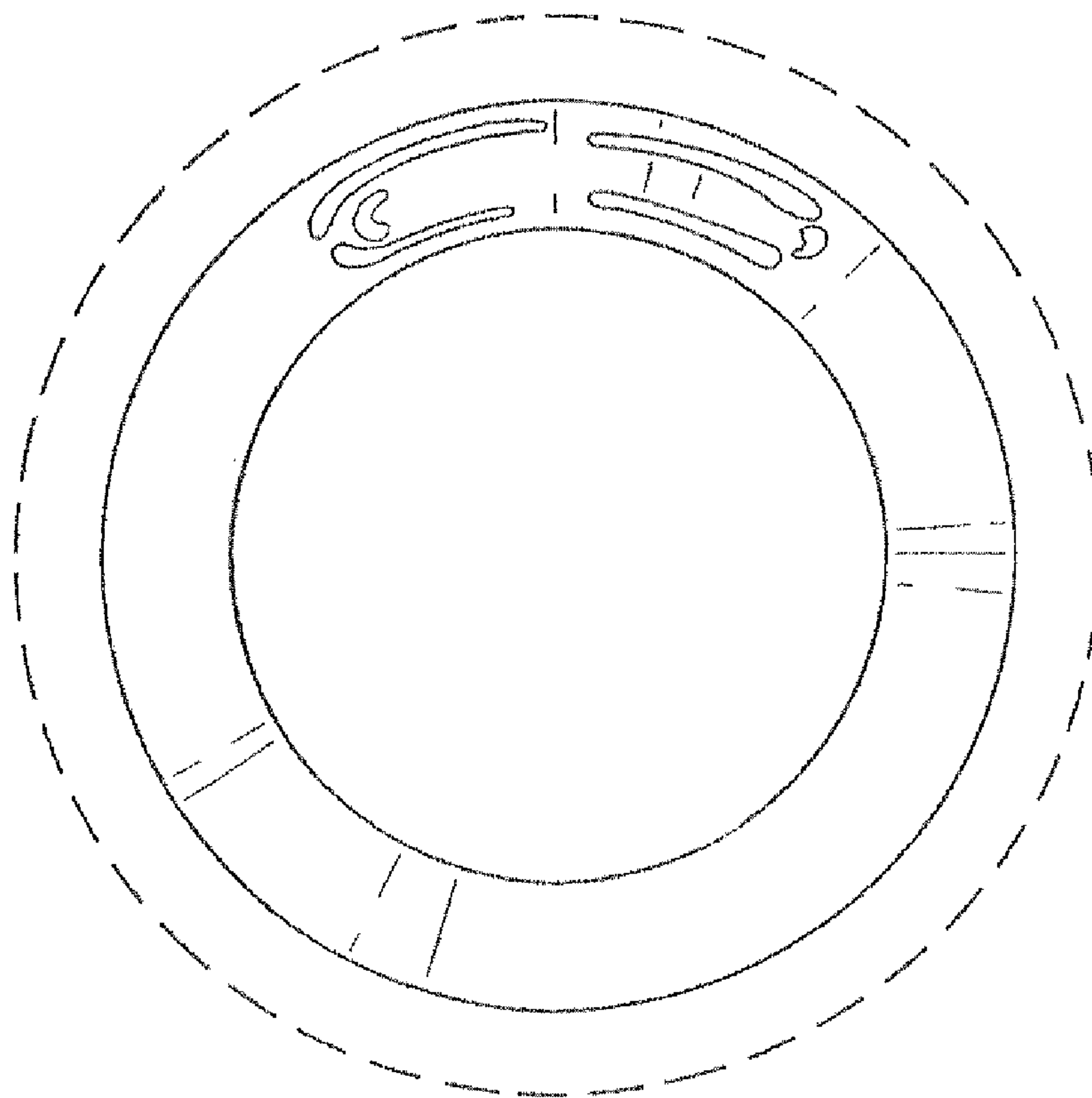
