FIG. 10 is a rear view;

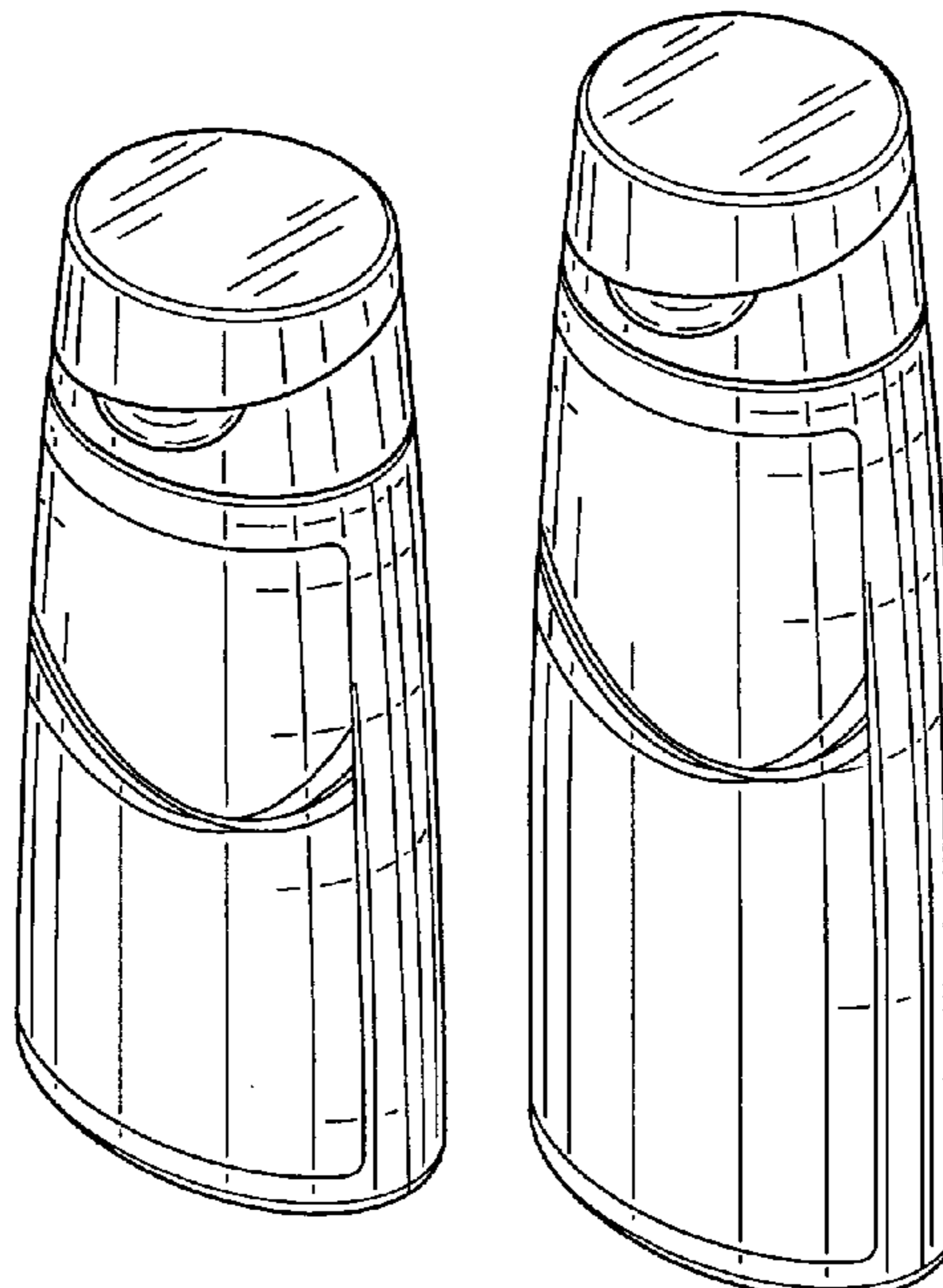
FIG. 11 is a top view;

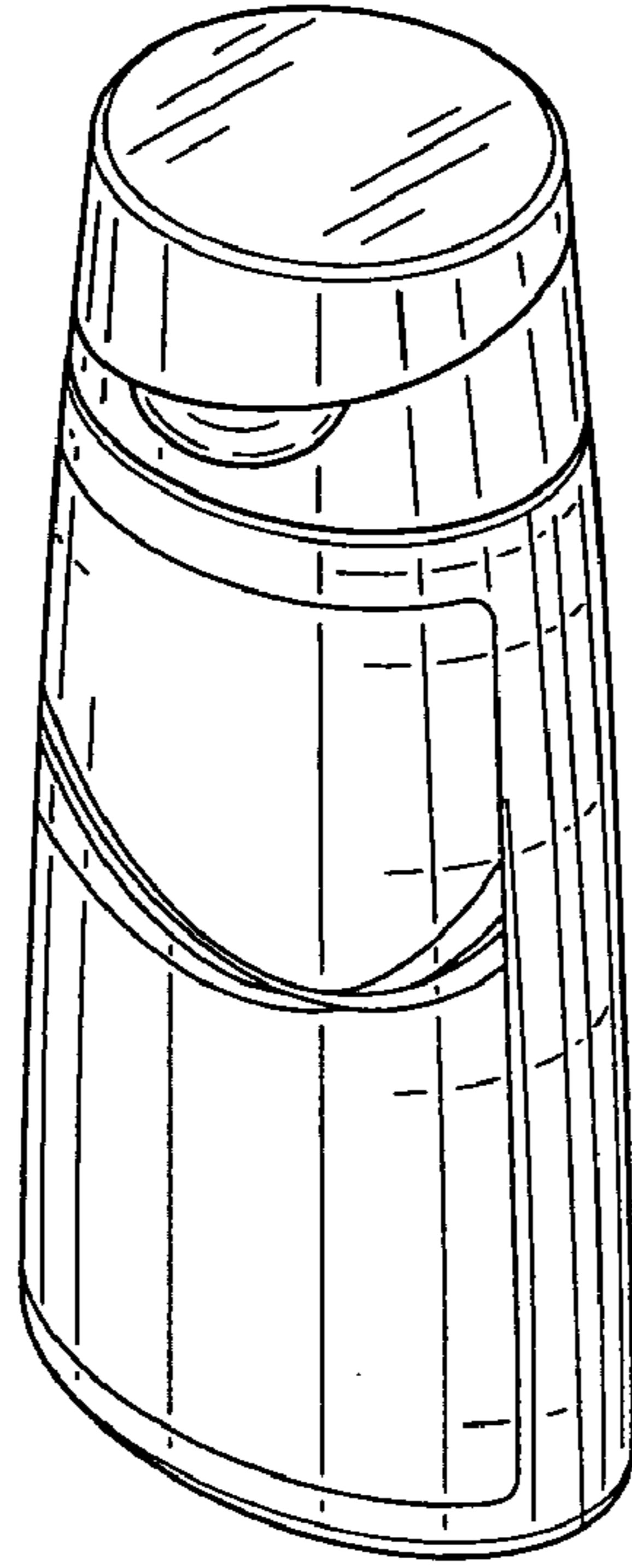

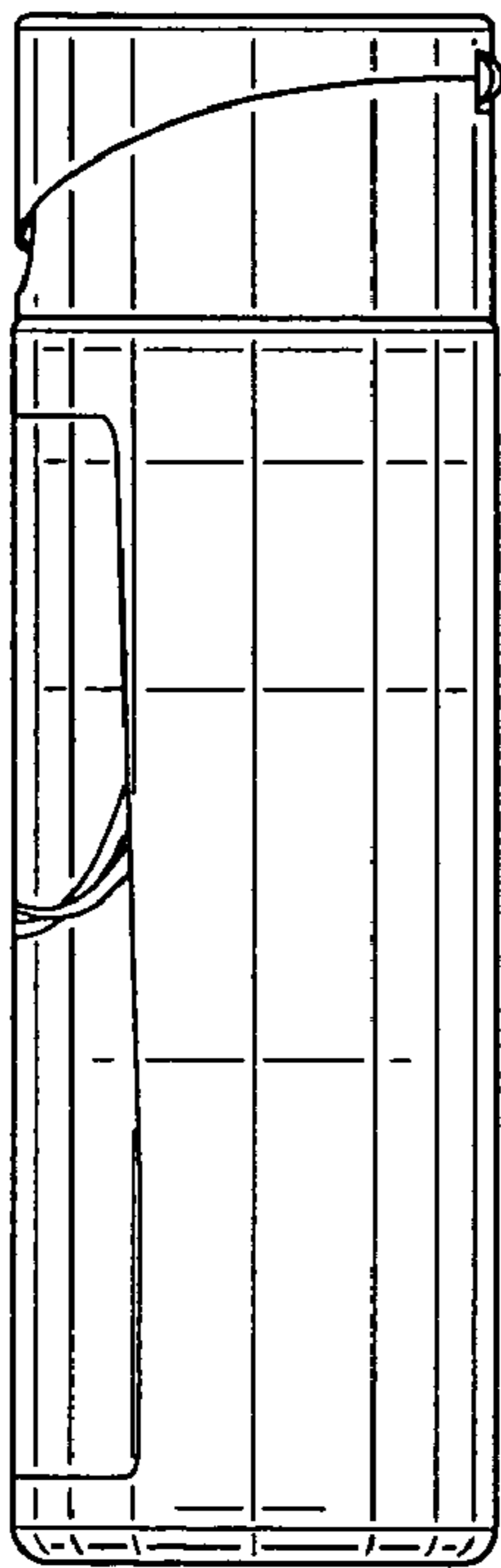

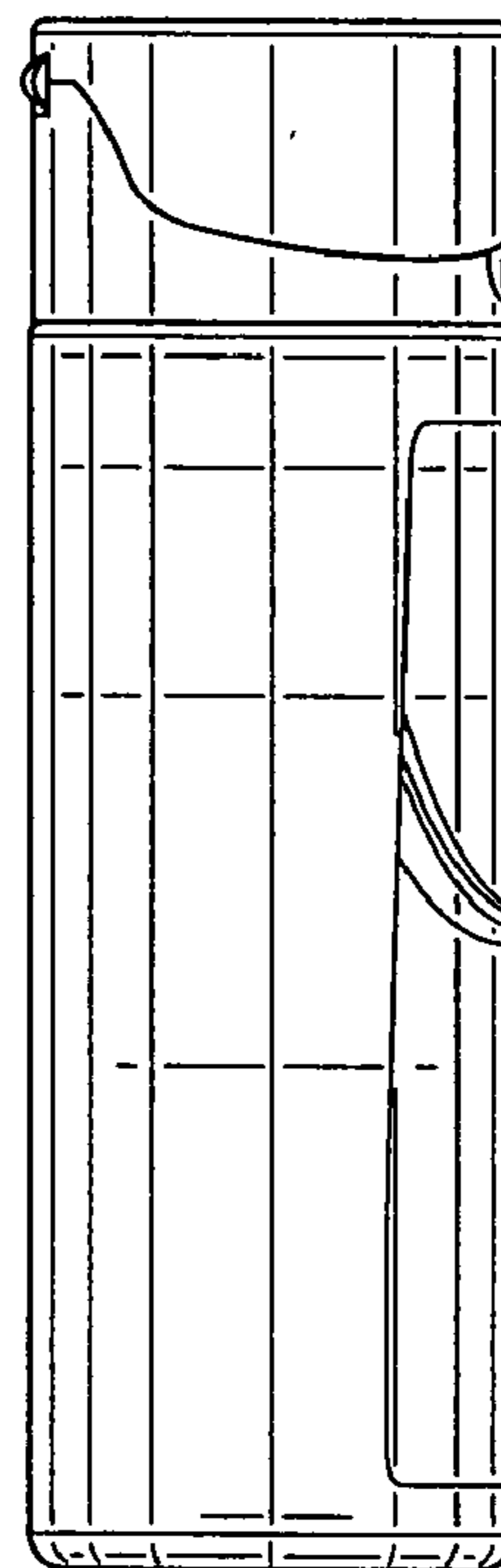

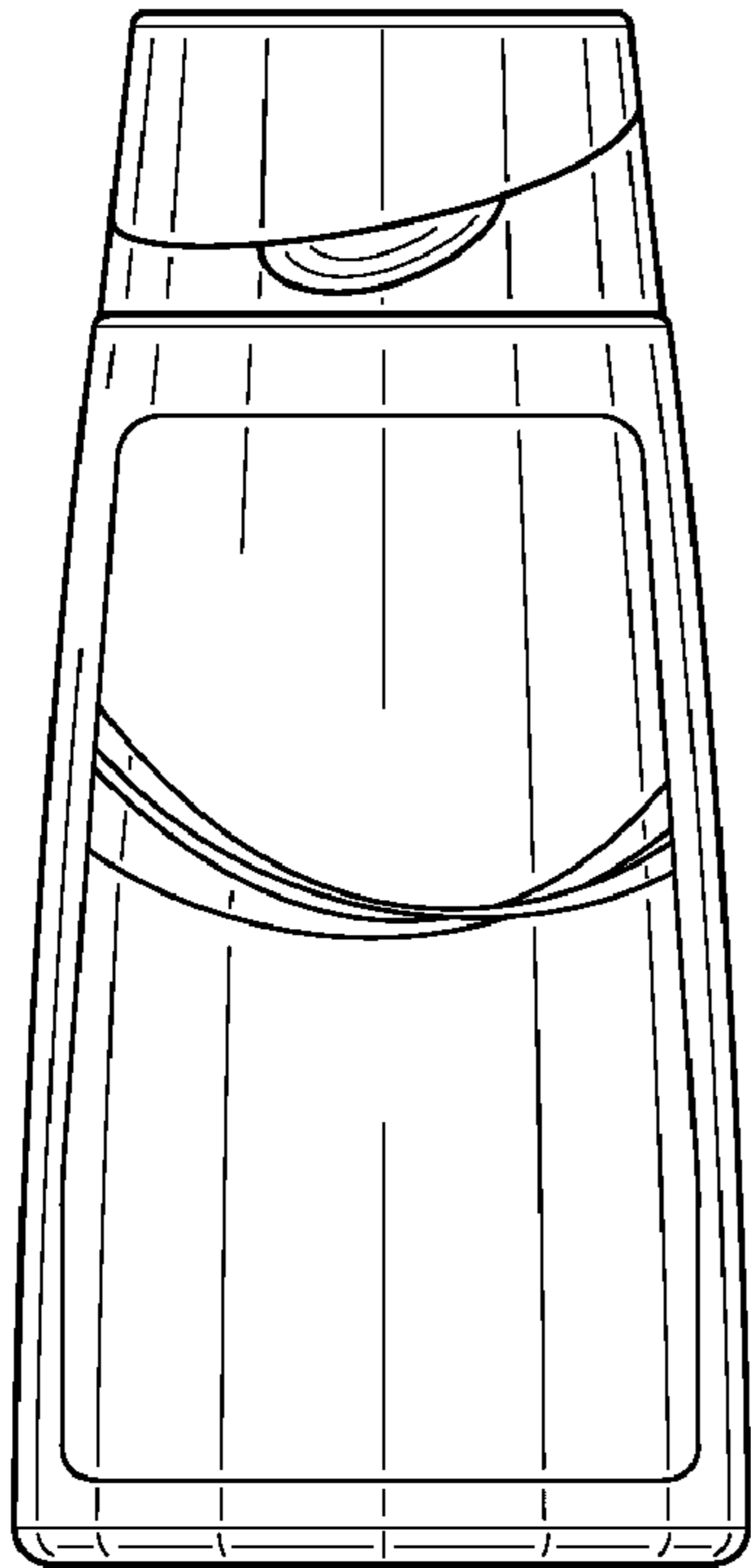

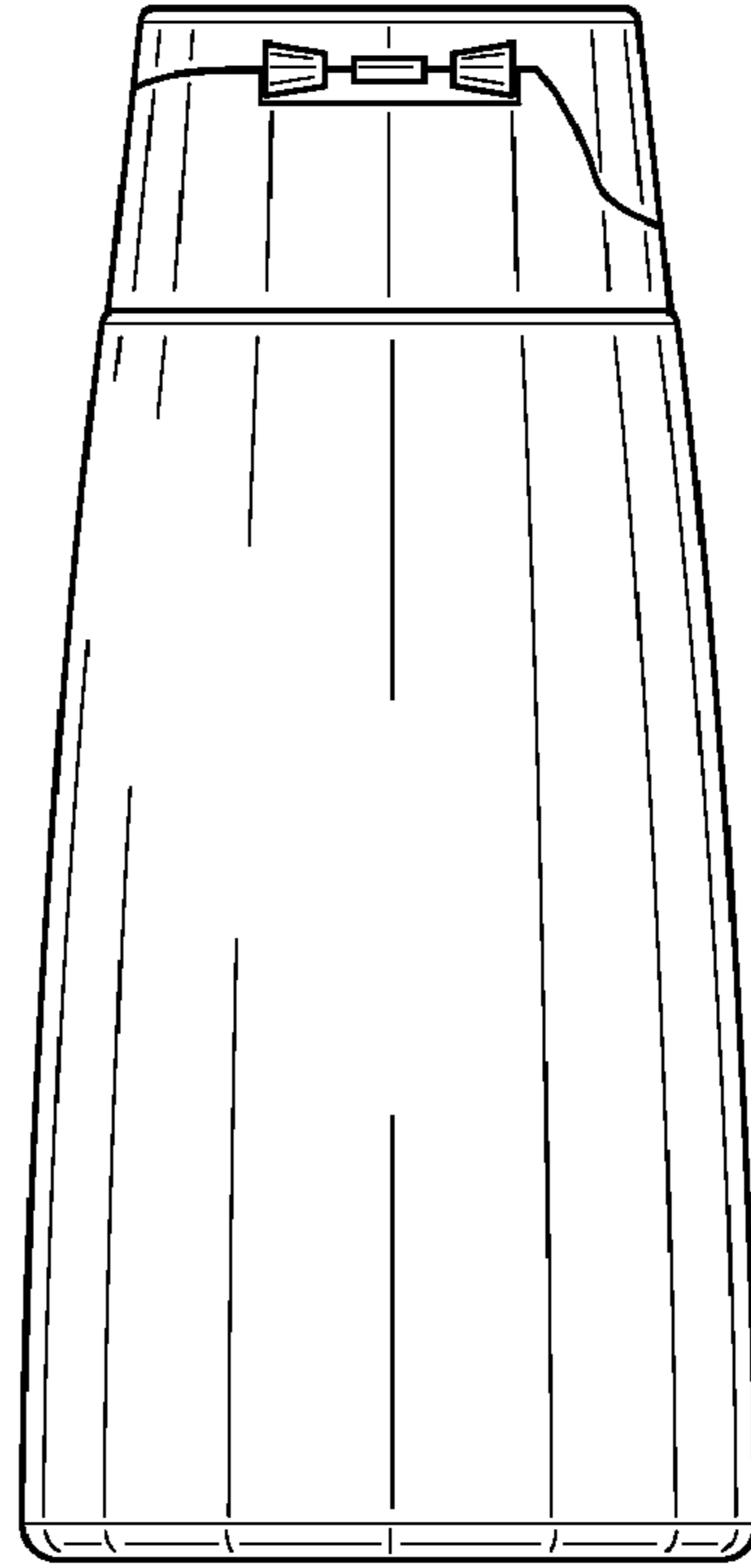

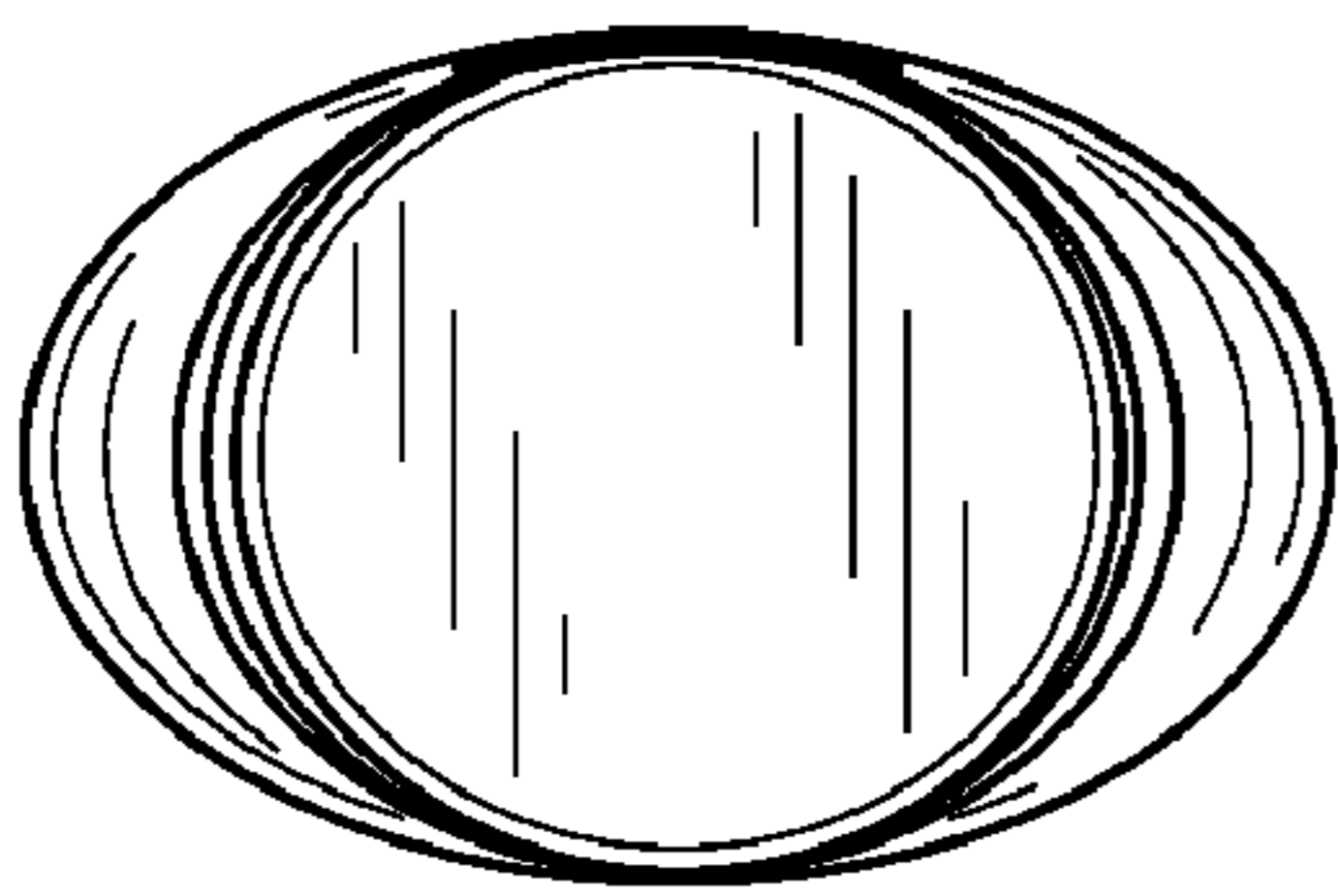

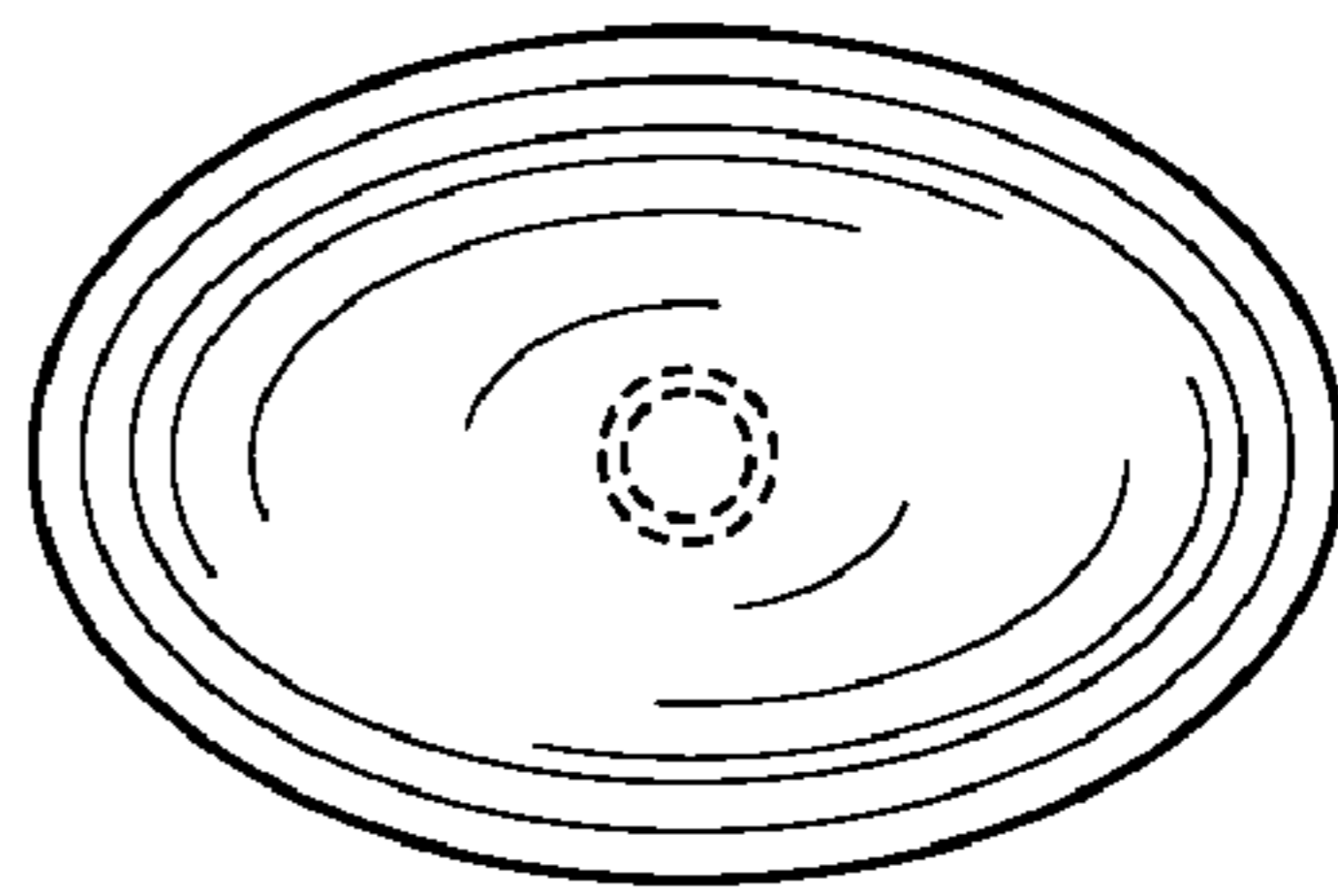

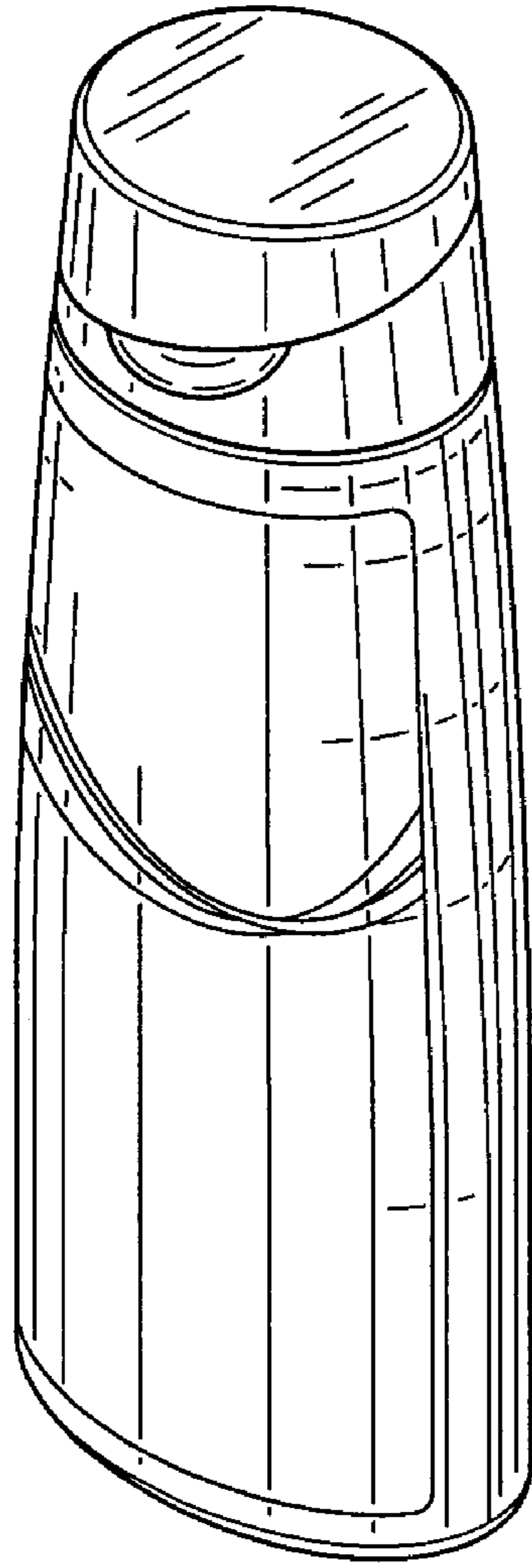

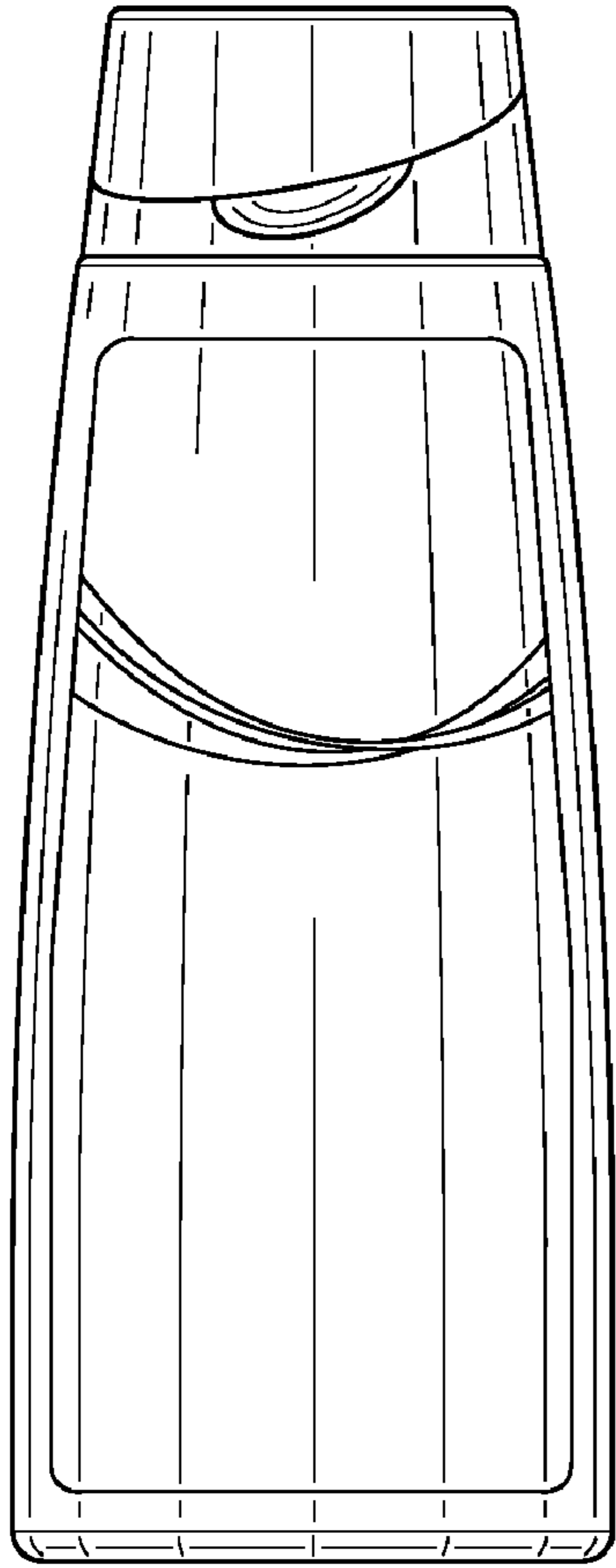

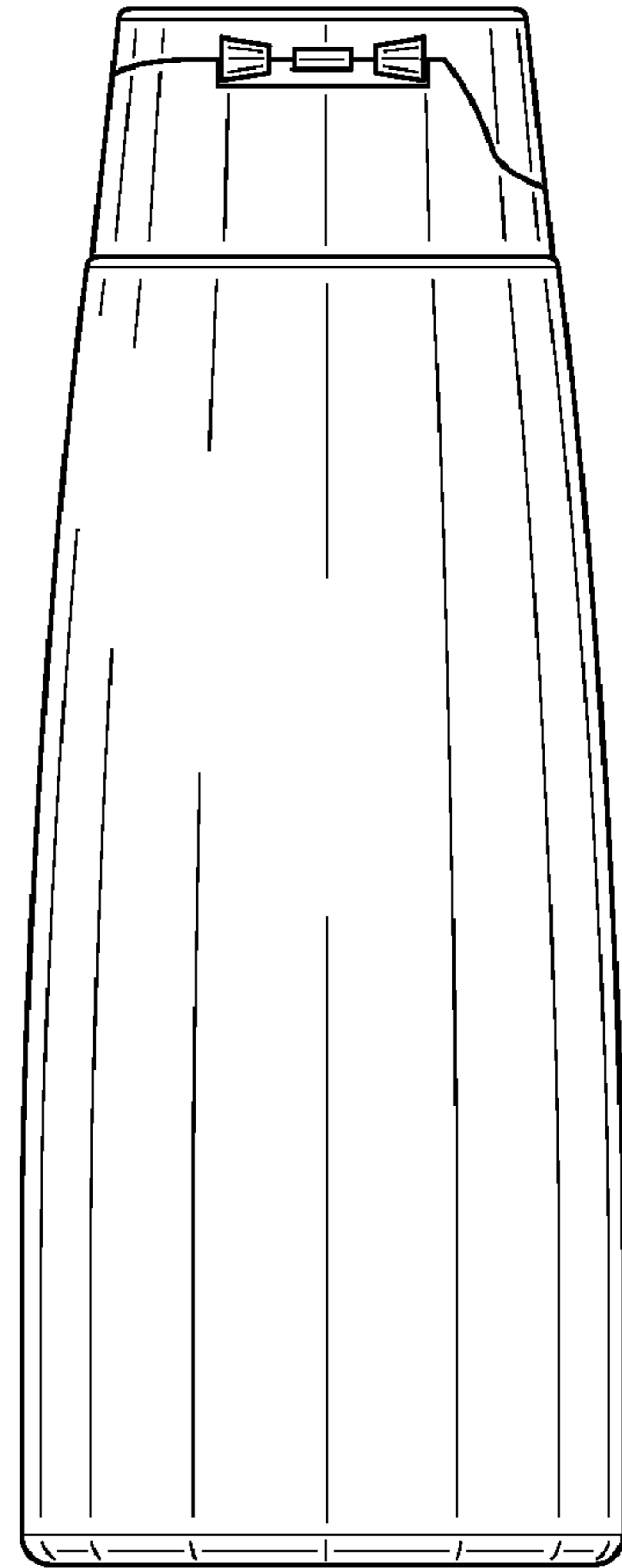

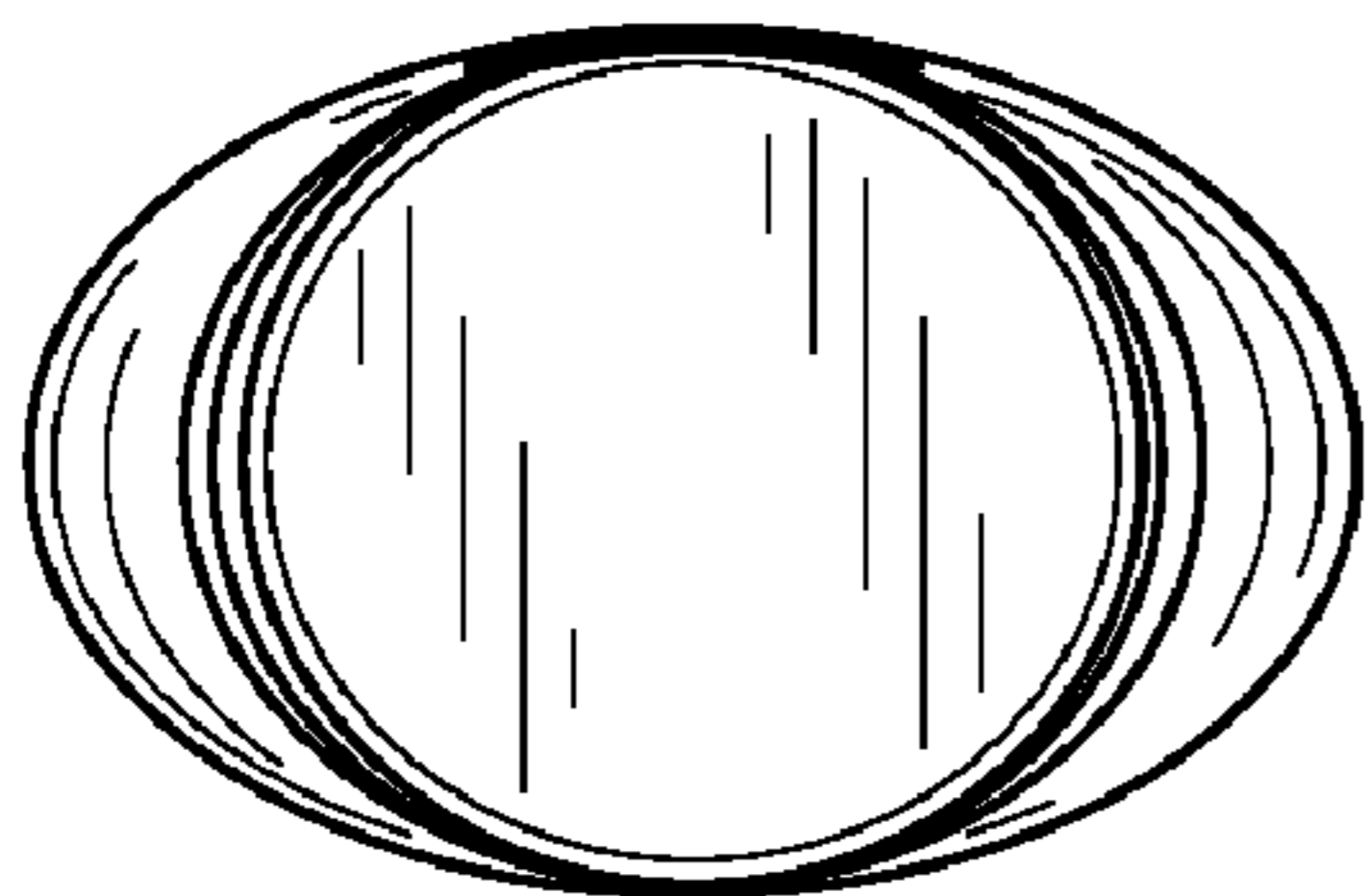

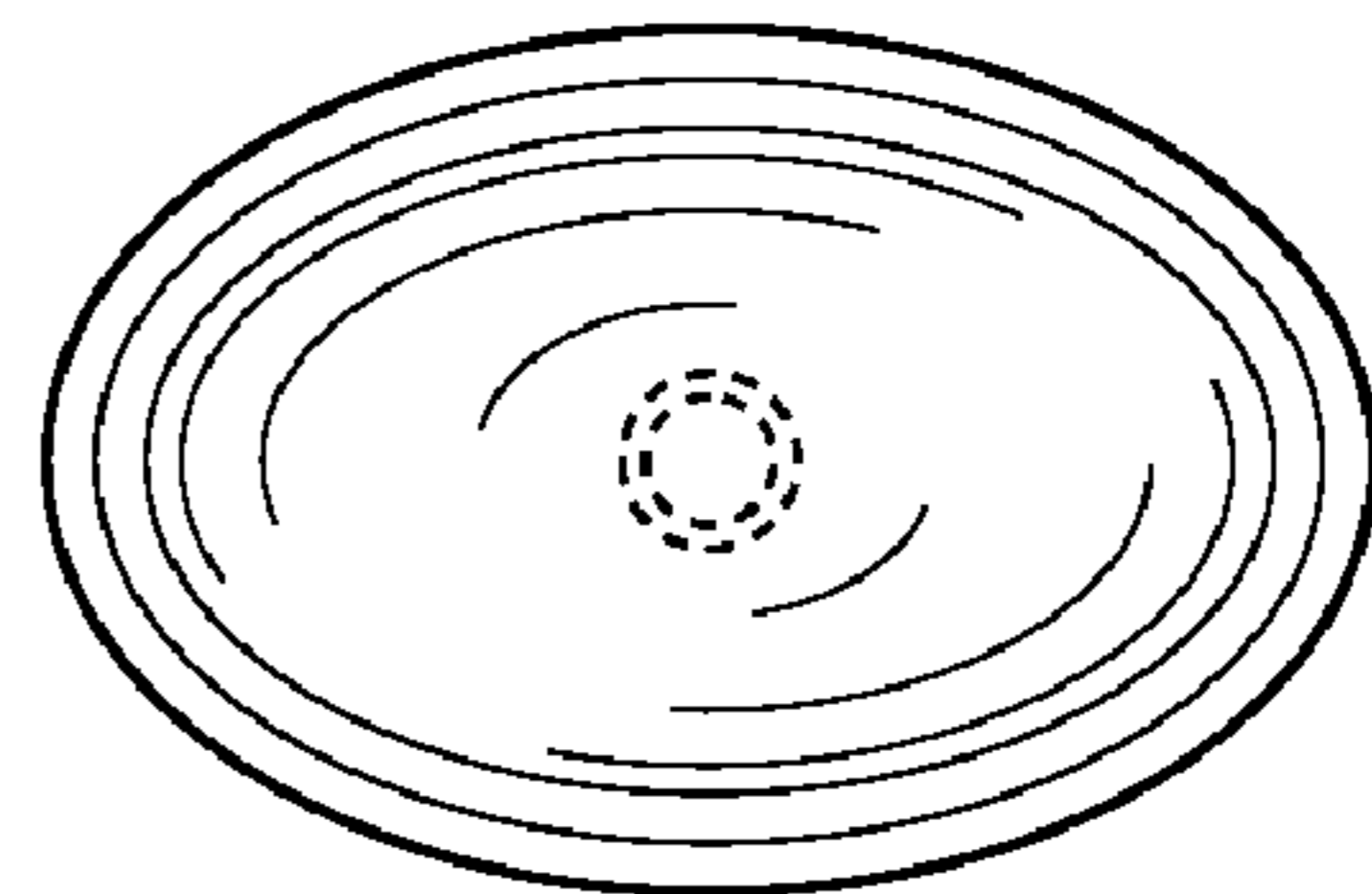

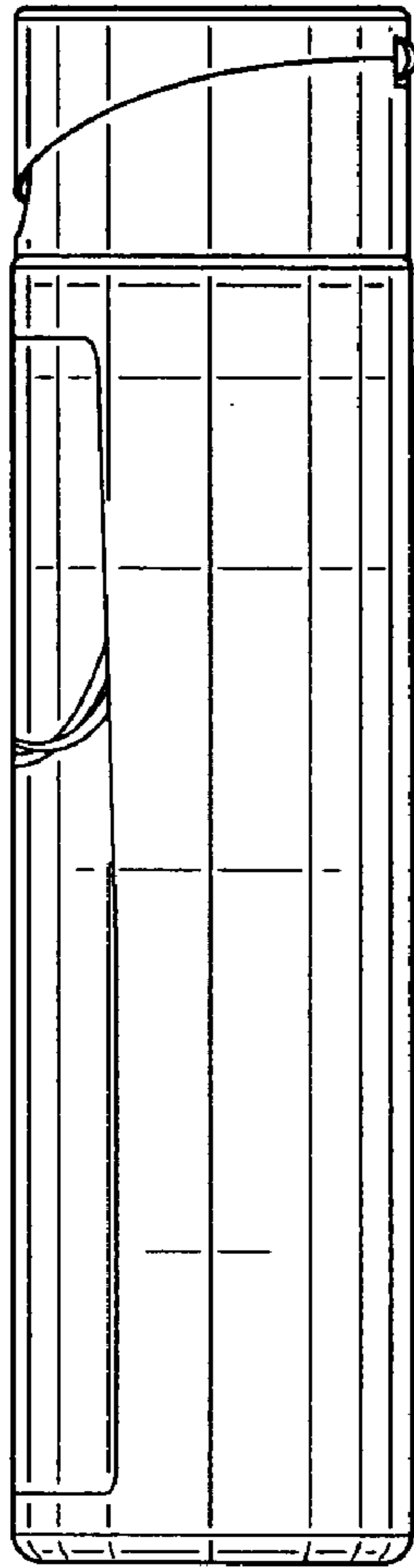

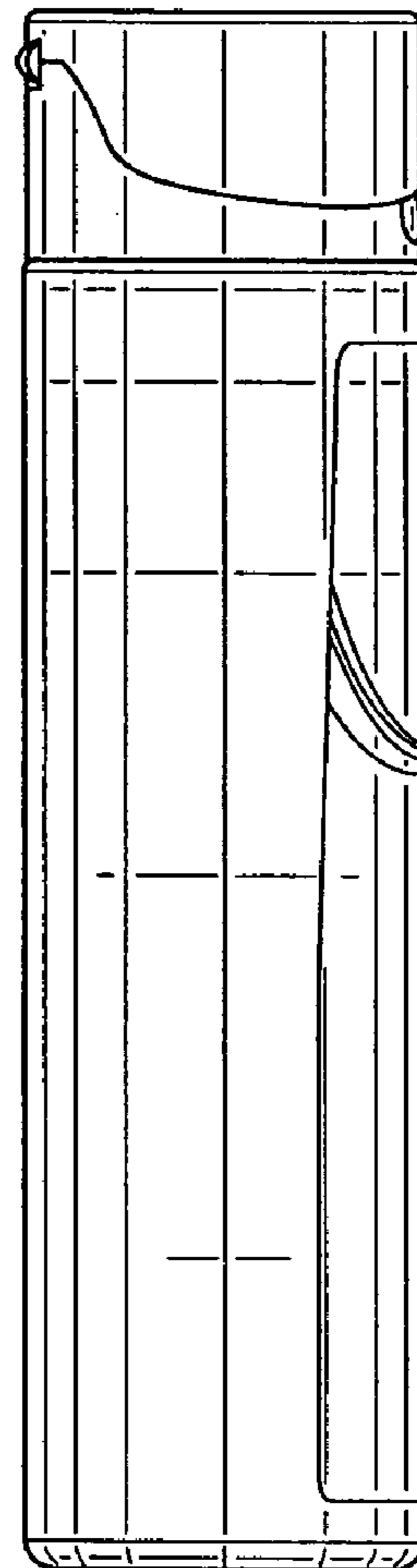
