FIG. 1 is a front elevation view of a combined pillow and alarm clock showing my new design;

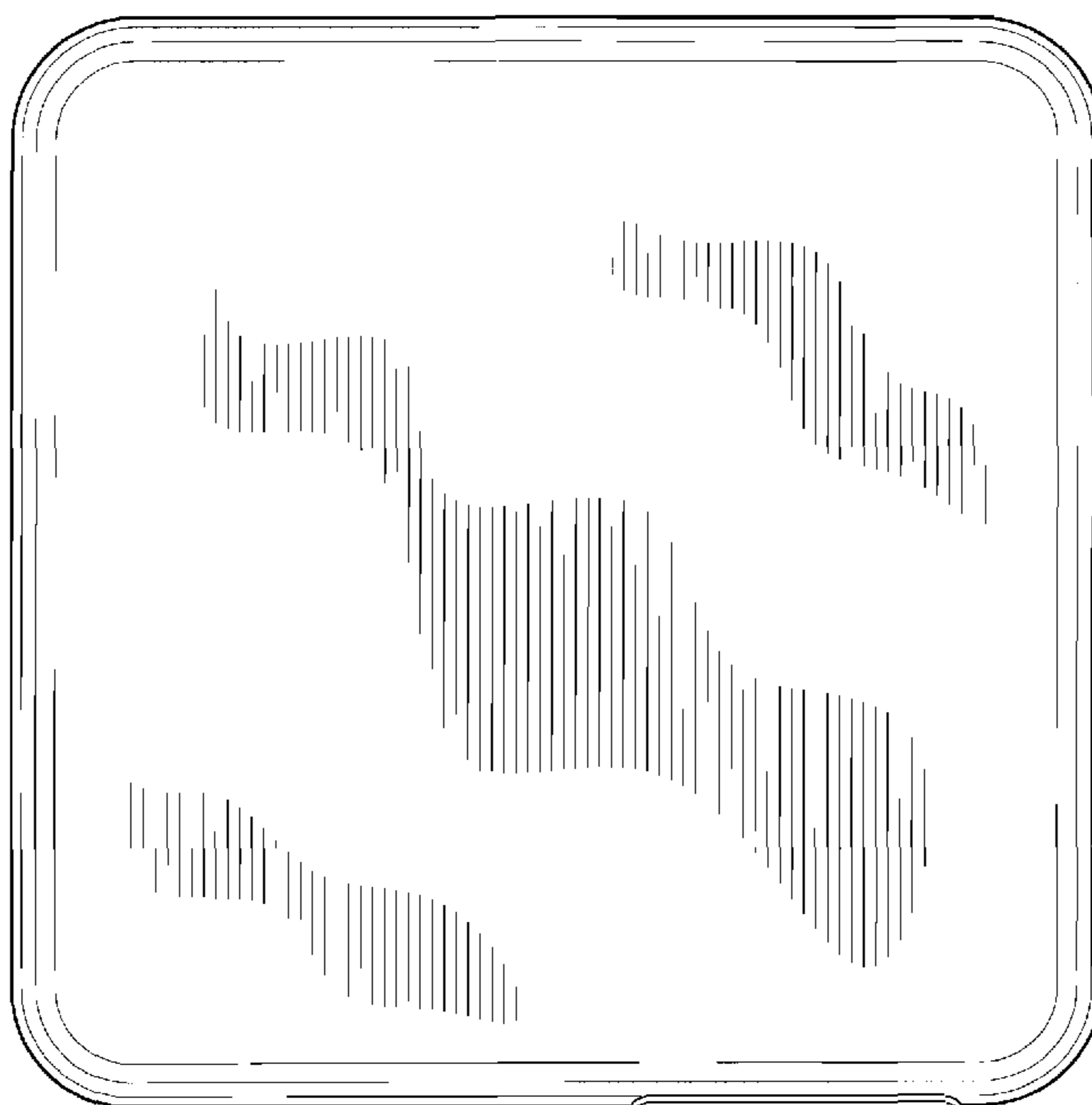
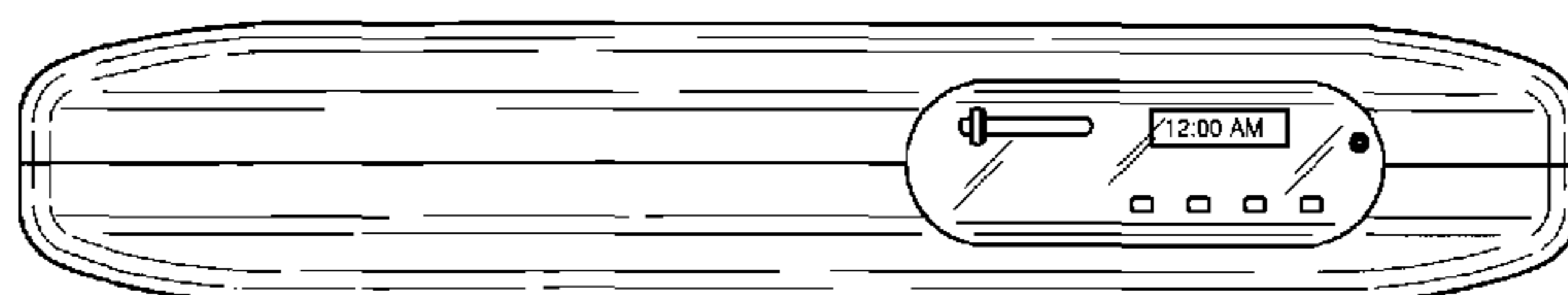
FIG. 2 is a rear elevation view;

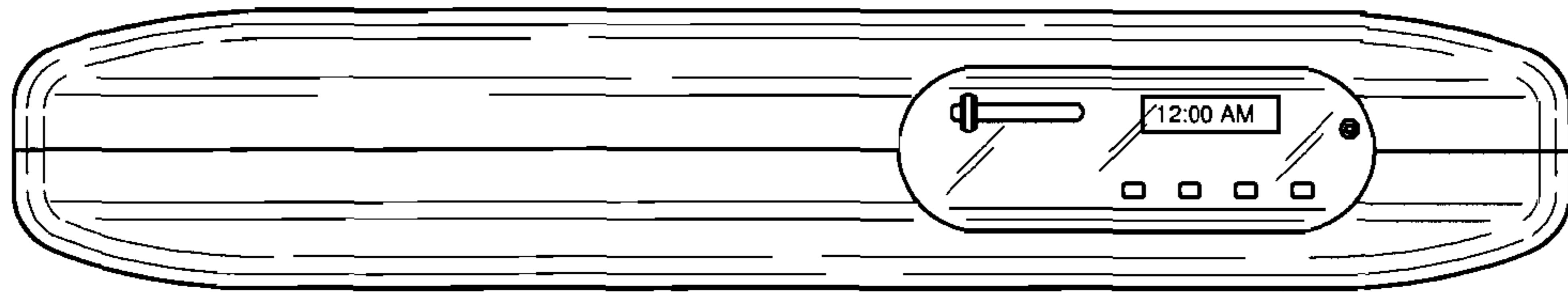

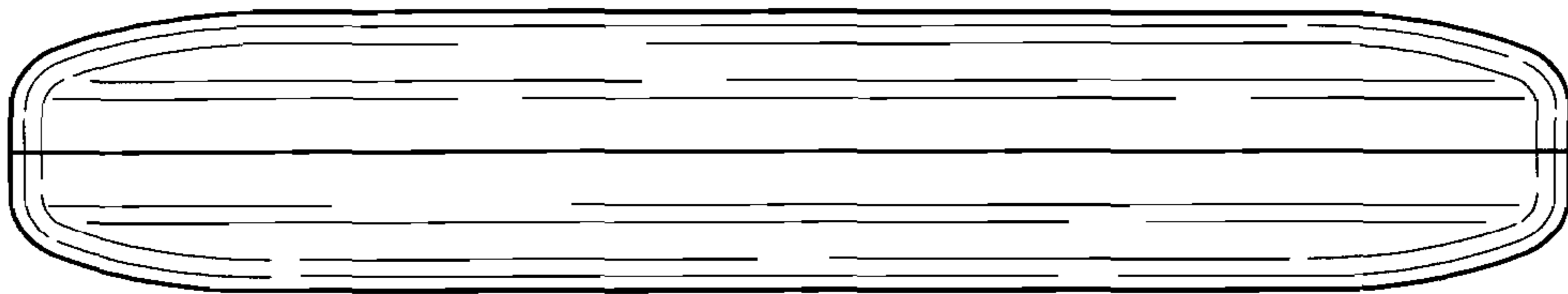

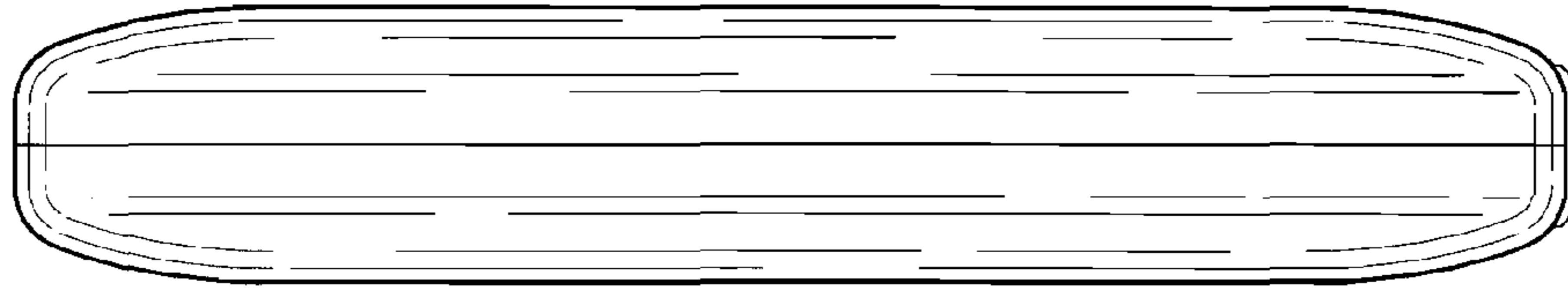

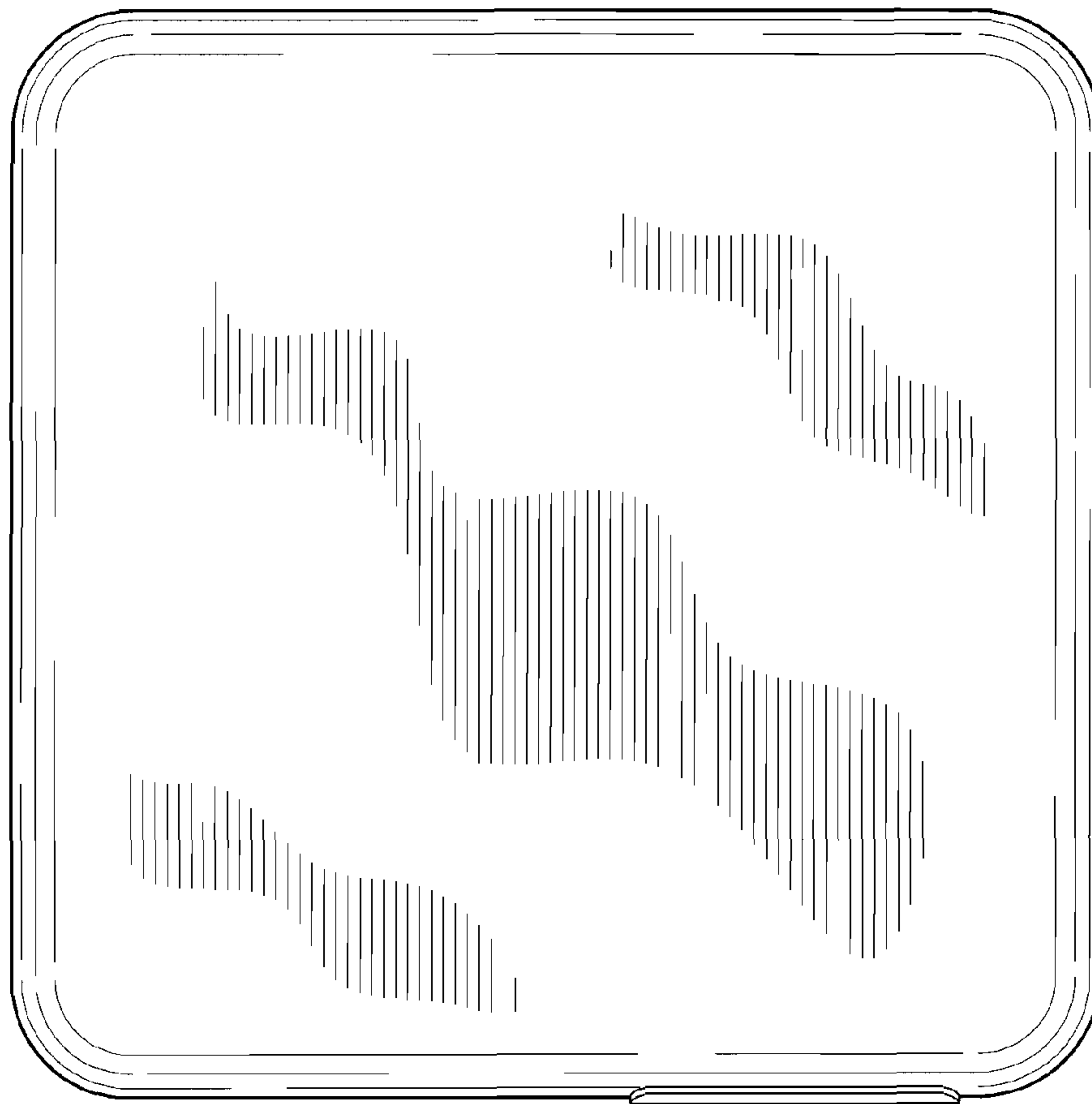
