FIG. 1 is a front view of a combined watch and band, showing my new design;

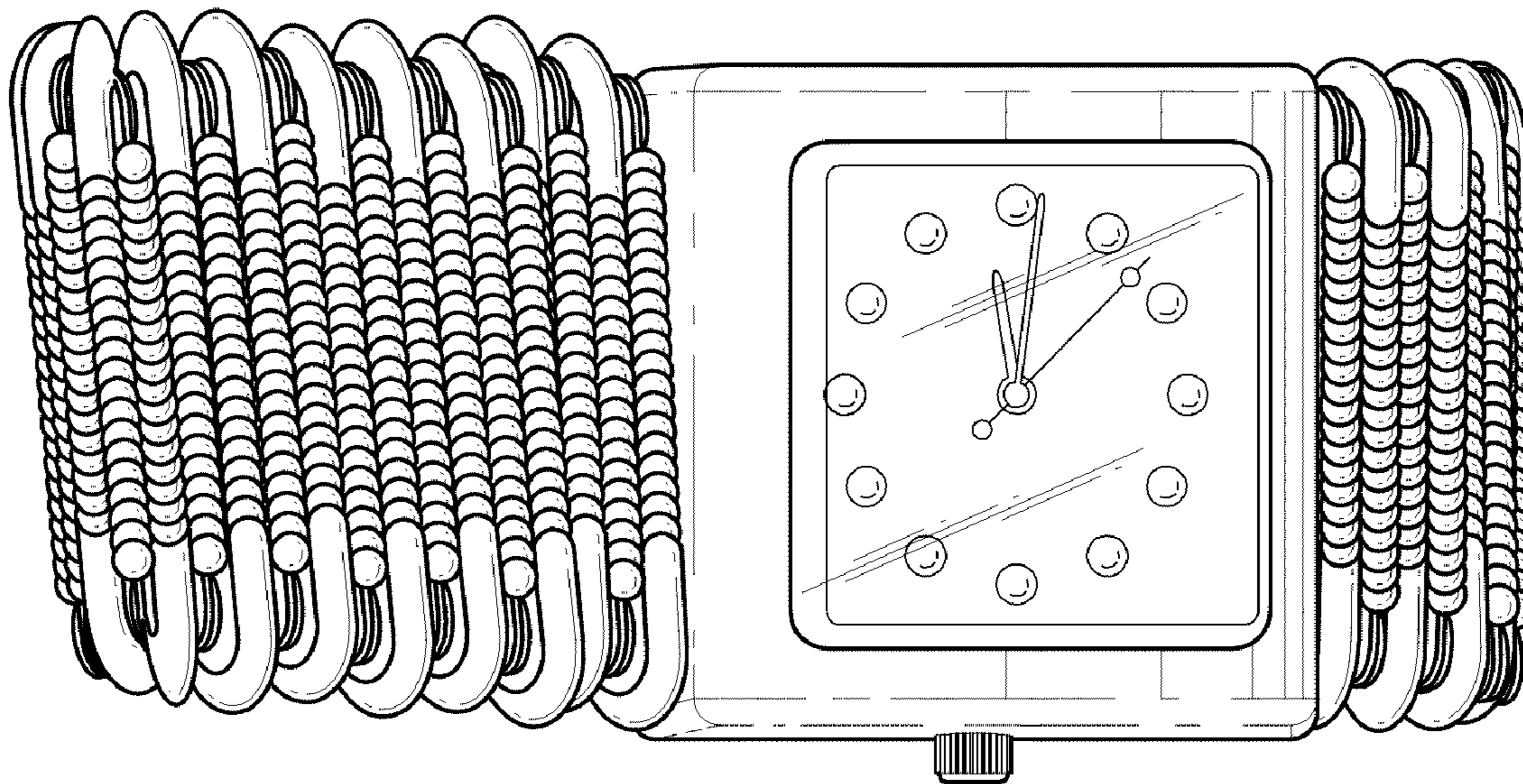
FIG. 2 is a rear view thereof;

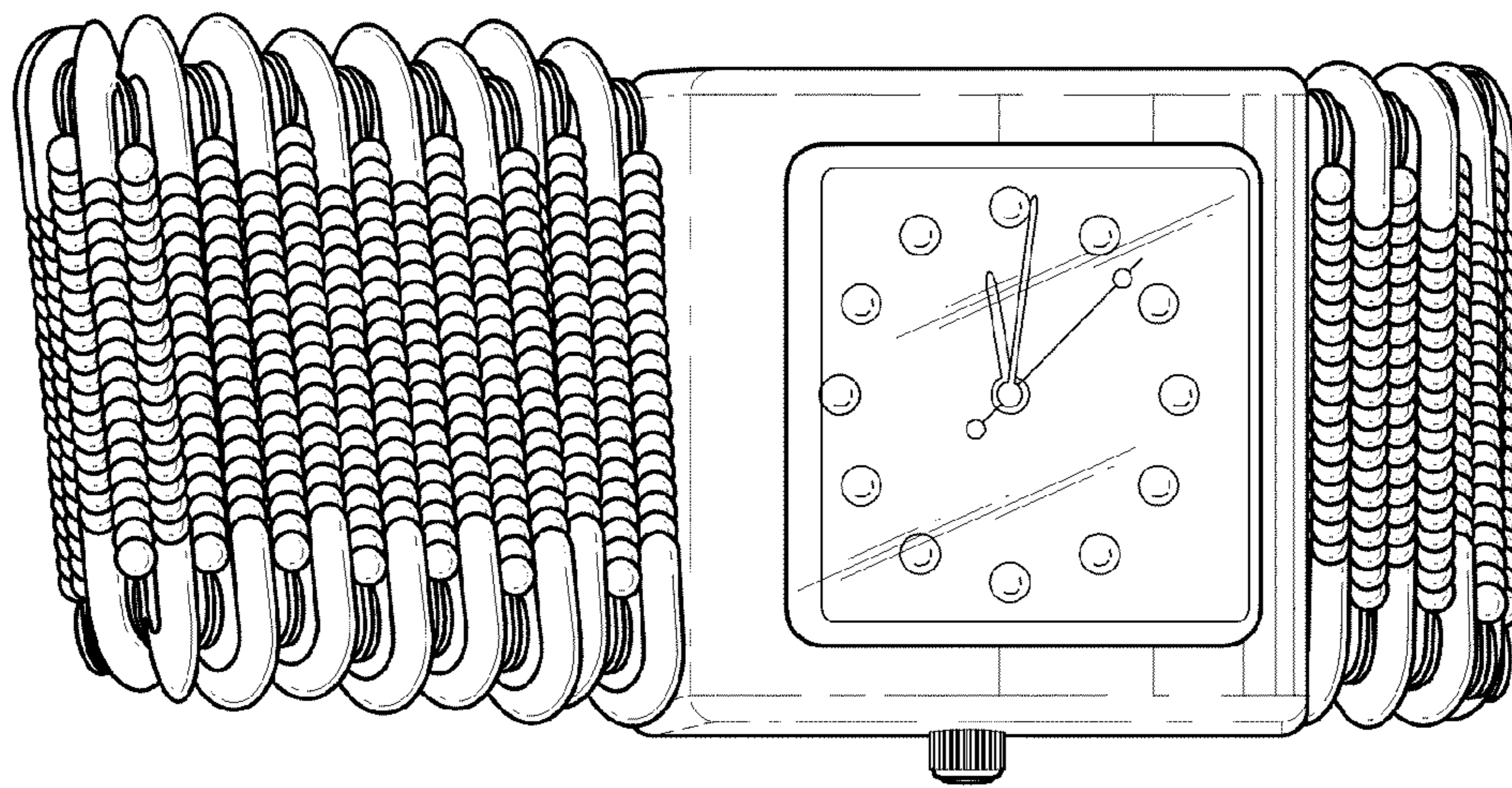

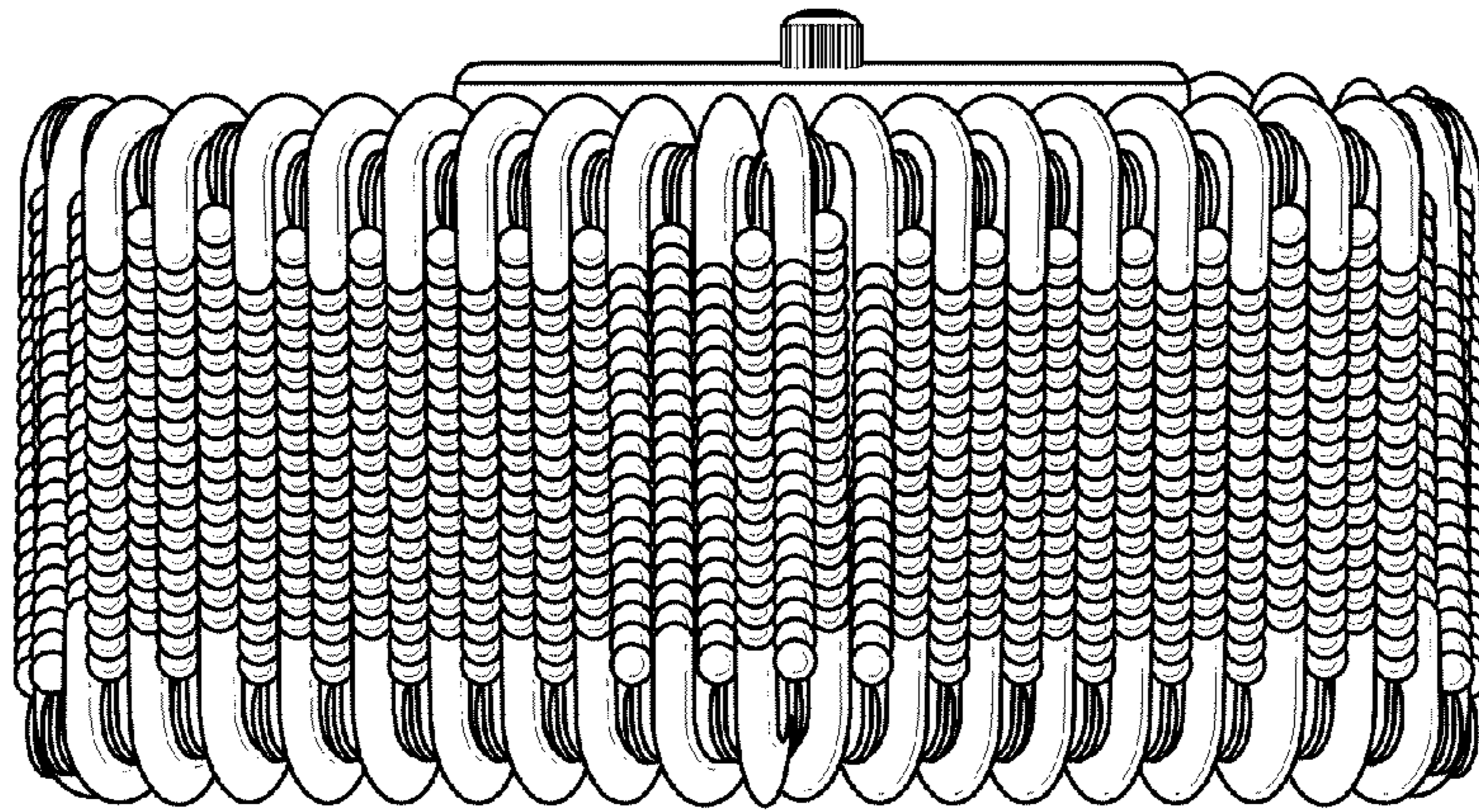

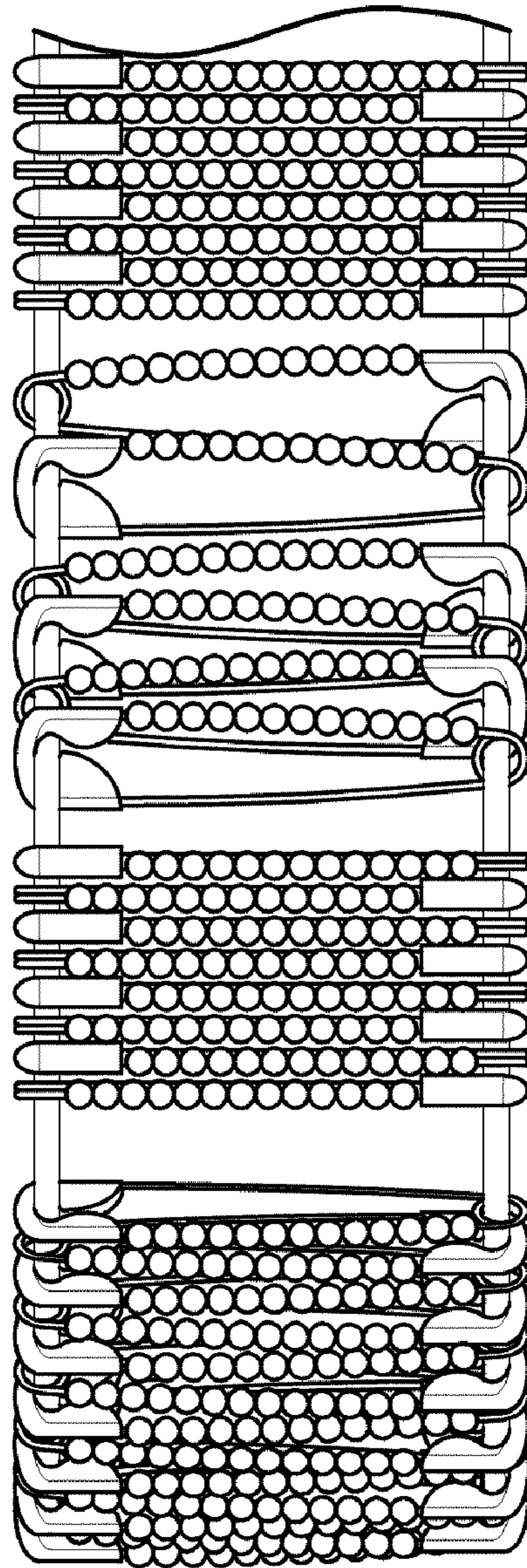

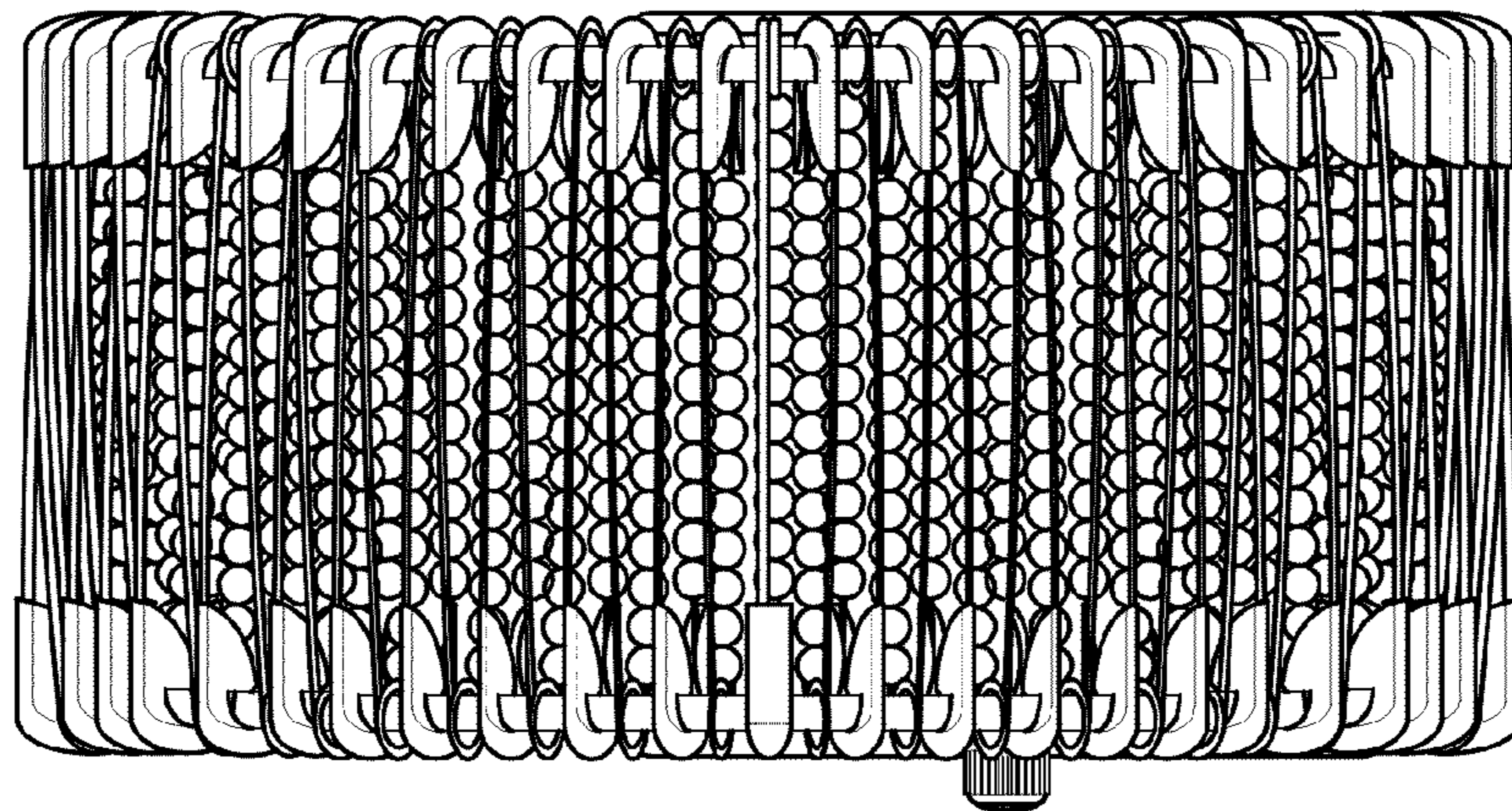

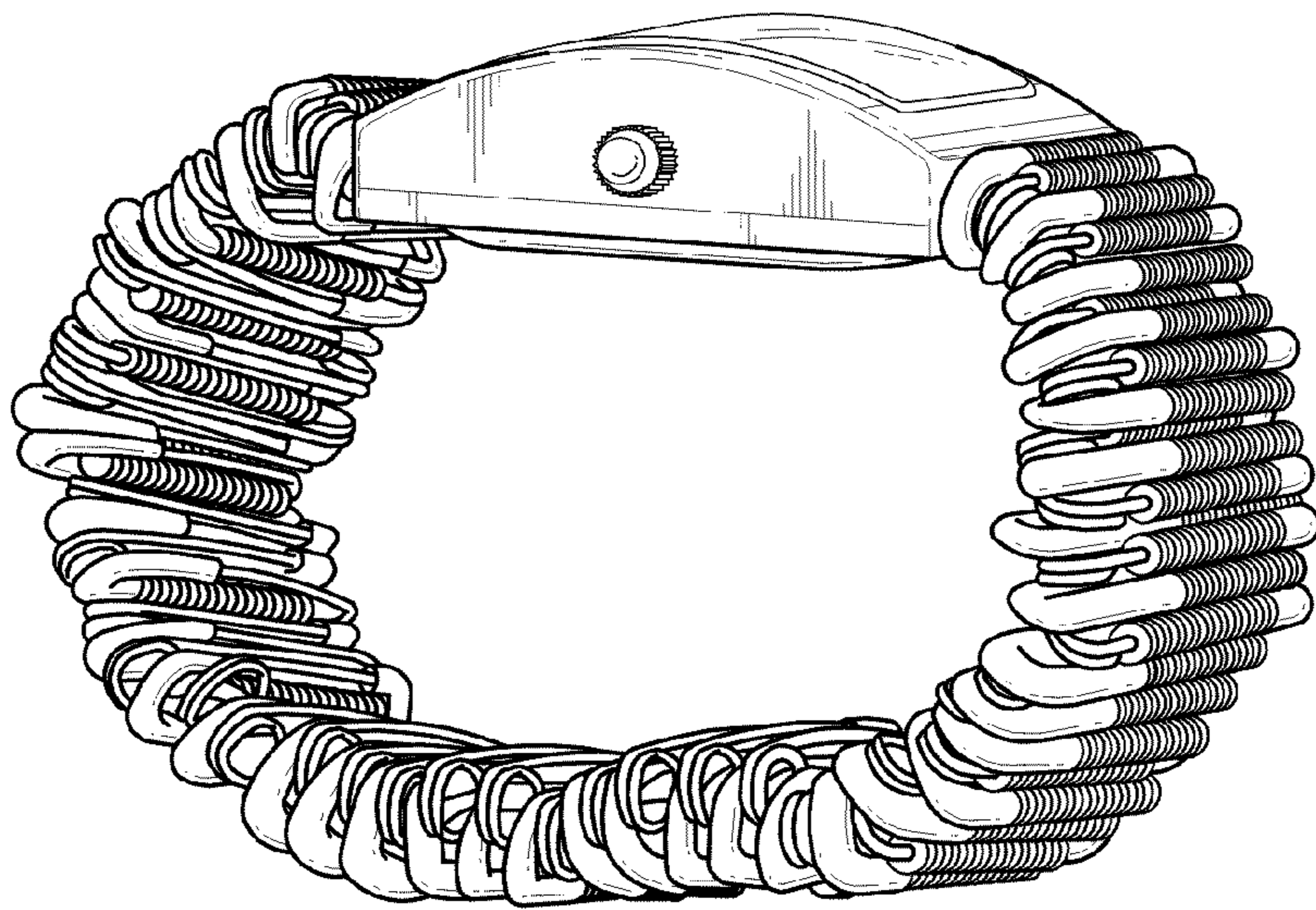
