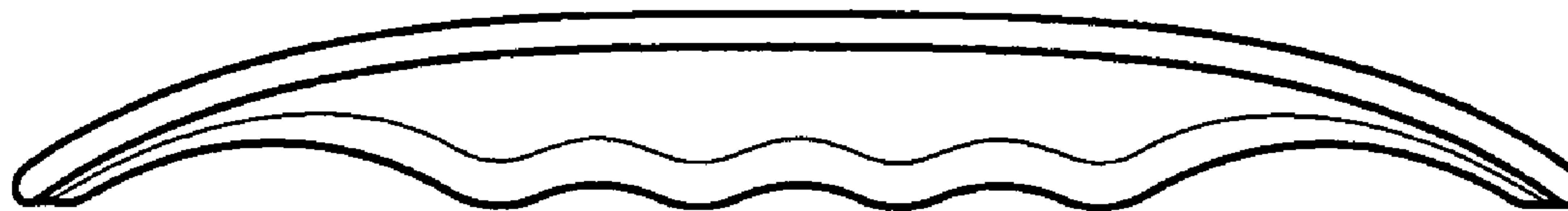
FIG. 4 is a right lateral view thereof;

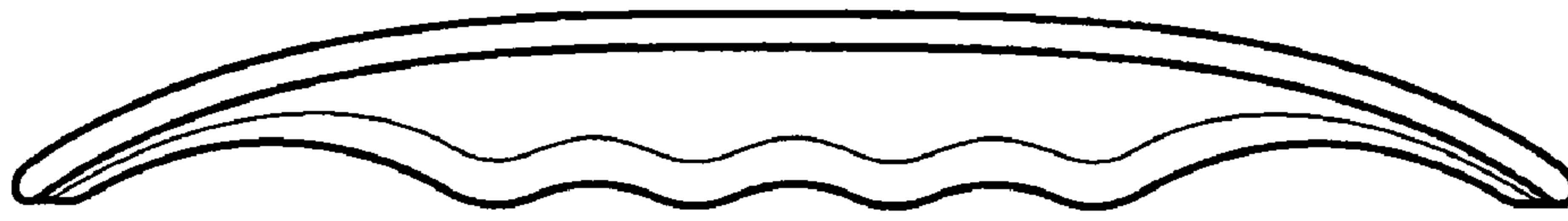

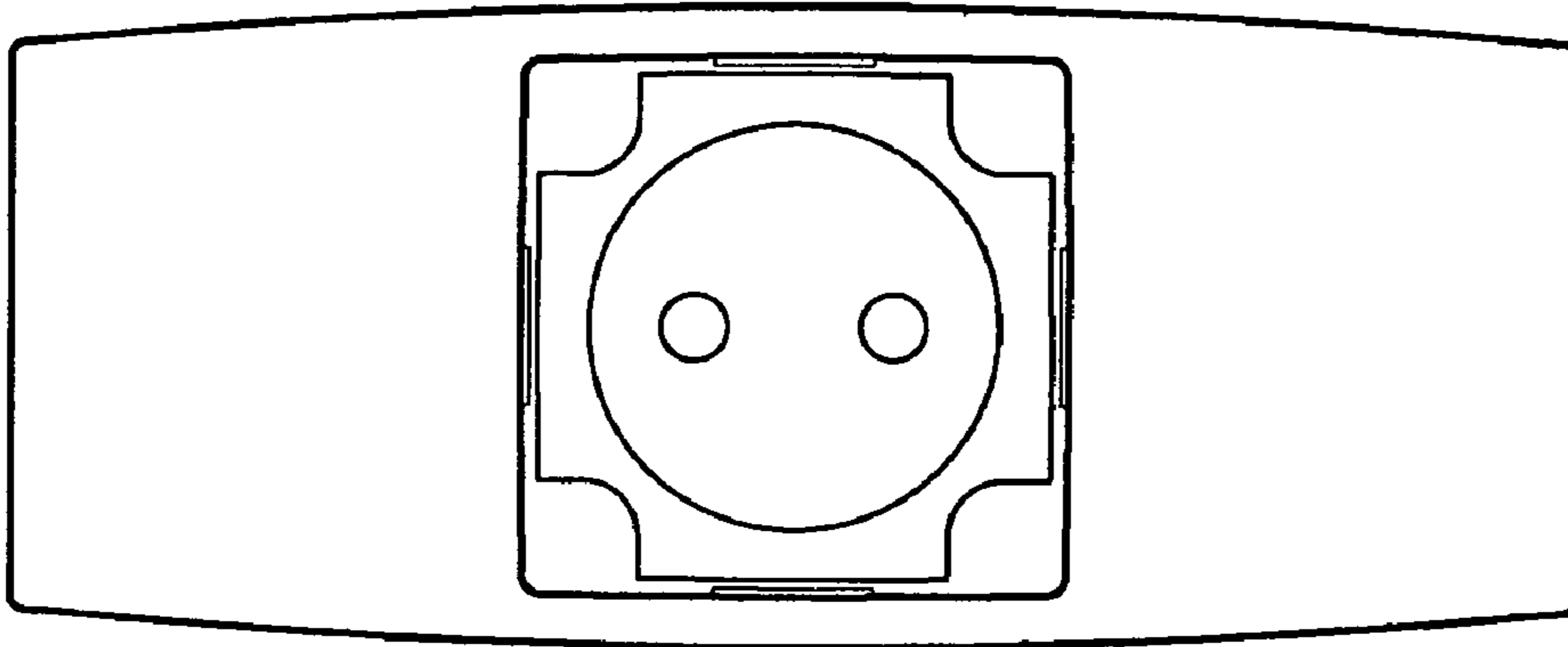

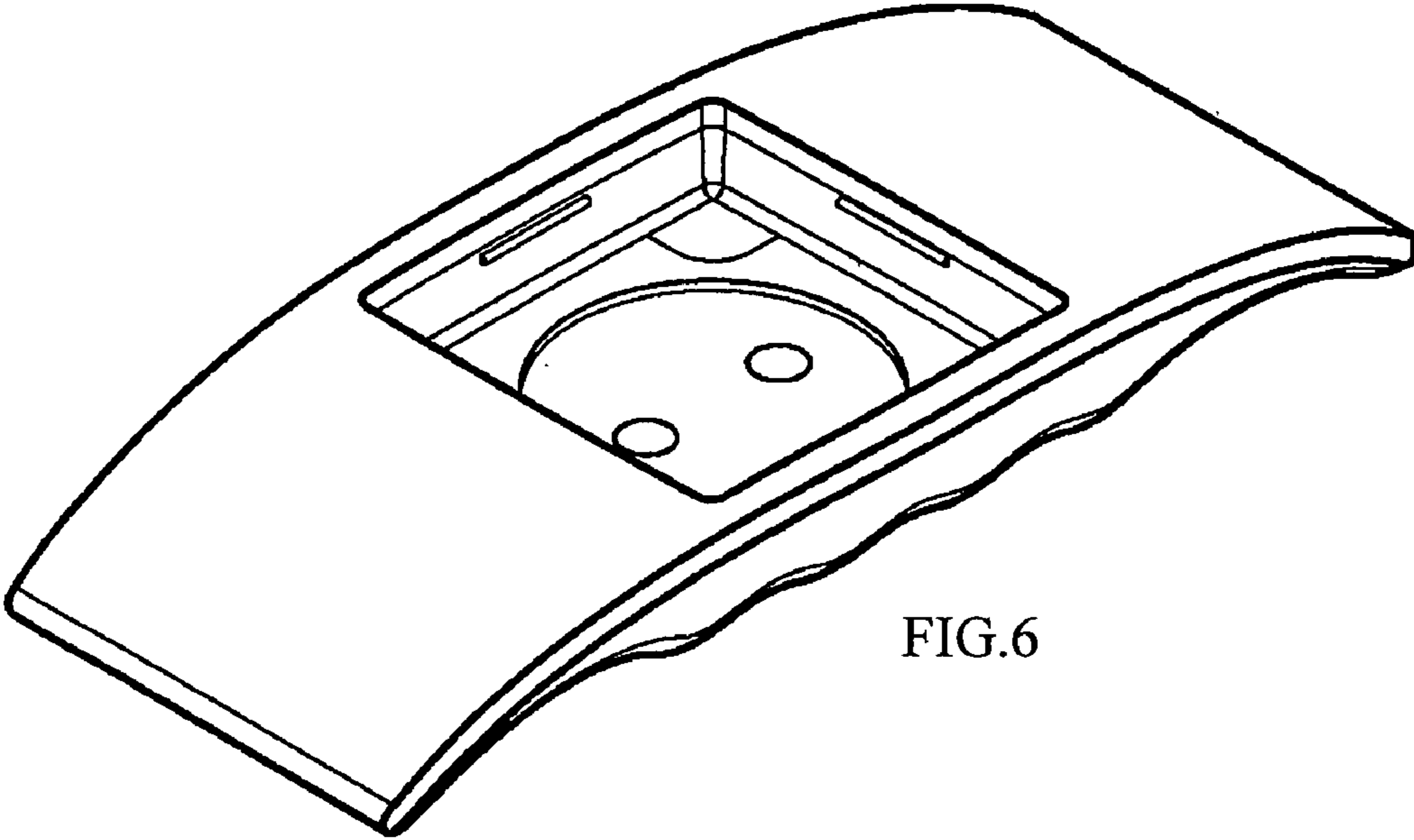
