**DESCRIPTION**

FIG. 4 is a rear view of the salt generator control station of FIG. 1;

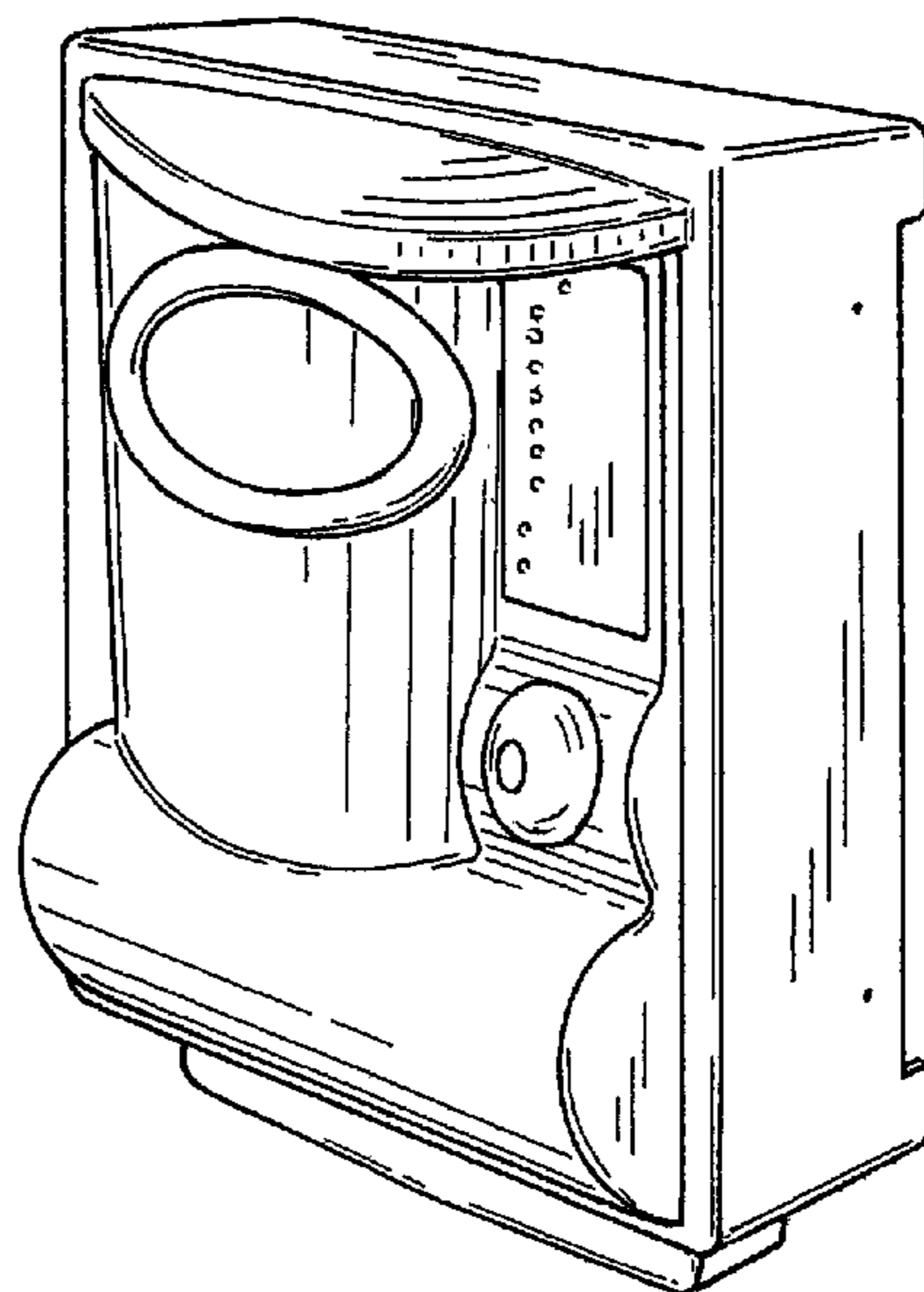
FIG. 5 is a left side view of the salt generator control station of FIG. 1;

FIG. 6 is a top view of the salt generator control station of FIG. 1; and,

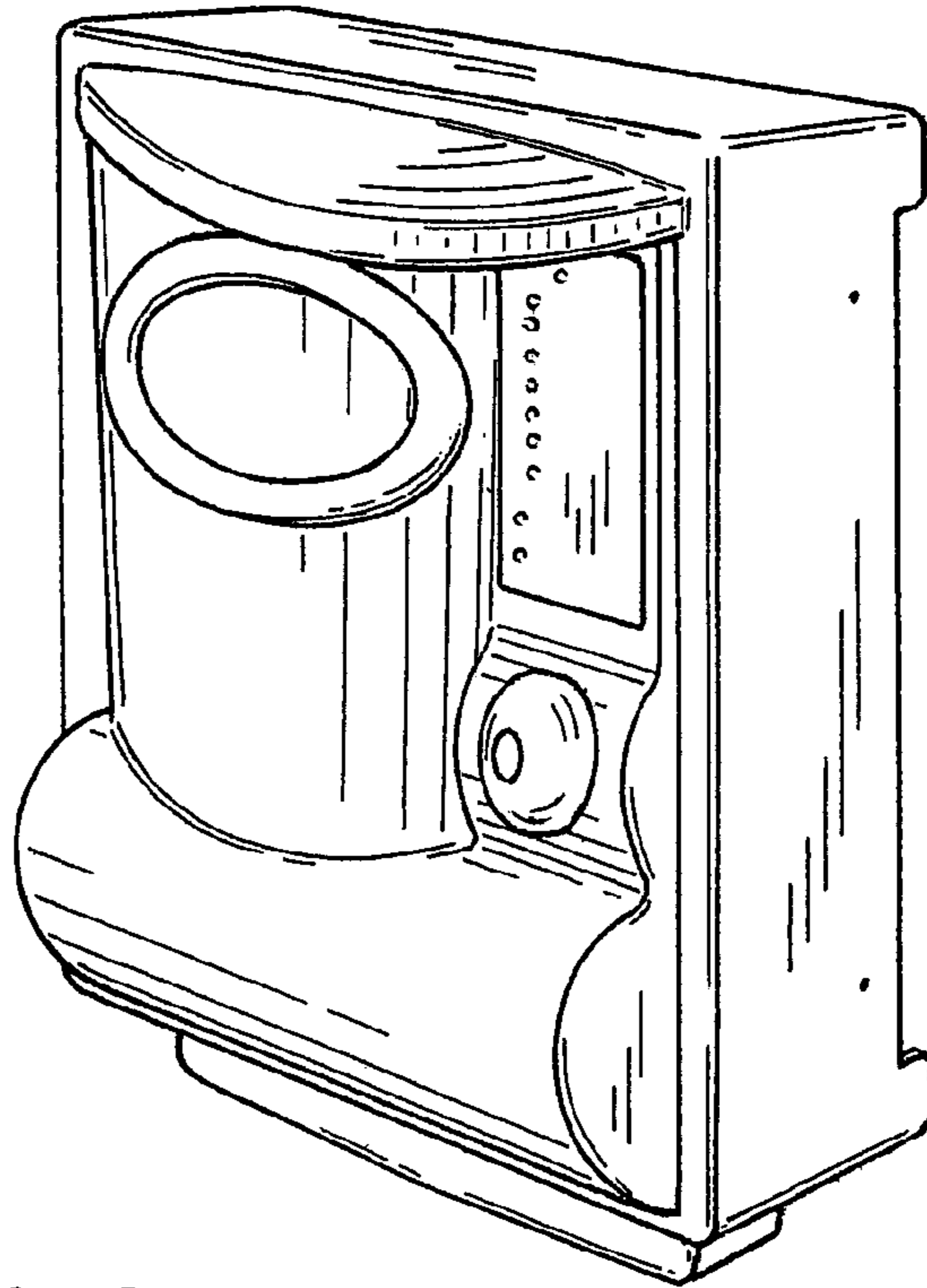
FIG. 7 is a bottom view of the salt generator control station of FIG. 1.

The broken line showing of portions of the rear of the salt generator control station is included for illustrative purposes only and forms no part of the claimed design.

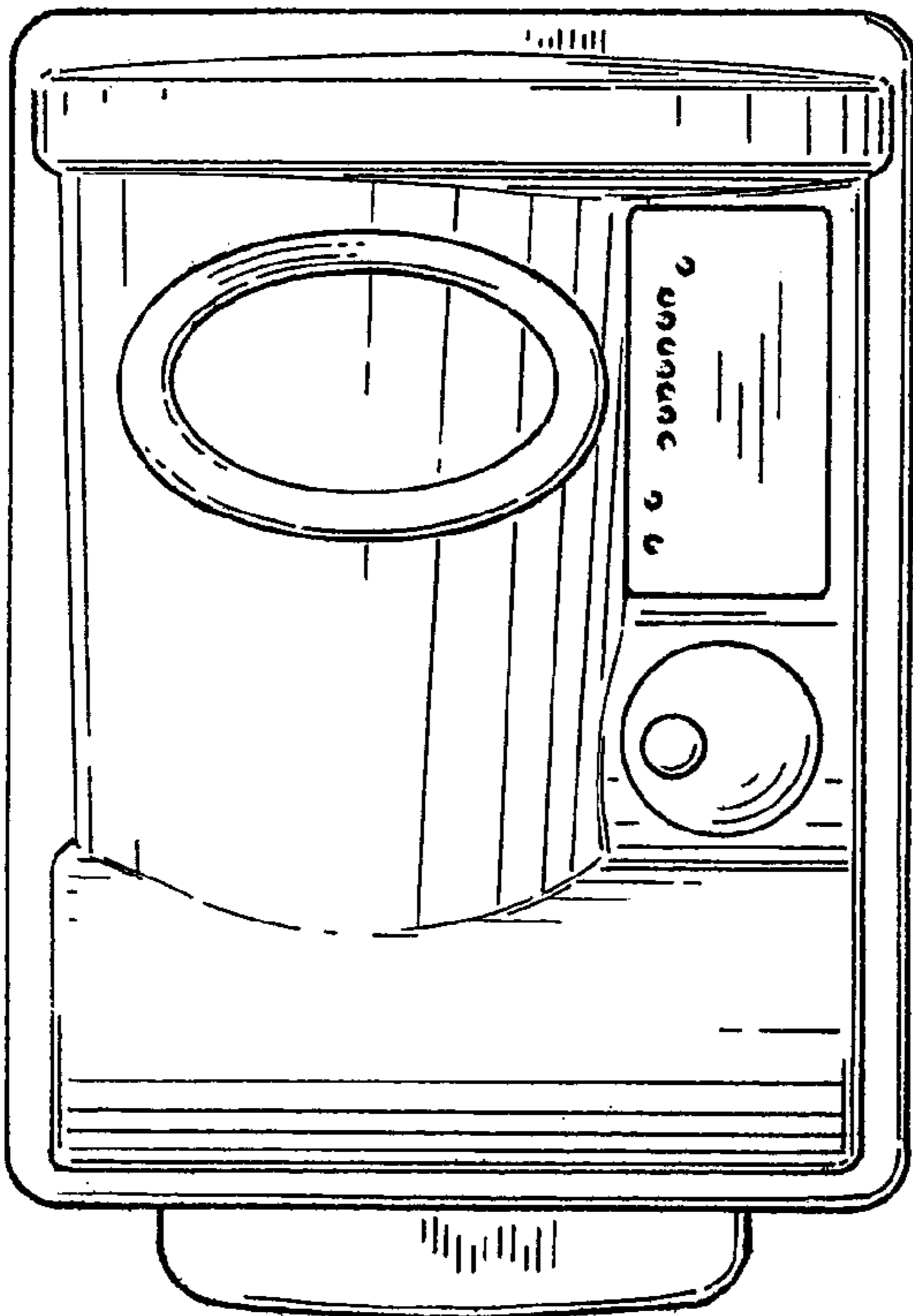

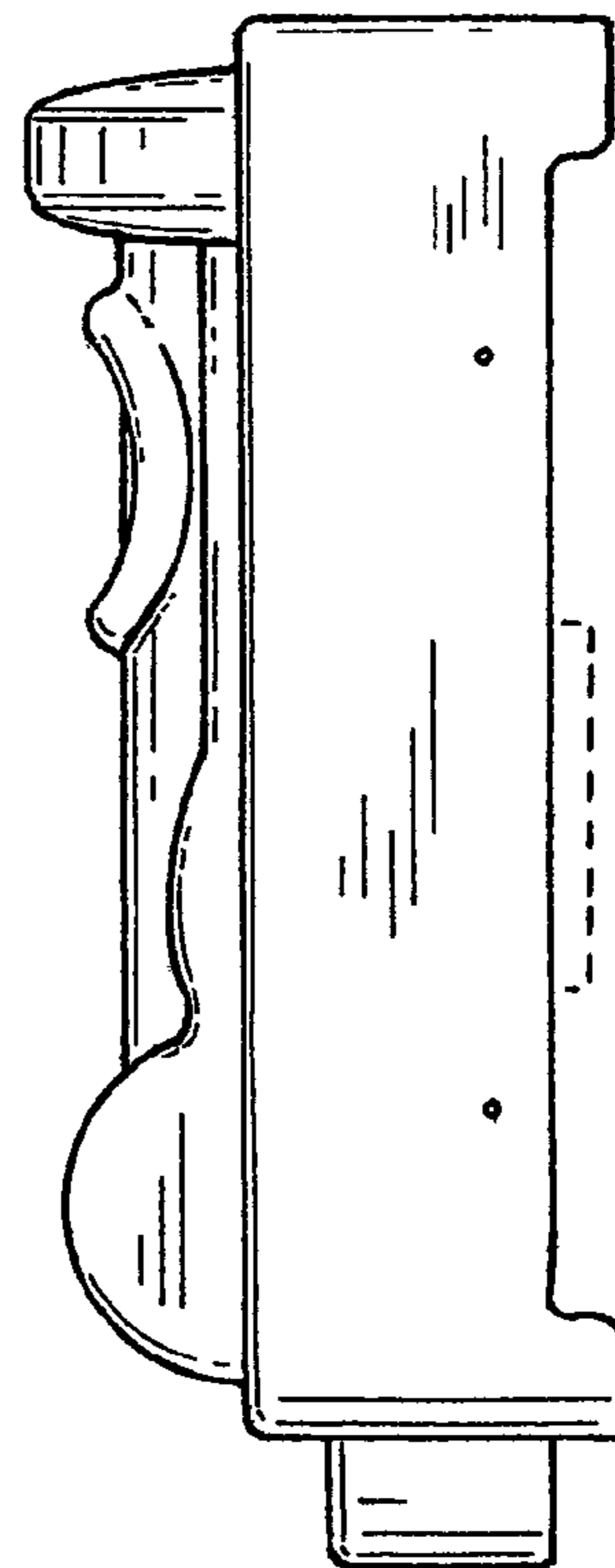

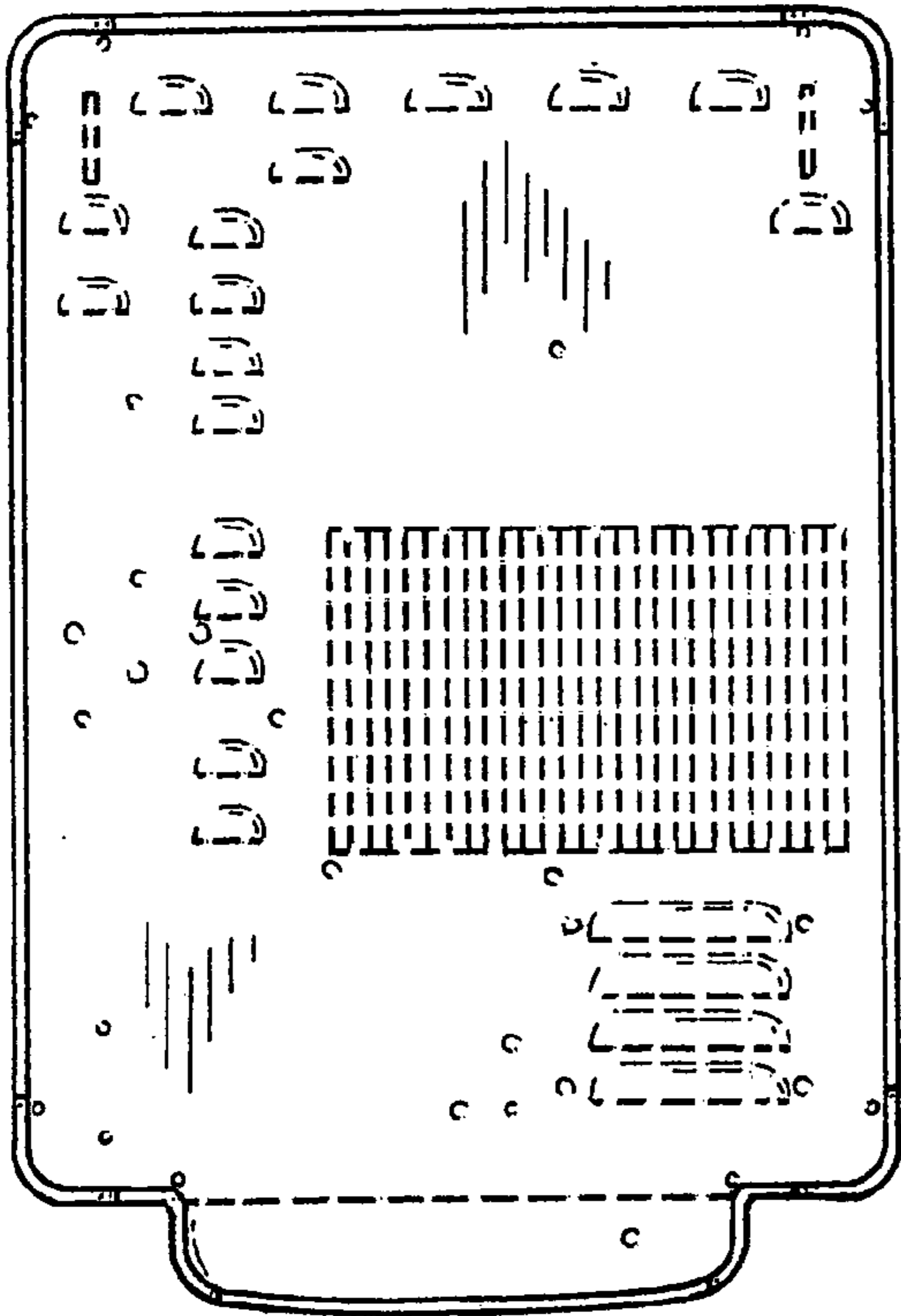

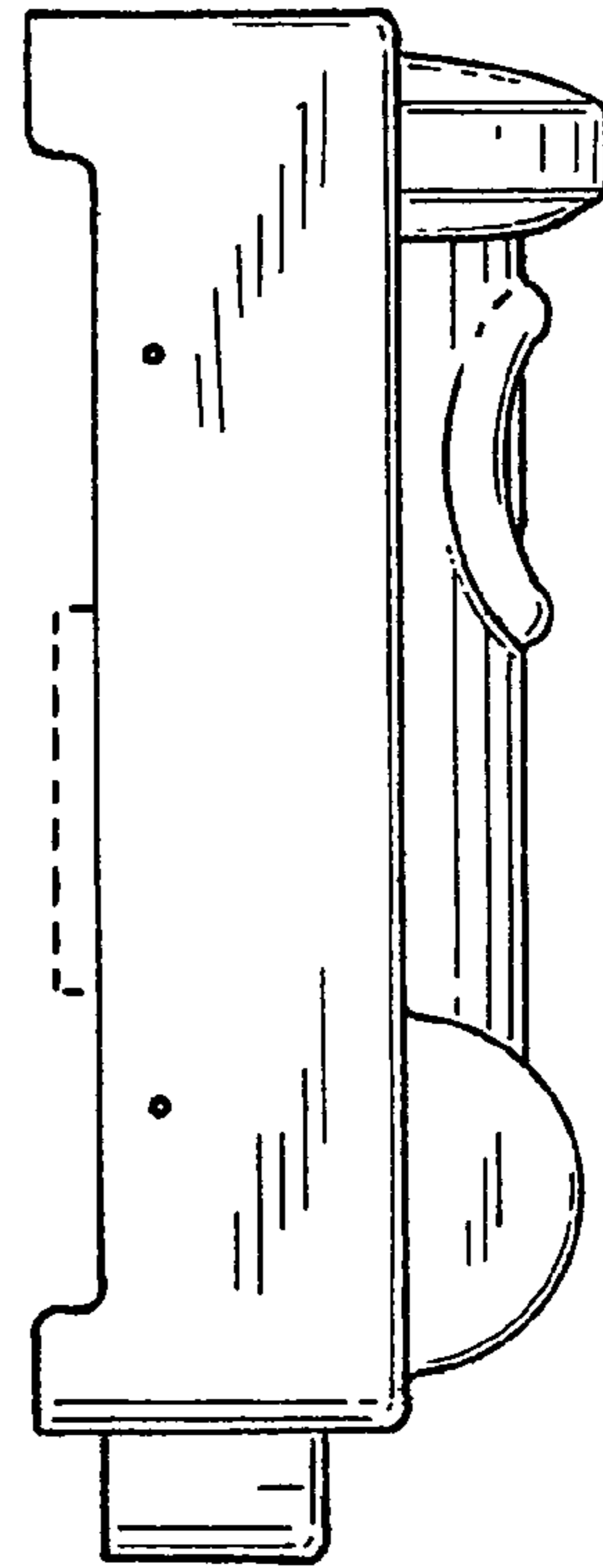

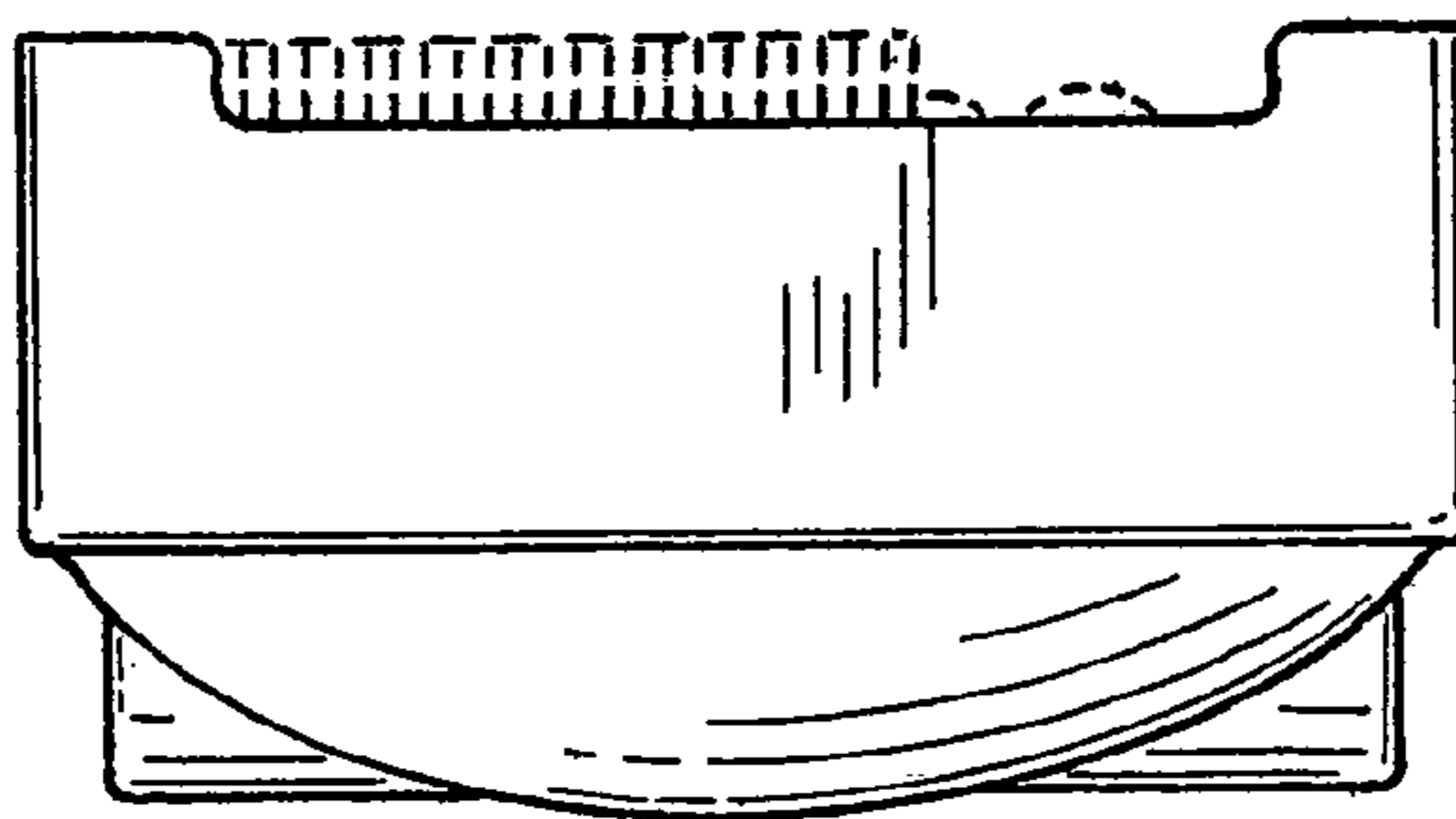
