FIG. 3 is a right lateral view FIG. 1 thereof;

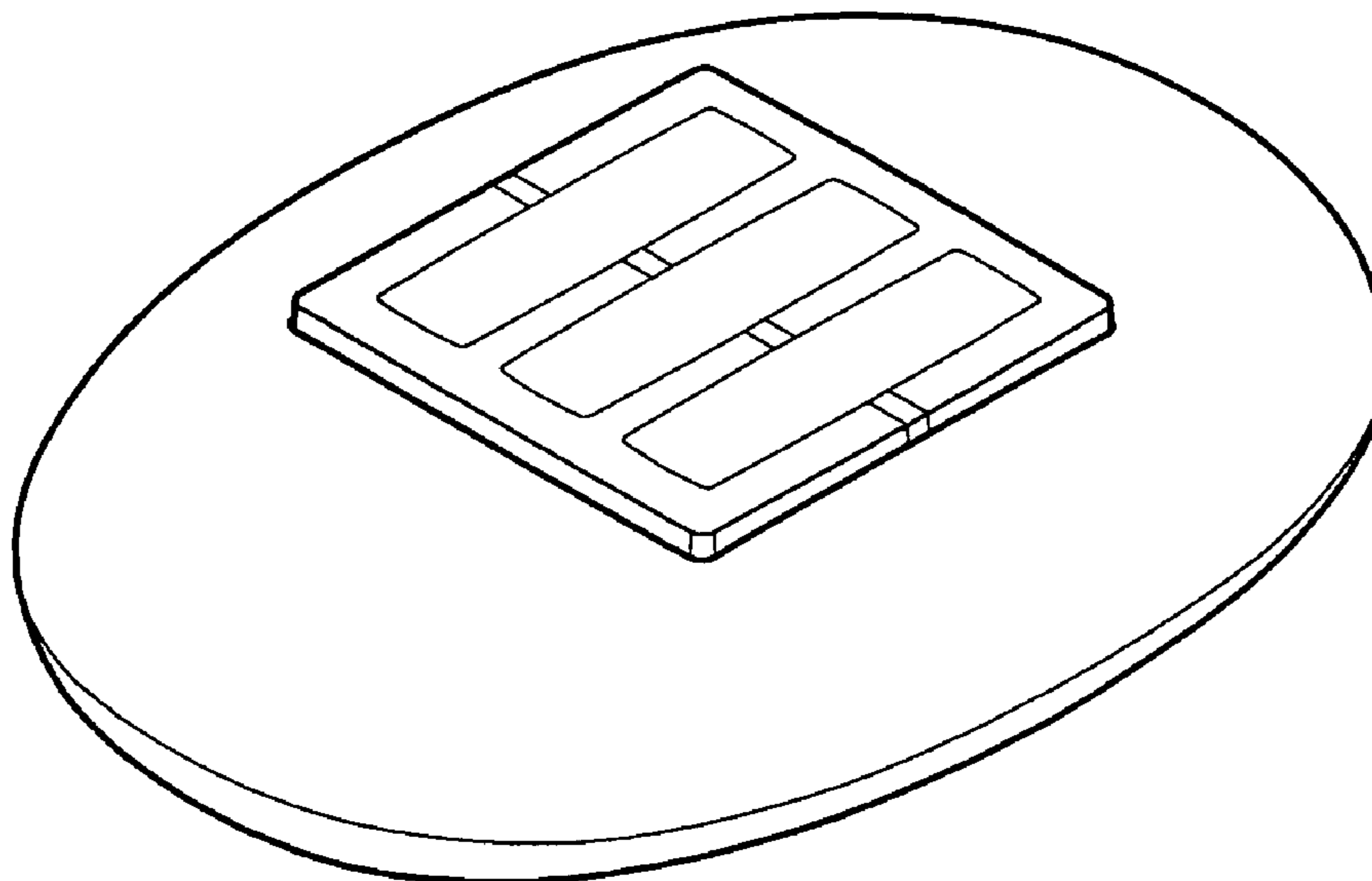
FIG. 4 is a left lateral view of FIG. 1 thereof;

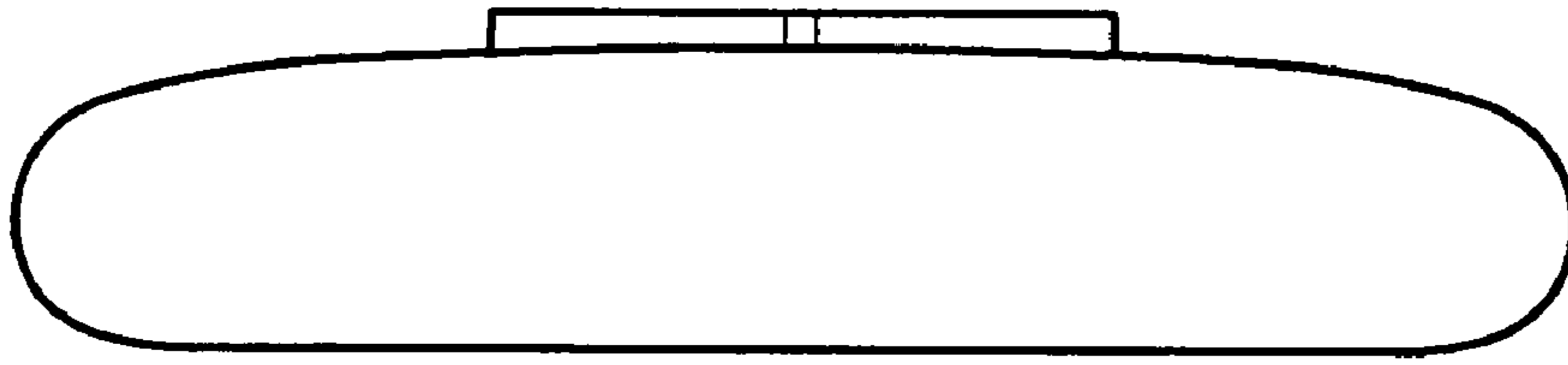

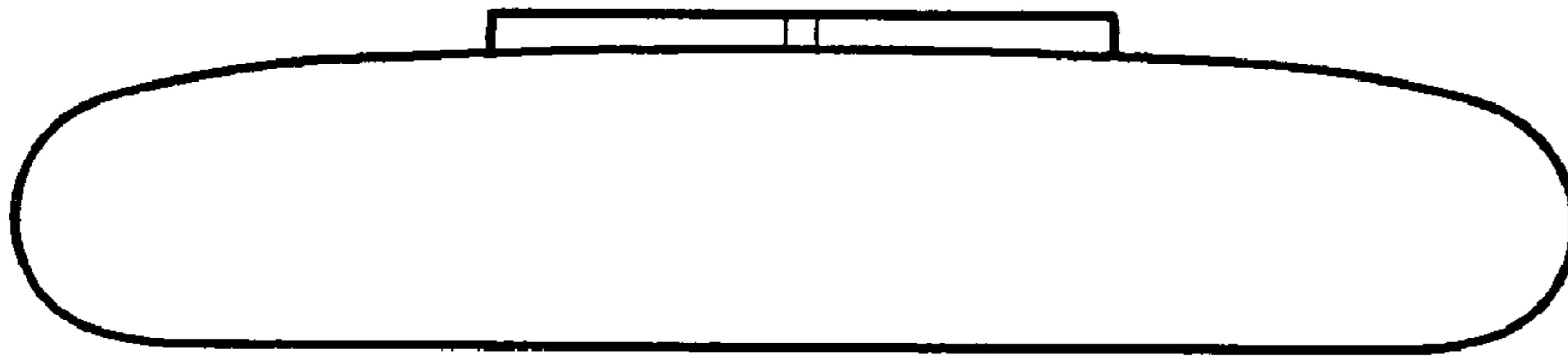

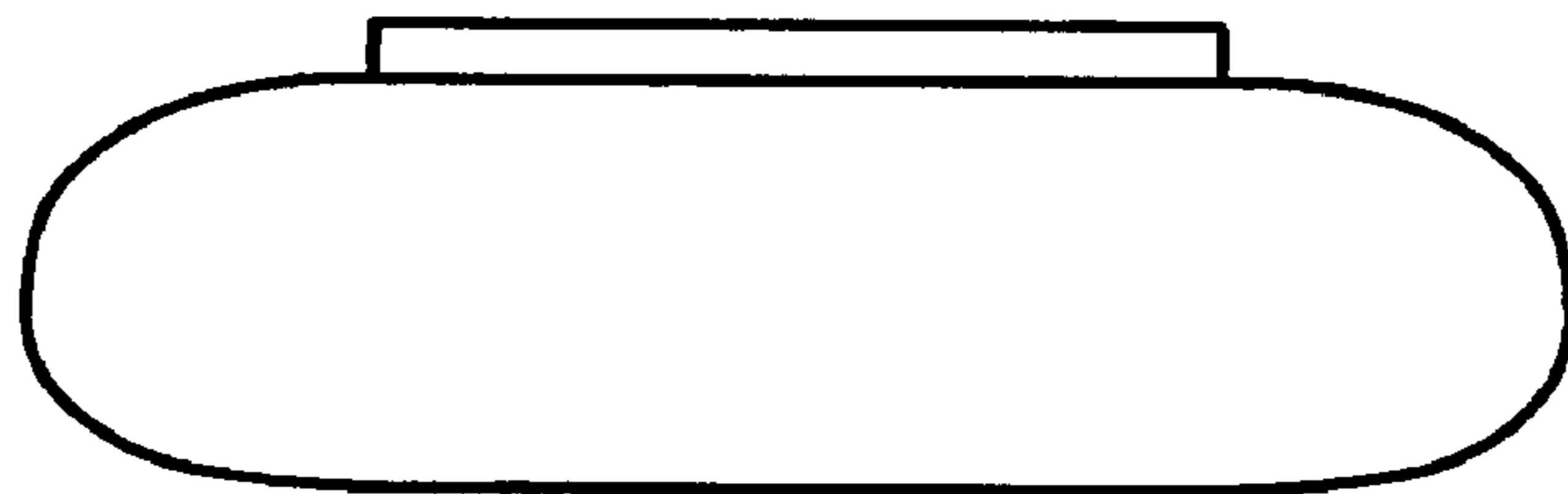

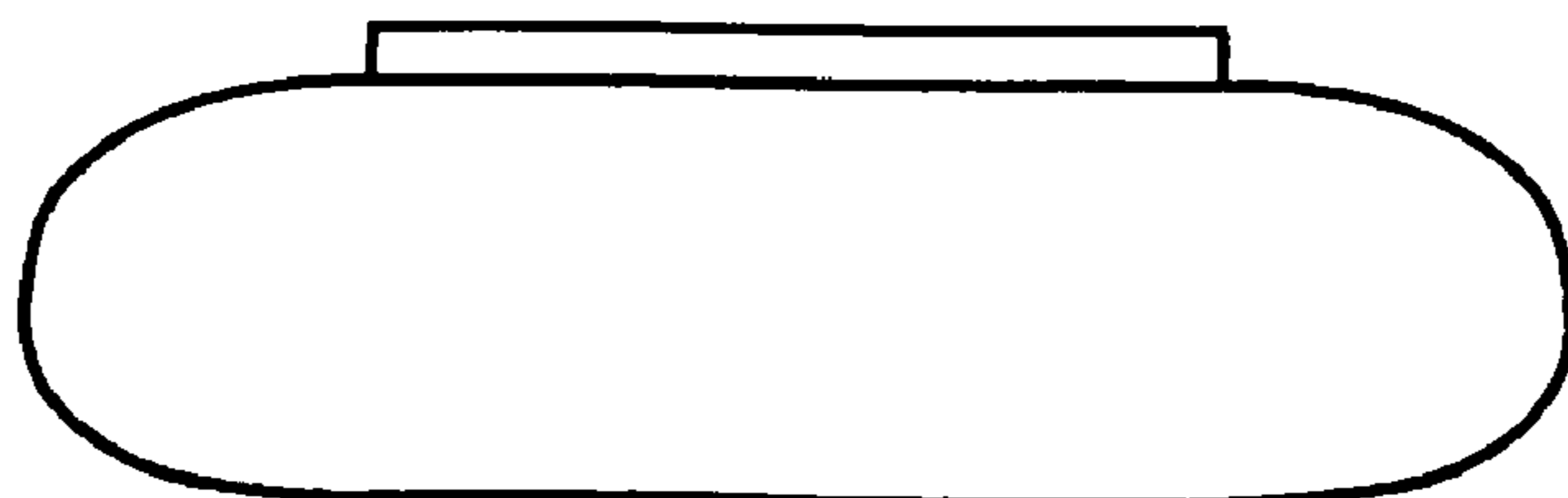

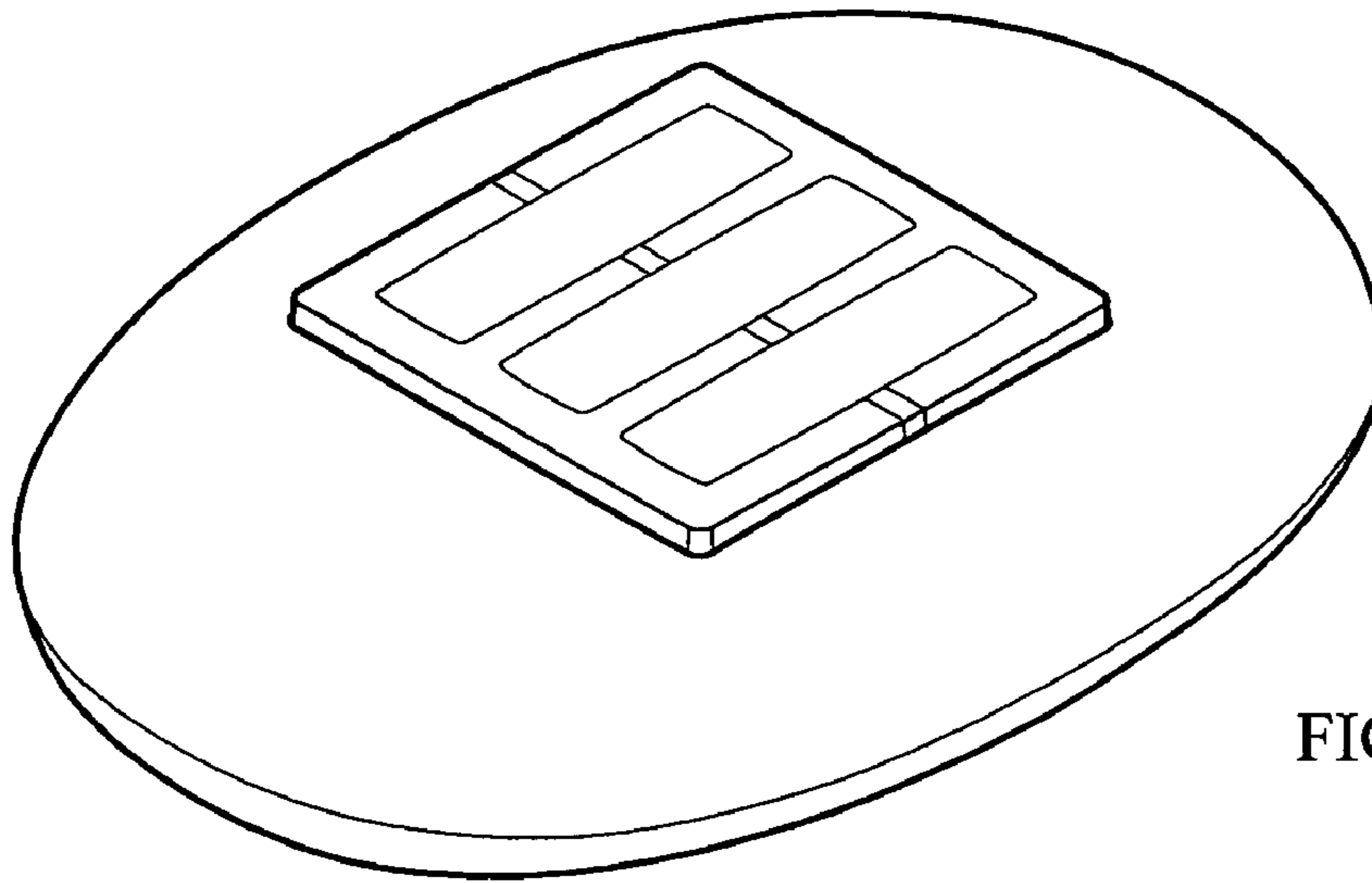

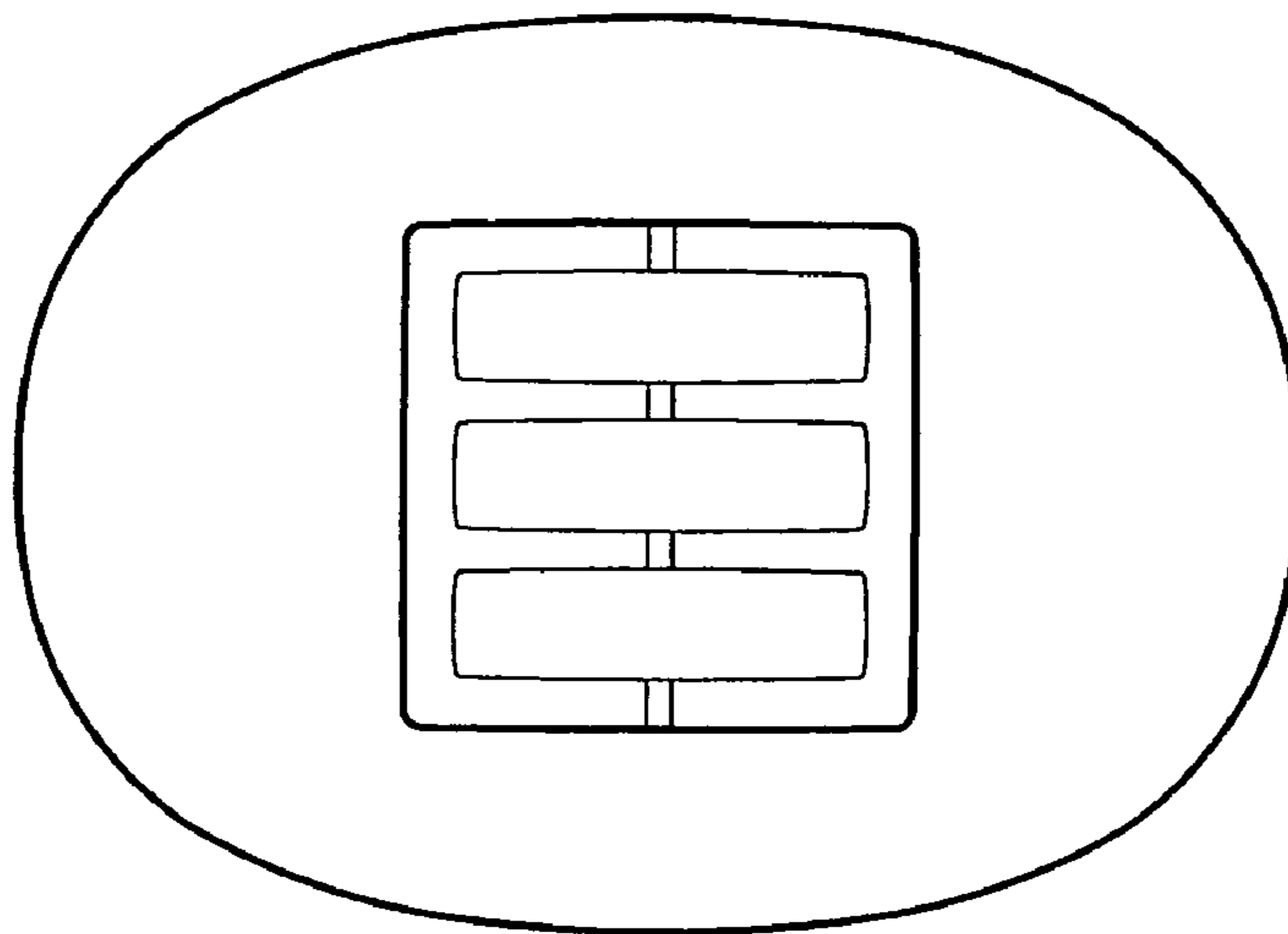

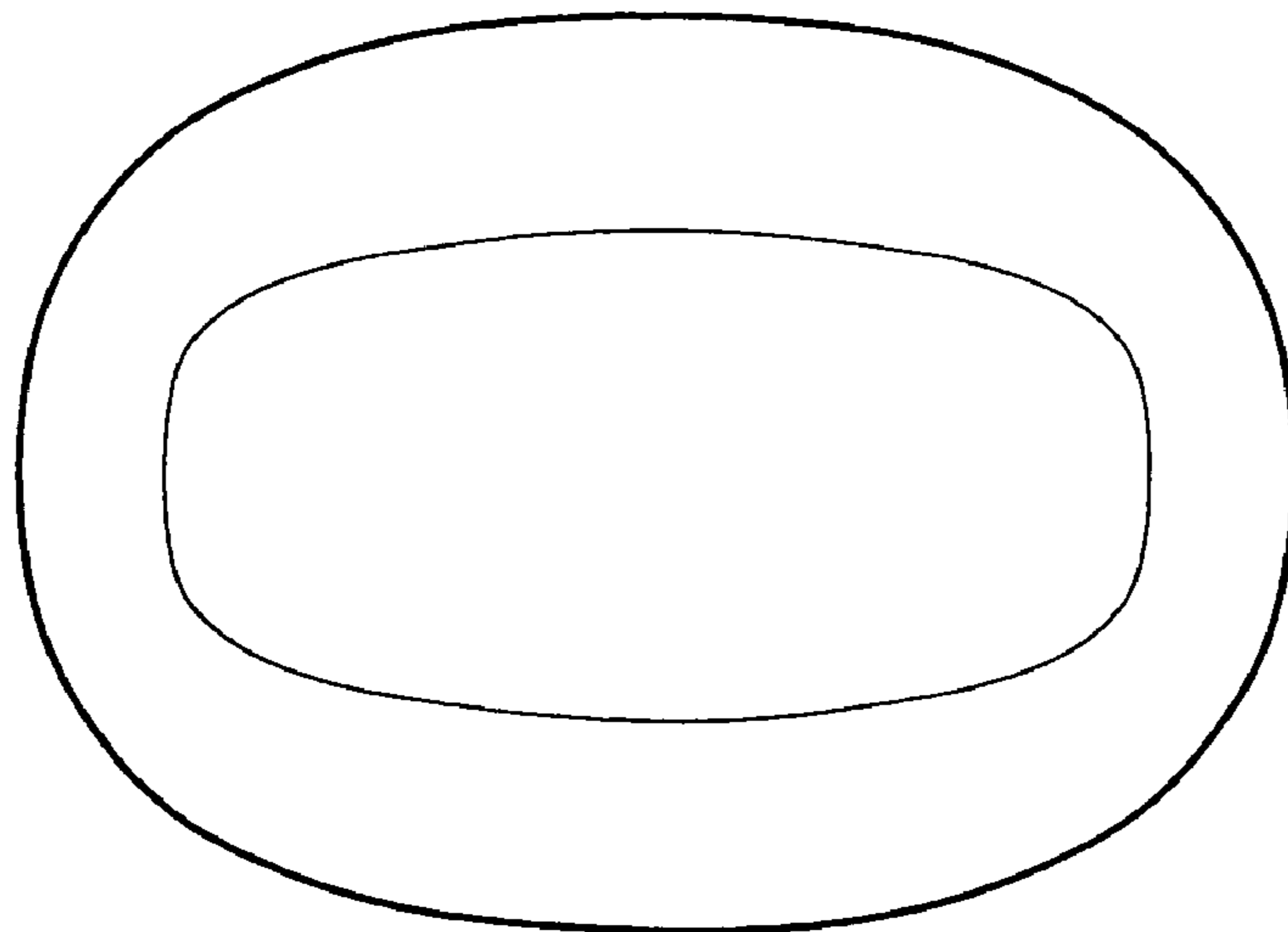
