through line 9-9 of the laminating machine of FIG. 1;

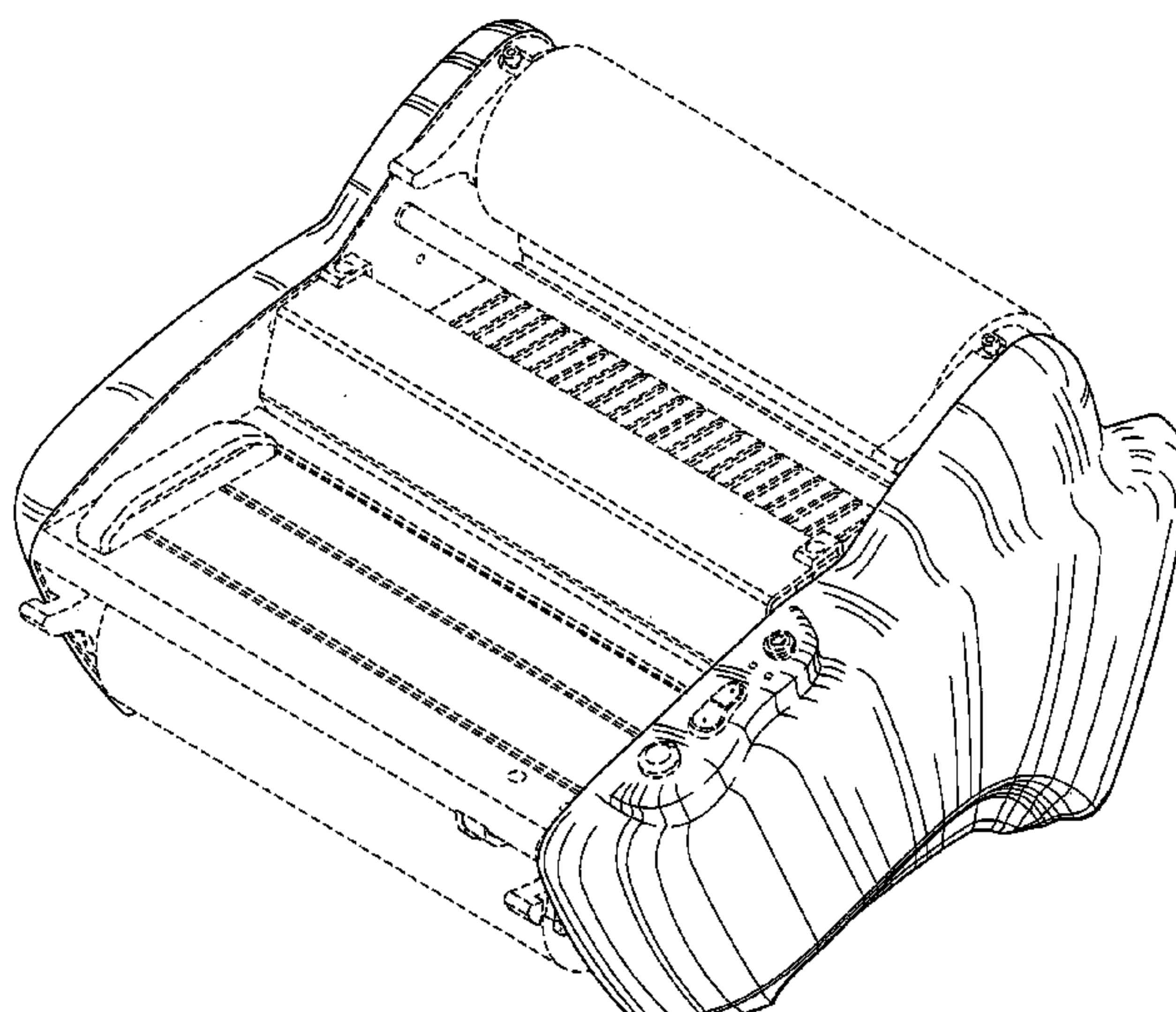


FIG. 10 is an enlarged fragmentary cross-sectional view taken through line 10-10 of the laminating machine of FIG. 1;

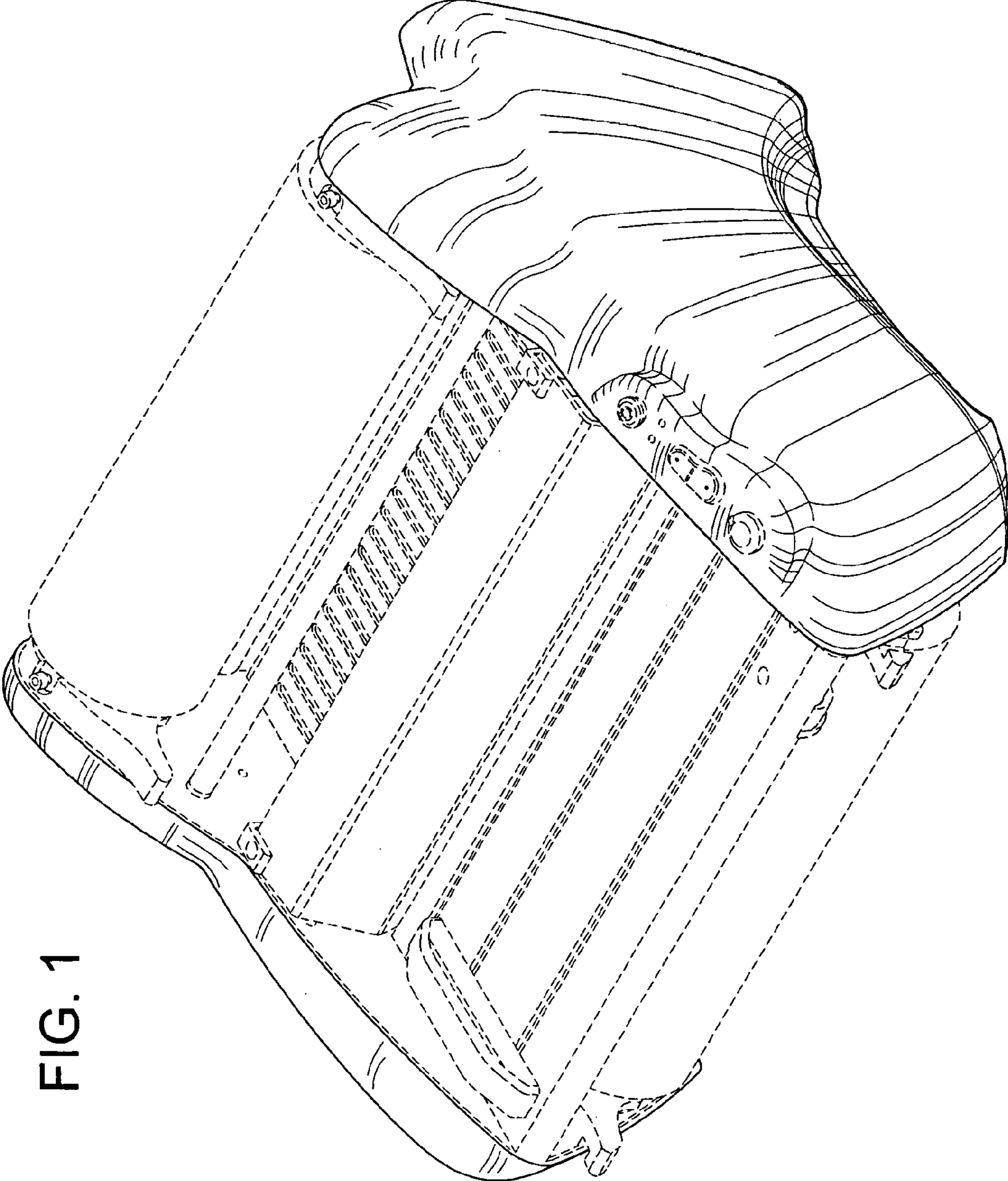

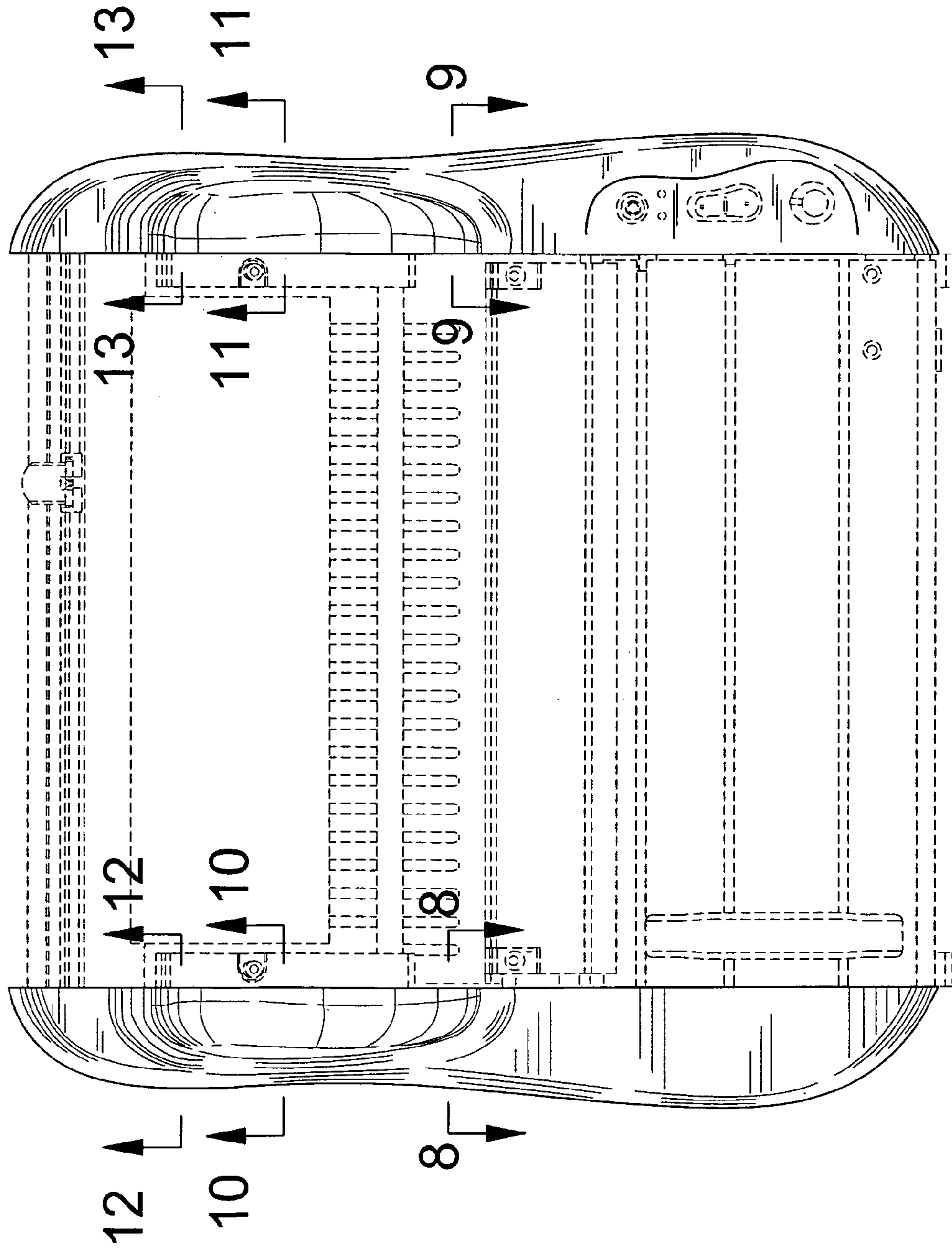
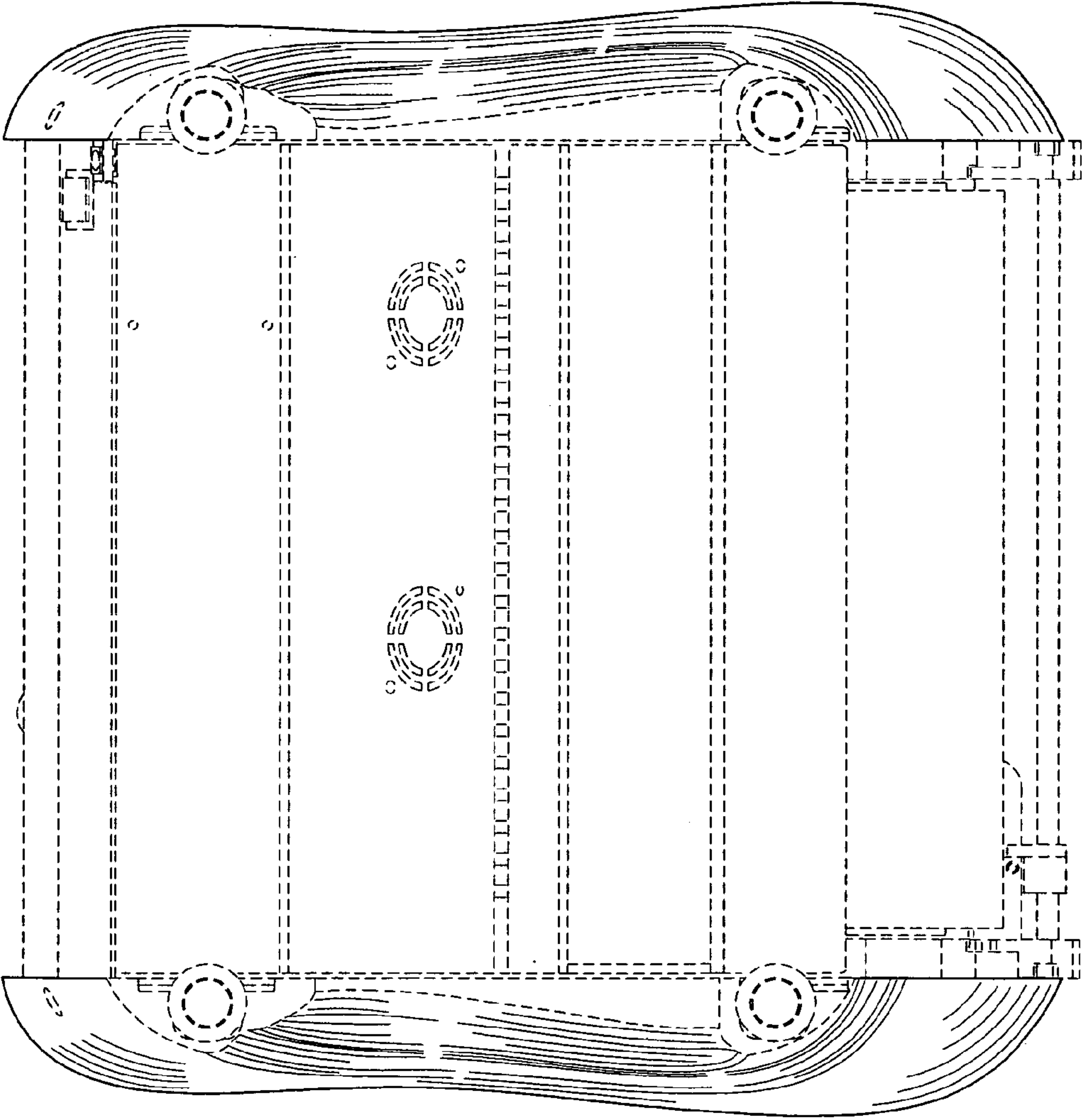

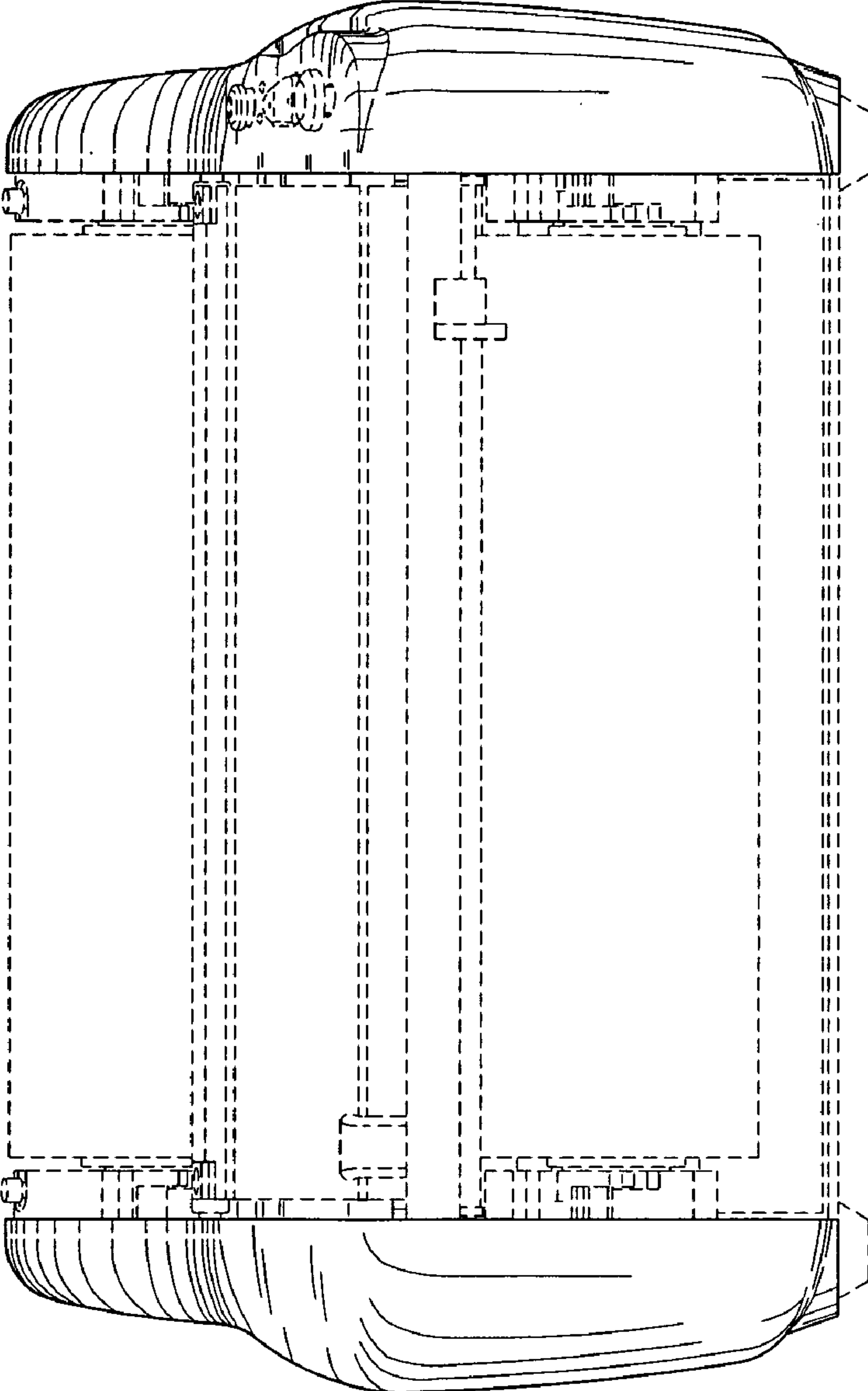
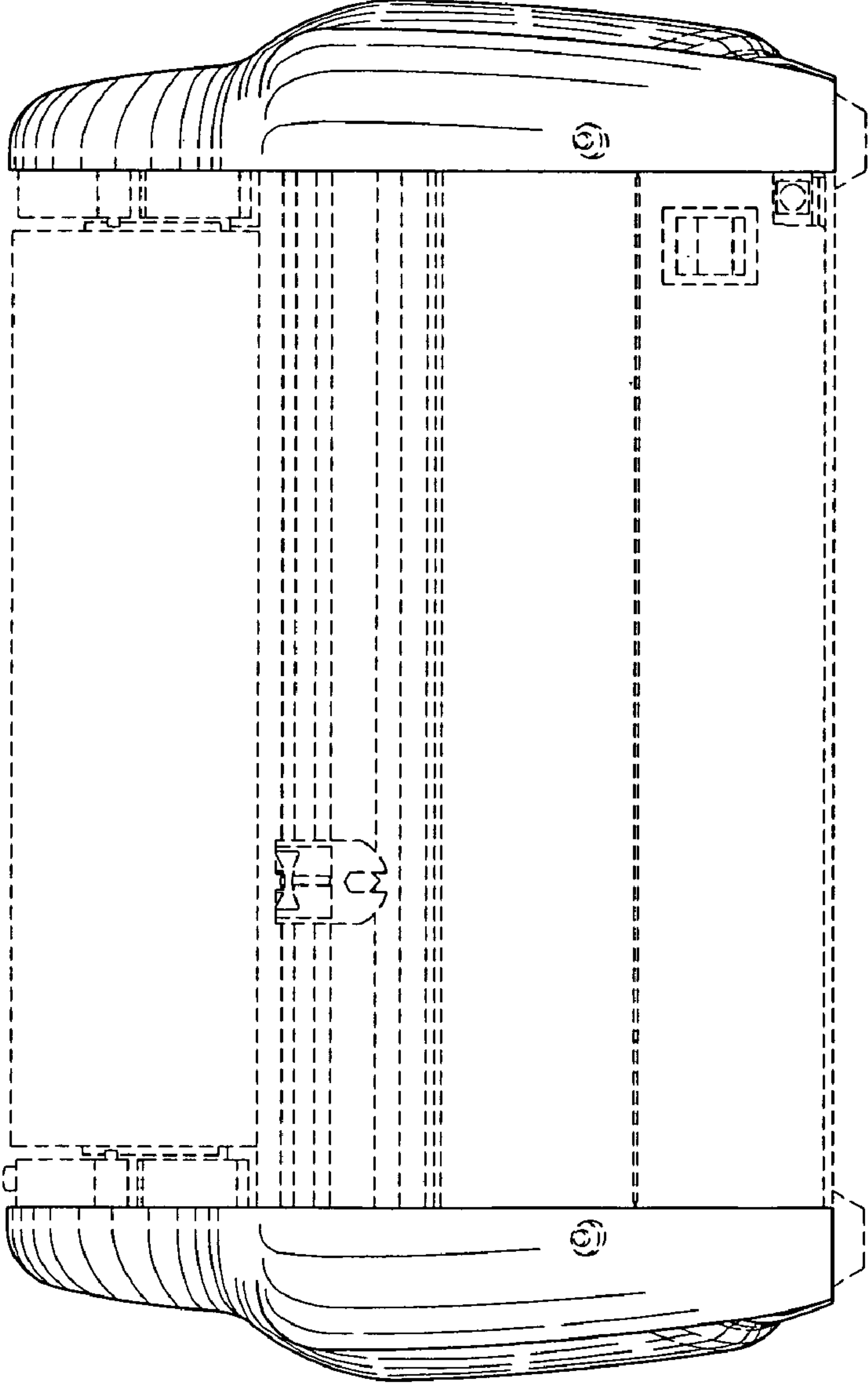

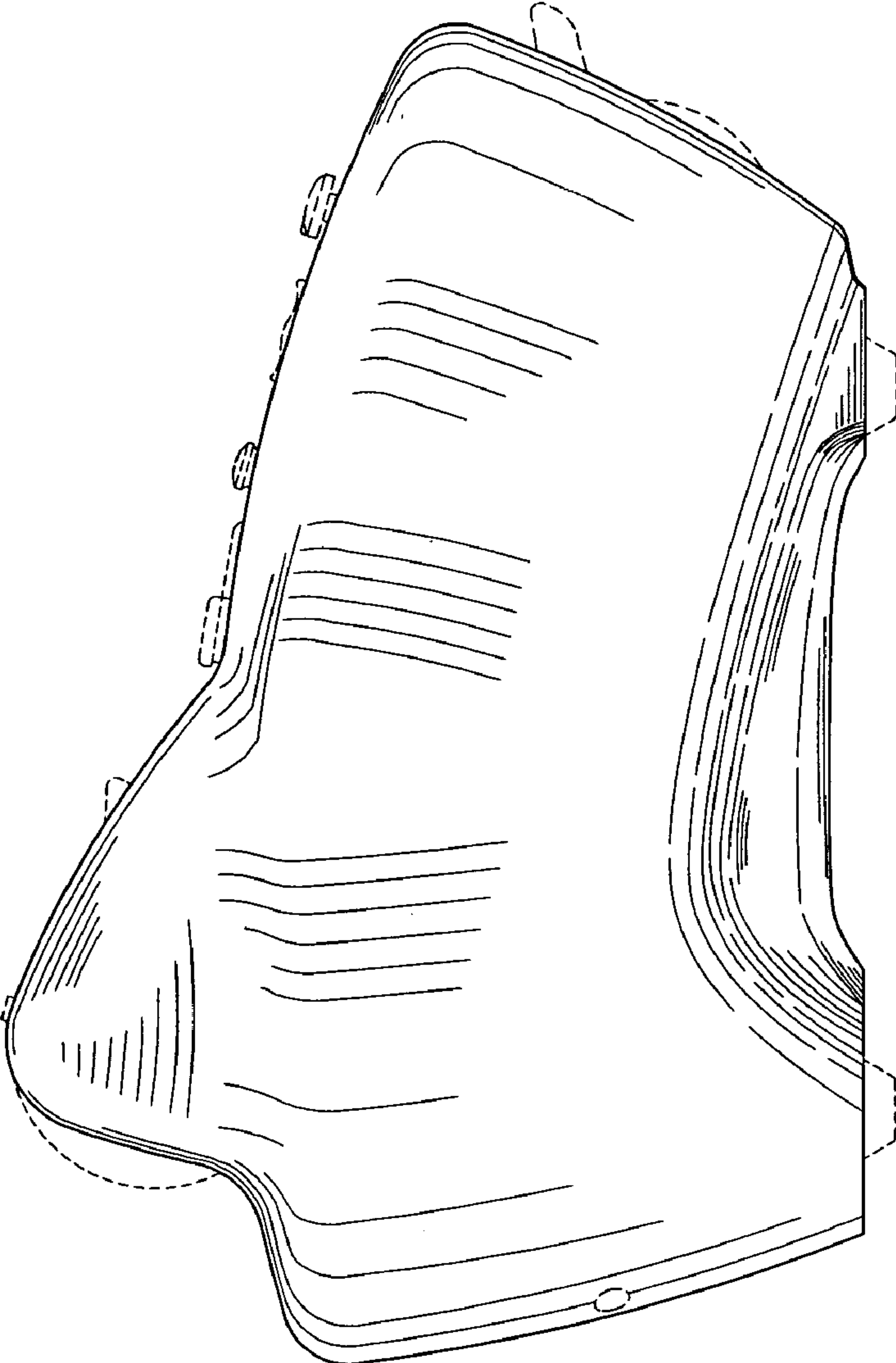
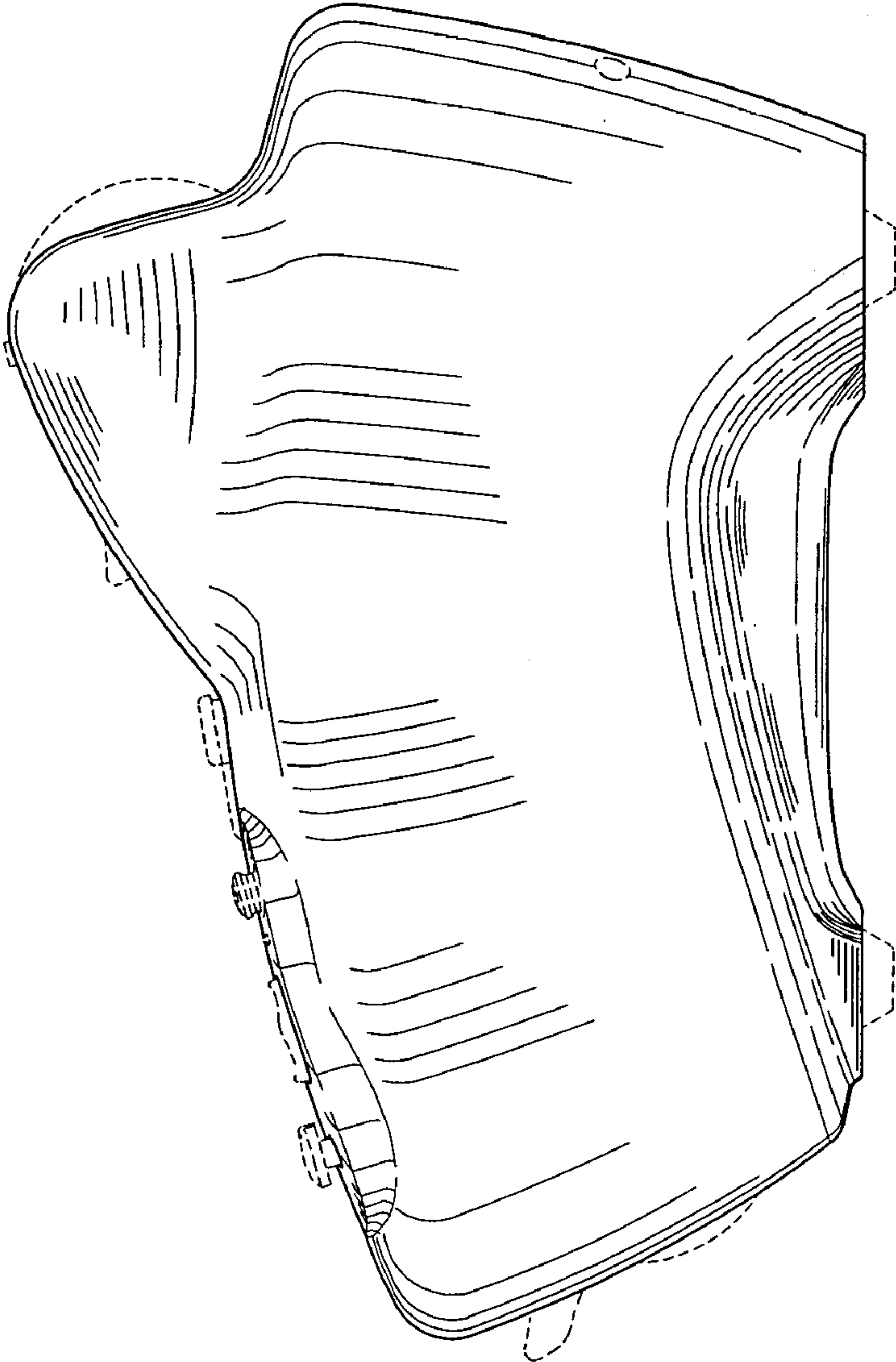

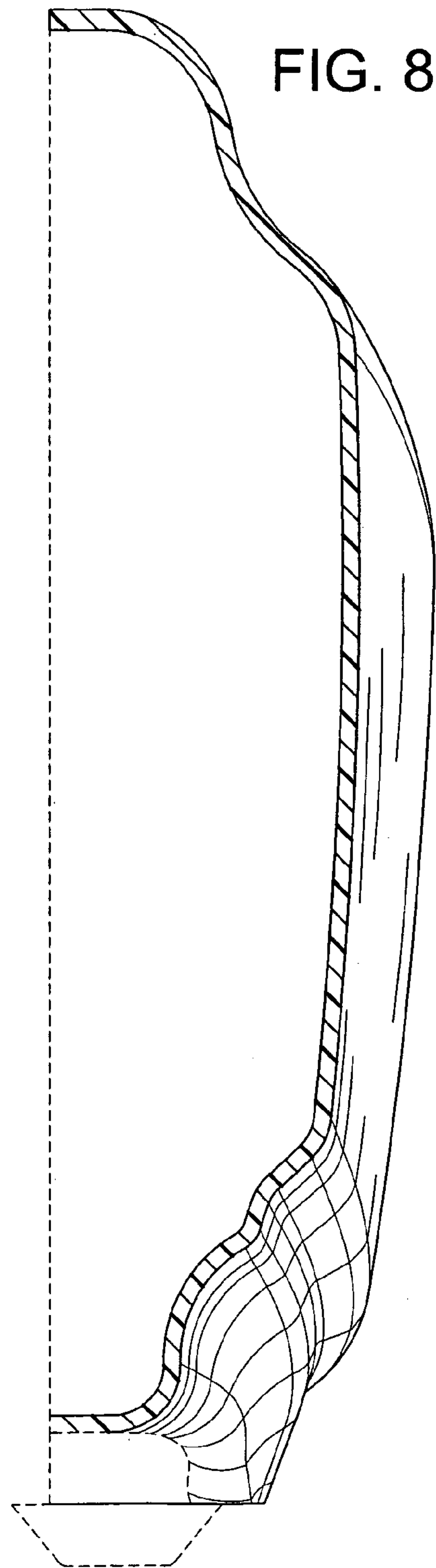
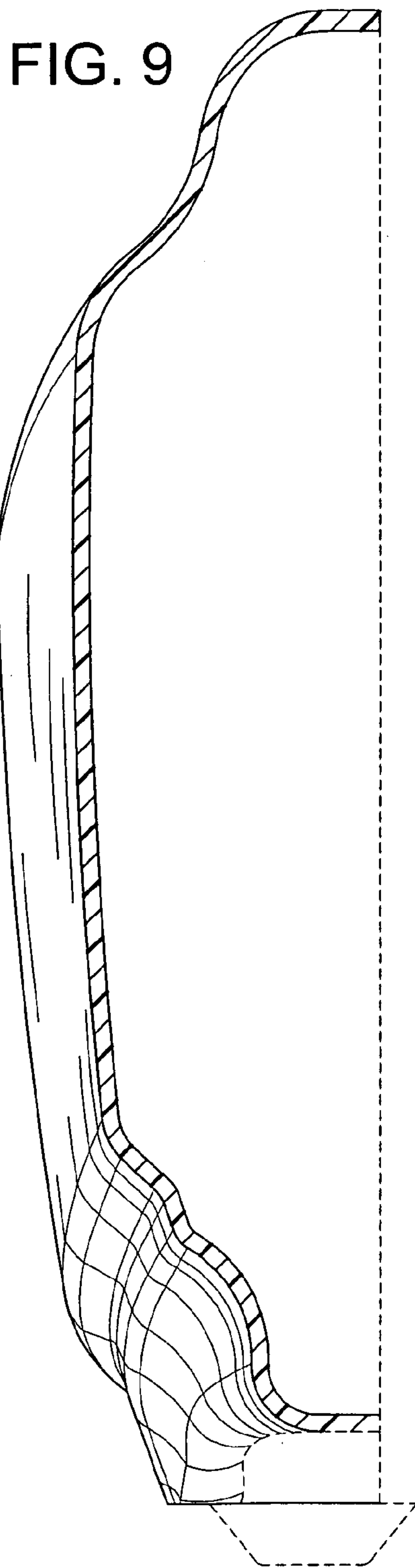

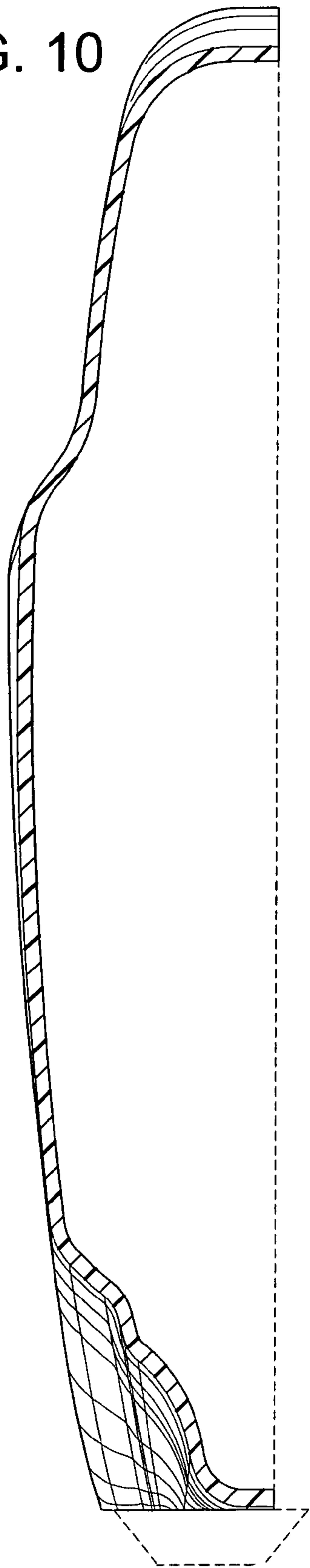

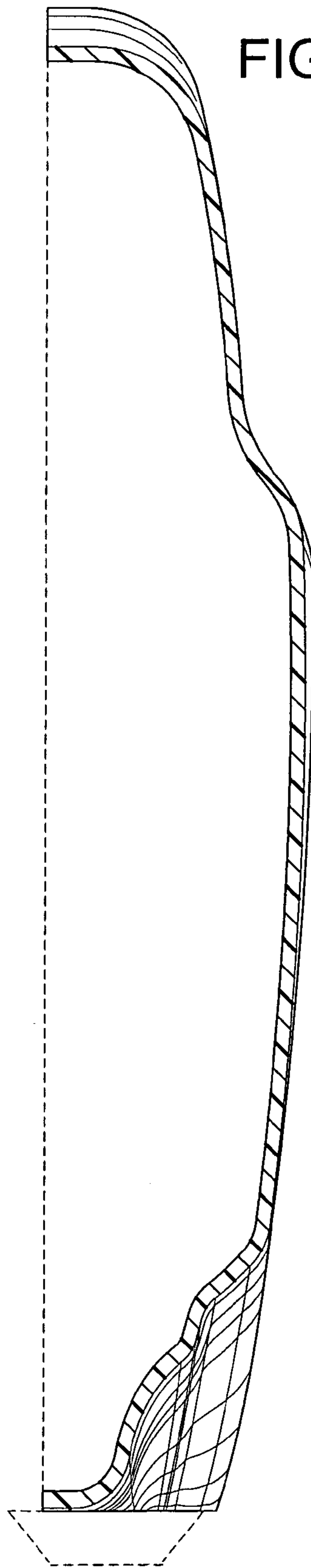

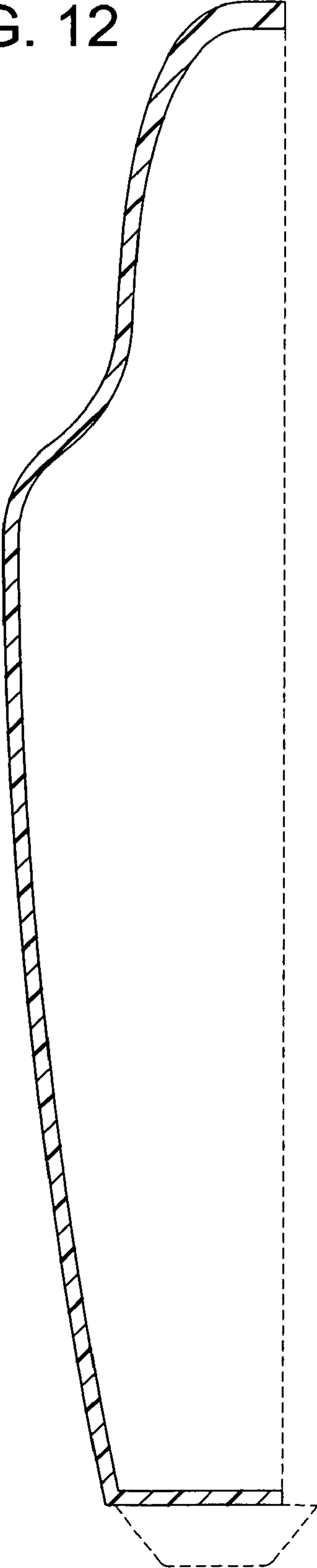
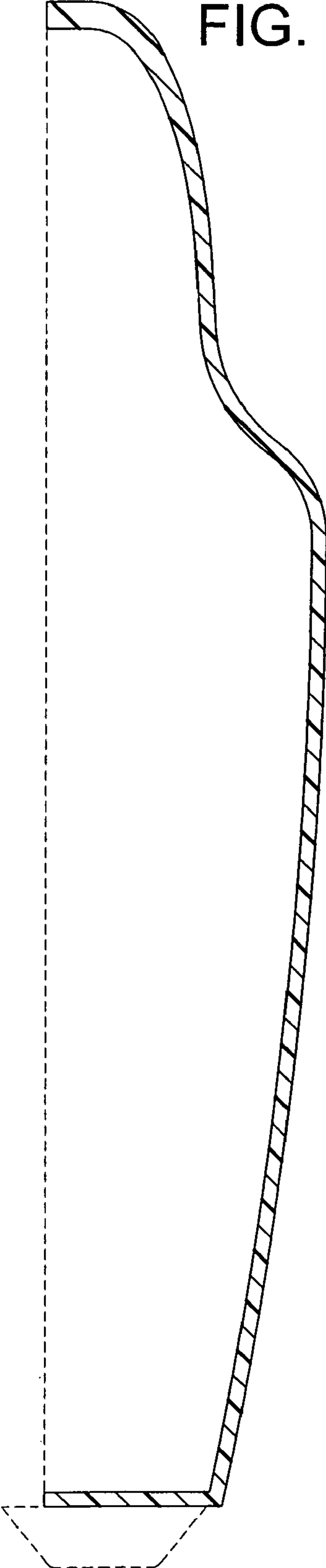

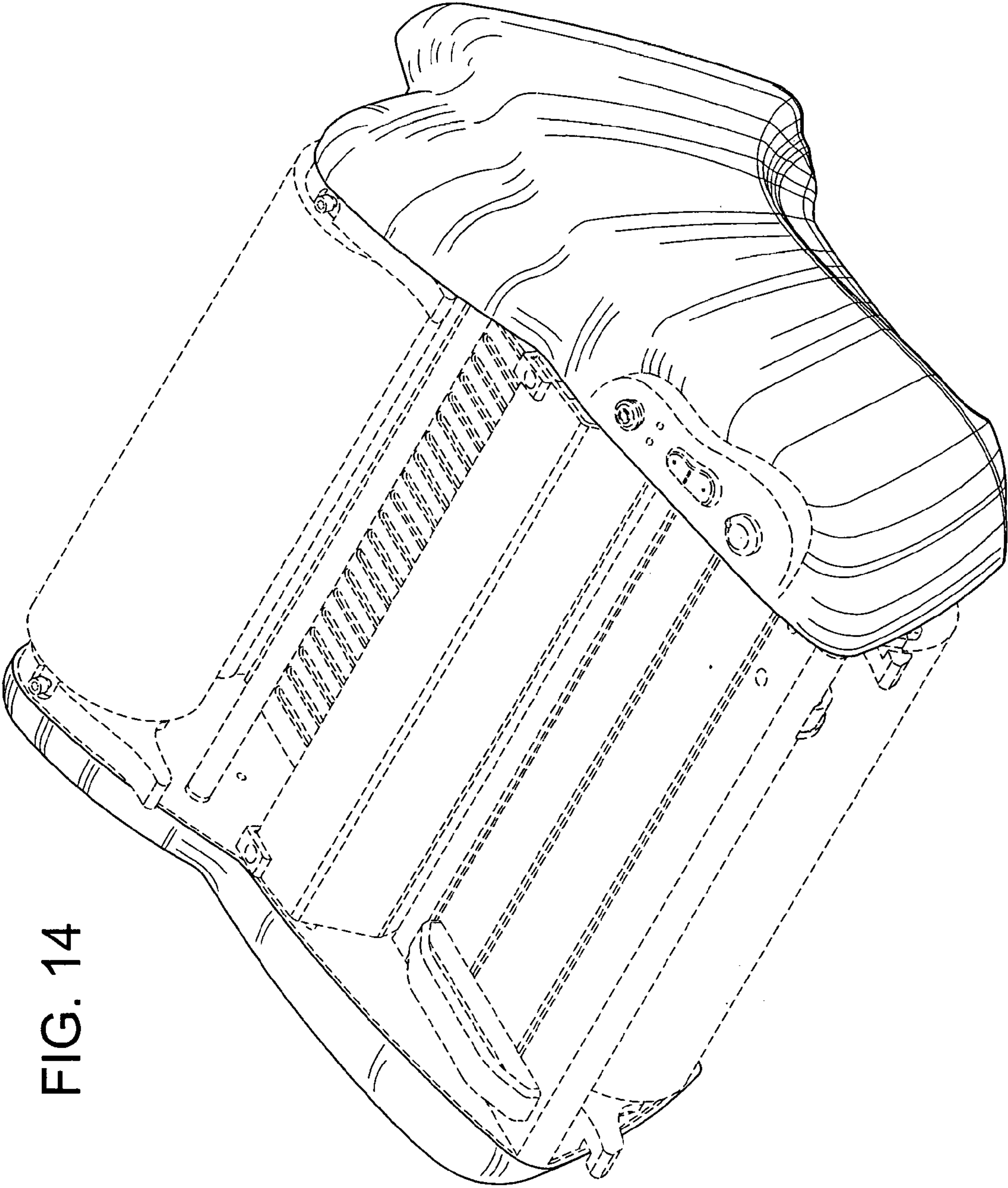

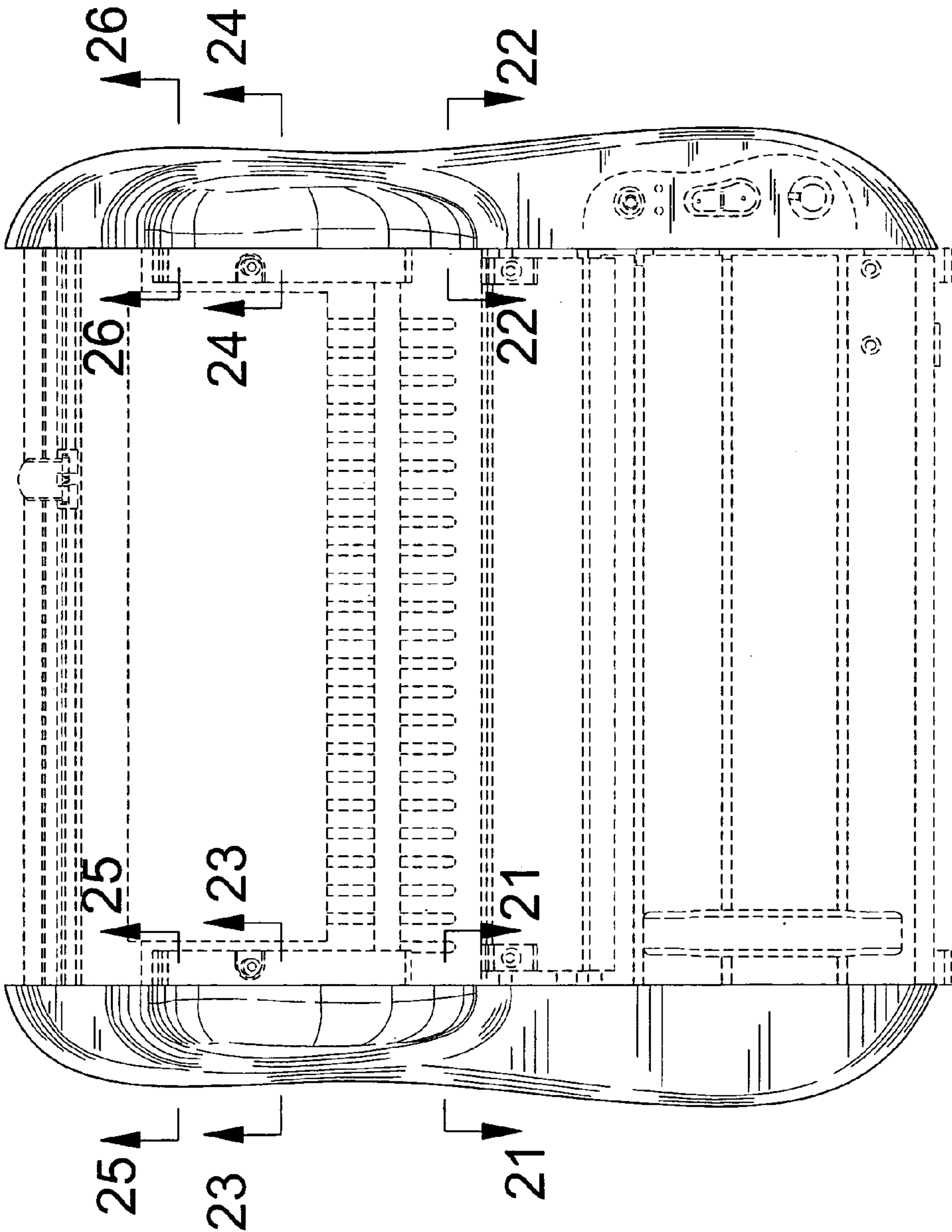

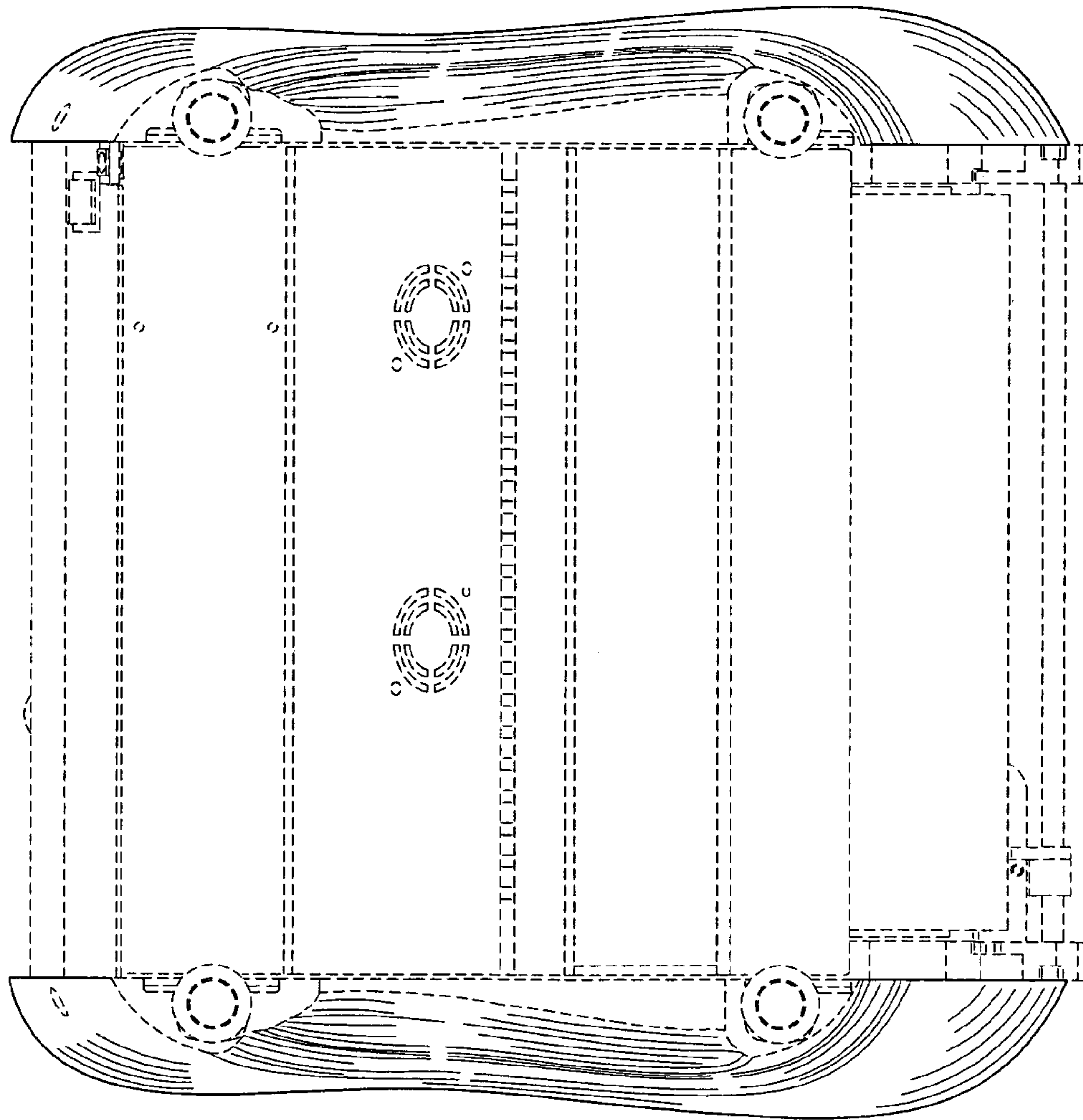

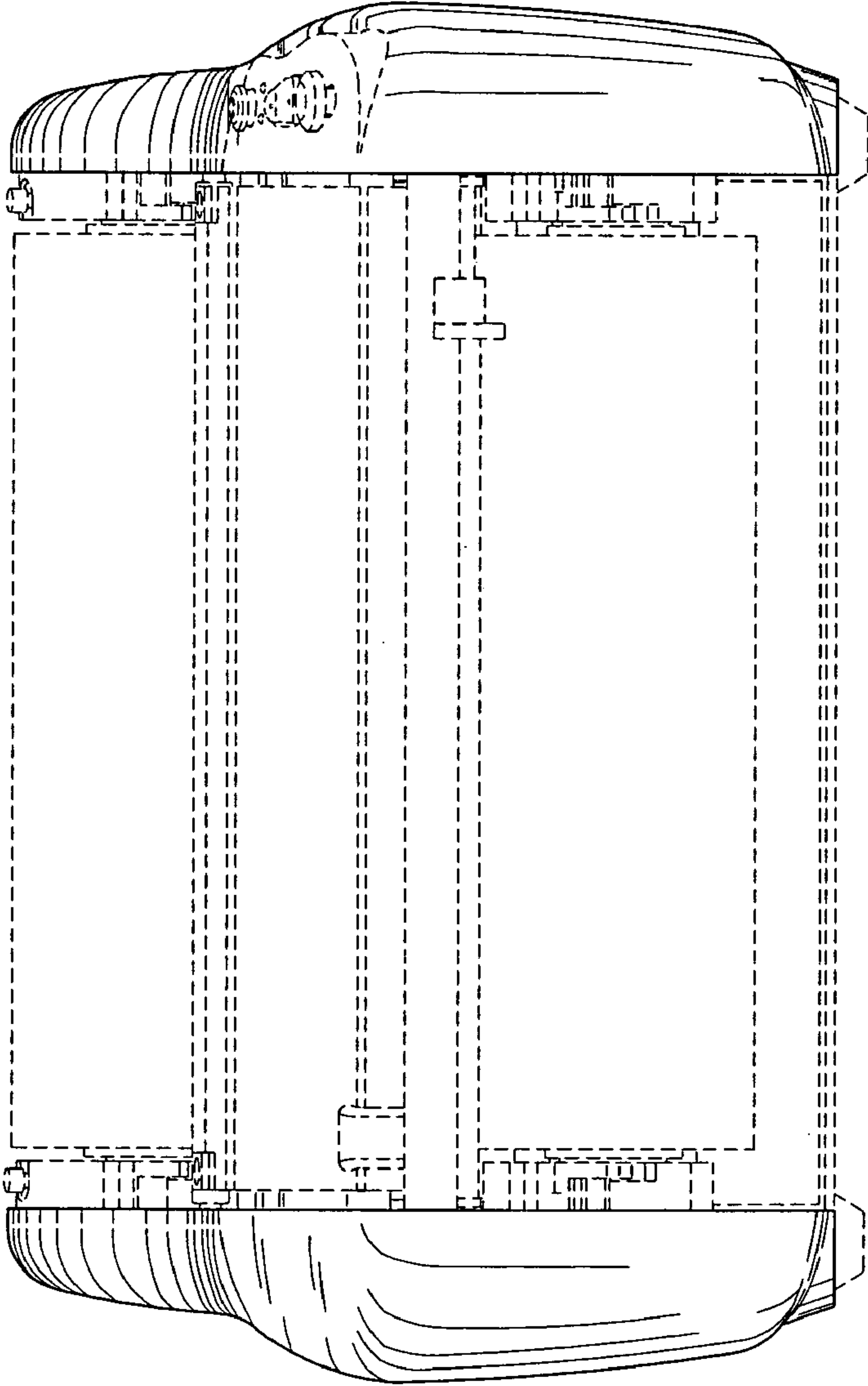
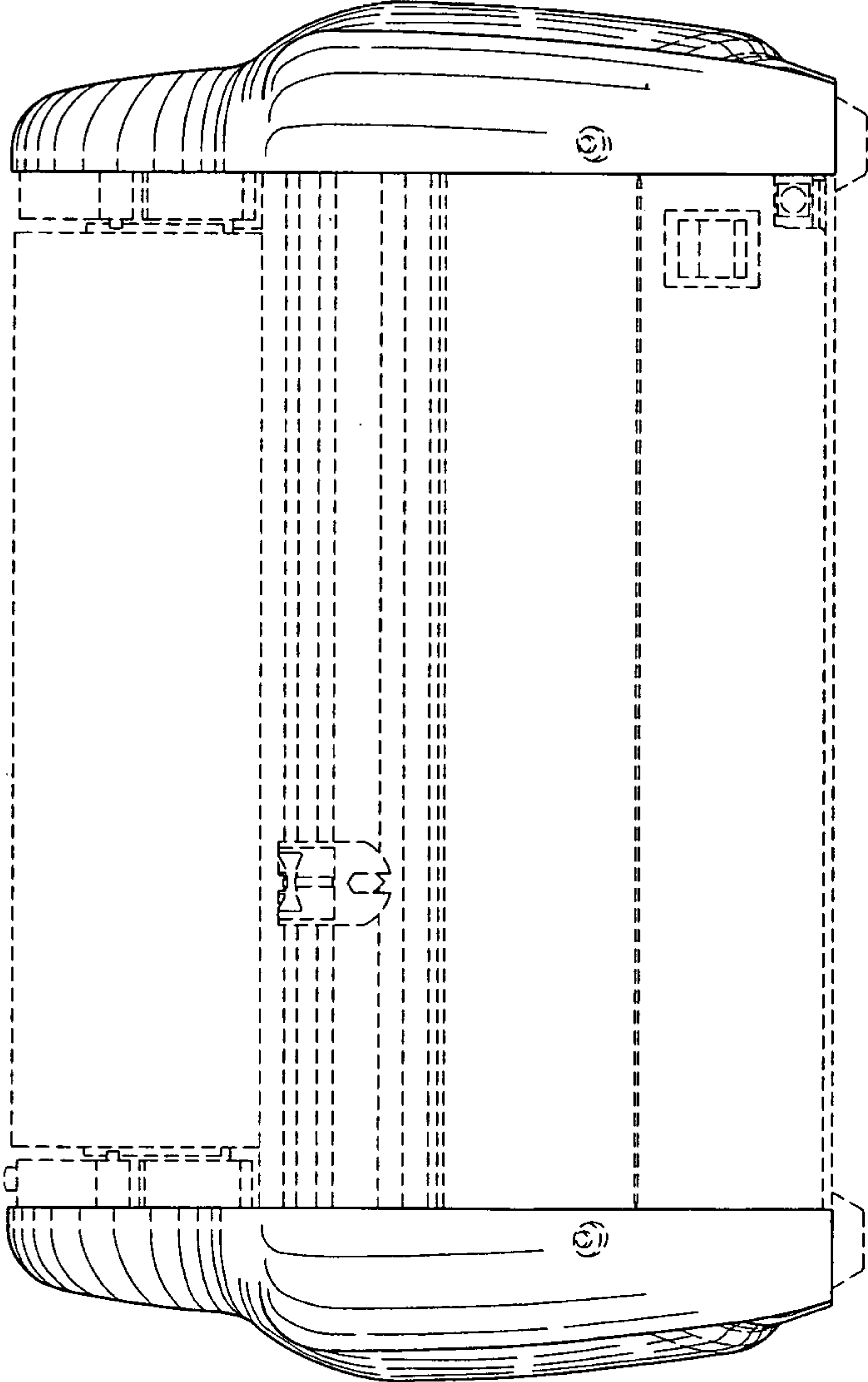

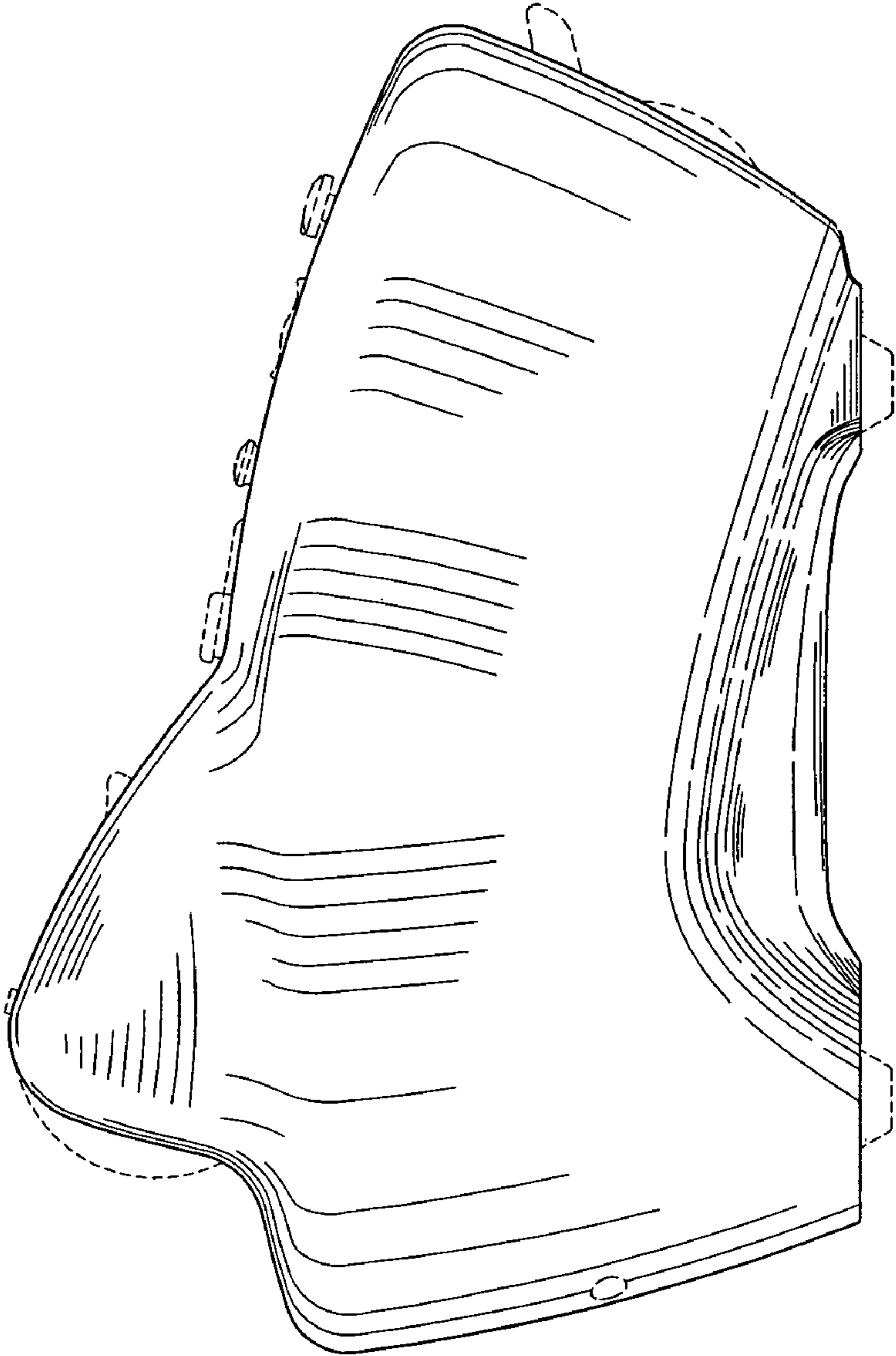

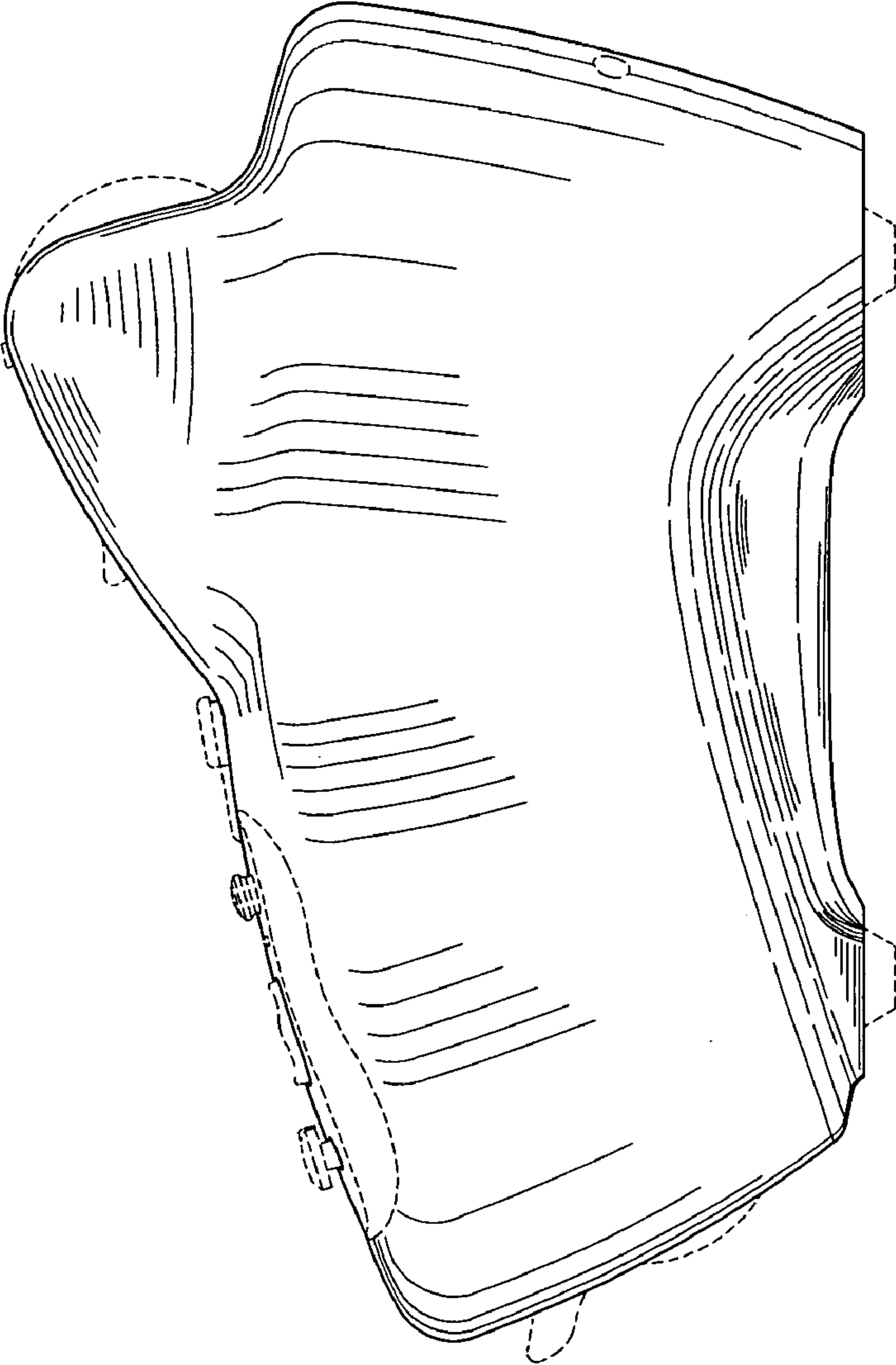

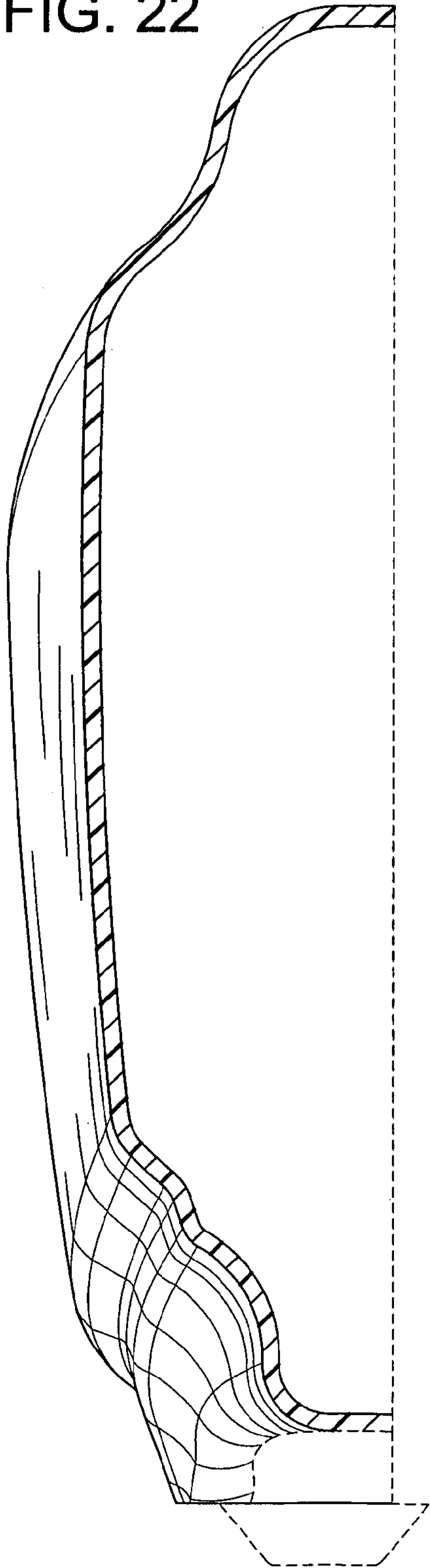

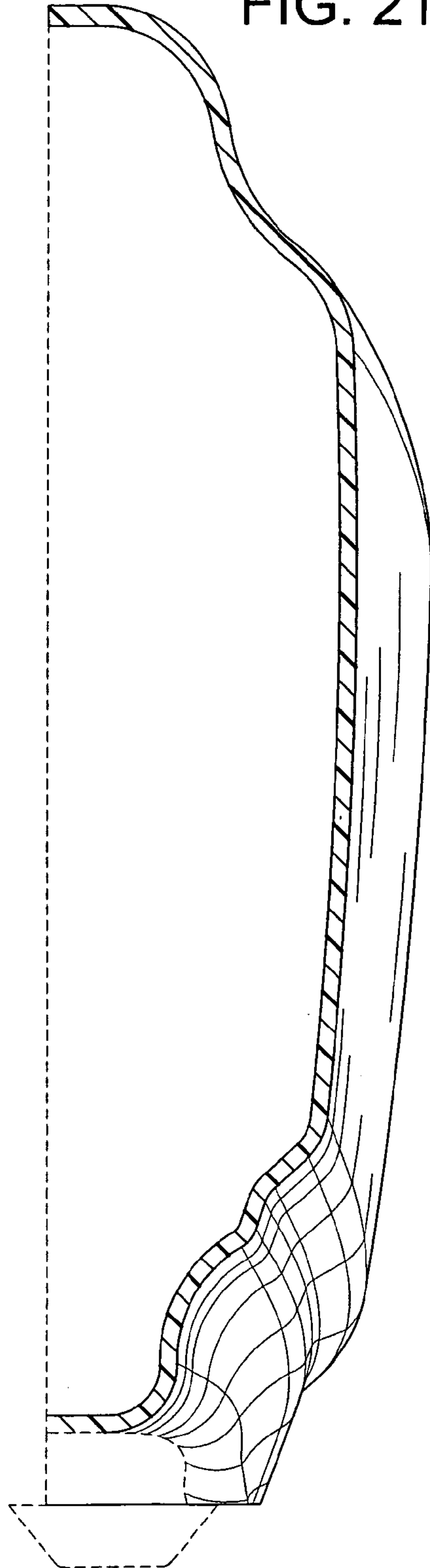

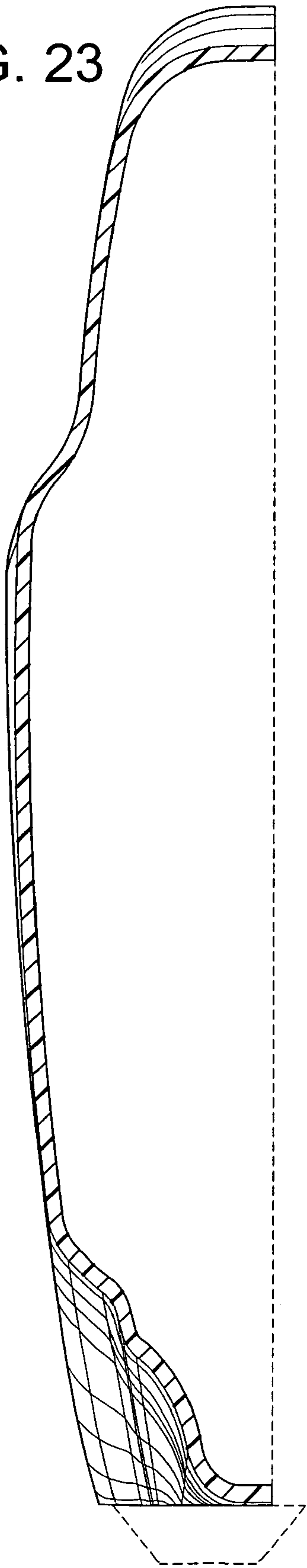

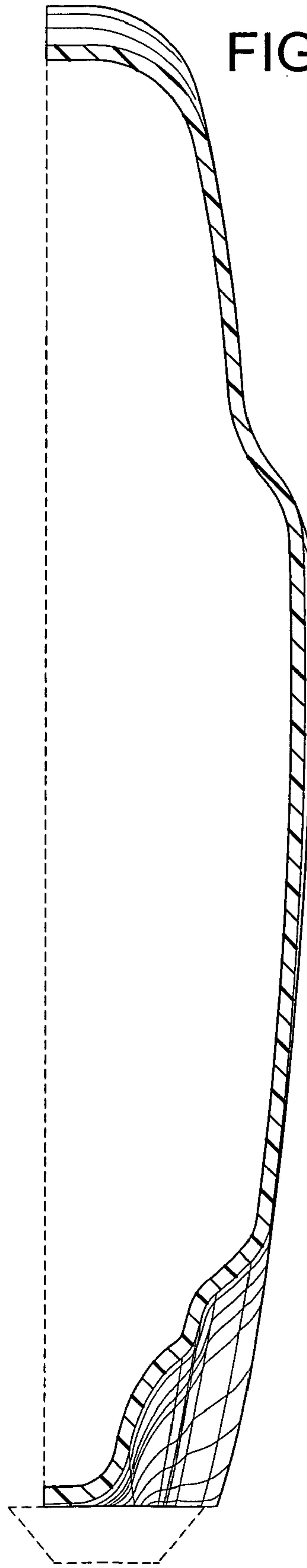

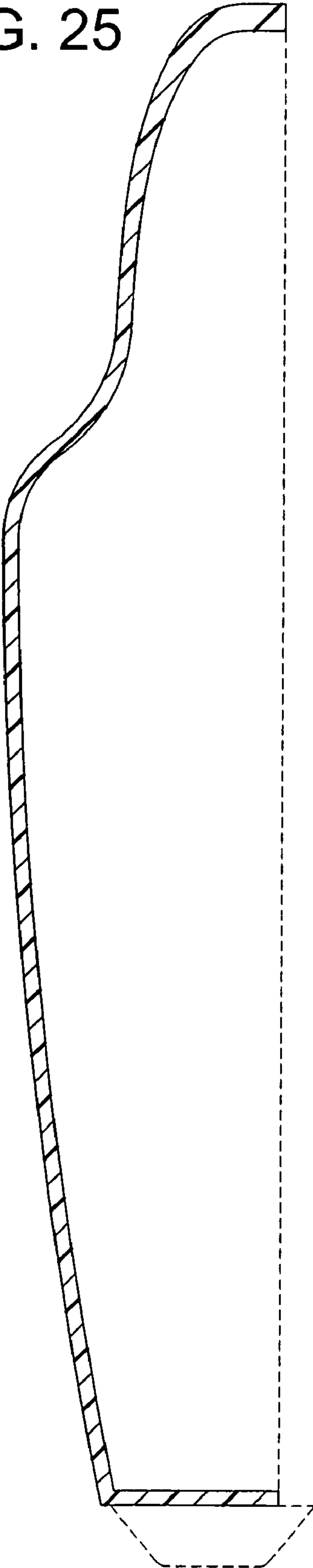
