(57) **CLAIM**

The ornamental design for a rattling hockey stick noise-  
maker, as shown and described.

**DESCRIPTION**

The design is used as a noisemaker and souvenir for sporting  
events; One embodiment includes an eyelet providing for  
the addition of a carrying strap.

FIG. 1 shows an isometric view of a first embodiment of the  
rattling hockey stick noisemaker, which excludes the eyelet  
that is shown in phantom lines for illustrative purposes;

FIG. 2 shows a front elevation view of the rattling hockey  
stick noisemaker of FIG. 1;

FIG. 3 shows a view of the rattling hockey stick noisemaker  
of FIG. 1 looking down on the rattling hockey stick noise-  
maker from above, when positioned as shown in FIG. 4;

FIG. 4 shows a left side elevation view of the rattling hockey  
stick noisemaker of FIG. 1;

FIG. 5 shows a right elevation side view of the rattling  
hockey stick noisemaker of FIG. 1;

FIG. 6 shows a back elevation view of the rattling hockey  
stick noisemaker of FIG. 1;

FIG. 7 shows a view of the rattling hockey stick noisemaker  
of FIG. 1 looking up at the rattling hockey stick noisemaker  
from underneath, when positioned as shown in FIG. 5.

FIG. 8 shows an isometric view of an alternate embodiment  
of the rattling hockey stick noisemaker, which includes the  
eyelet;

FIG. 9 shows a front elevation view of the rattling hockey  
stick noisemaker of FIG. 8;

FIG. 10 shows a view of the rattling hockey stick noise-  
maker of FIG. 8 looking down on the rattling hockey stick  
noisemaker from above, when positioned as shown in FIG.  
11;

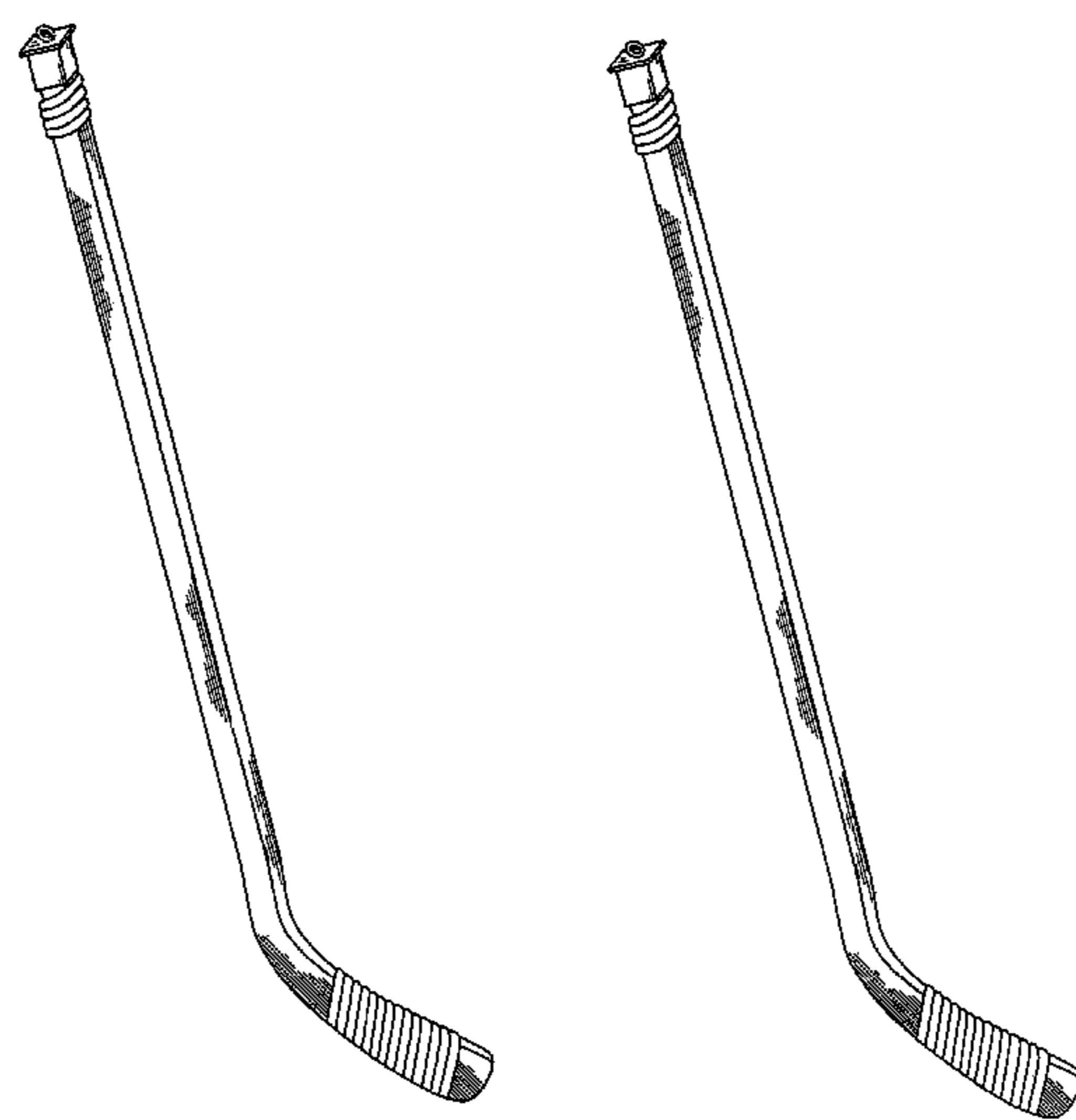
FIG. 11 shows a left side elevation view of the rattling  
hockey stick noisemaker of FIG. 8;

FIG. 12 shows a right elevation side view of the rattling  
hockey stick noisemaker of FIG. 8;

FIG. 13 shows a back elevation view of the rattling hockey

FIG. 14 shows a view of the rattling hockey stick noise-  
maker of FIG. 8 looking up at the rattling hockey stick  
noisemaker from underneath, when positioned as shown in  
FIG. 12.

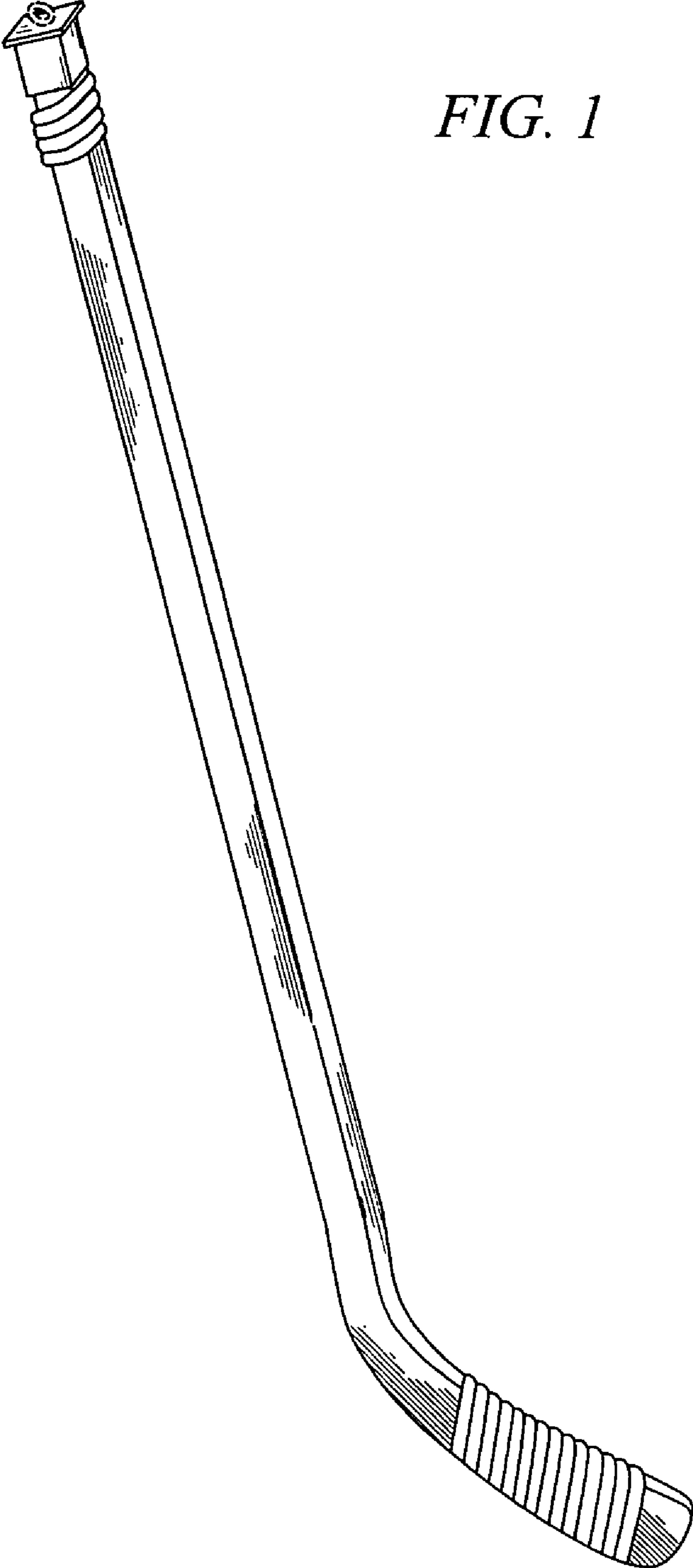

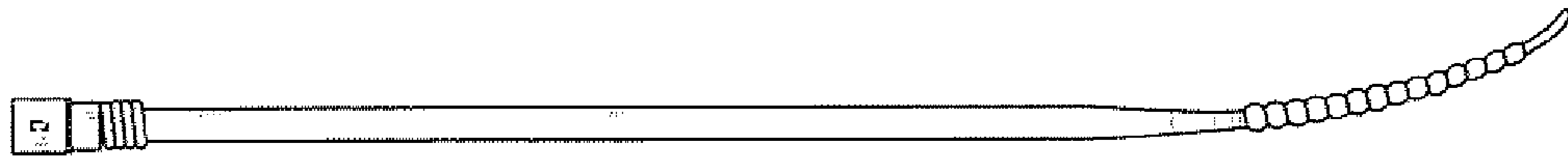

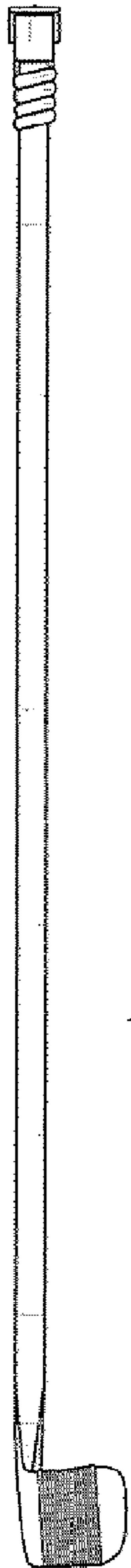

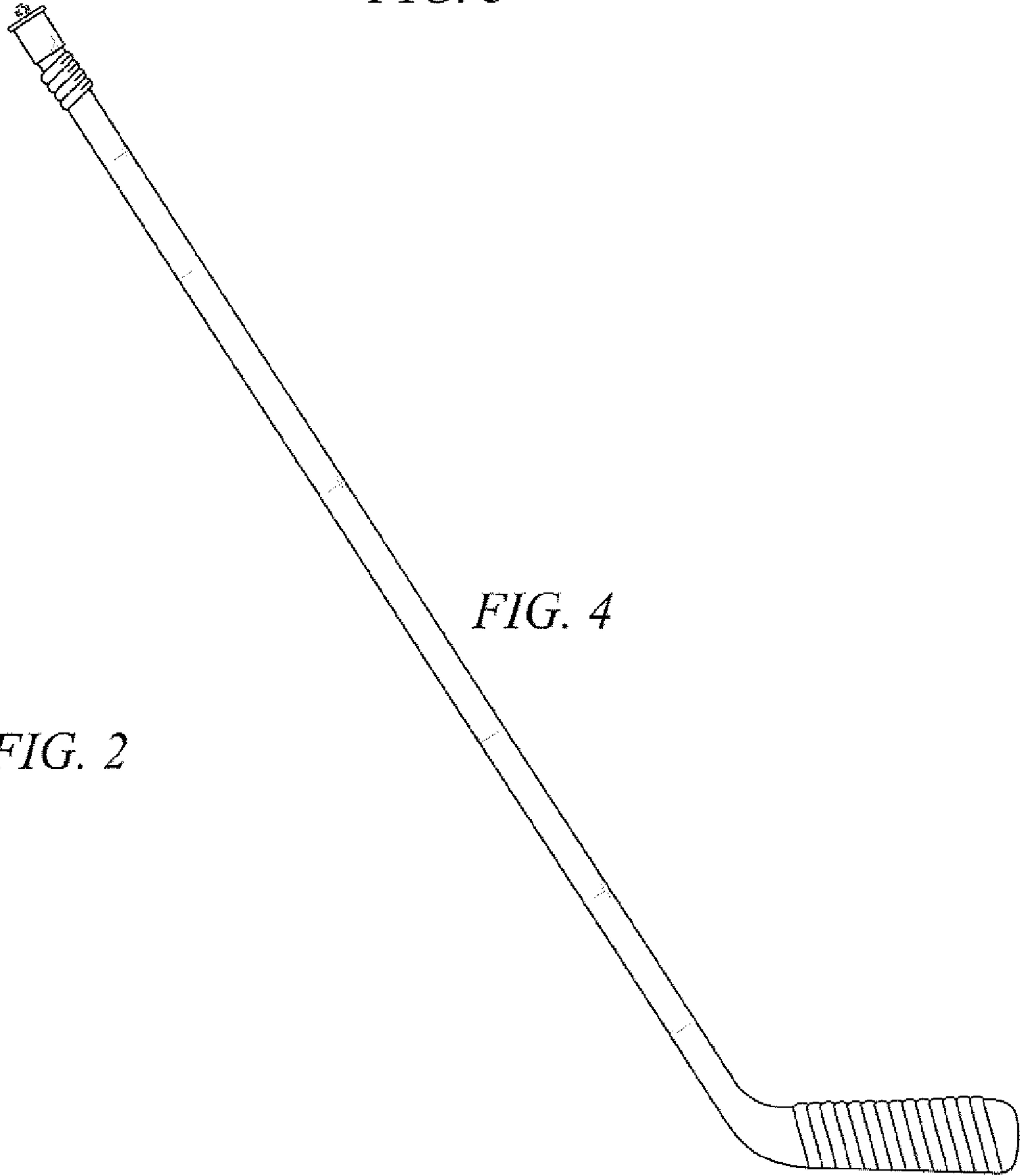
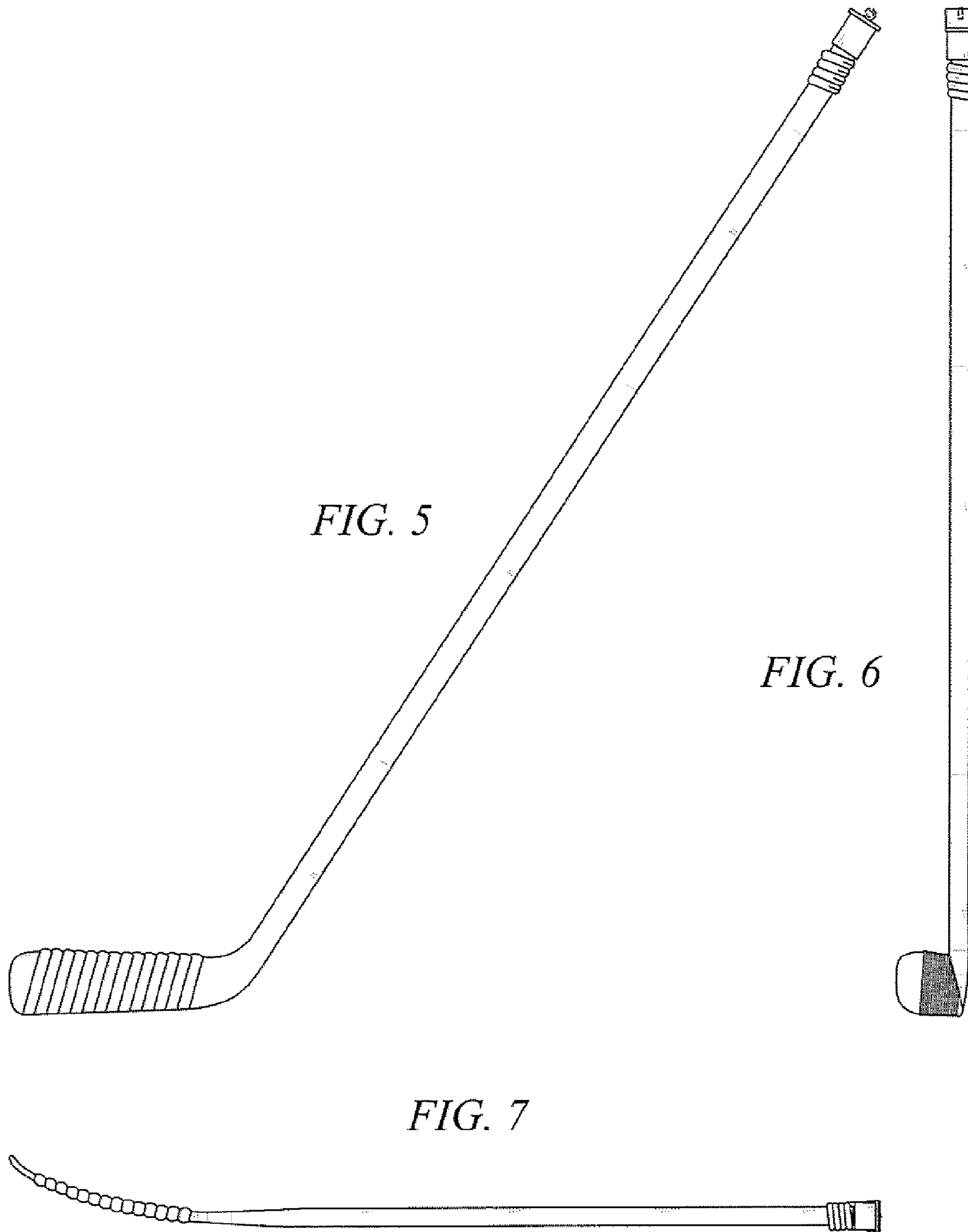
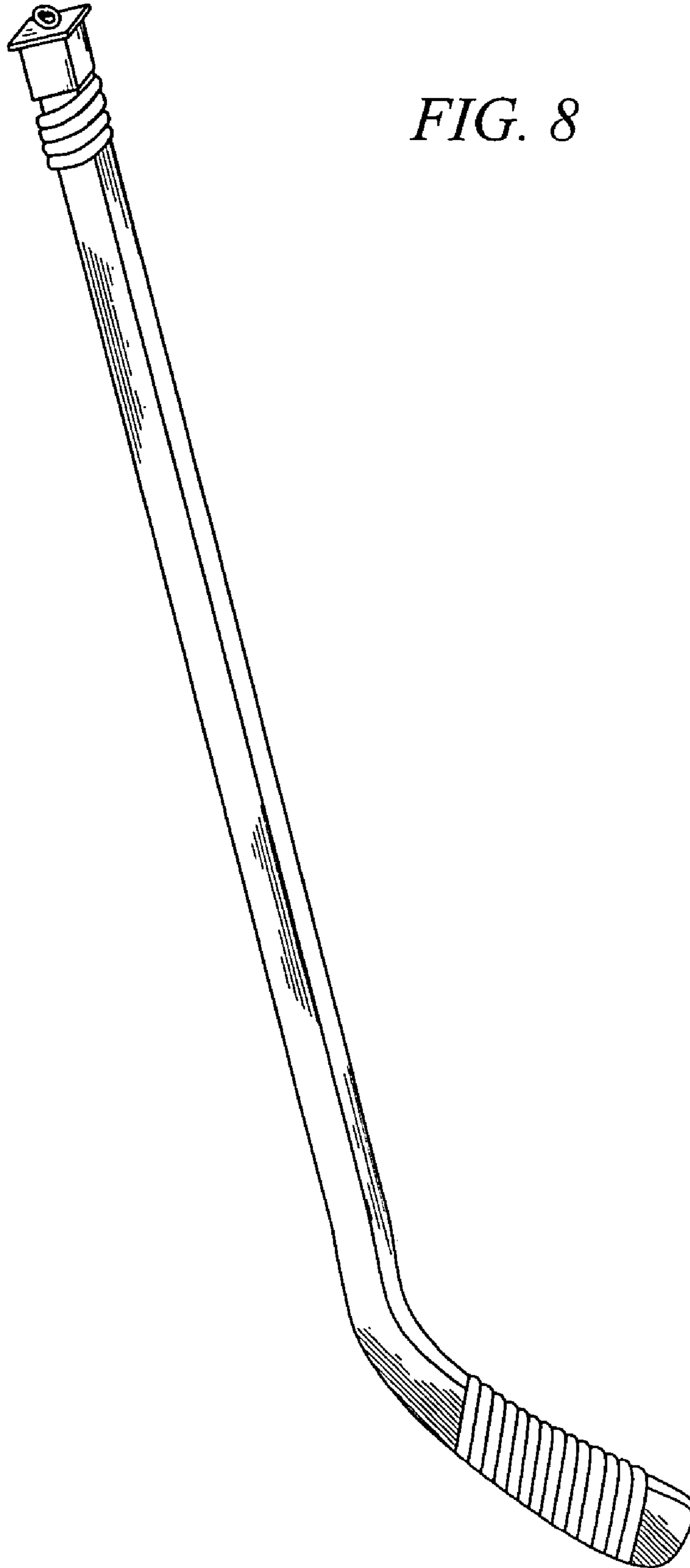

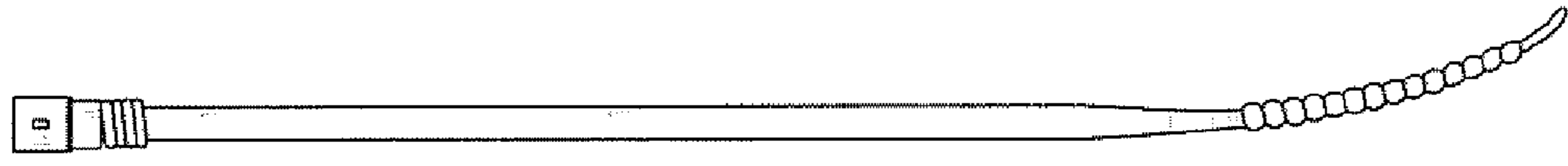

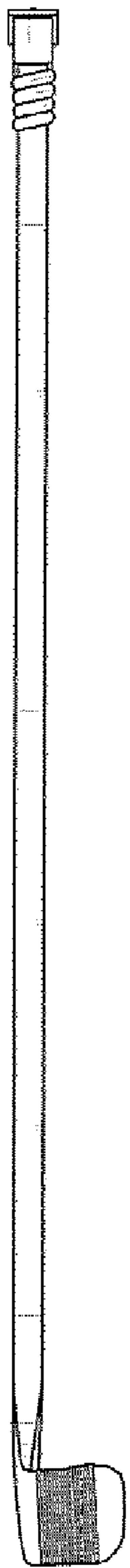

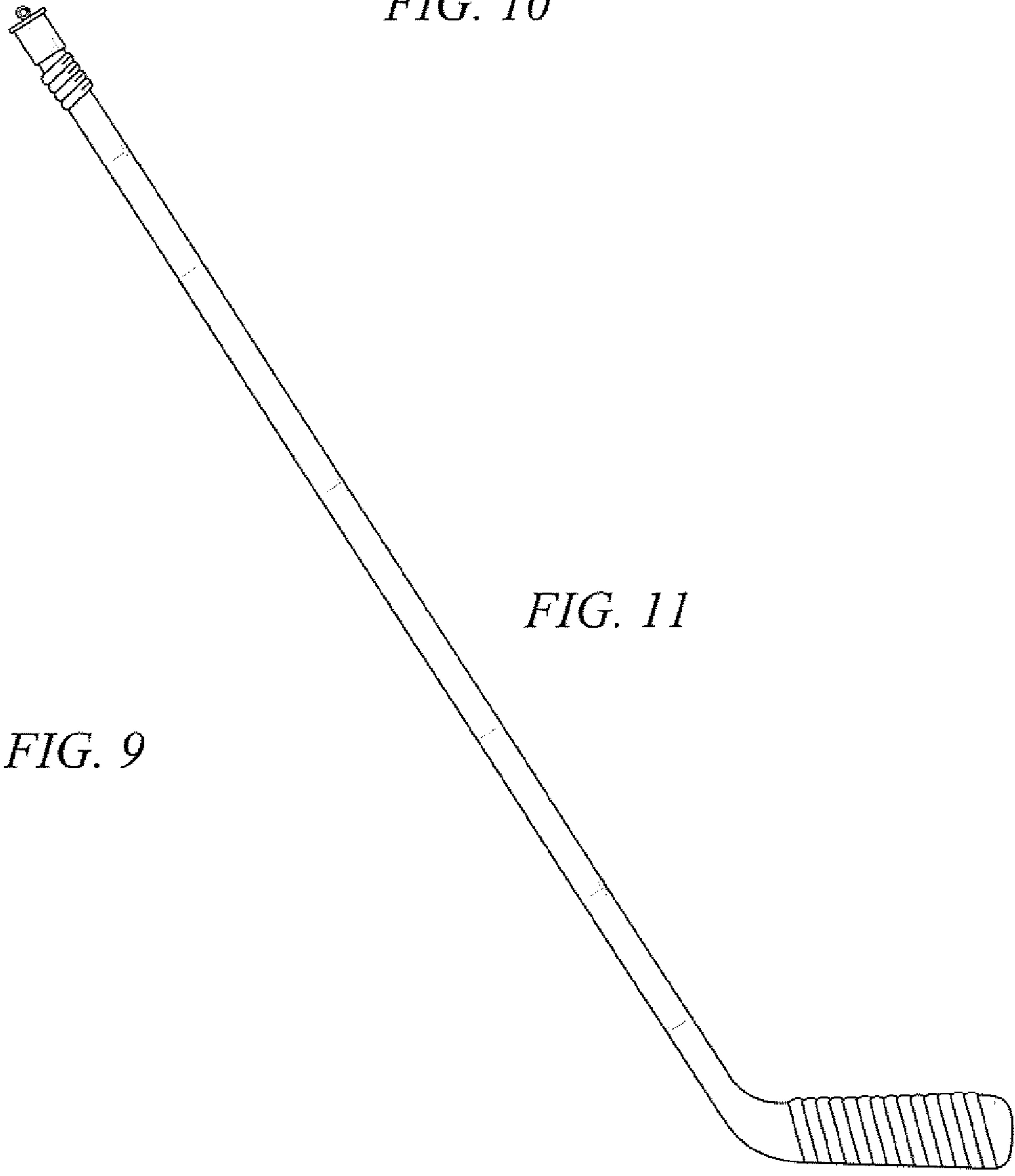
