DESCRIPTION

FIG. 1 is a perspective view of a product trolley showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

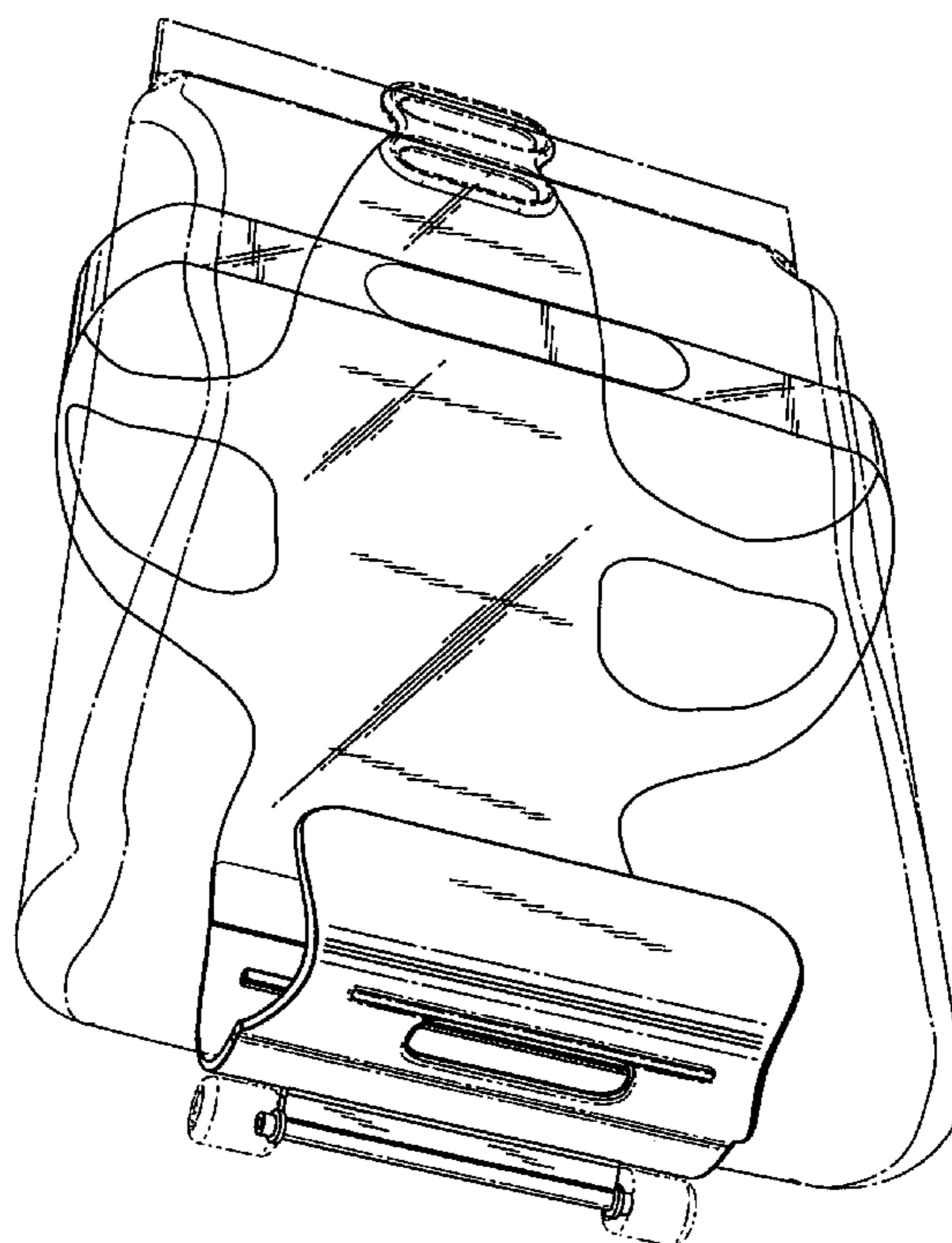
FIG. 4 is a right end view thereof, with the left view being a mirror image;

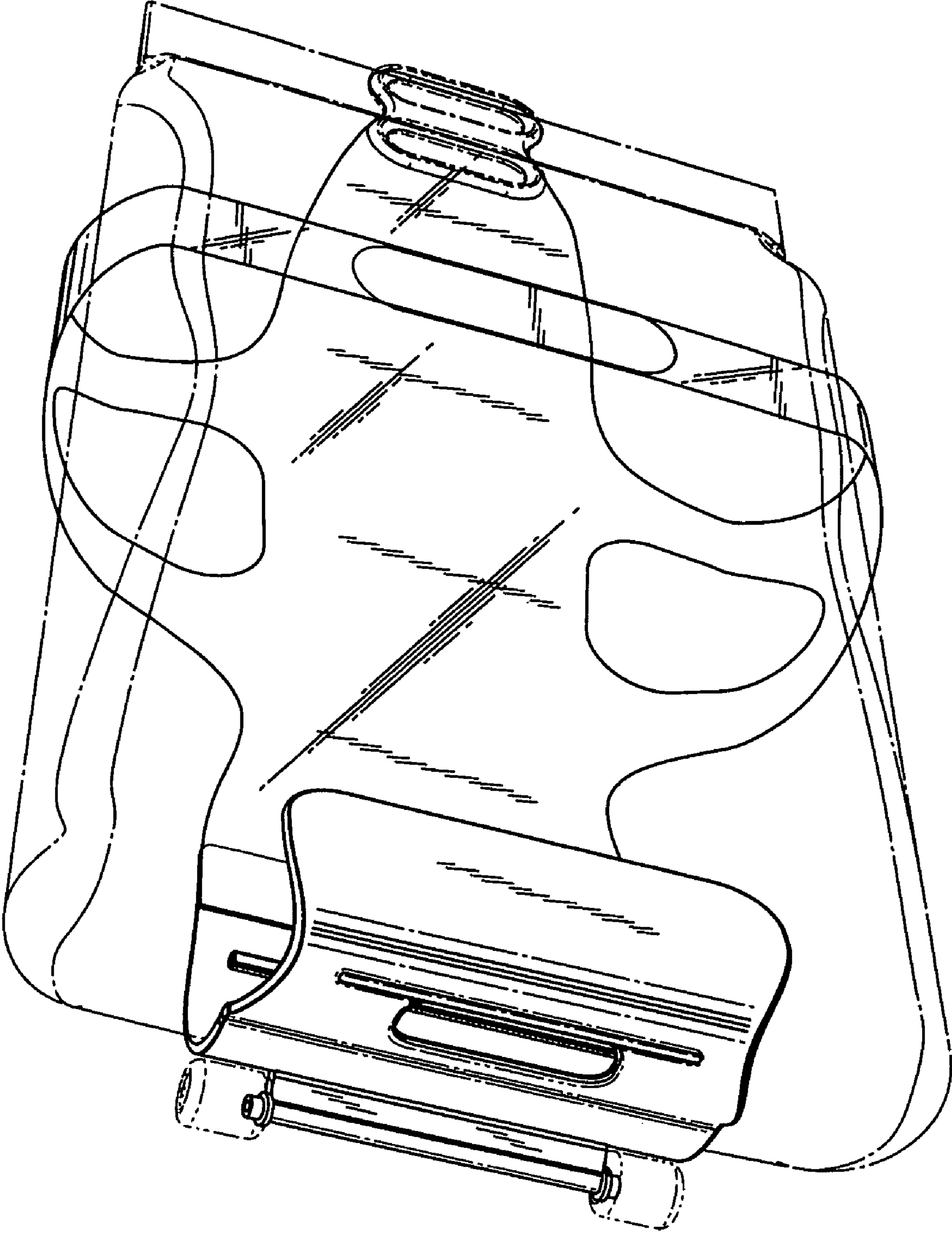

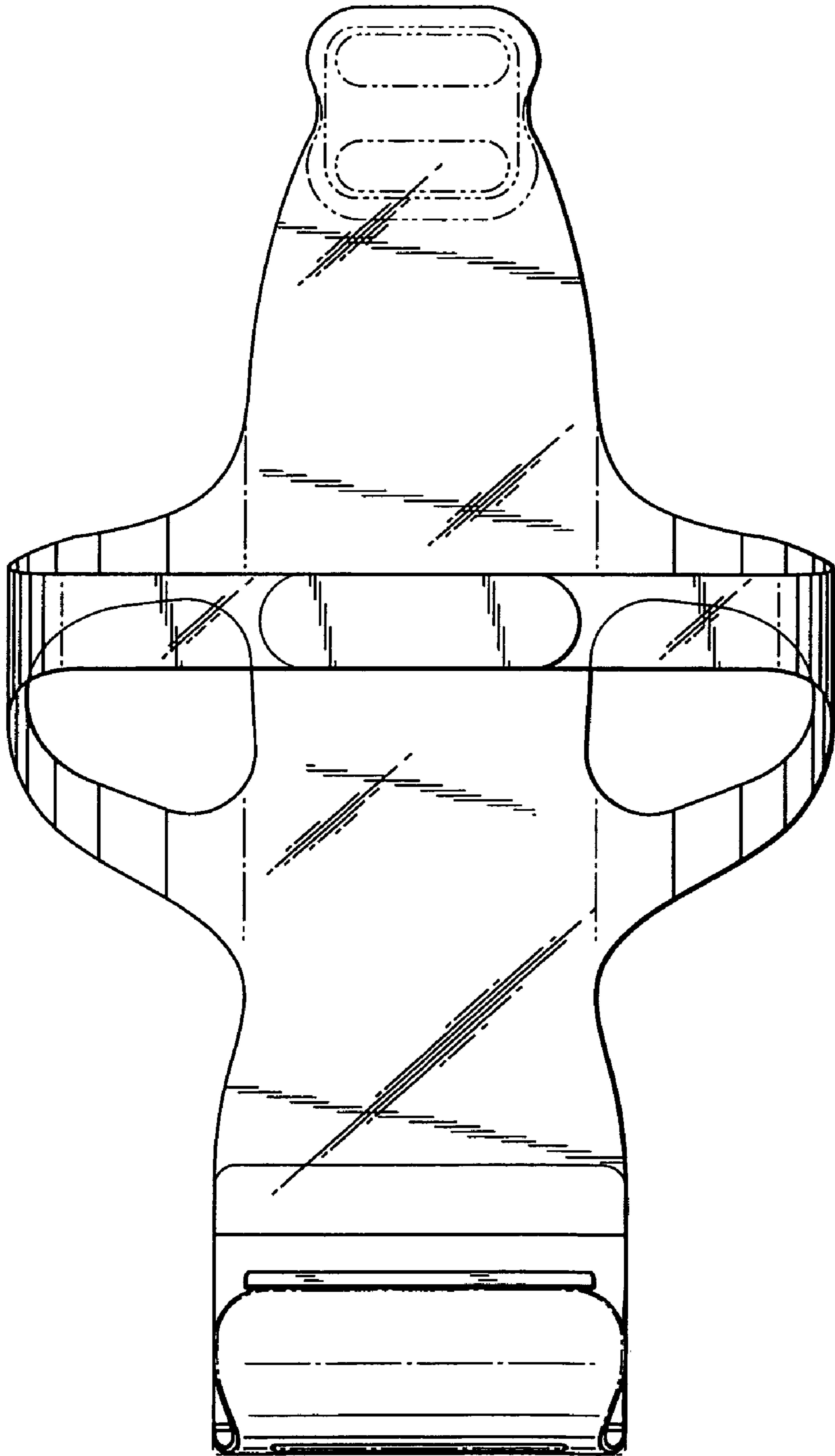

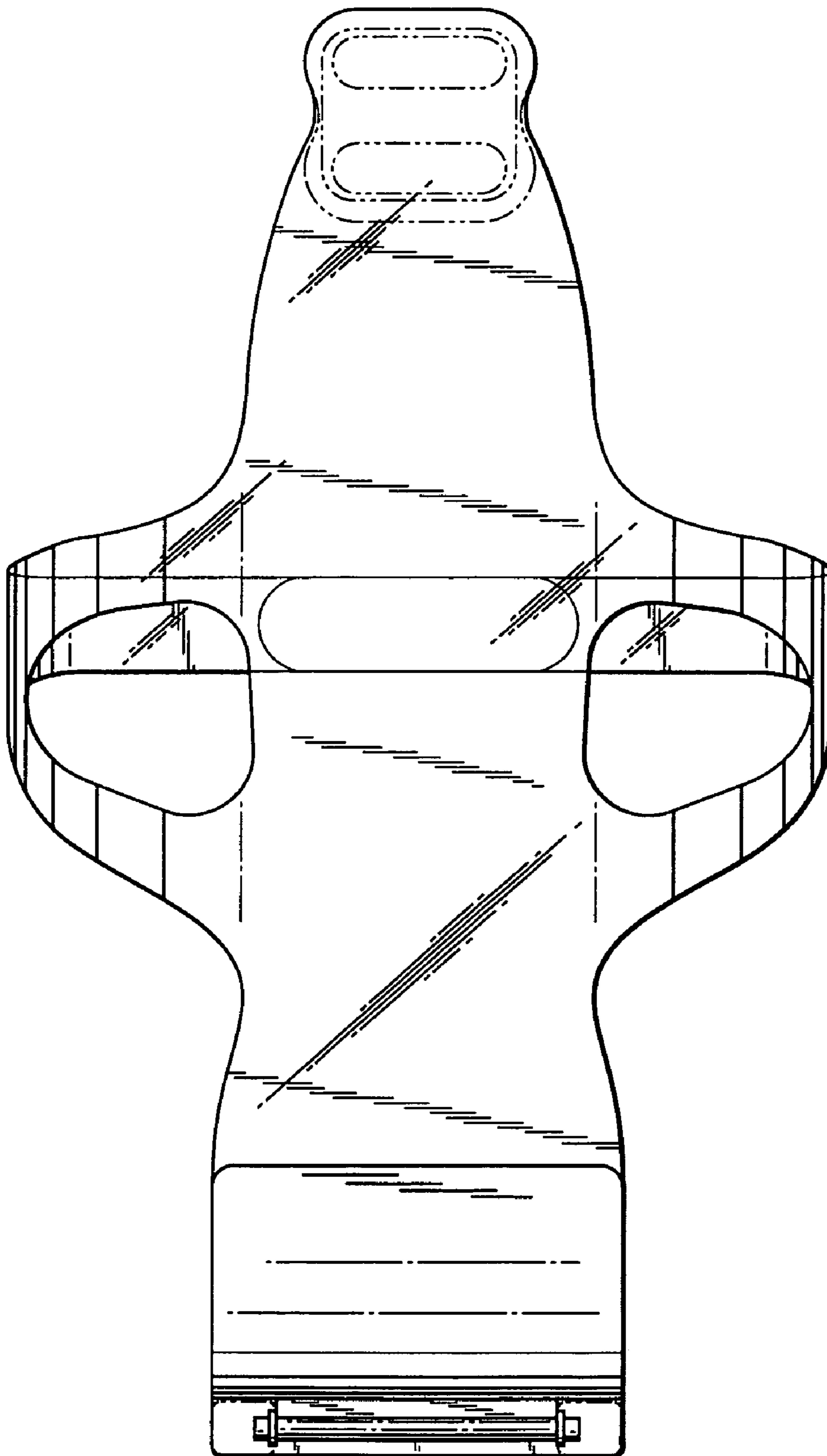

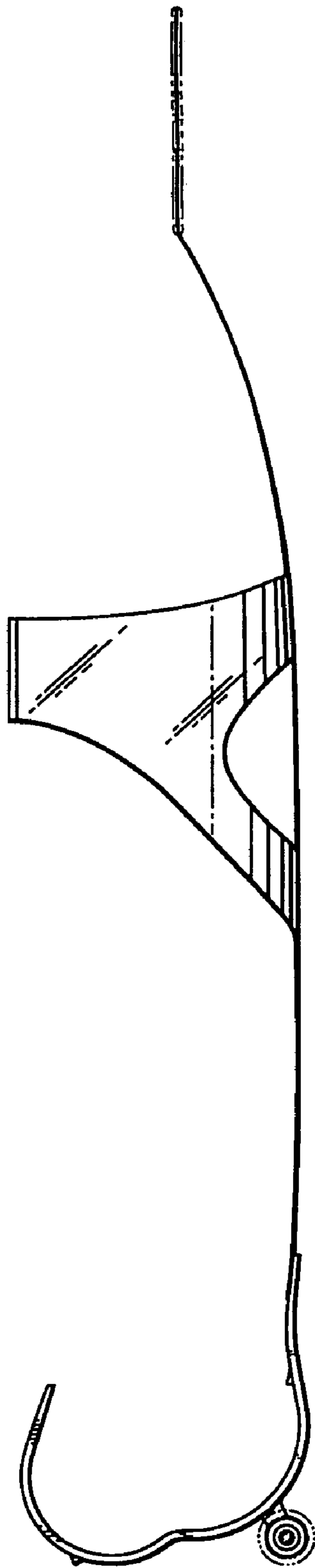

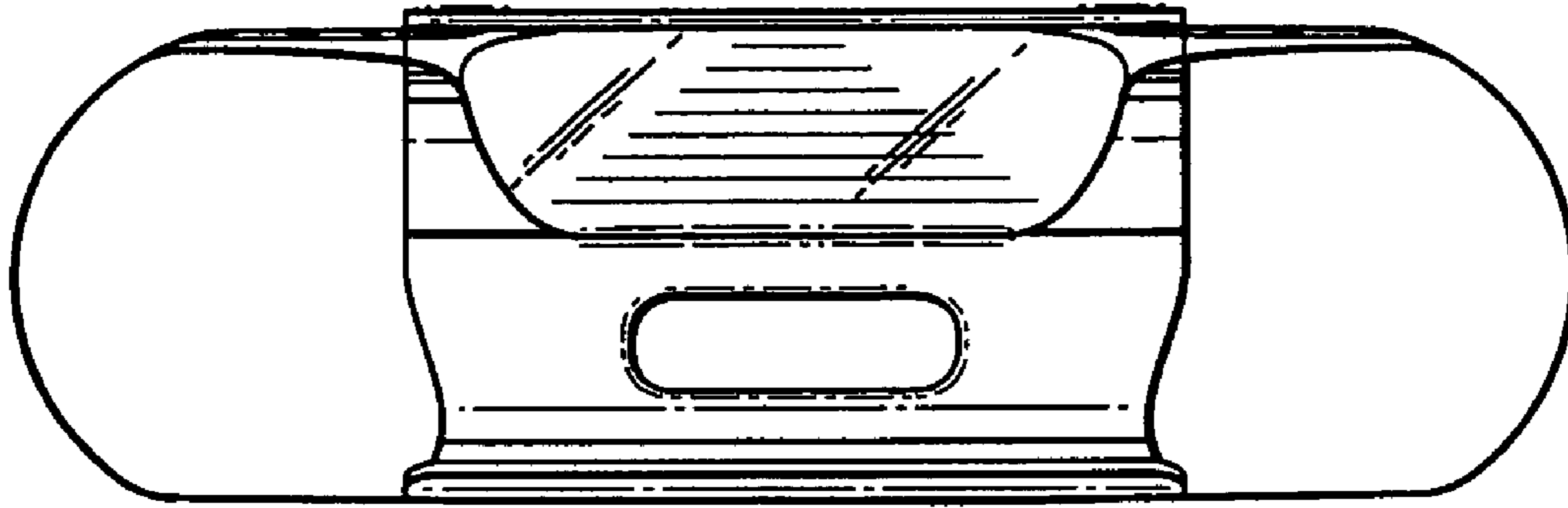

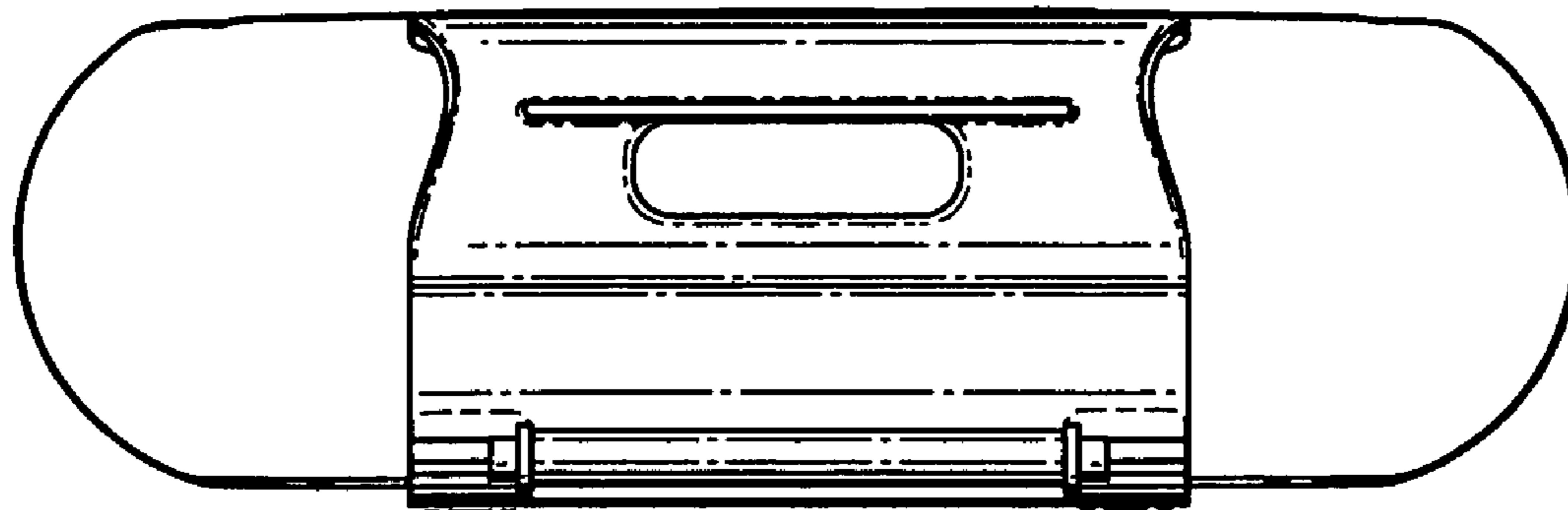
