**DESCRIPTION**

FIG. 1 is a right-front-top perspective view of a shopping list holder that embodies Applicants' ornamental design;

FIG. 4 is a rear view of the shopping list holder of FIG. 1;

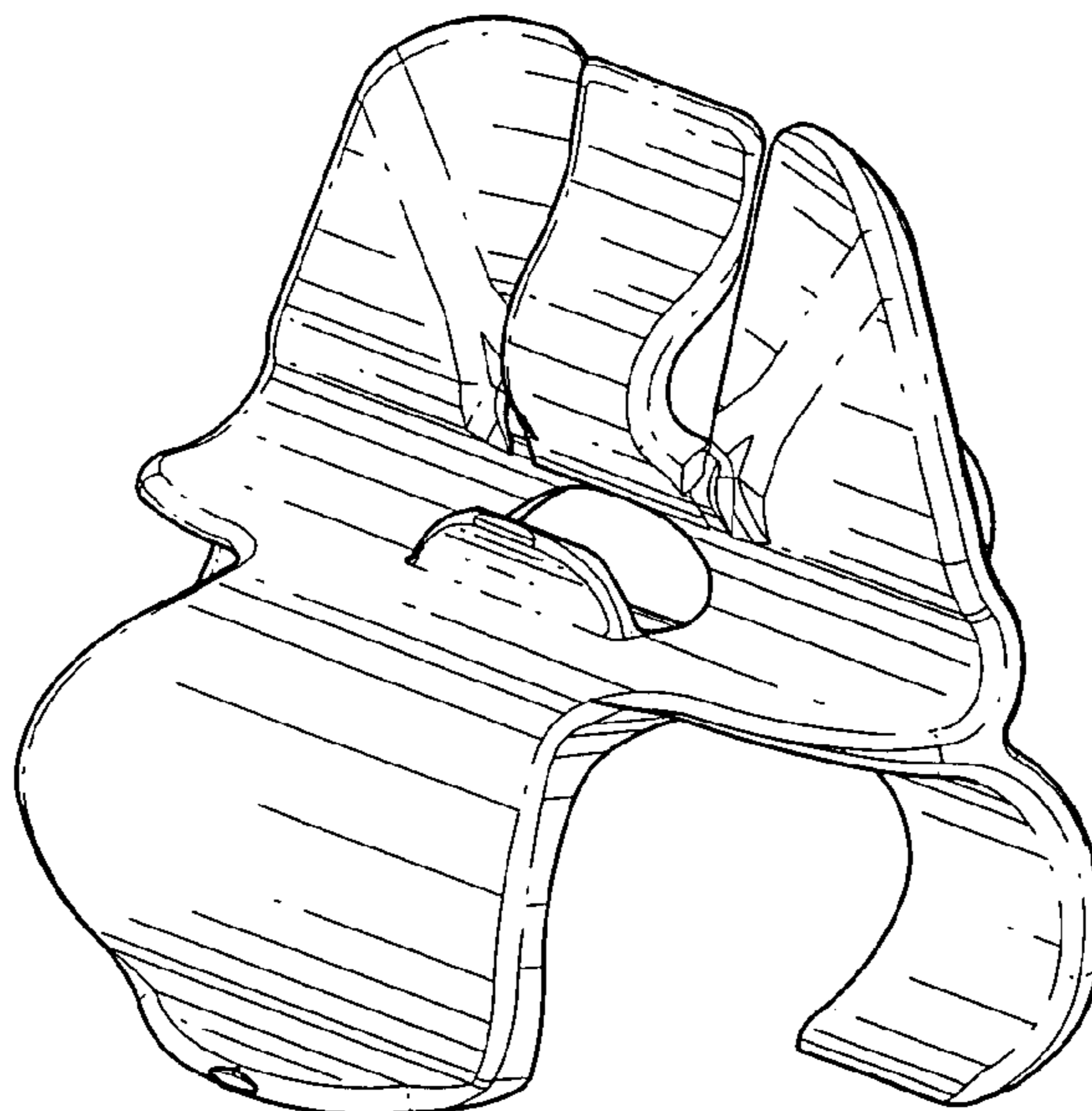
FIG. 5 is a bottom view of the shopping list holder of FIG. 1;

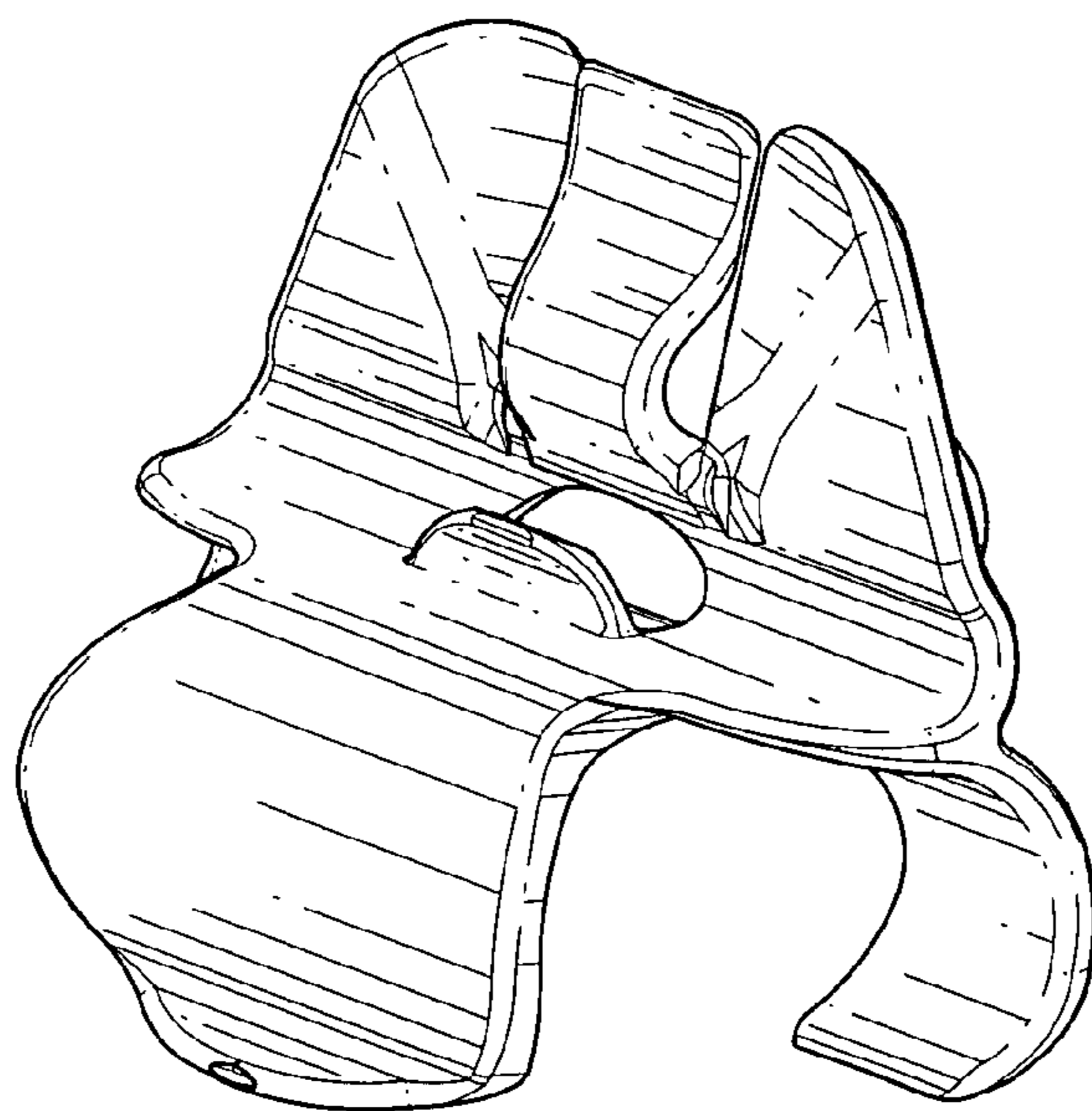

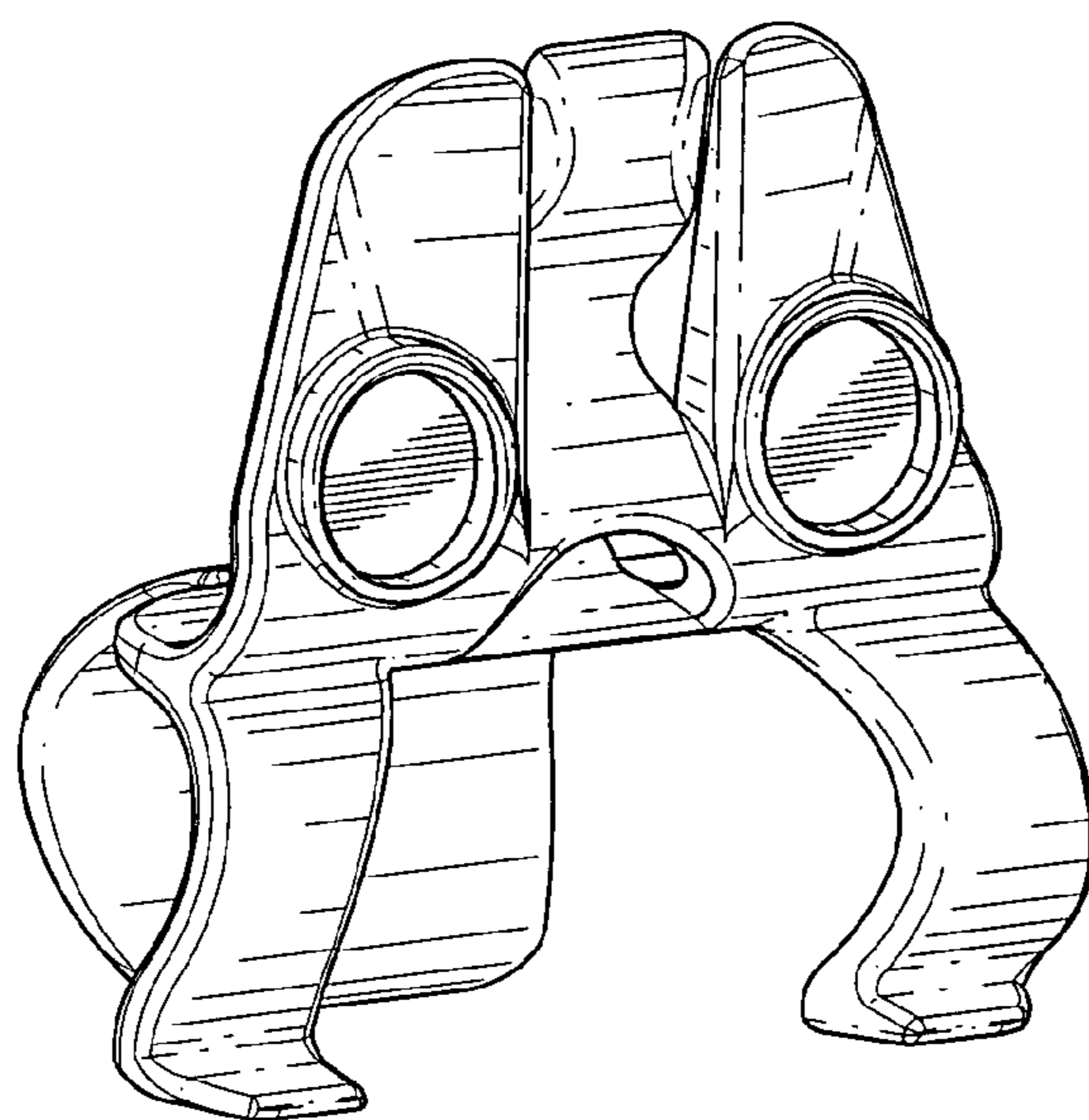

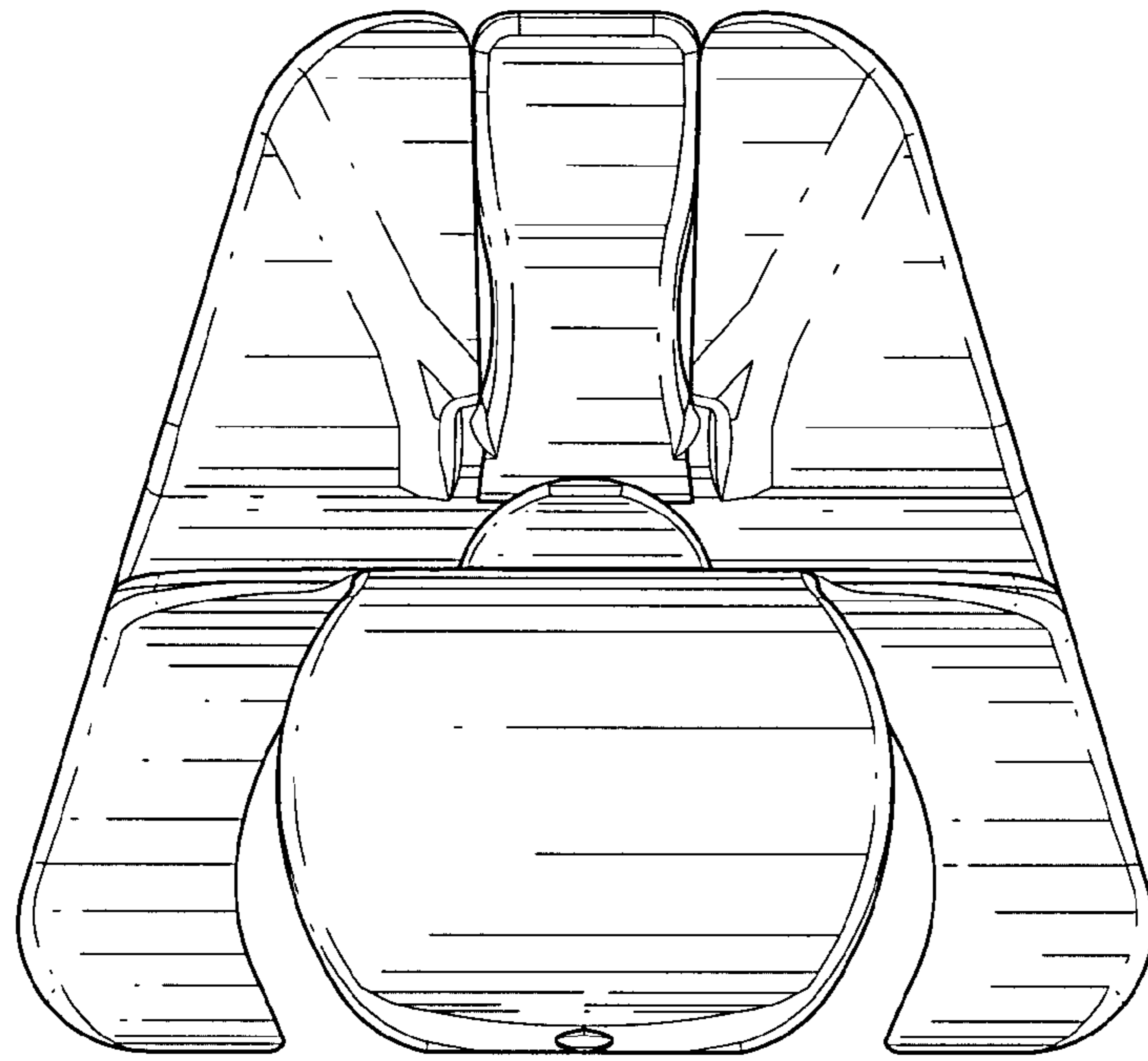

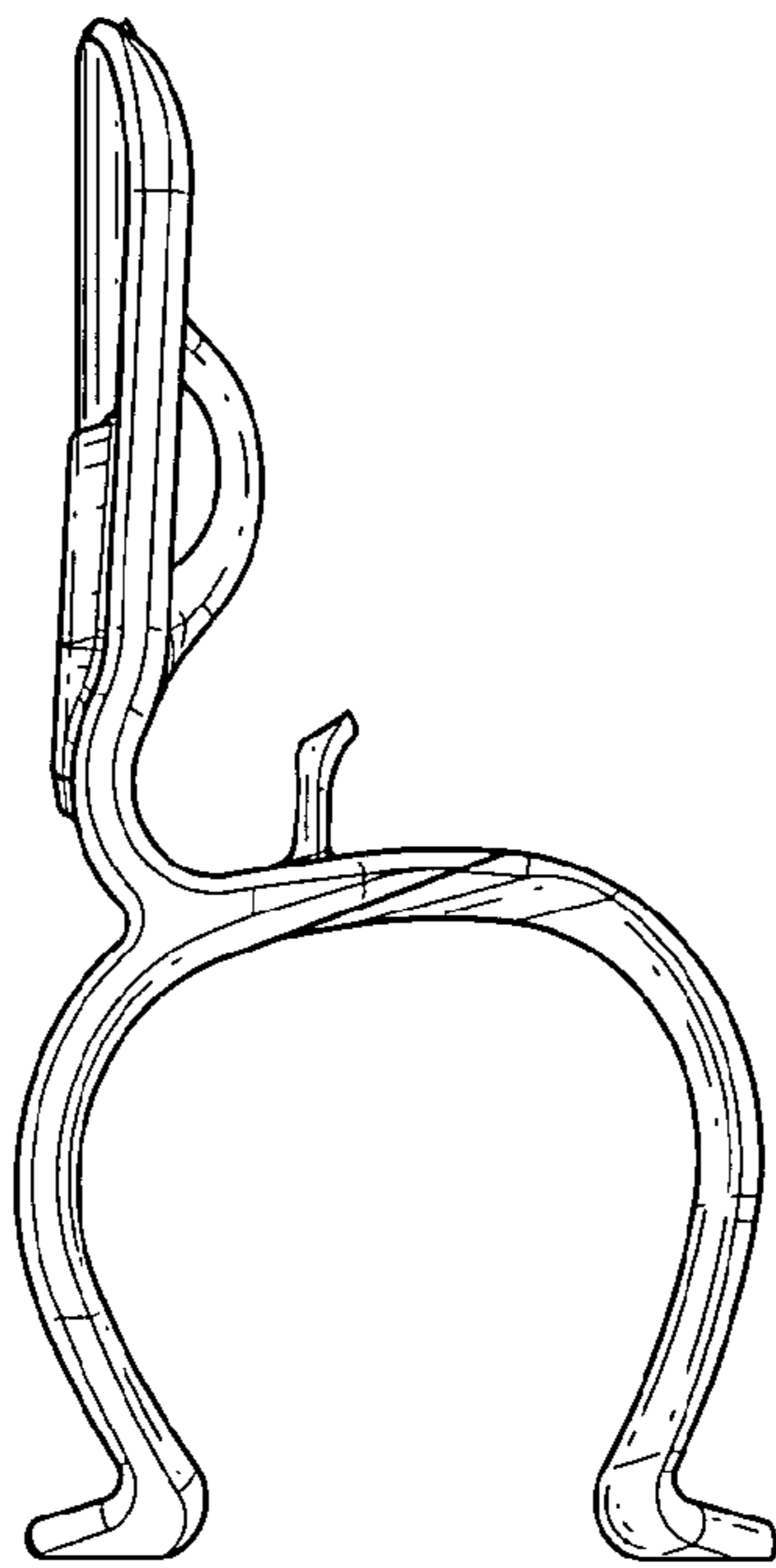

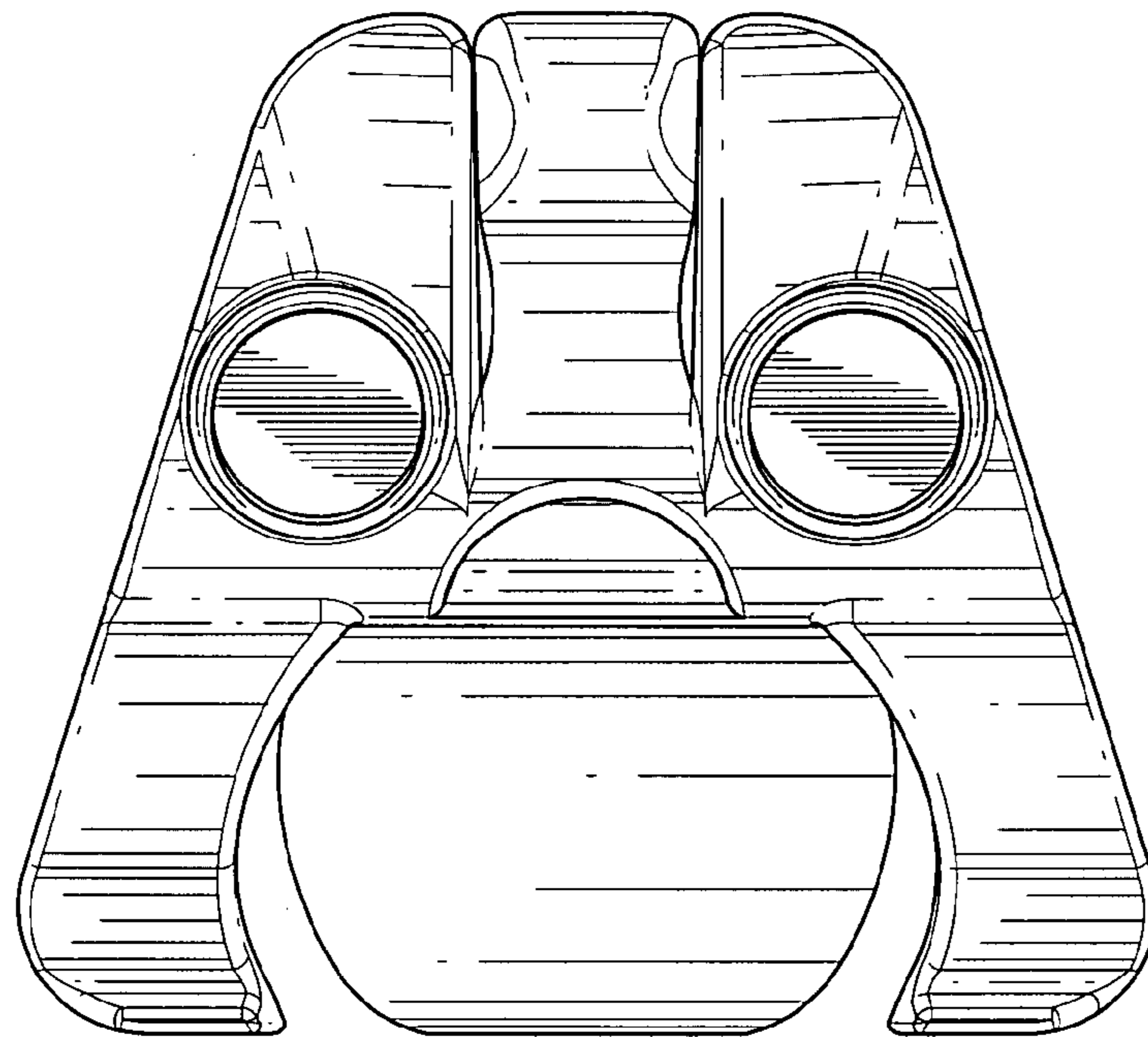

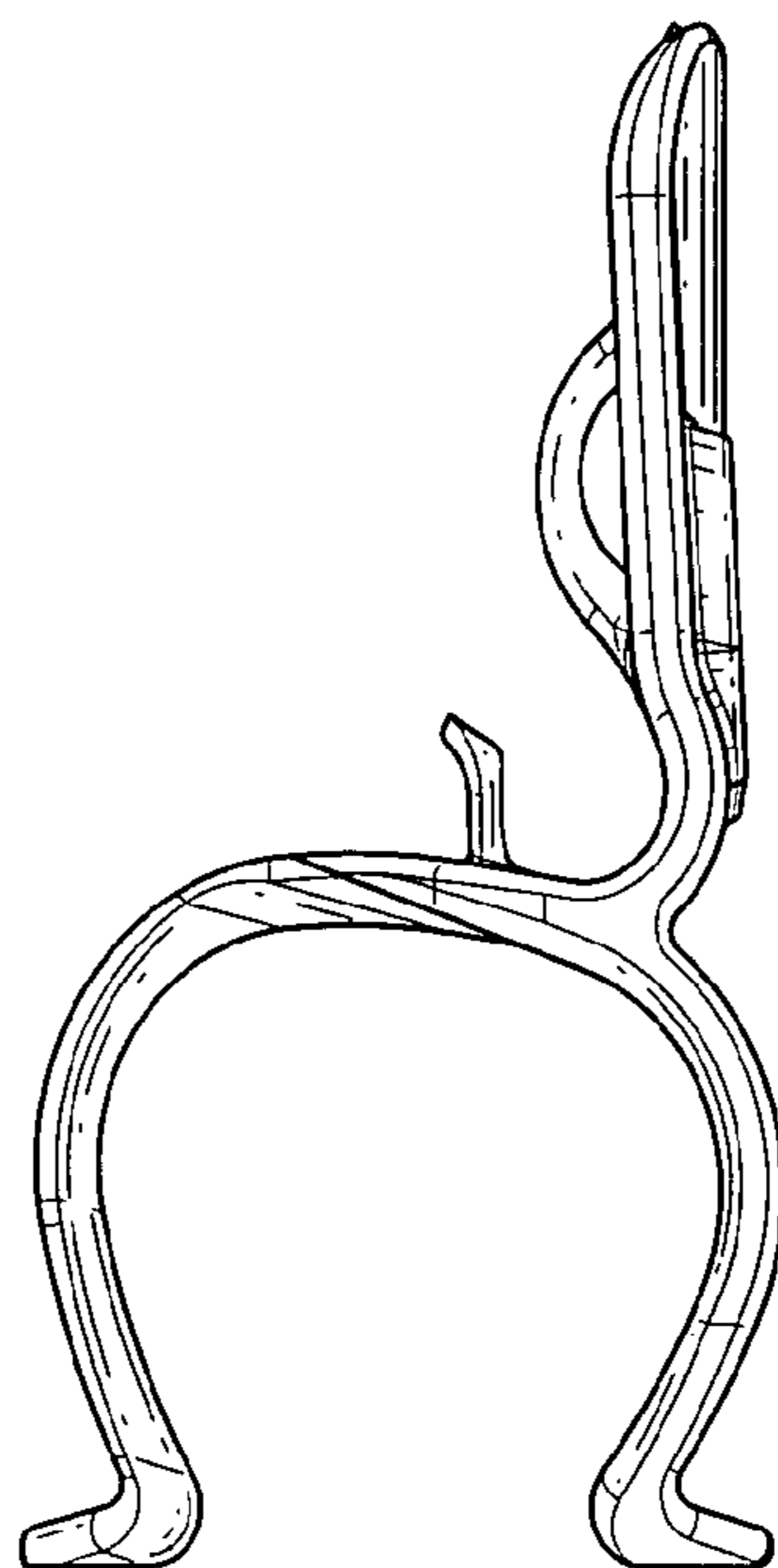

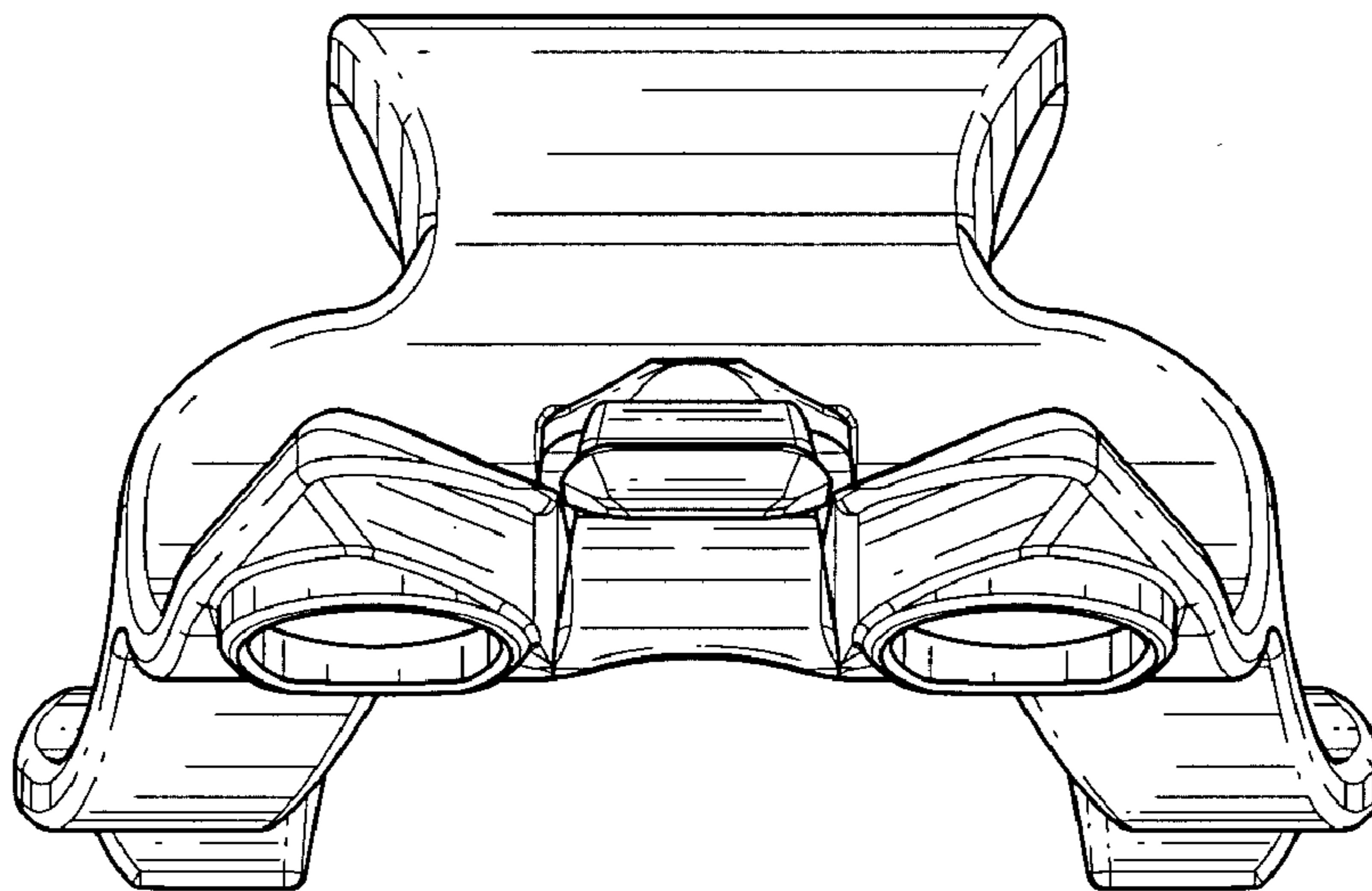

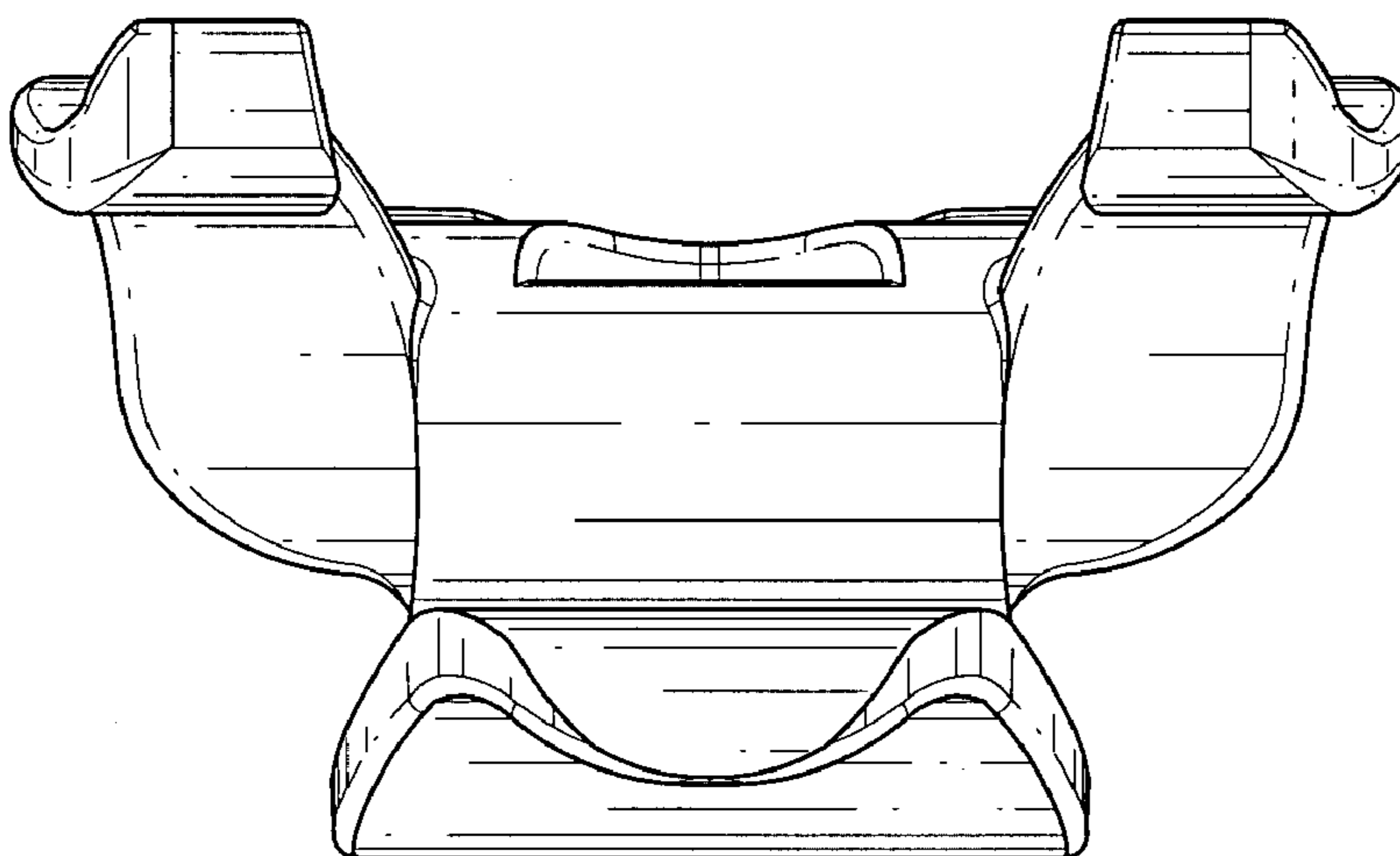
