**DESCRIPTION**

FIG. 1 is a perspective view of a sewing basket.

FIG. 2 is a front plan view of the sewing basket seen in FIG. 1.

FIG. 3 is a rear plan view of the sewing basket seen in FIG. 1.

FIG. 4 is a left elevation view of the sewing basket of FIG. 1.

FIG. 5 is a right elevation view of the sewing basket of FIG. 1.

FIG. 6 is a top plan view of the sewing basket of FIG. 1.

FIG. 7 is a bottom plan view of the sewing basket of FIG. 1.

FIG. 8 is a perspective view of an alternative embodiment of a sewing basket.

FIG. 9 is a front plan view of the sewing basket seen in FIG. 8.

FIG. 10 is a rear plan view of the sewing basket seen in FIG. 8.

FIG. 11 is a left elevation view of the sewing basket of FIG. 8.

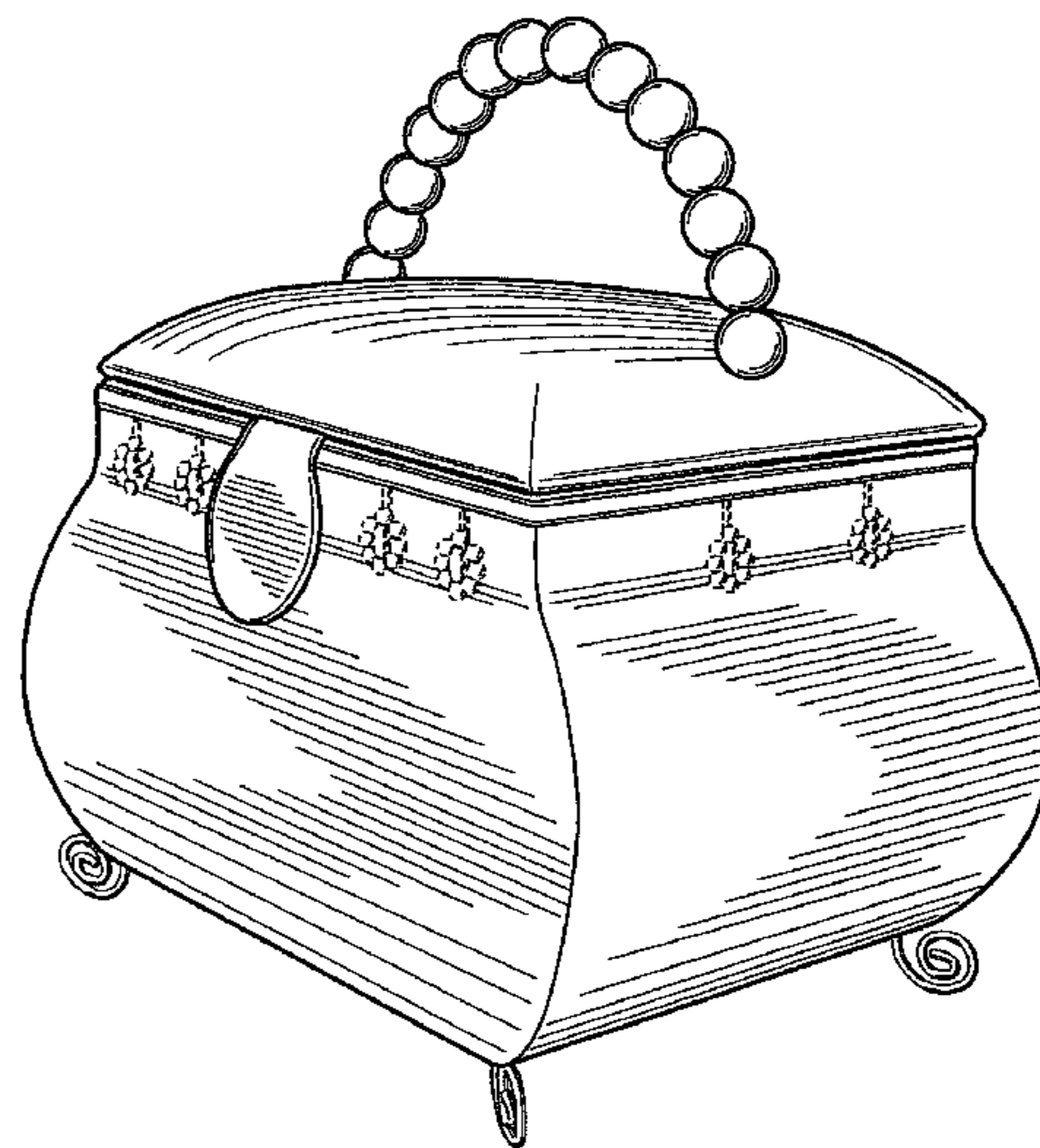
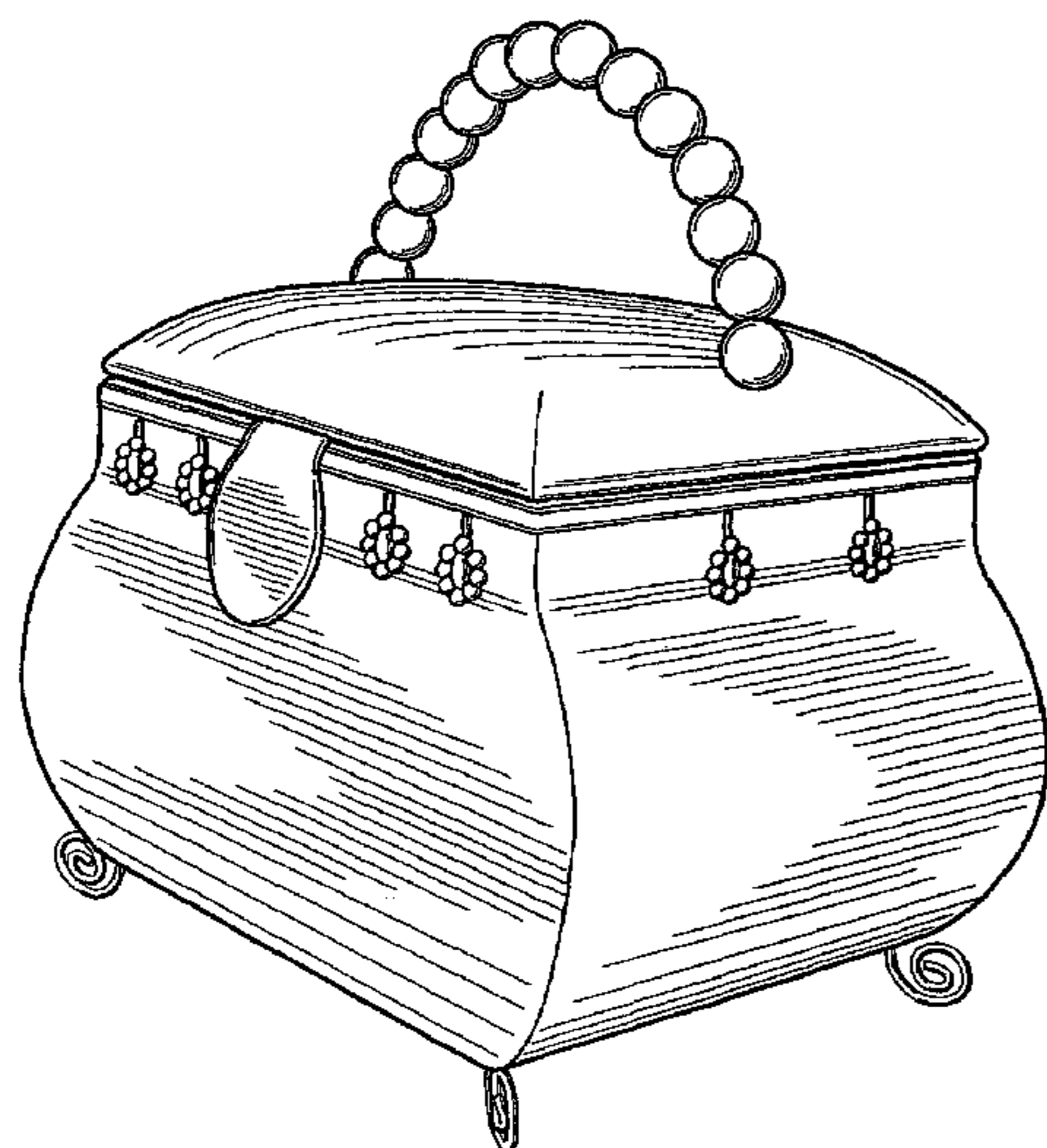
FIG. 12 is a right elevation view of the sewing basket of FIG. 8.

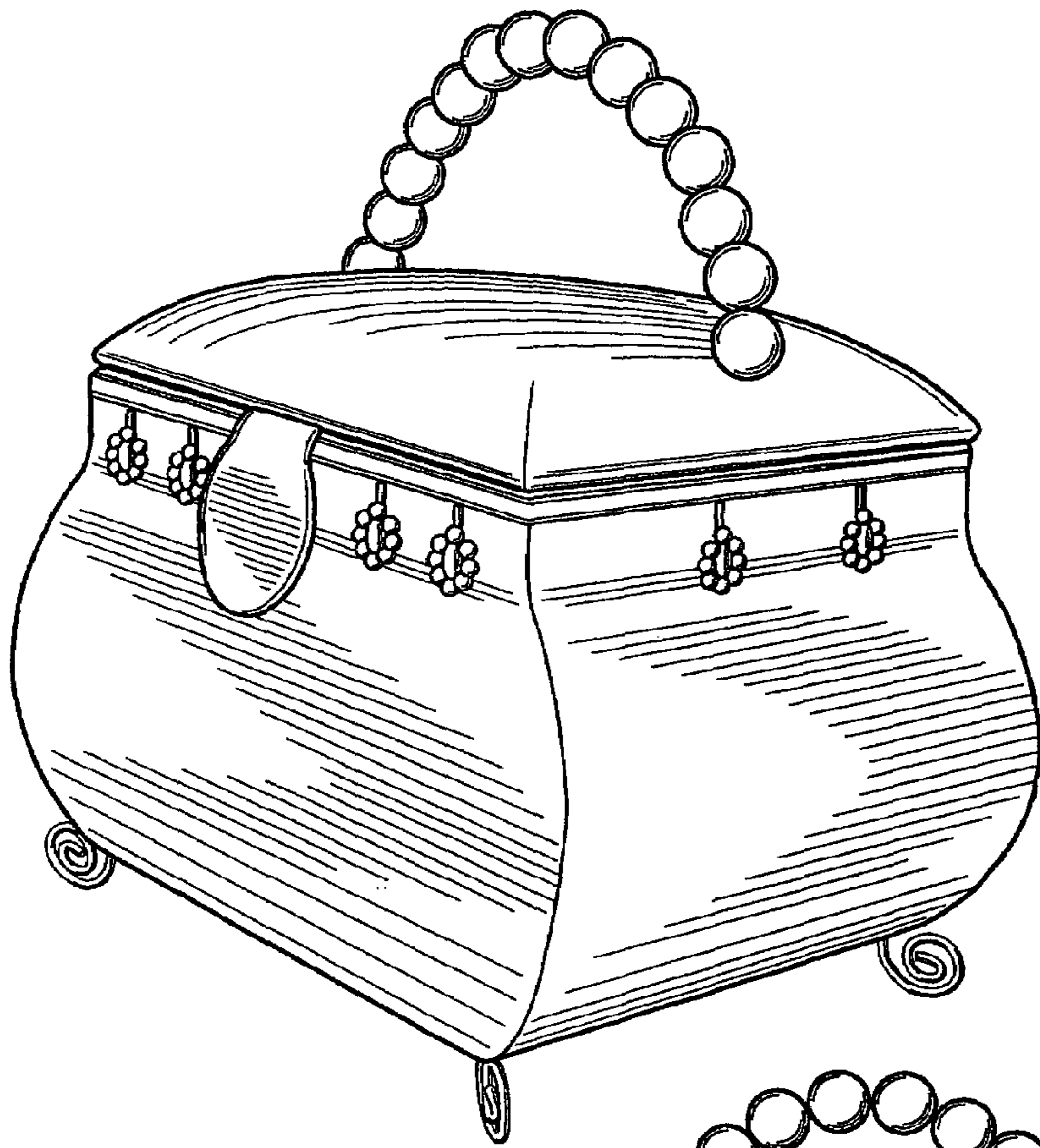

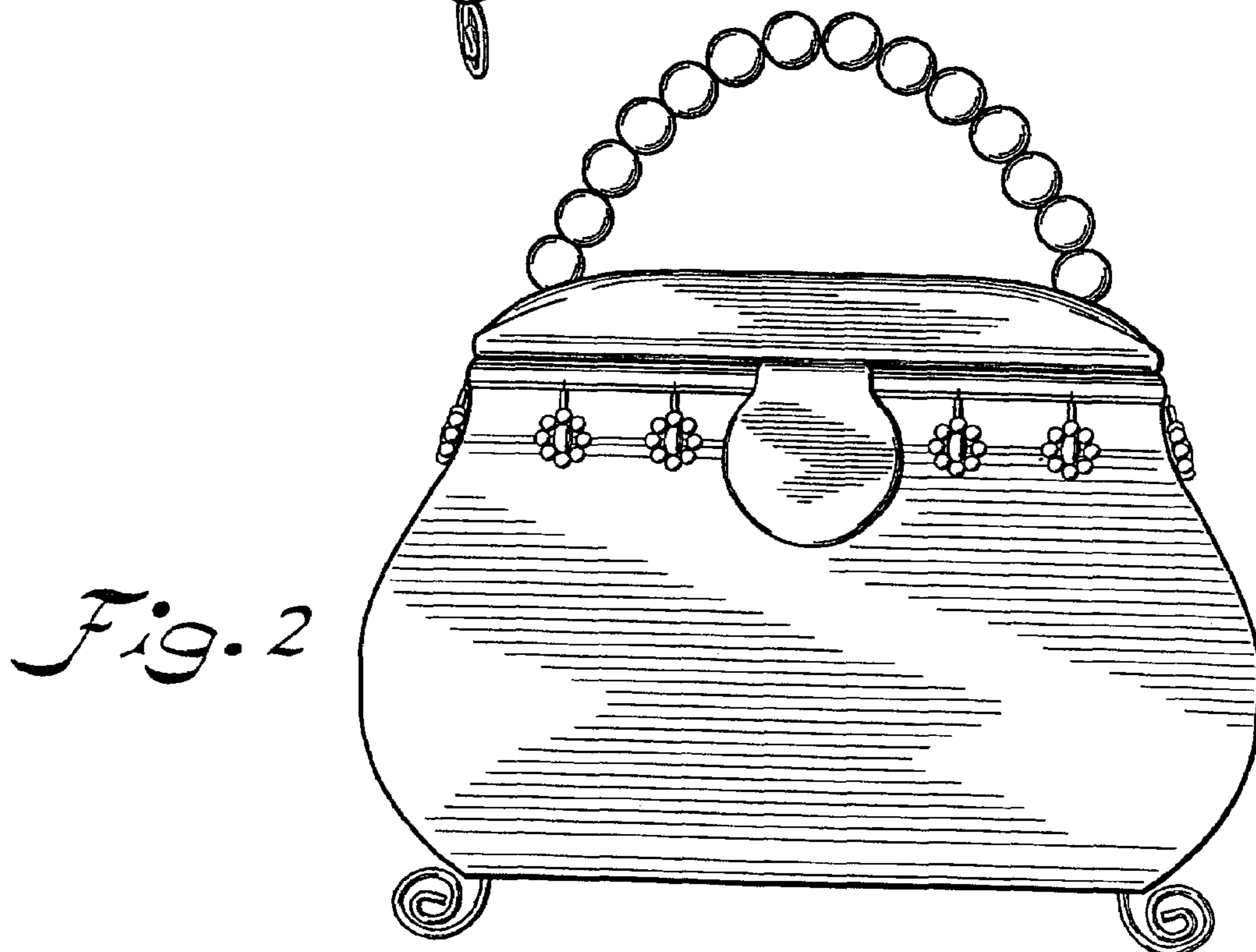

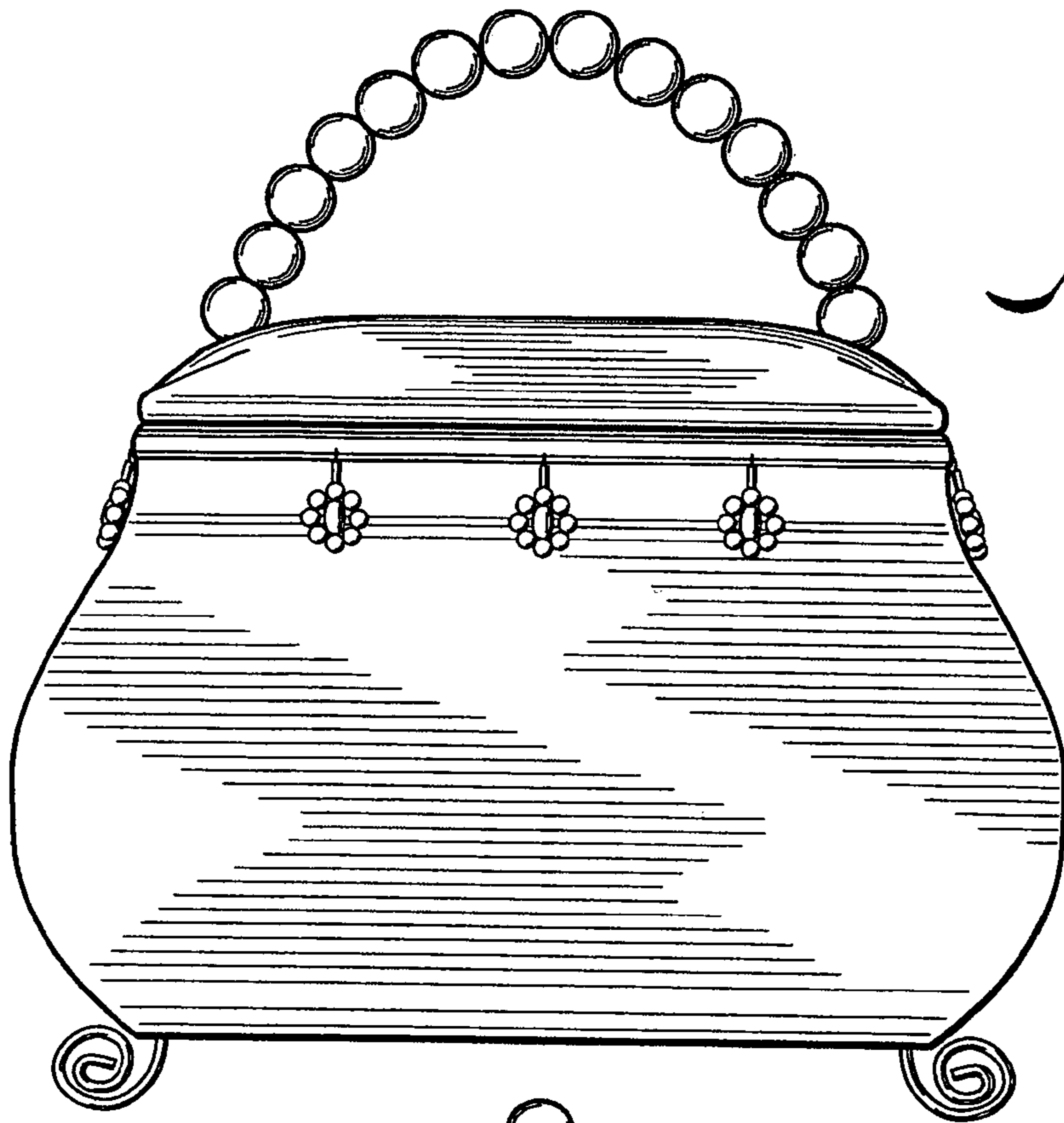

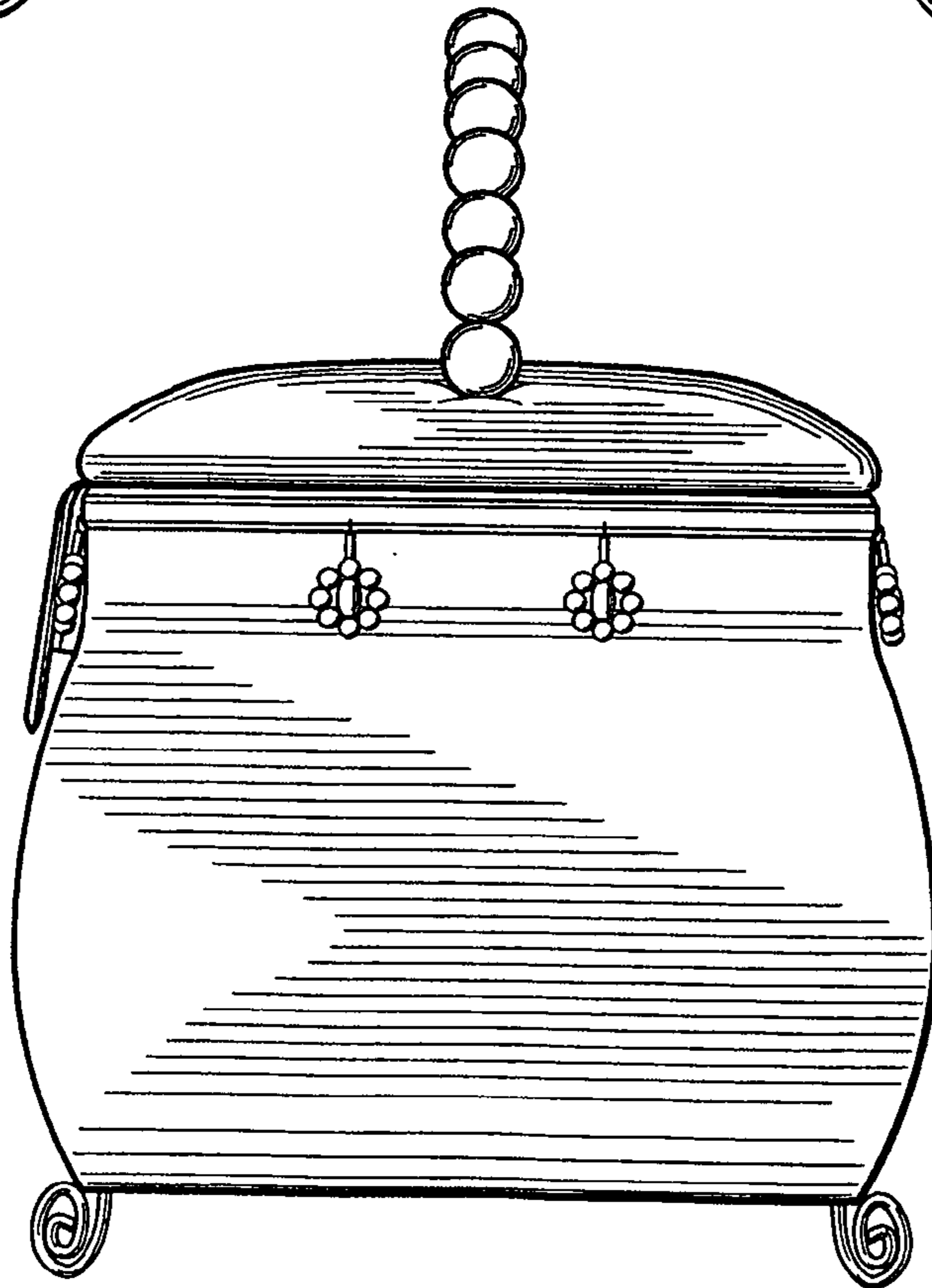

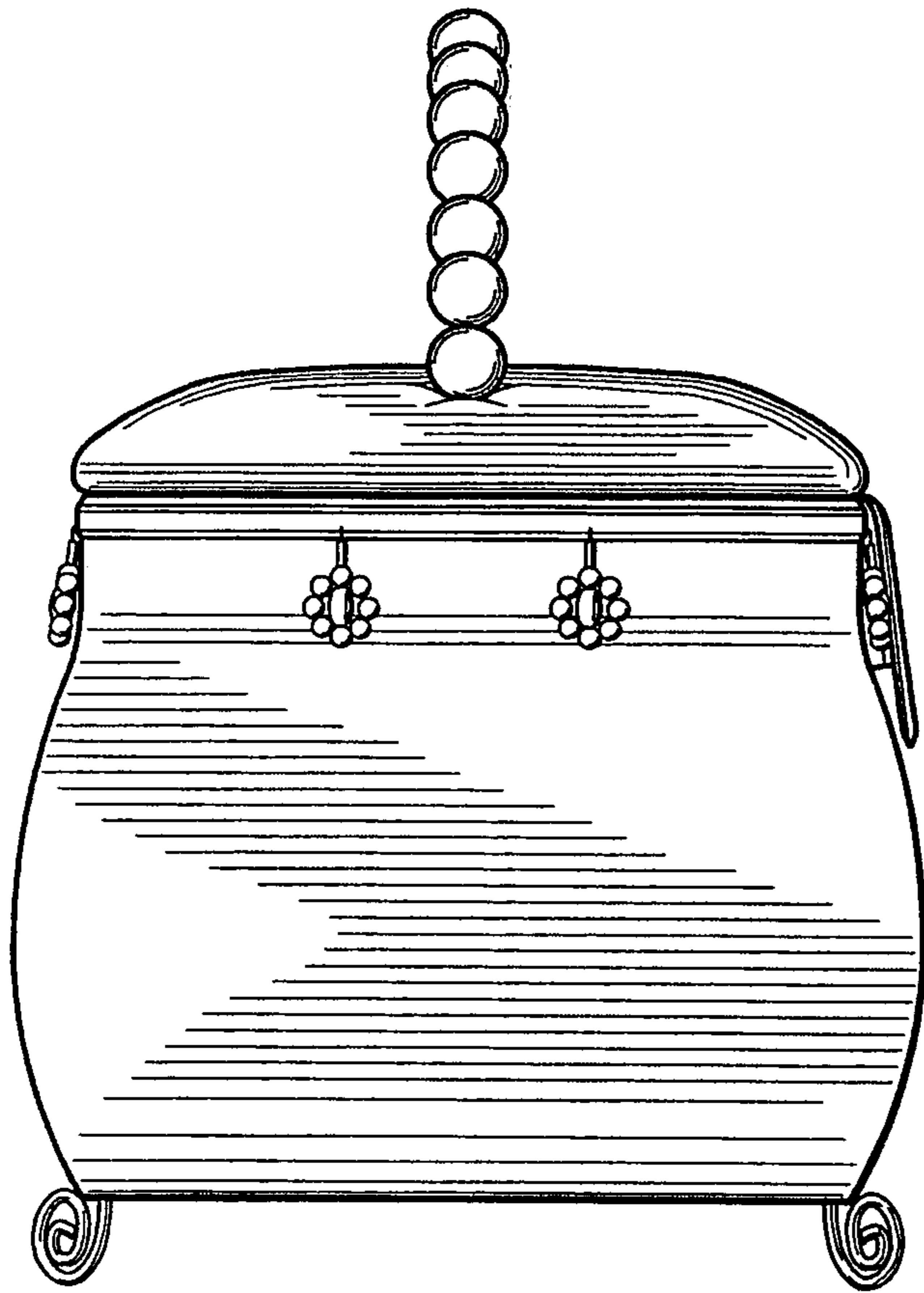

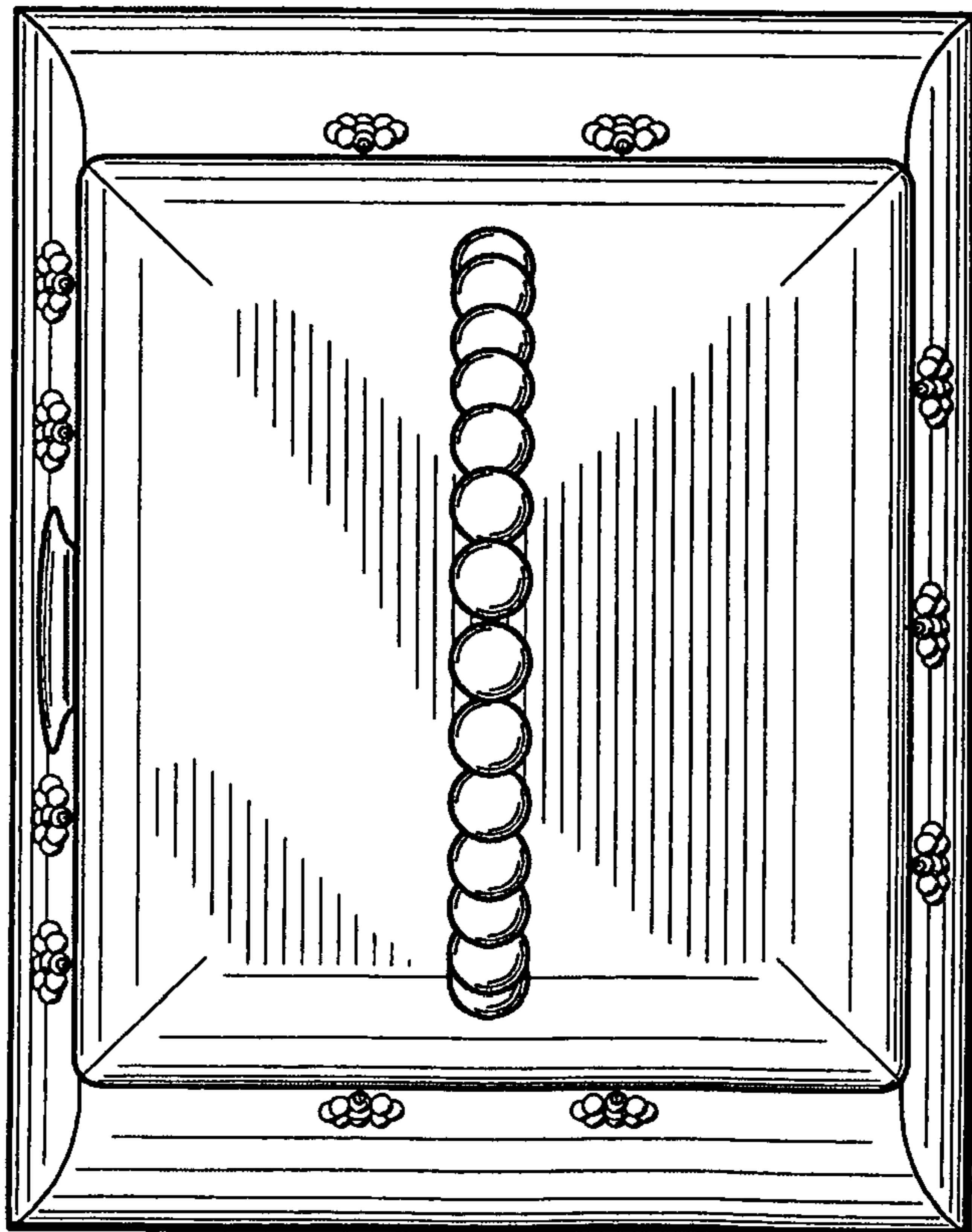

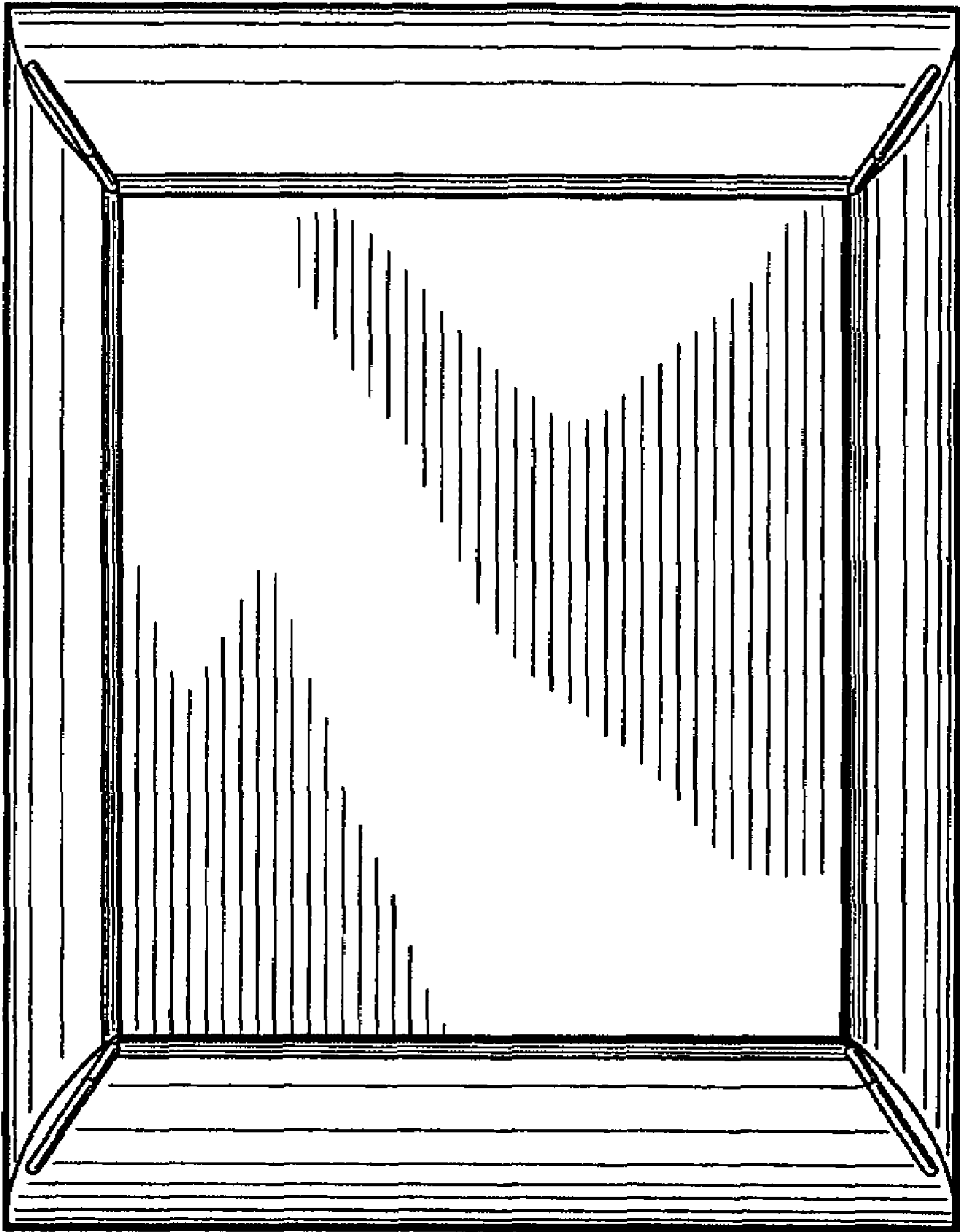

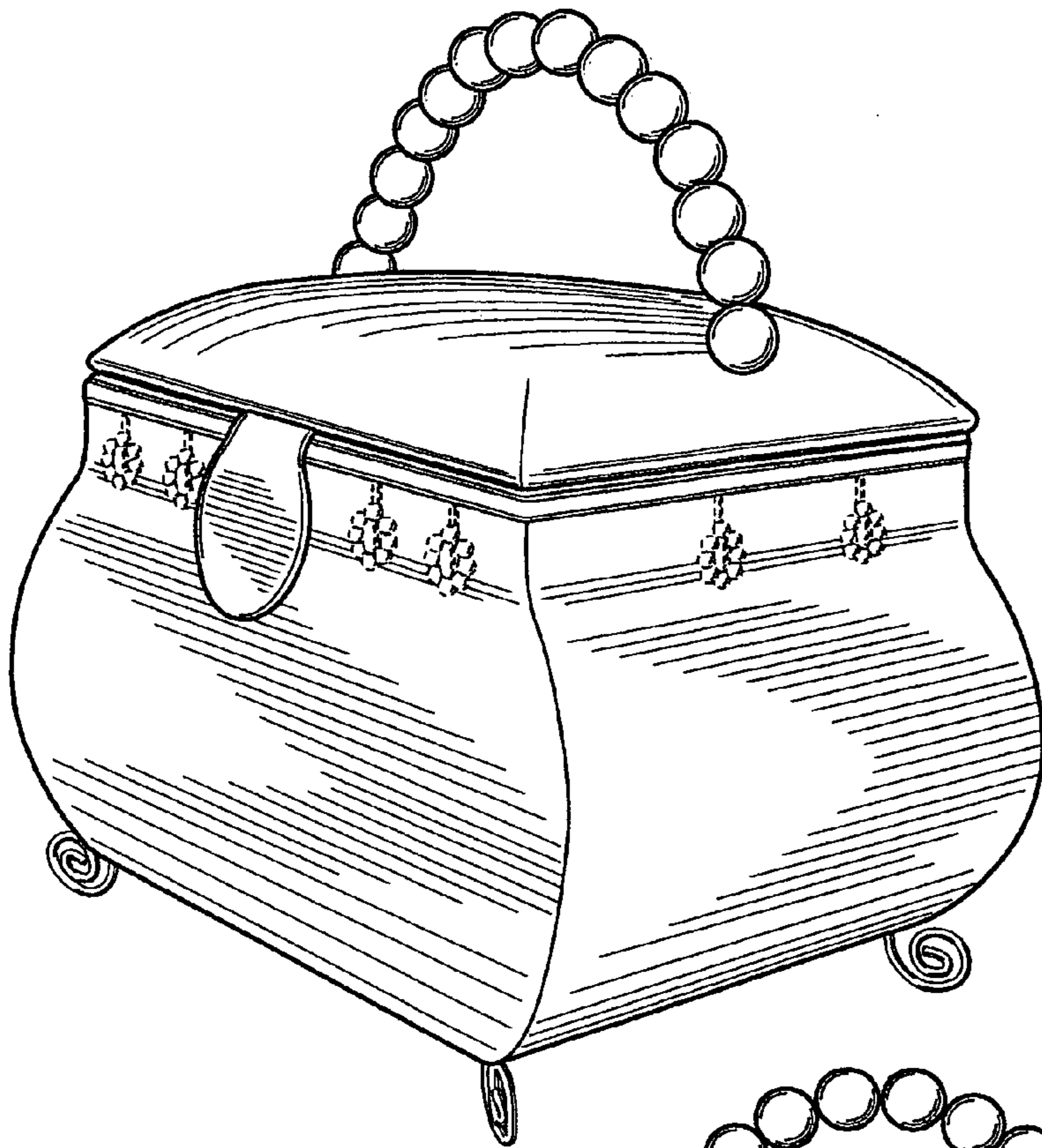

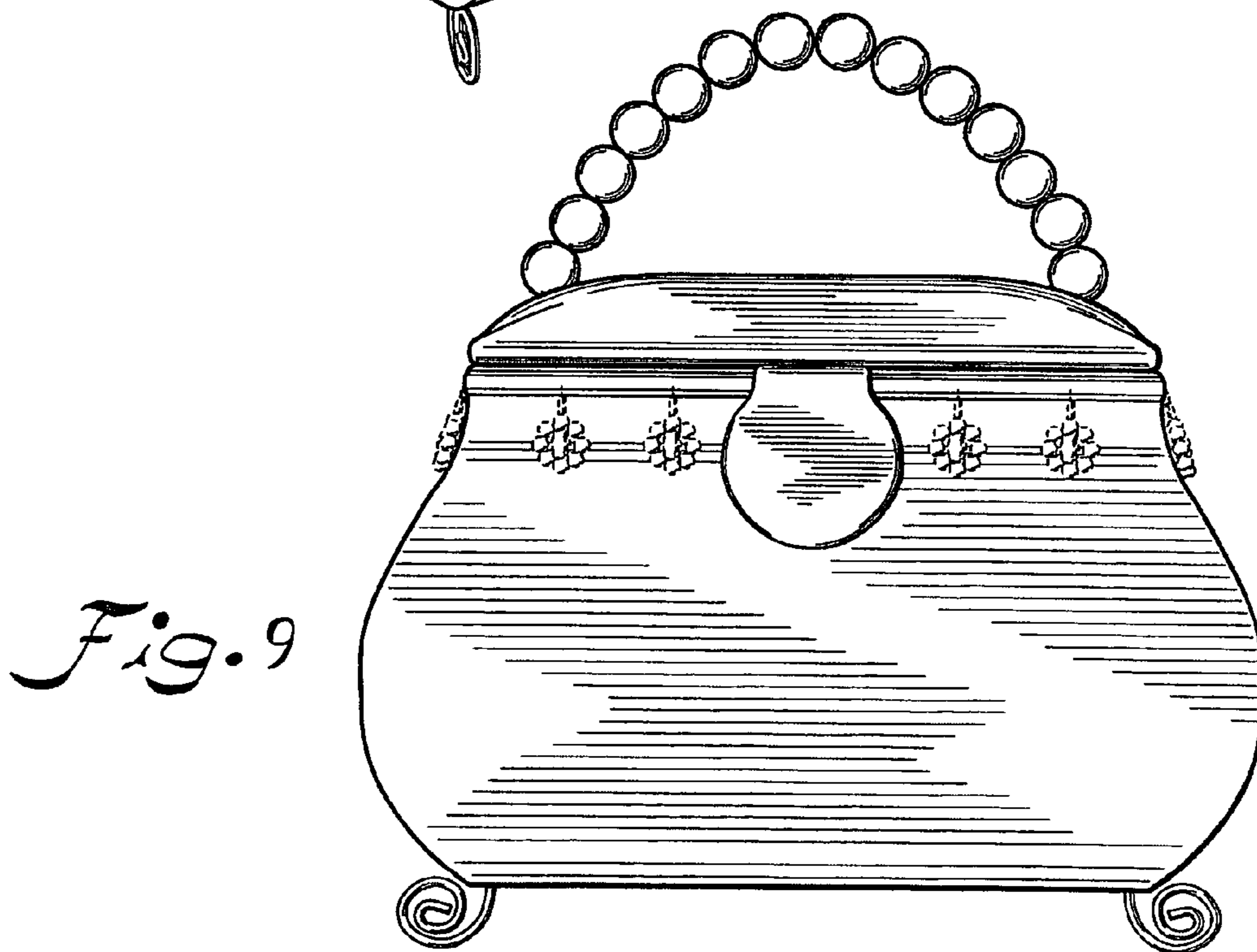

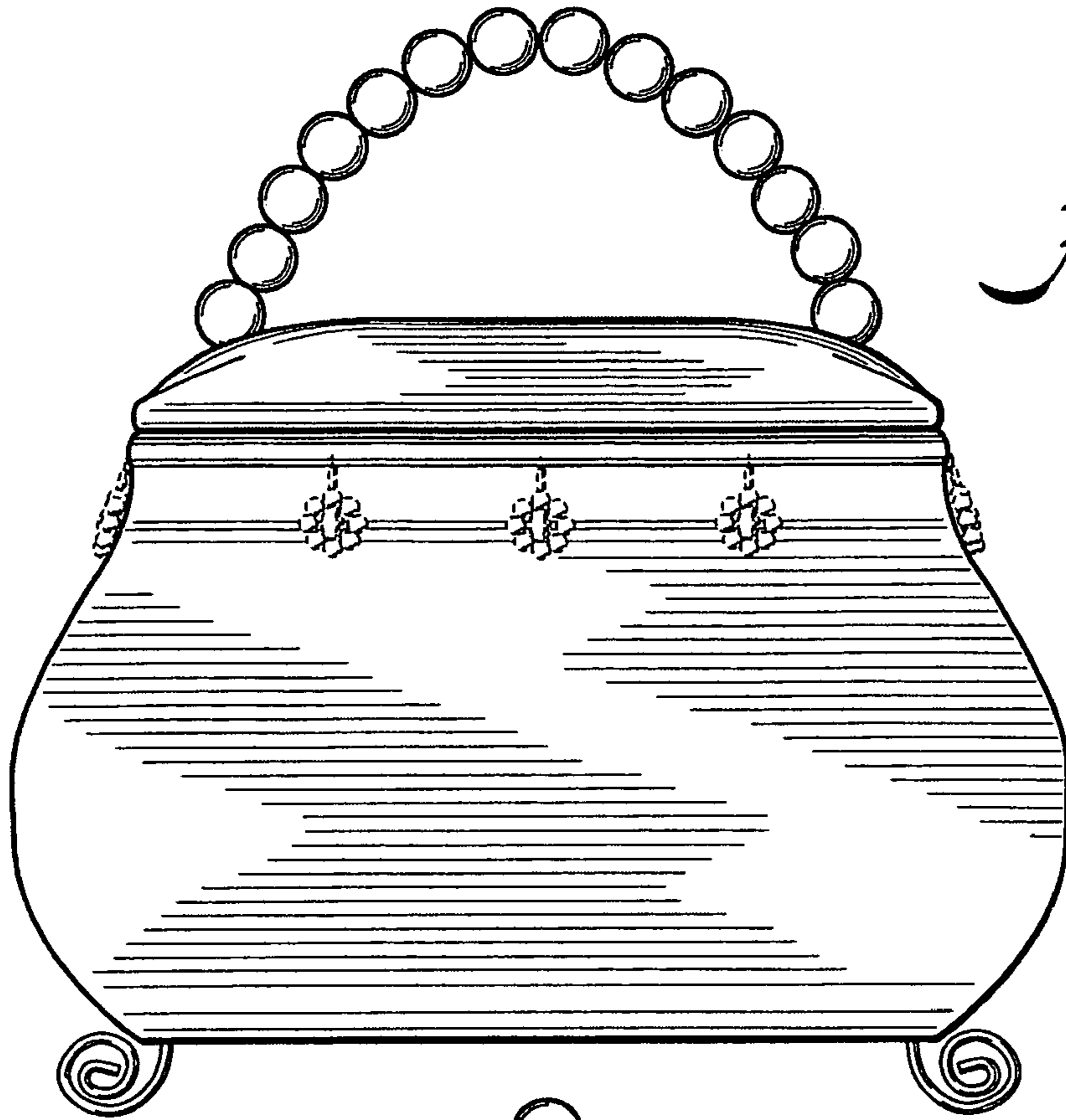

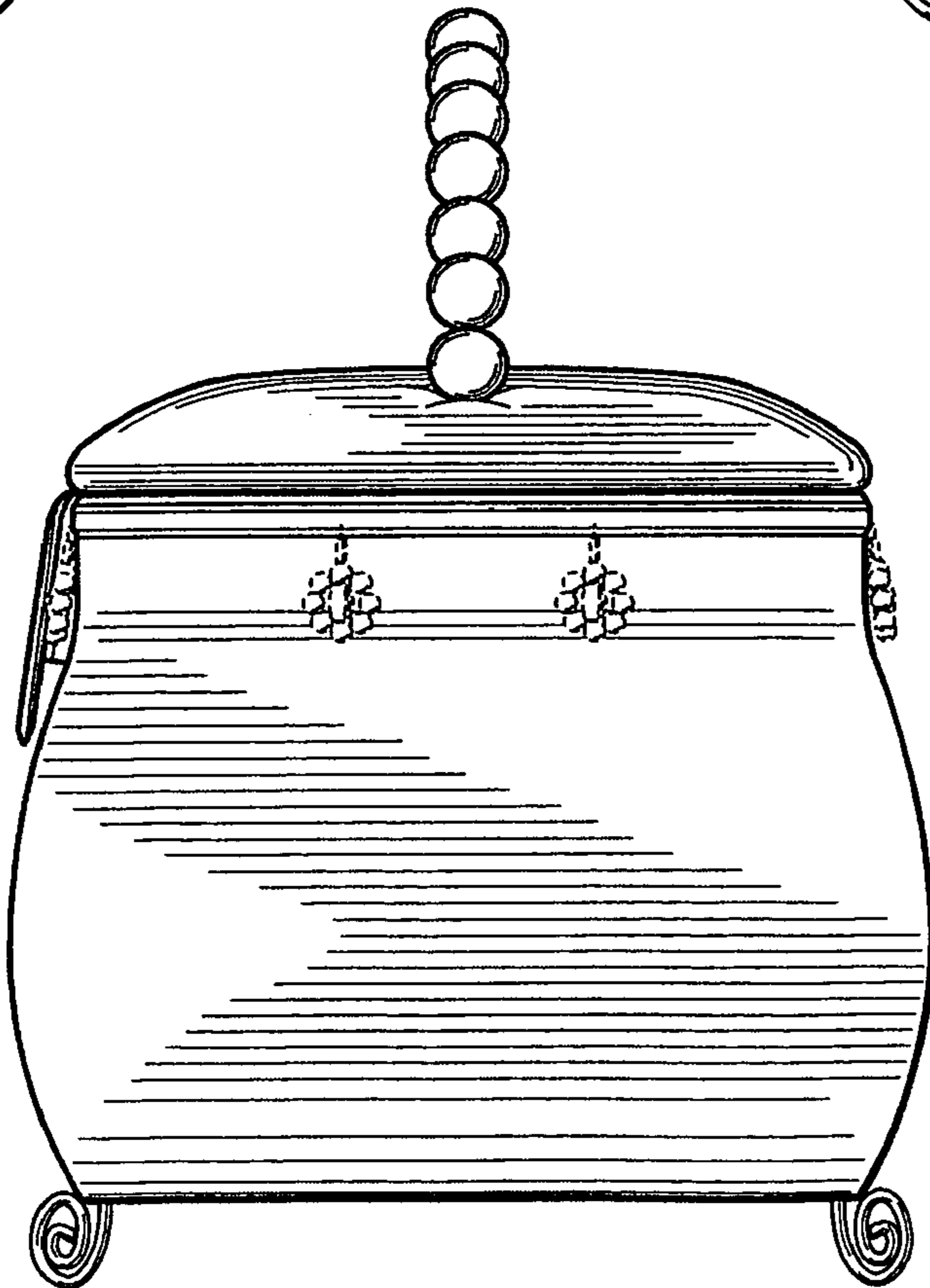

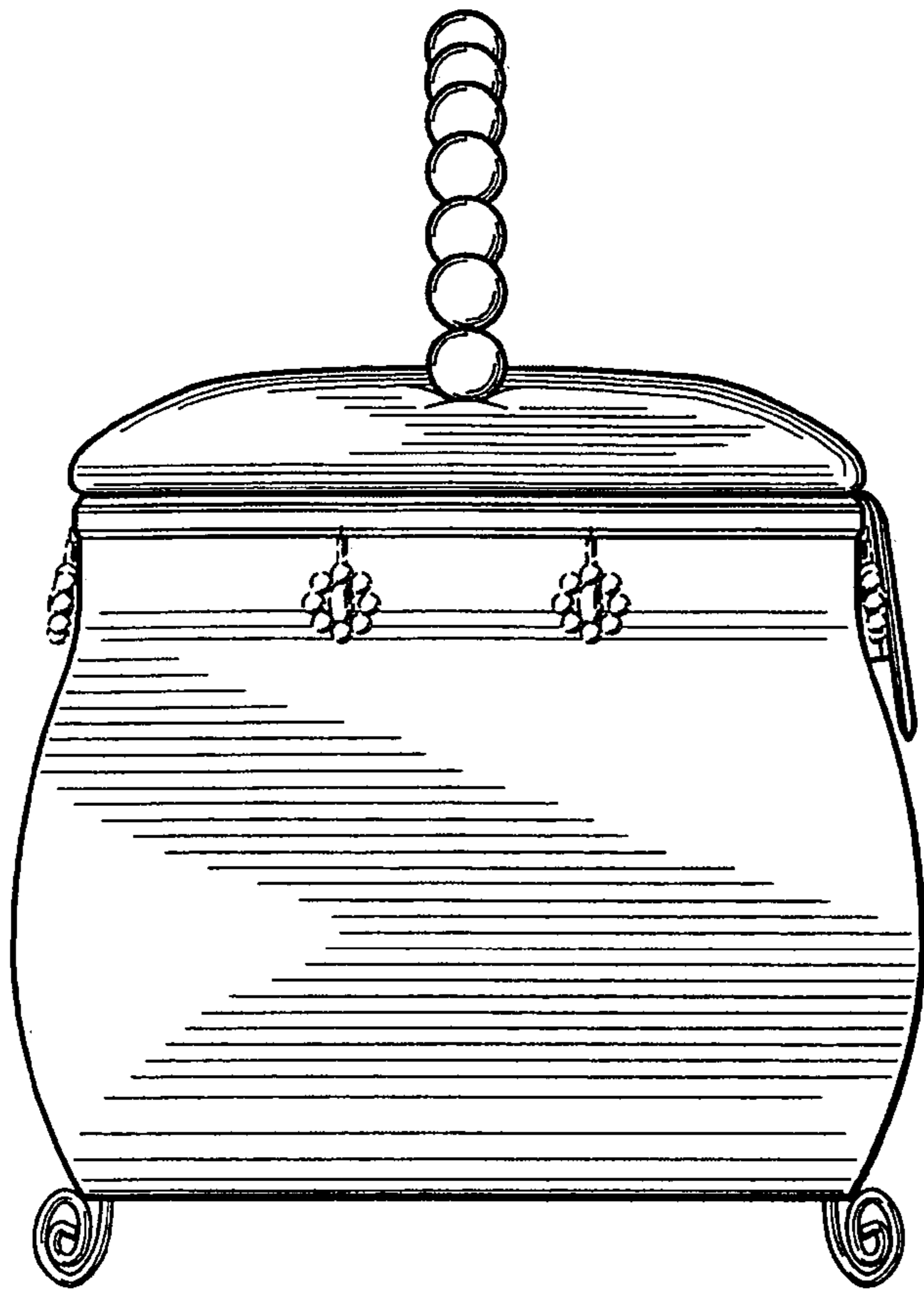

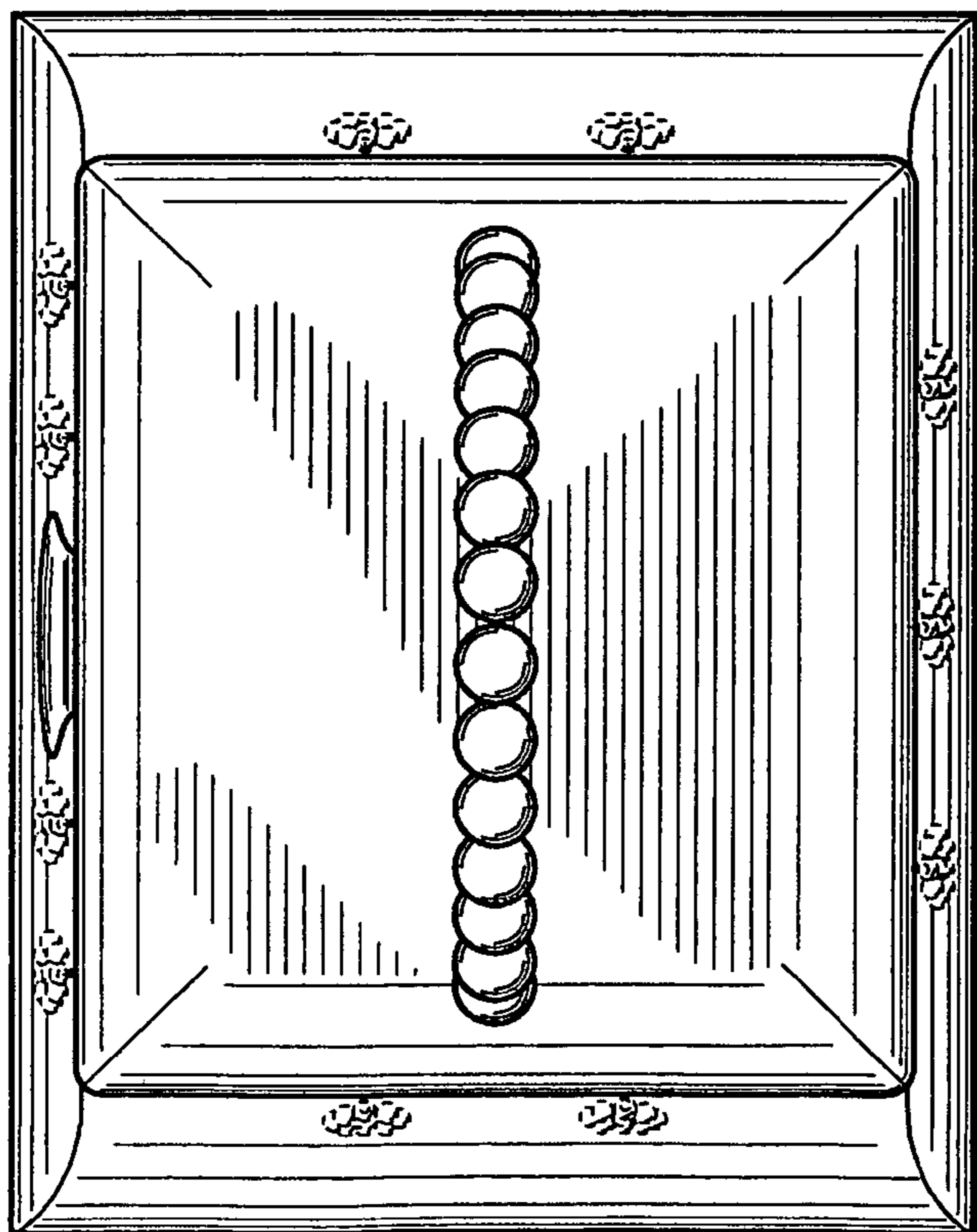

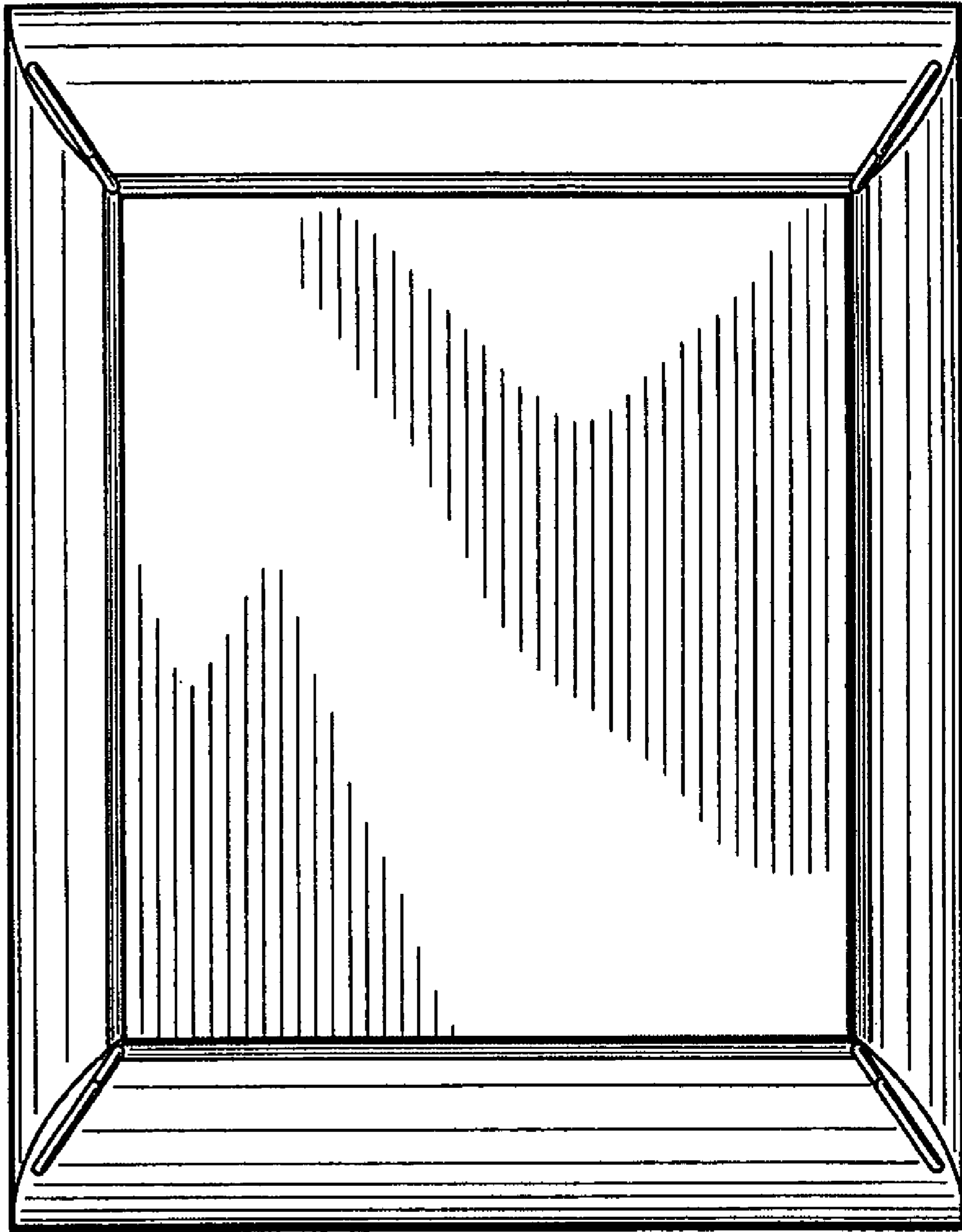
