(57) **CLAIM**

The ornamental design for a picture frame with graduation tassel retainer, as shown and described.

**DESCRIPTION**

The present invention relates generally to photograph or picture frames, and, more specifically, to a frame for displaying photographs in combination with a graduation tassel.

FIG. 1 is a front view of a picture frame with graduation tassel retainer according to the present invention;

FIG. 2 is a rear view of a picture frame with graduation tassel retainer according to the present invention;

FIG. 3 is a left side view of a picture frame with graduation tassel retainer according to the present invention;

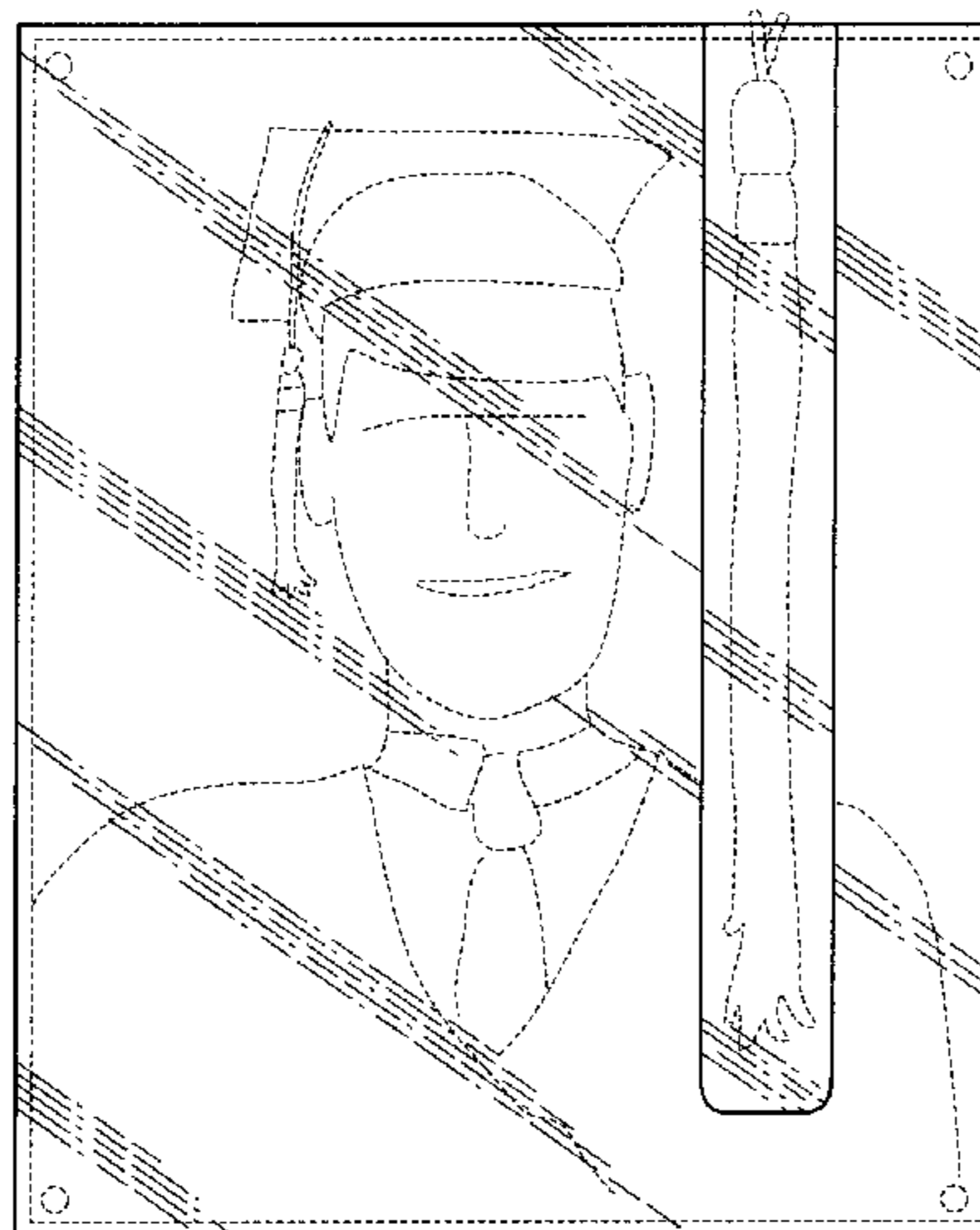
FIG. 4 is a right side view of a picture frame with graduation tassel retainer according to the present invention;

FIG. 5 is a bottom view of a picture frame with graduation tassel retainer according to the present invention; and,

FIG. 6 is a top view of a picture frame with graduation tassel retainer according to the present invention.

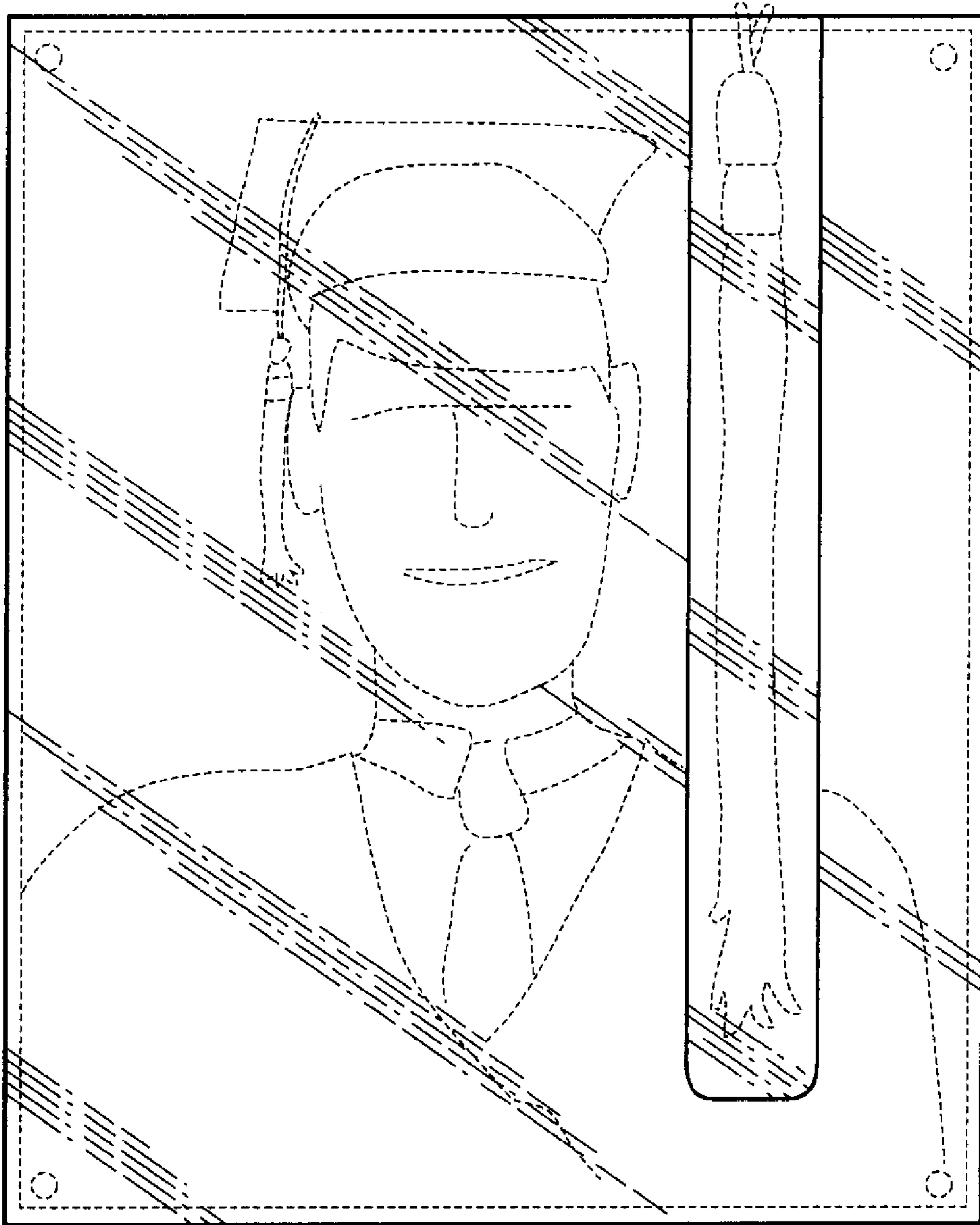

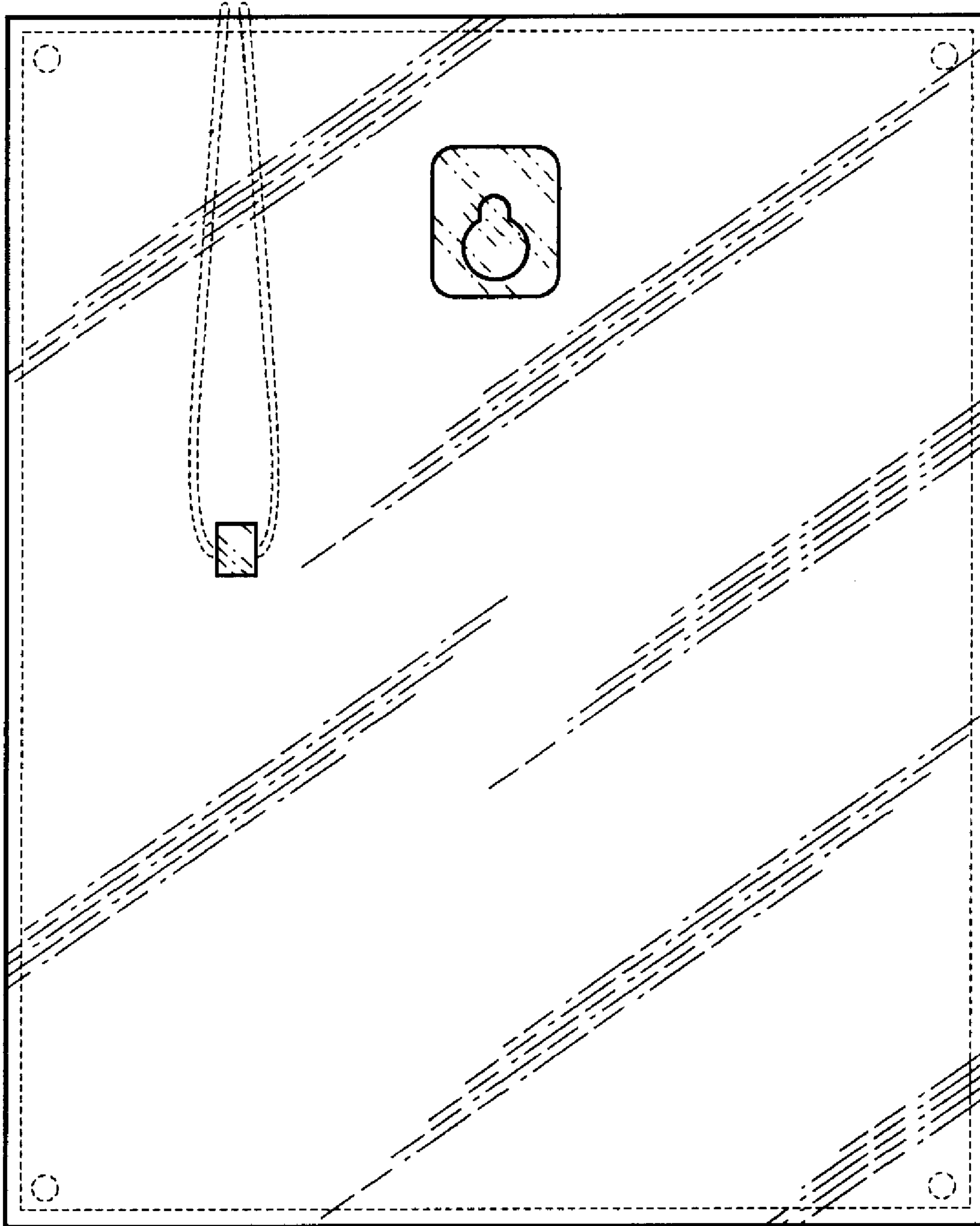

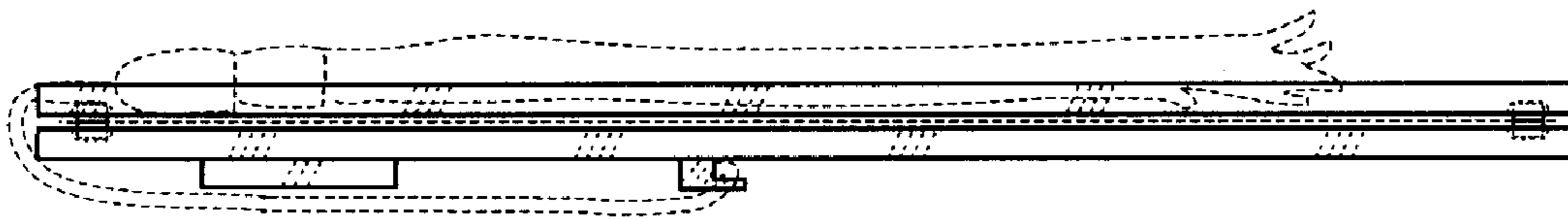

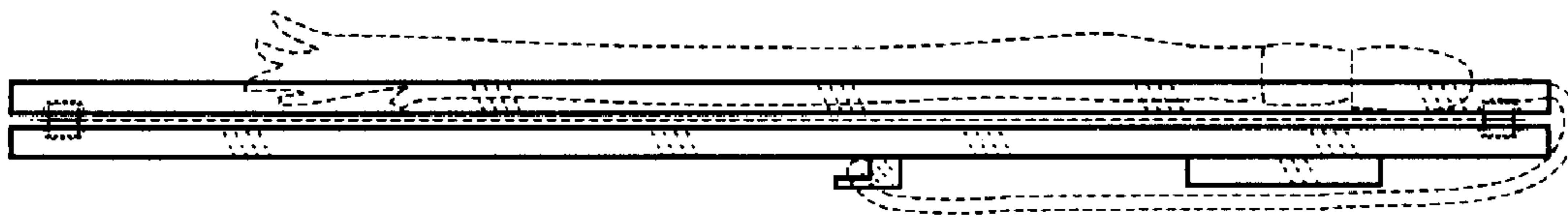

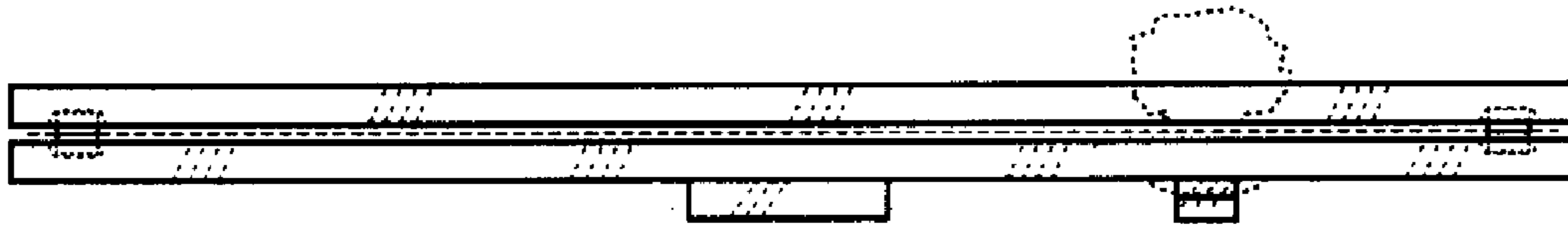

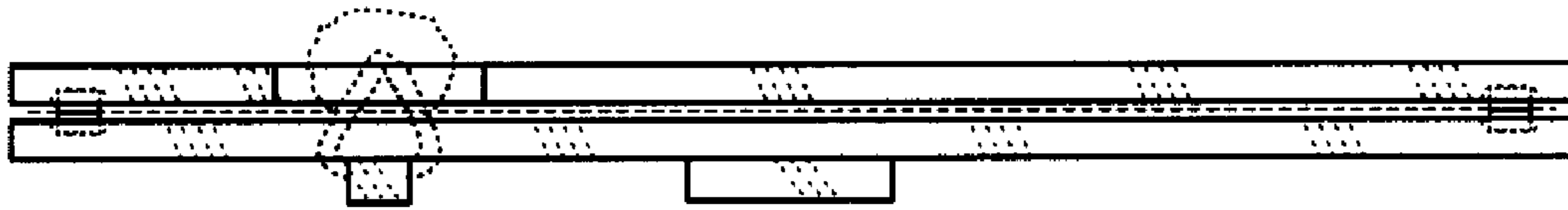
