(57) **CLAIM**

I claim the ornamental design for a sofa, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the sofa showing my design.

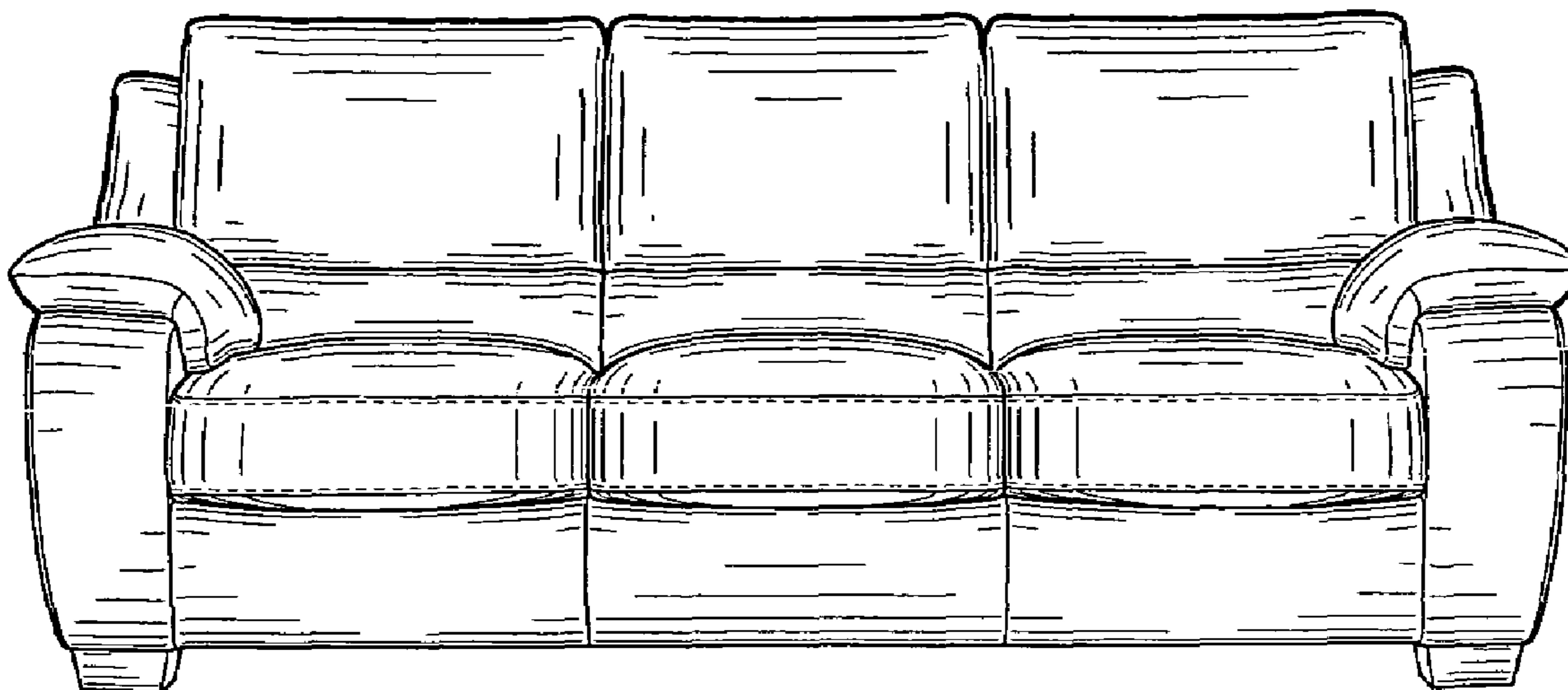
FIG. 2 is top plan view thereof;

FIG. 3 is a back perspective view thereof; and,

FIG. 4 is a side view thereof, an opposite side view being a mirror image thereof.

The broken lines shown on the sofa are understood to represent stitching.

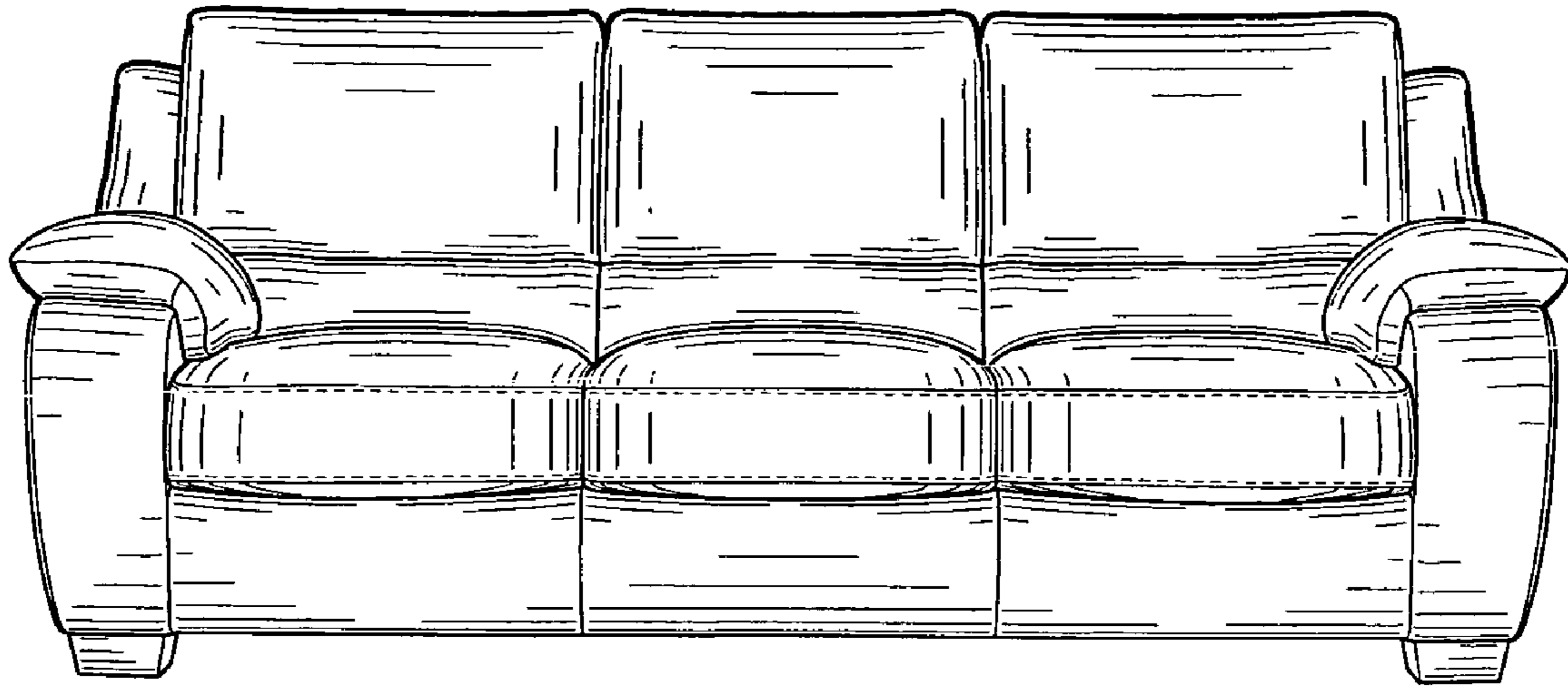

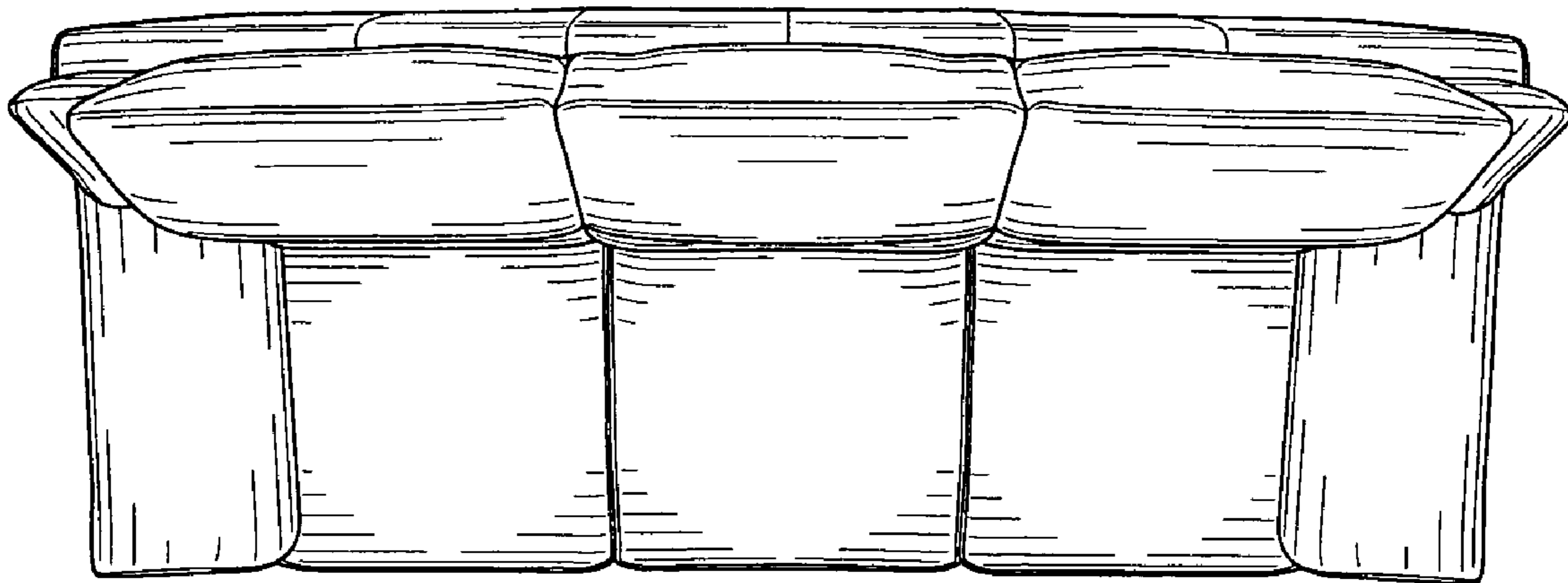

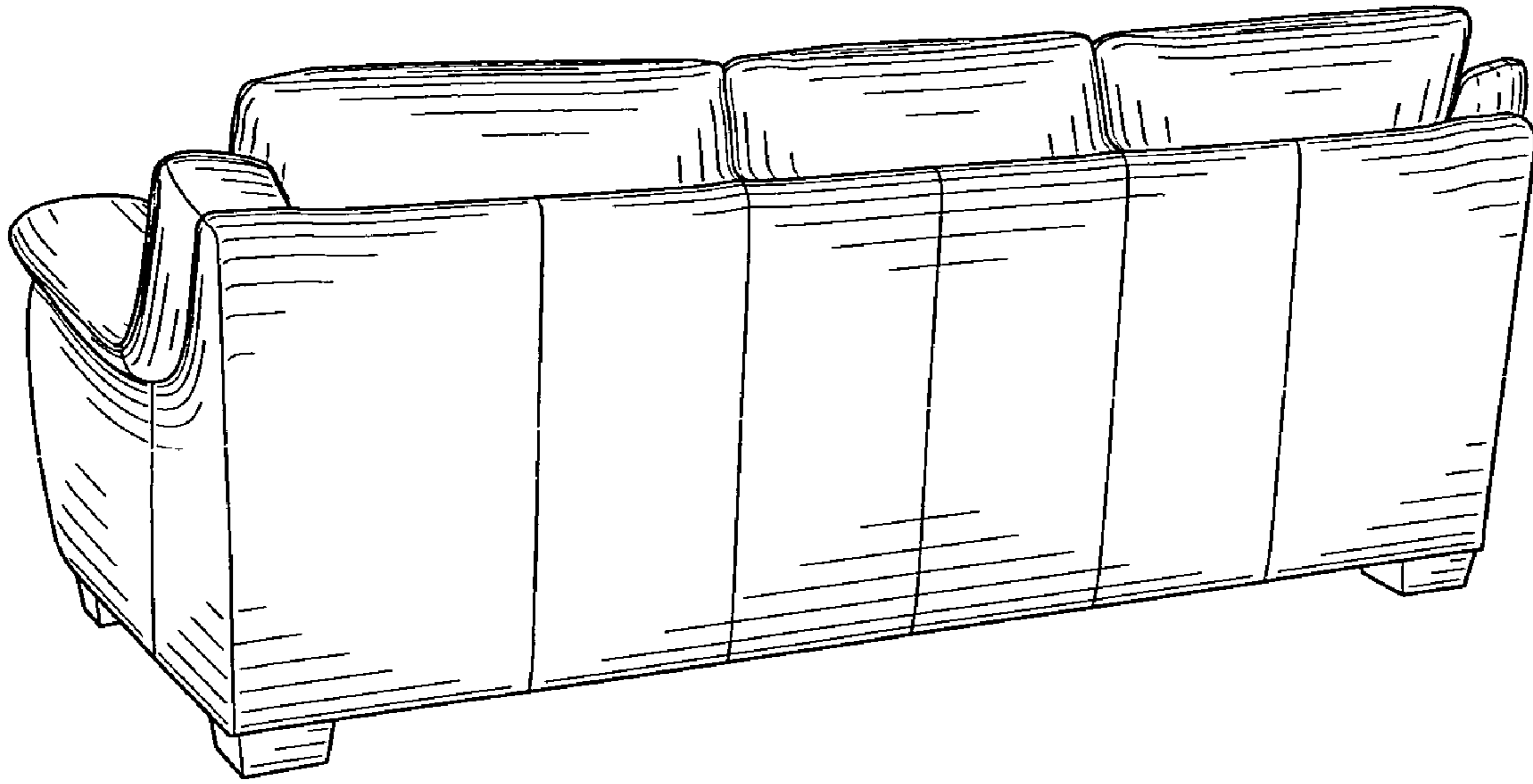

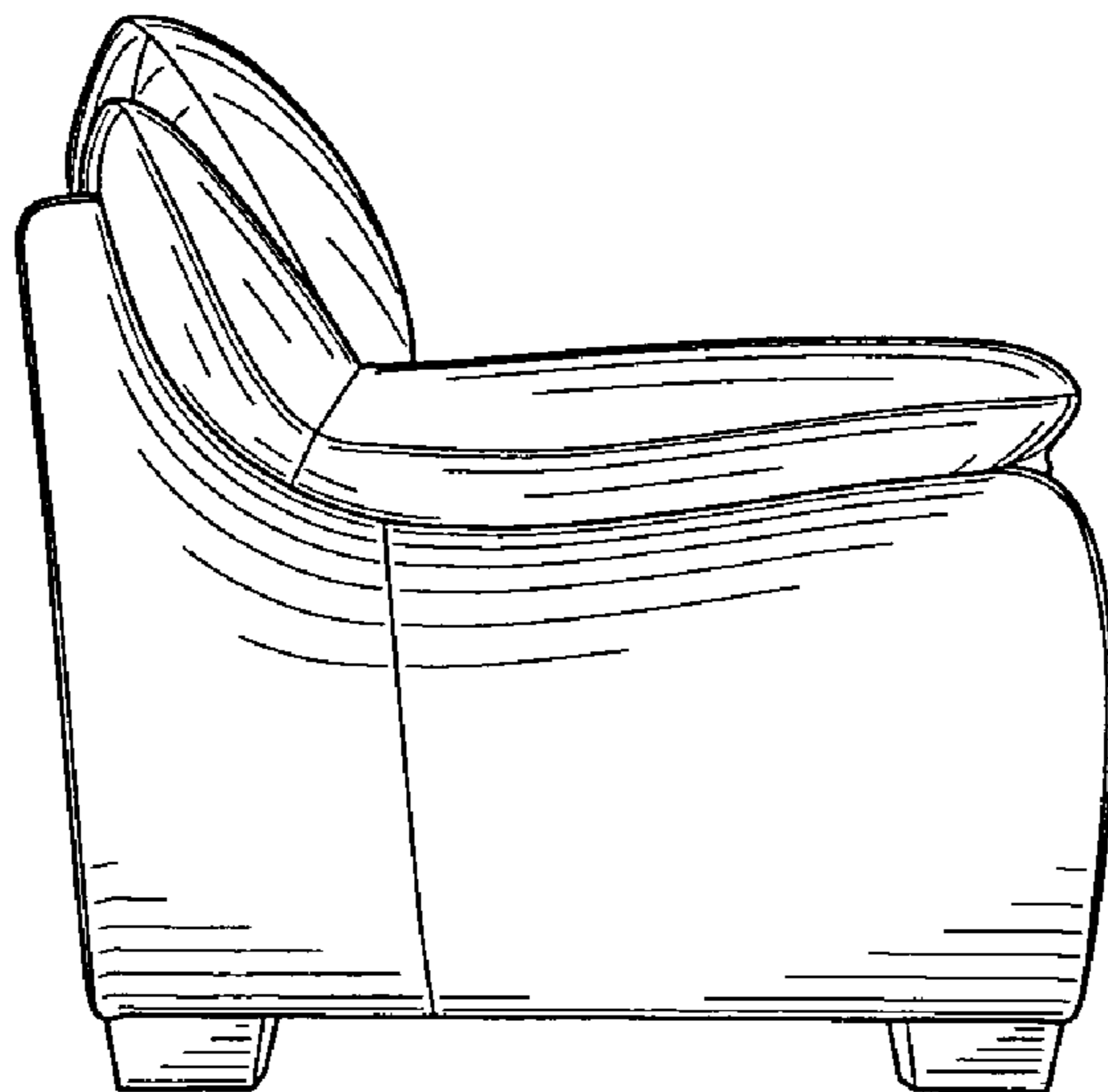
