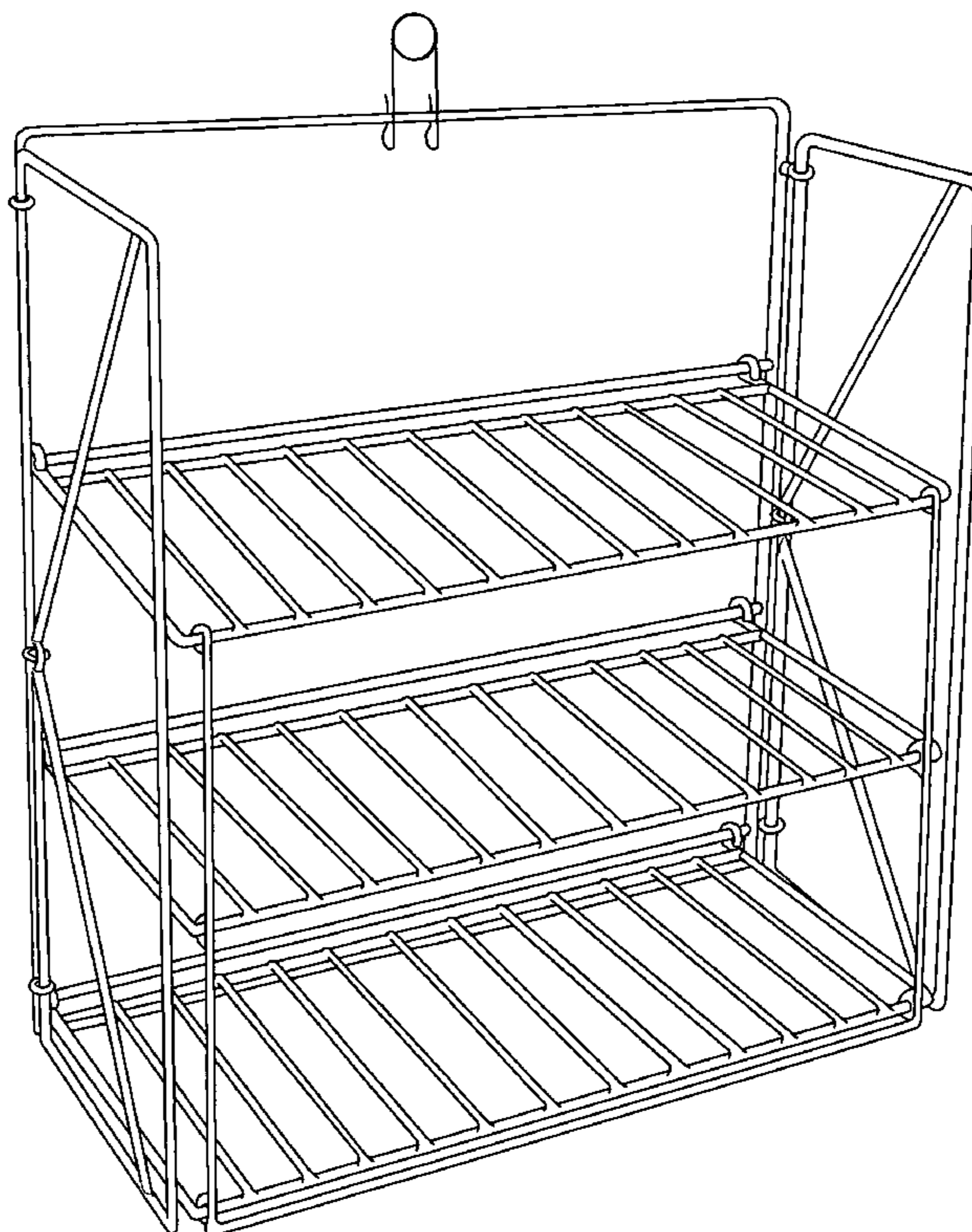
FIG. 3 is a perspective view from the back of the ornamental design of the collapsible shelf unit of the invention.

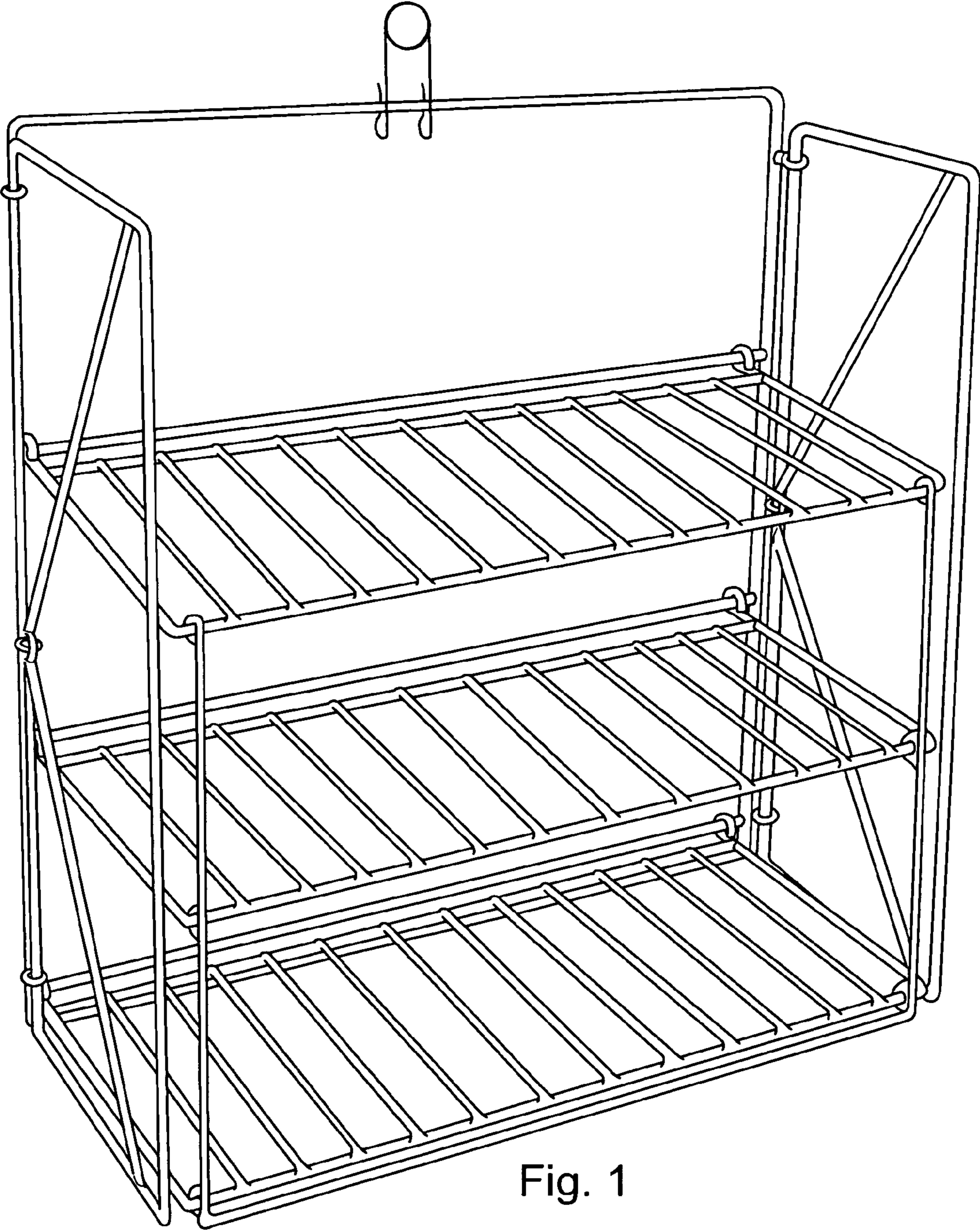

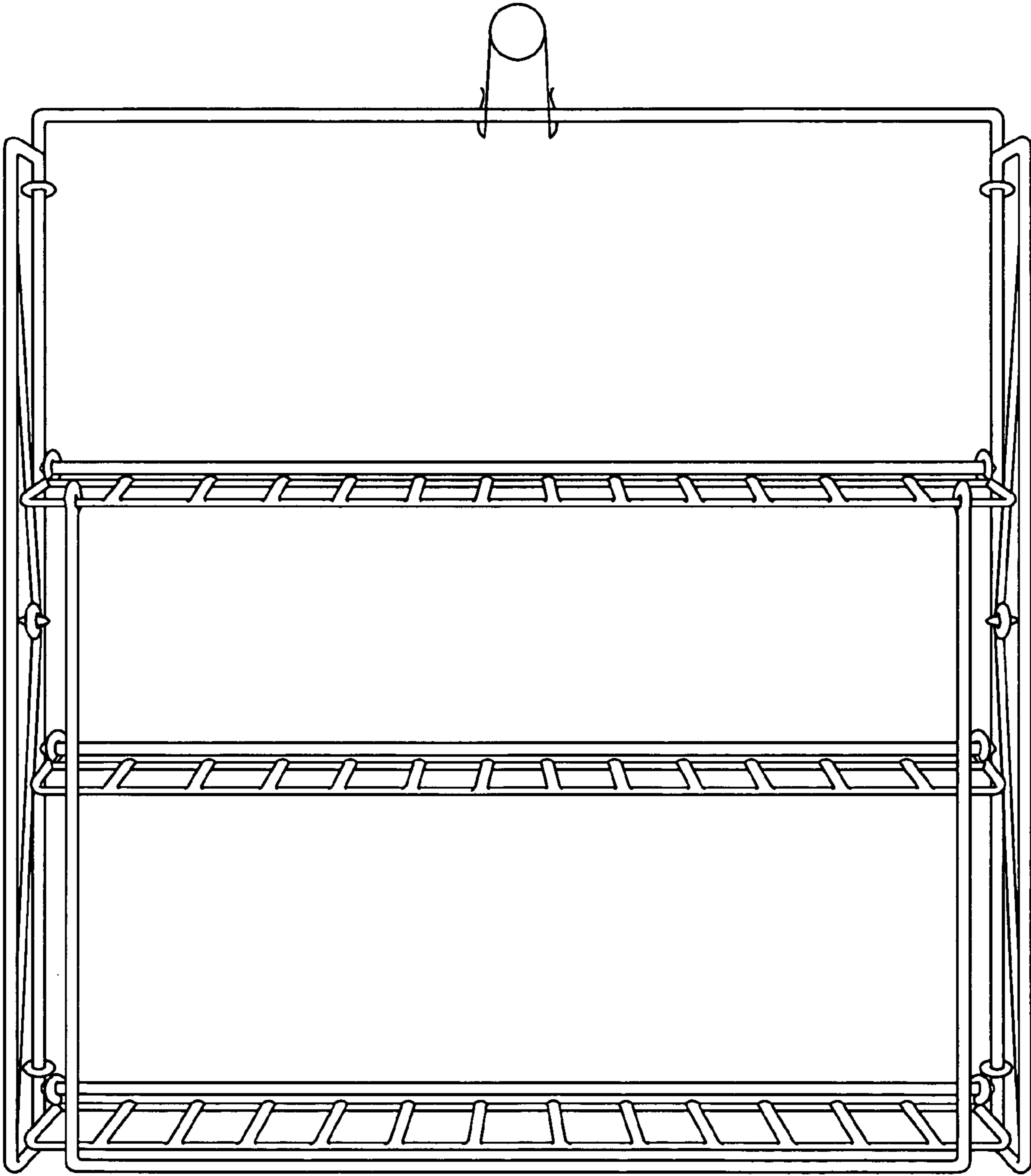

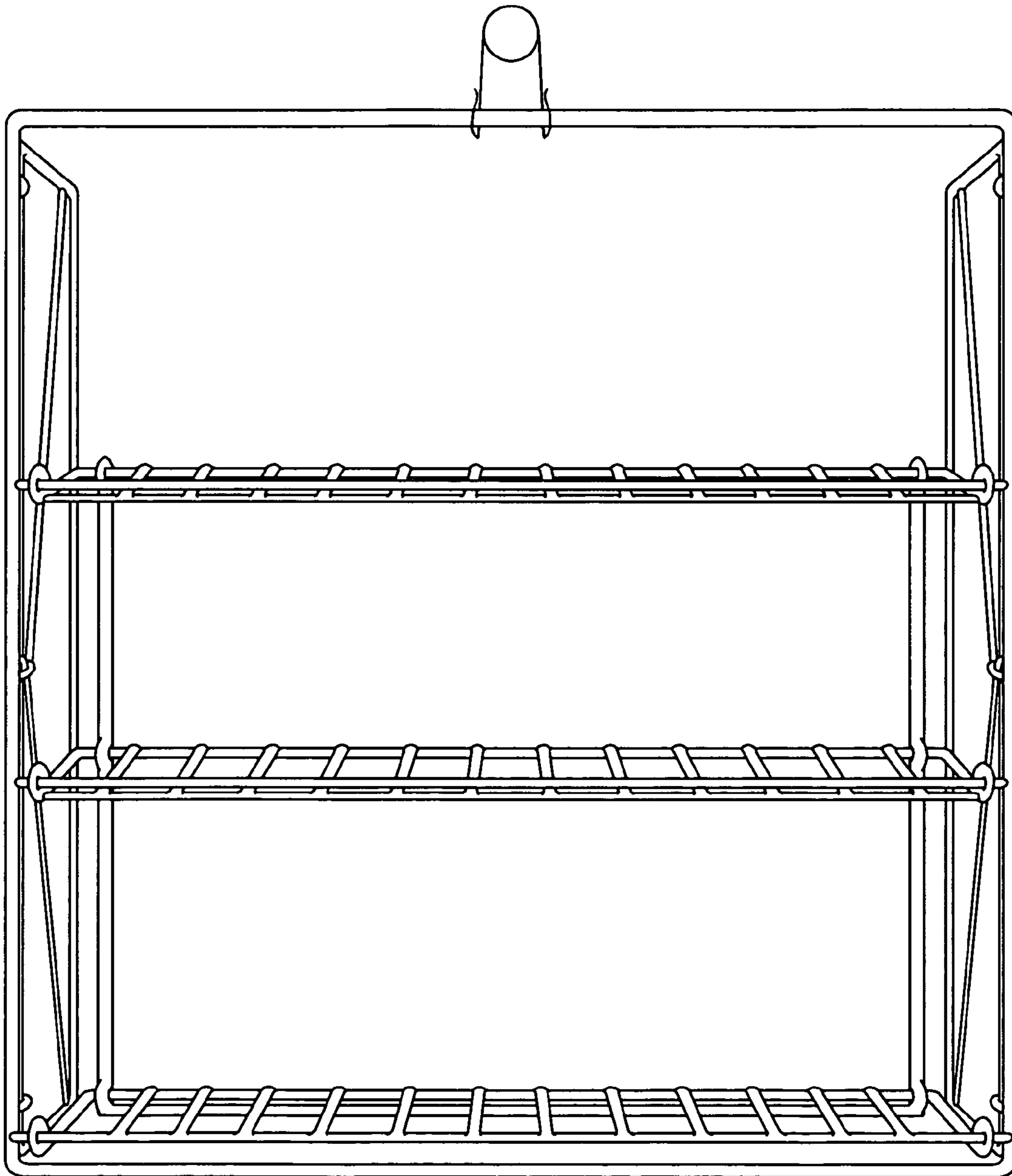

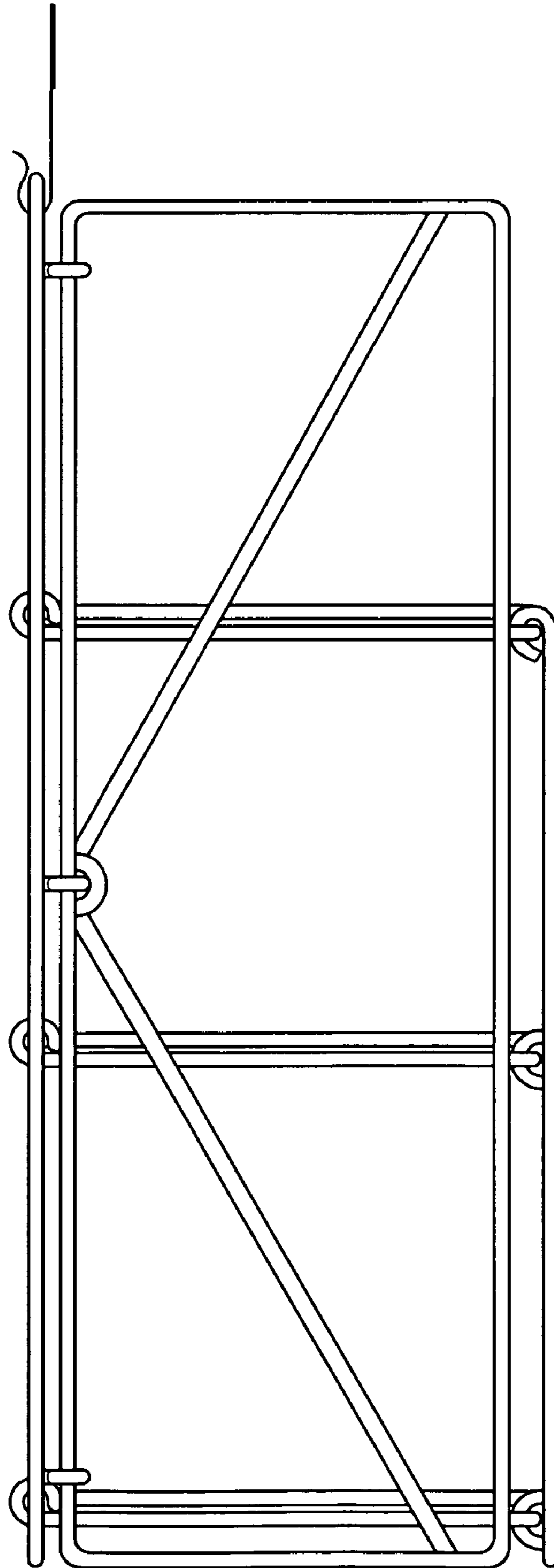

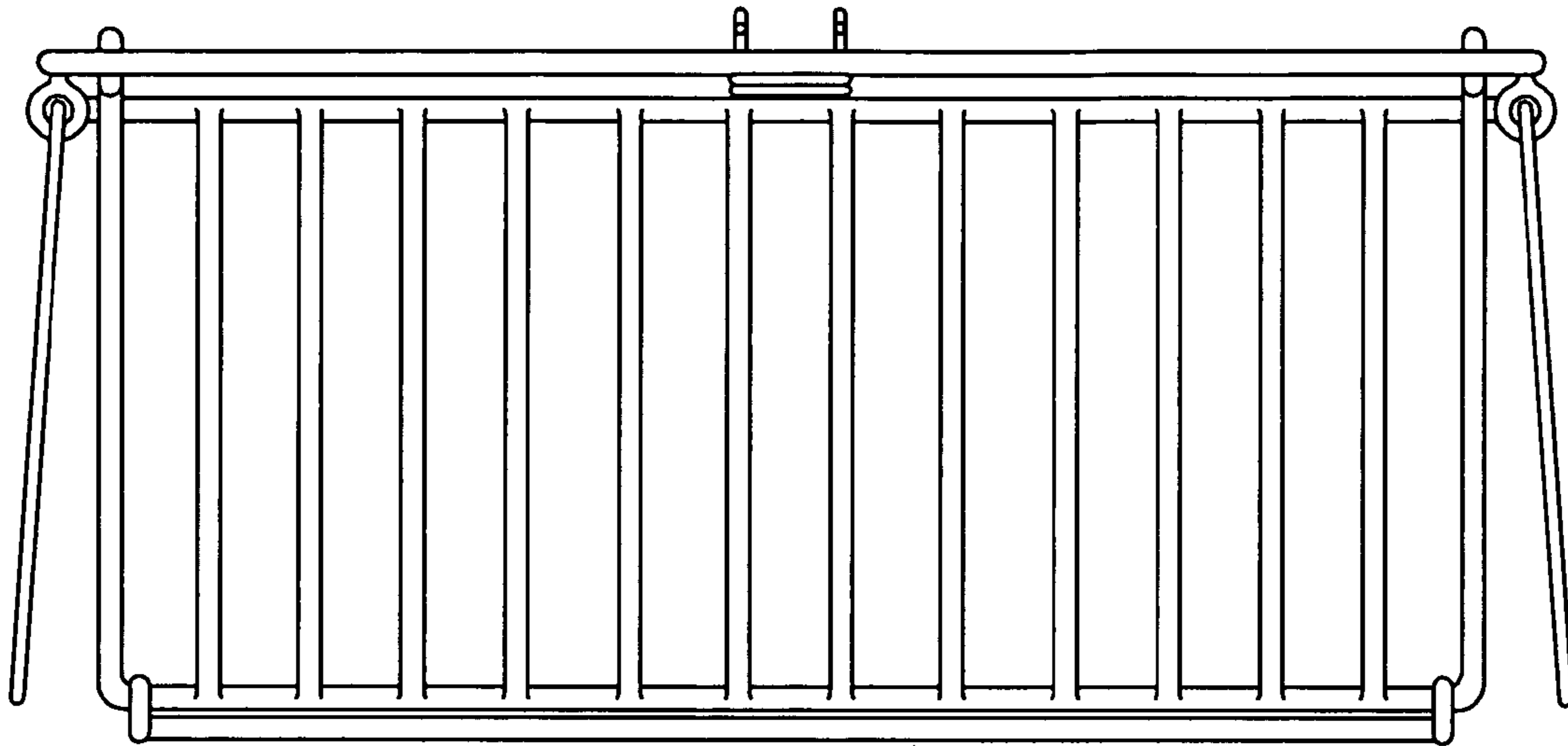

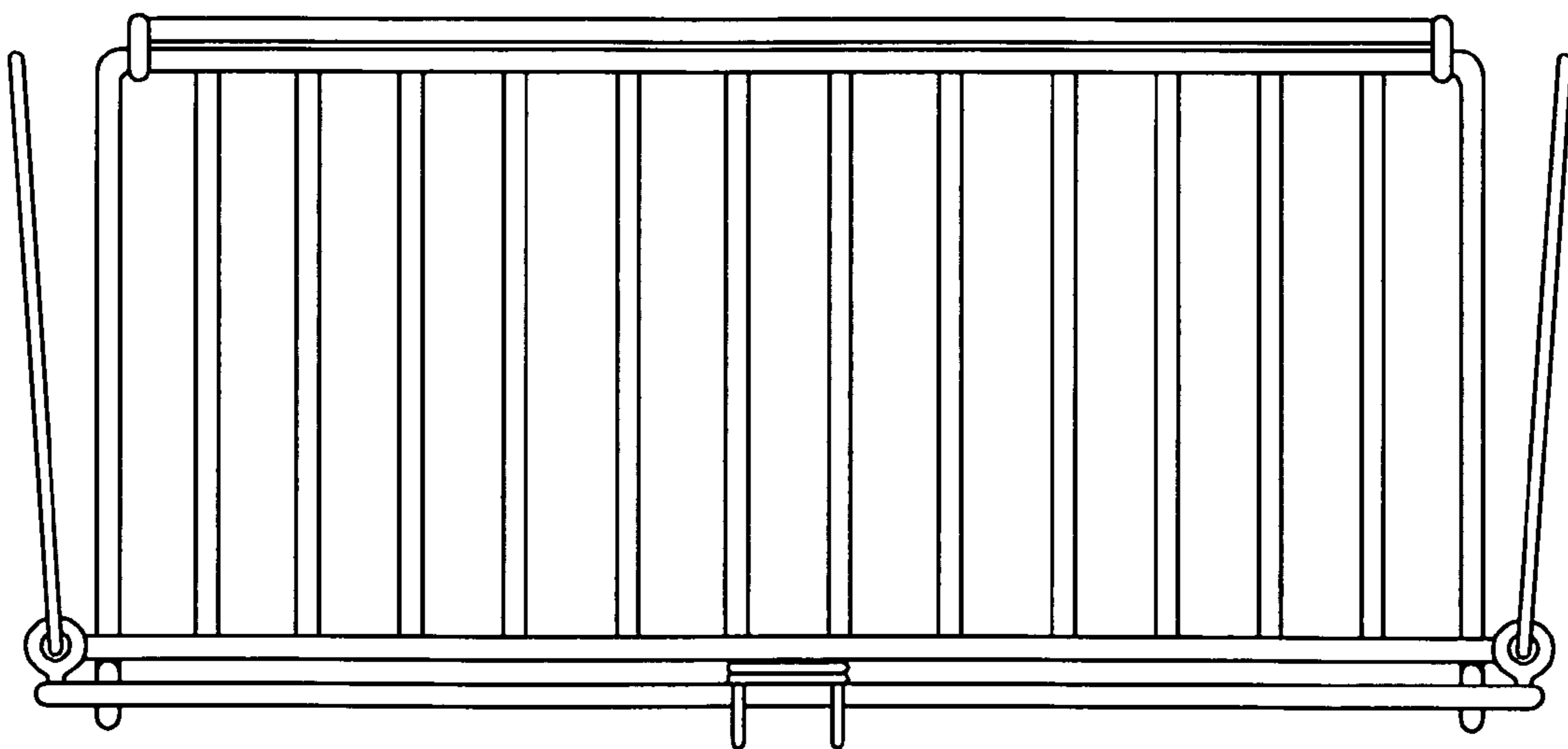
