**DESCRIPTION**

FIG. 1 is a perspective view of a beverage cup showing my new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

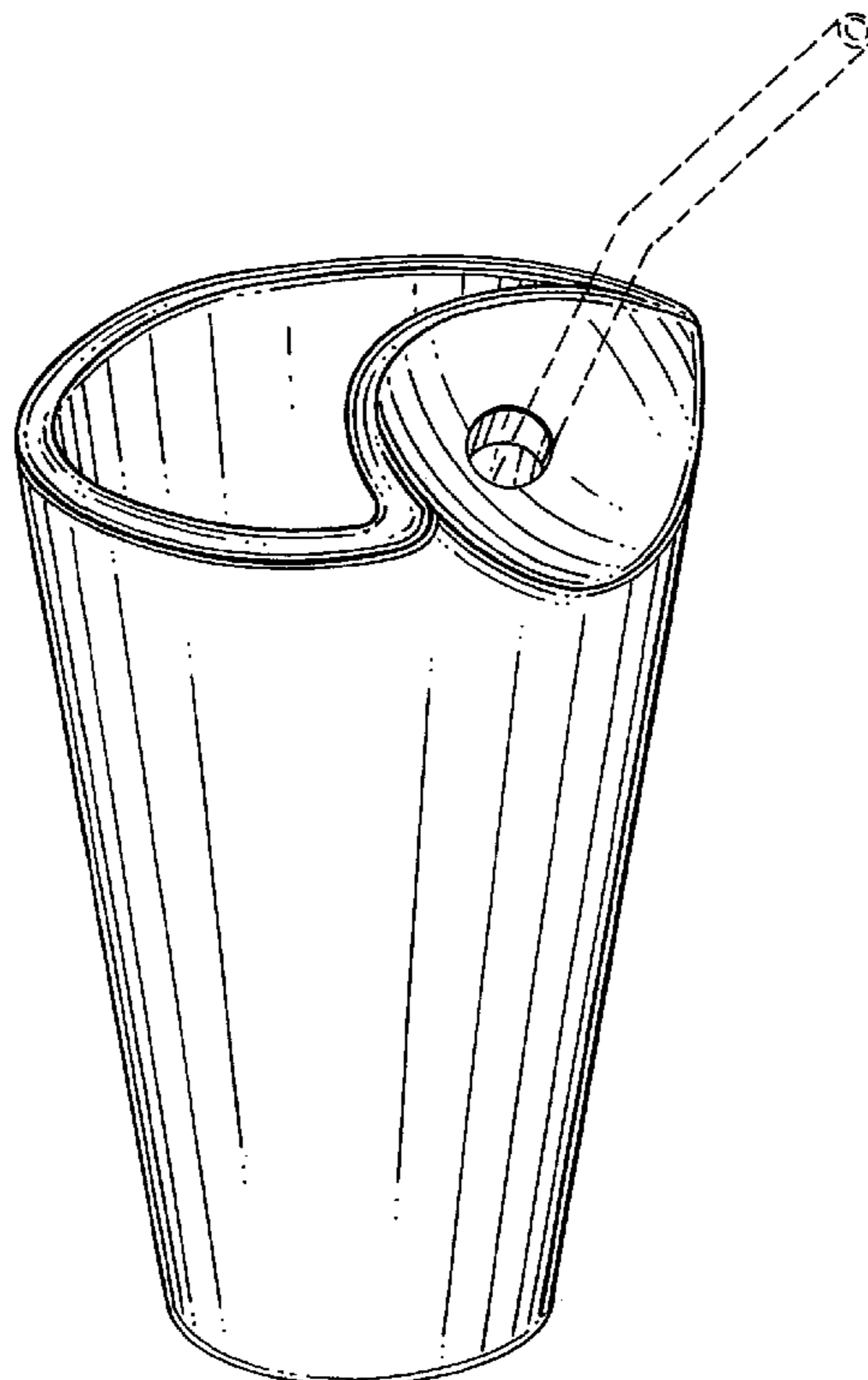
FIG. 5 is a rear elevational view thereof; and,

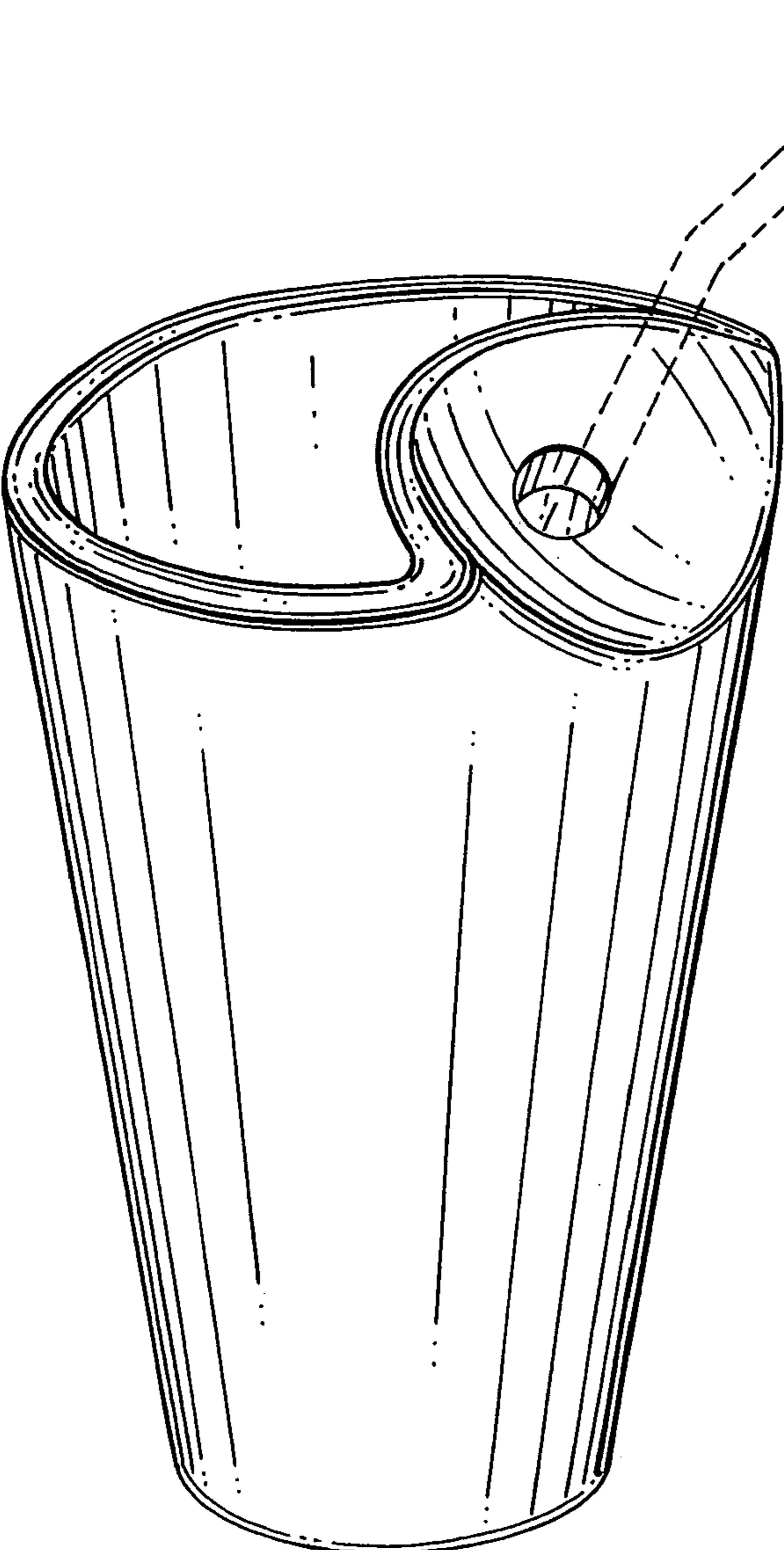

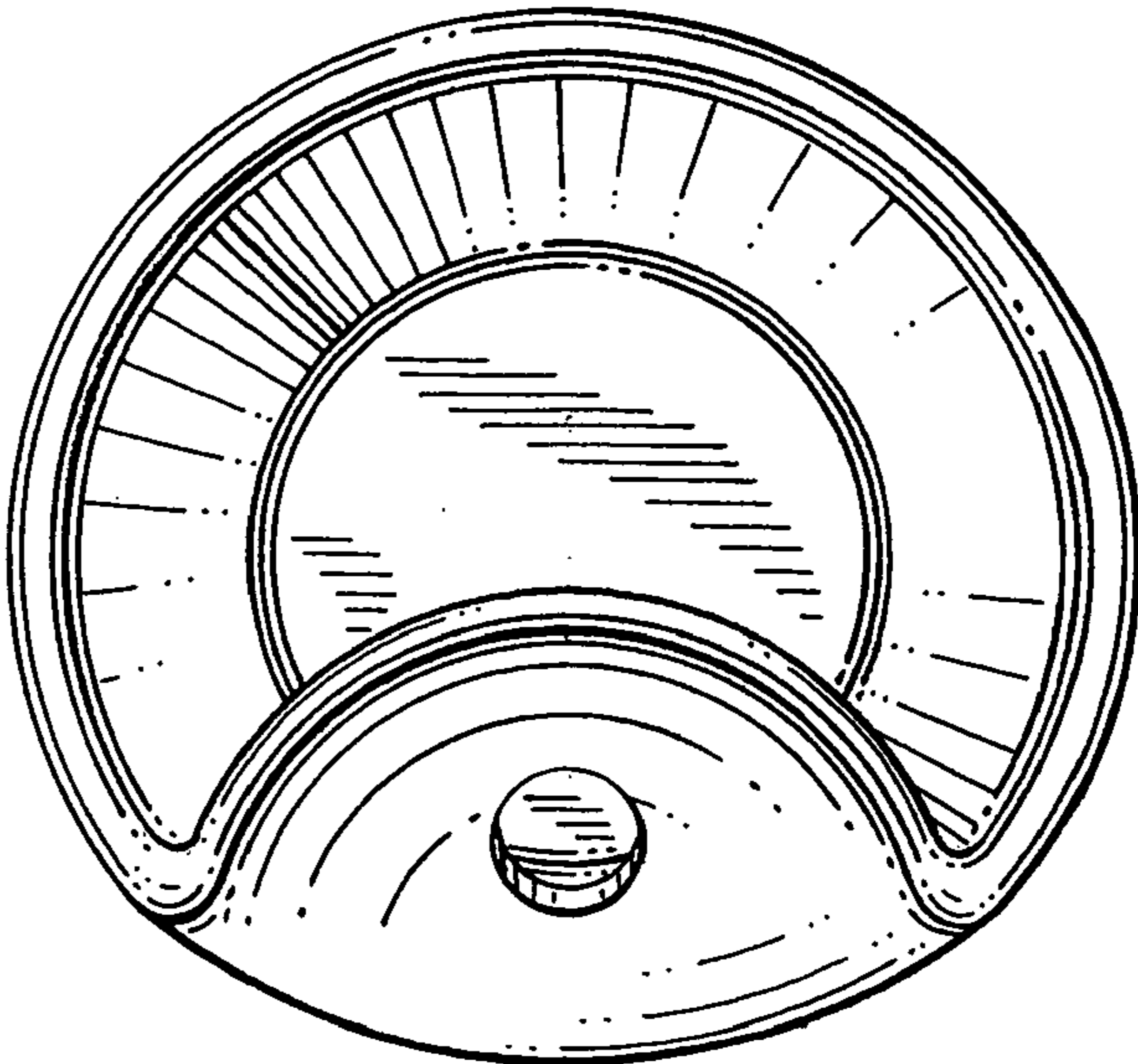
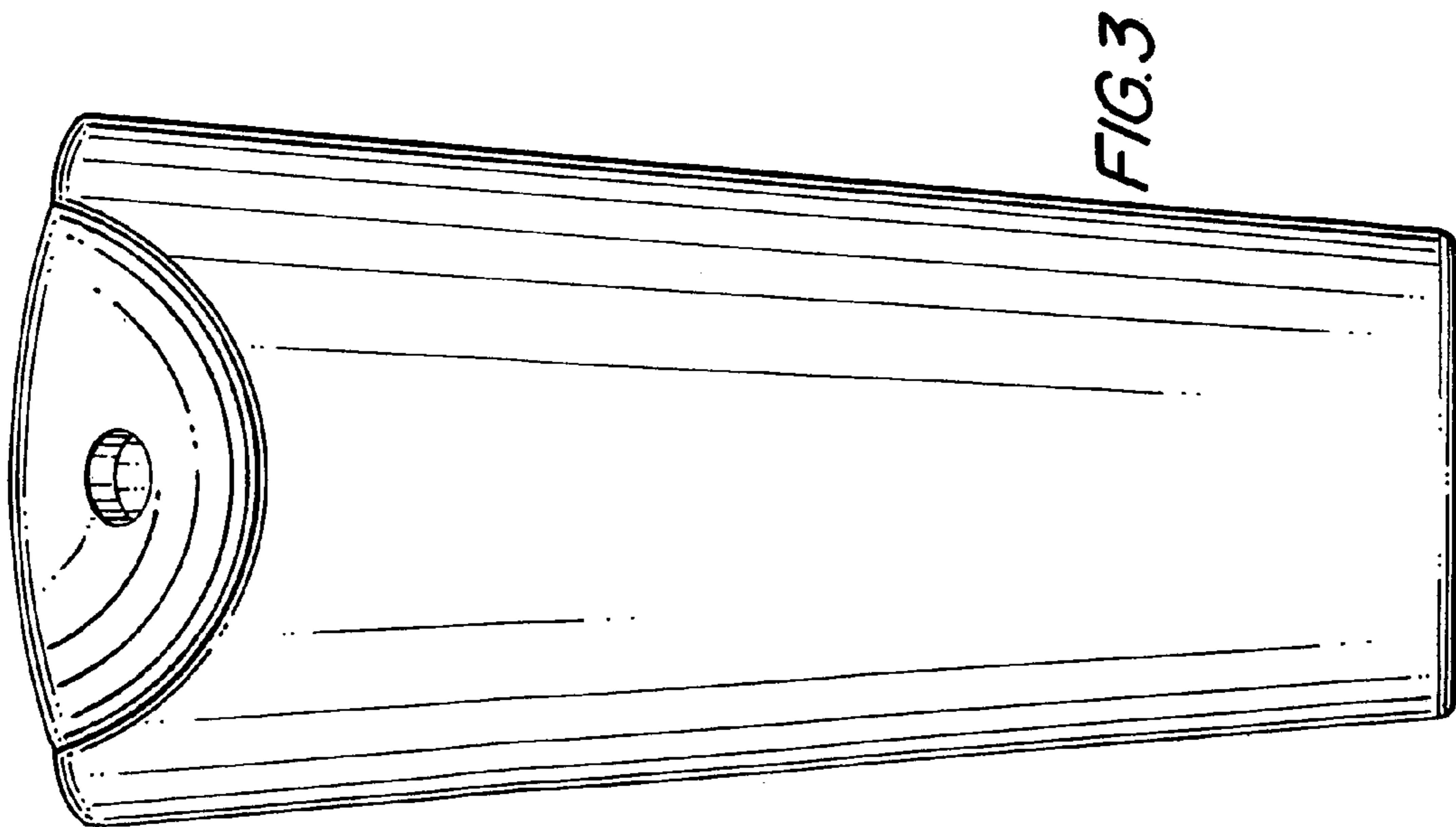
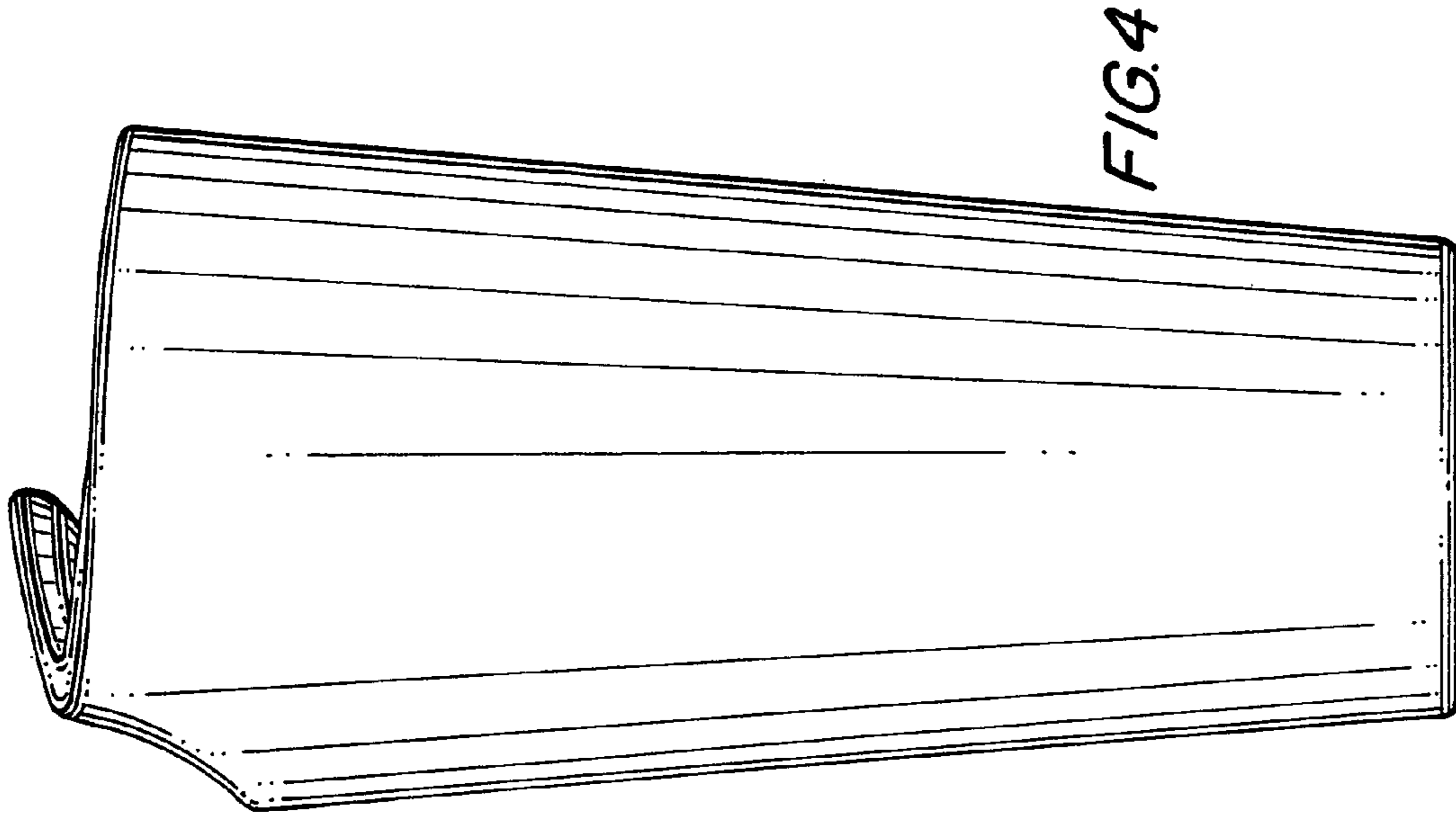
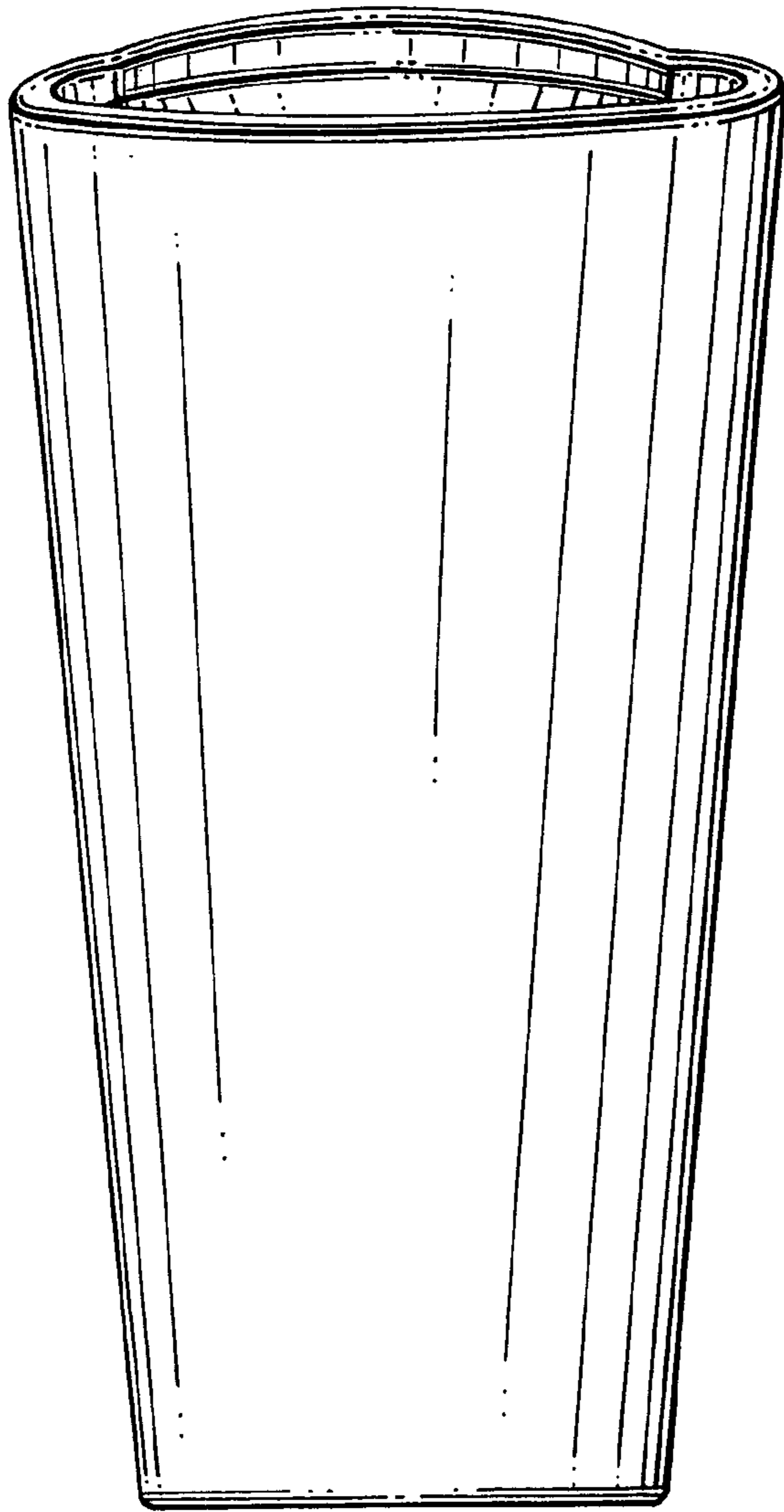
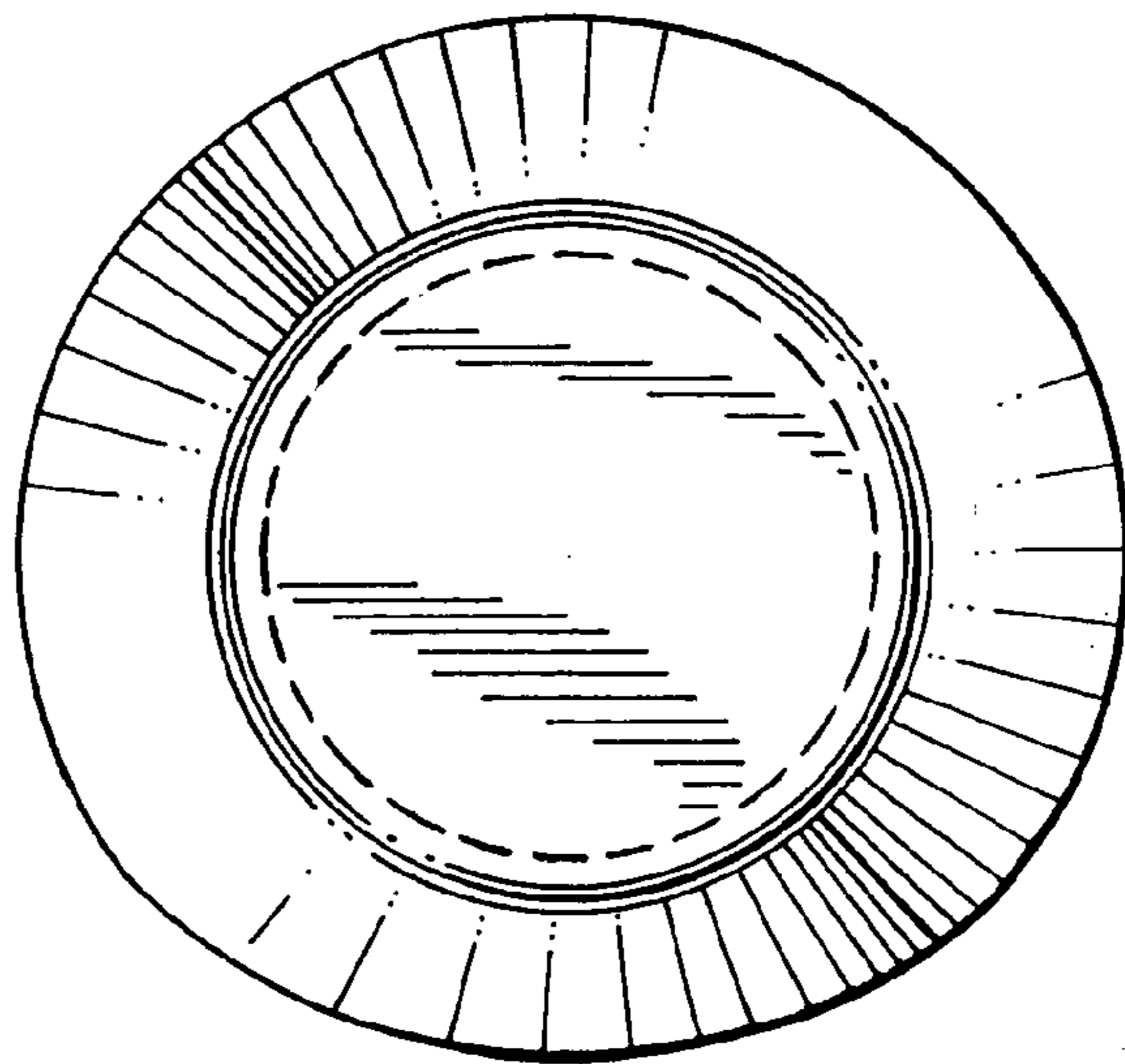
