(57) **CLAIM**

The ornamental design for a conduit layout tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a conduit layout tool showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left side elevation view thereof; and

FIG. 7 is a right side elevation view thereof.

FIG. 8 is a front elevation view of a second embodiment of a conduit layout tool;

FIG. 9 is a rear elevation view thereof; and,

FIG. 10 is a left side elevational view thereof.

The top and bottom plan views and right side elevation view of the second embodiment are identical to FIGS. 4, 5, and 7 respectively.

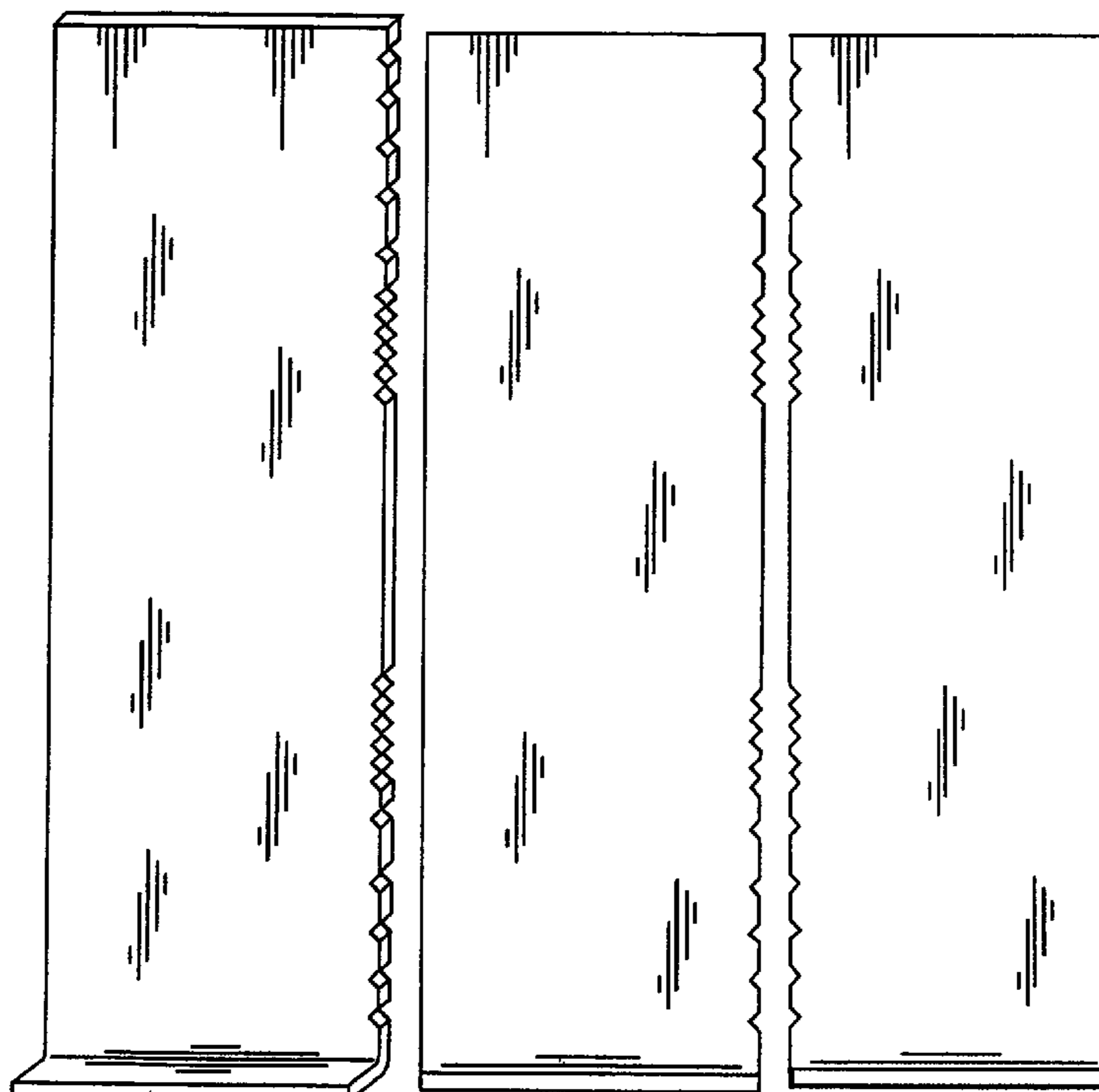

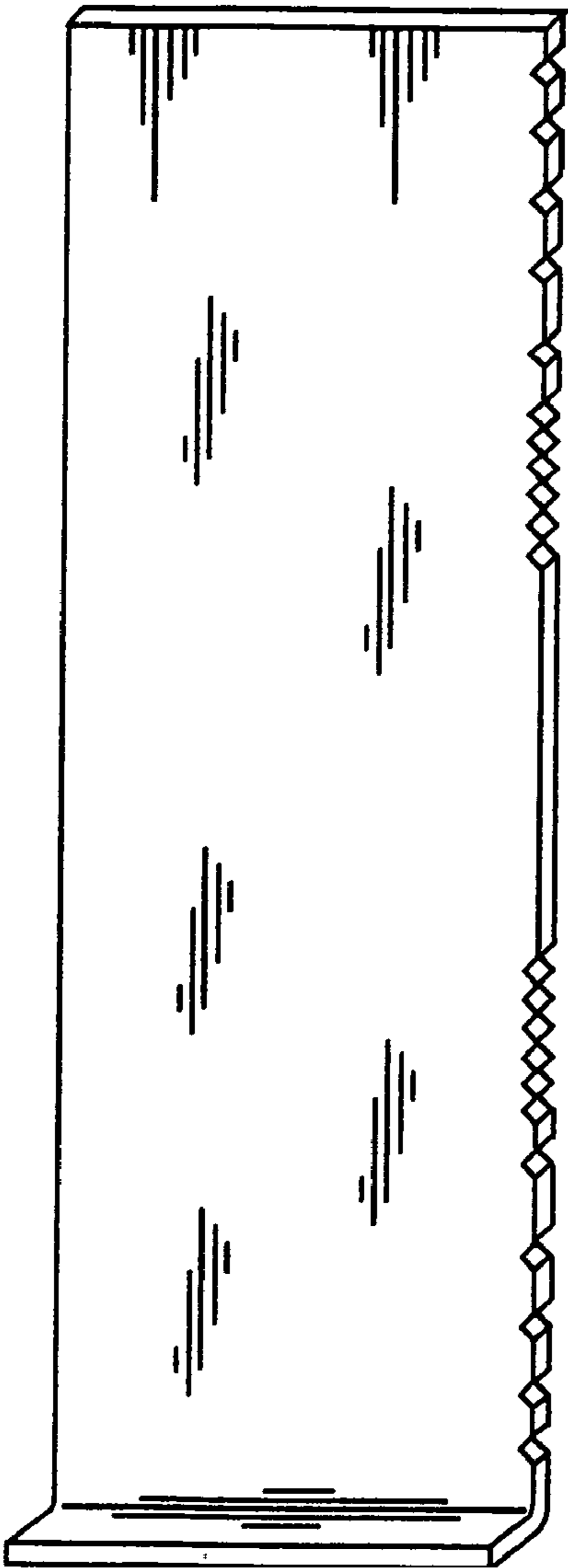

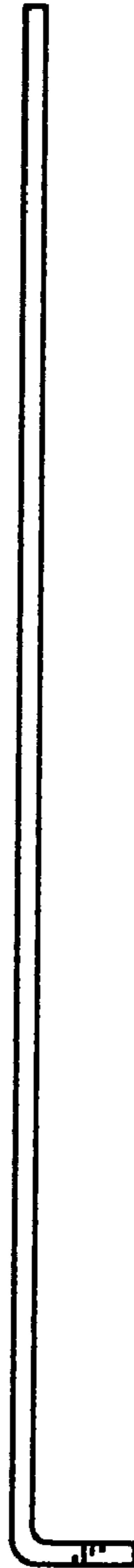
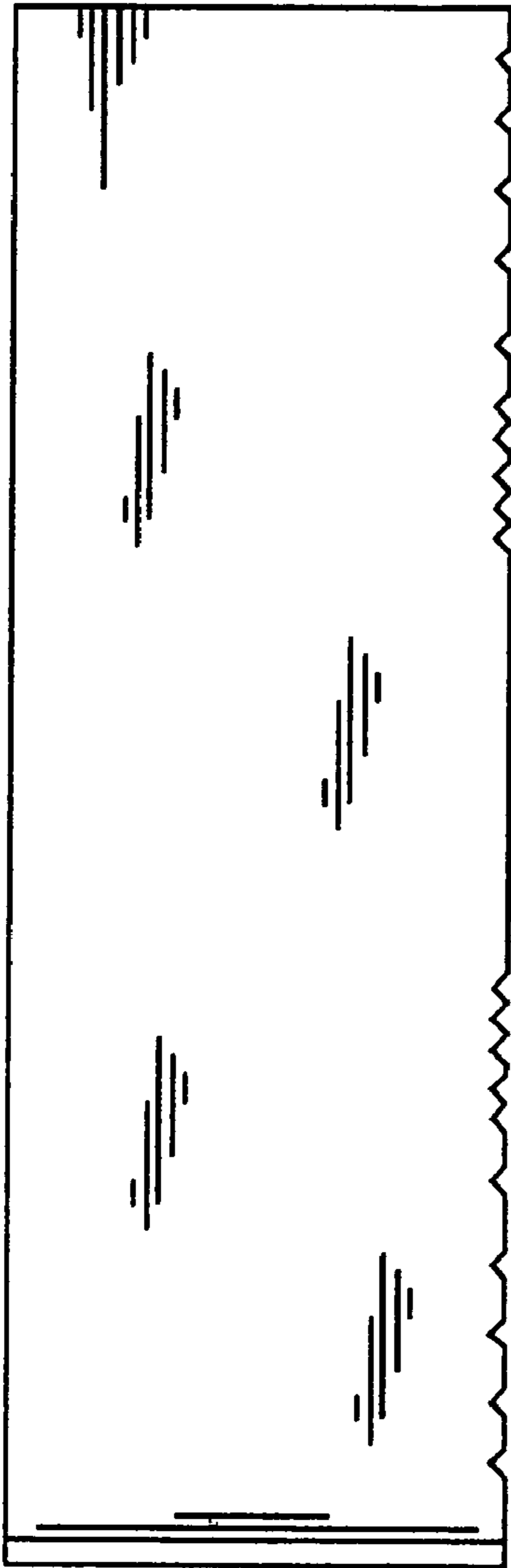


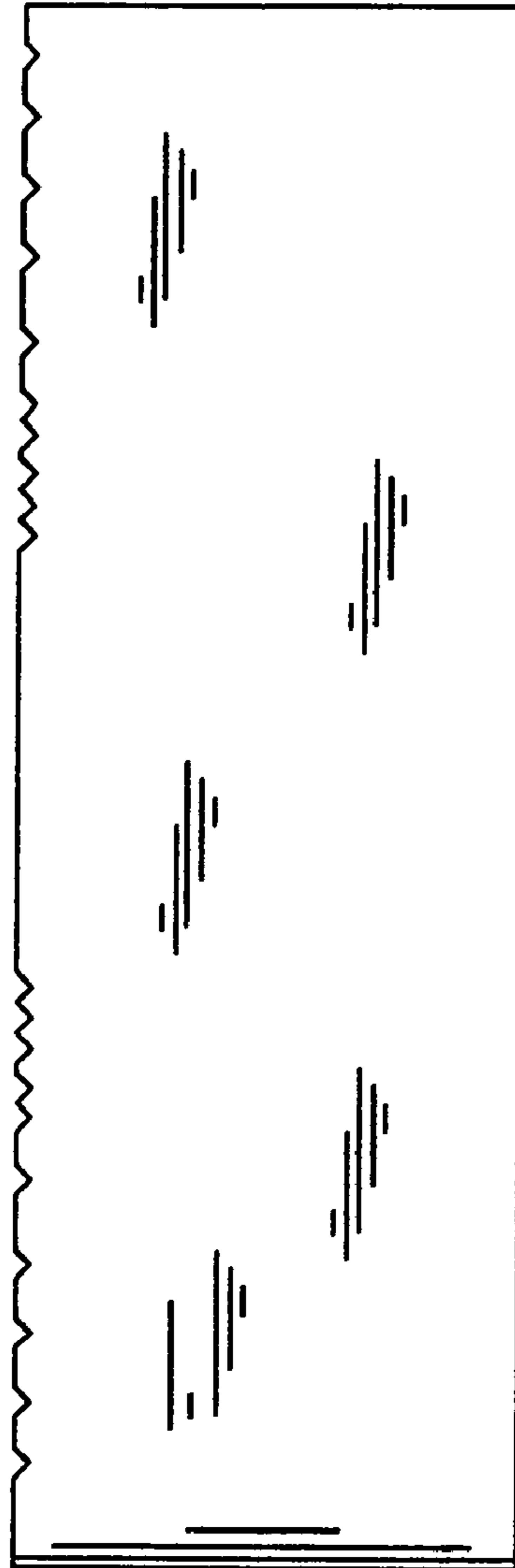

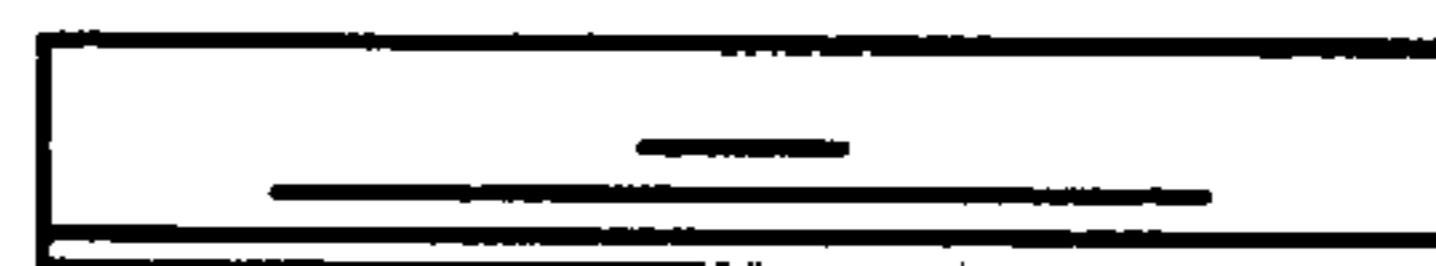

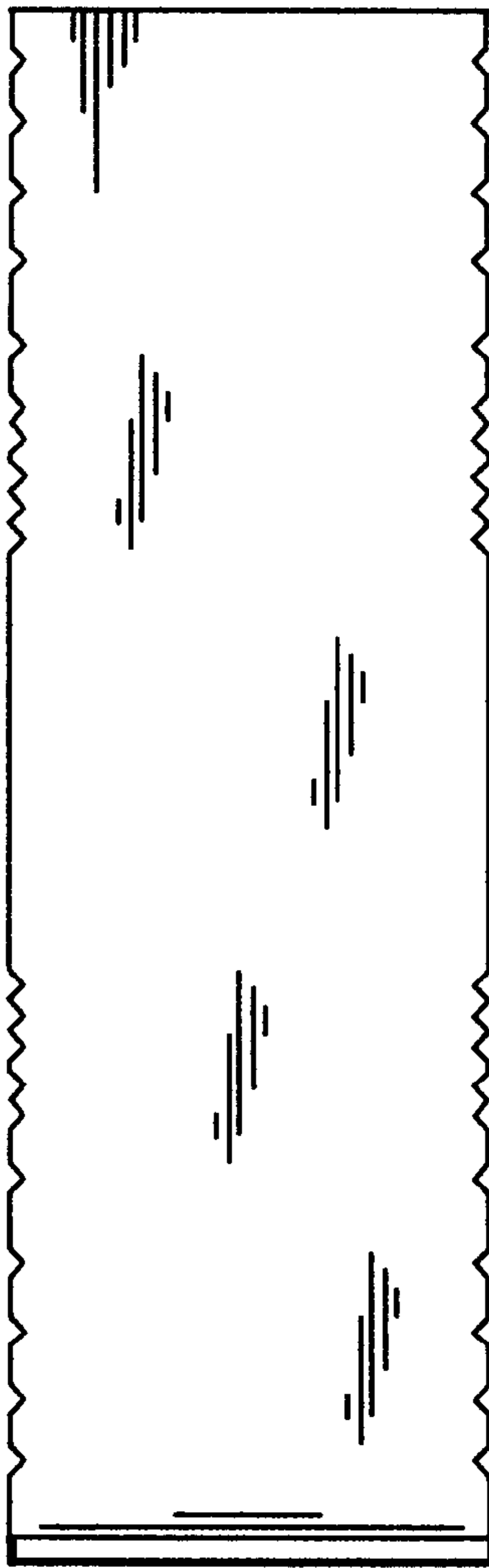

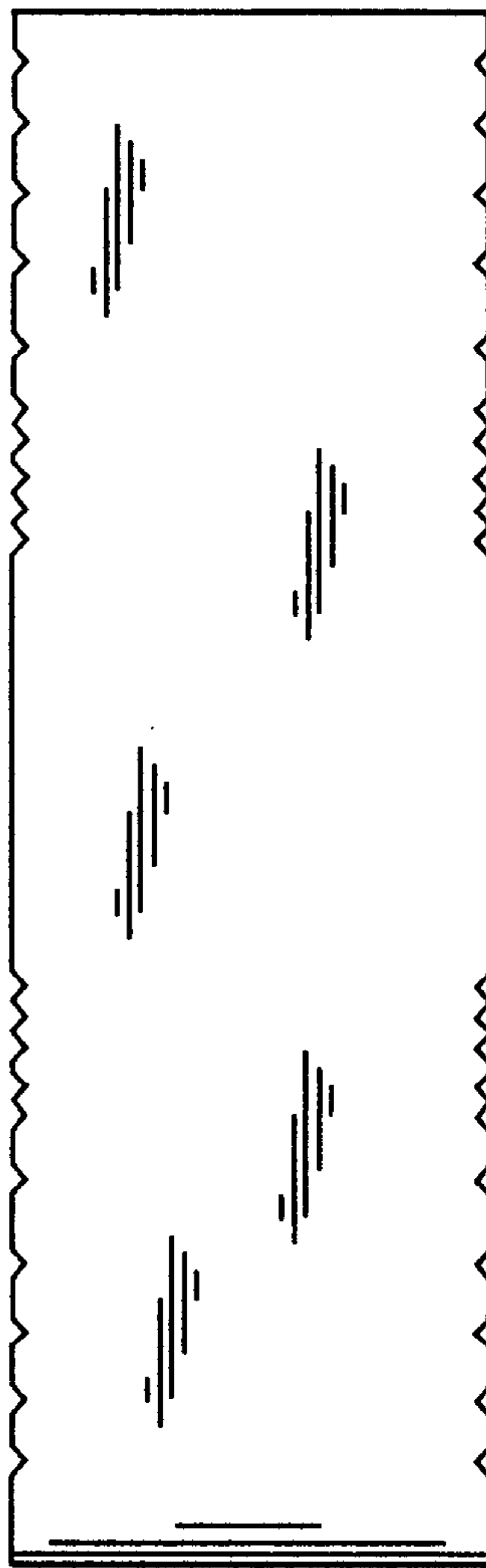
