FIG. 1 is an upper front perspective view of the present invention.

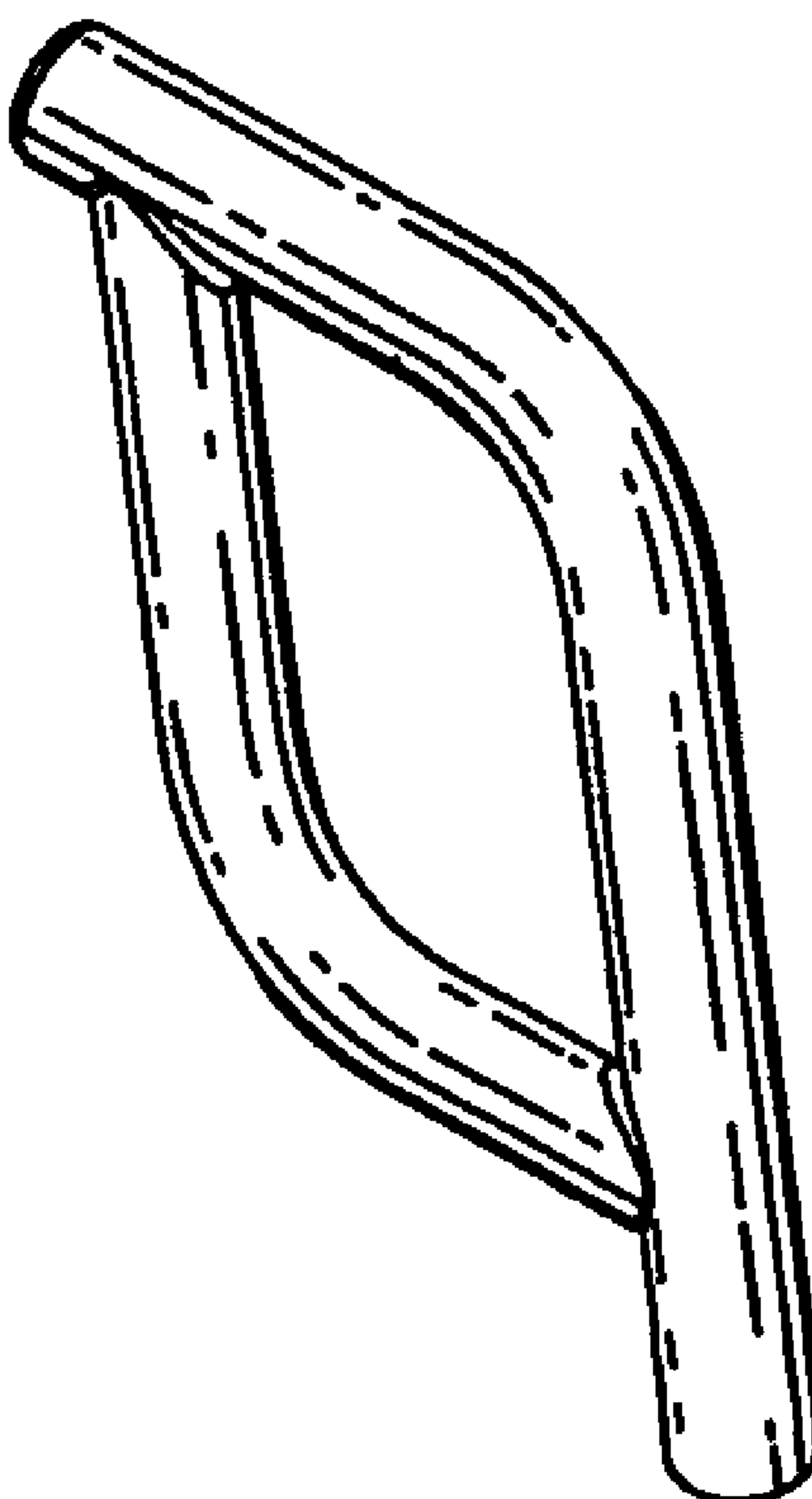
FIG. 2 is a front view of the present invention.

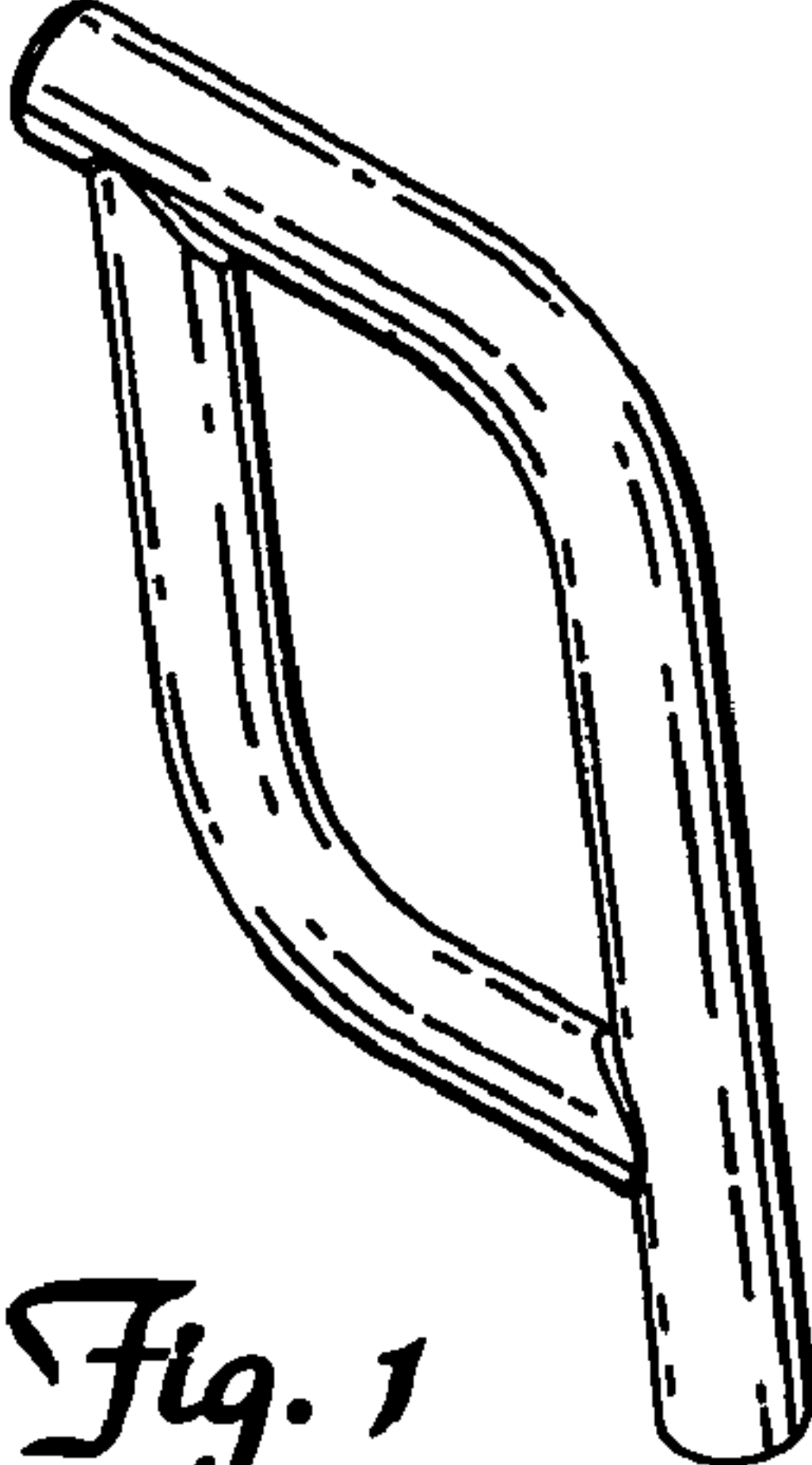

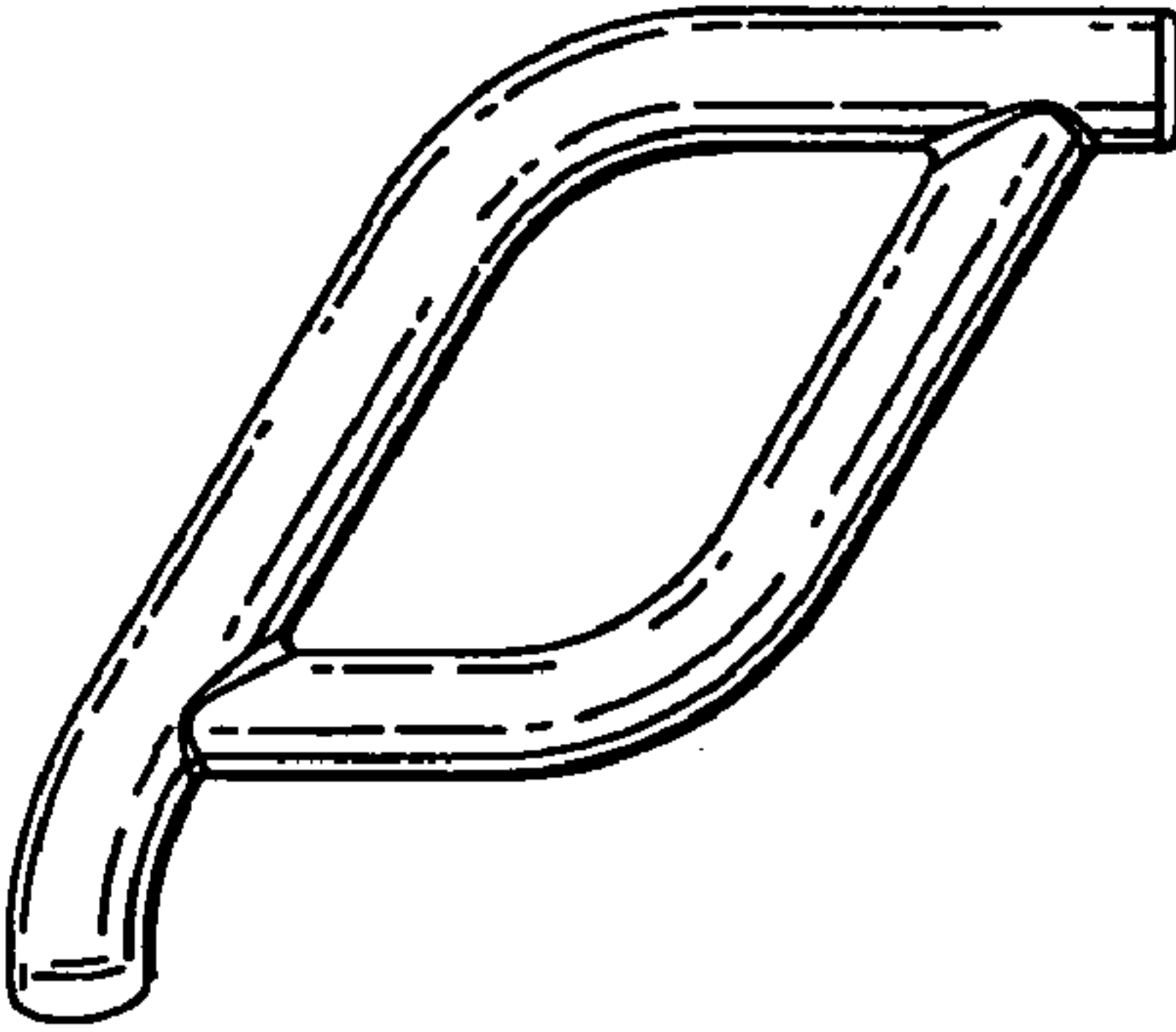

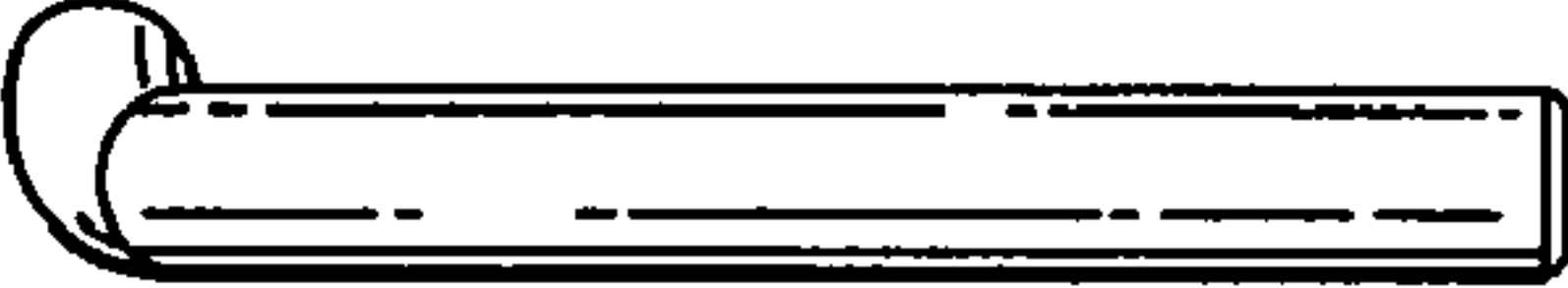
