We claim, the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a bottle showing our new design;

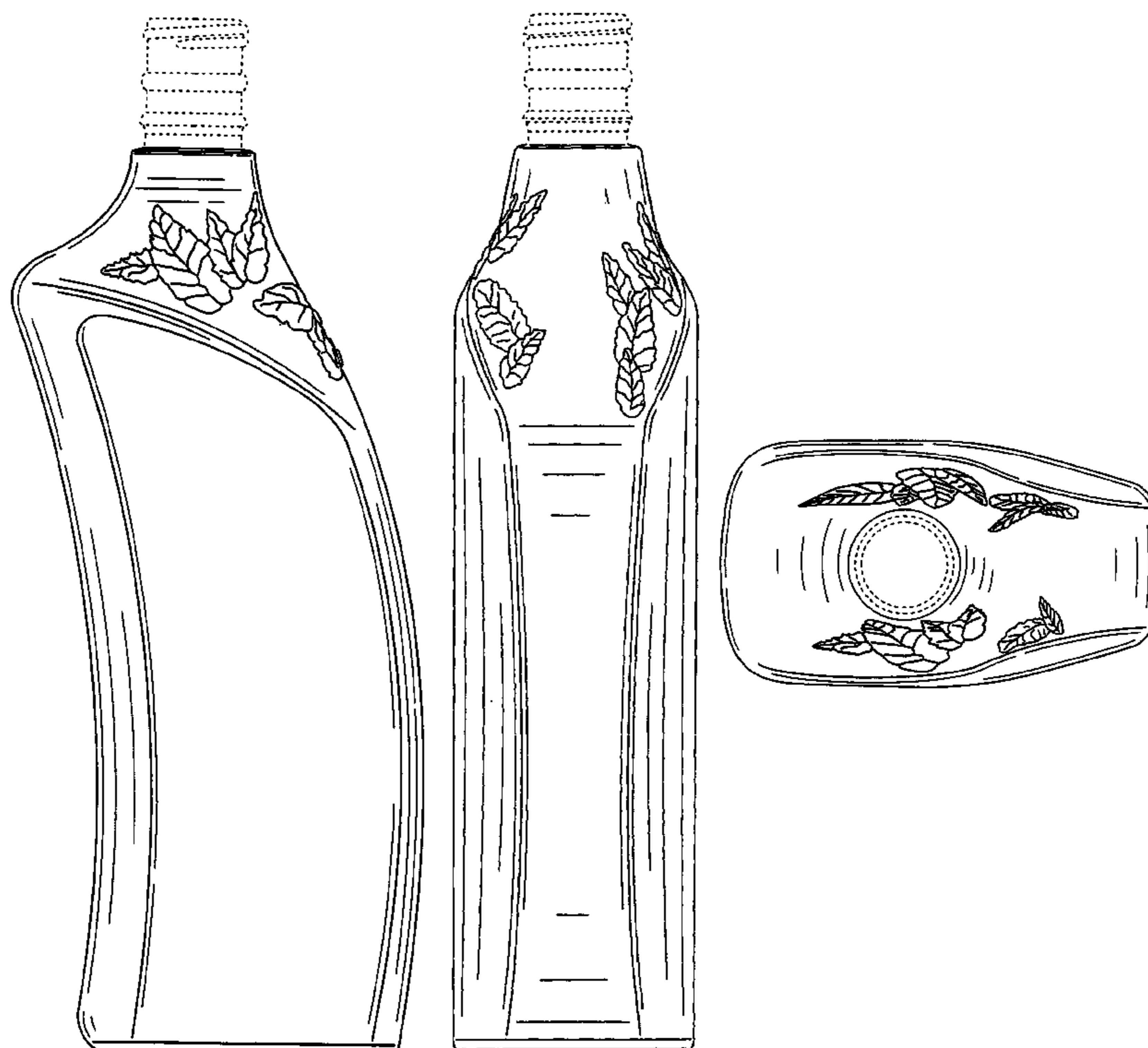

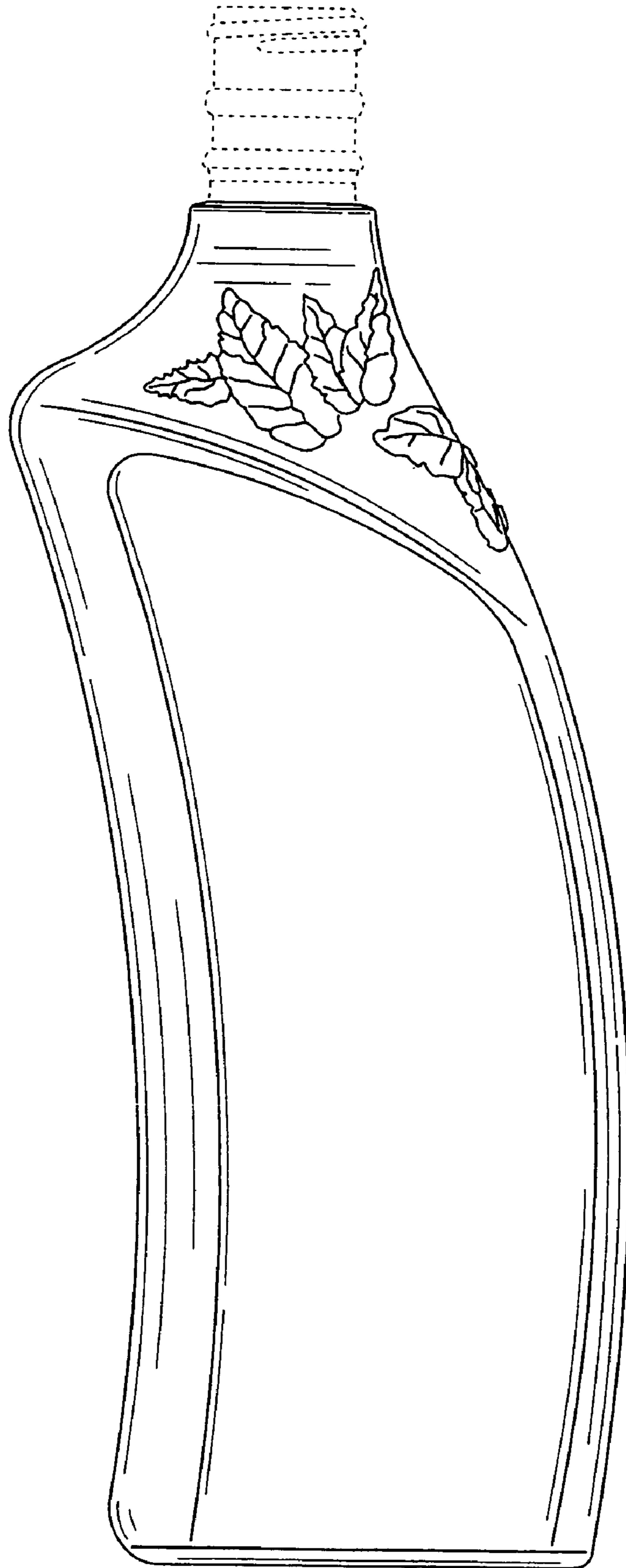

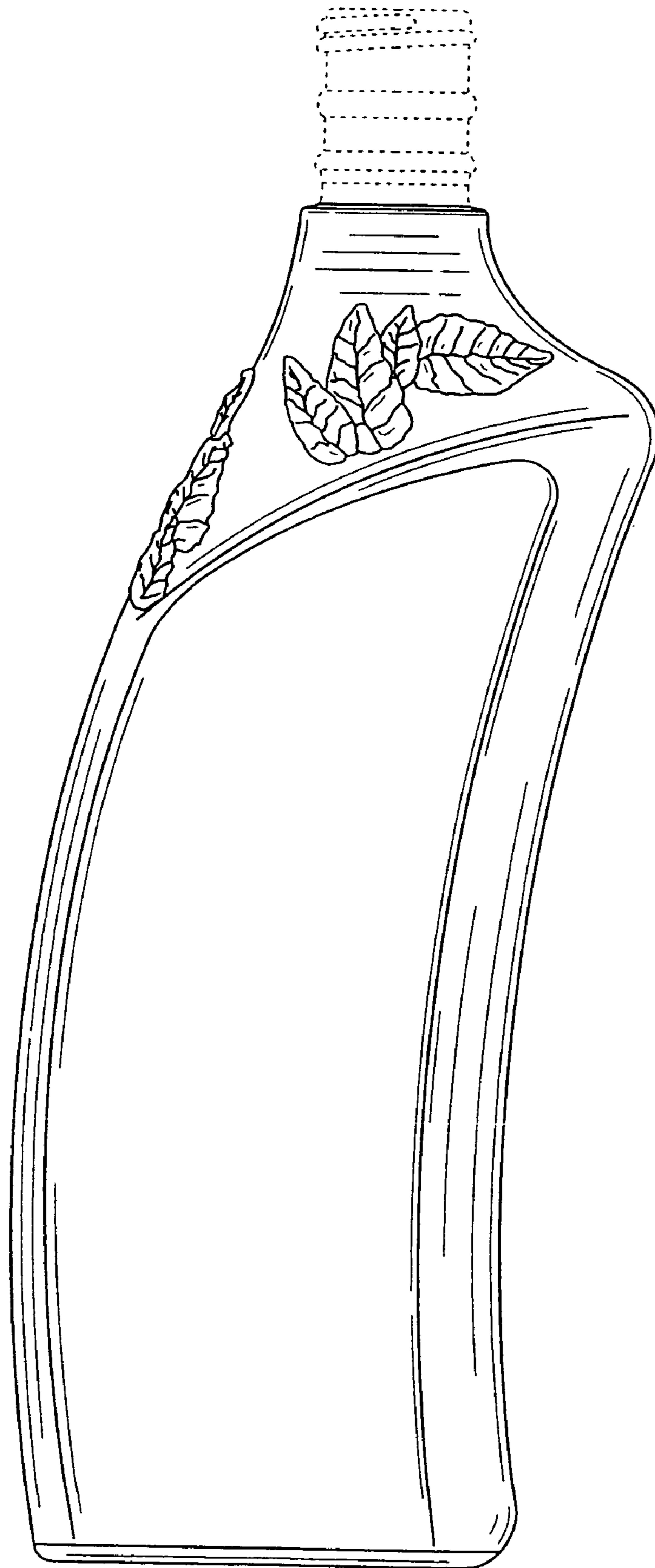

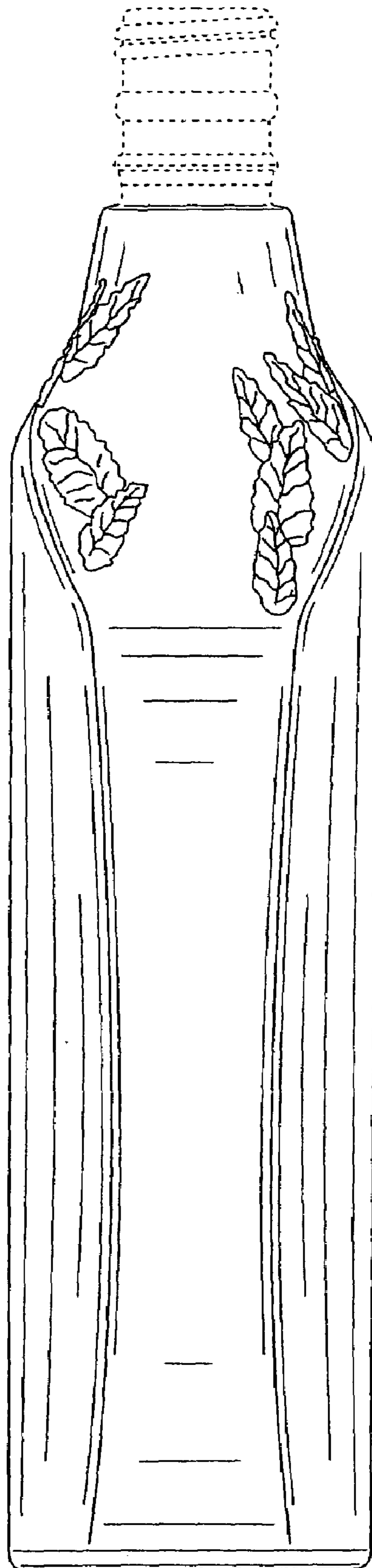

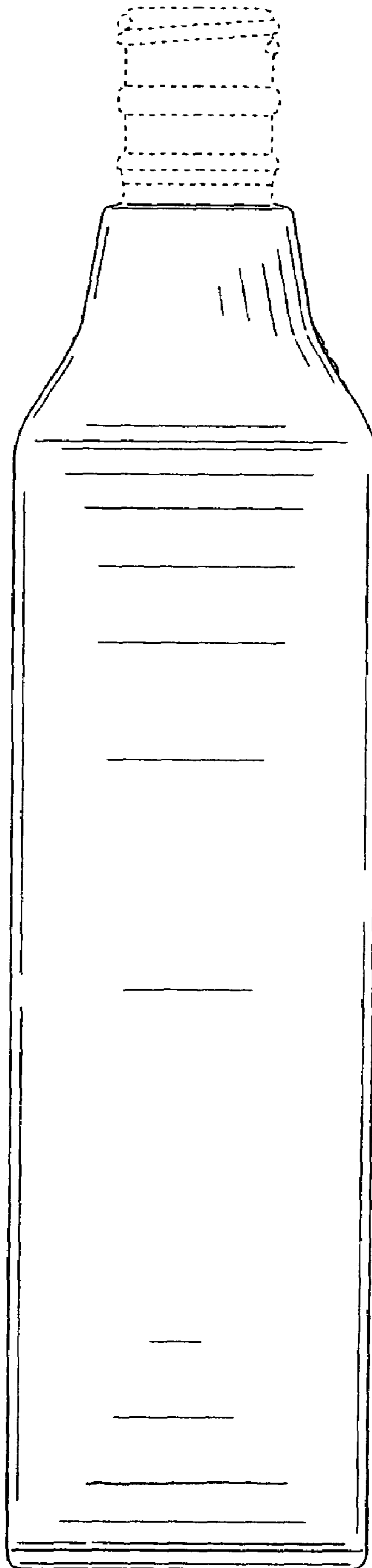

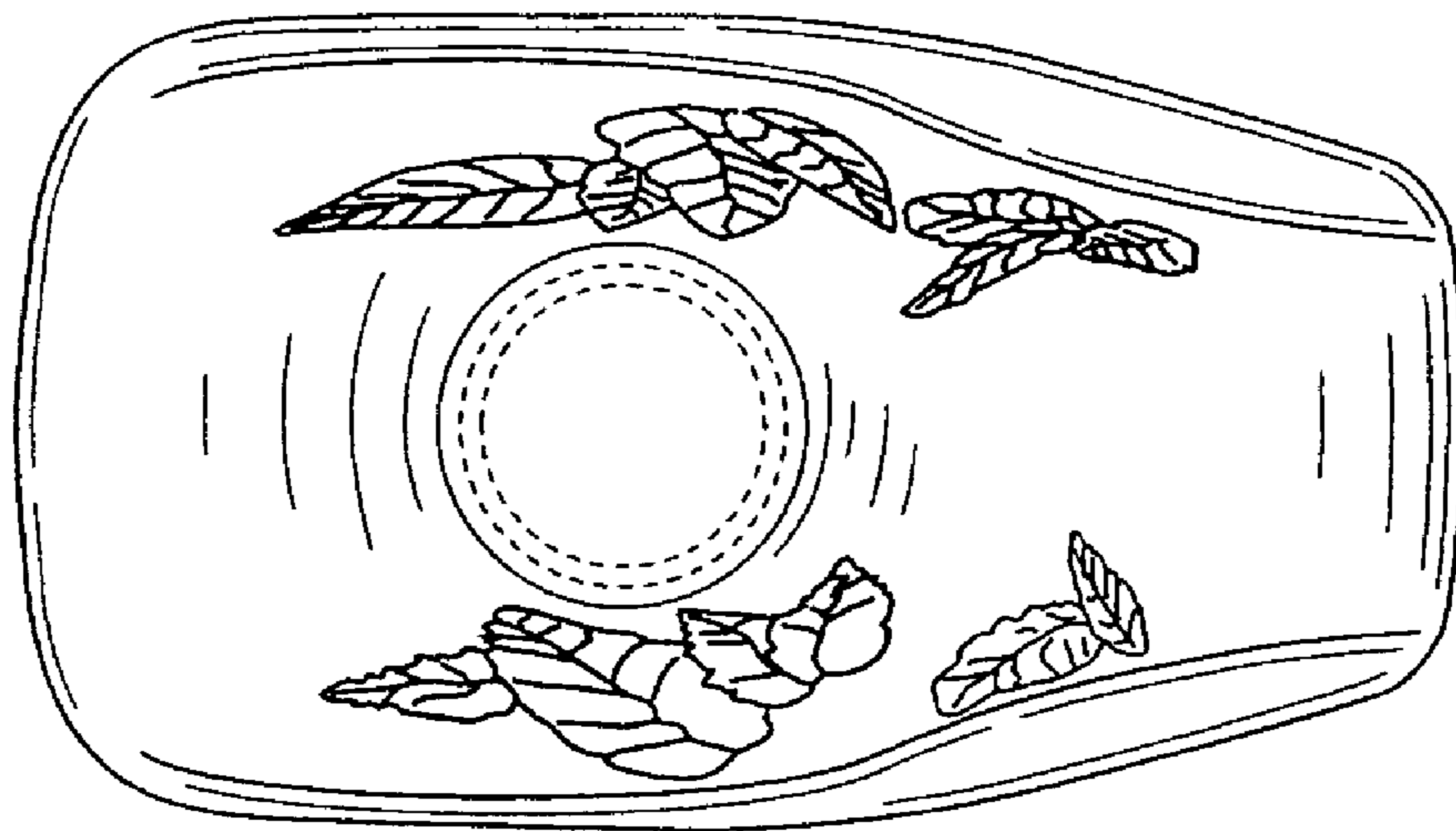
