FIG. 1 is a top perspective view of a packaging with pre-filled pyramidal bowls, showing our new design;

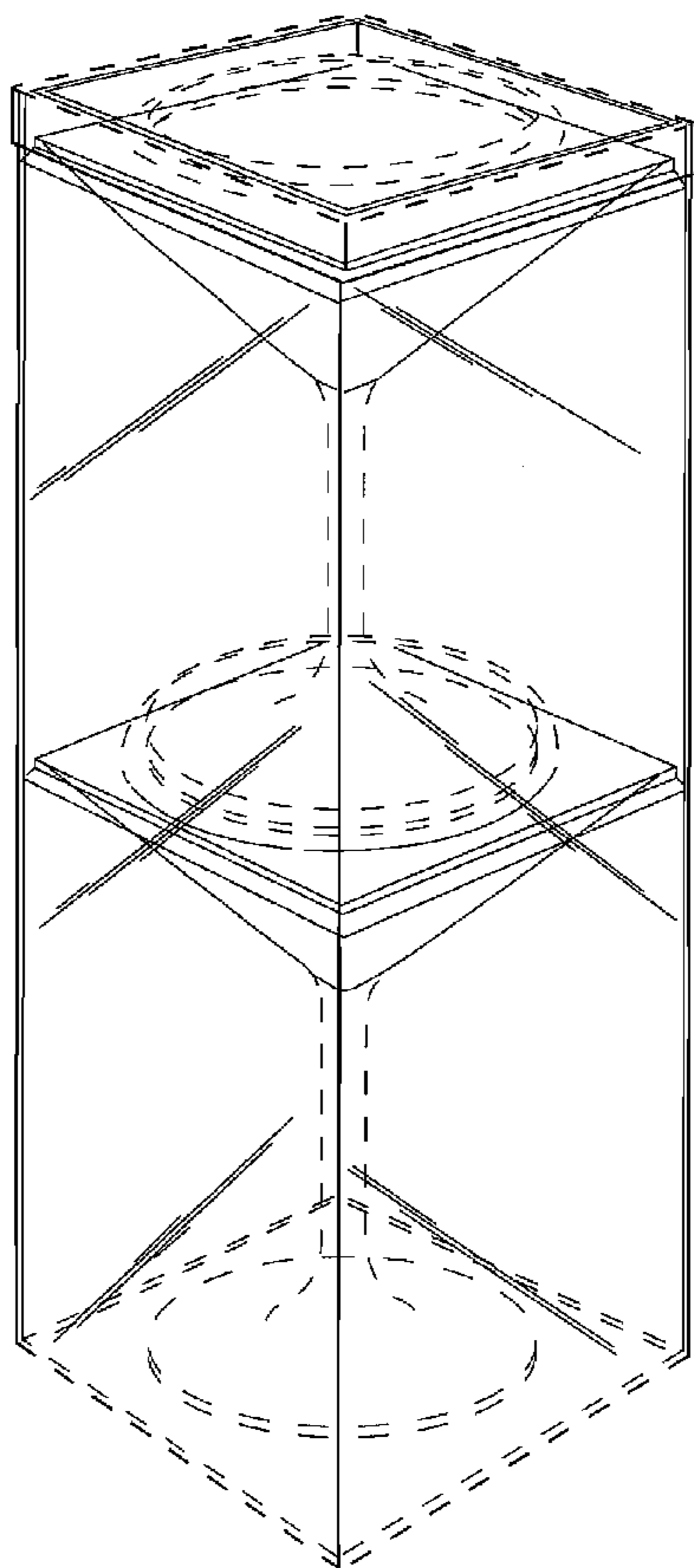
FIG. 2 is a side plan view thereof;

FIG. 3 is a top plan view thereof; and,

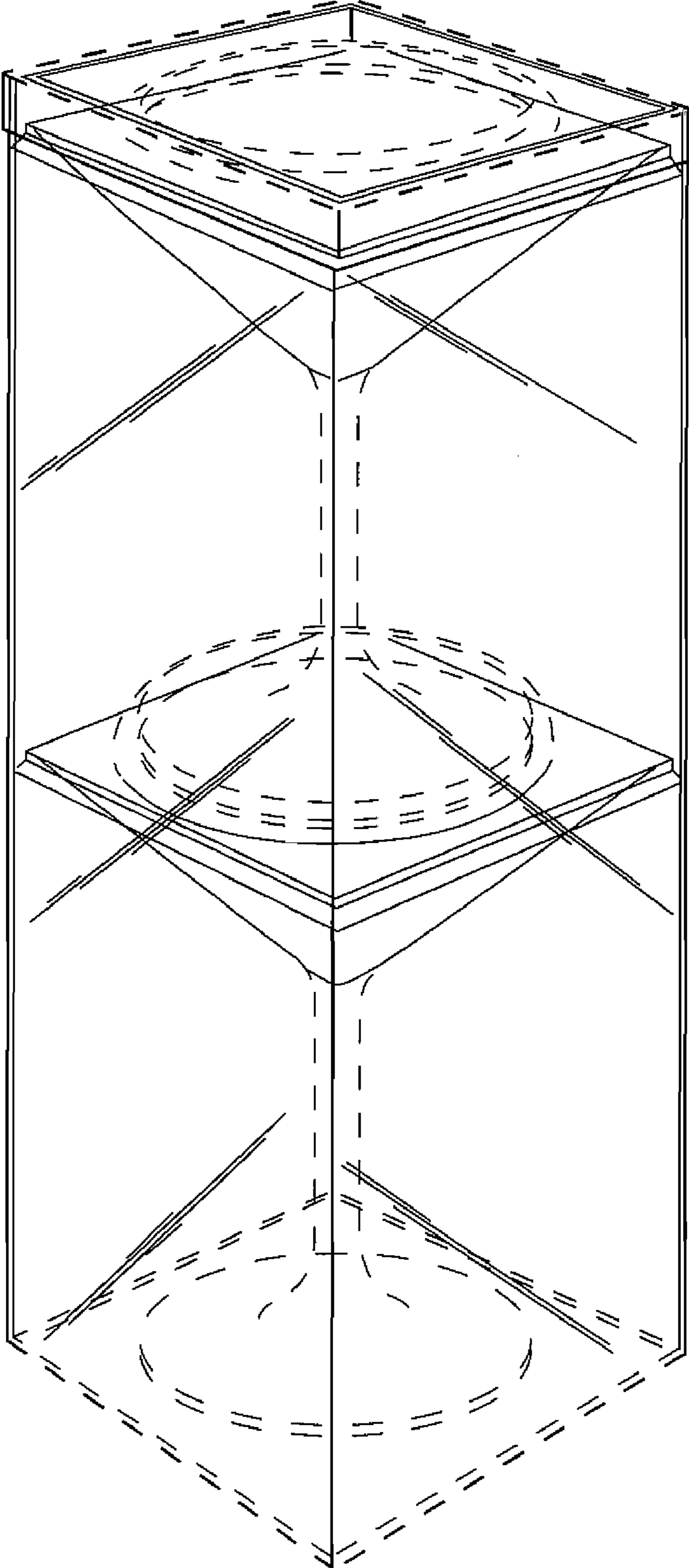
FIG. 4 is a bottom plan view thereof.

The broken lines shown in the drawing disclosure are for illustrative purposes only and form no part of the claimed design.

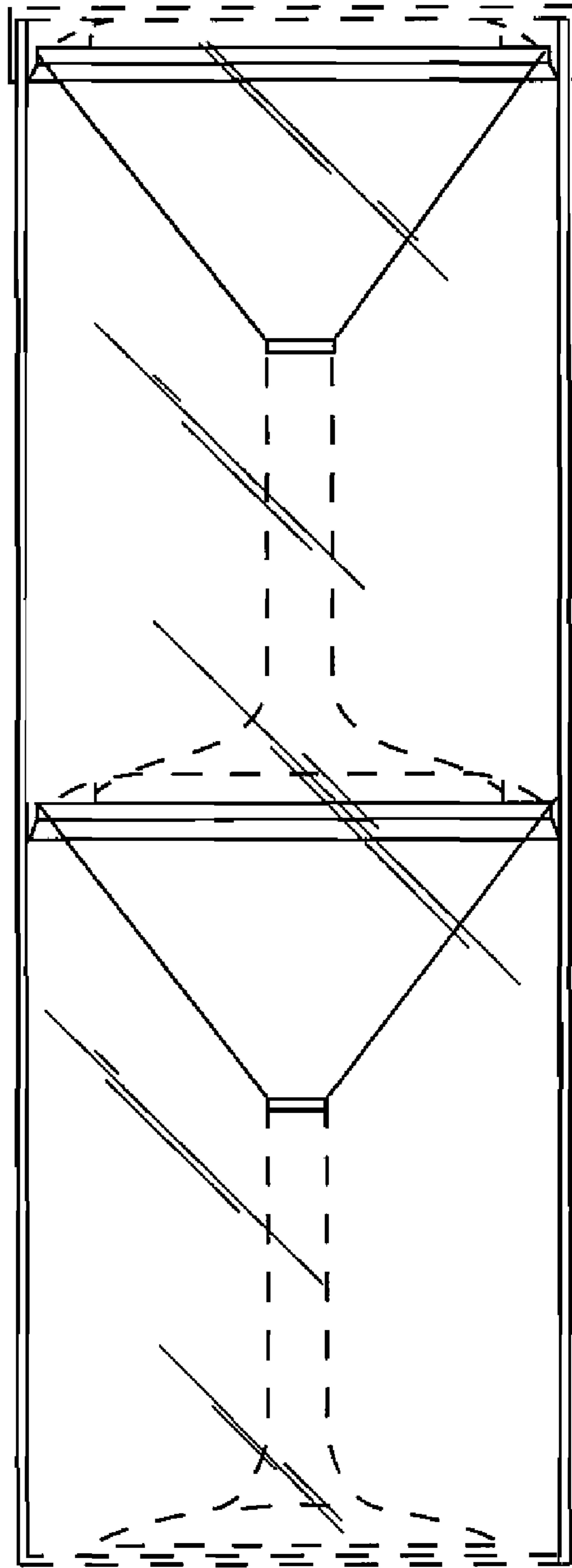

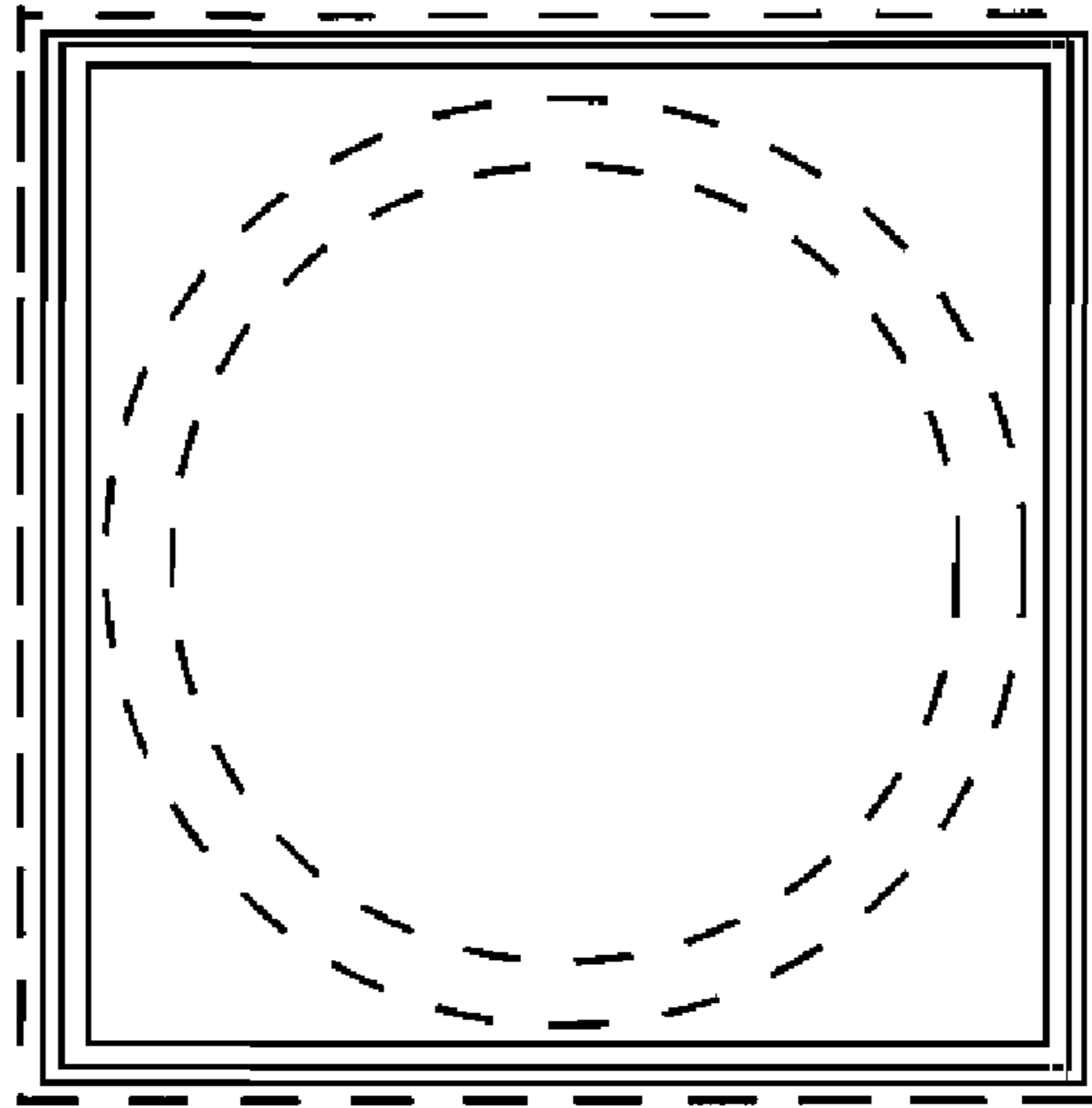
