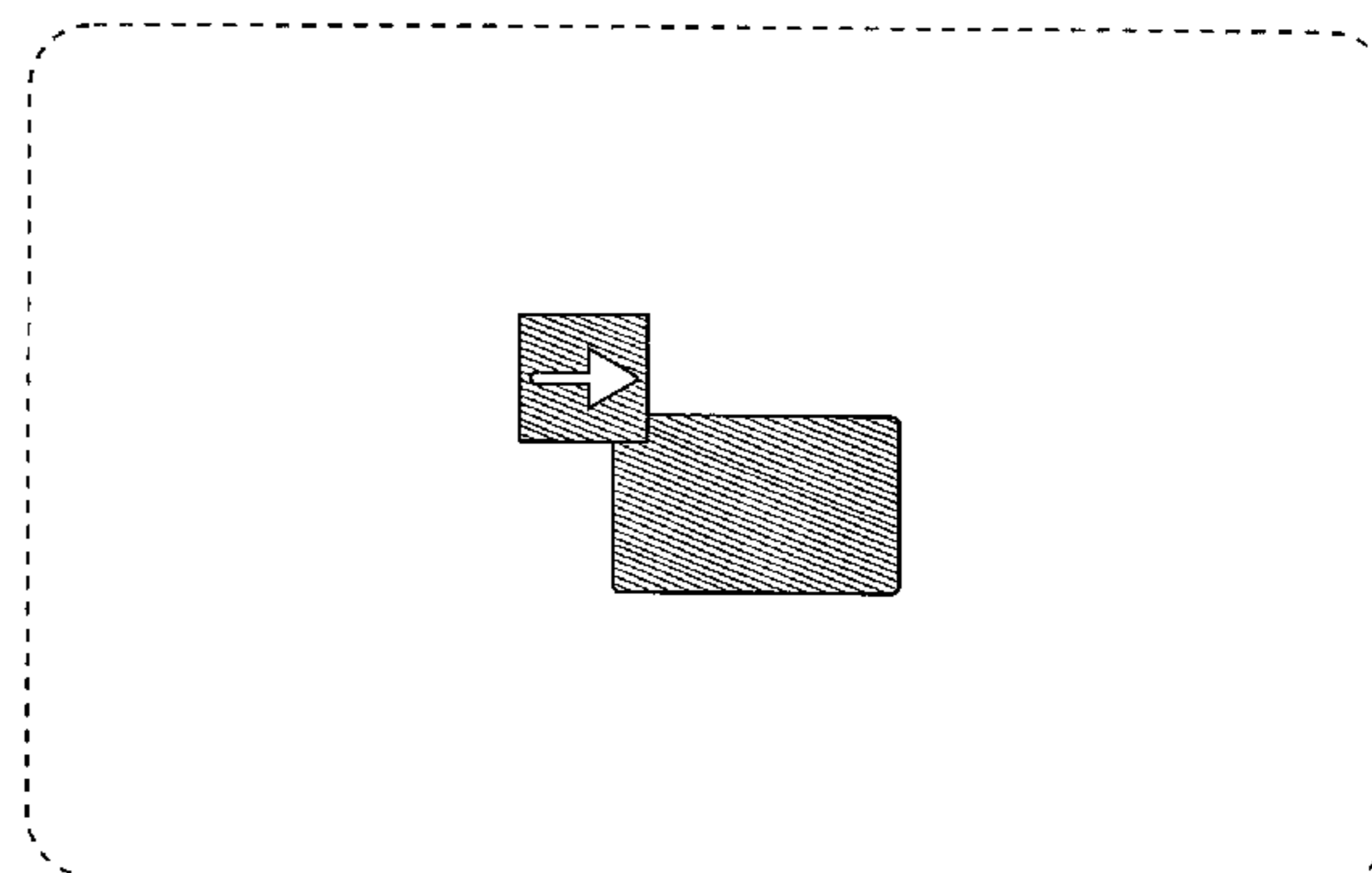
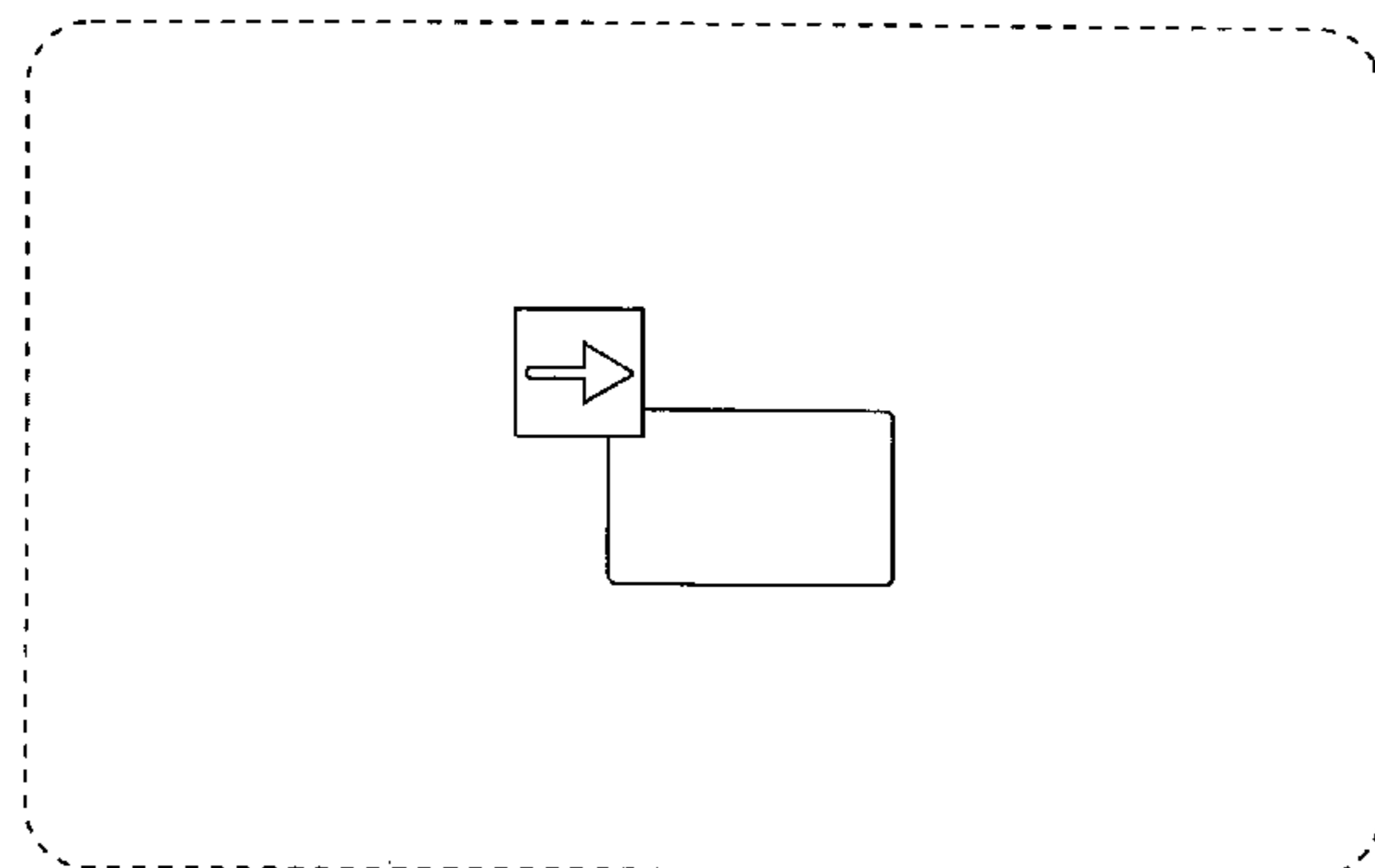

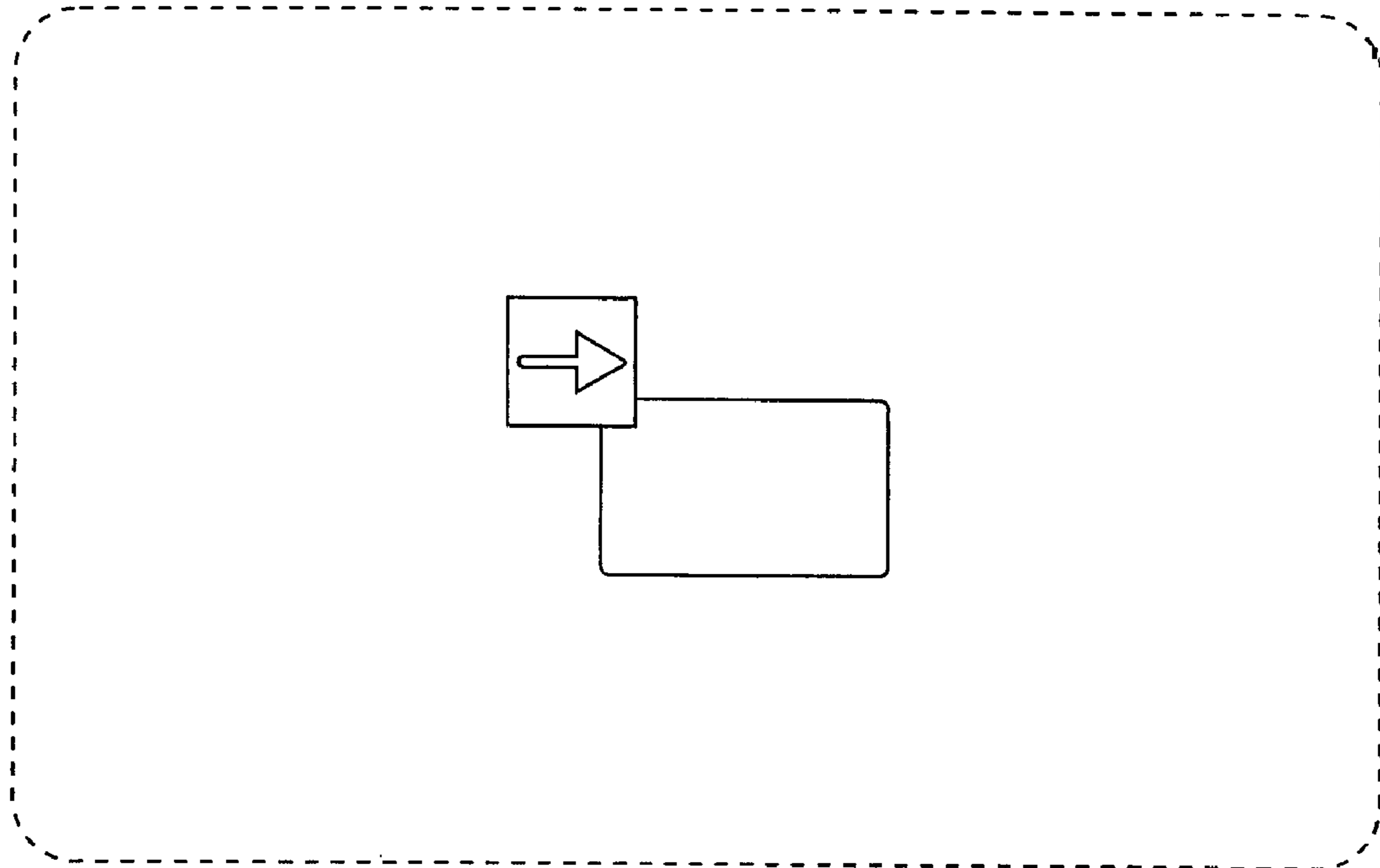
FIG. 1 depicts first embodiment of an icon for a display

green.

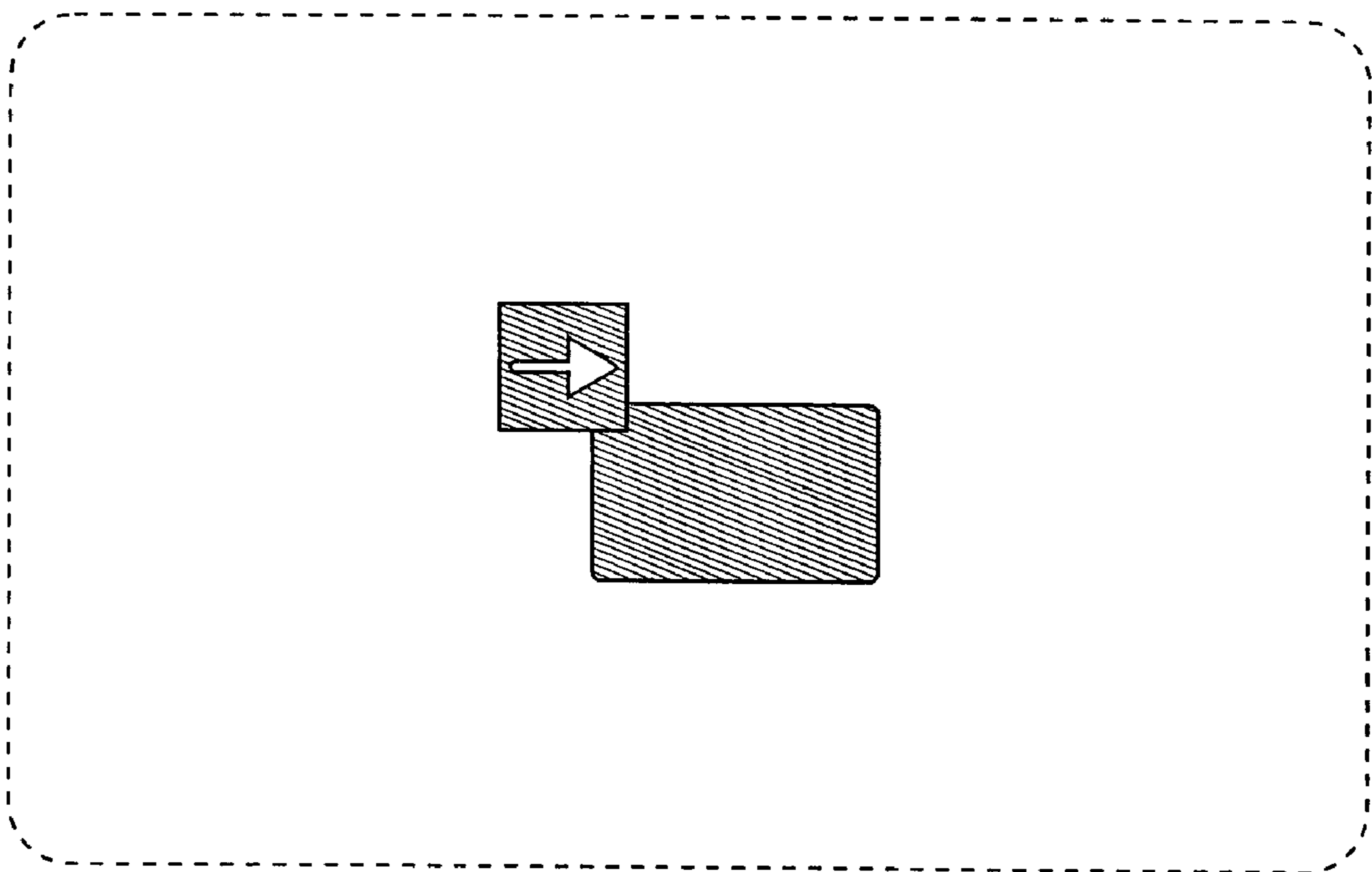
The broken line drawing of the display screen is for illus-
