DESCRIPTION

FIG. 1 is a perspective view of a MP3 player;

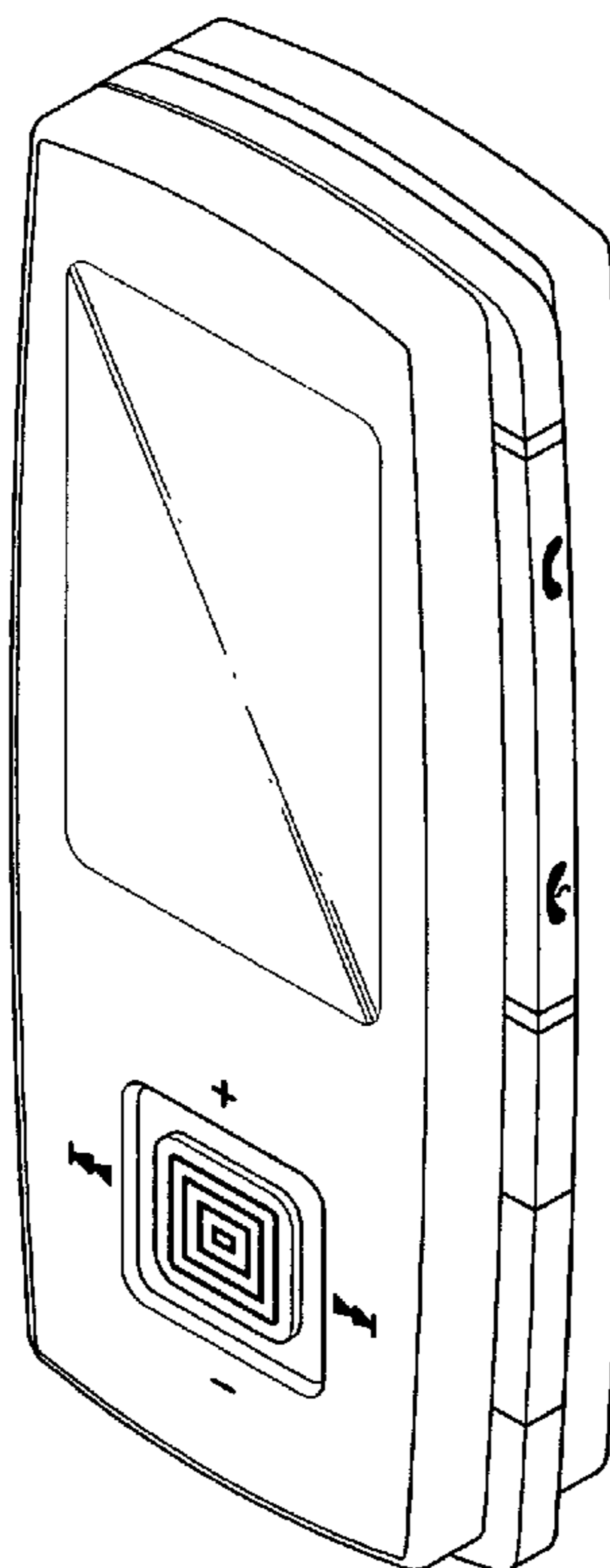

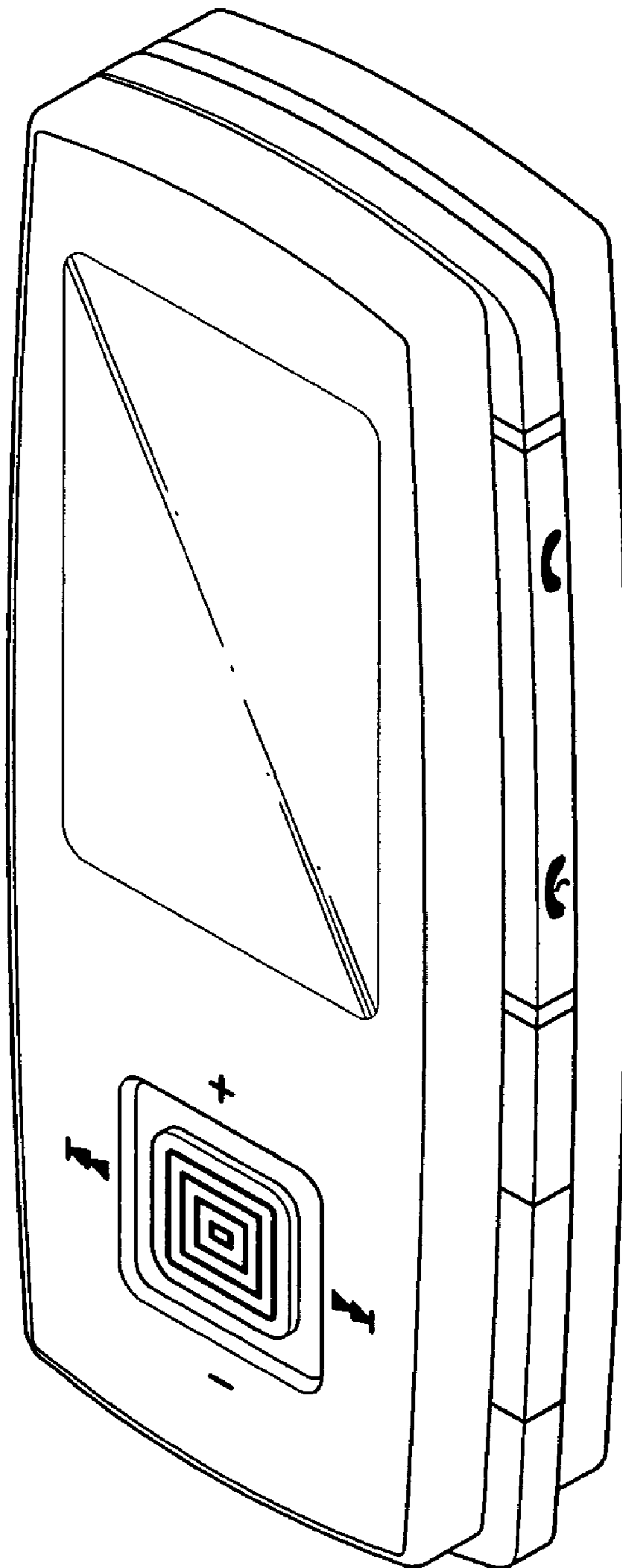

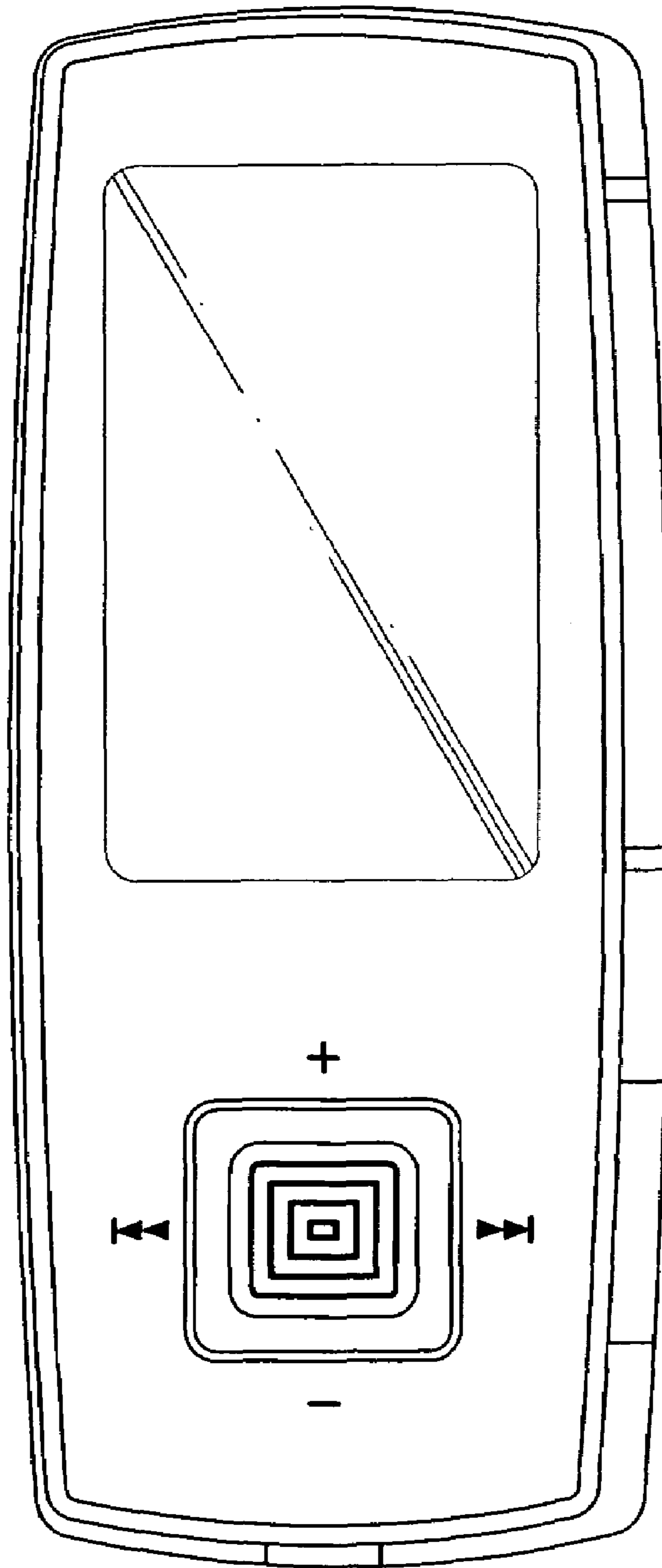

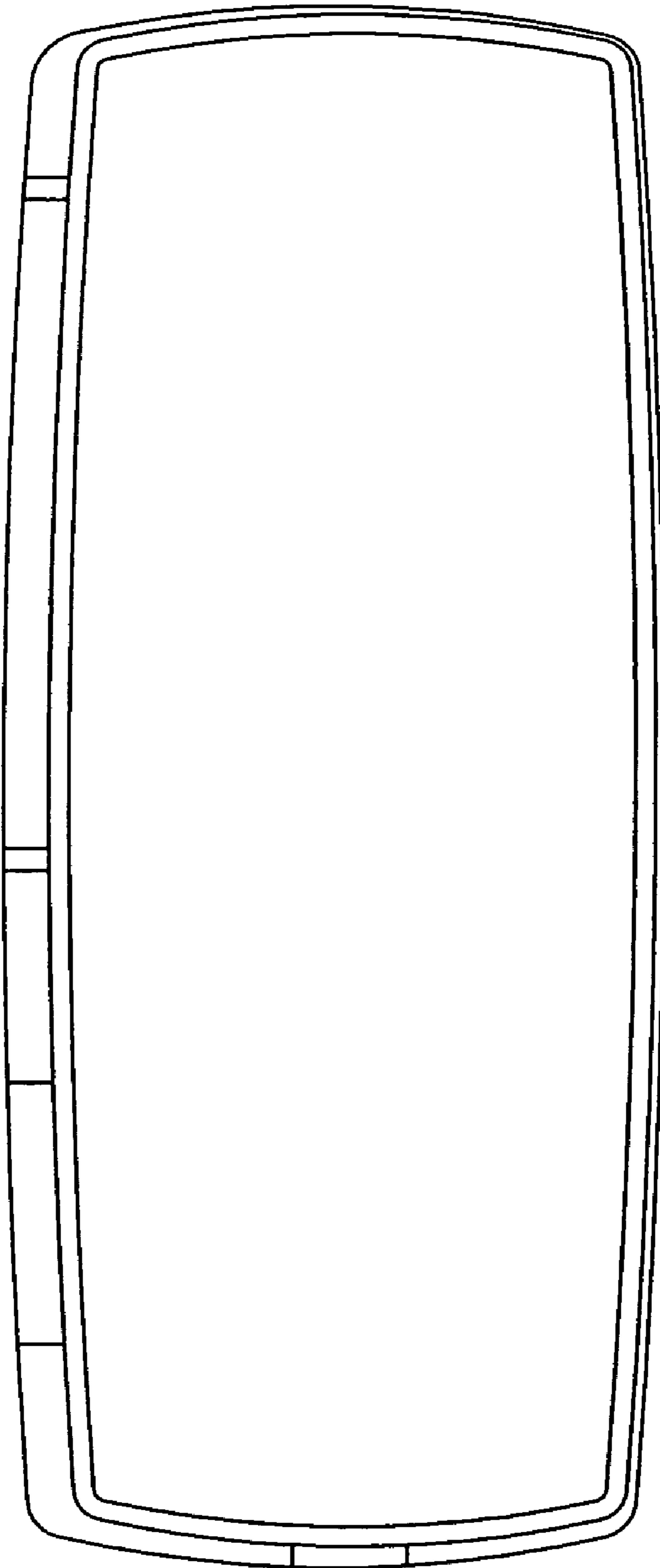

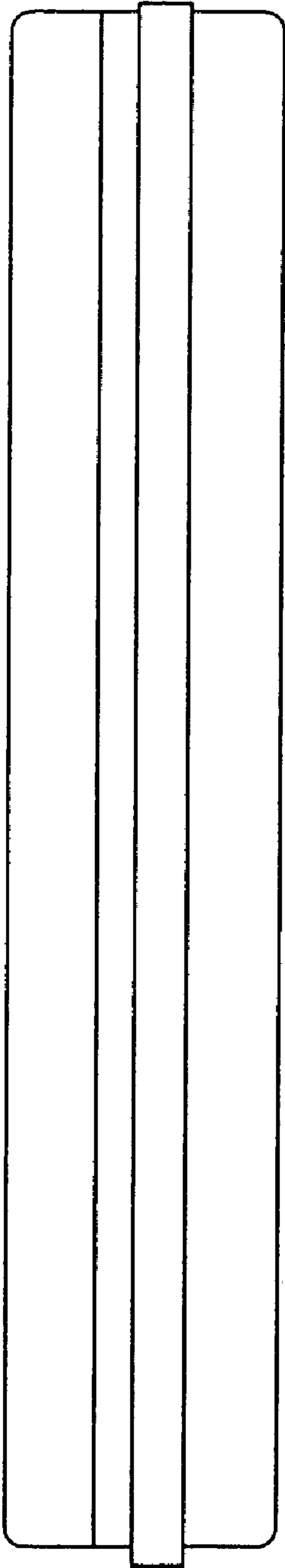

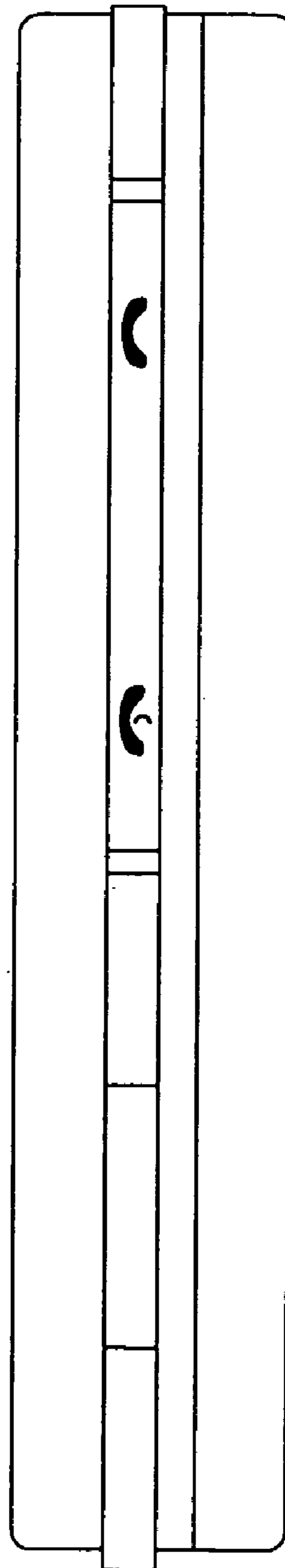

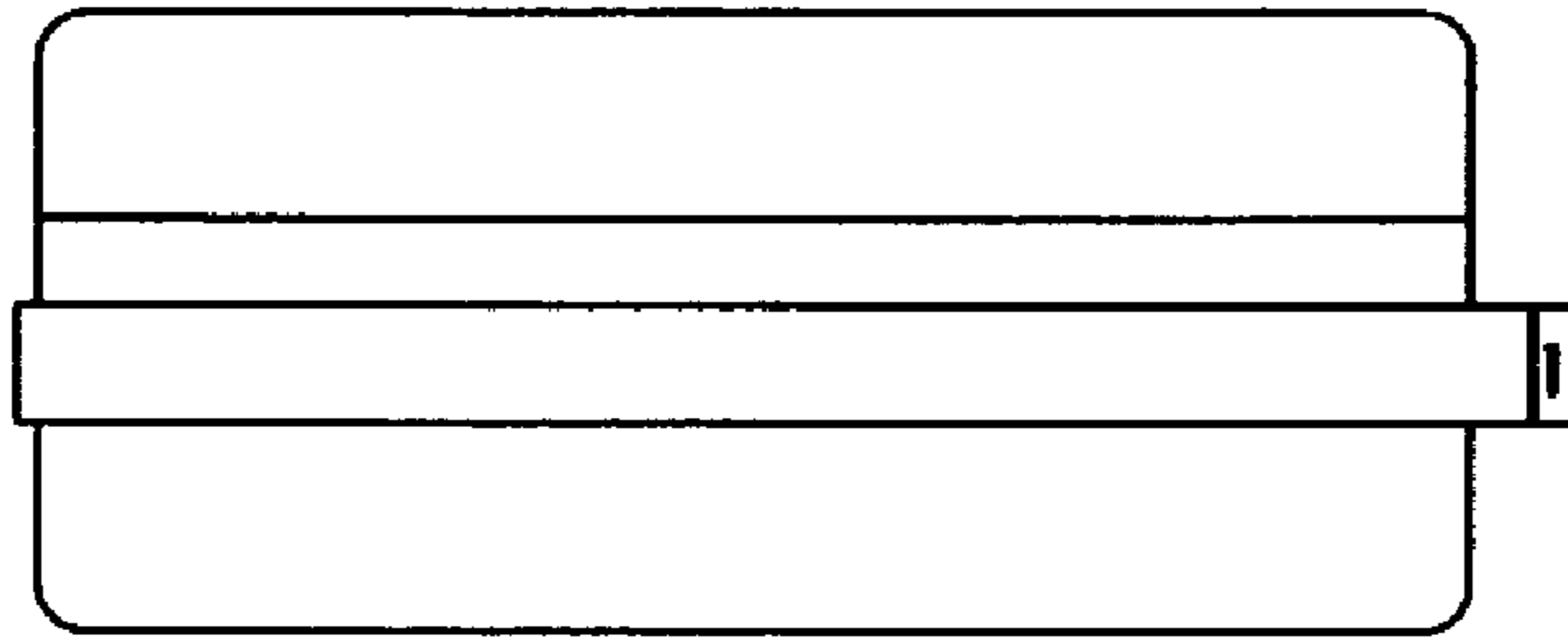
