FIG. 2 is a right rear perspective of the claimed design.

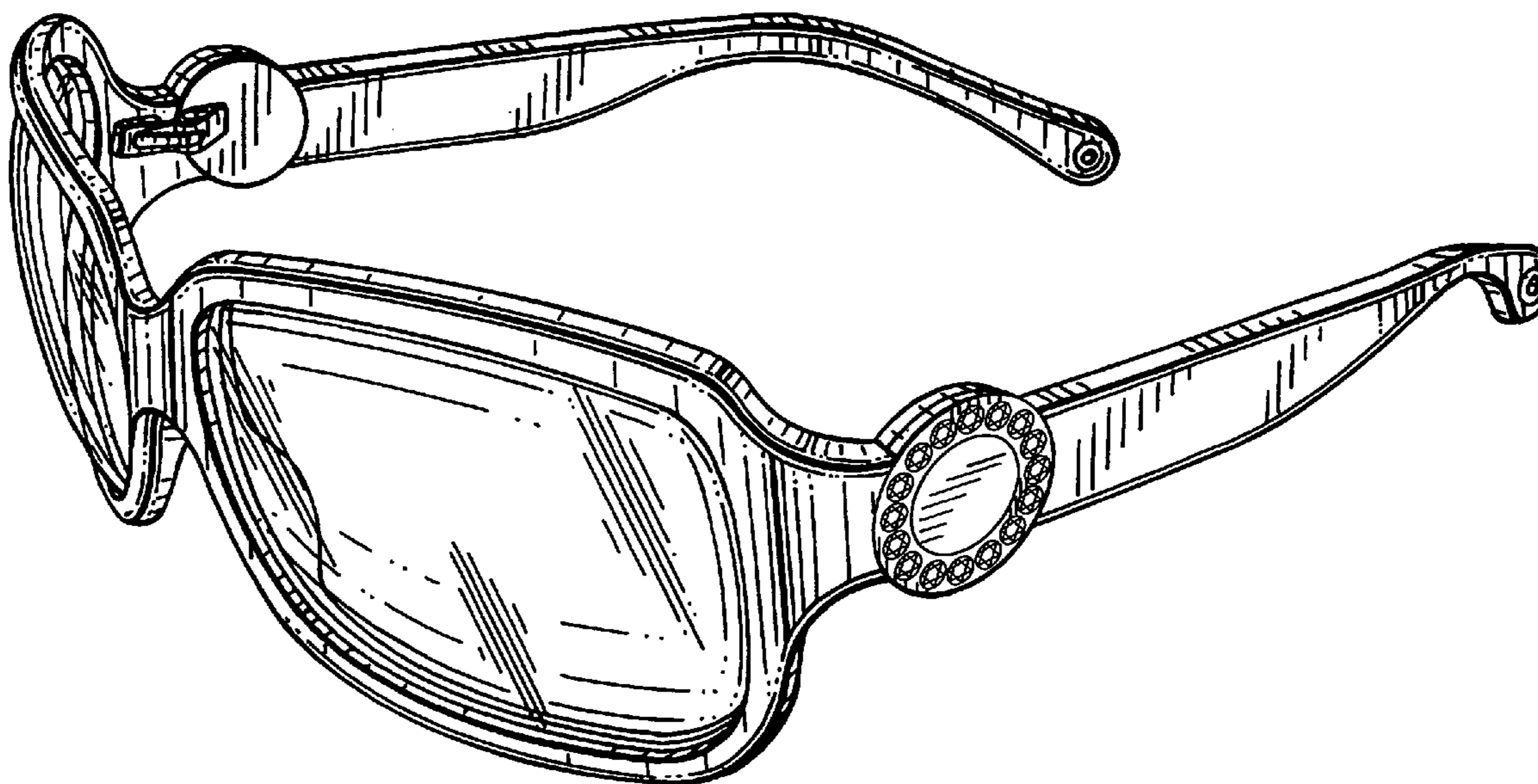
FIG. 3 is a top plan view of the claimed design.

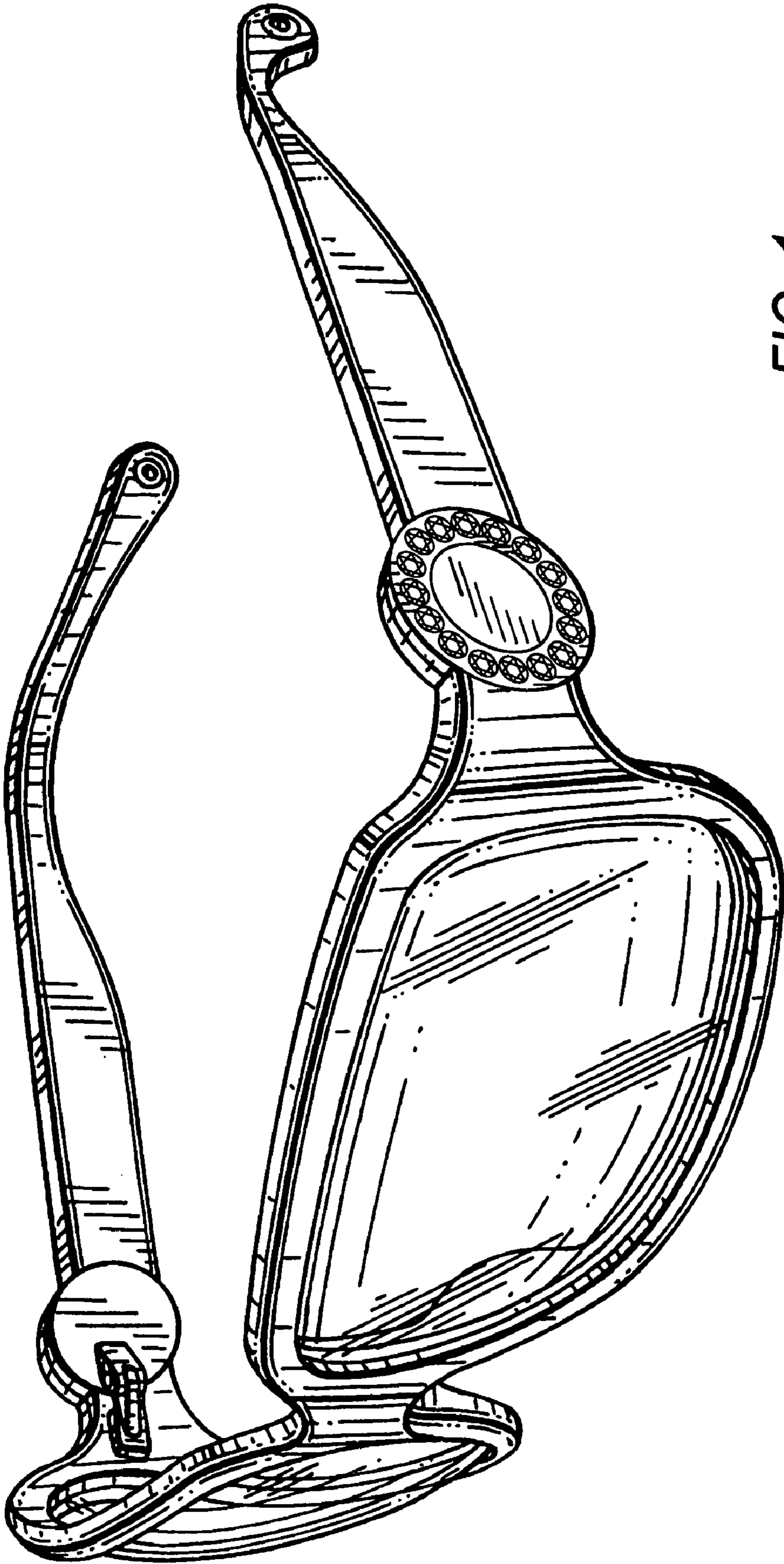

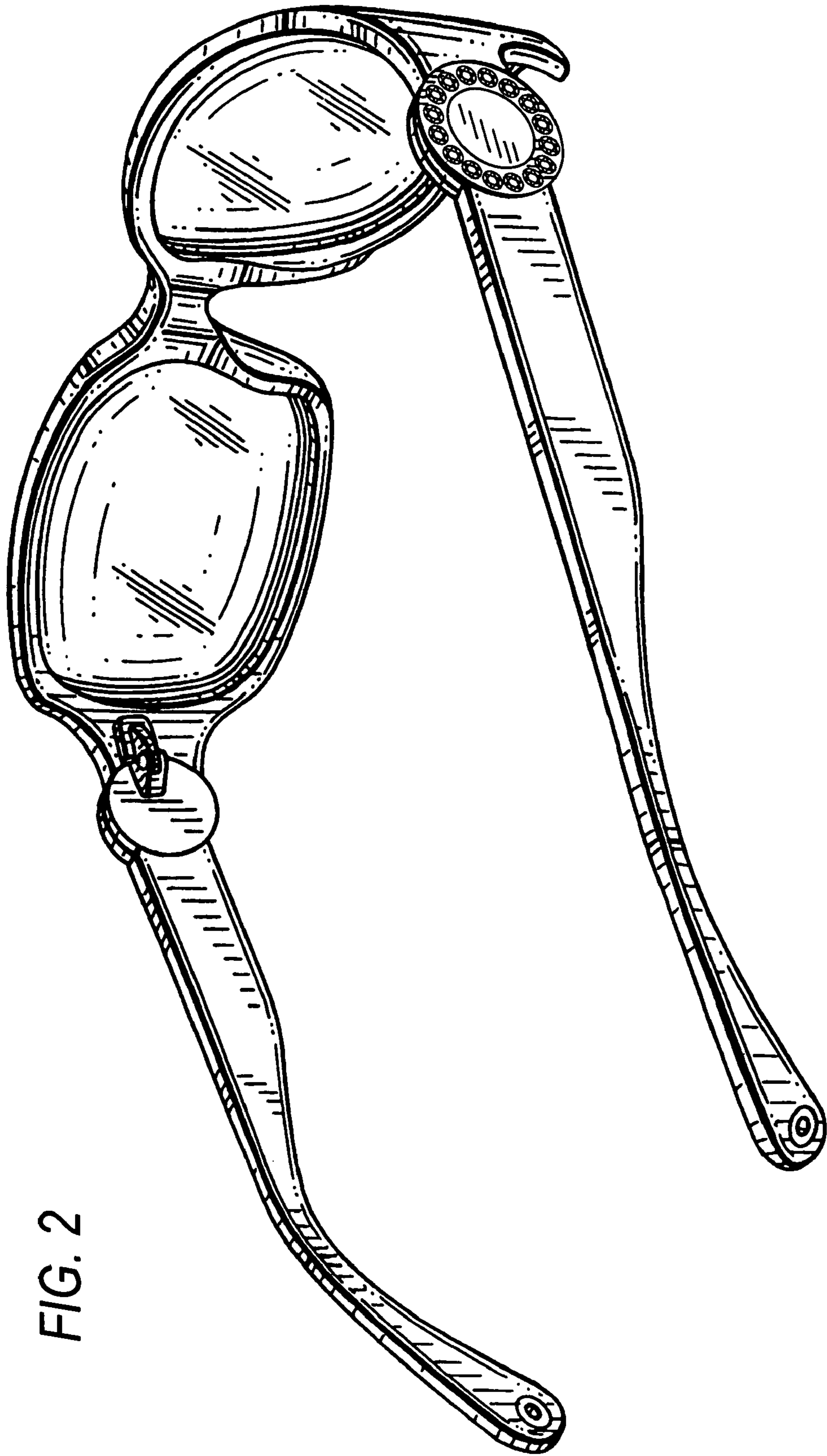

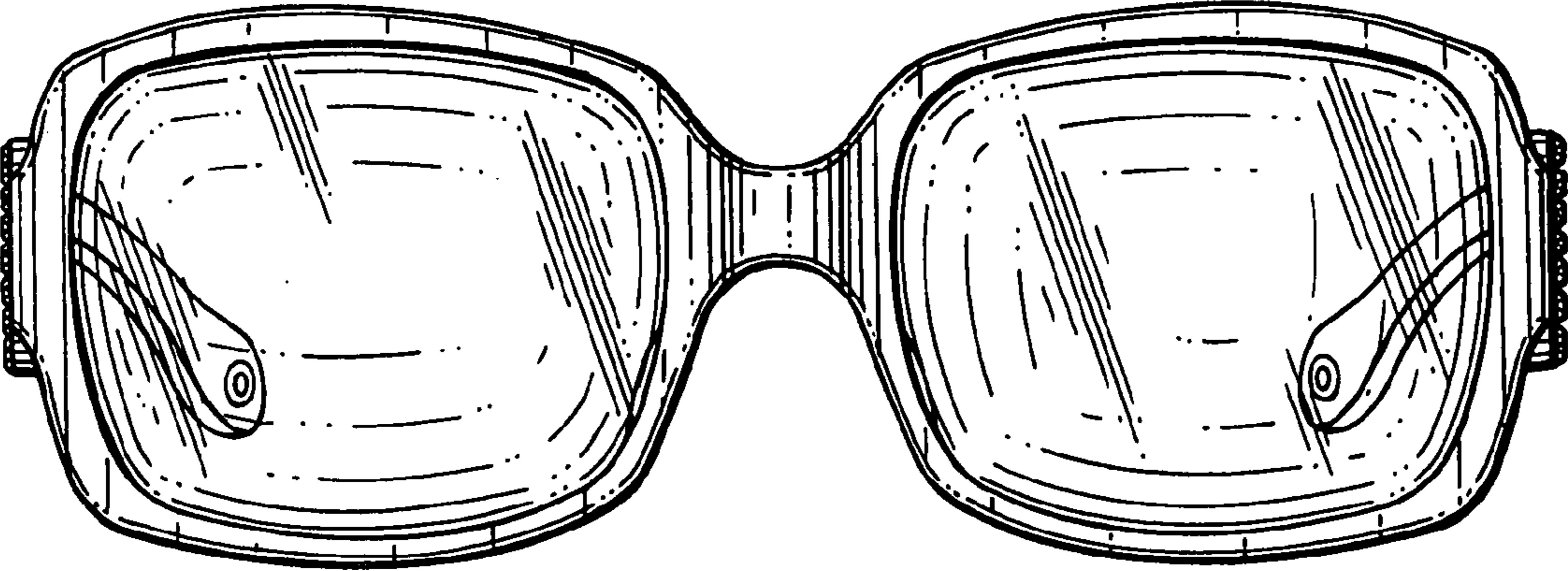
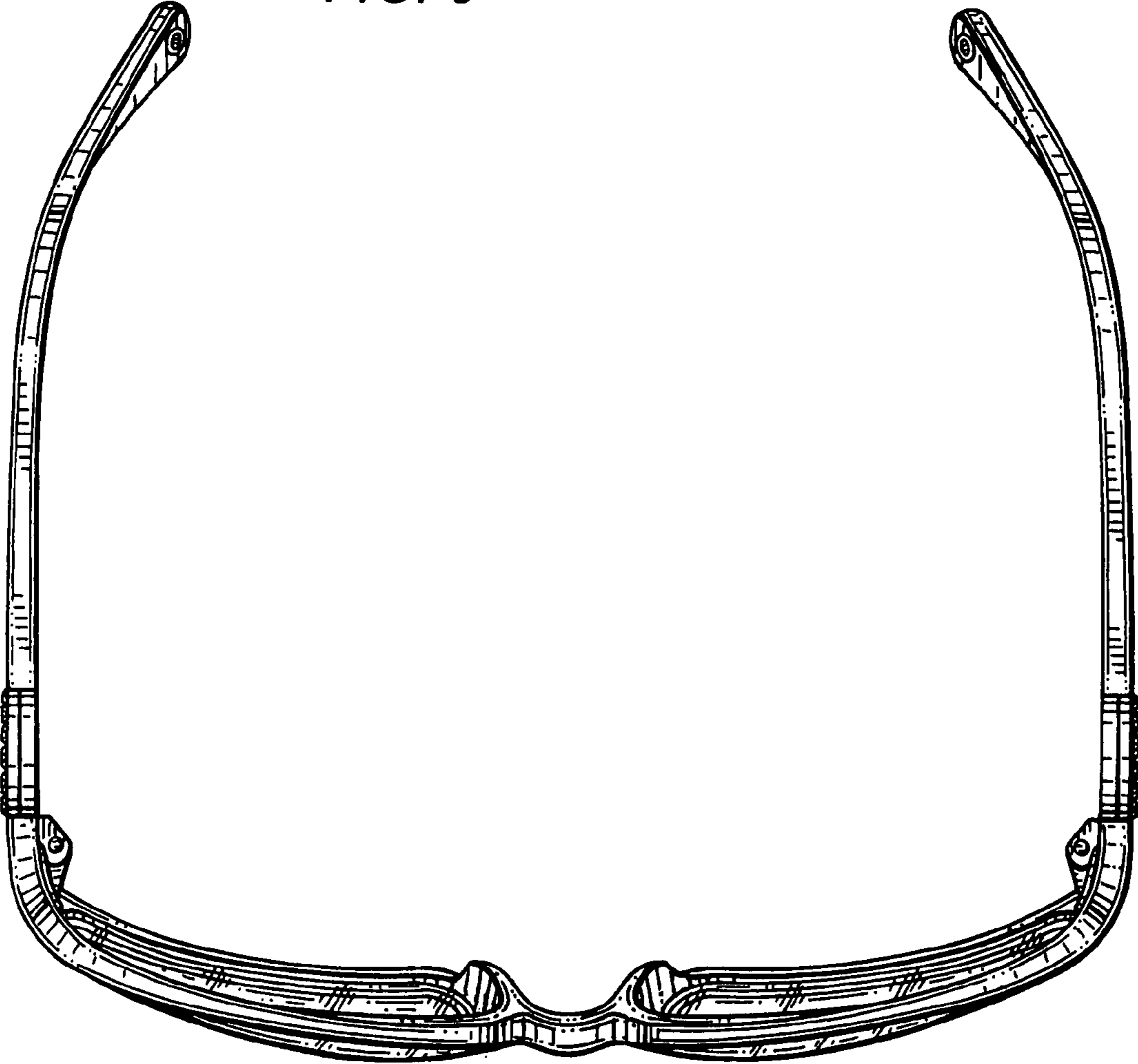

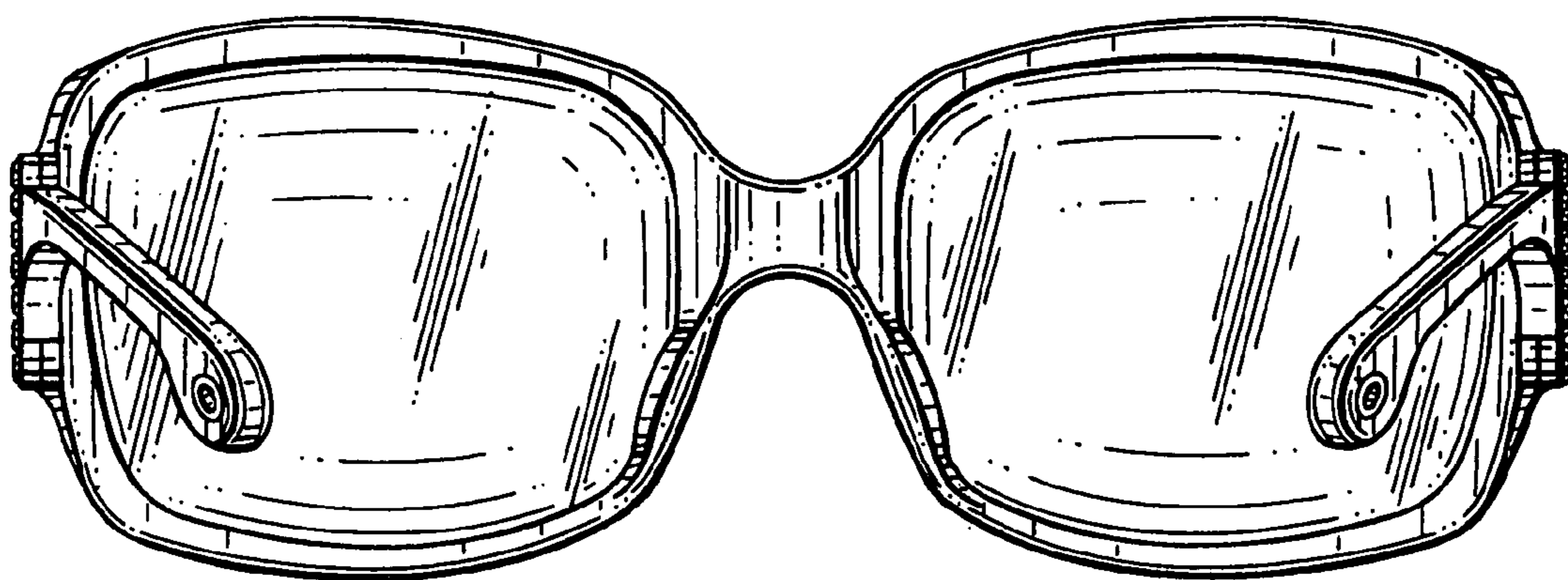
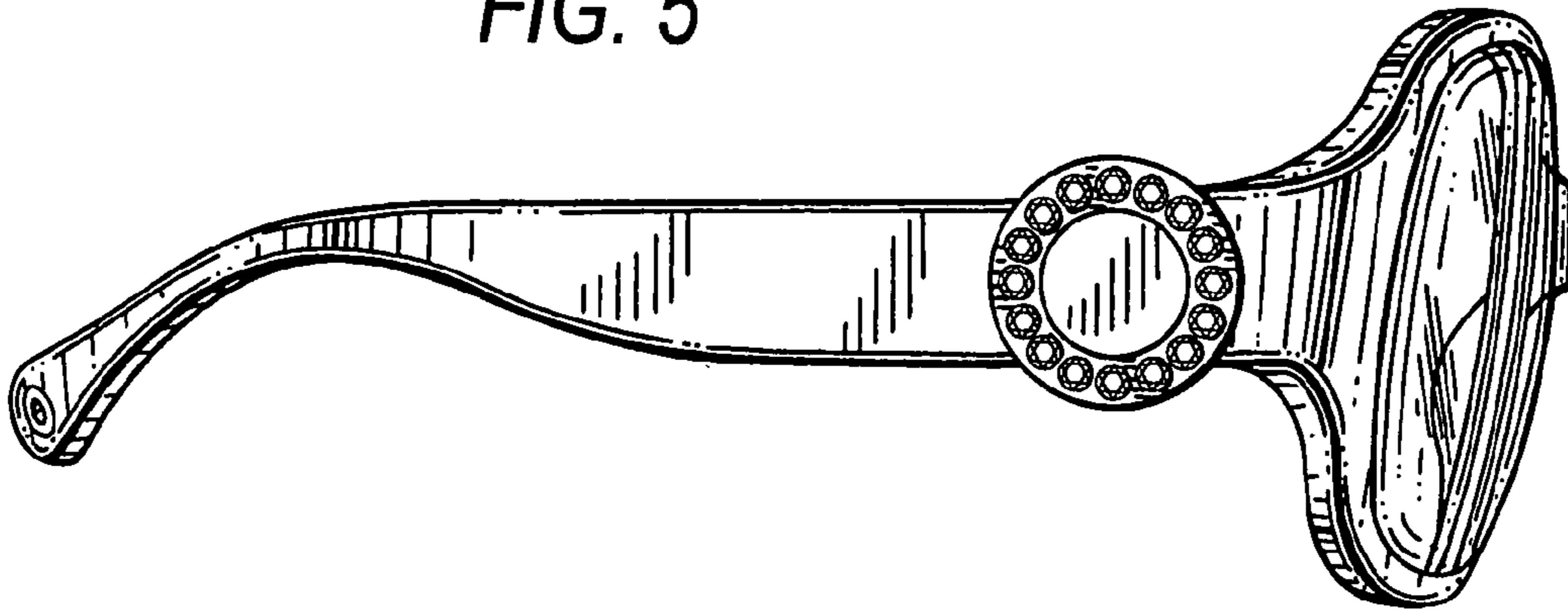
