(57) **CLAIM**

The ornamental design for a media display system for a ski-lift chair, as shown and described.

DESCRIPTION

FIG. 1 is a top rear perspective view of a media display system for a ski-lift chair, showing my new design;

FIG. 2 is a top plan view of the media display system of FIG. 1, showing the design;

FIG. 3 is a rear elevation view of the media display system of FIG. 1, showing the design;

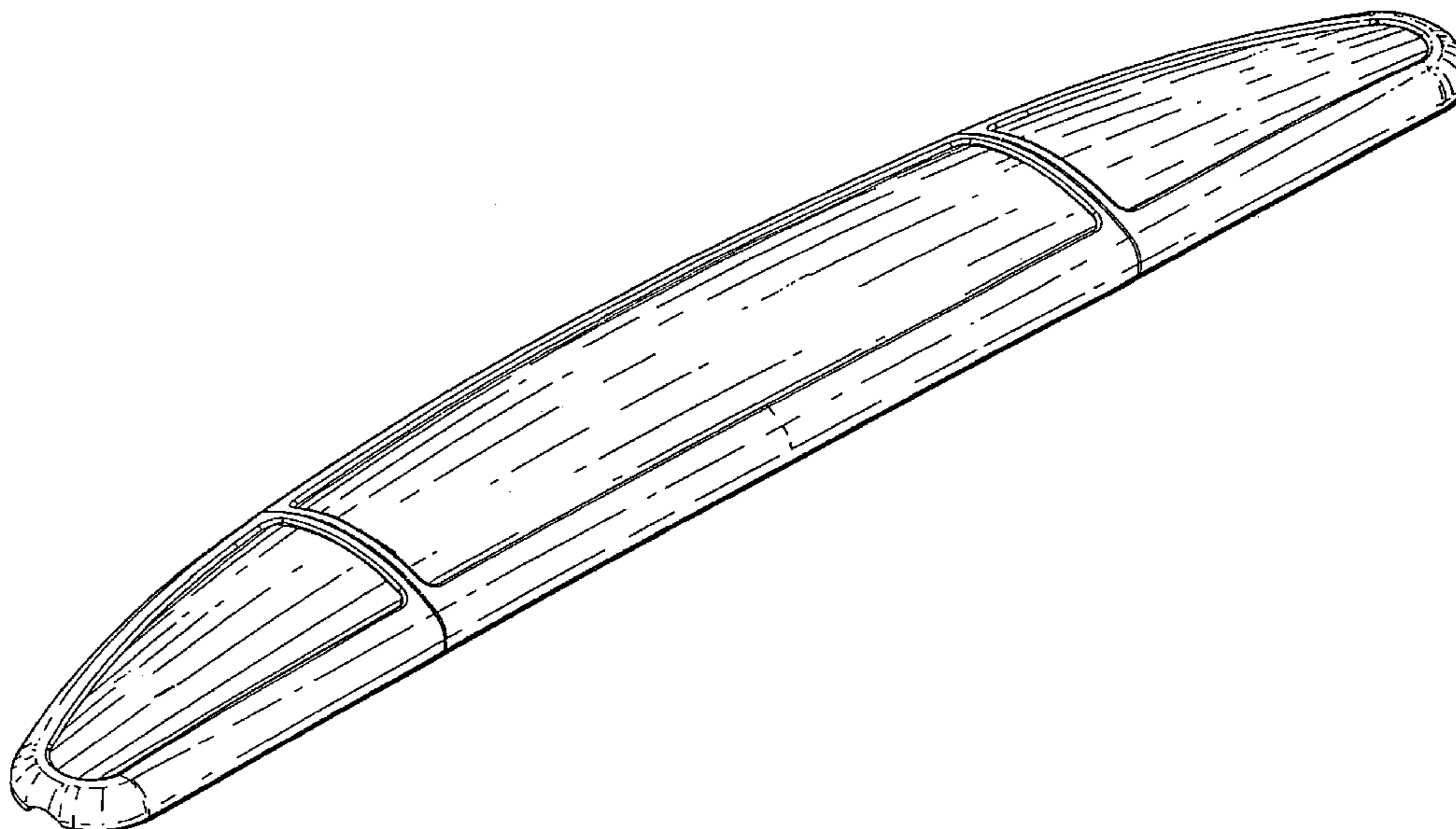
FIG. 4 is an enlarged left side elevation view of the media display system of FIG. 1, showing the design, the right side elevation view being a mirror image thereof;

FIG. 5 is a bottom plan view of the media display system of FIG. 1, showing the design; and,

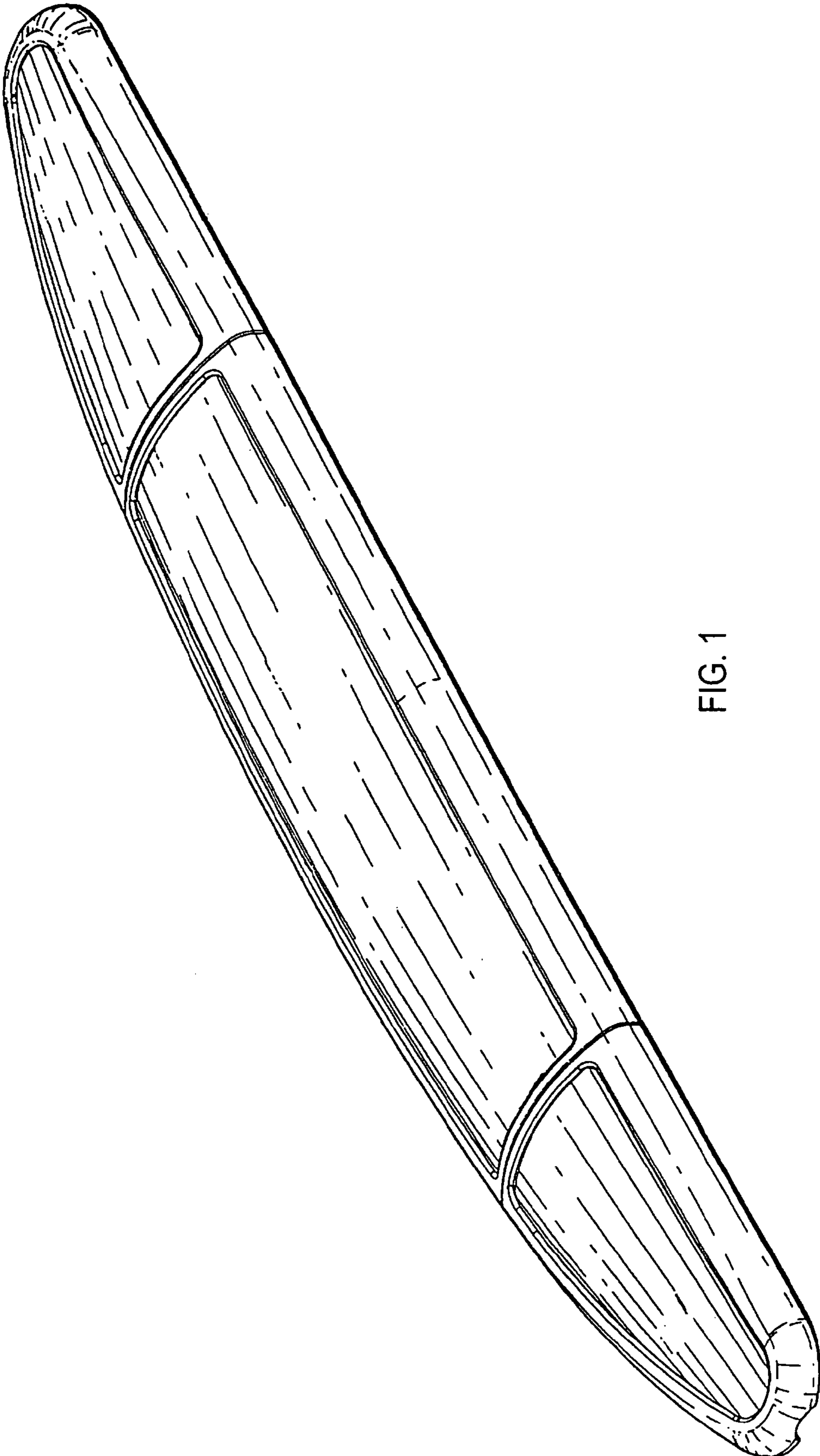

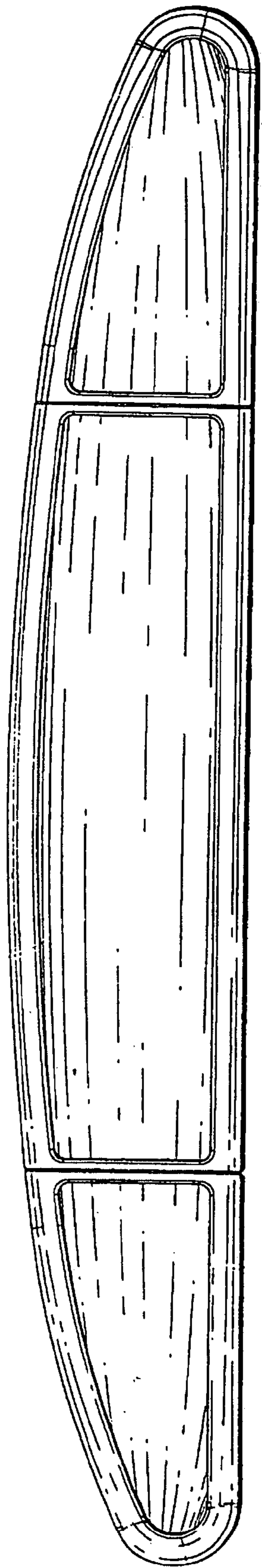

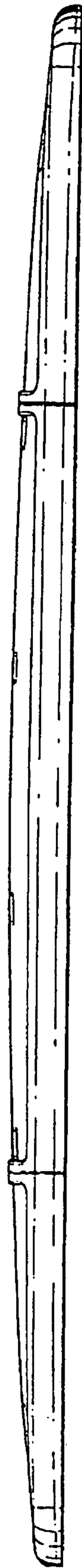

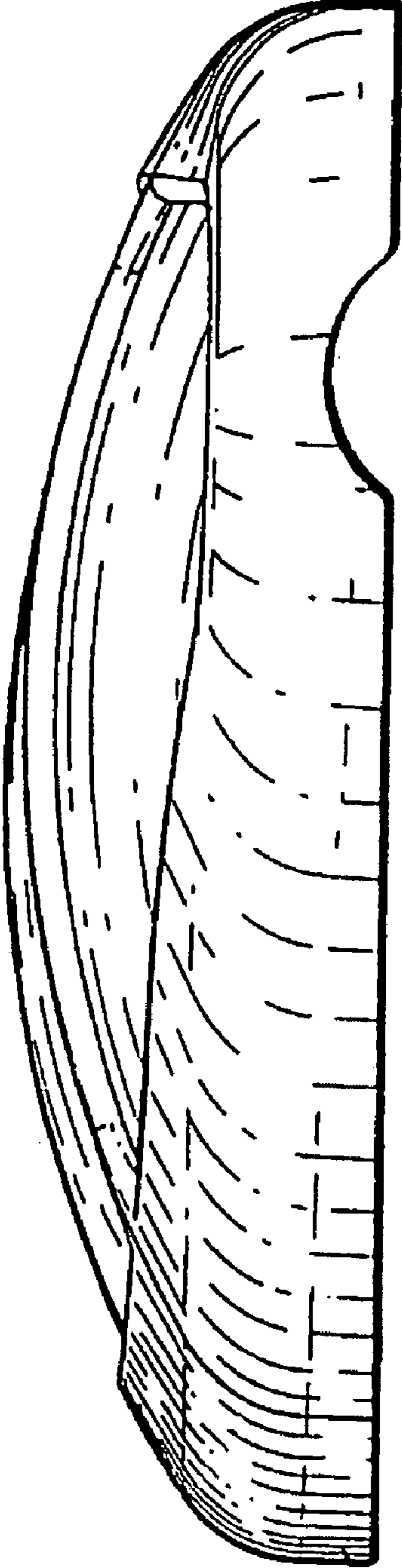

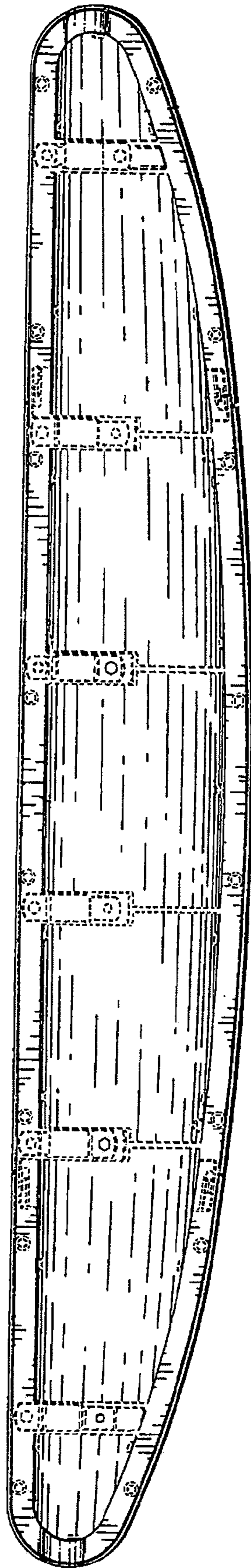
