FIG. 3 shows a rear view of the hockey blade shown in FIG. 1.

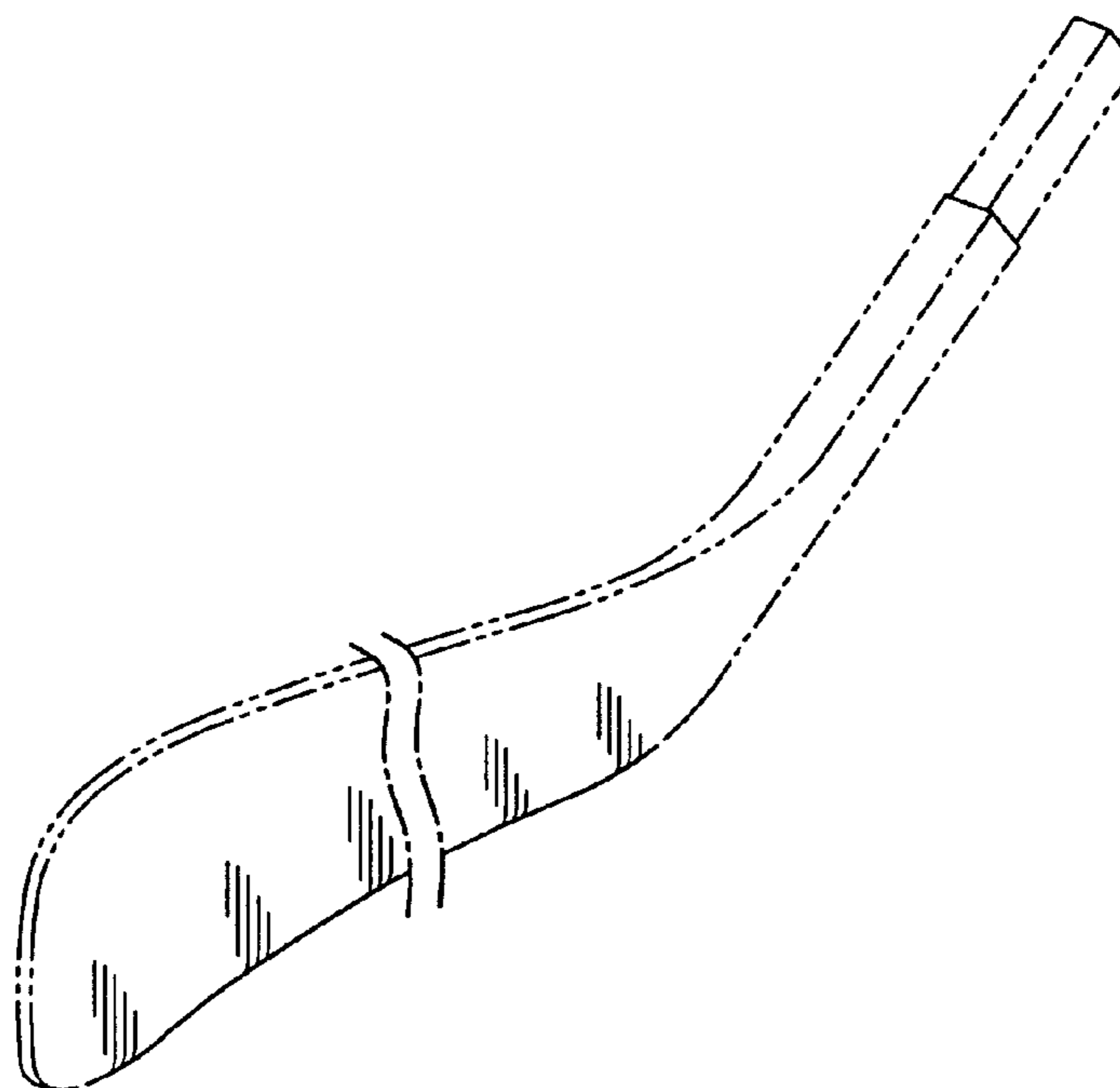
FIG. 4 shows a top view of the hockey blade shown in FIG. 1.

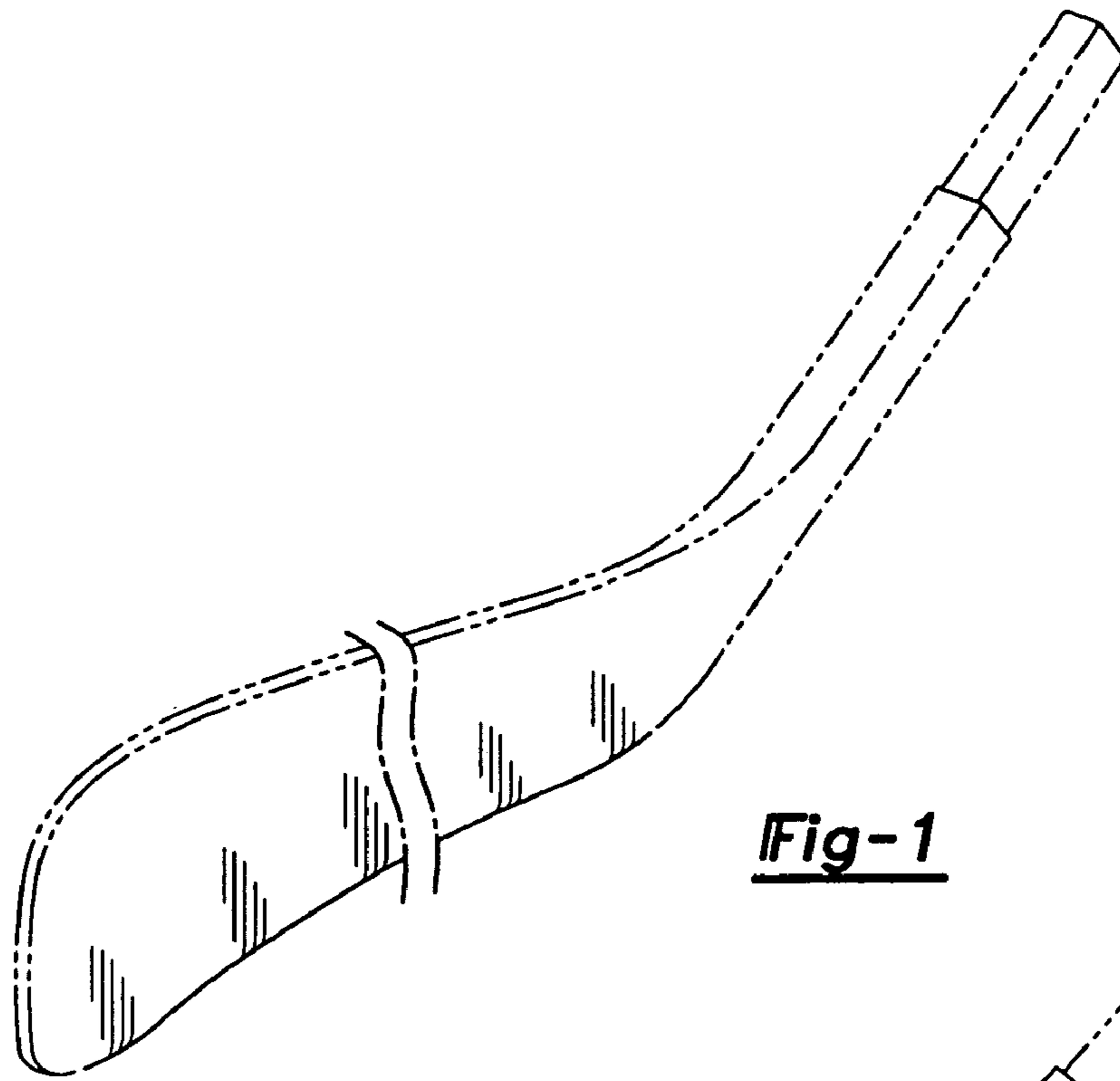

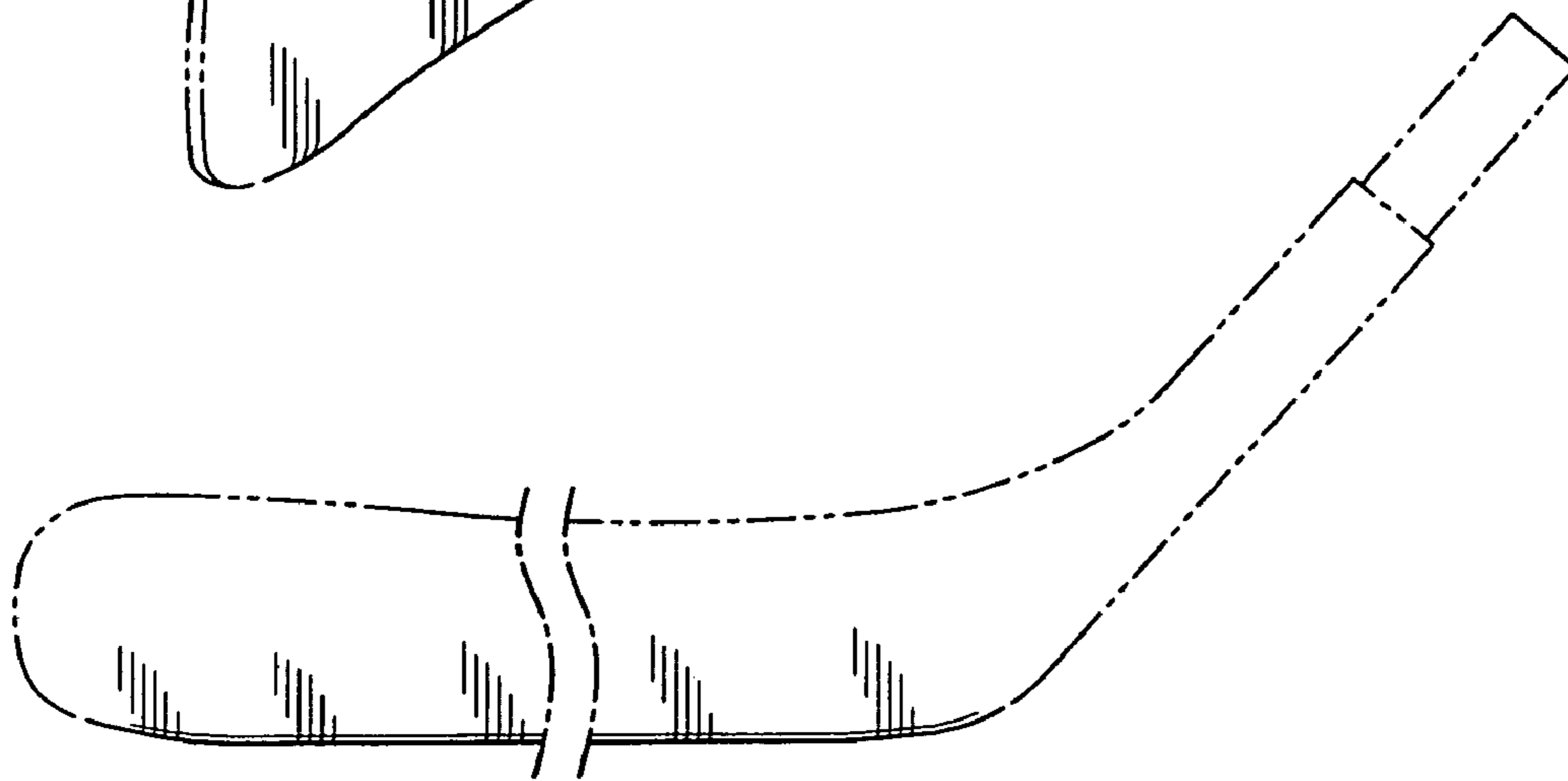

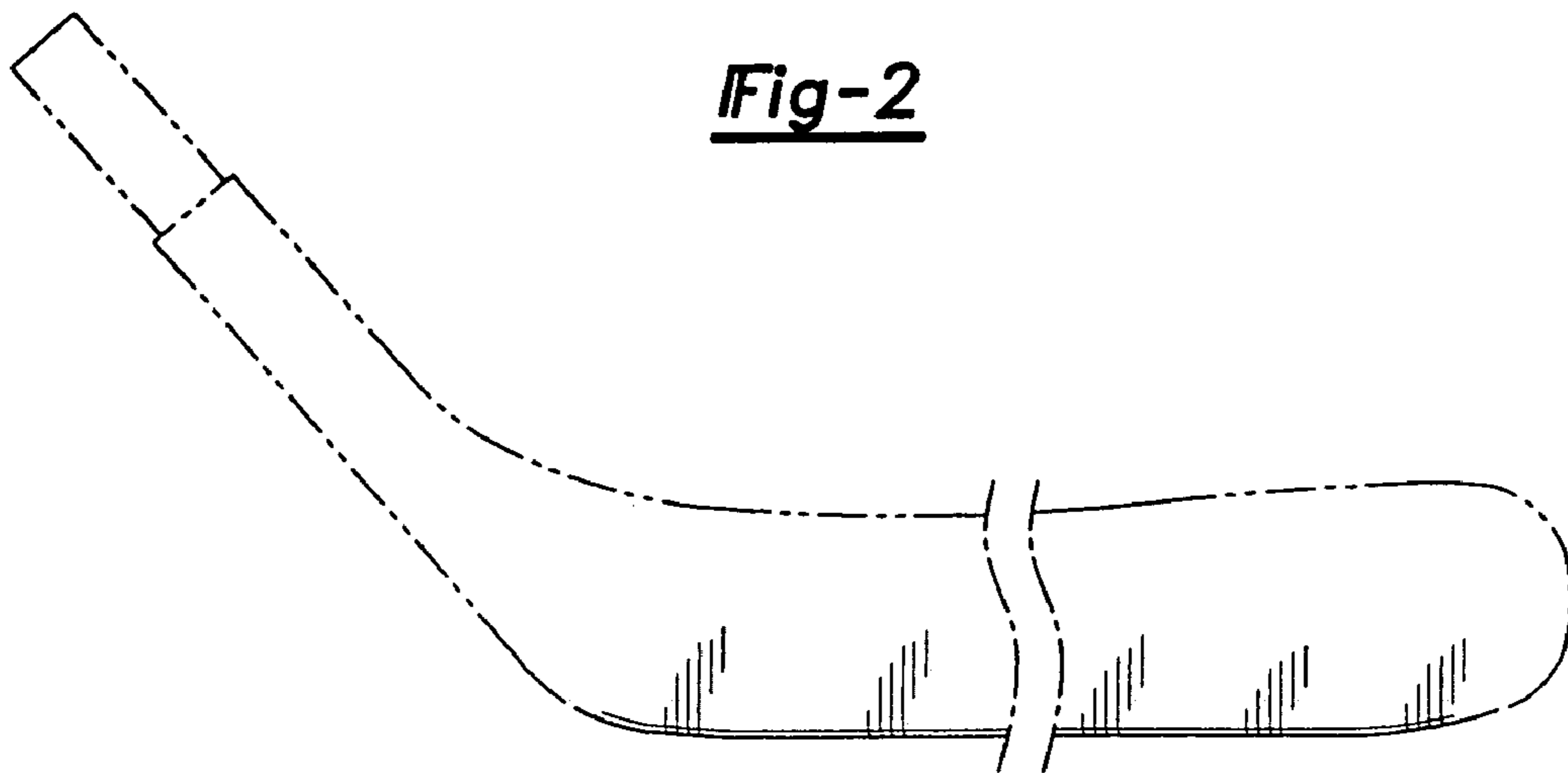

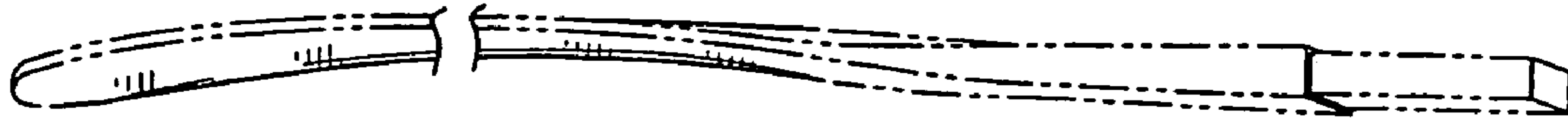

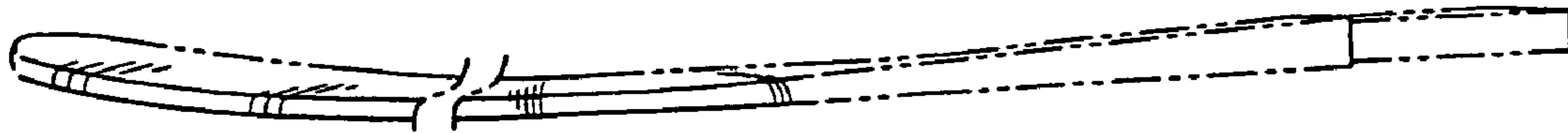

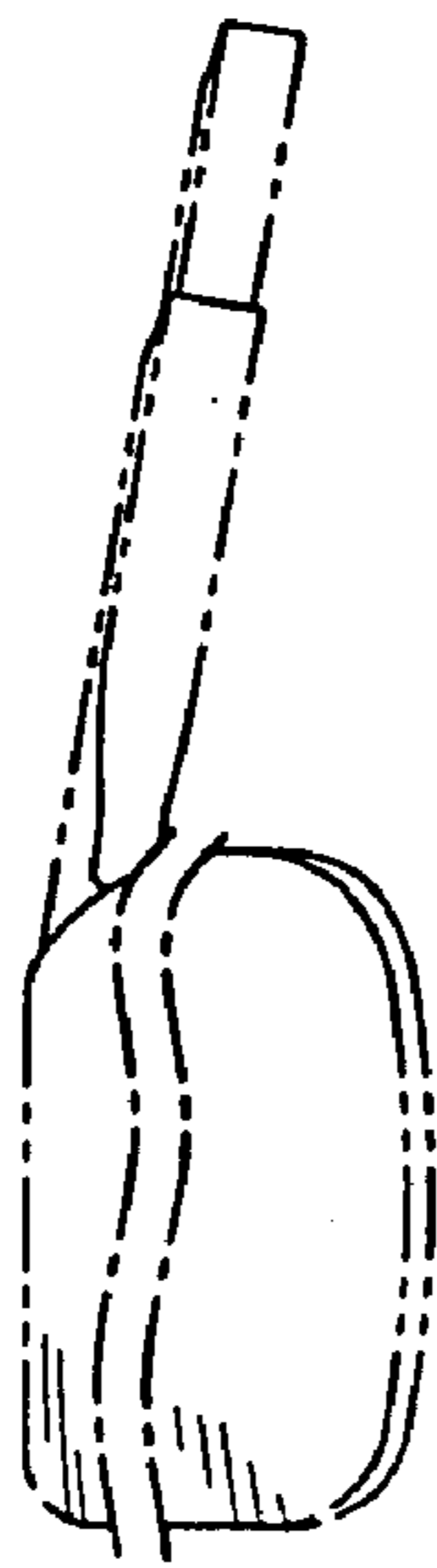
