FIG. 3 is a front view of the device.

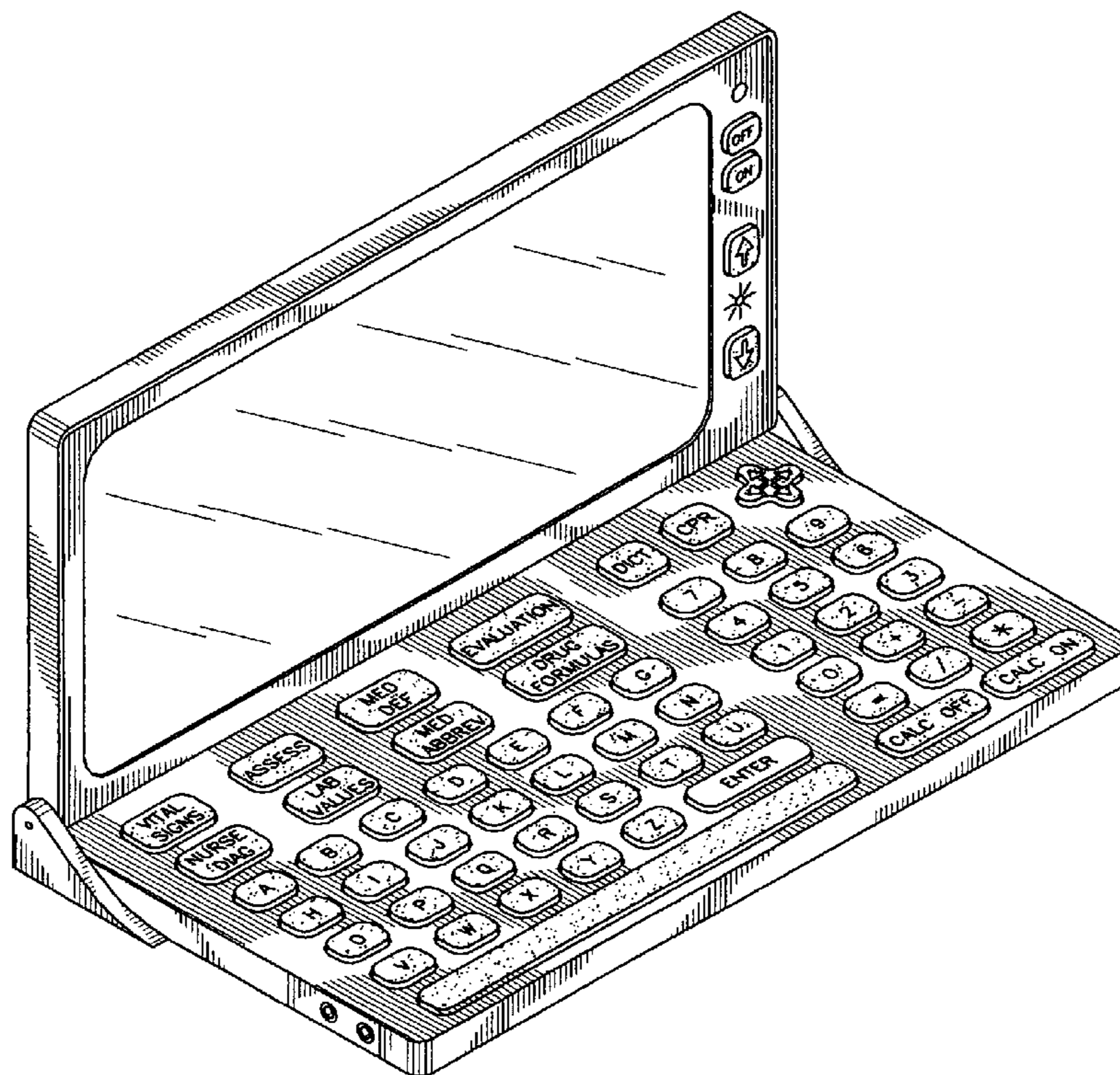
FIG. 4 is a back view of the device.

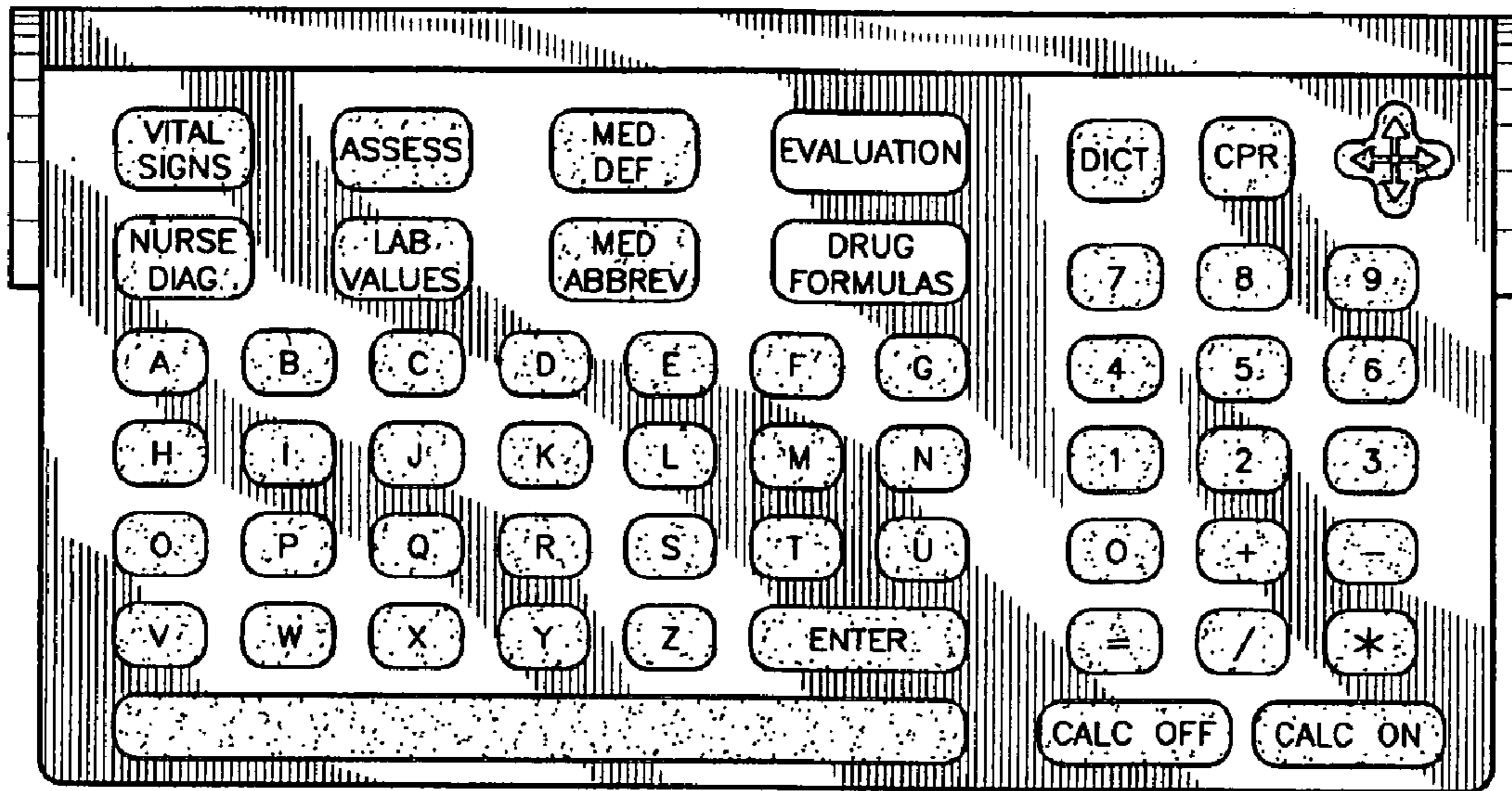

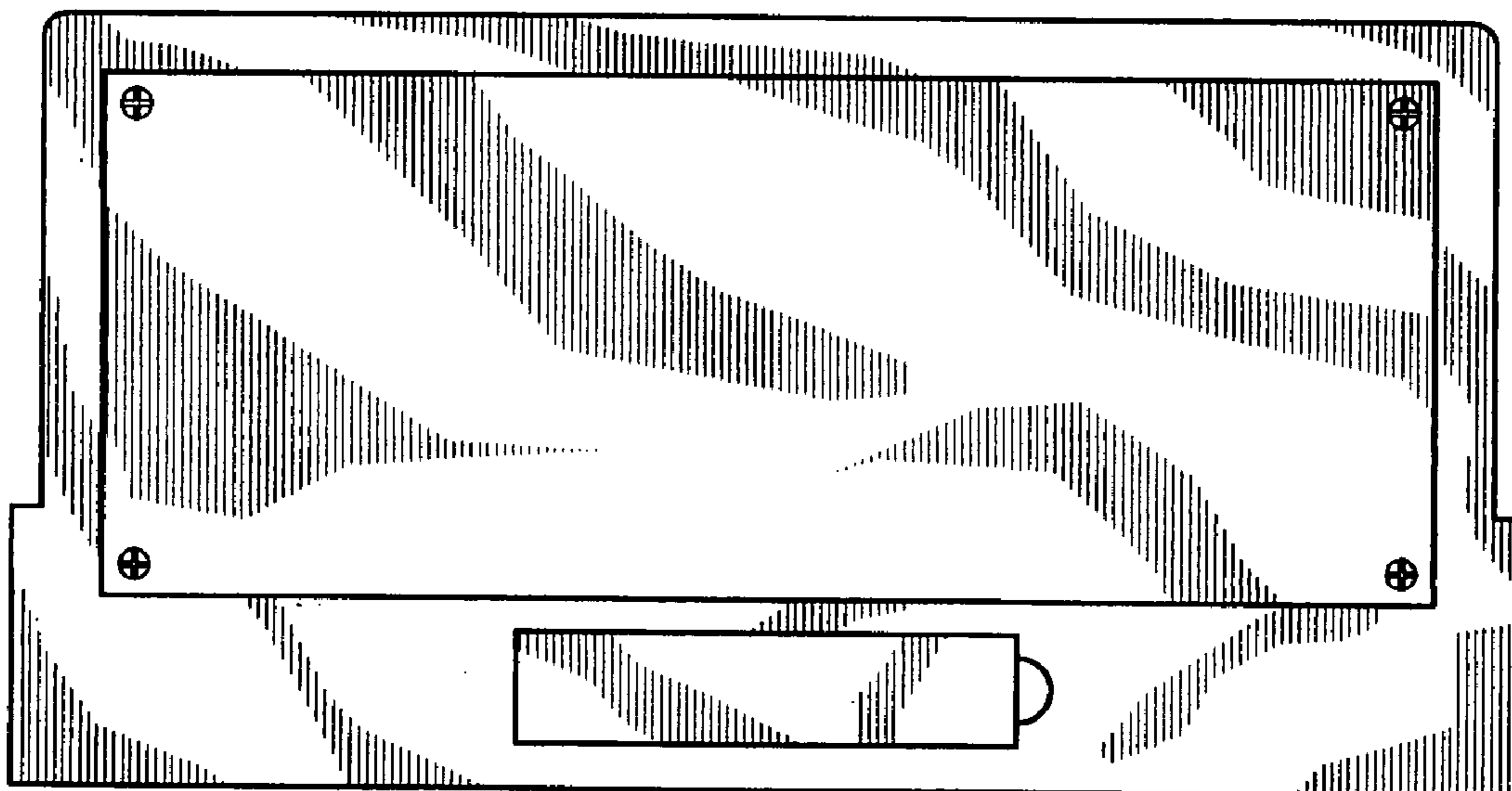

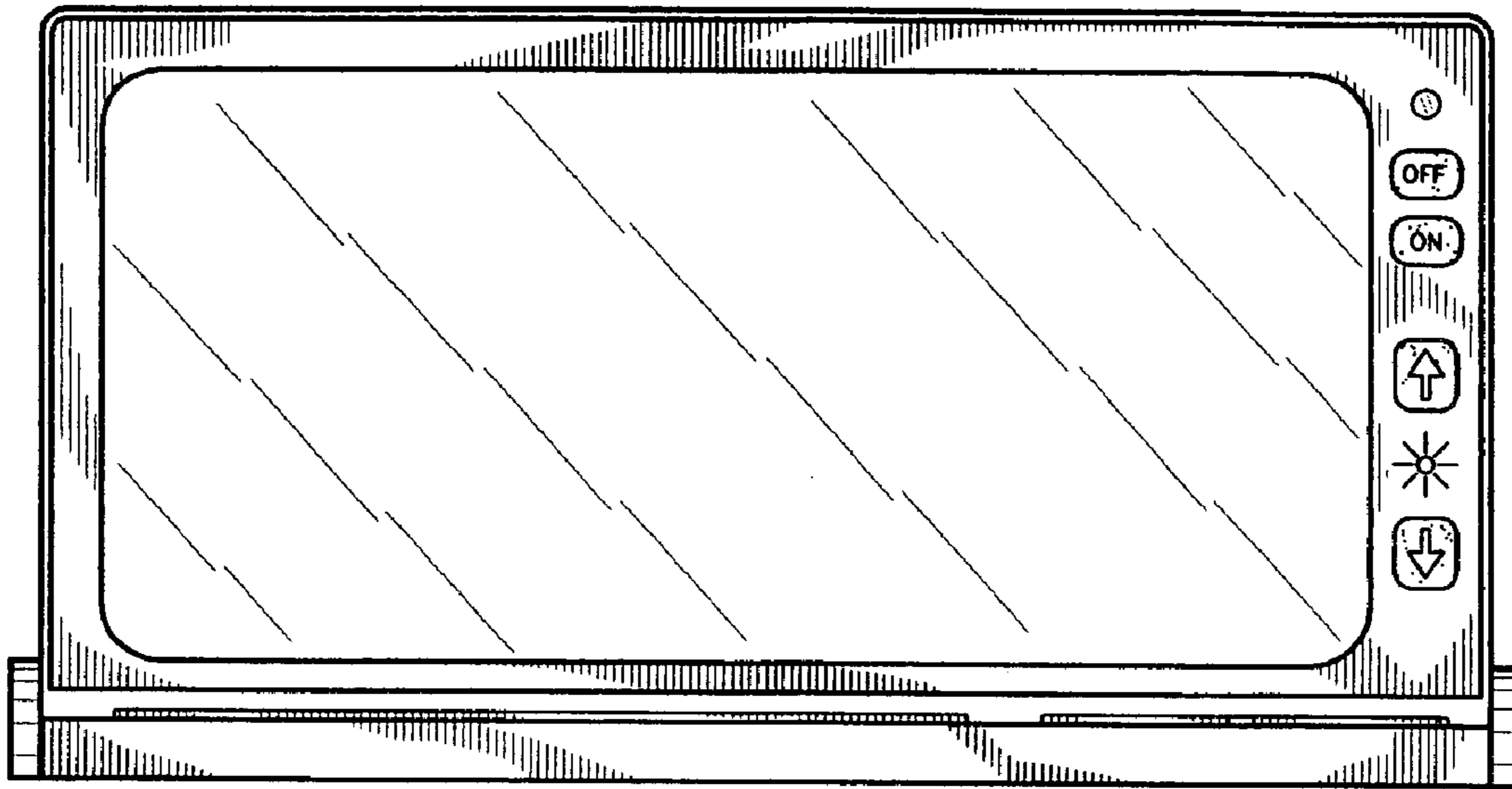

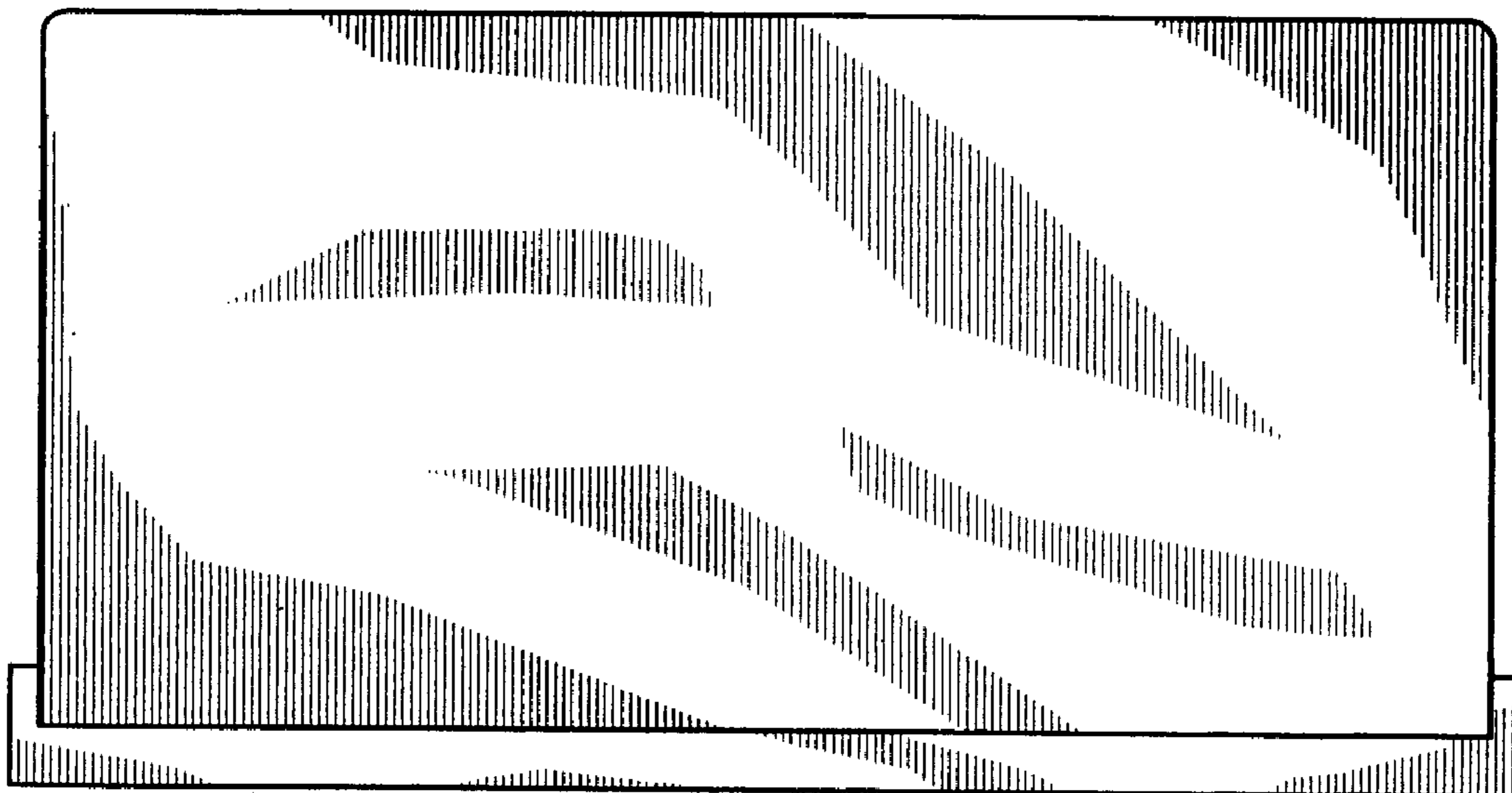

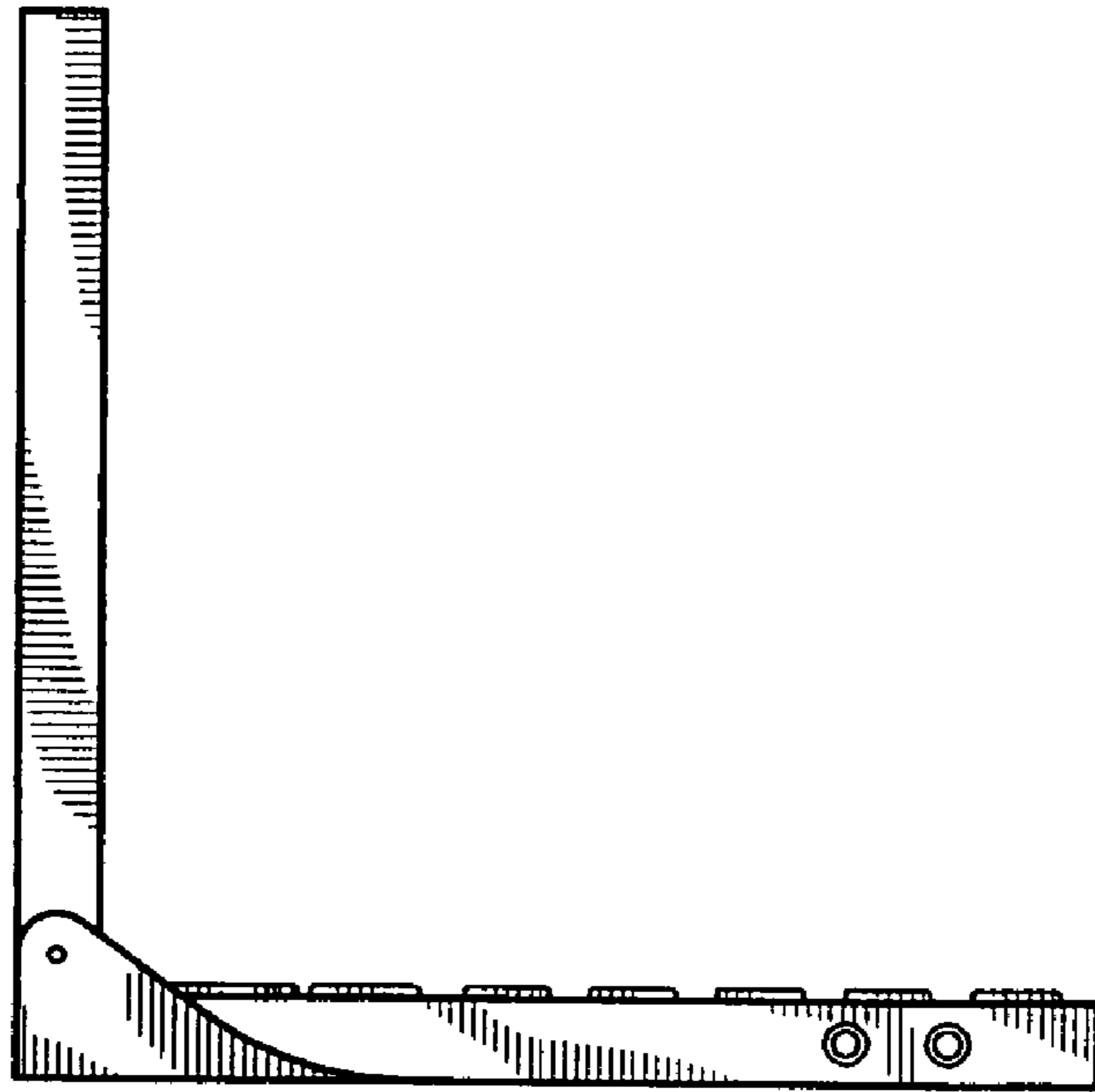

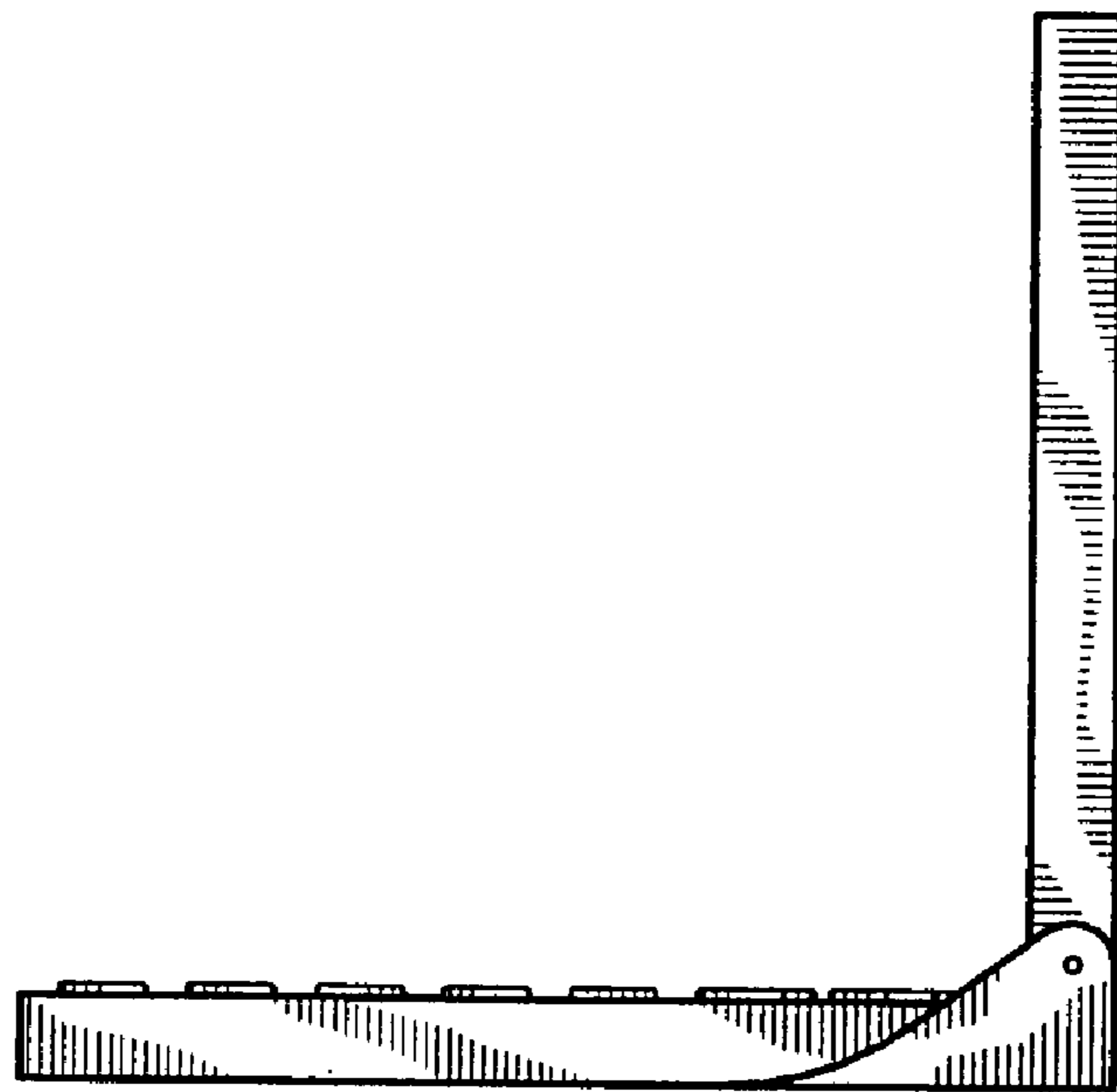

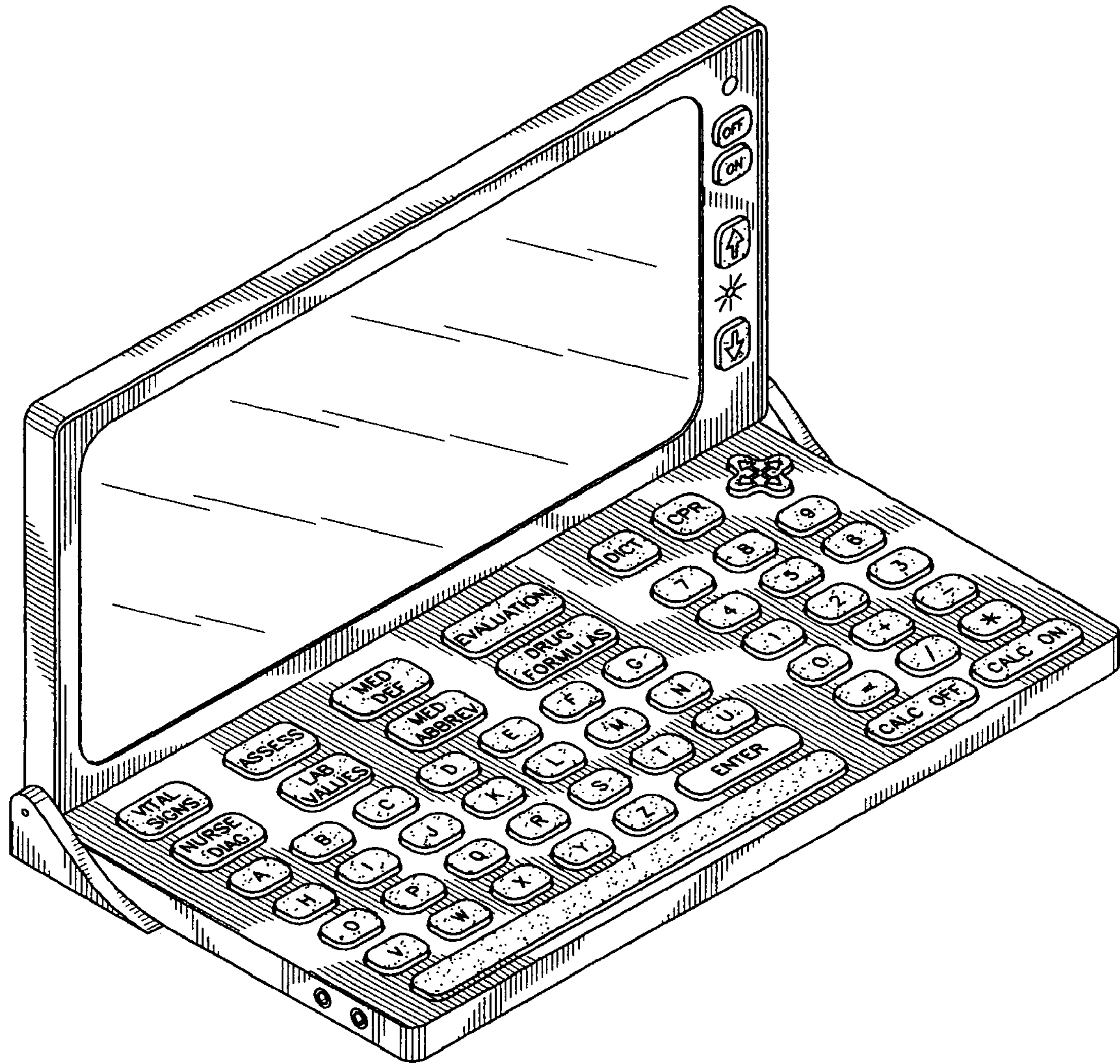
