The ornamental design for a hookah, as shown and described.

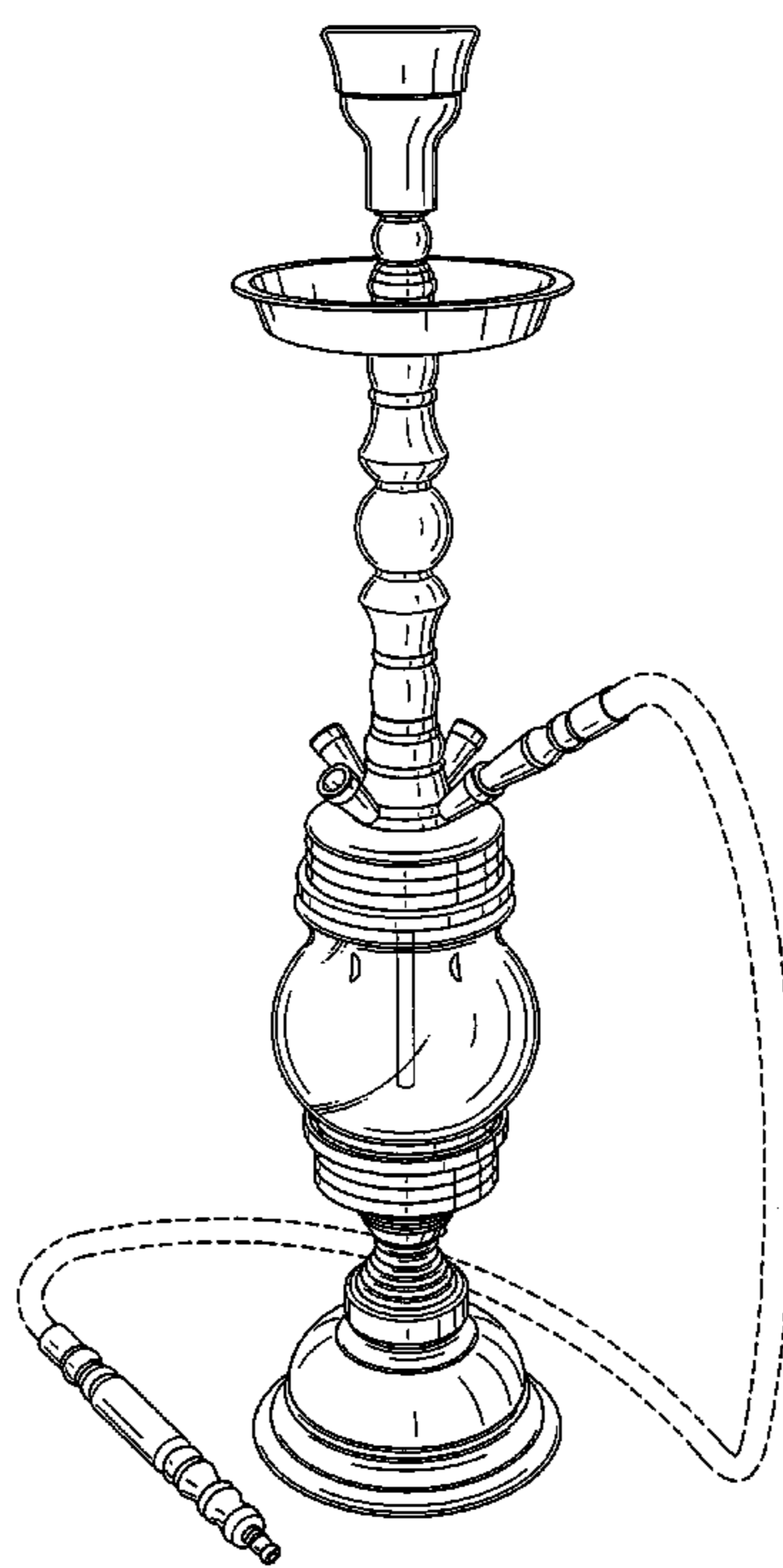
DESCRIPTION

FIG. 1 is a perspective view of my design for a hookah;
 FIG. 2 is an elevation view of the side of the hookah;
 FIG. 3 is another elevation view of the side of the hookah;
 FIG. 4 is another elevation view of the side of the hookah;
 FIG. 5 is another elevation view of the side of the hookah;
 FIG. 6 is a top plan view of the hookah;
 FIG. 7 is a bottom plan view of the hookah;
 FIG. 8 is a perspective view of the mouthpiece to the hookah;
 FIG. 9 is an elevation view of the side of the mouthpiece to the hookah;
 FIG. 10 is a top plan view looking into the mouthpiece to the hookah;
 FIG. 11 is a perspective view of the connector which connects the mouthpiece to the hookah;
 FIG. 12 is an elevation view of the side of said connector; and,
 FIG. 13 is a top plan view looking into said connector.

The broken lines are shown for illustrative purposes only and form no part of the claimed design.

The hookah, mouthpiece, and connector are disclosed separately for convenience of illustration.

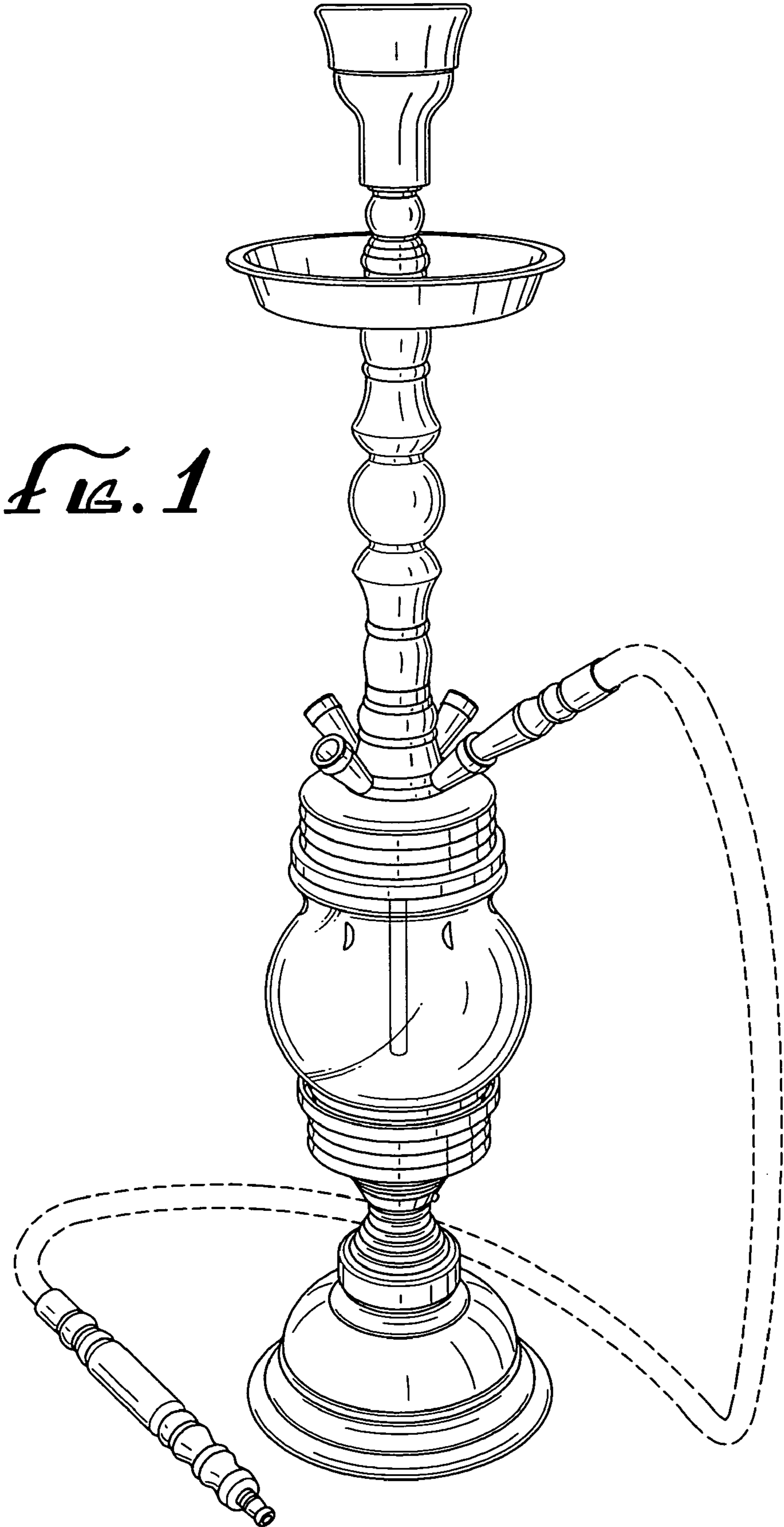

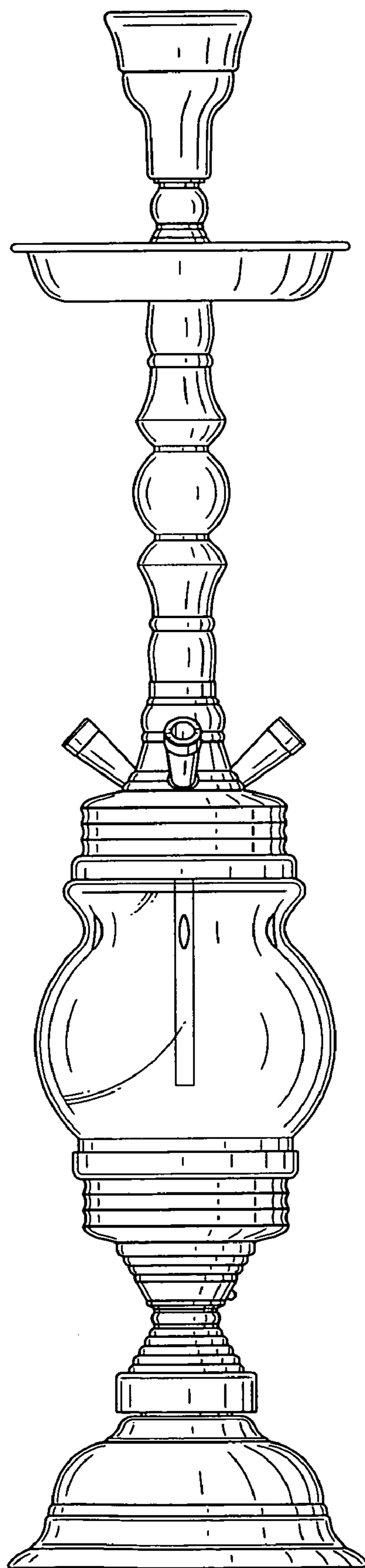

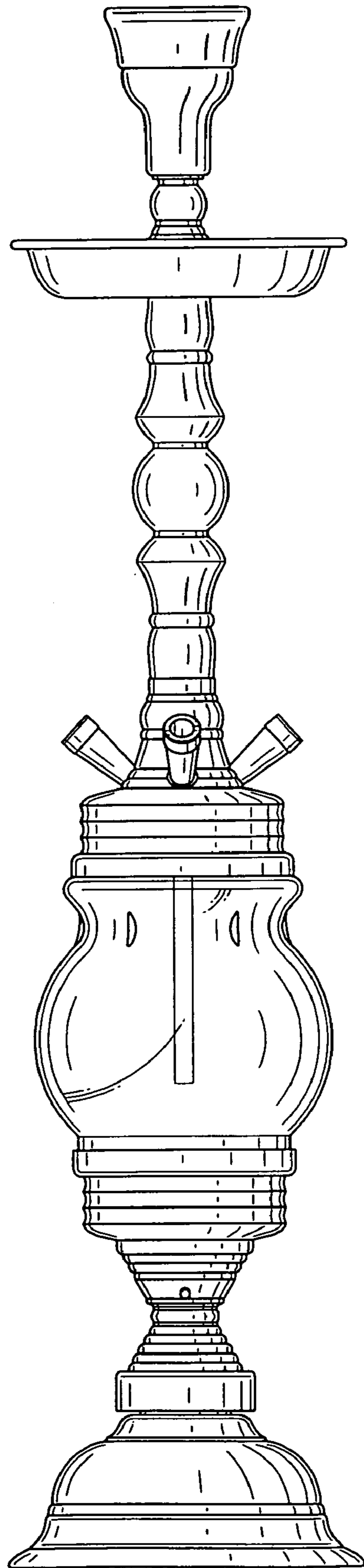

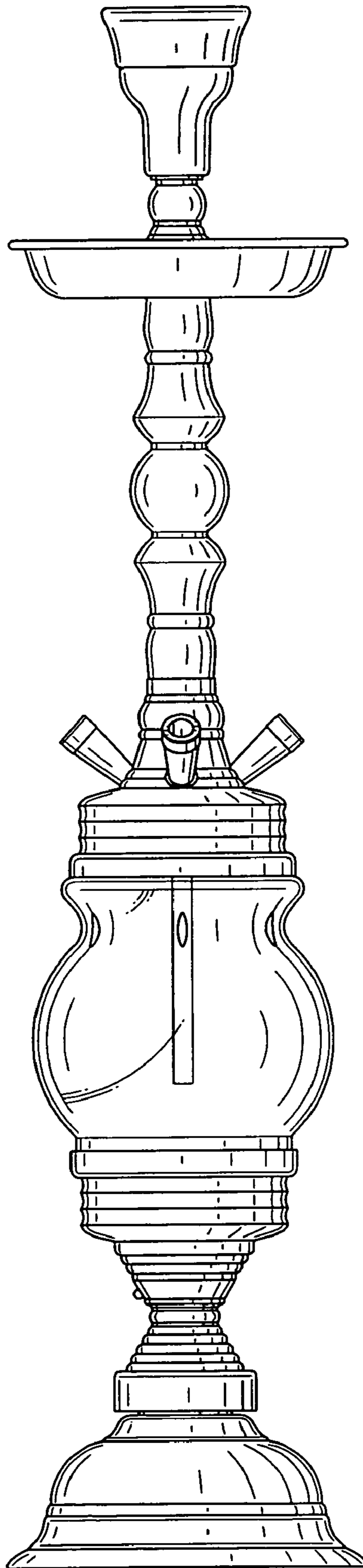
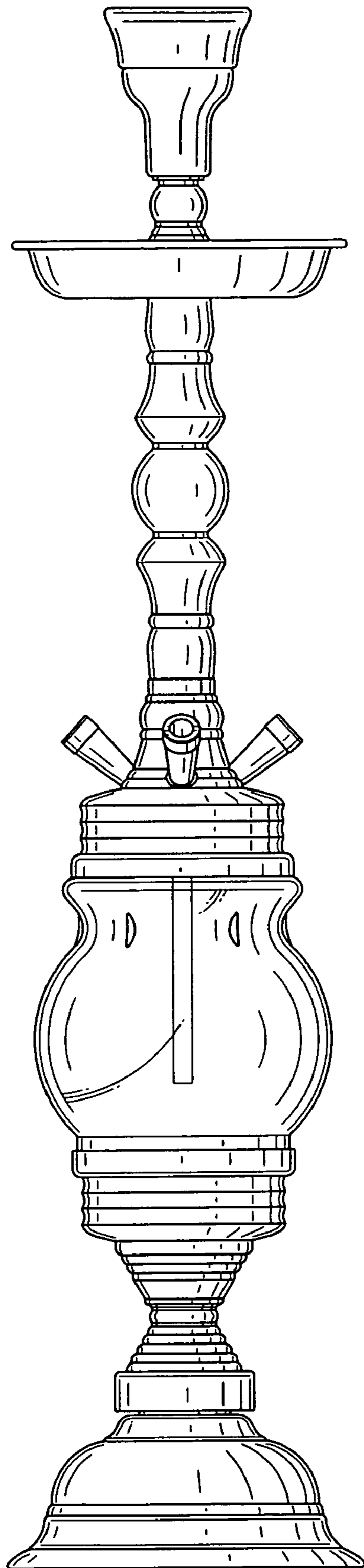

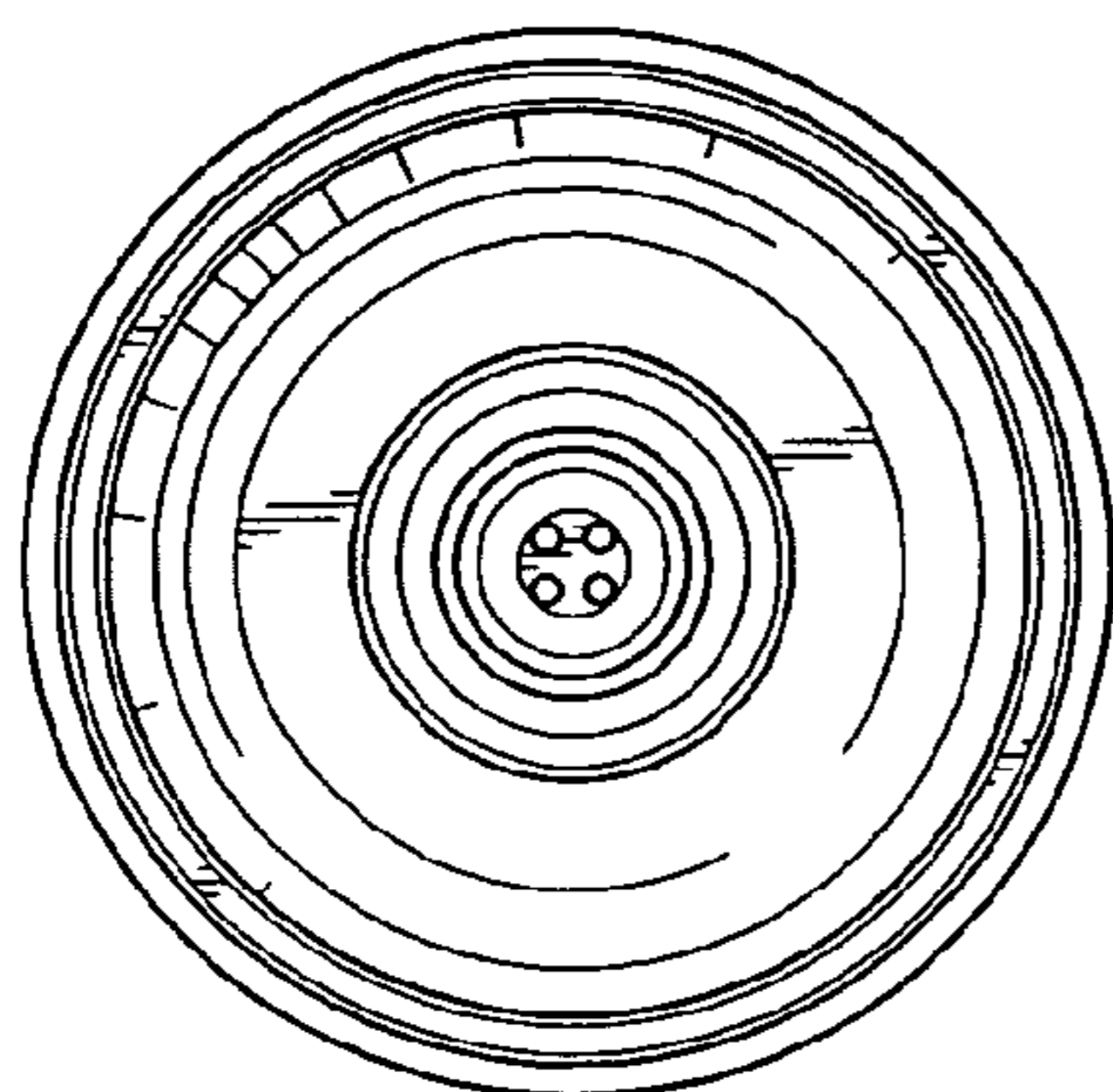

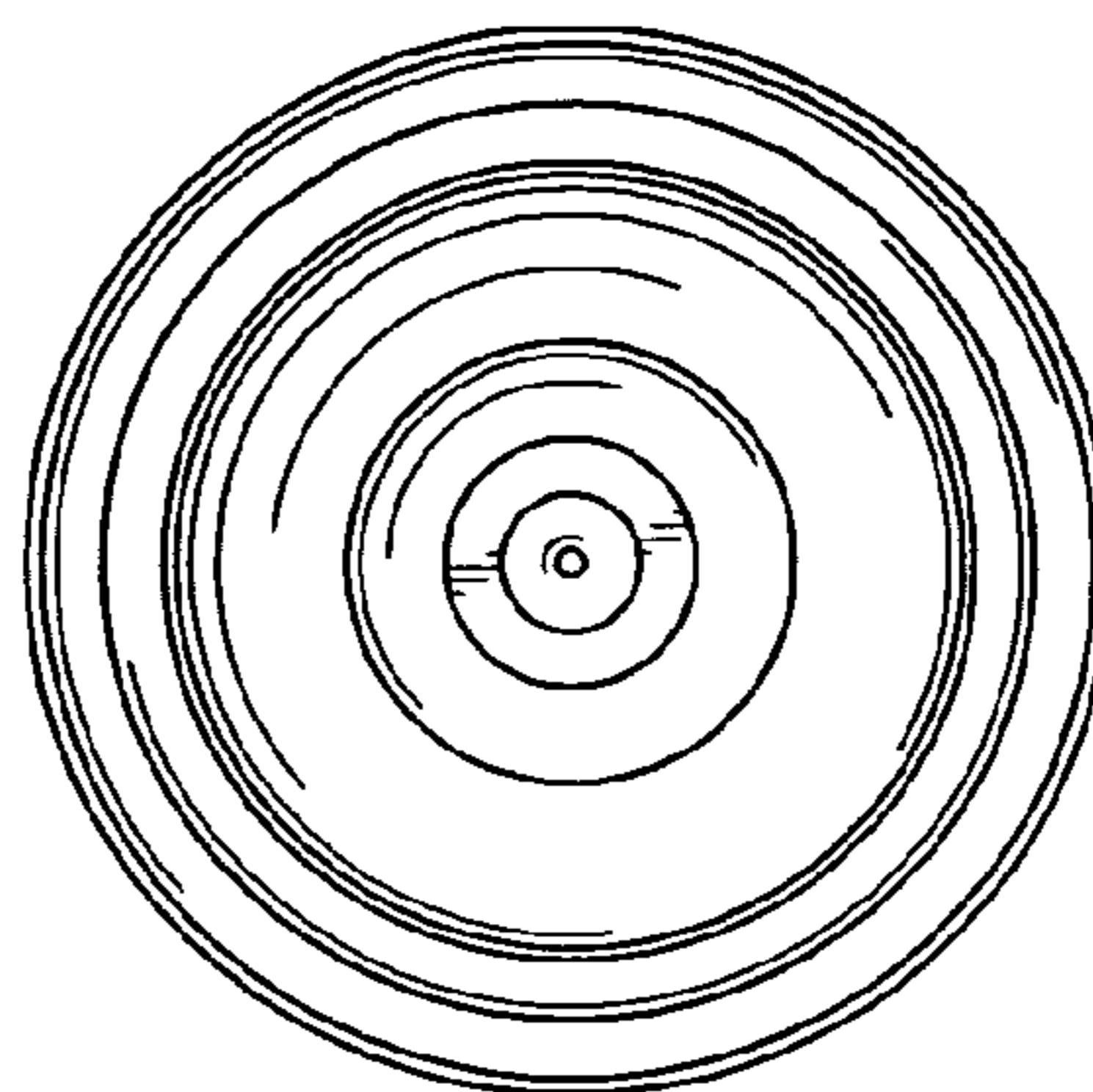

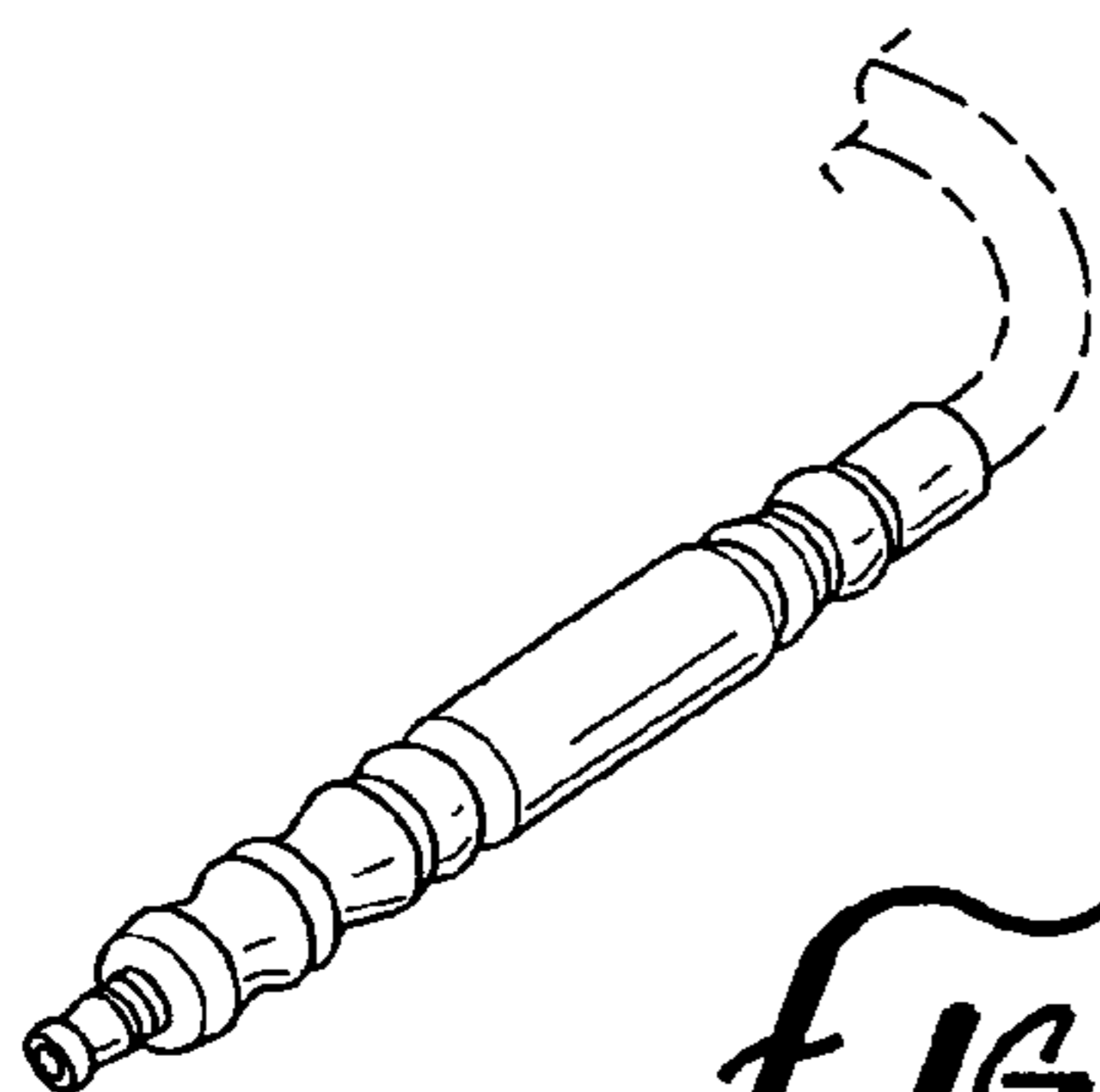

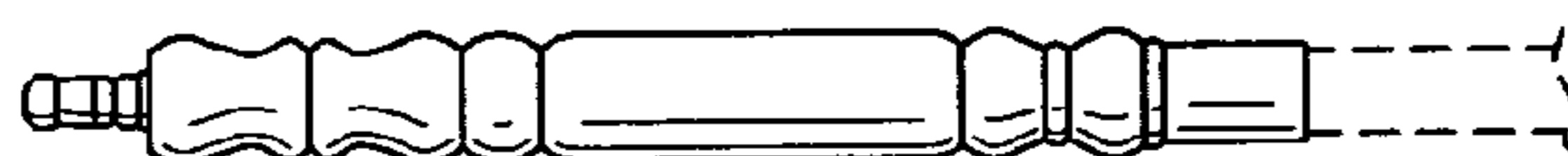

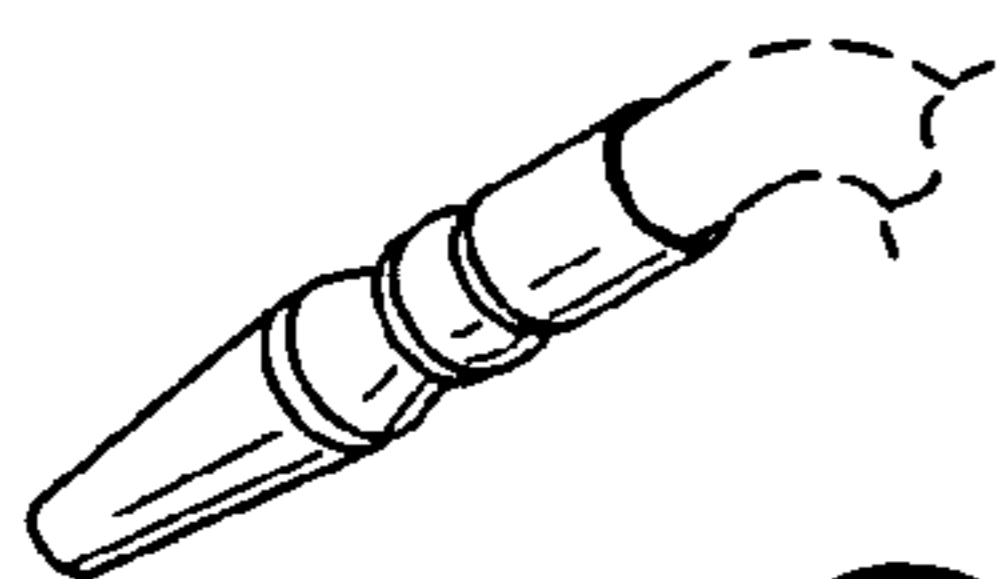
