FIG. 2 is a left side view;

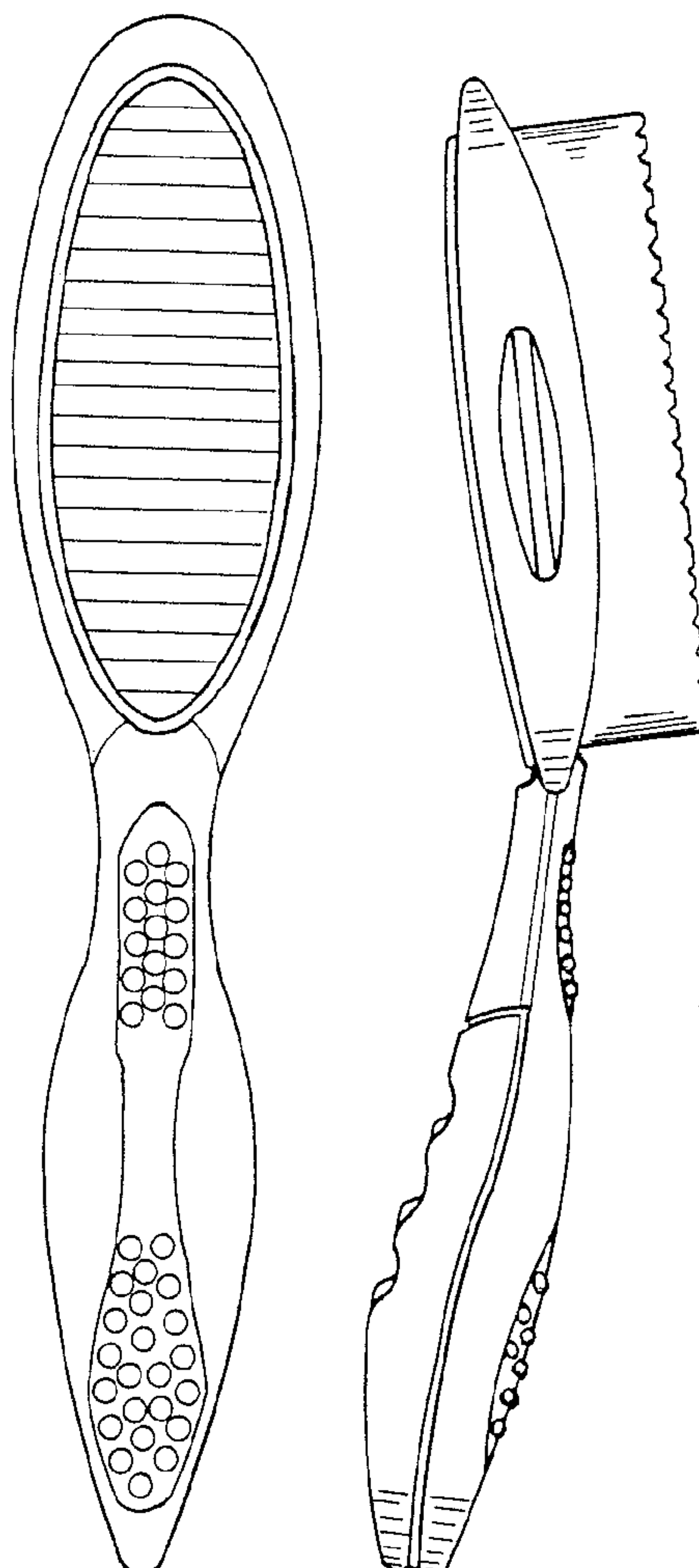
FIG. 3 is a bottom view;

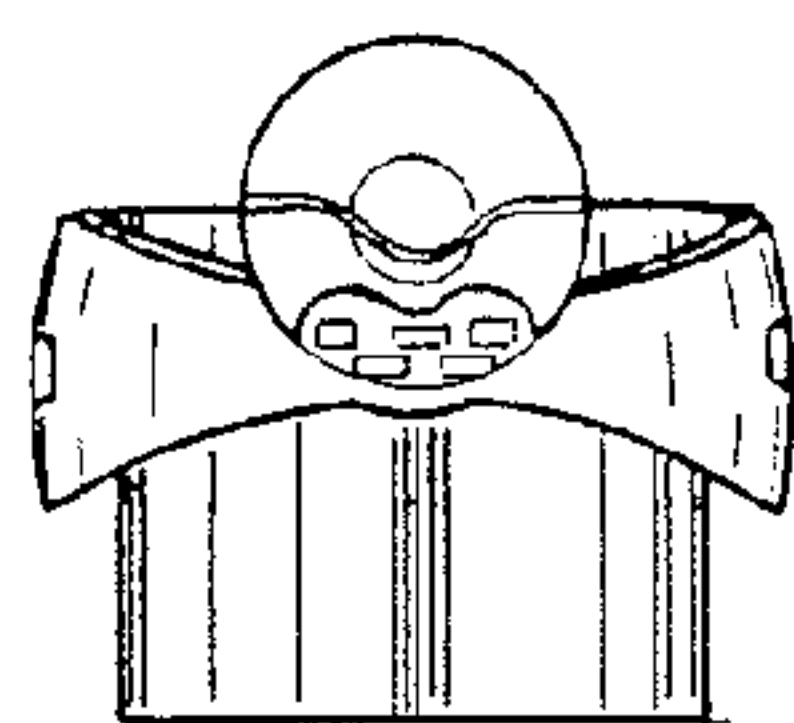

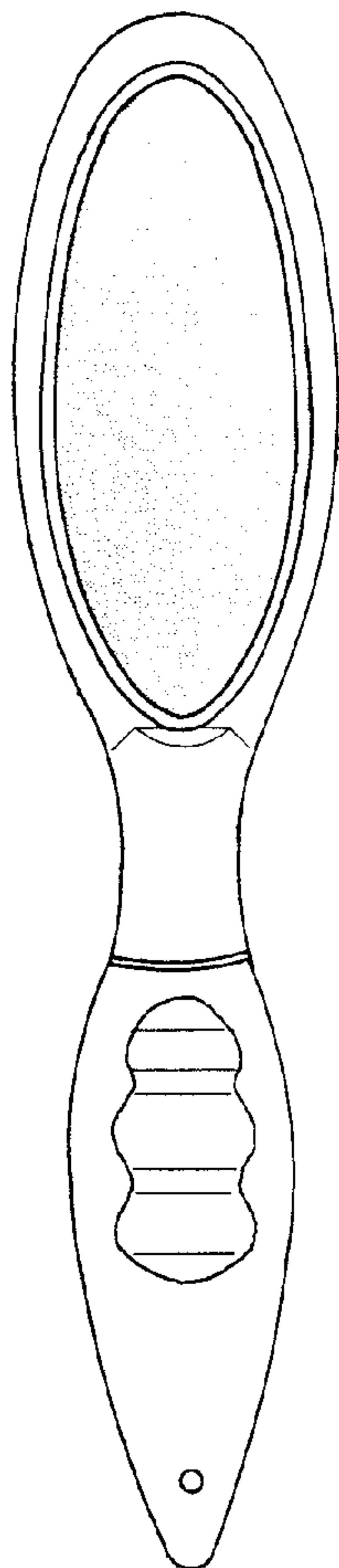

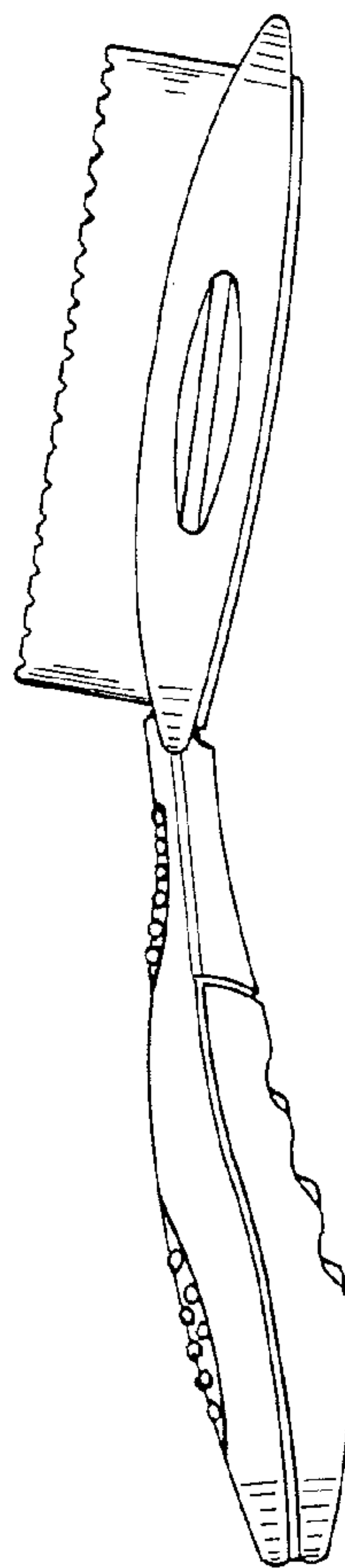

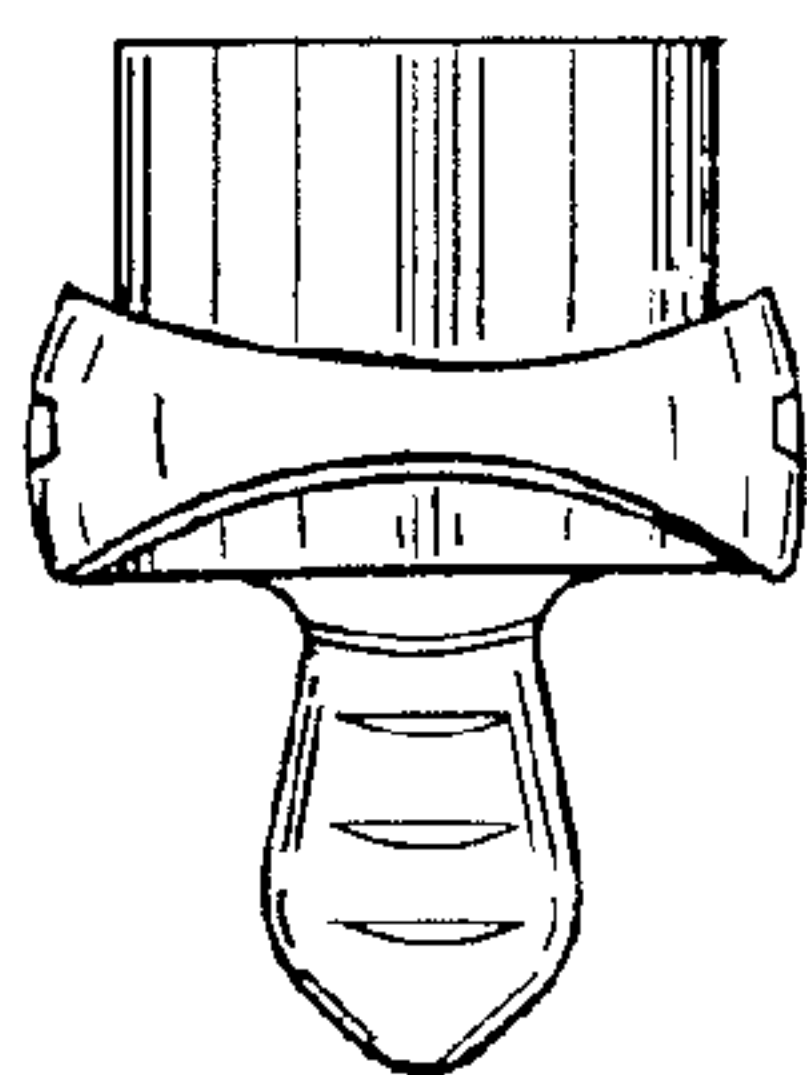

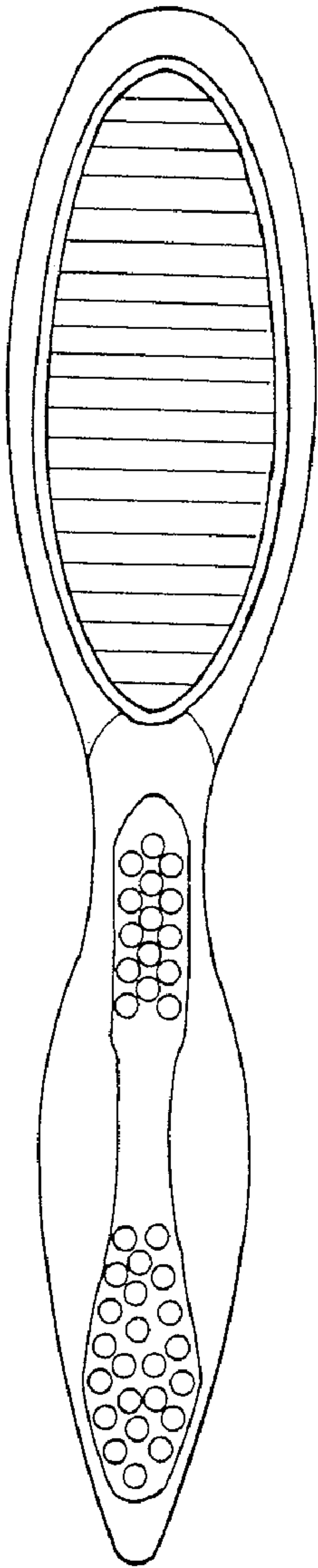

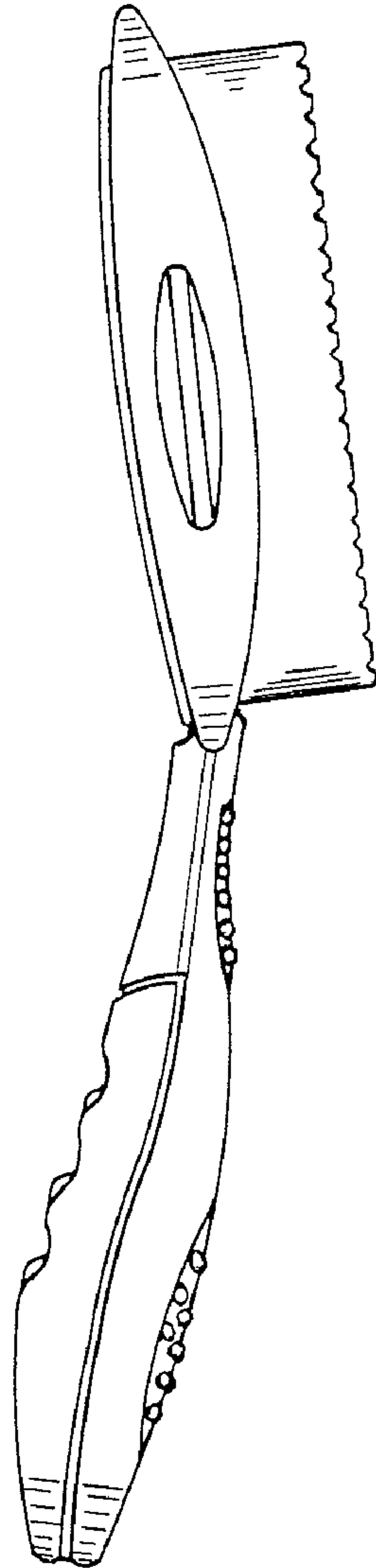
