FIG. 2 a front elevational view thereof;

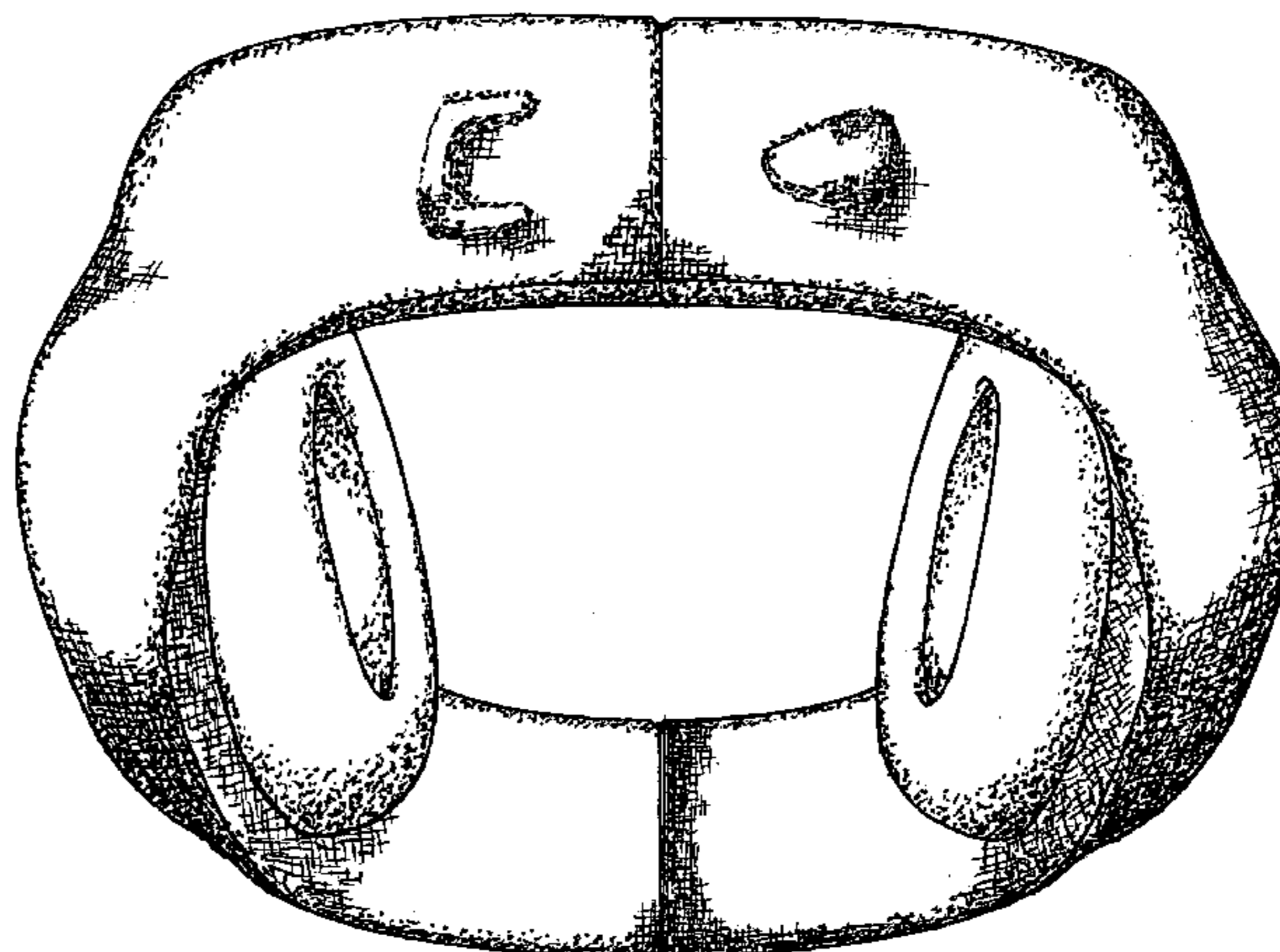
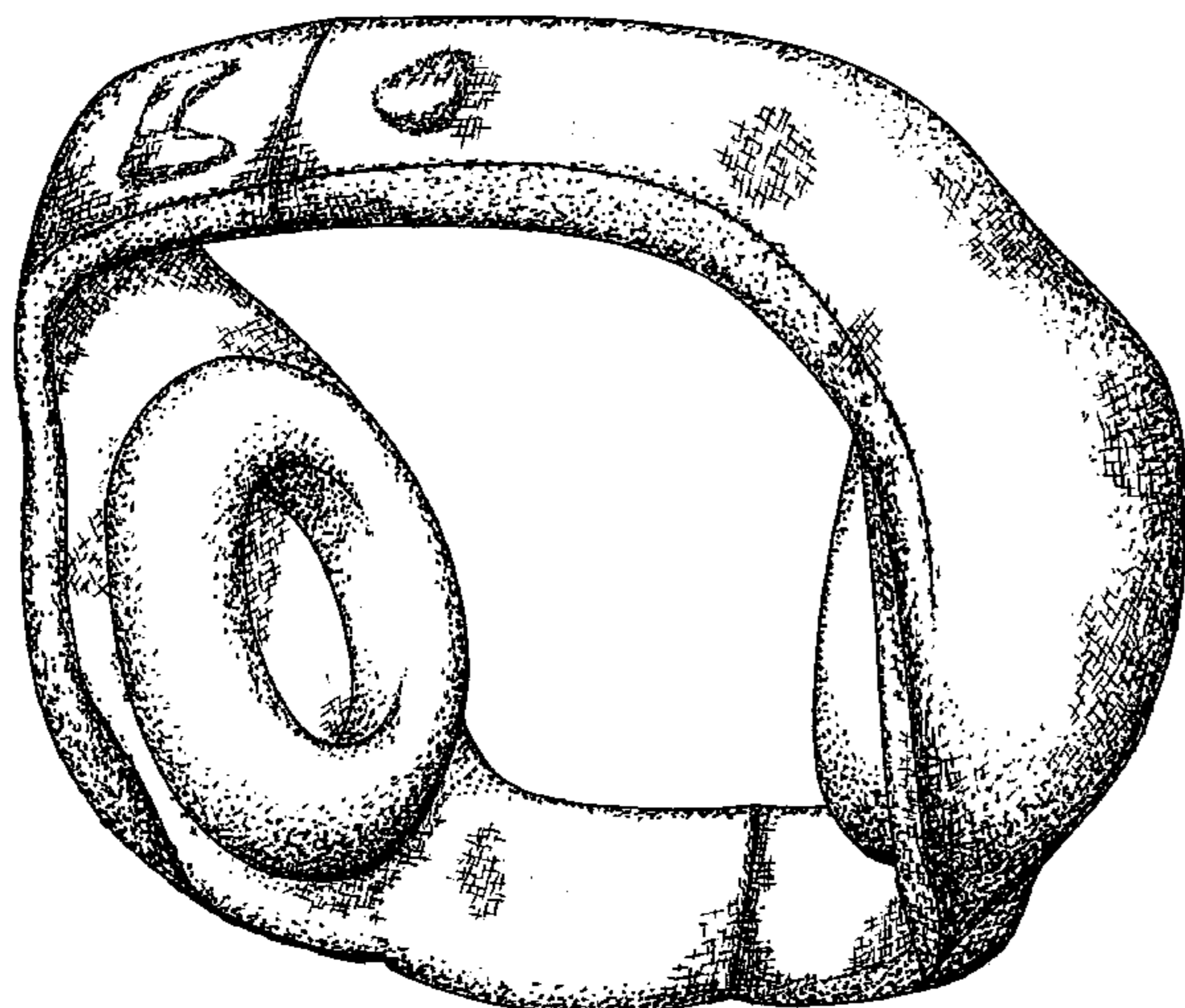
FIG. 3 a rear elevational view thereof;

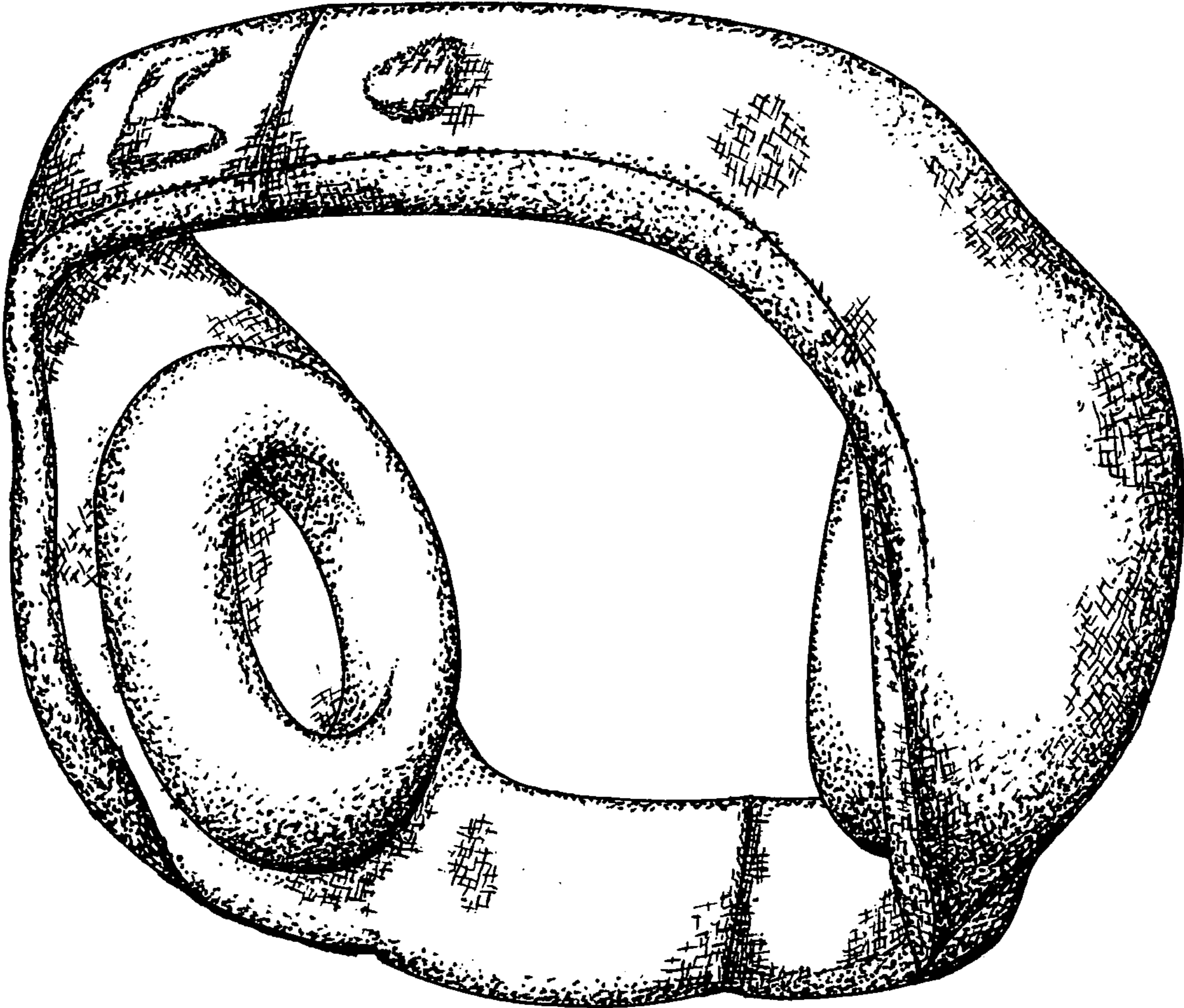

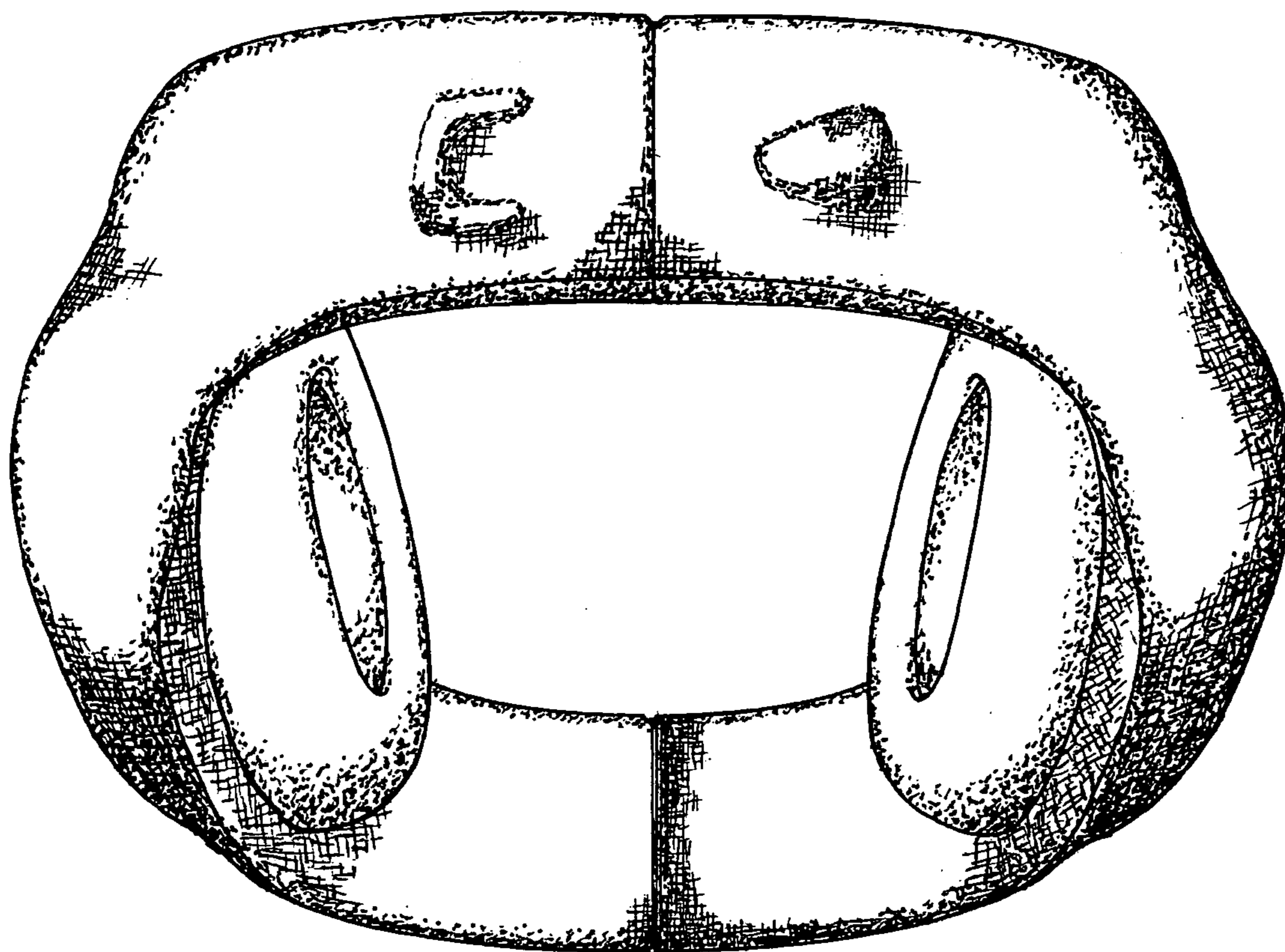

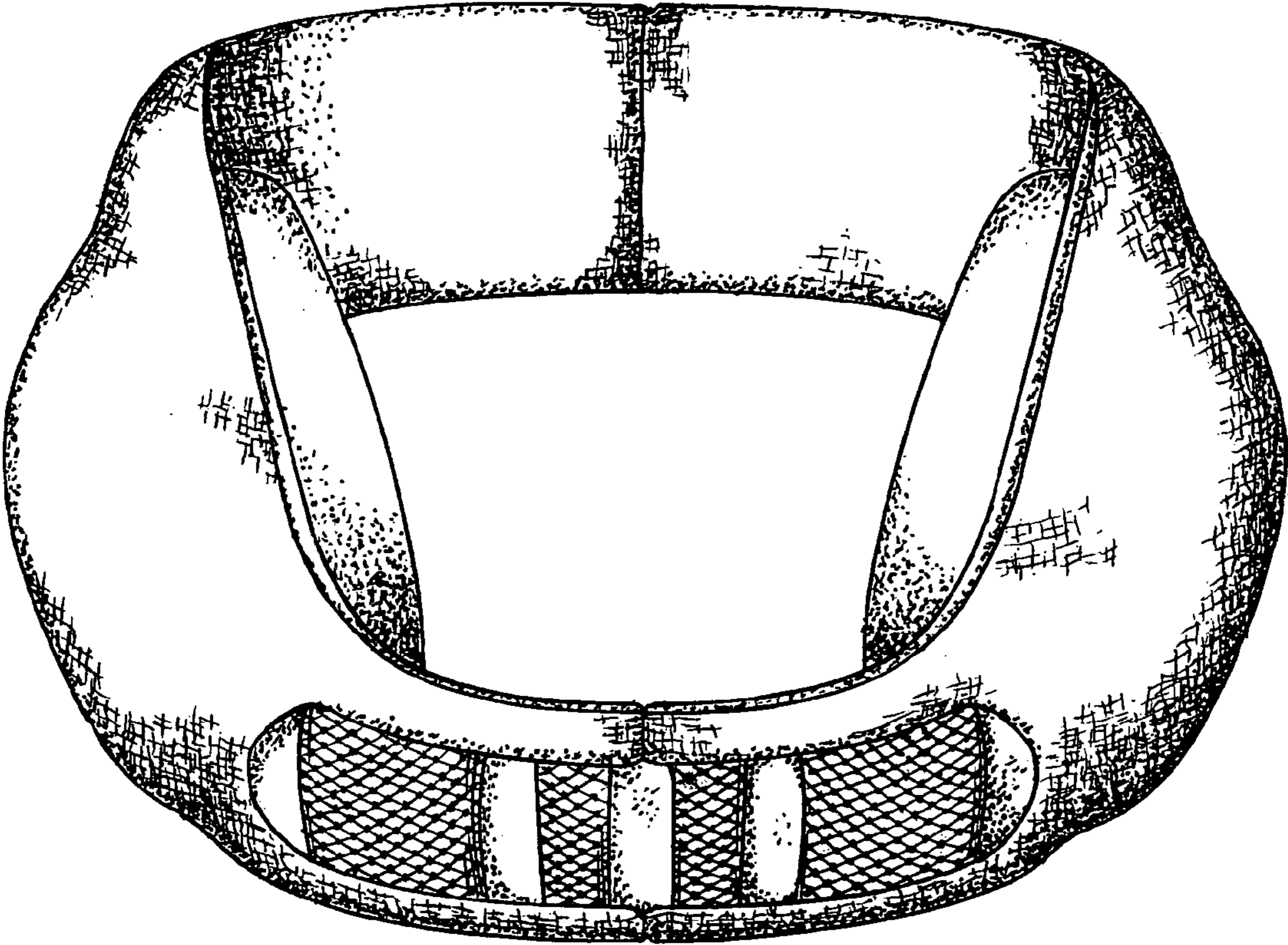

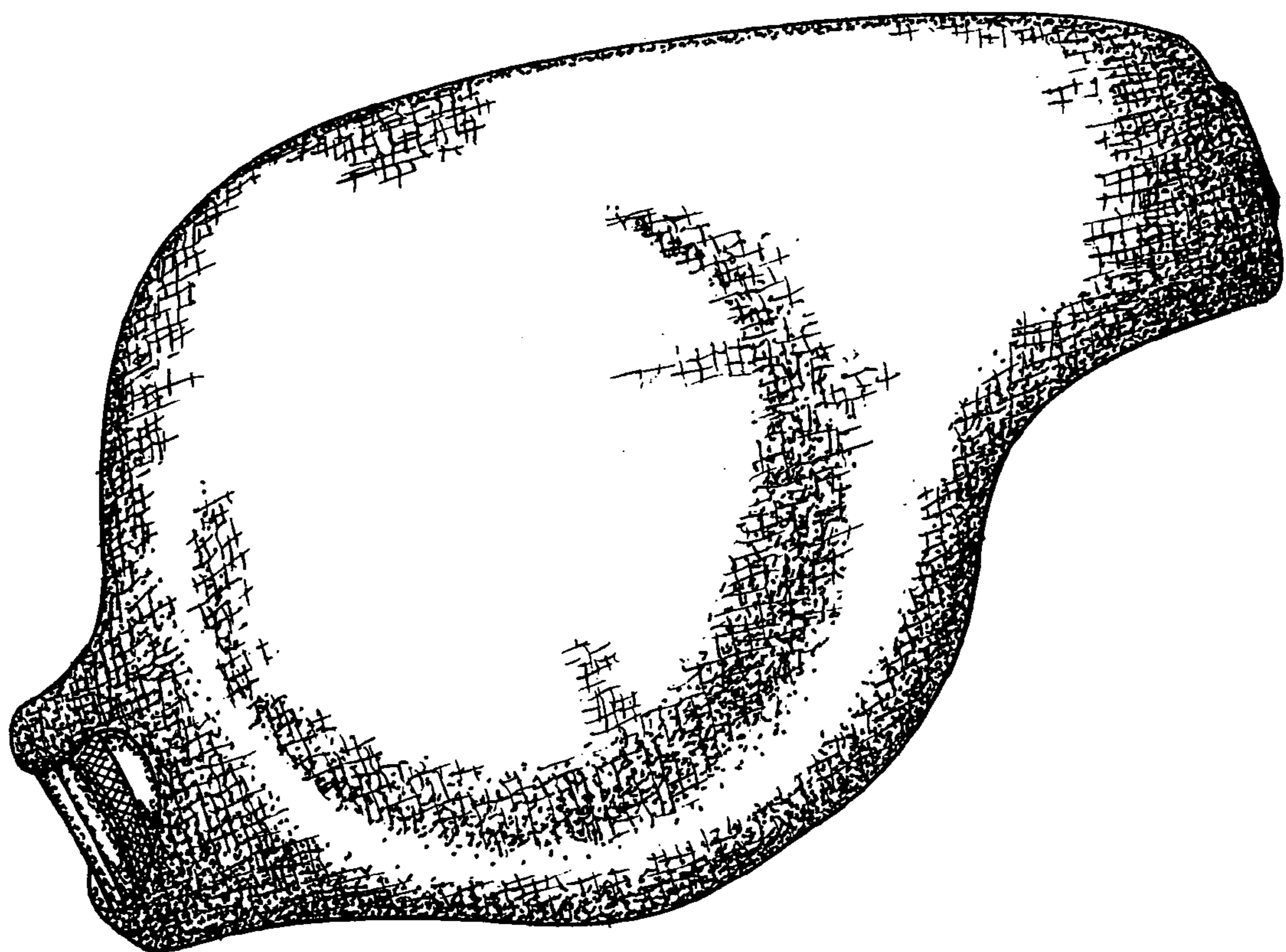

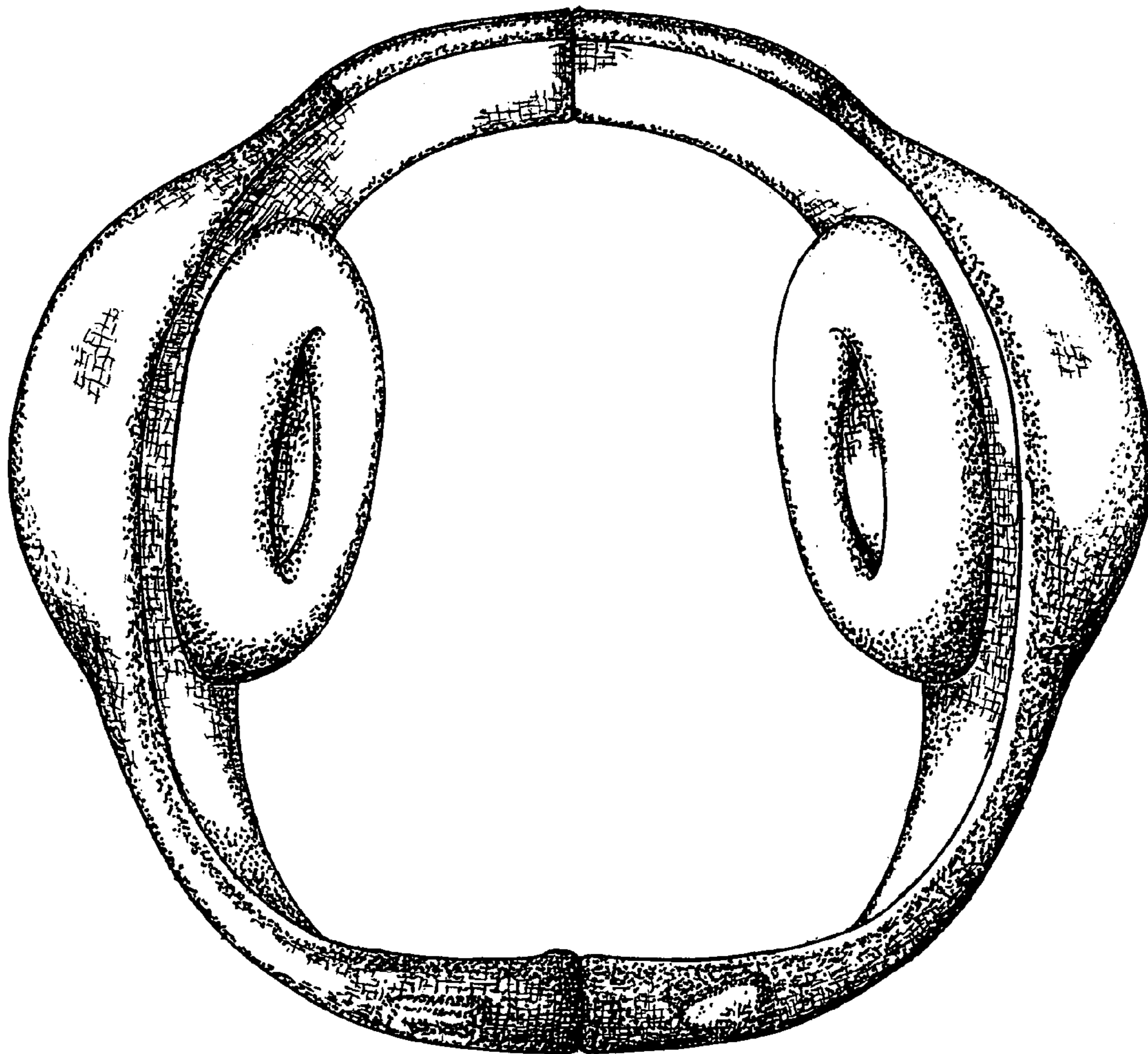

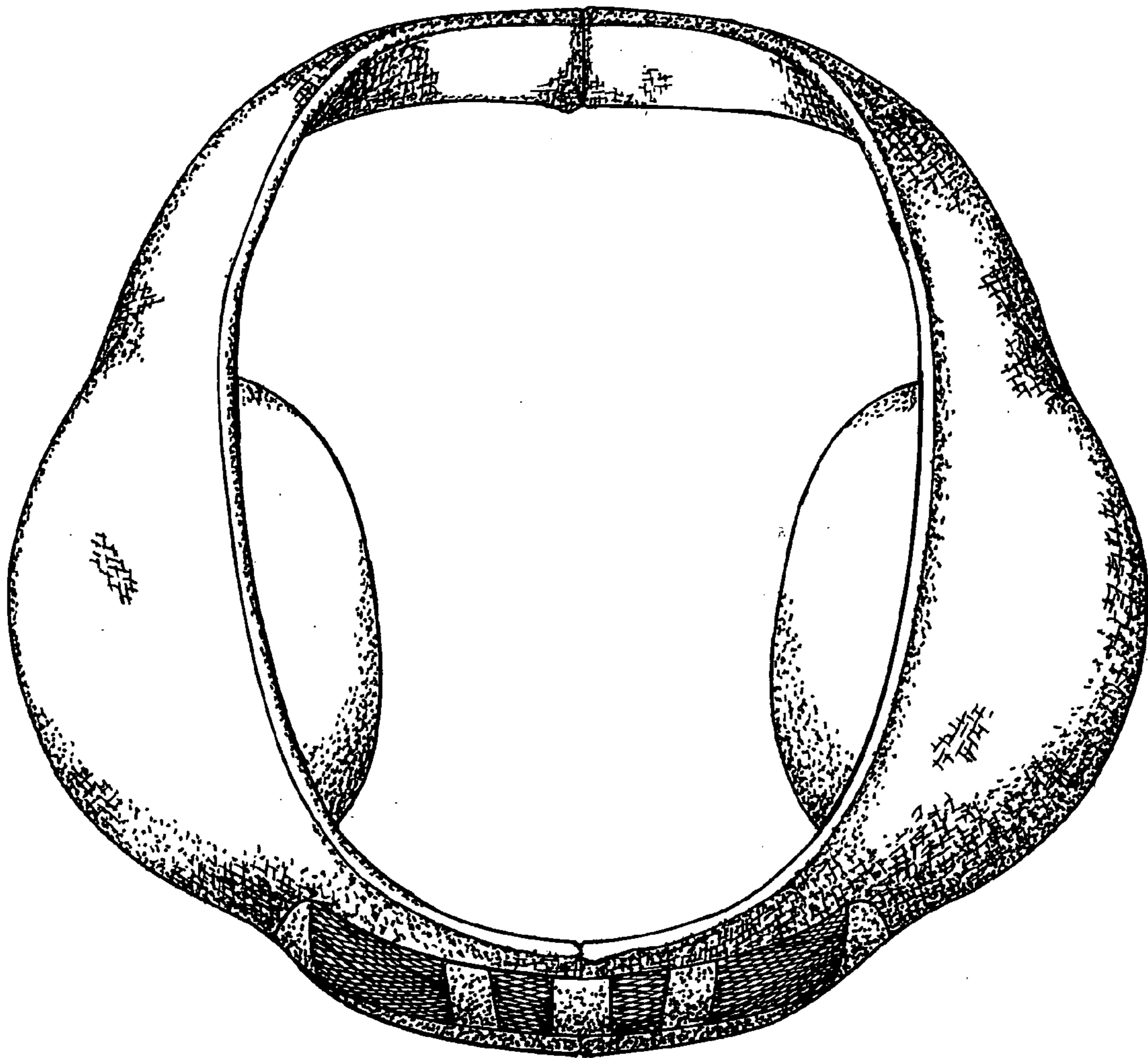
