(57) **CLAIM**

The ornamental design for an arm for a conveyor belt cleaner, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of an arm for a conveyor belt cleaner;

FIG. 2 is a top plan view of the arm;

FIG. 3 is a left side elevational view of the arm, the right side elevational view being a mirror image;

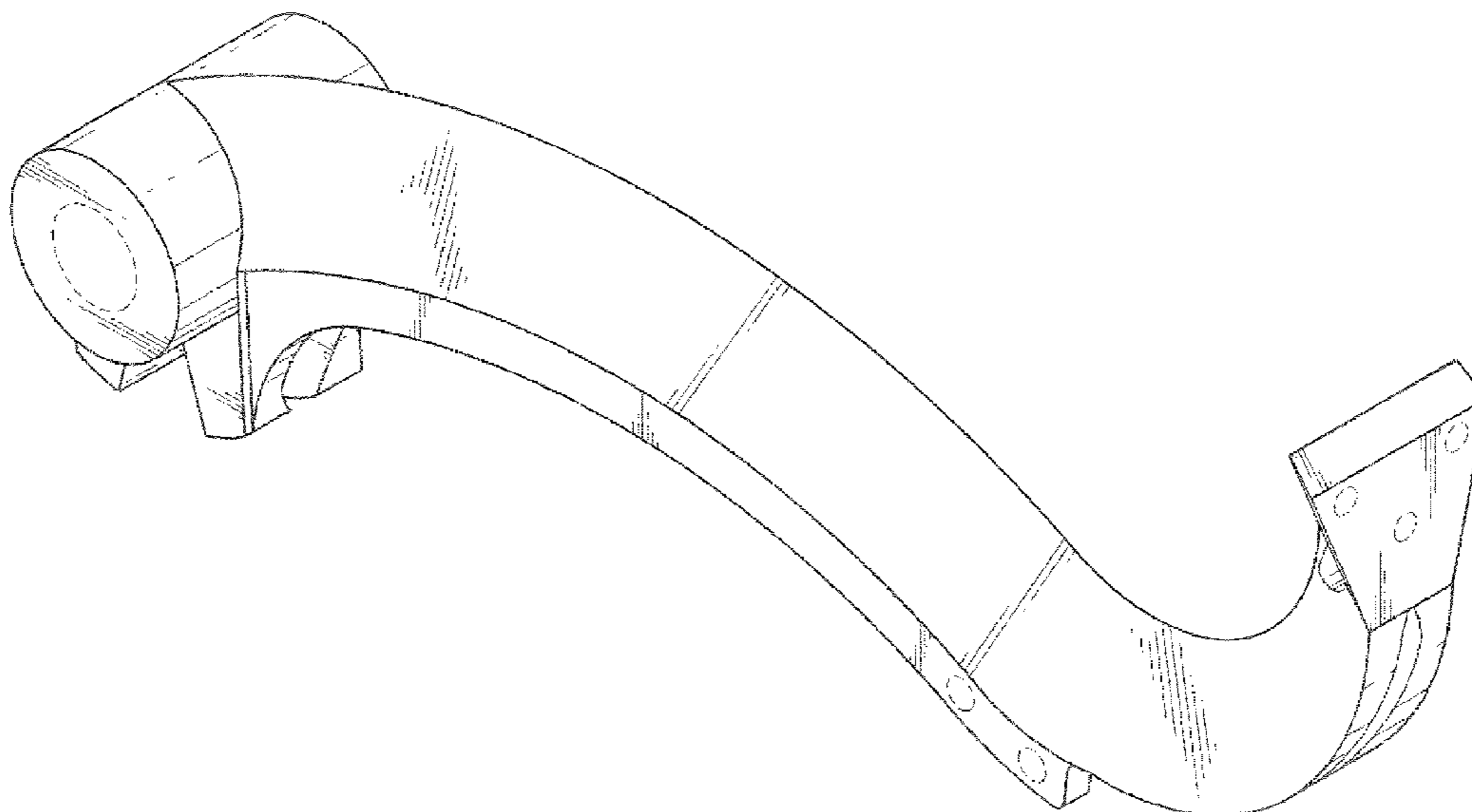
FIG. 4 is a rear elevational view of the arm;

FIG. 5 is a front elevational view of the arm; and,

FIG. 6 is a bottom view of the arm.

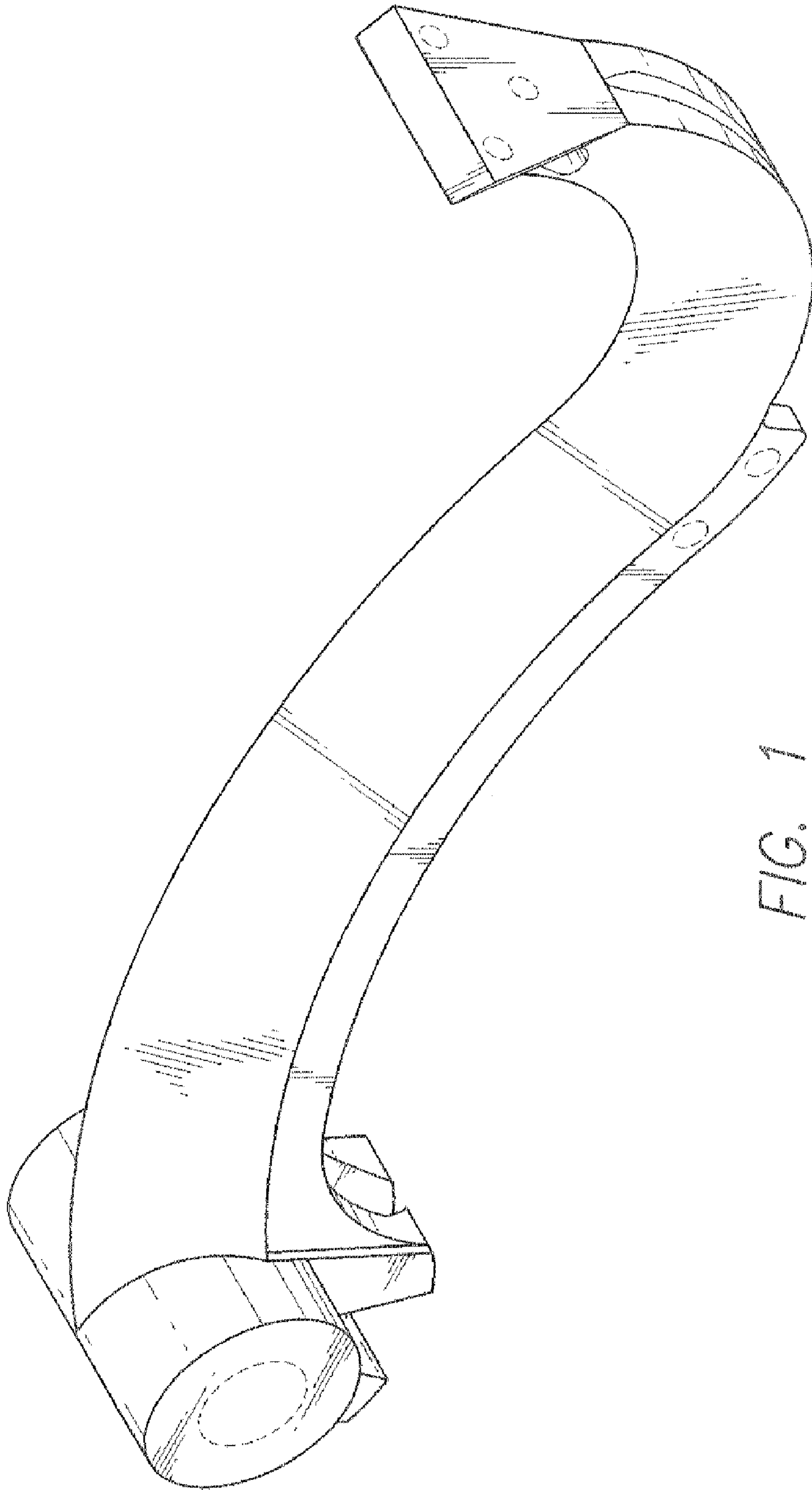

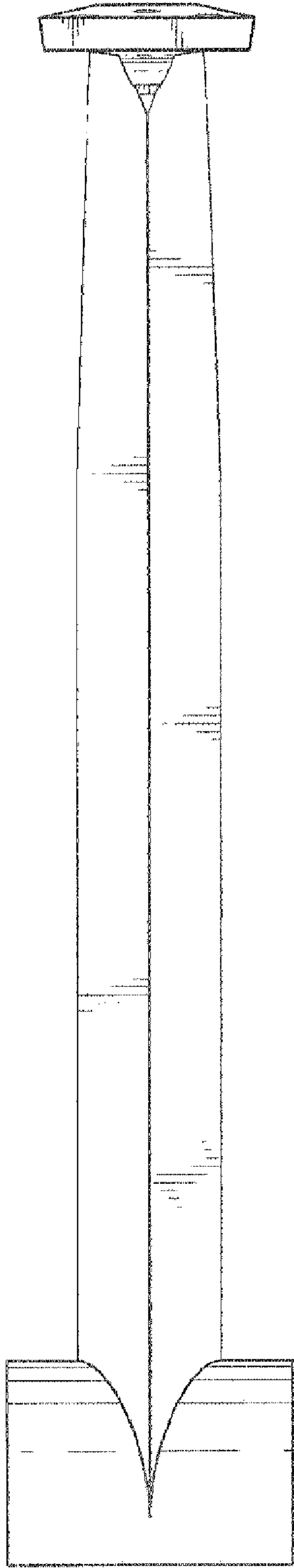

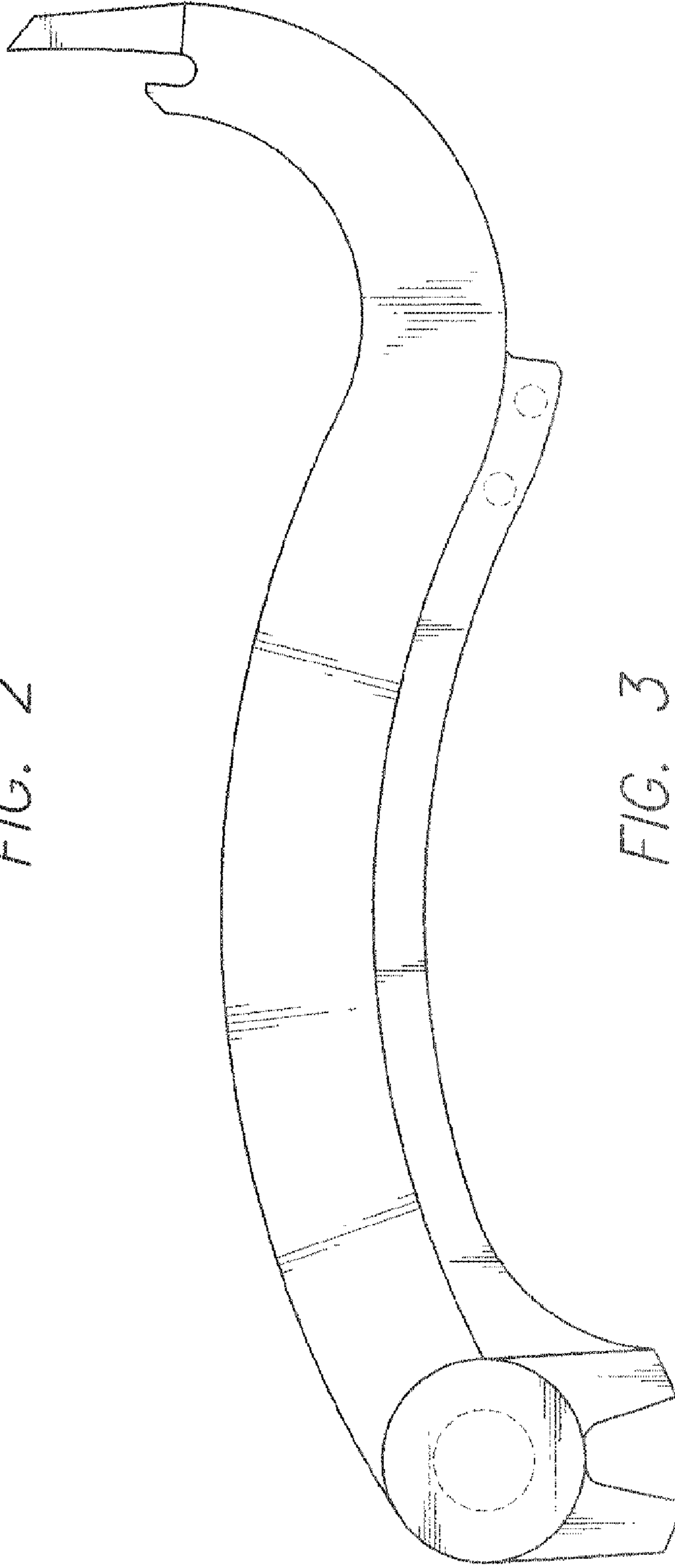

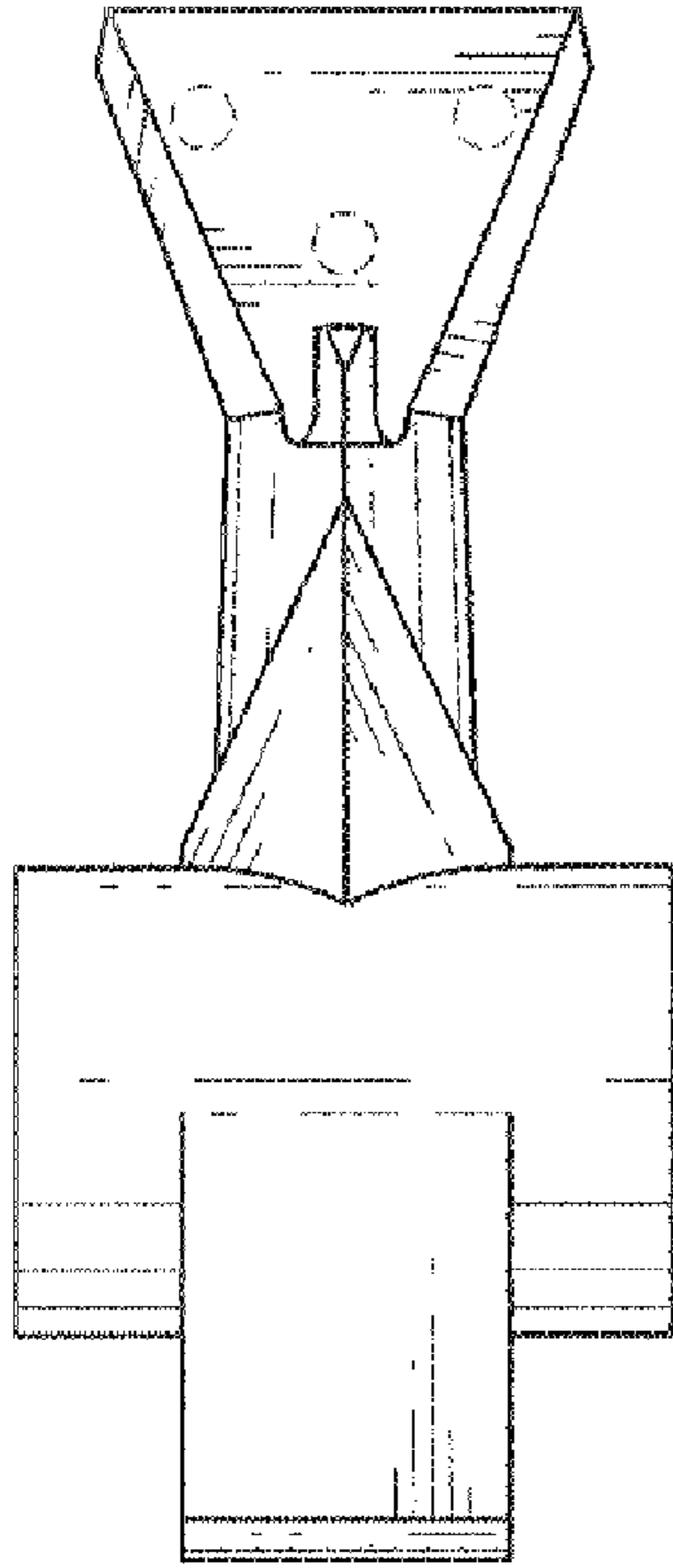

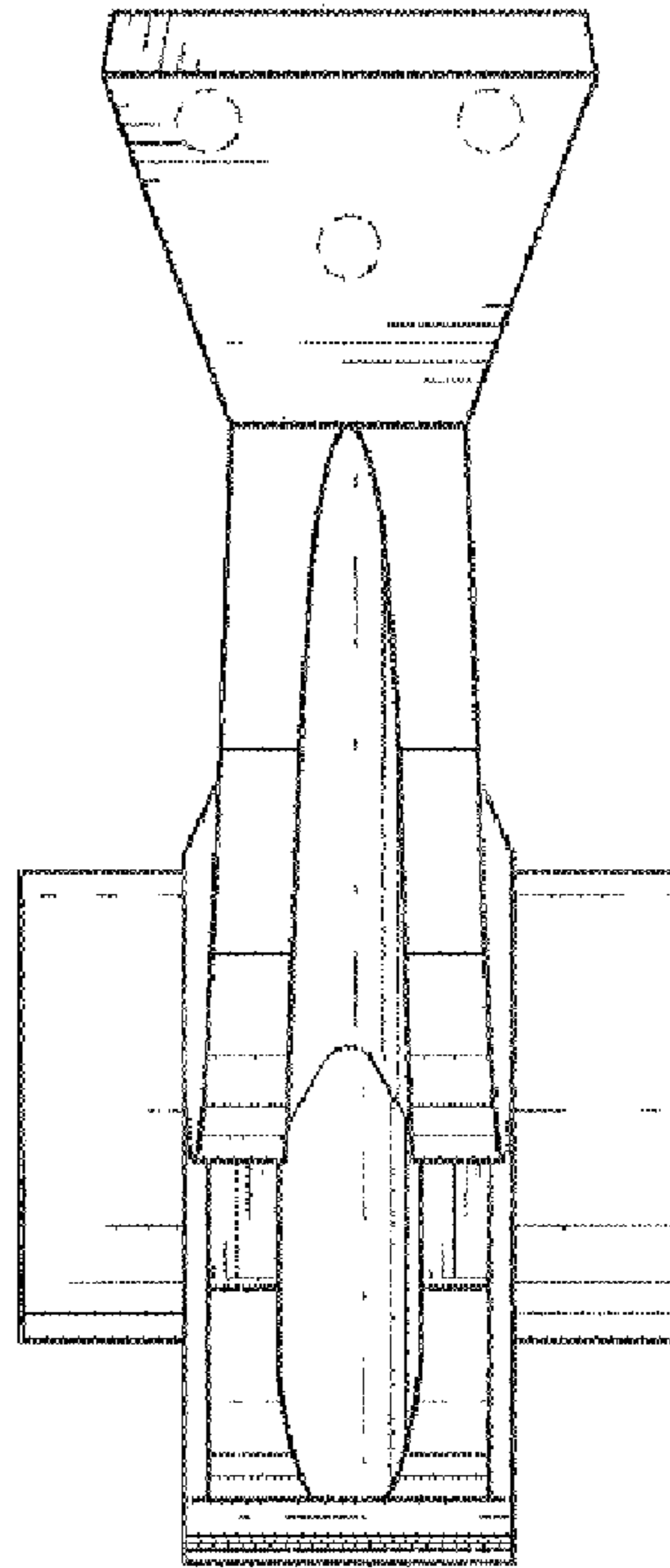

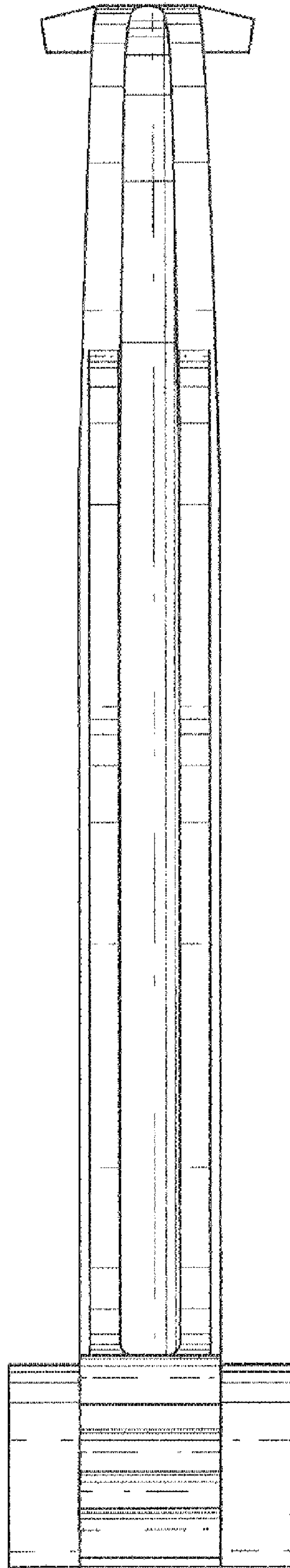
