(57) **CLAIM**

The ornamental design for a beverage dispenser tote bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a preferred embodiment of a beverage dispenser tote bag in accordance with our invention;

FIG. 2 is a front elevation view of the beverage dispenser tote bag shown in FIG. 1;

FIG. 3 is a rear elevation view of the beverage dispenser tote bag shown in FIG. 1;

FIG. 4 is a right side elevation view of the beverage dispenser tote bag shown in FIG. 1;

FIG. 5 is a left side elevation view of the beverage dispenser tote bag shown in FIG. 1;

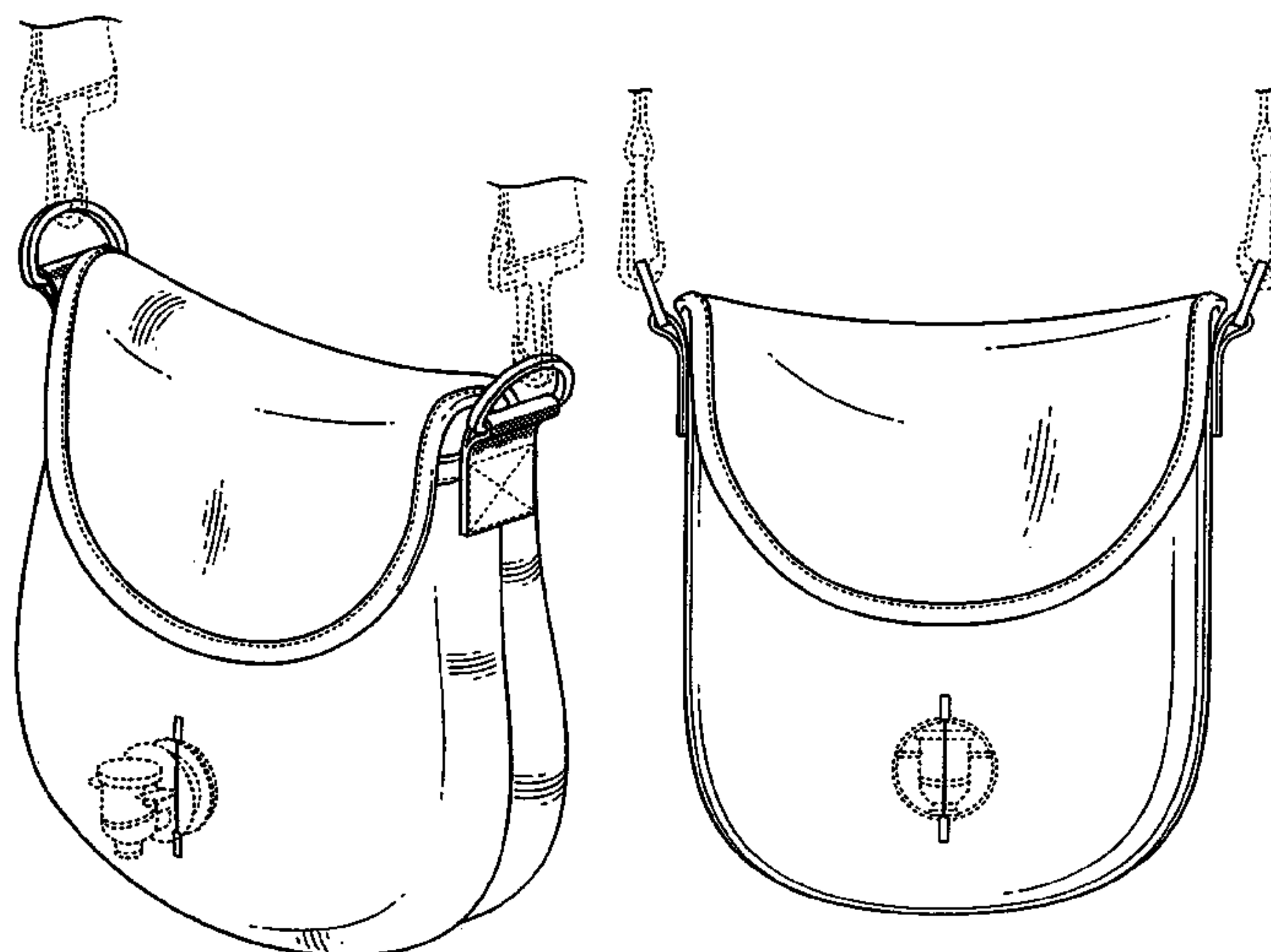
FIG. 6 is a top plan view of the beverage dispenser tote bag shown in FIG. 1; and,

FIG. 7 is a bottom plan view of the beverage dispenser tote bag shown in FIG. 1.

The dashed lines illustrating the strap hooks and the beverage dispenser nozzle, respectively, are for illustration purposes only and form no part of the present invention.

The broken lines on the flap of the bag and on the sides represent stitching.

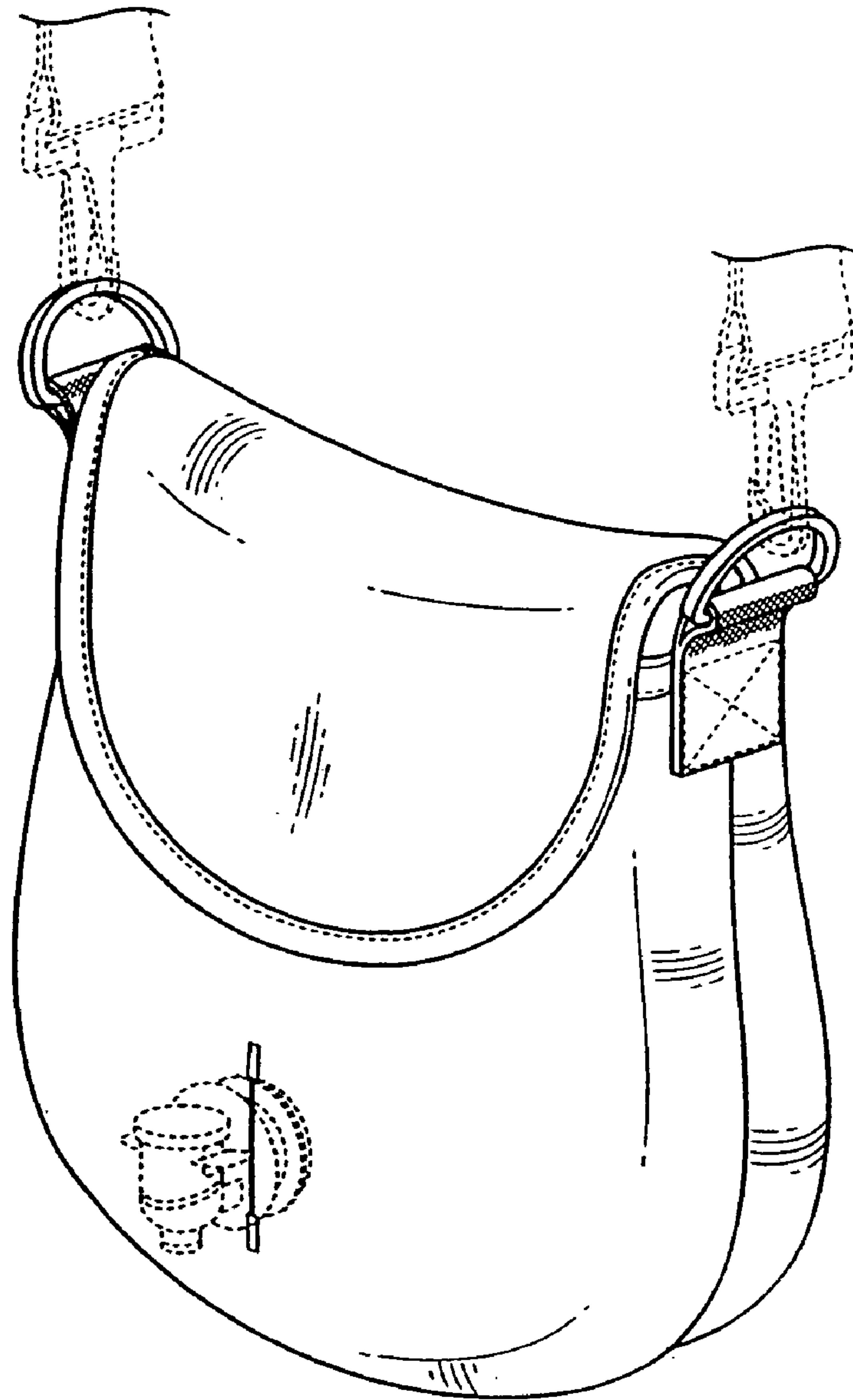

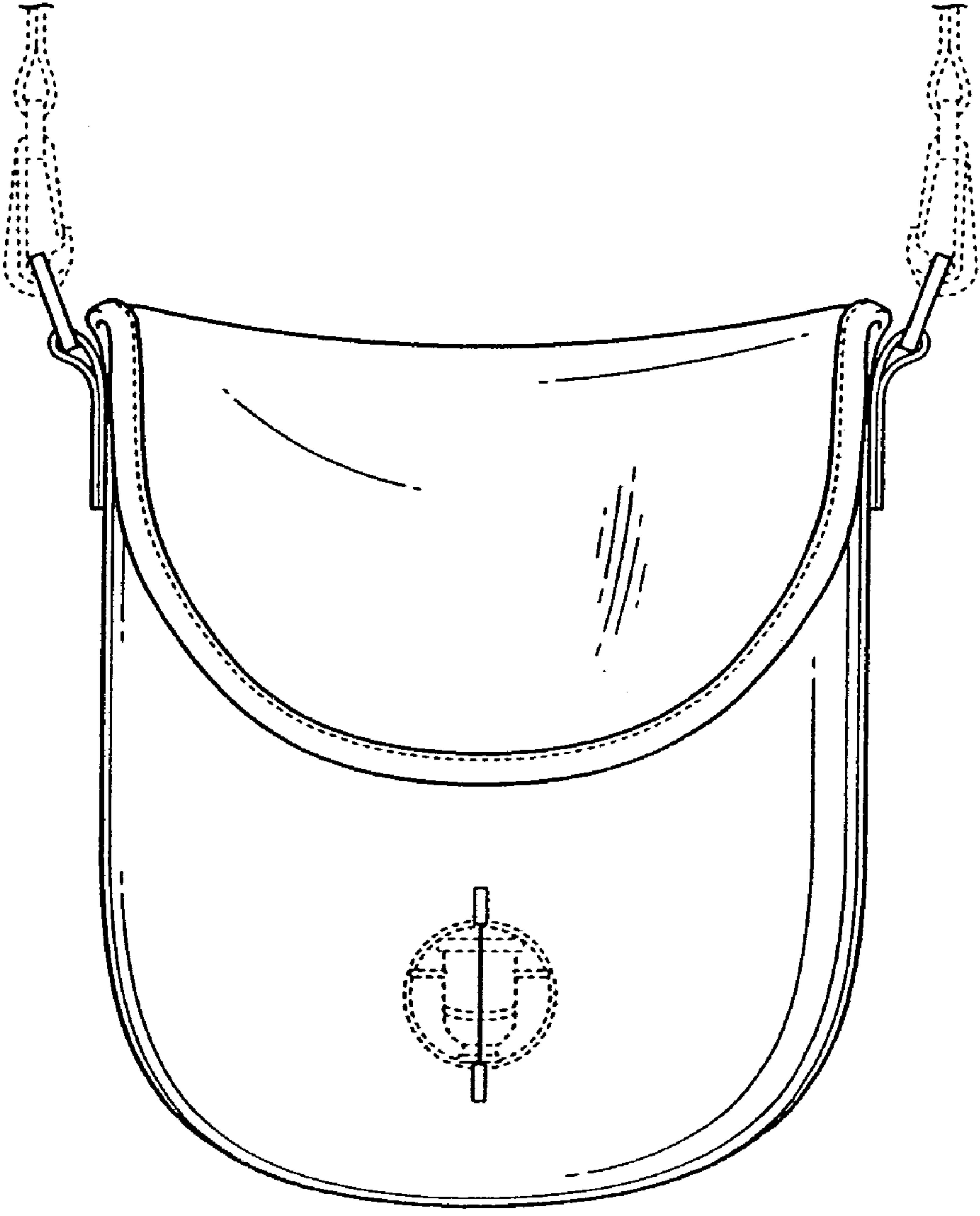

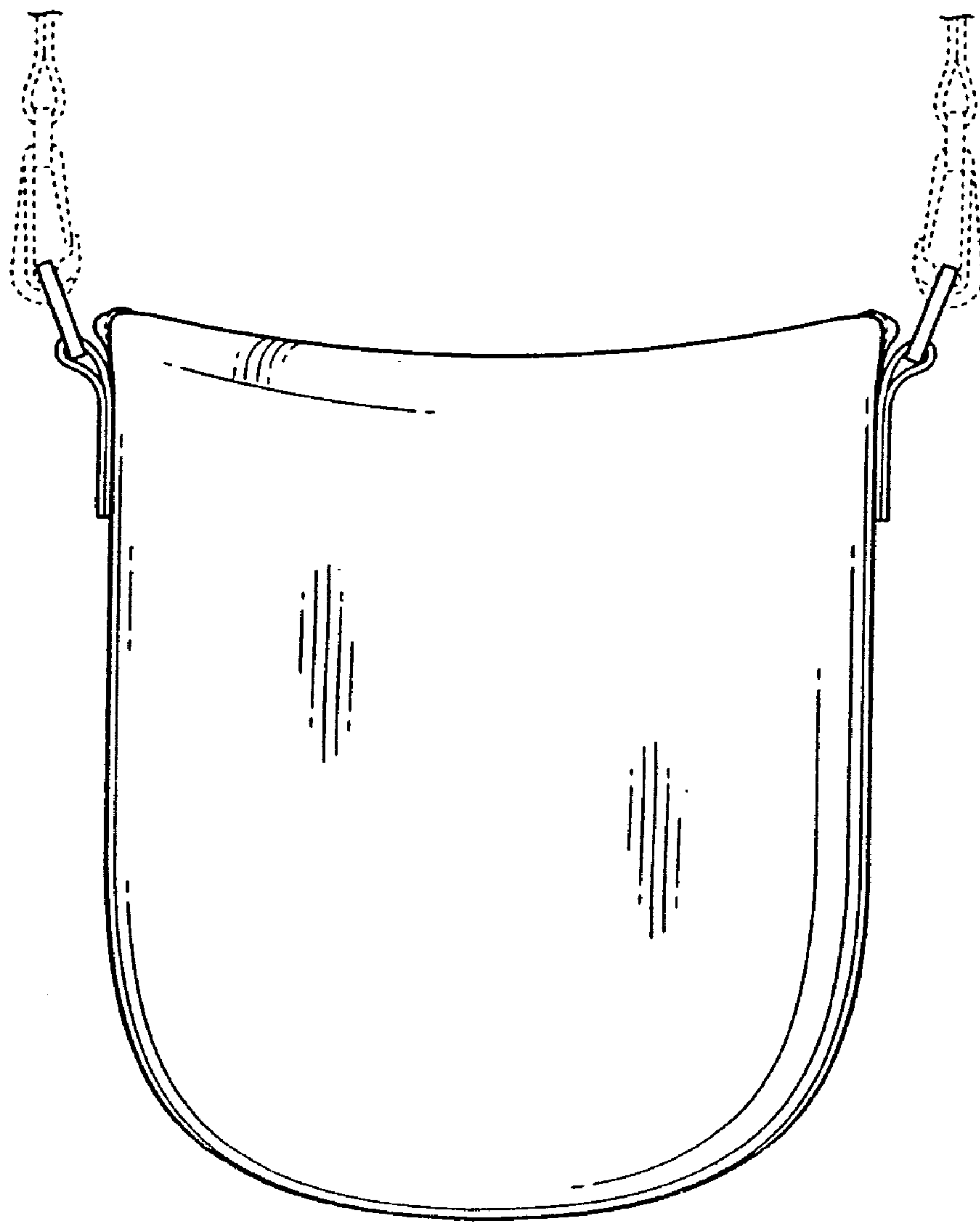

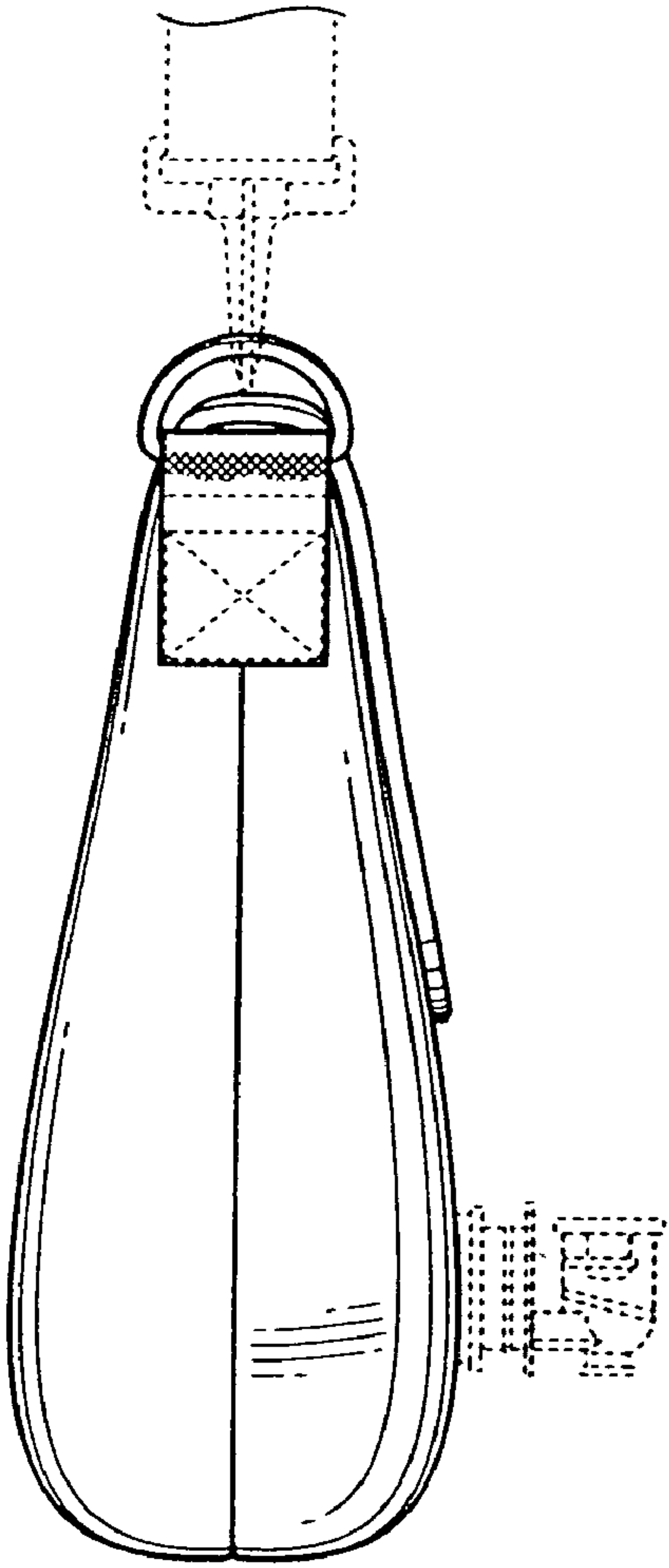

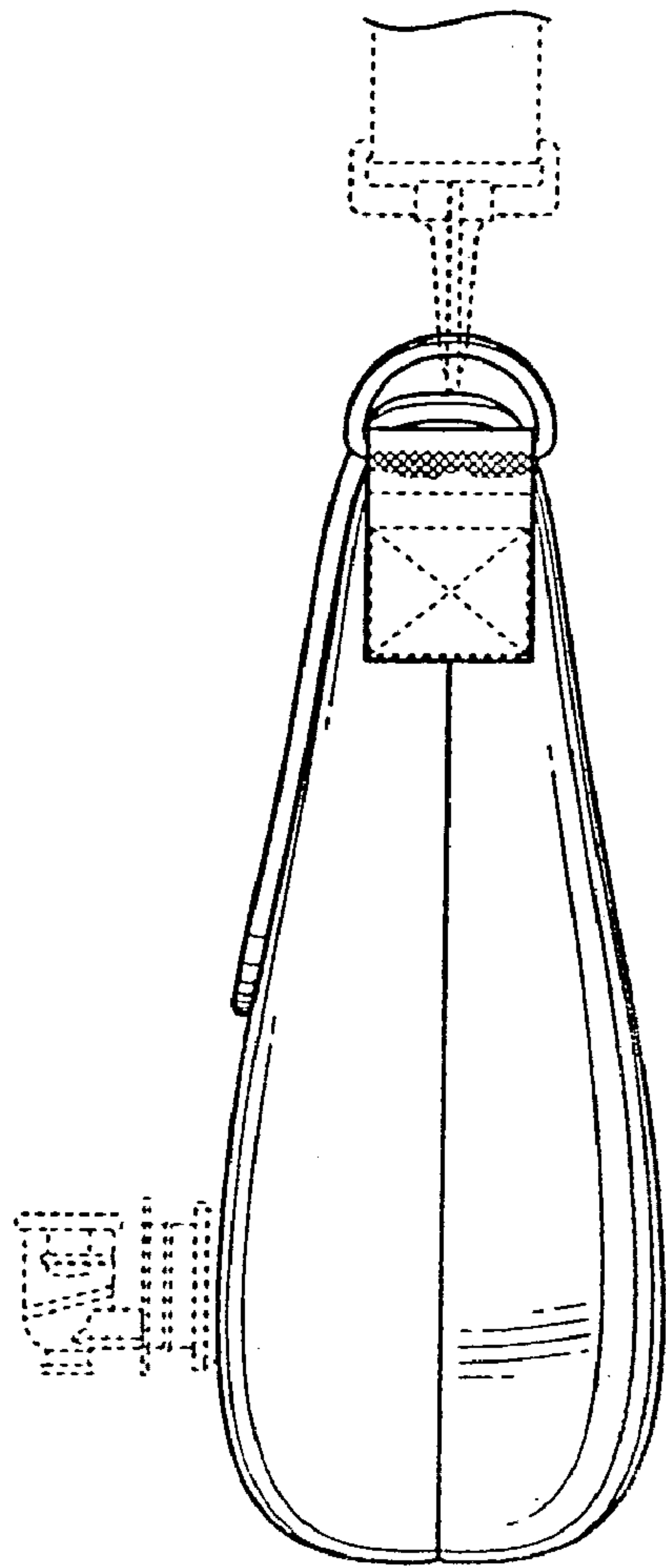

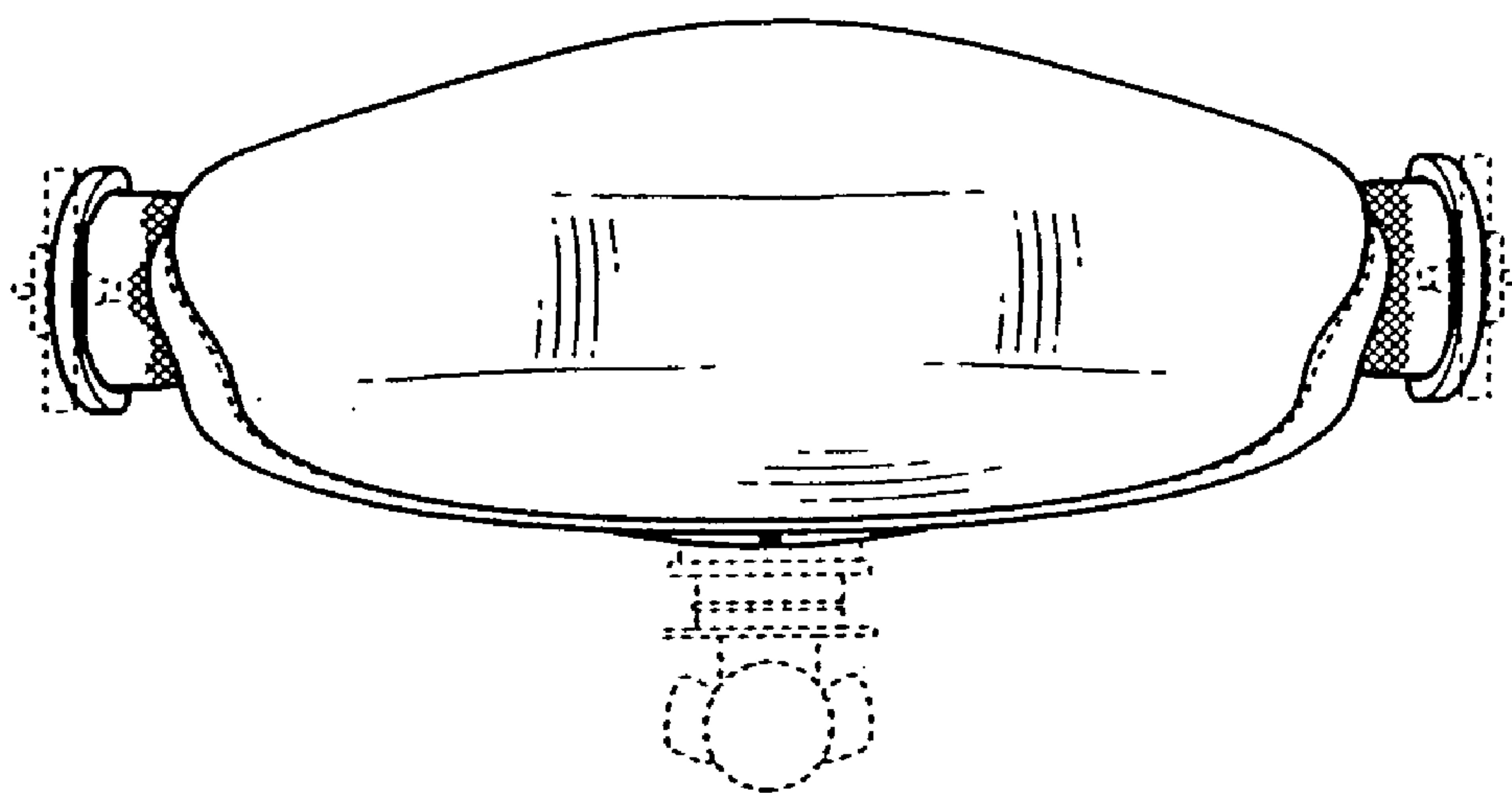

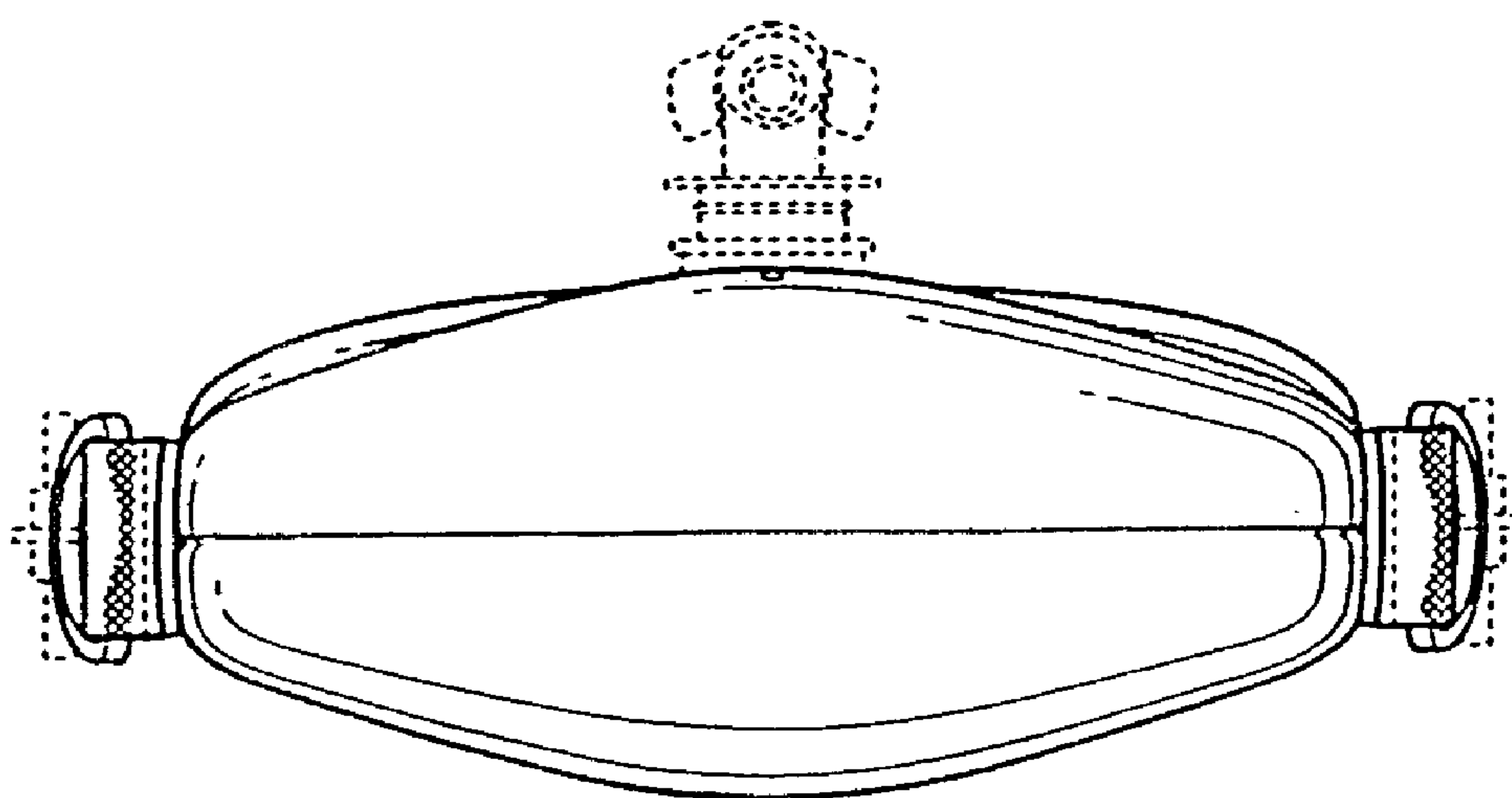
