1.

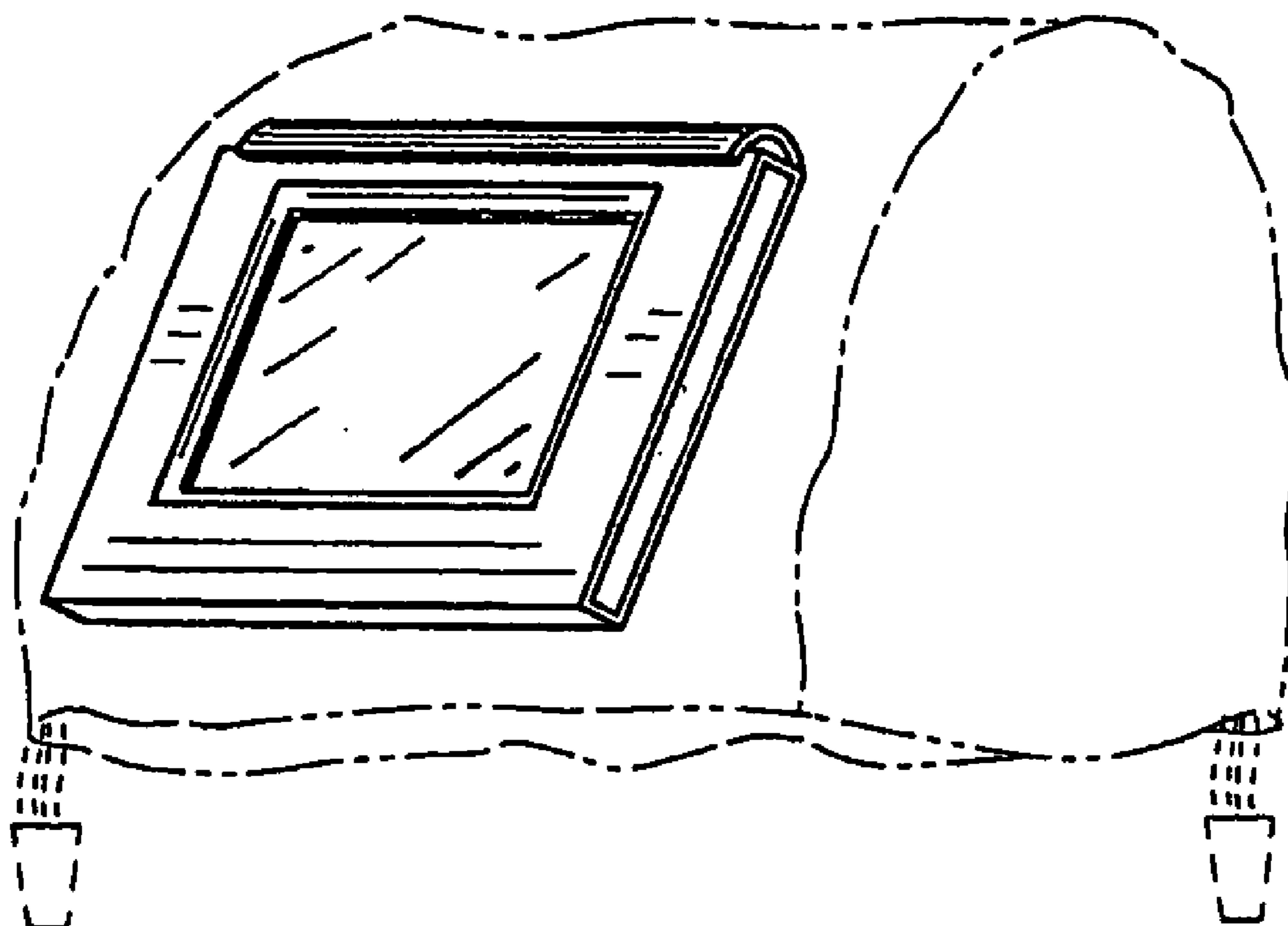

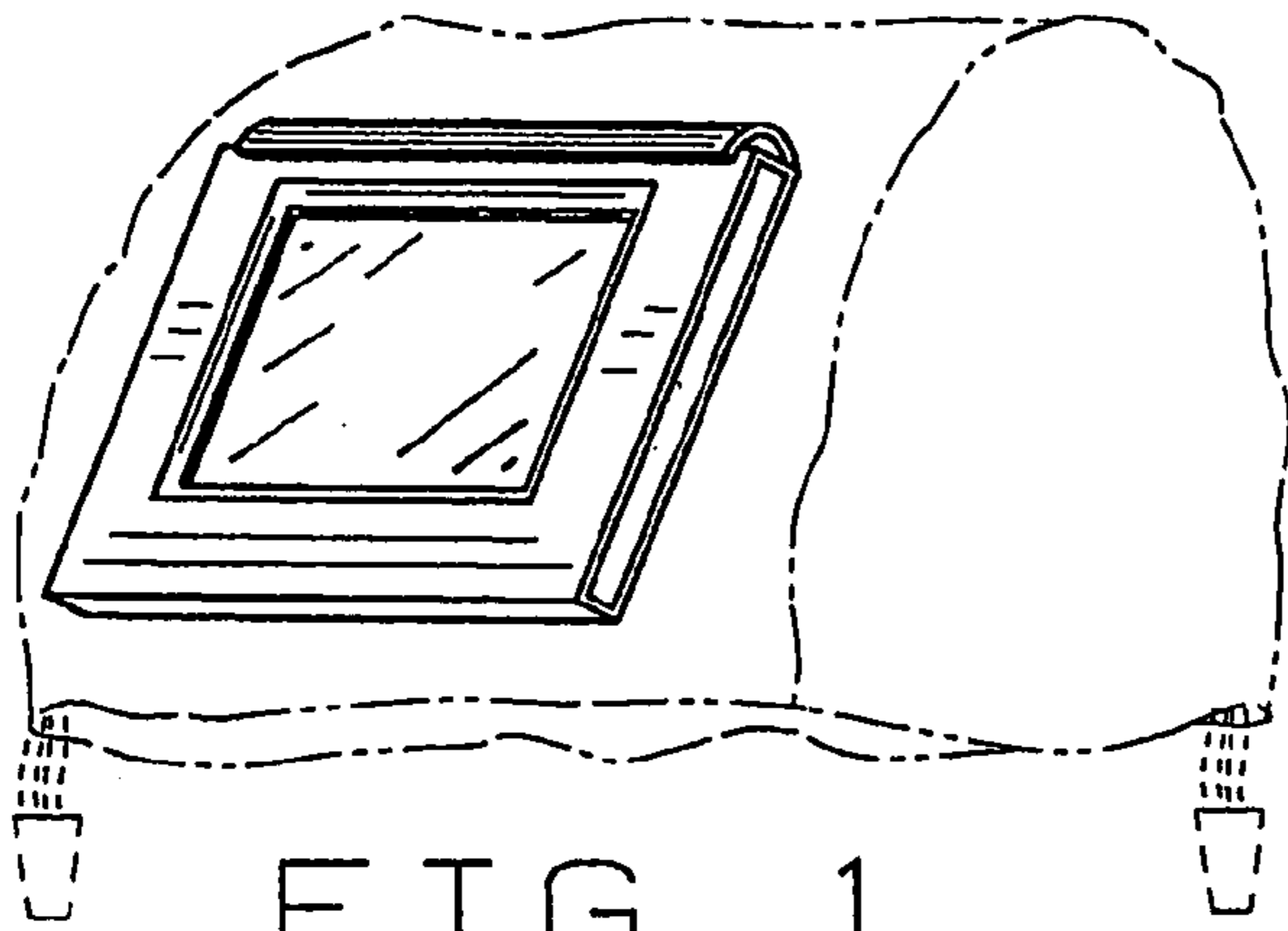

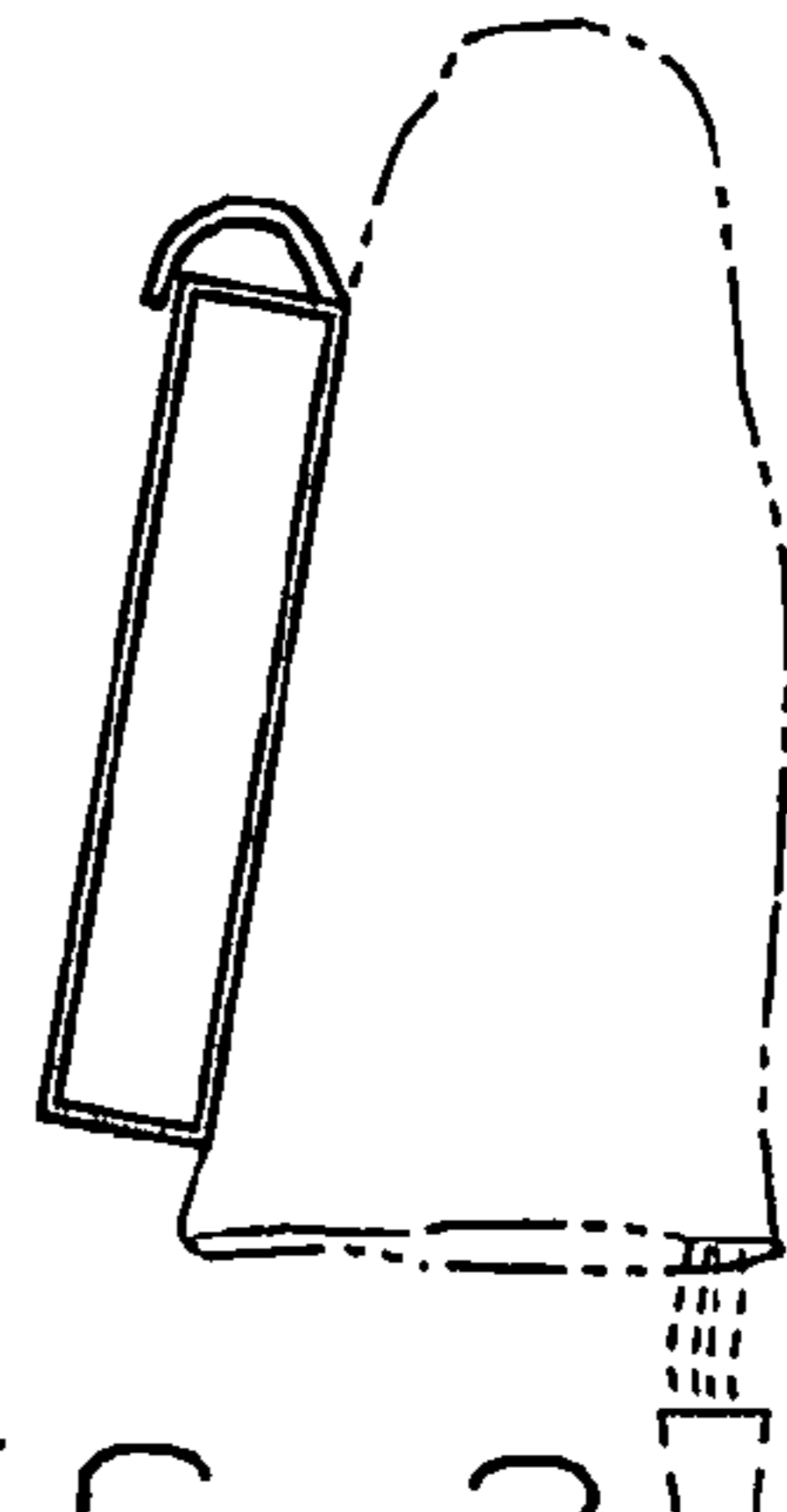

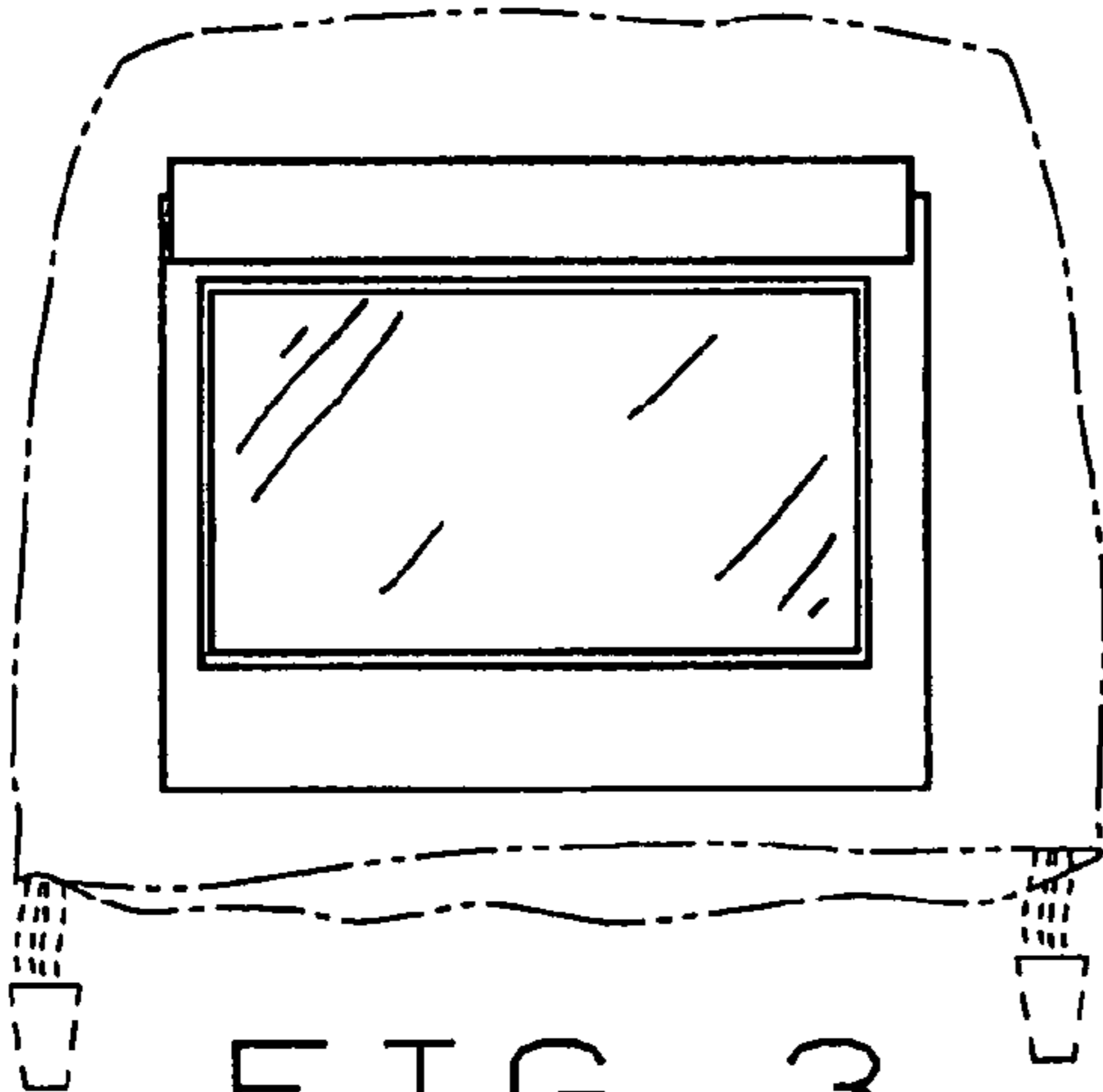

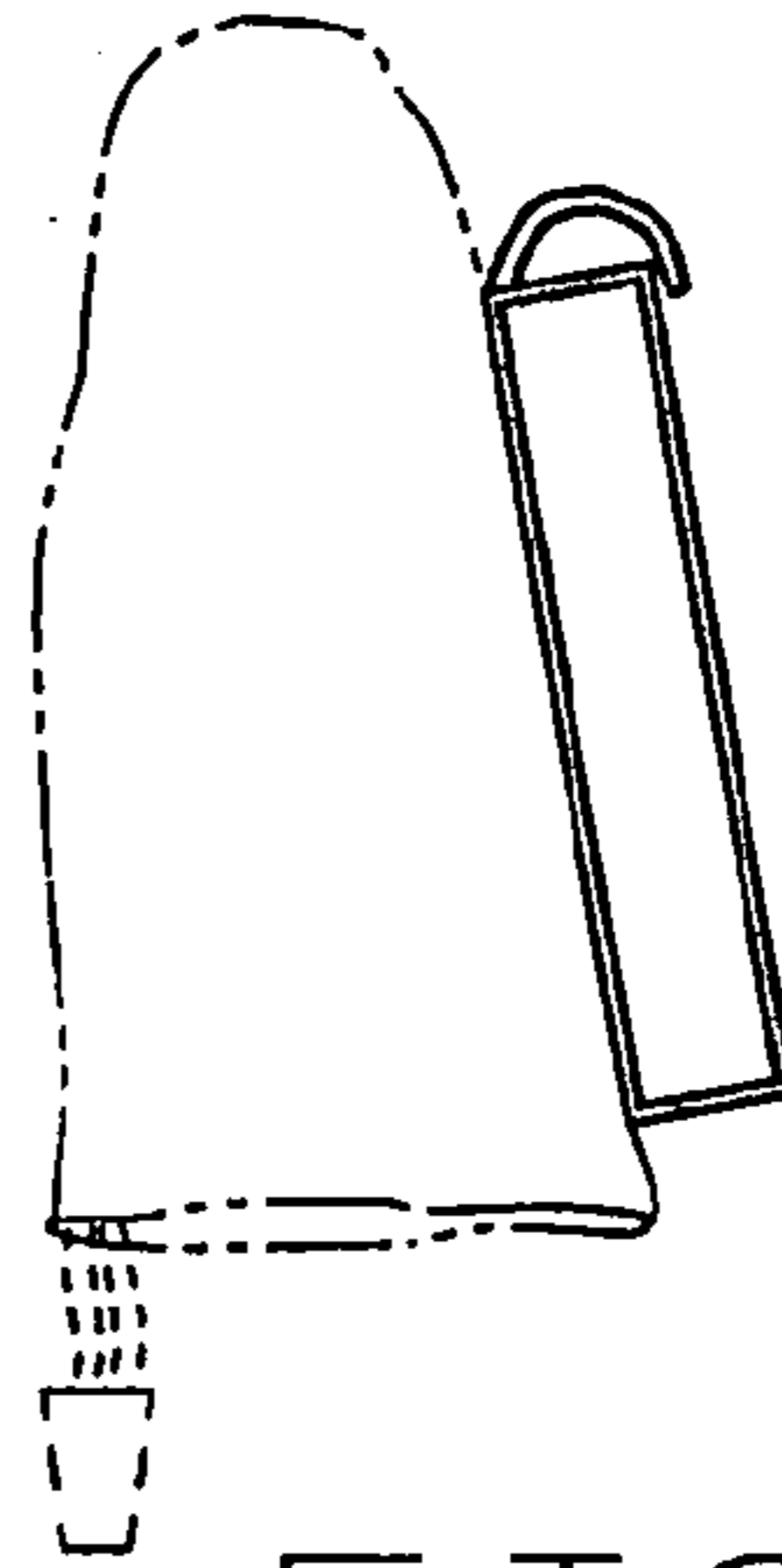

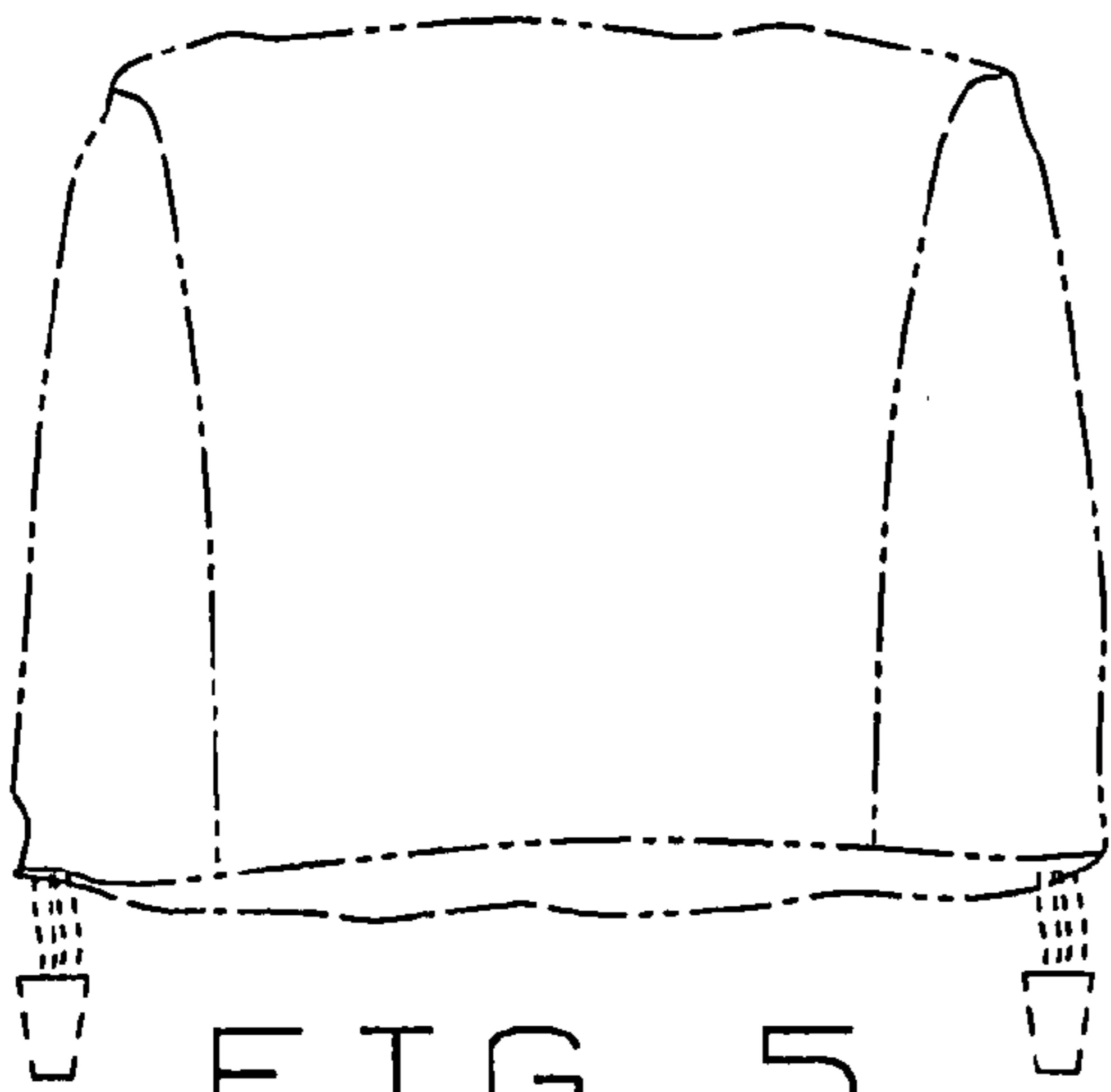

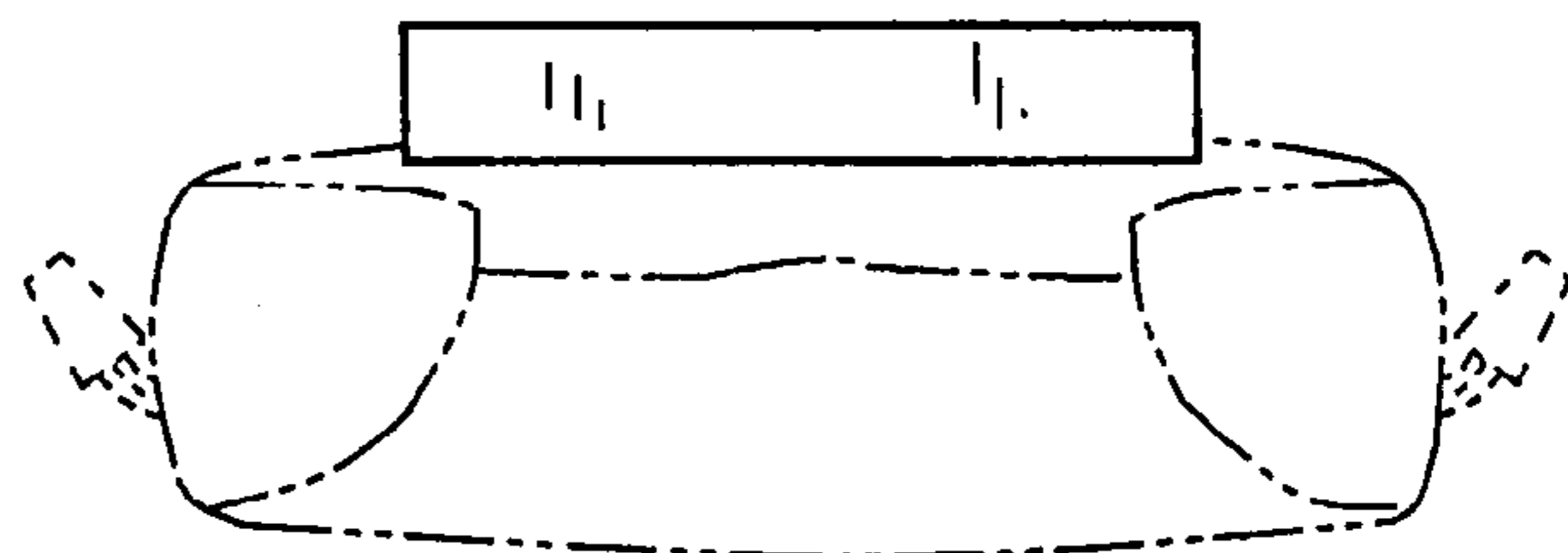

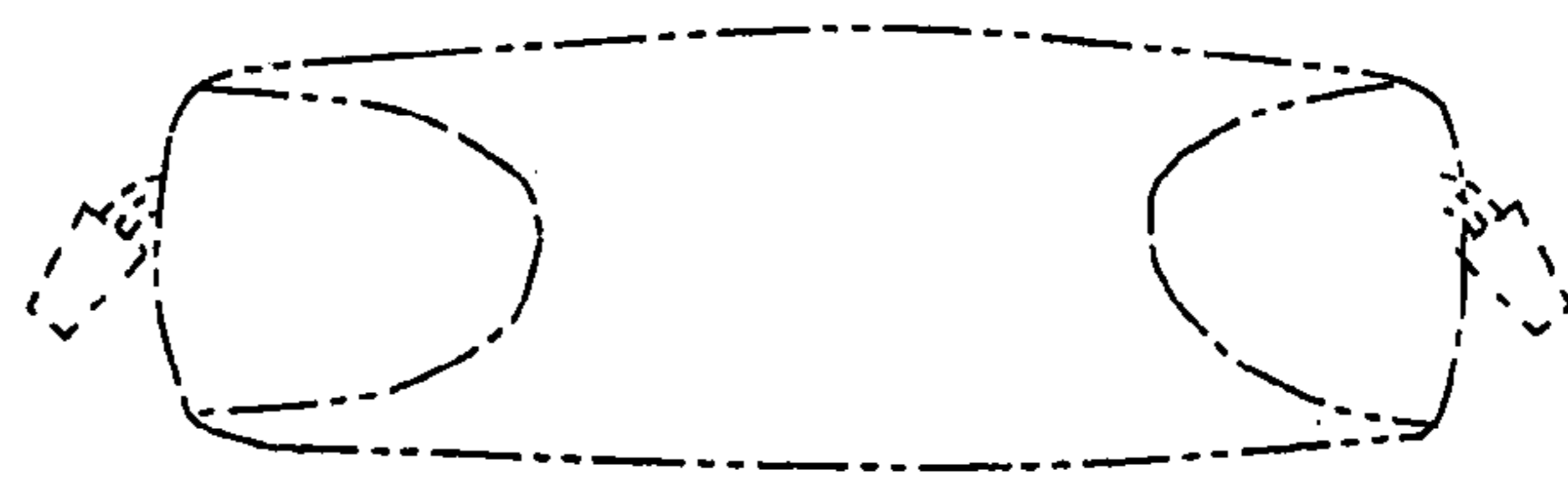
