DESCRIPTION

FIG. 1 is a rear perspective view of a runner's straw showing my new design, wherein a partial view of a hand is shown in broken lines for illustrative purposes only and forming a part of the claimed design;

FIG. 2 is a front perspective view of a runner's straw showing my new design, wherein a partial view of a hand is shown in broken lines for illustrative purposes only and forming a part of the claimed design;

FIG. 4 is a left side view thereof;

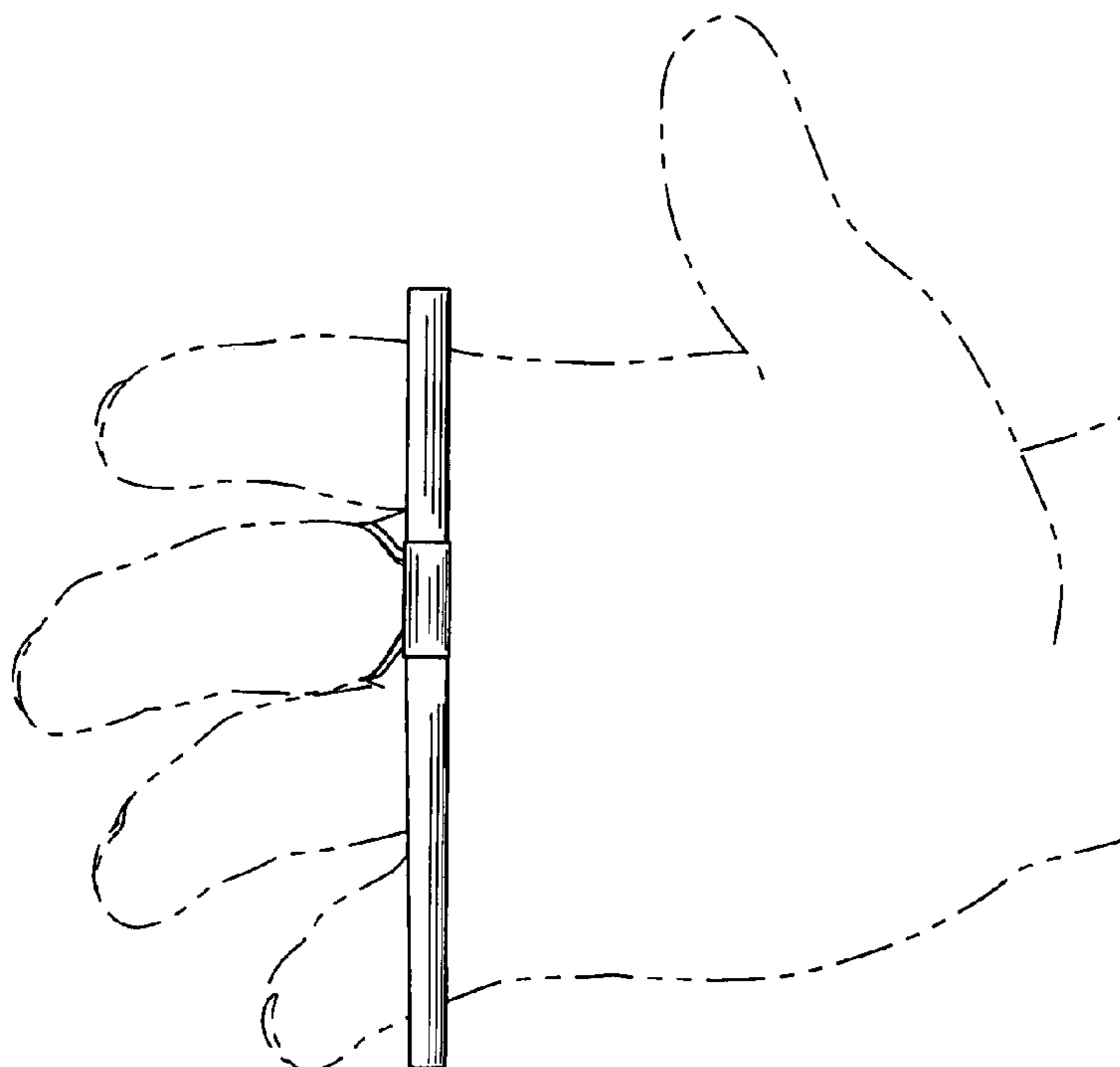
FIG. 5 is a bottom view thereof;

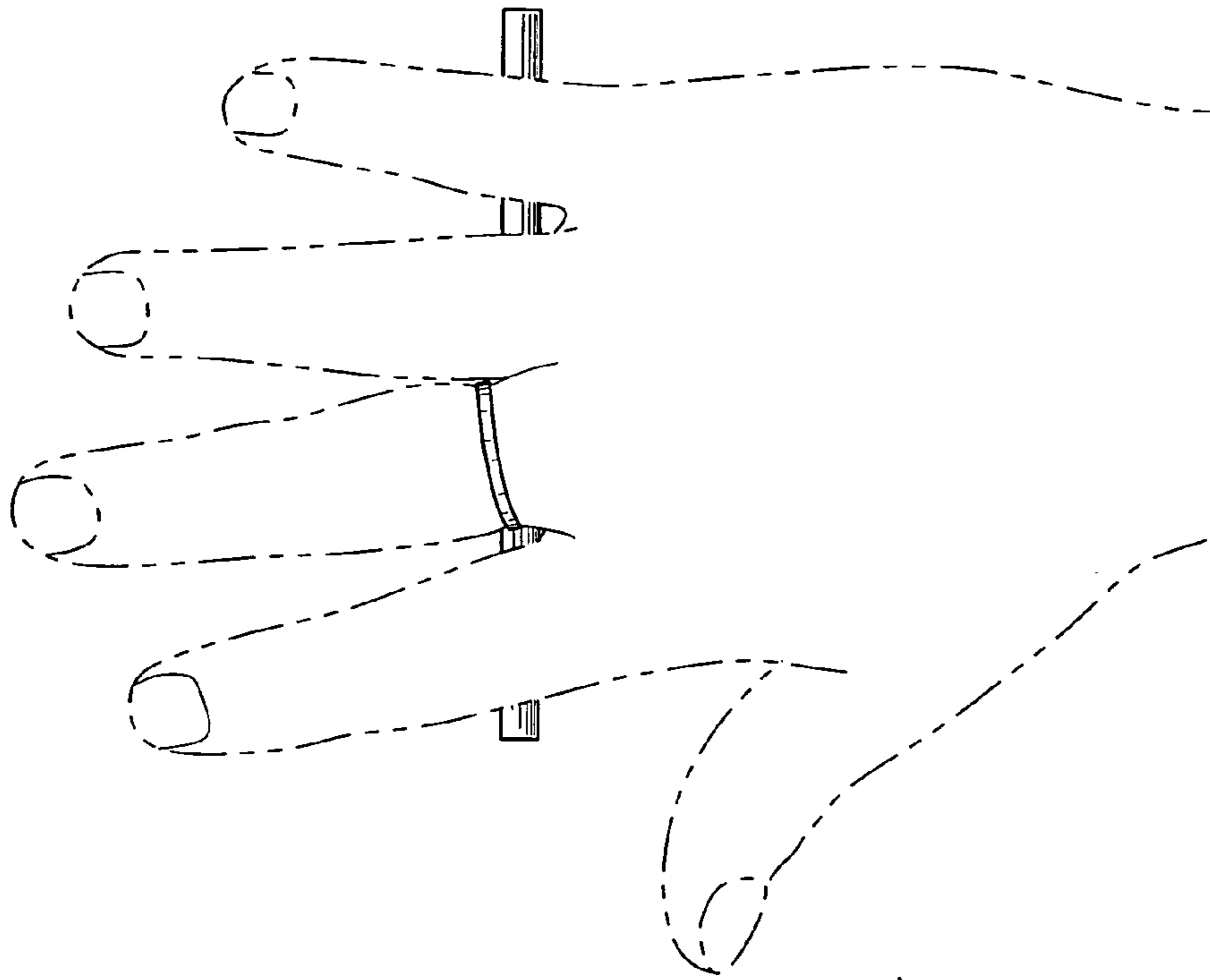

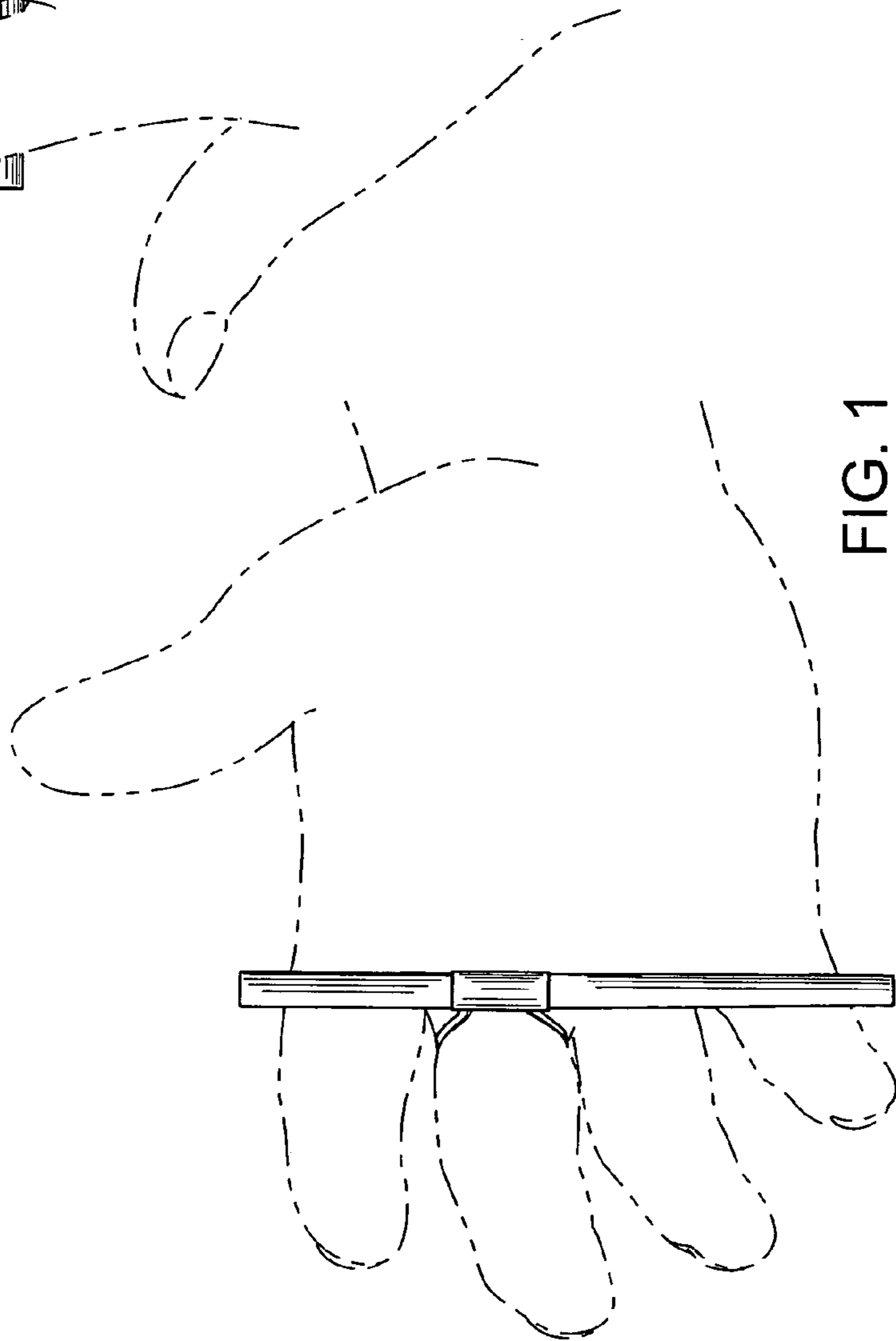

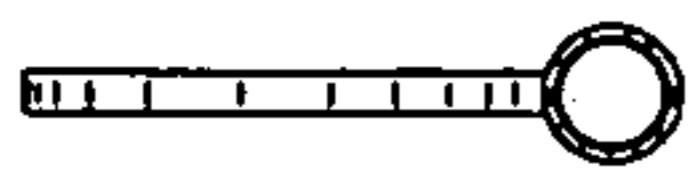

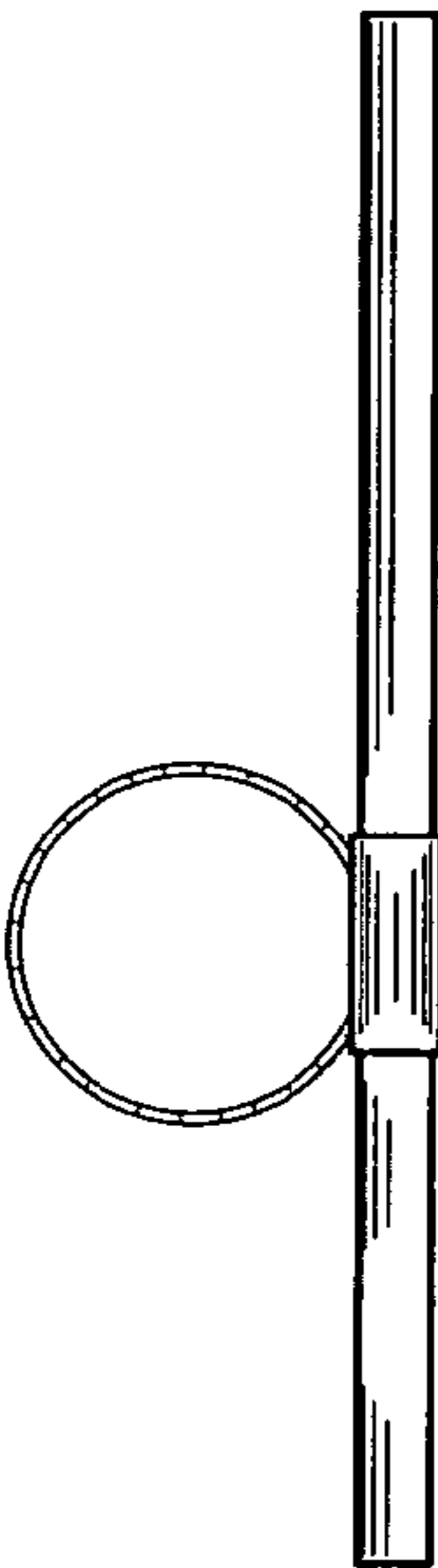

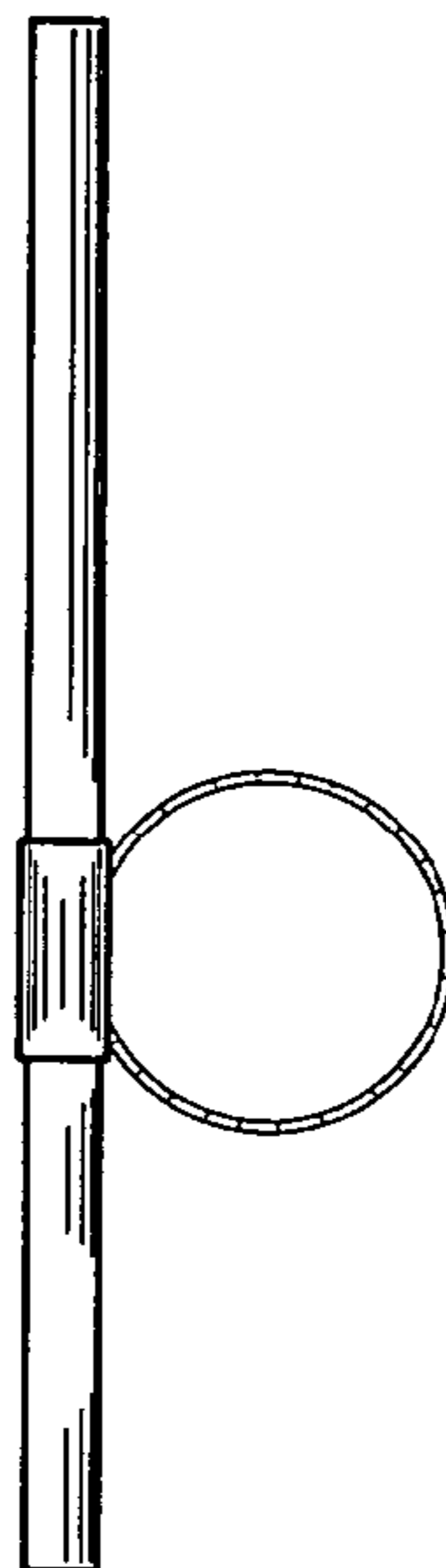

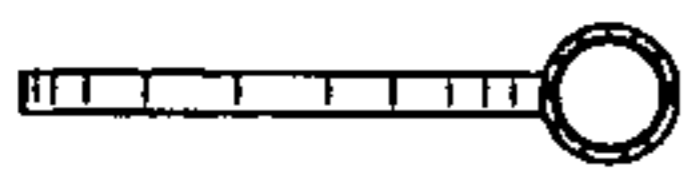
