DESCRIPTION

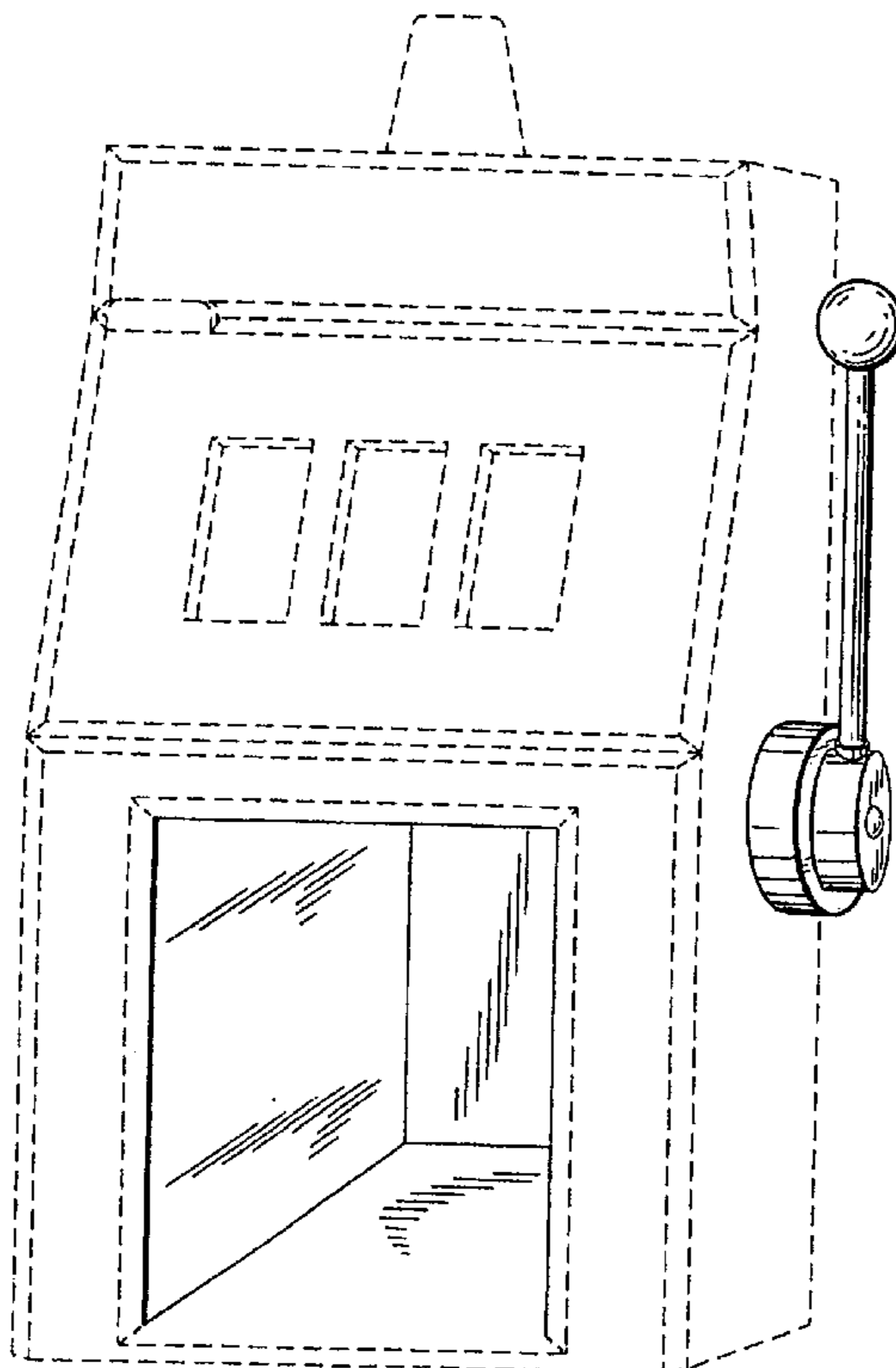
FIG. 1 is a front perspective view of a beverage dispenser;

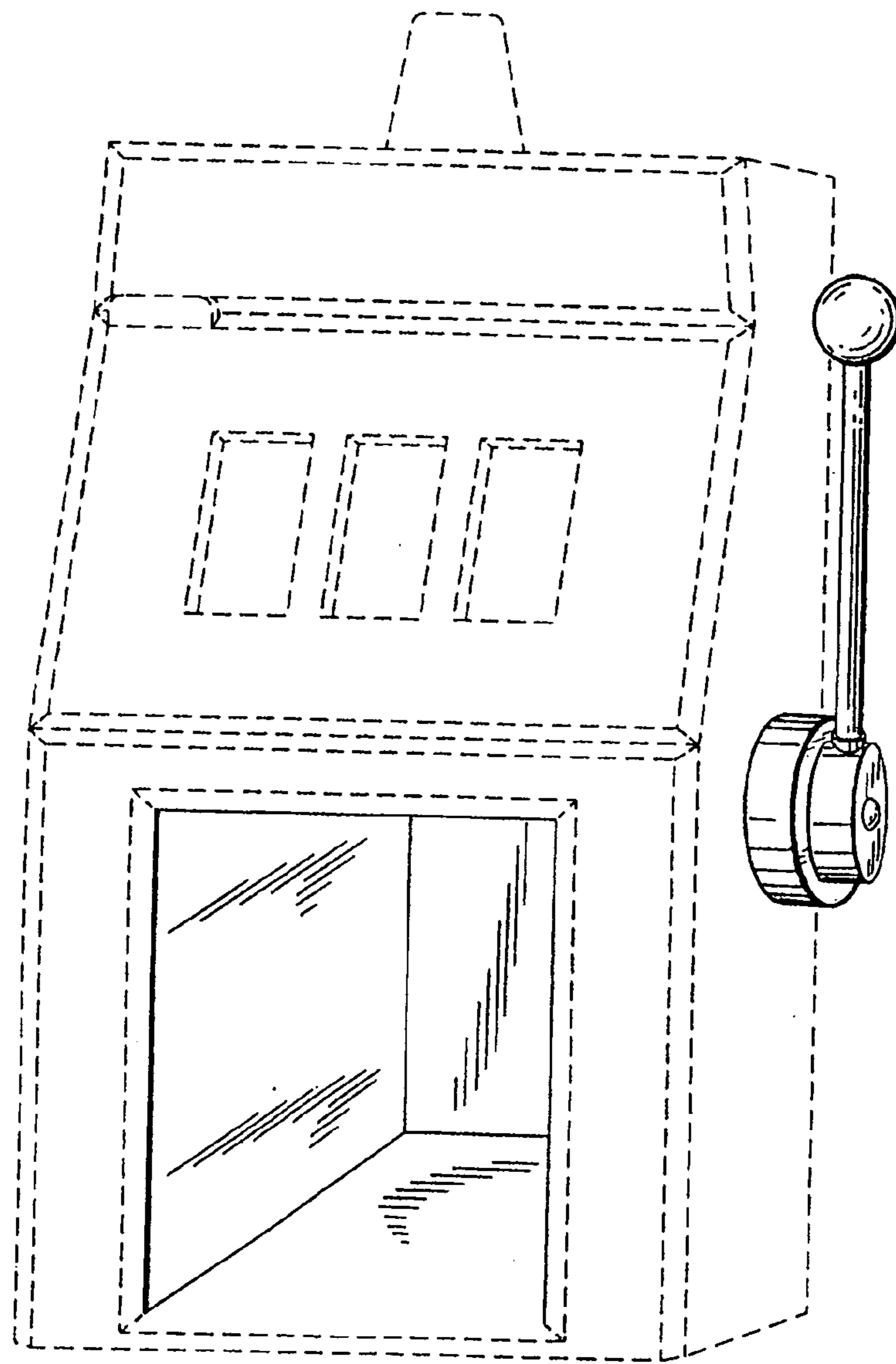

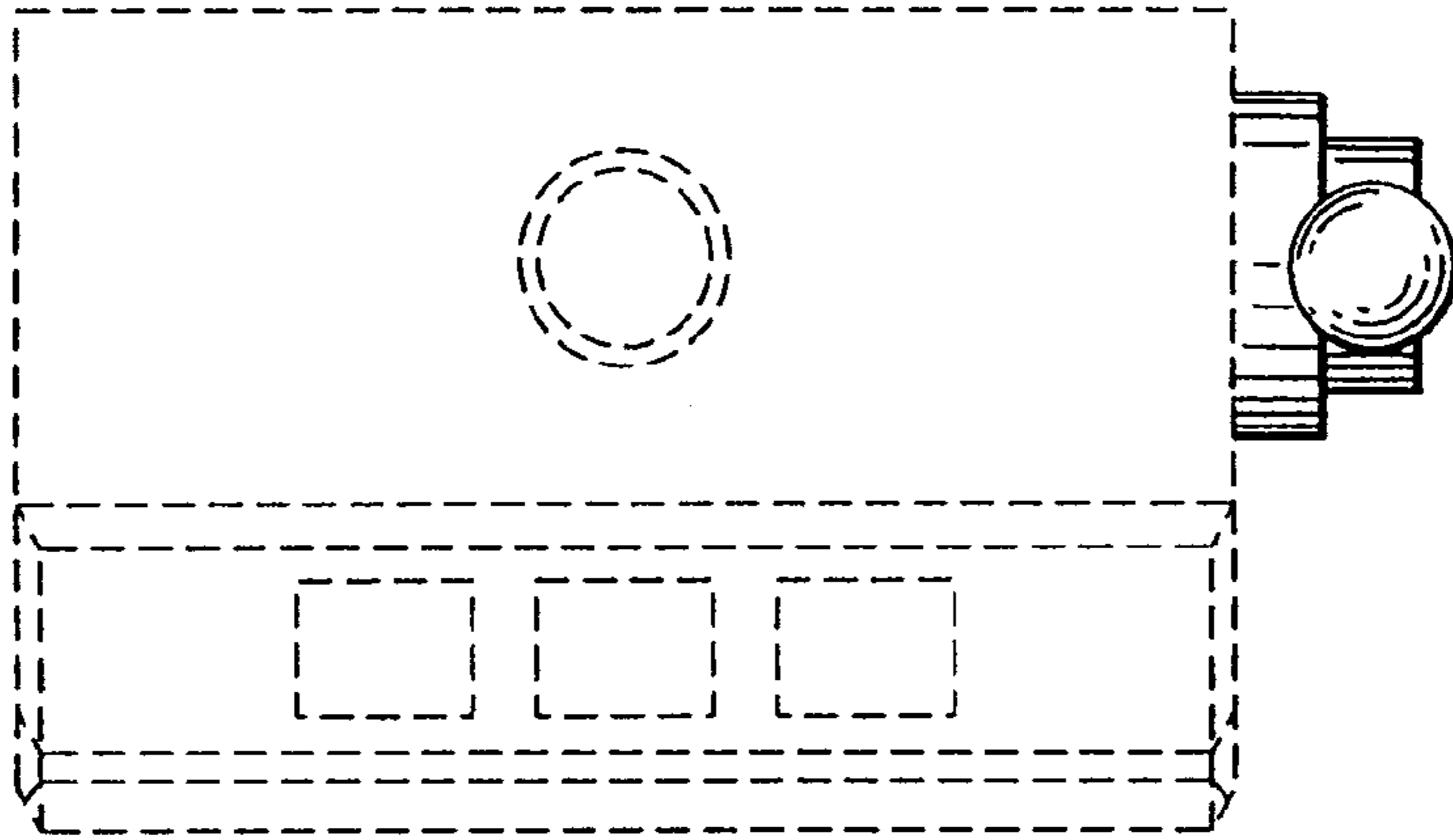

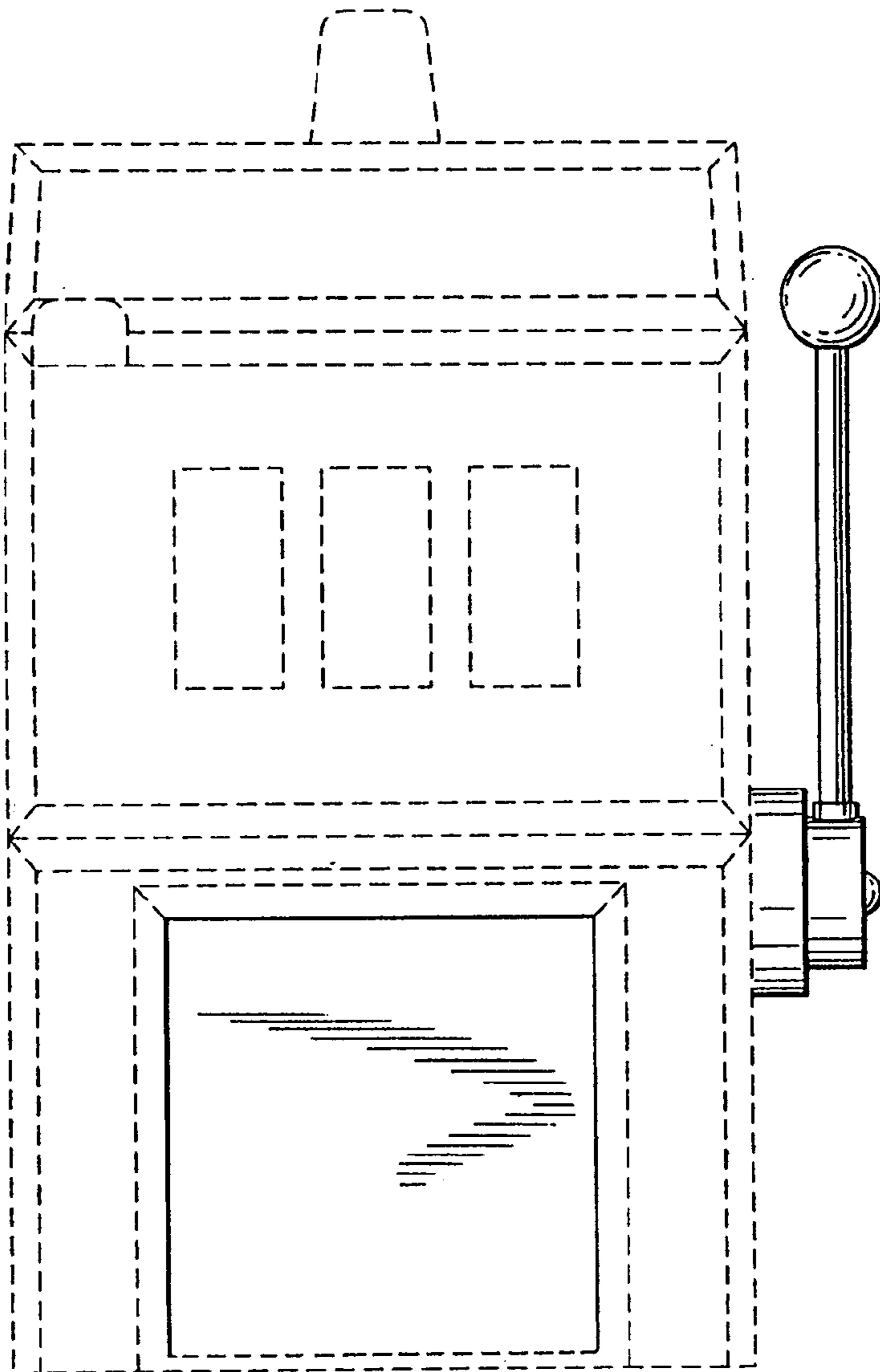

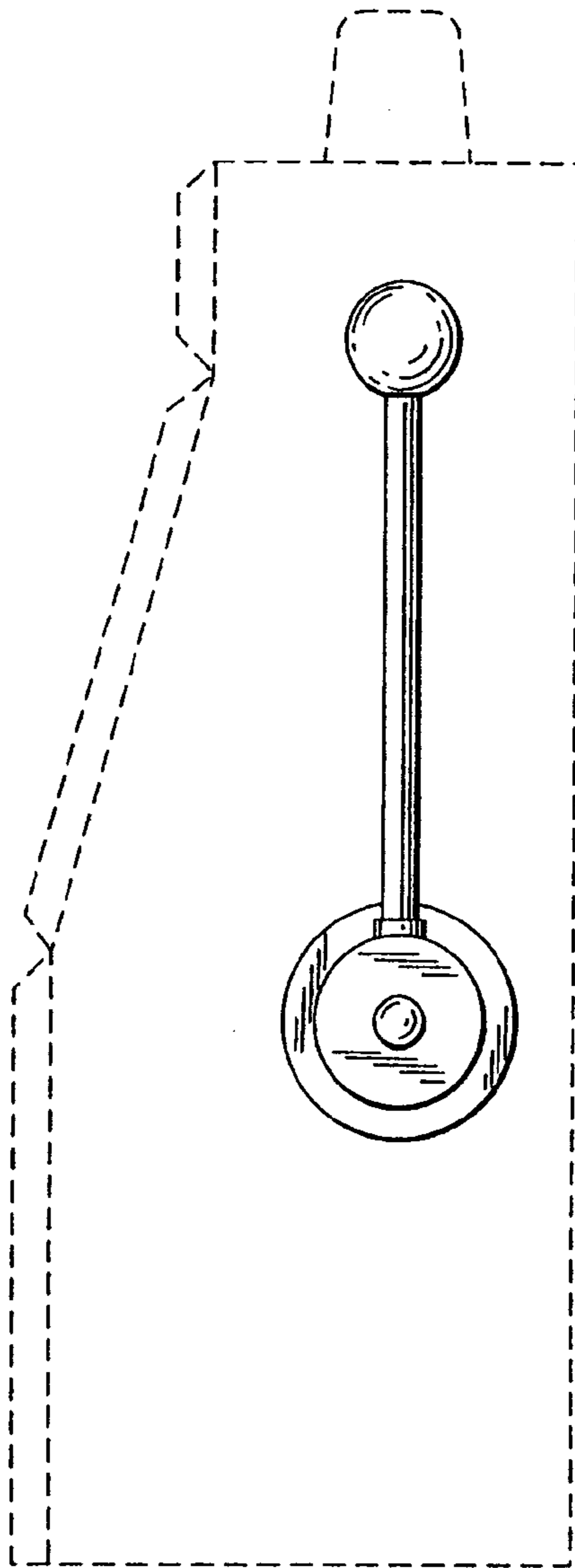
