FIG. 1 is a perspective view of a container showing my design;

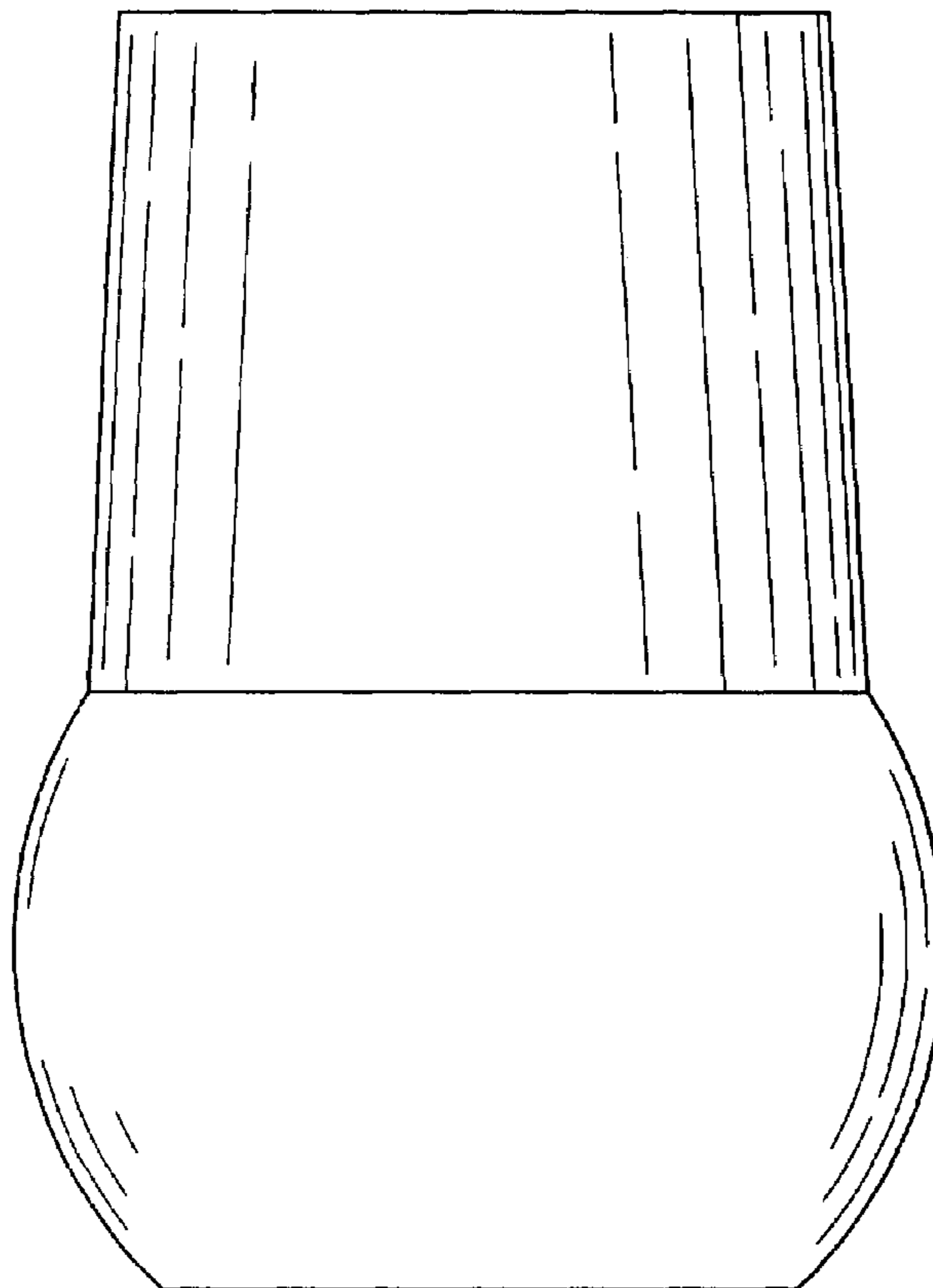
FIG. 2 is an elevational view thereof, with all elevational views being identical;

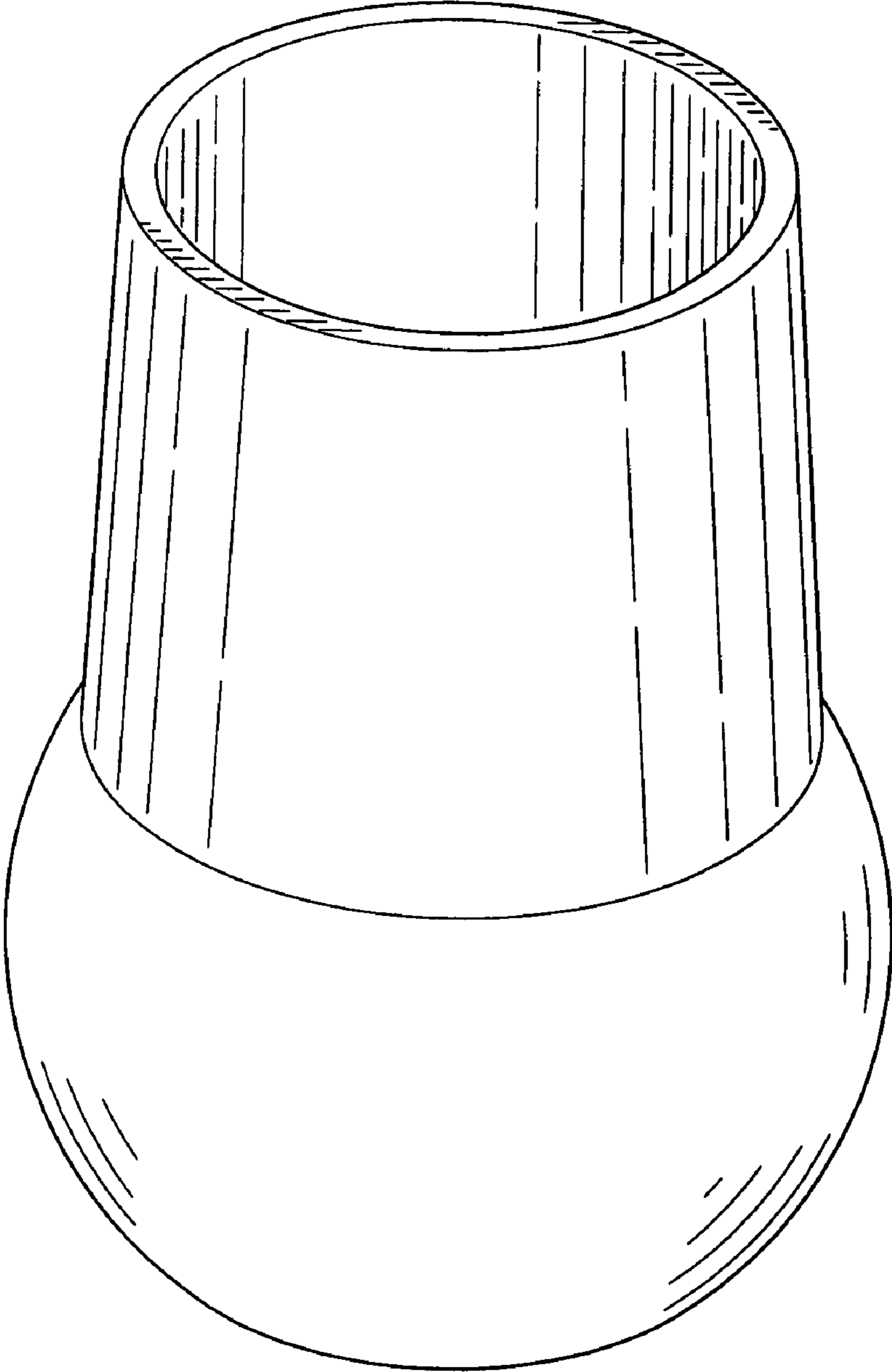

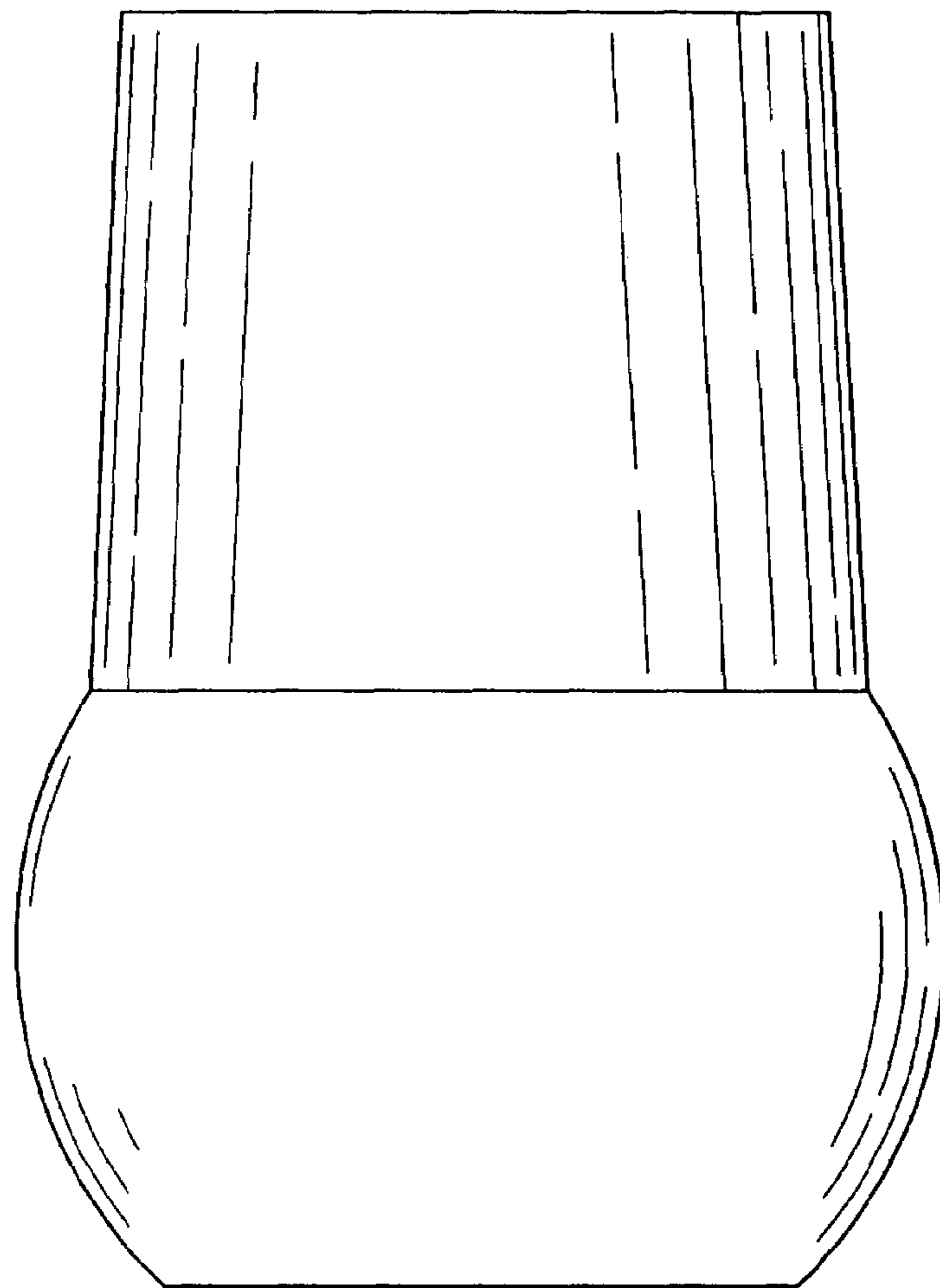

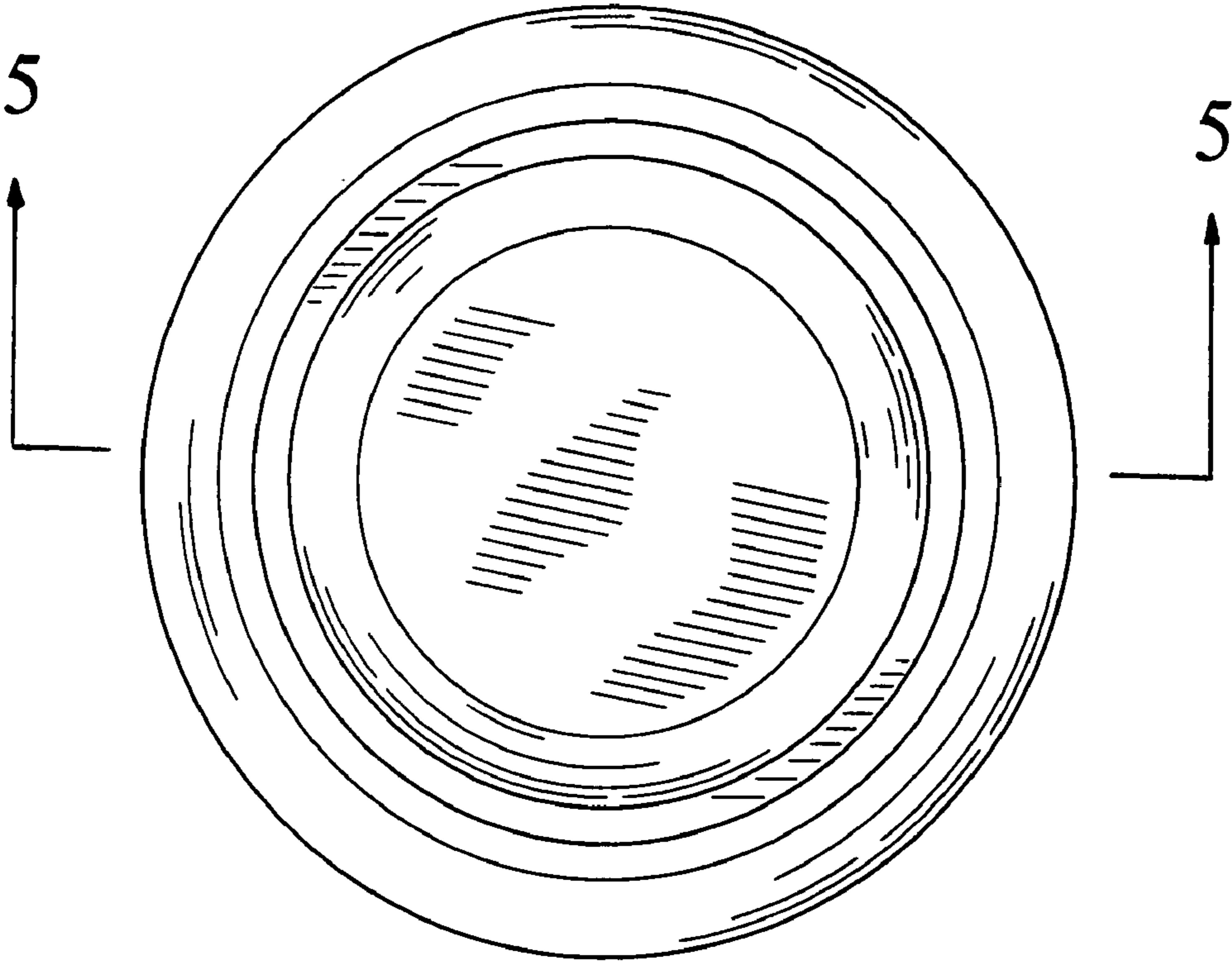

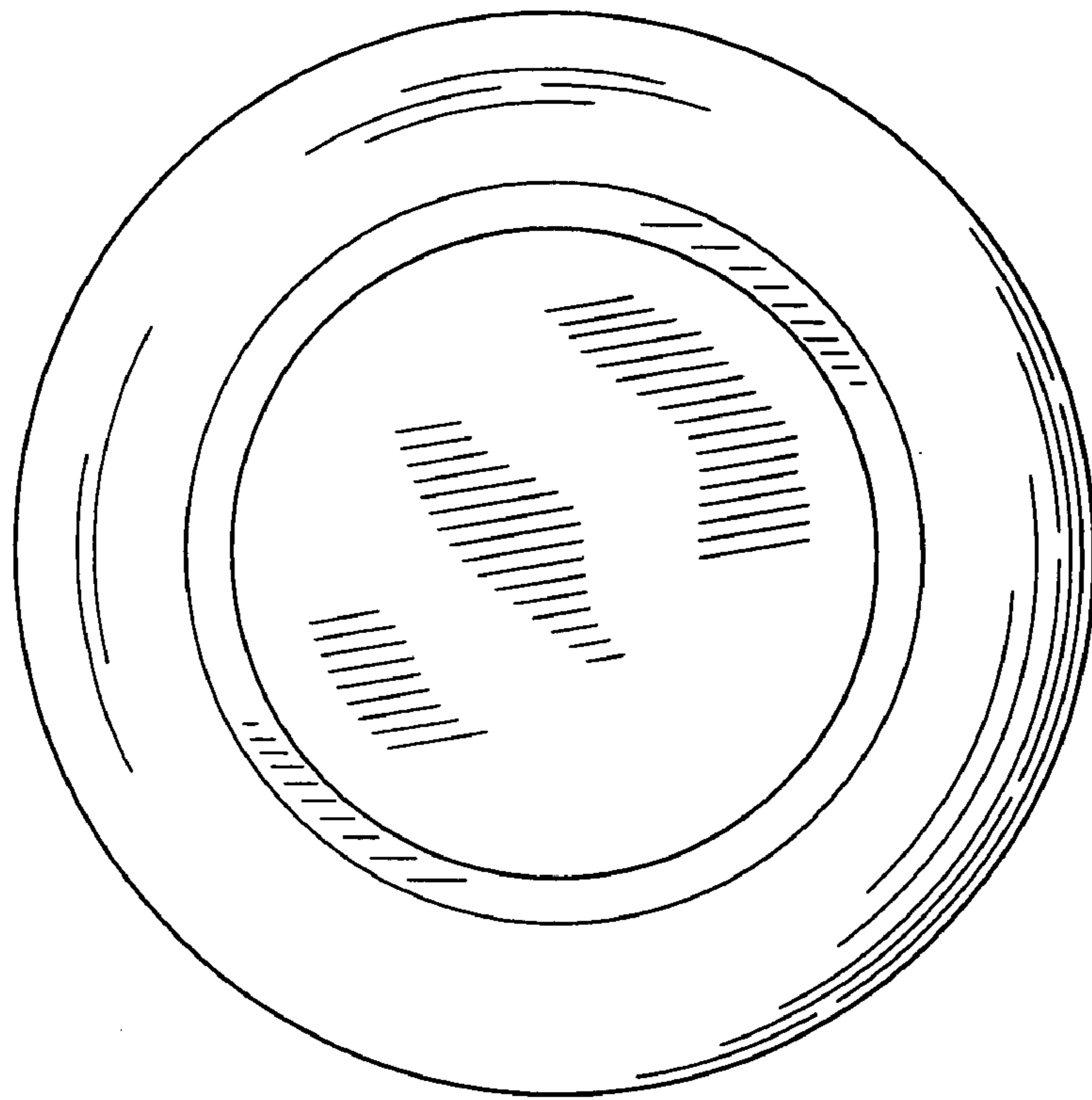

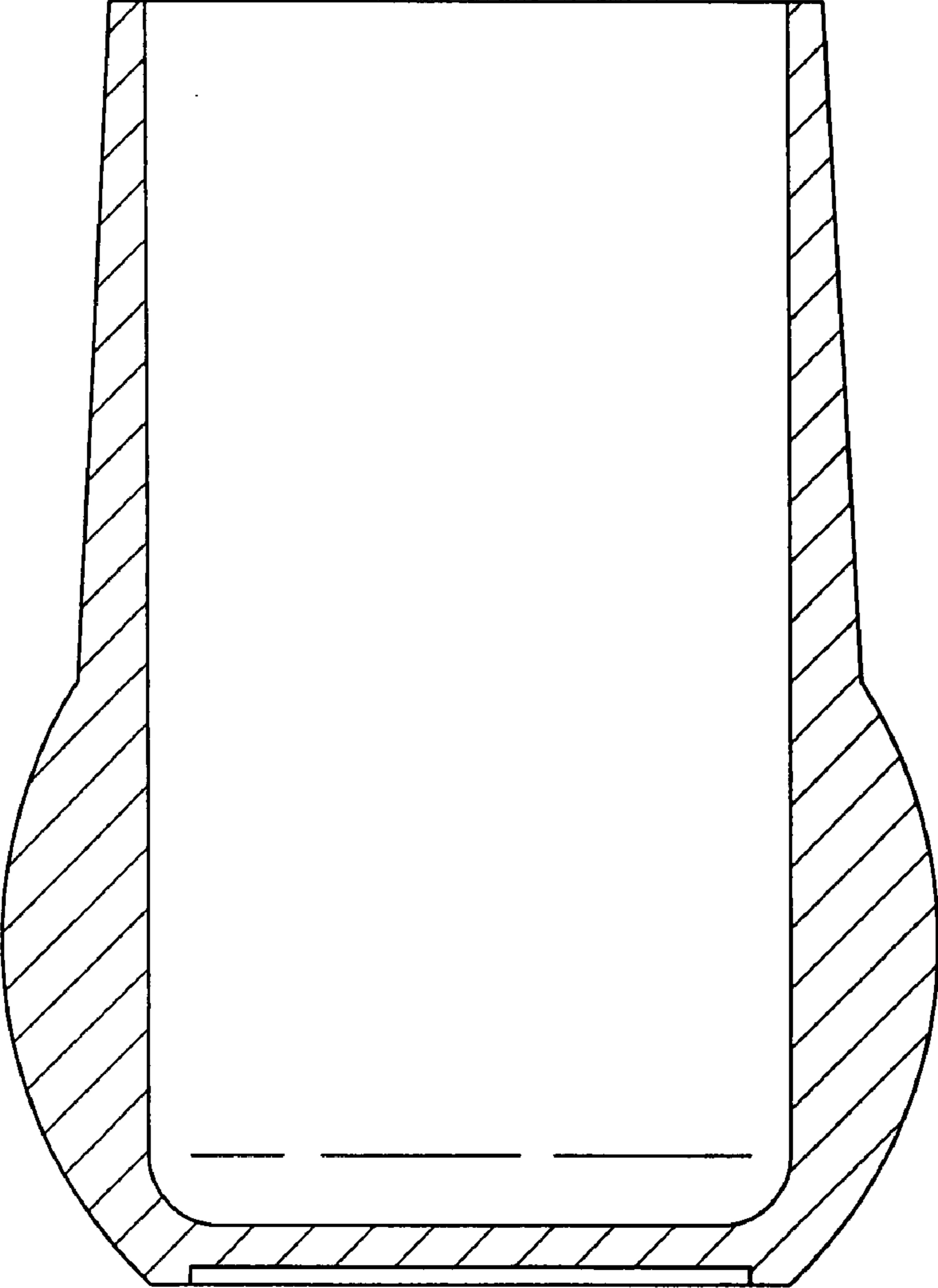
