FIG. 2 is a front elevation view thereof;

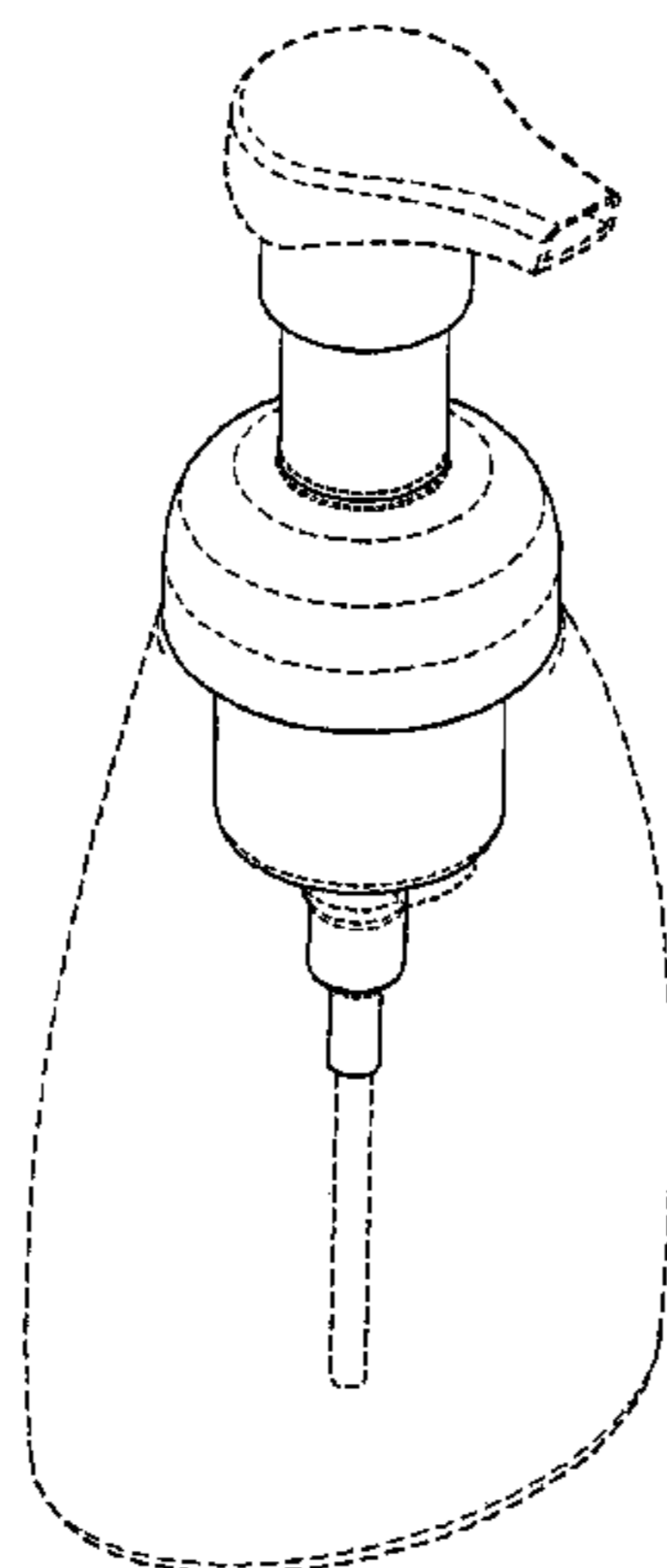
FIG. 3 is a side elevation view thereof;

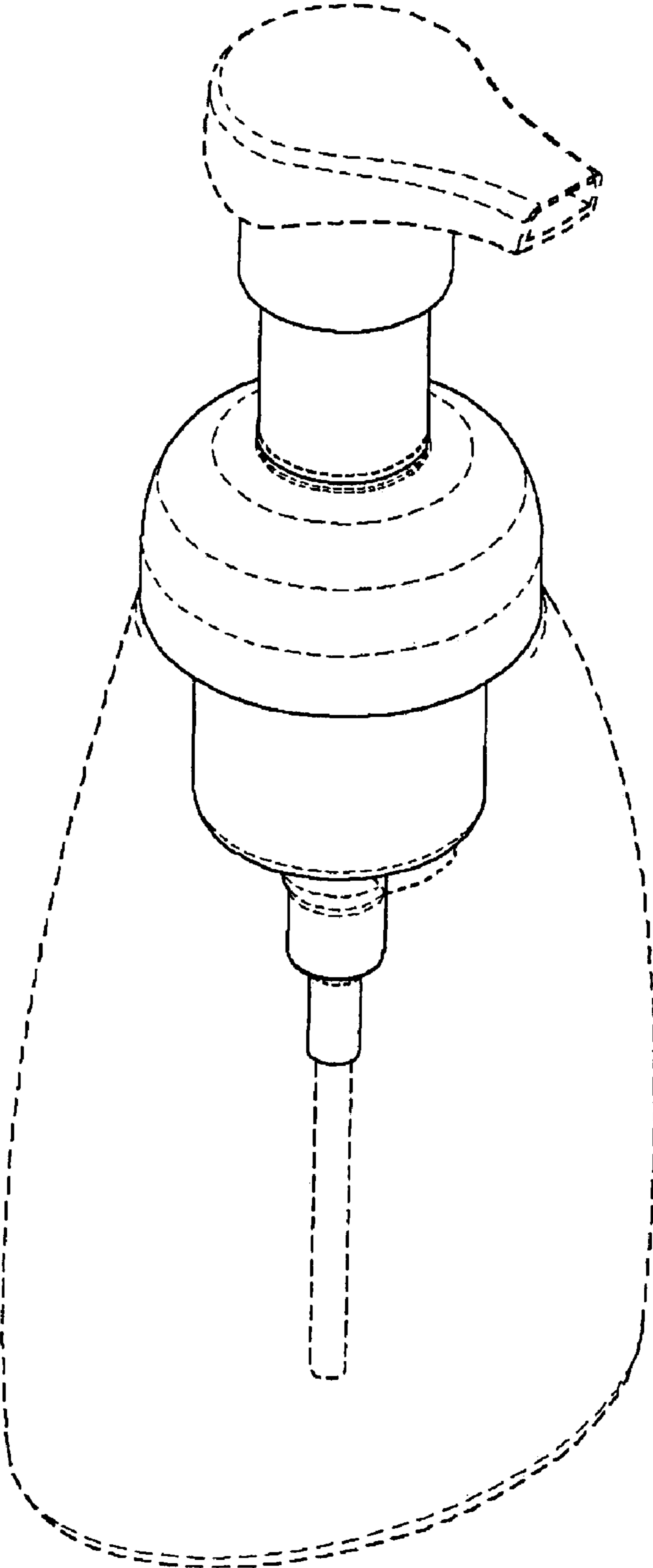

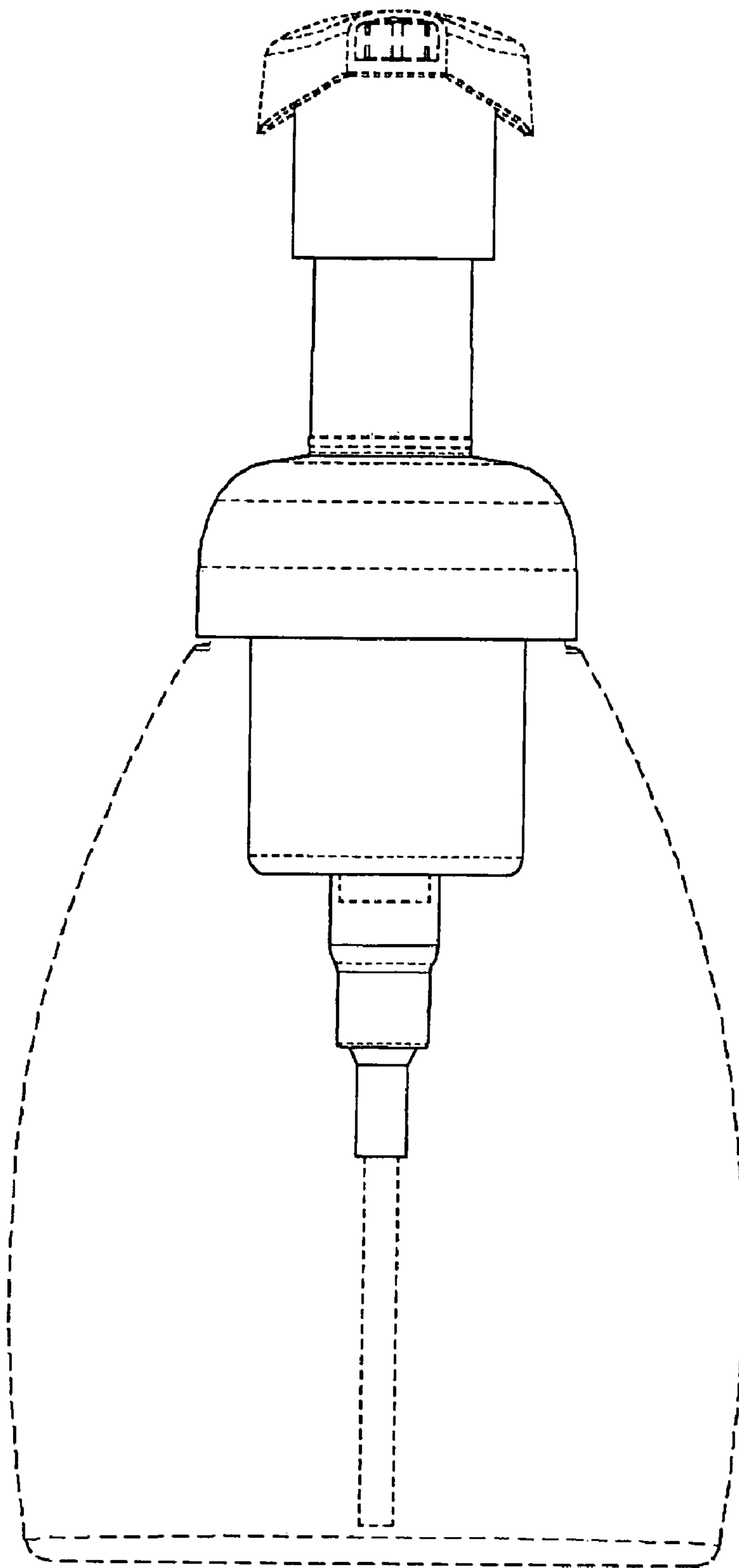

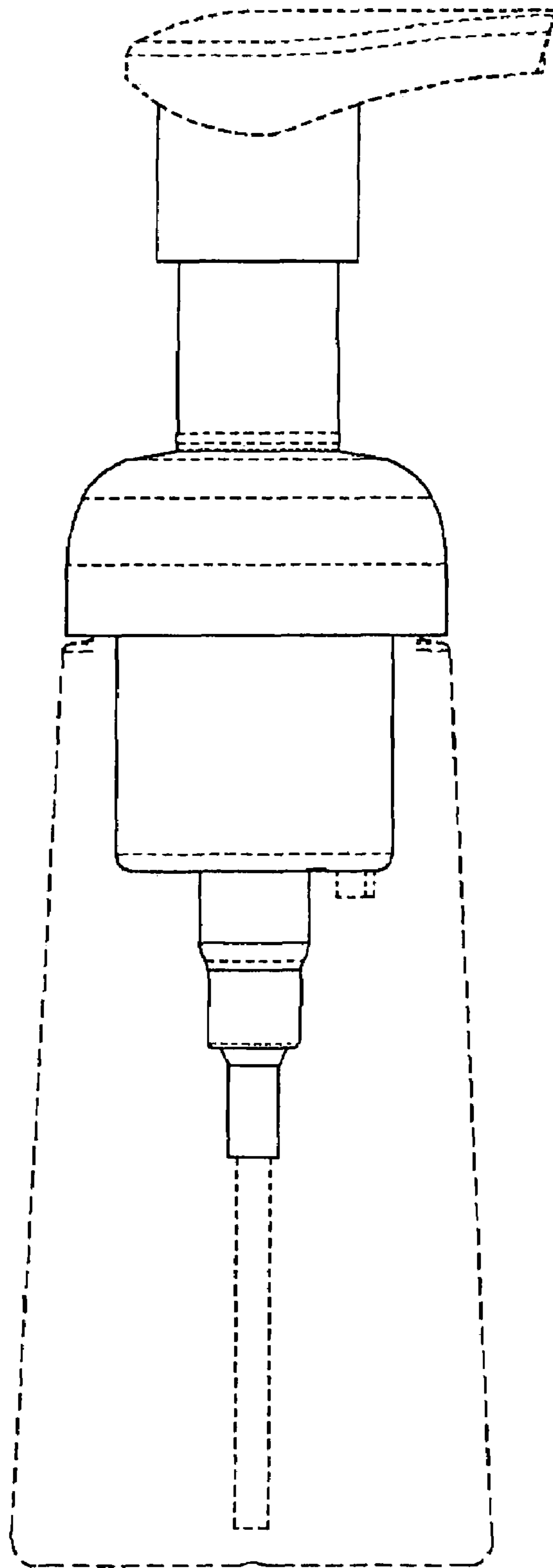

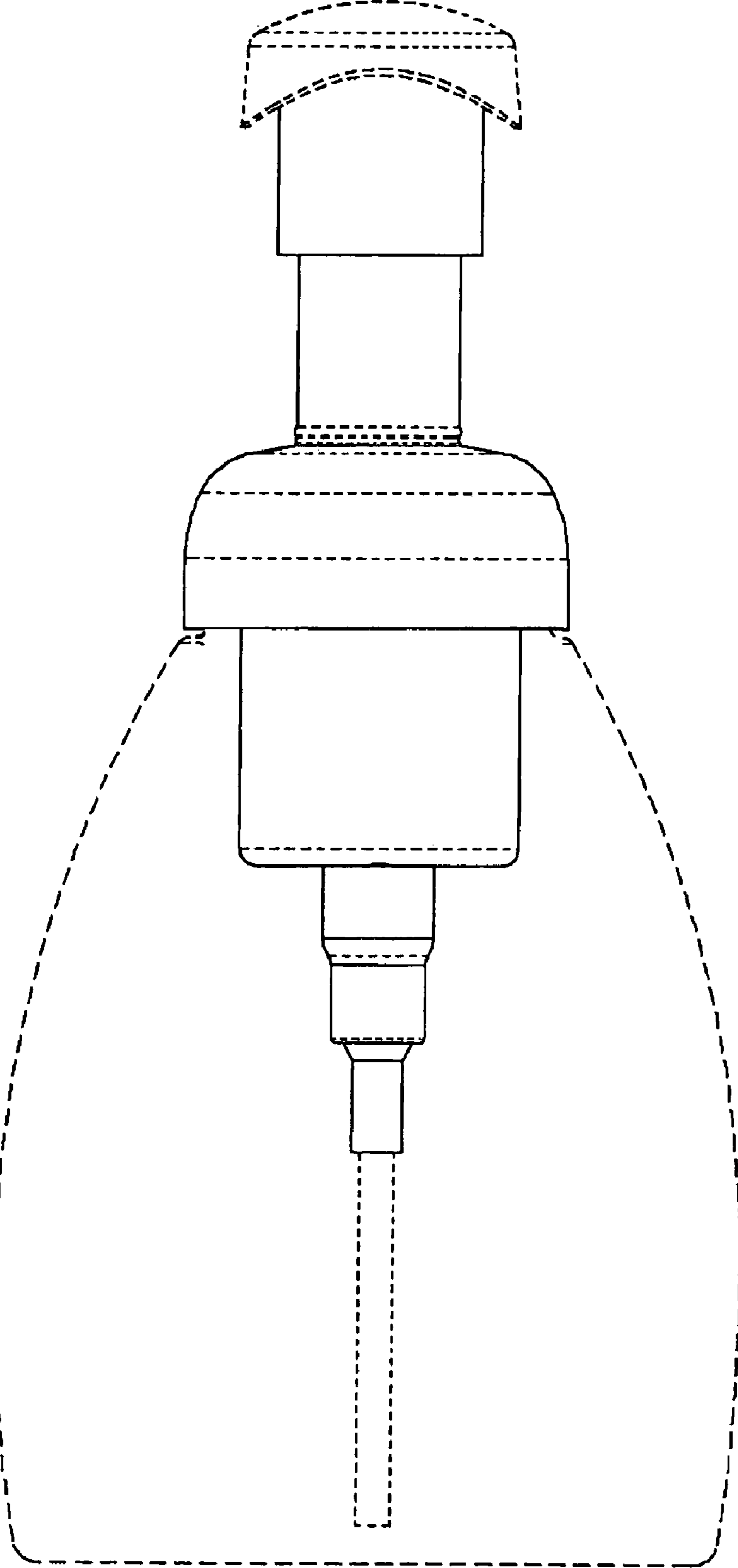

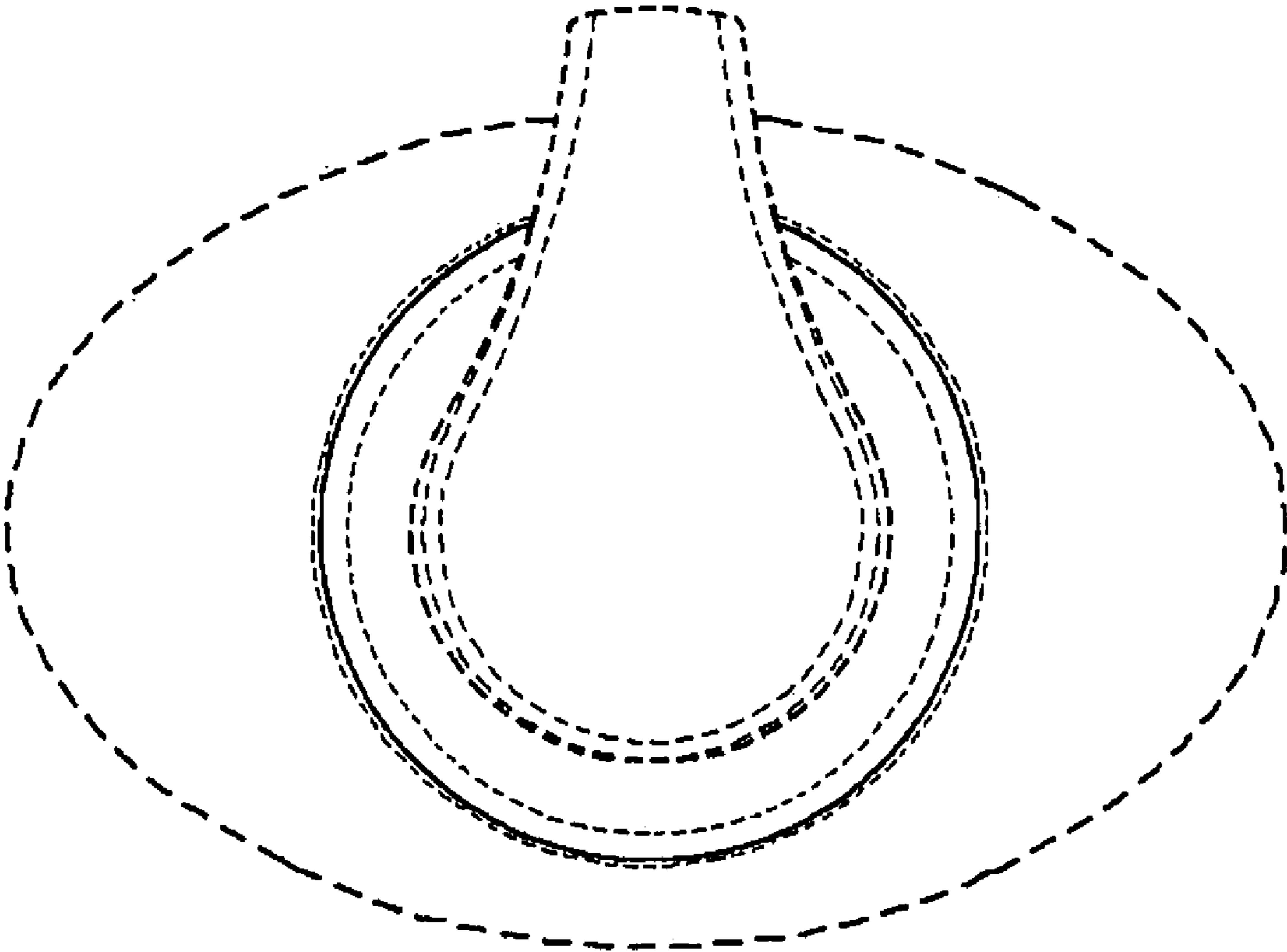
