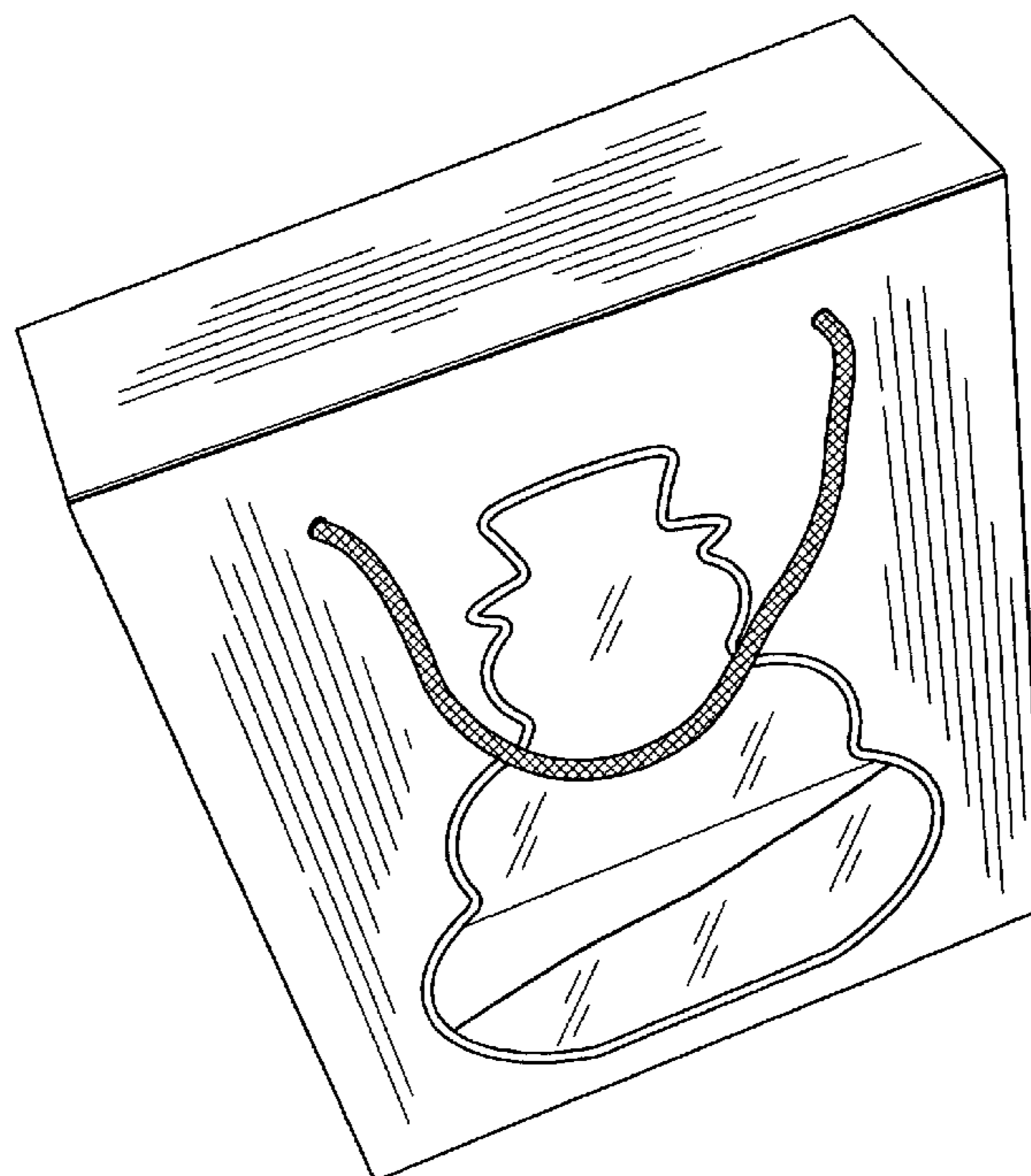
(57) **CLAIM**

The ornamental design for a gift bag with insert pocket, substantially as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a gift bag with insert pocket showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a side elevational view thereof, the opposite side being a mirror image thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.

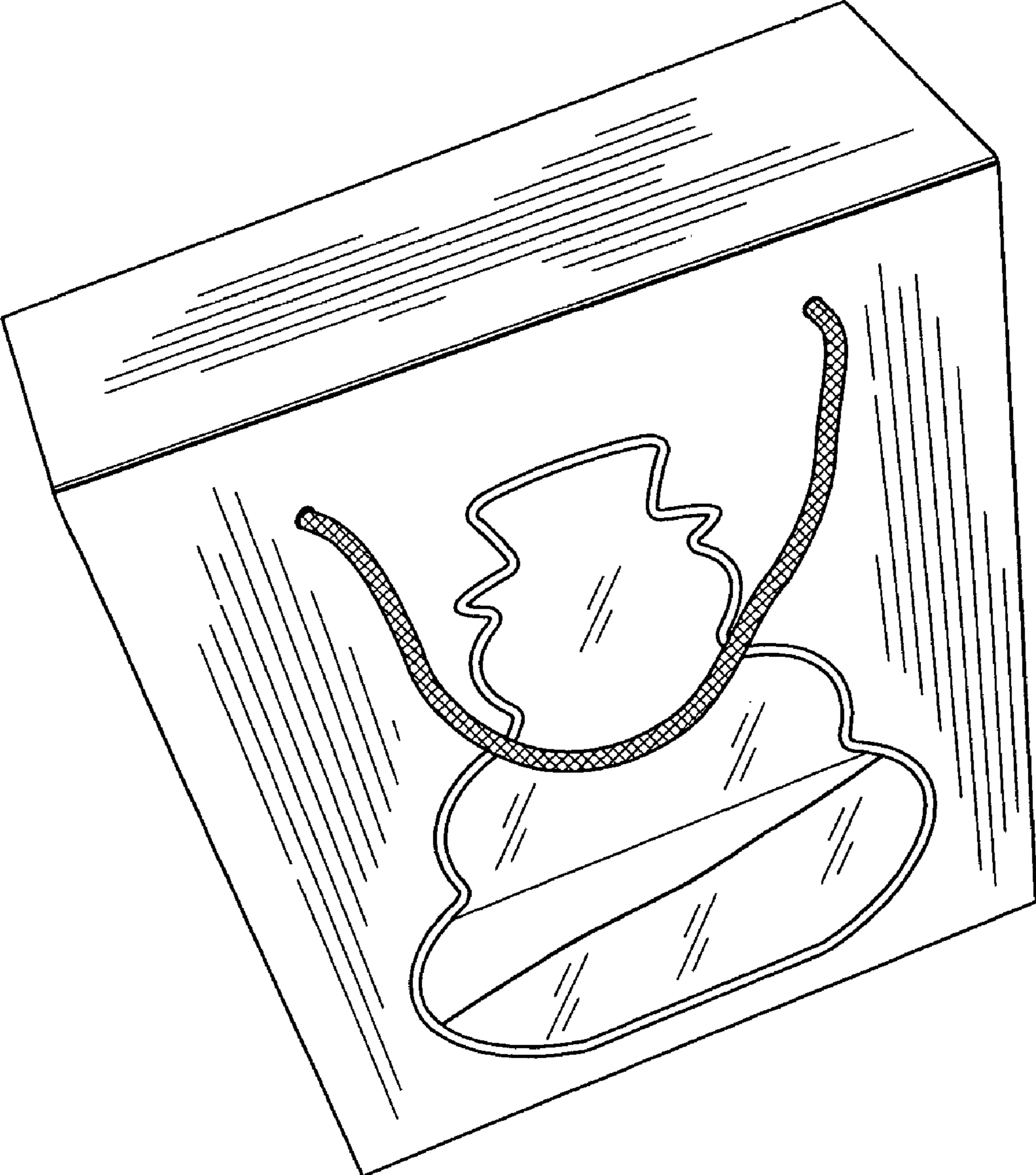

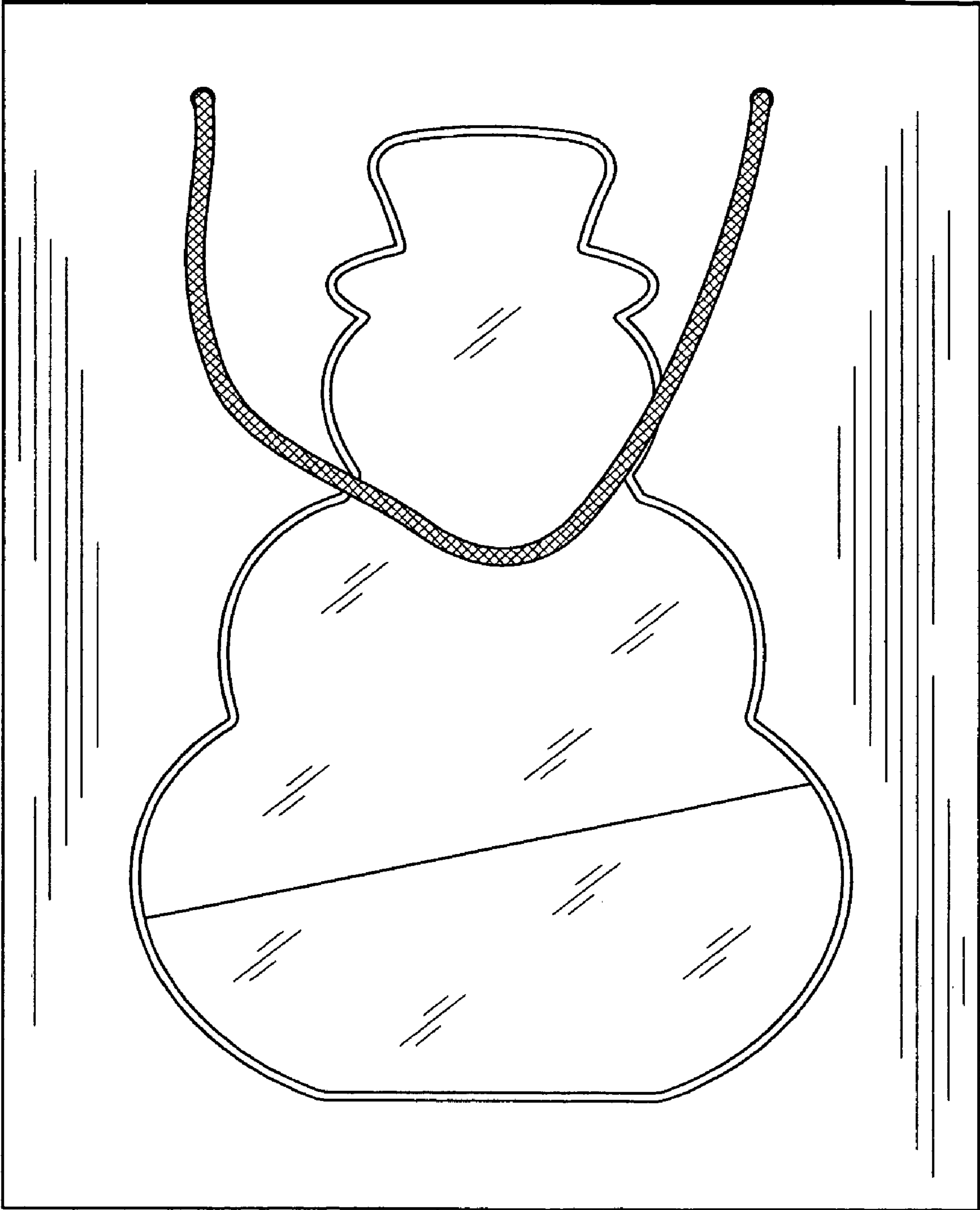

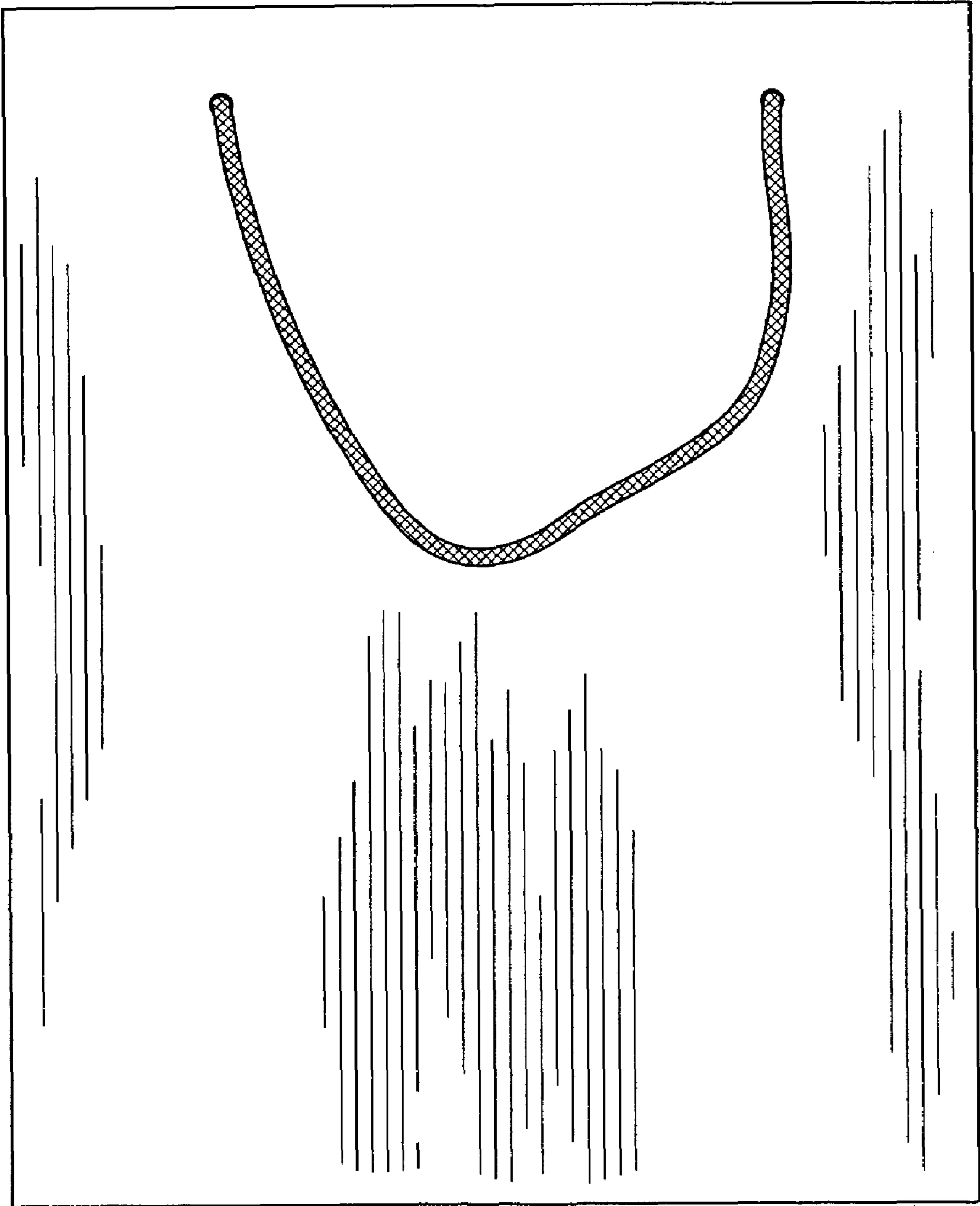

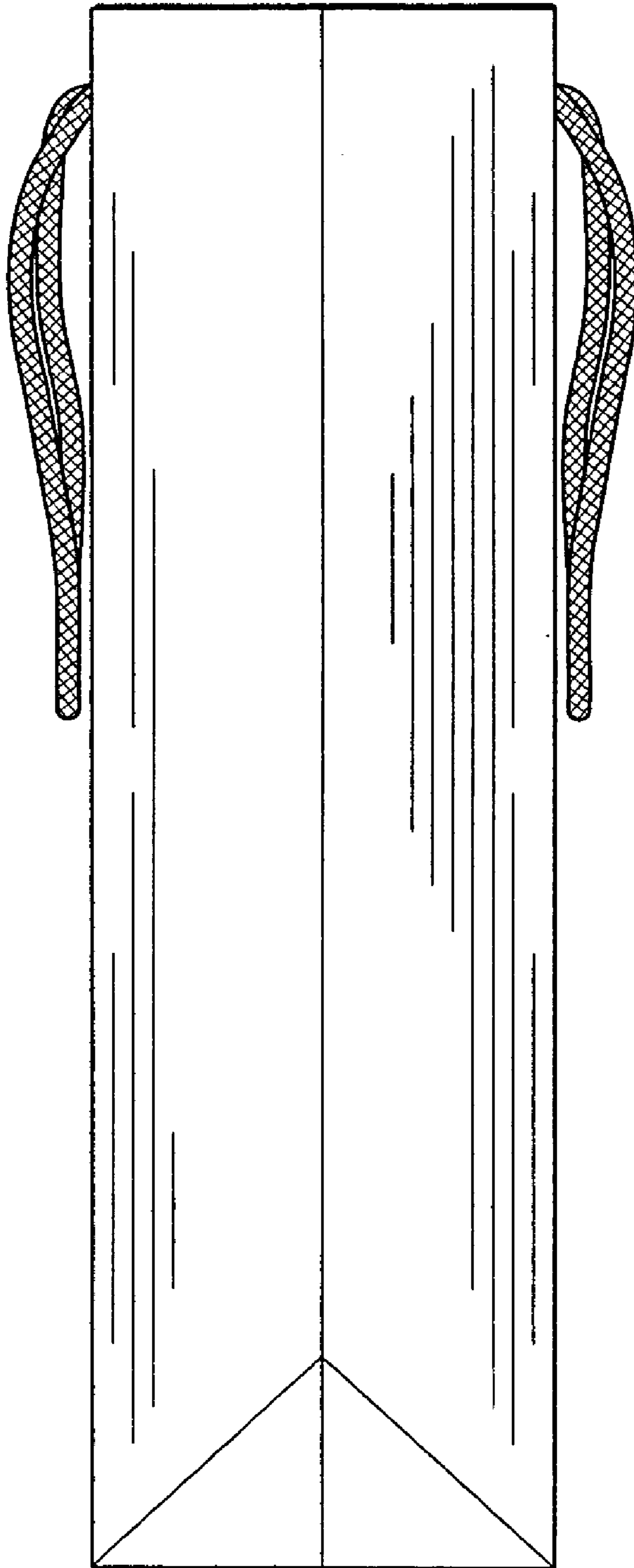

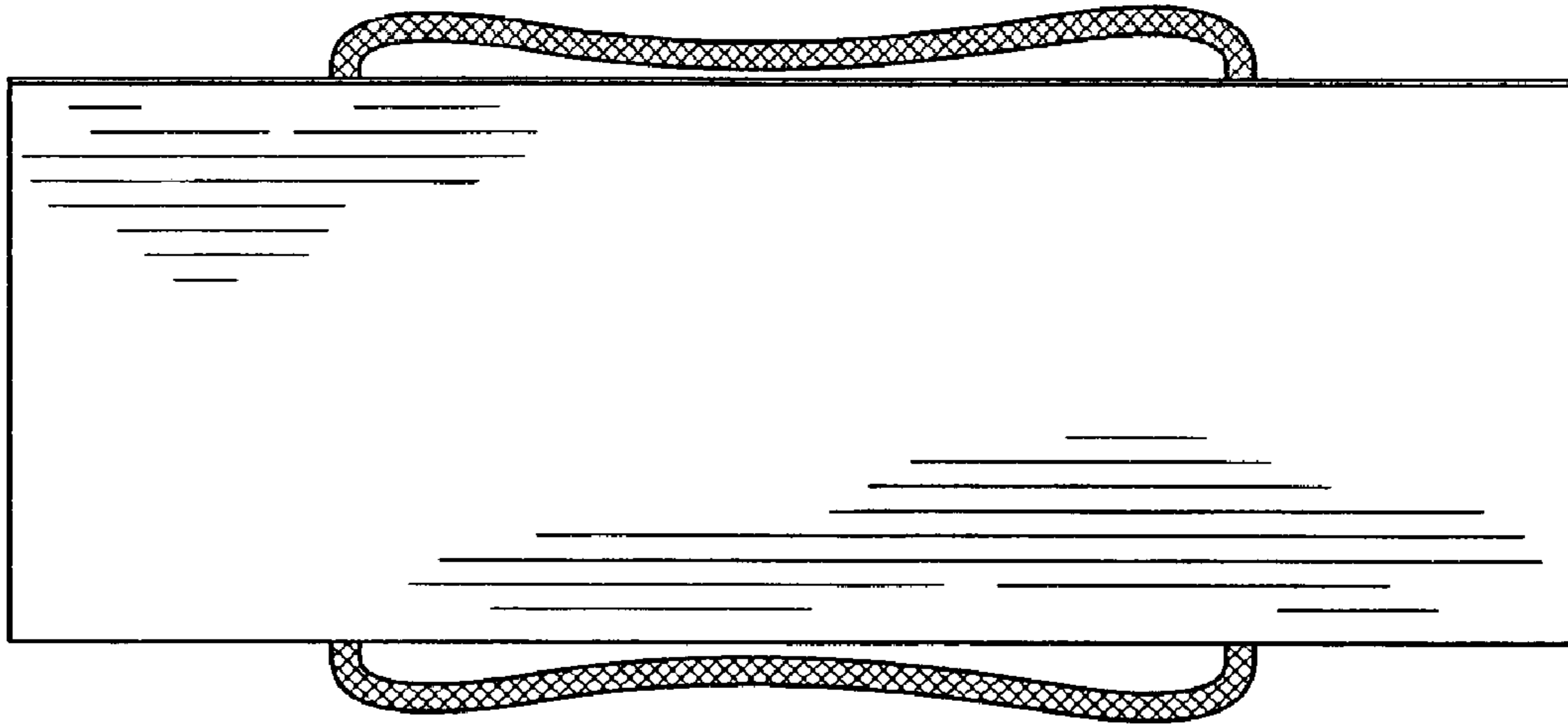

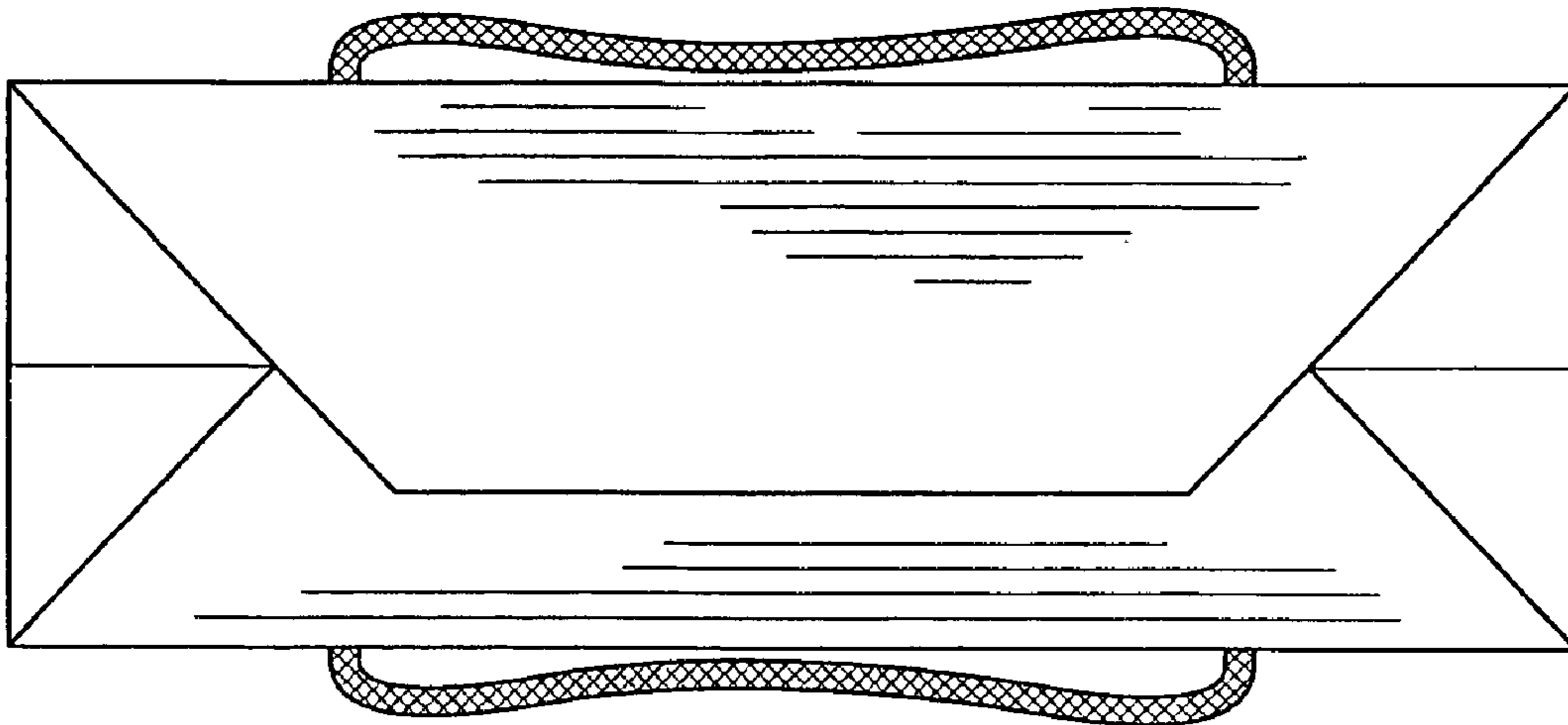
