FIG. 1 is a front elevational view of a football vase showing my new design.

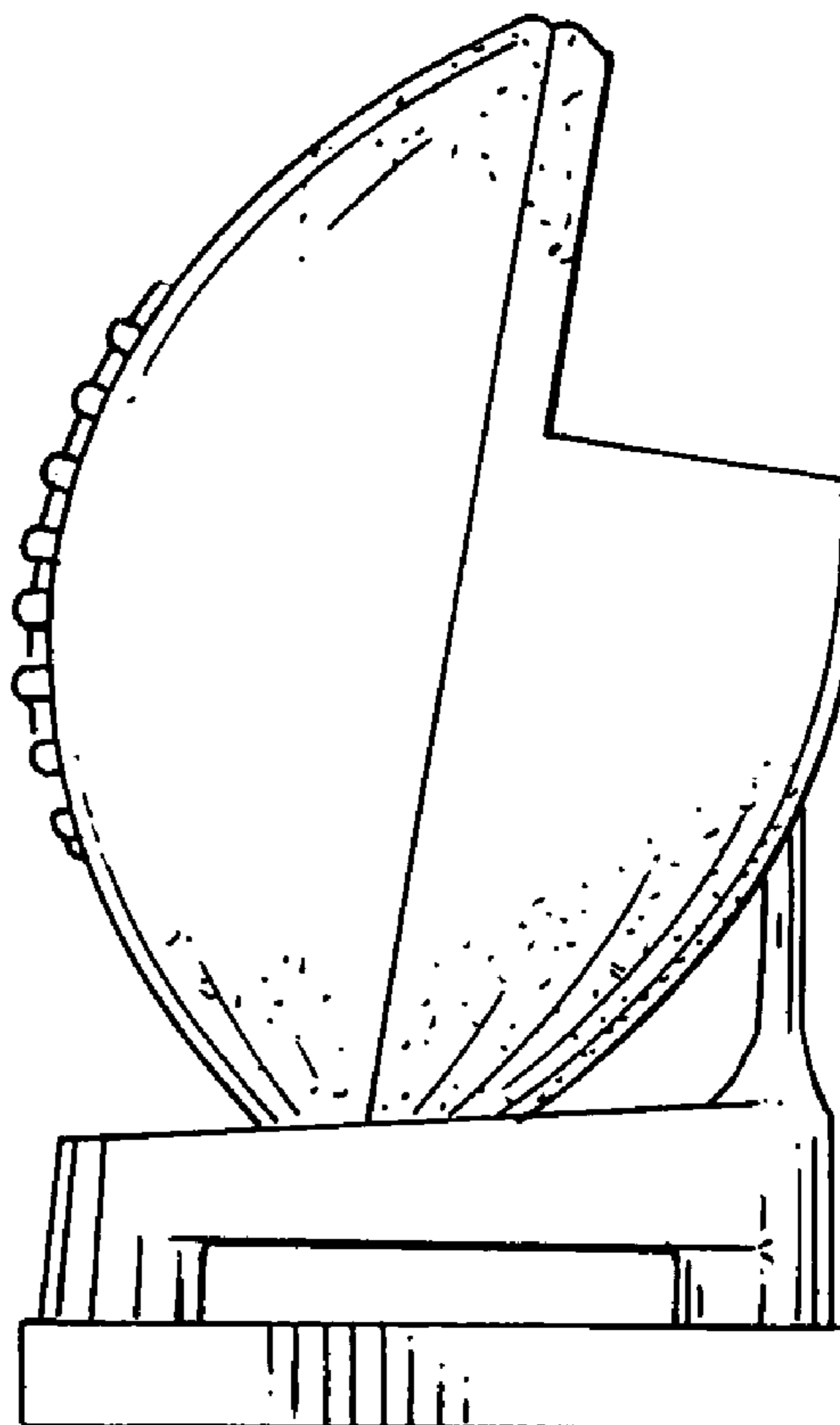
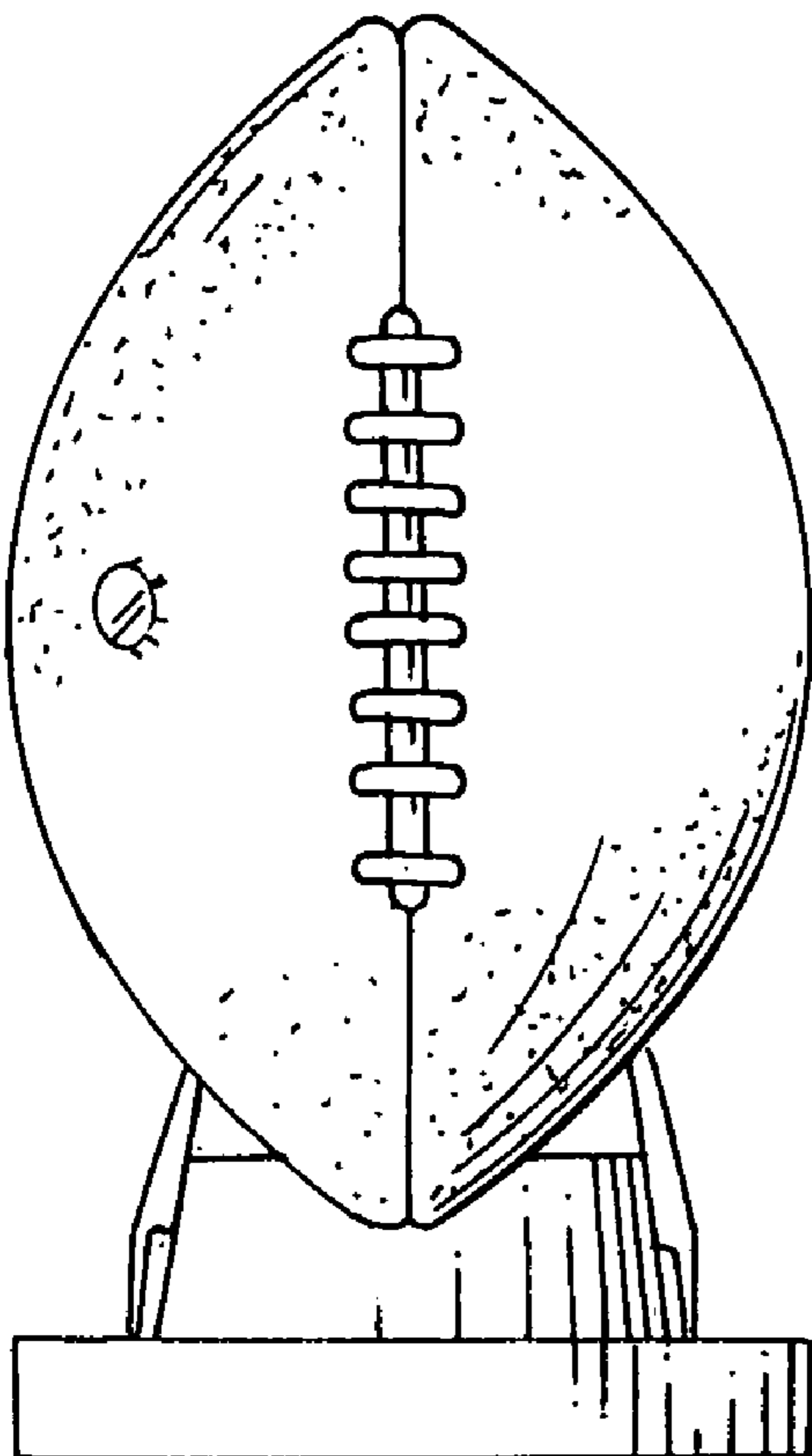
FIG. 2 is a right side elevational view thereof.

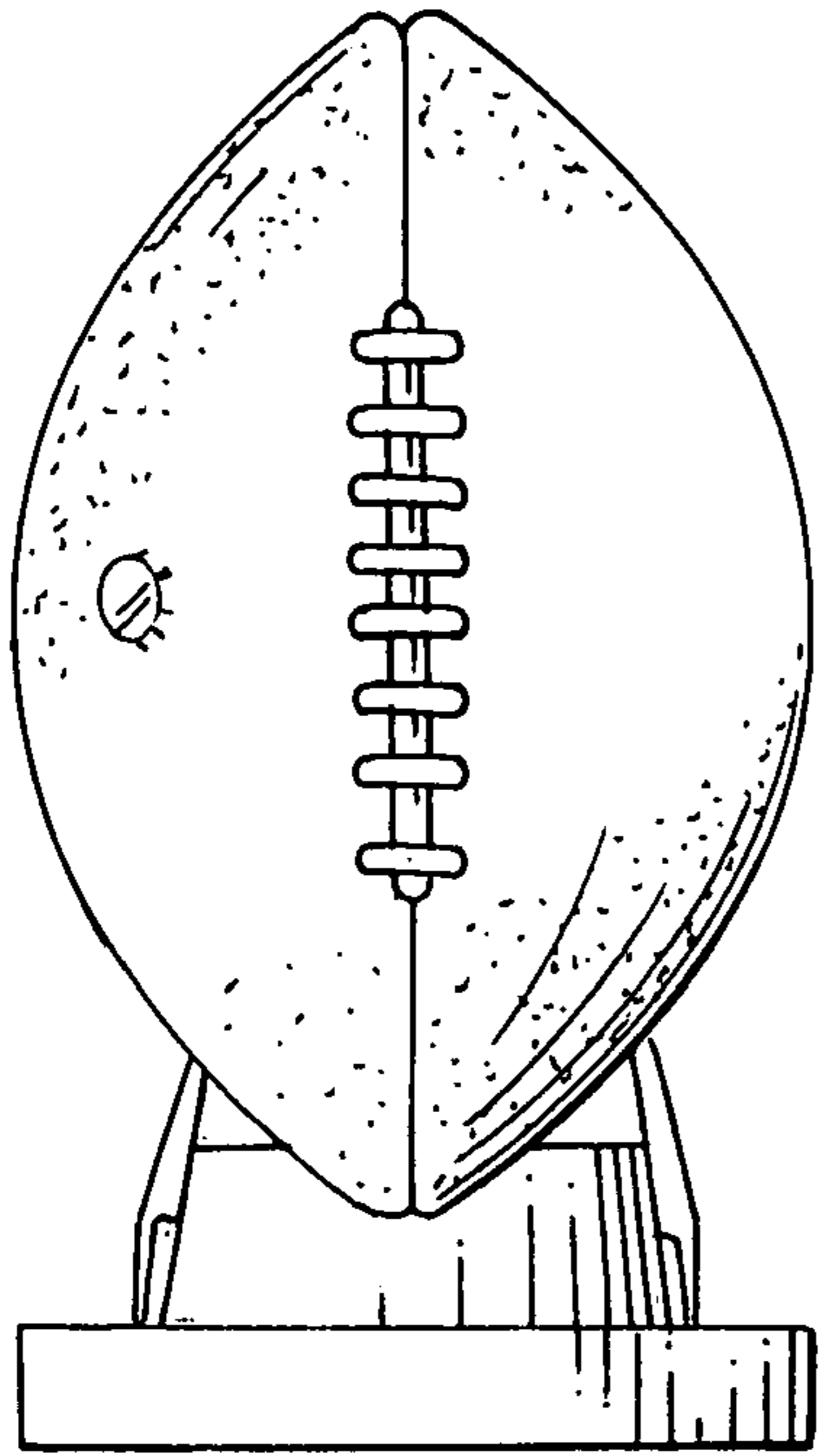

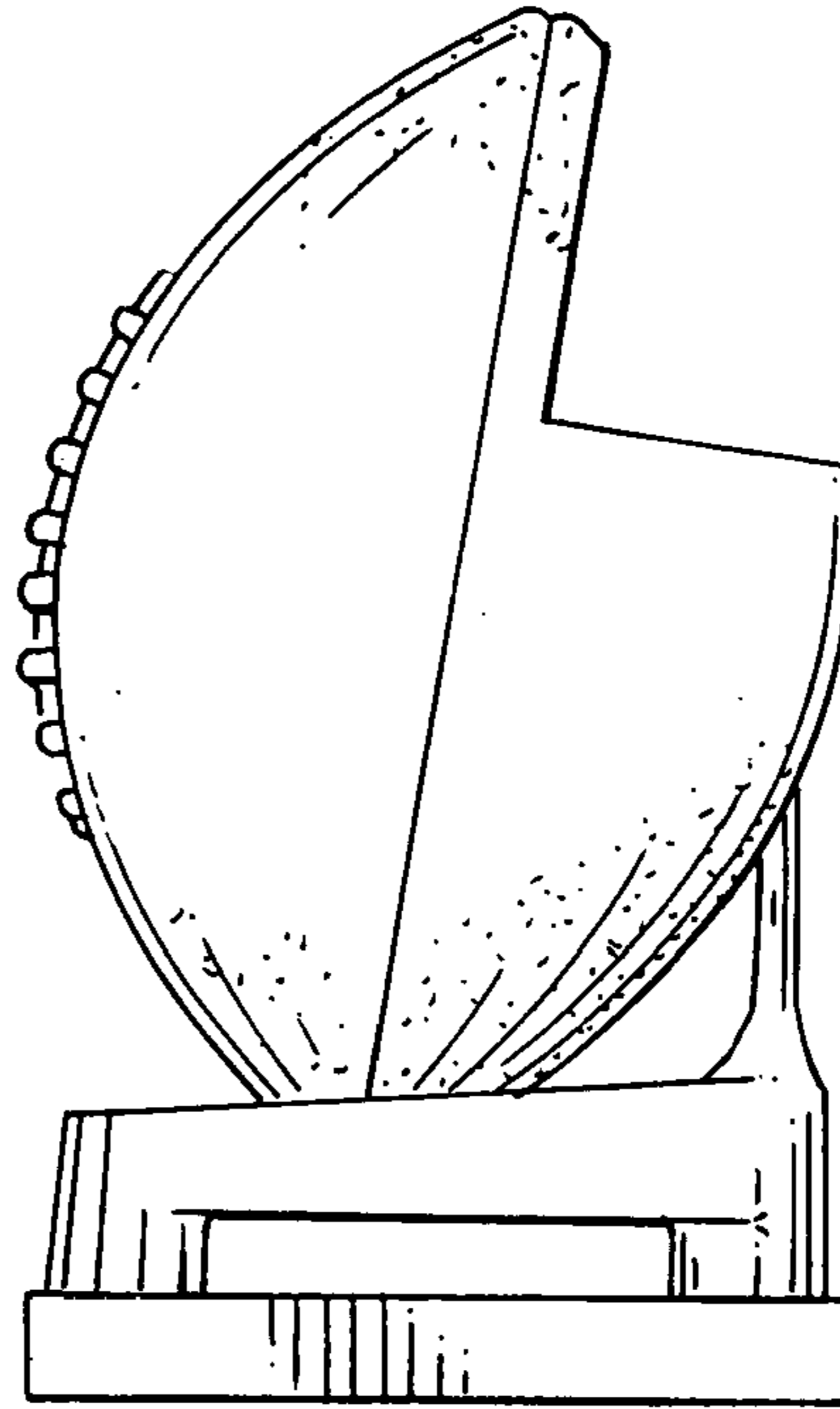

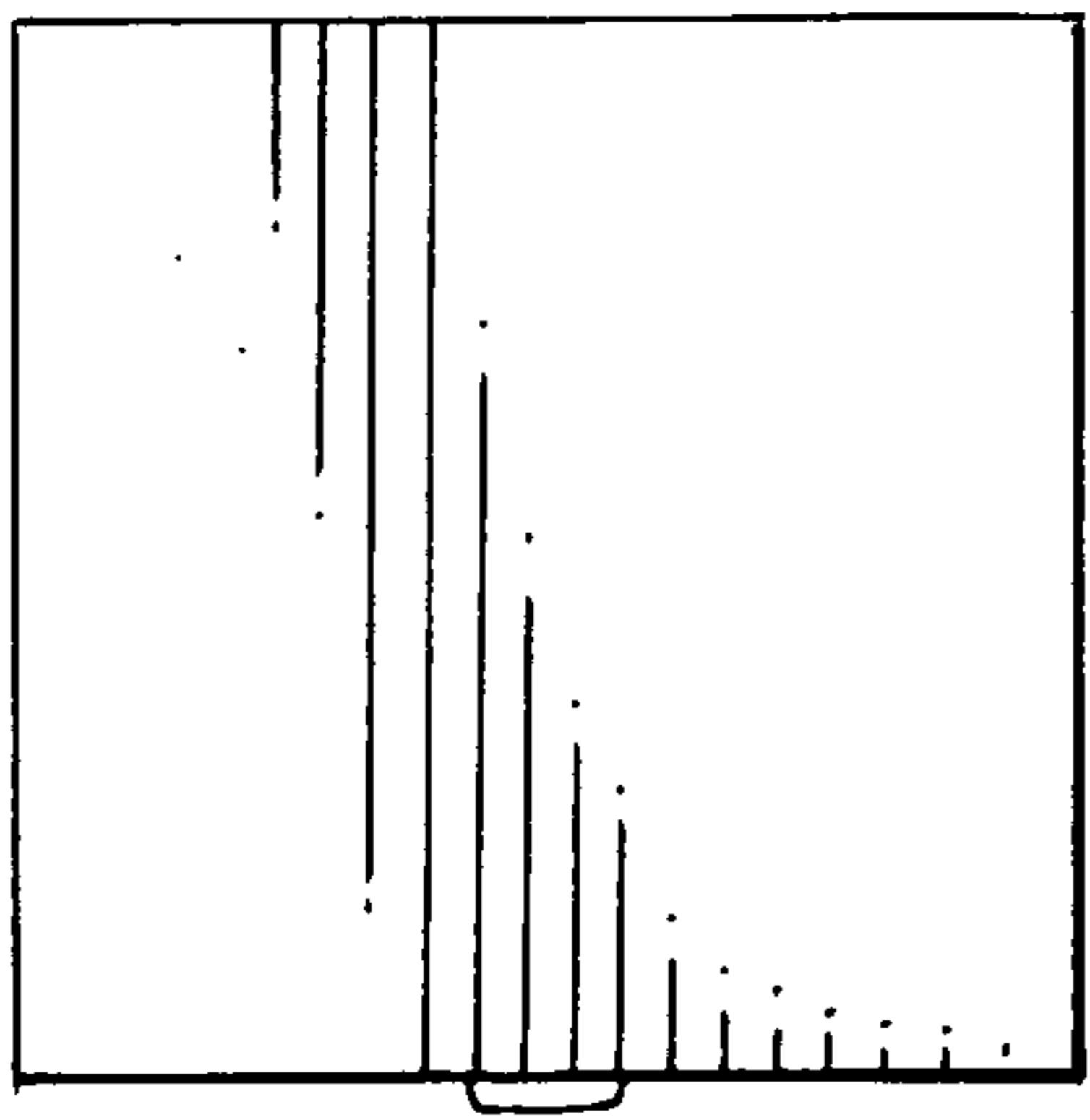

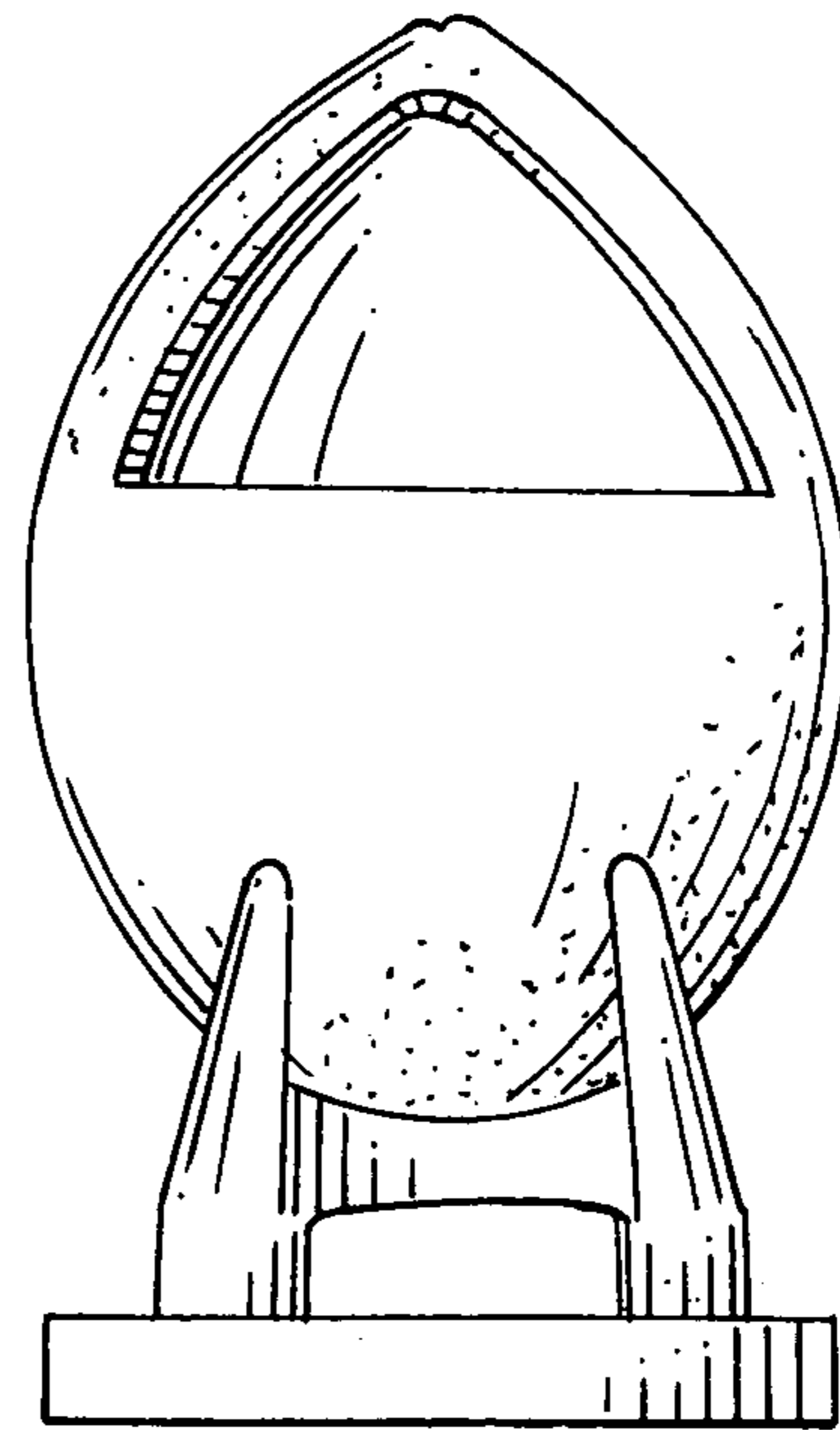

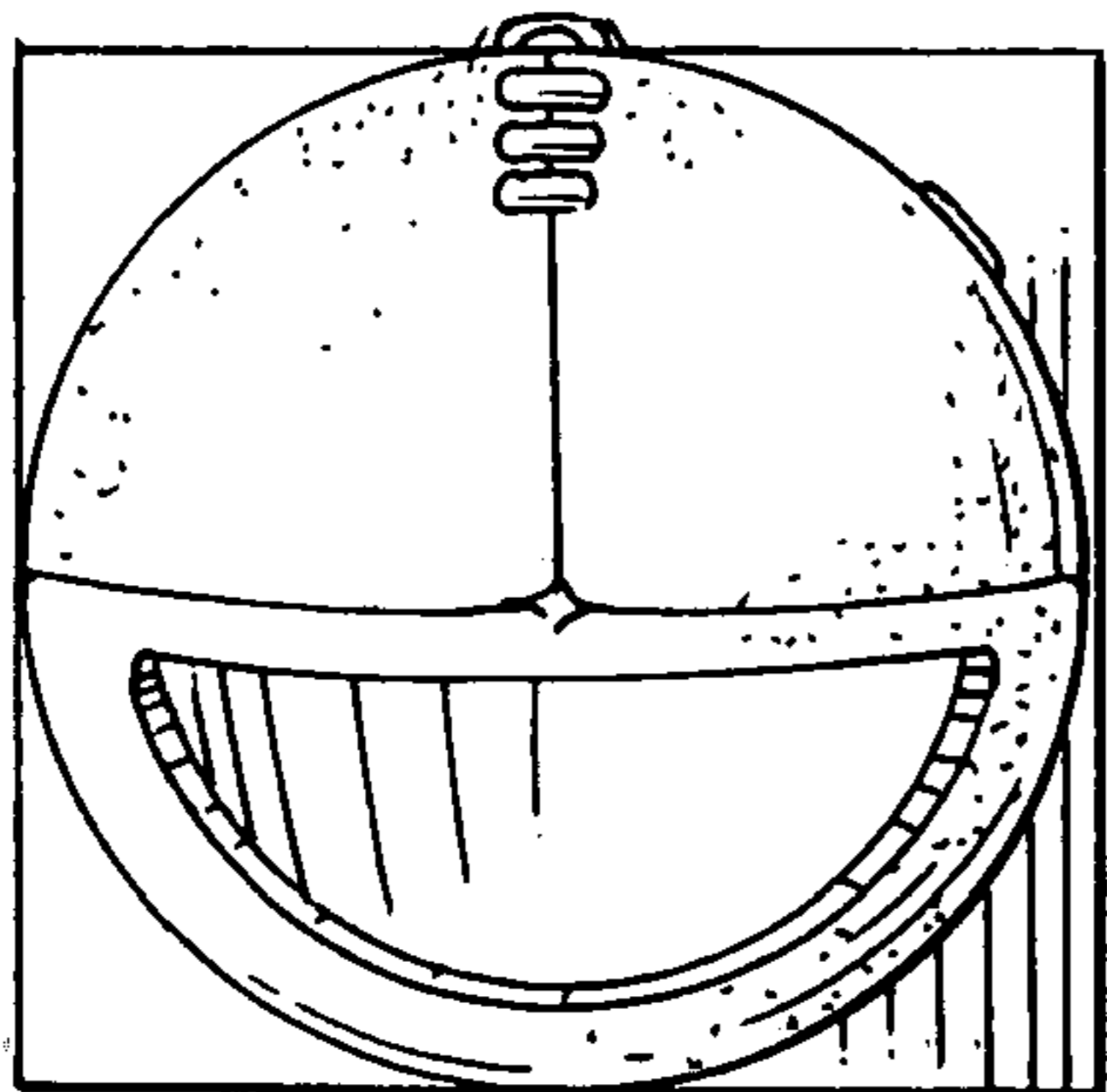
