**DESCRIPTION**

FIG. 8 is a right side view of FIG. 7;

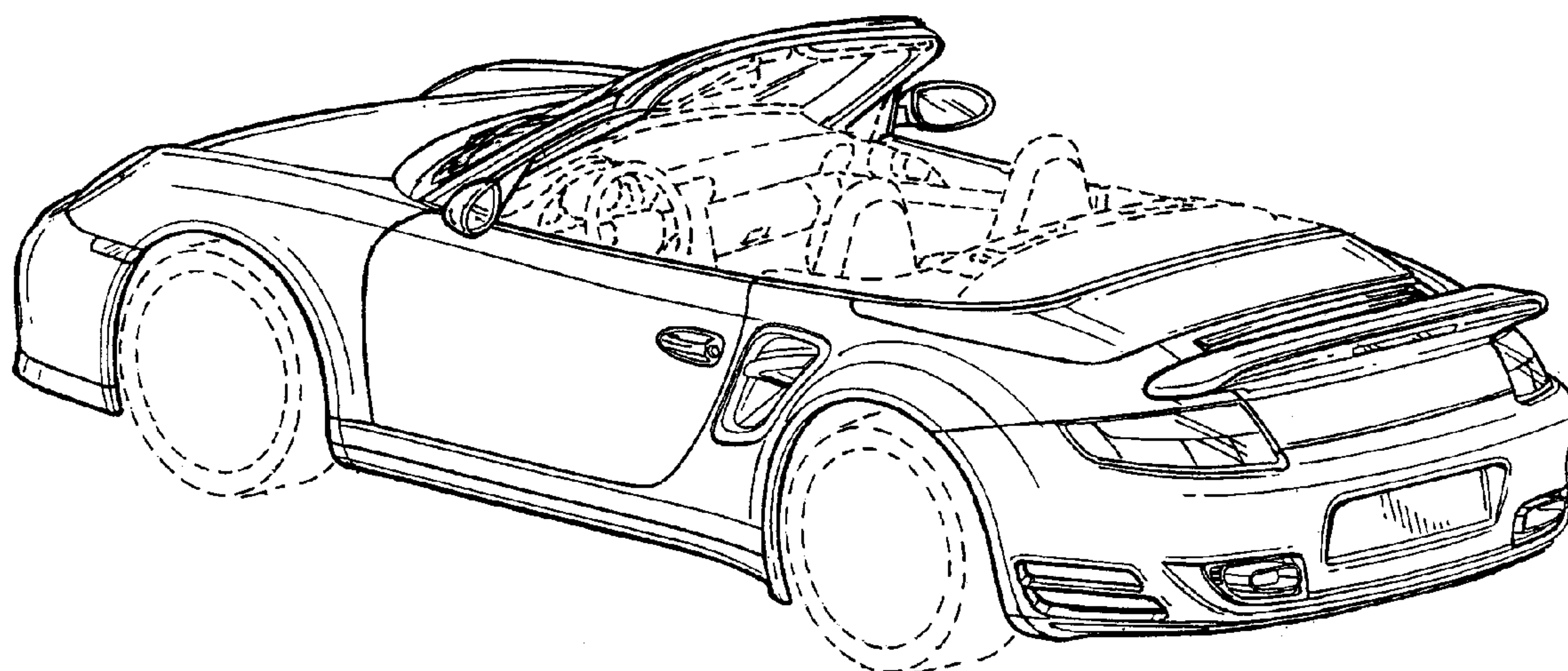
FIG. 9 is a front view of FIG. 7;

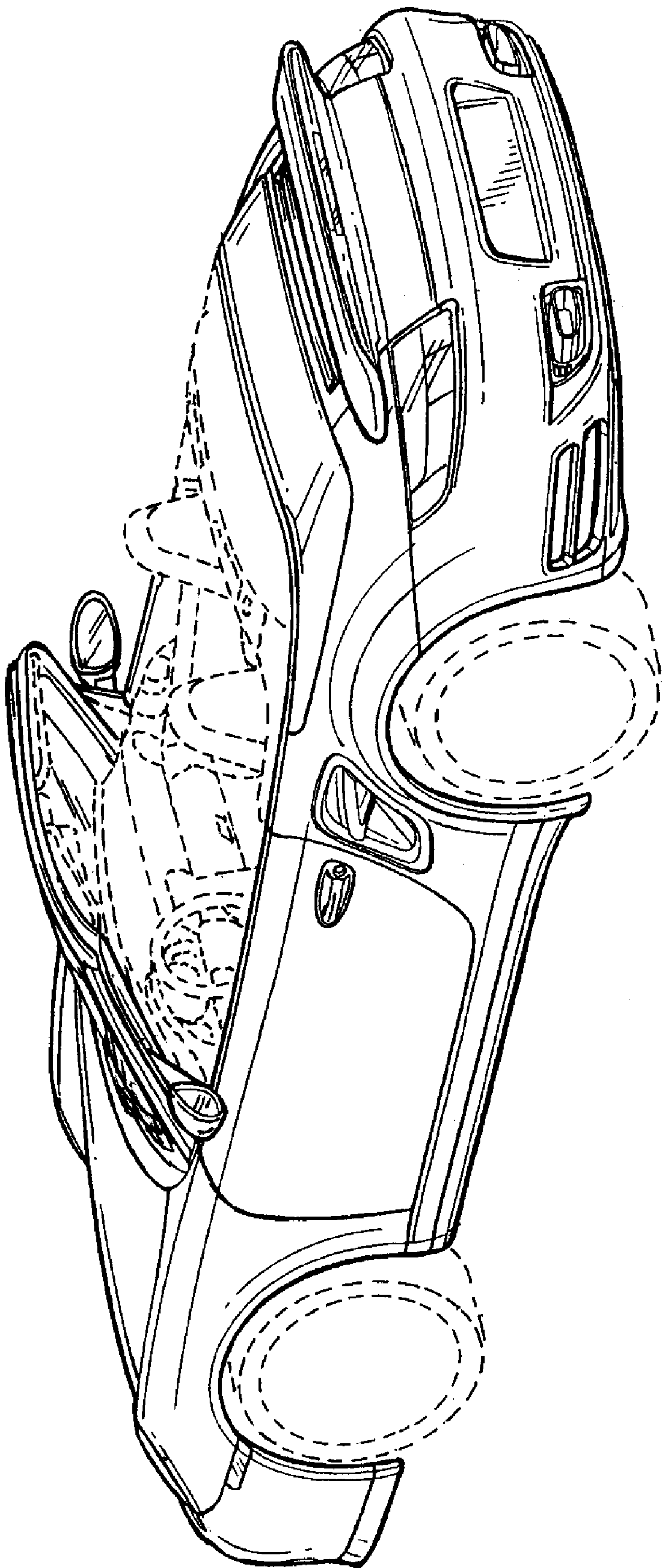

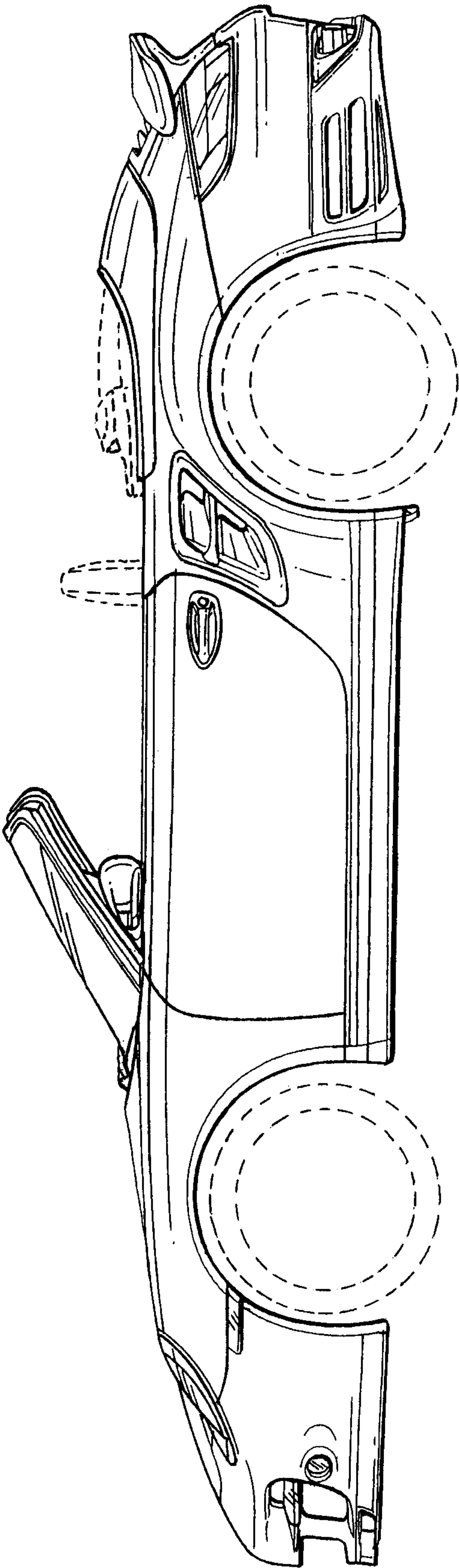

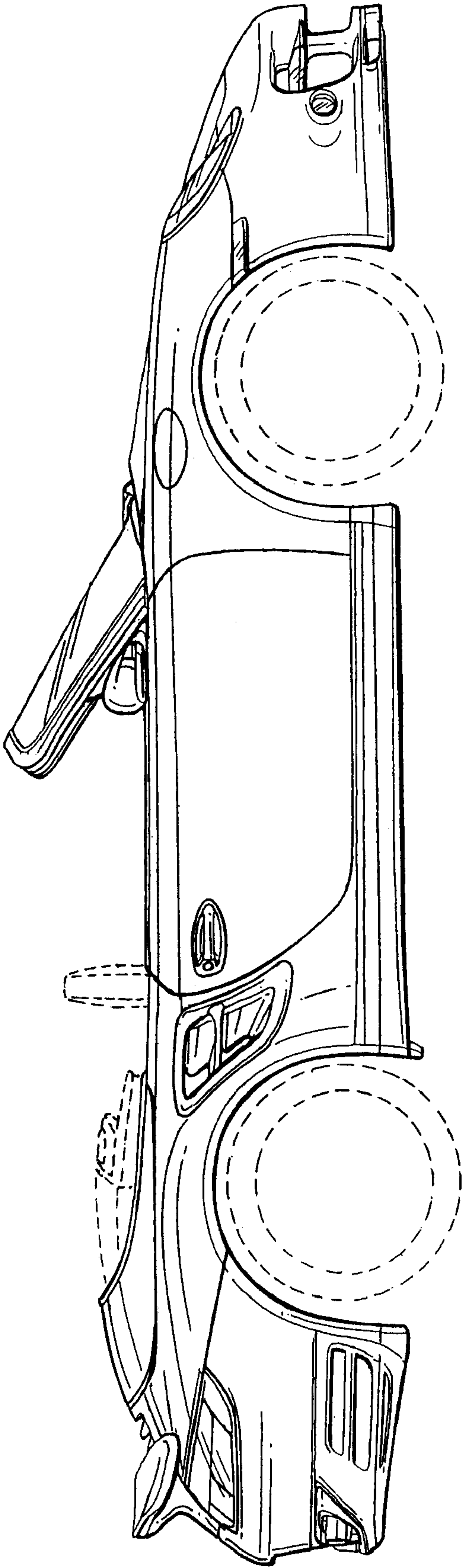

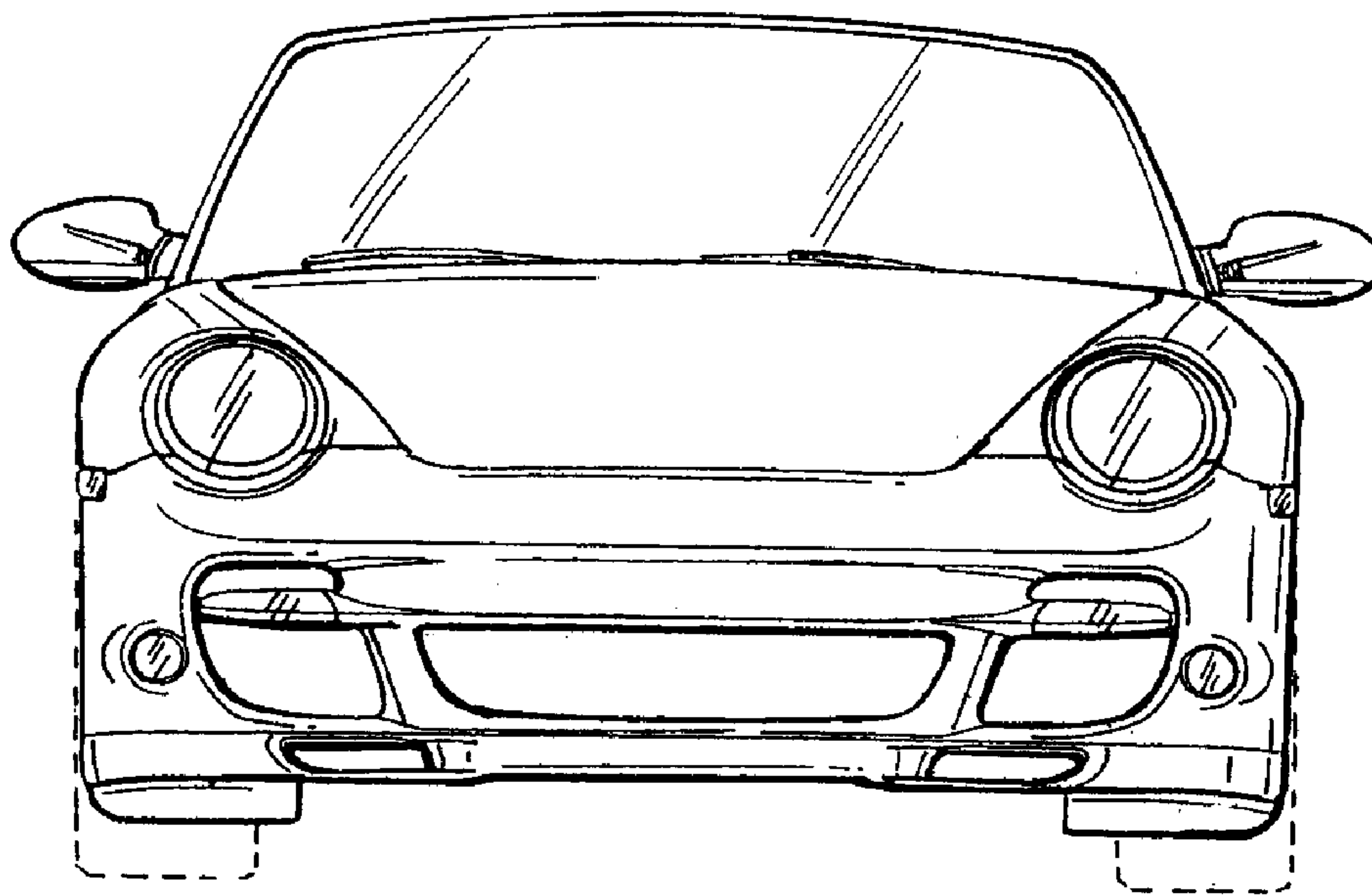

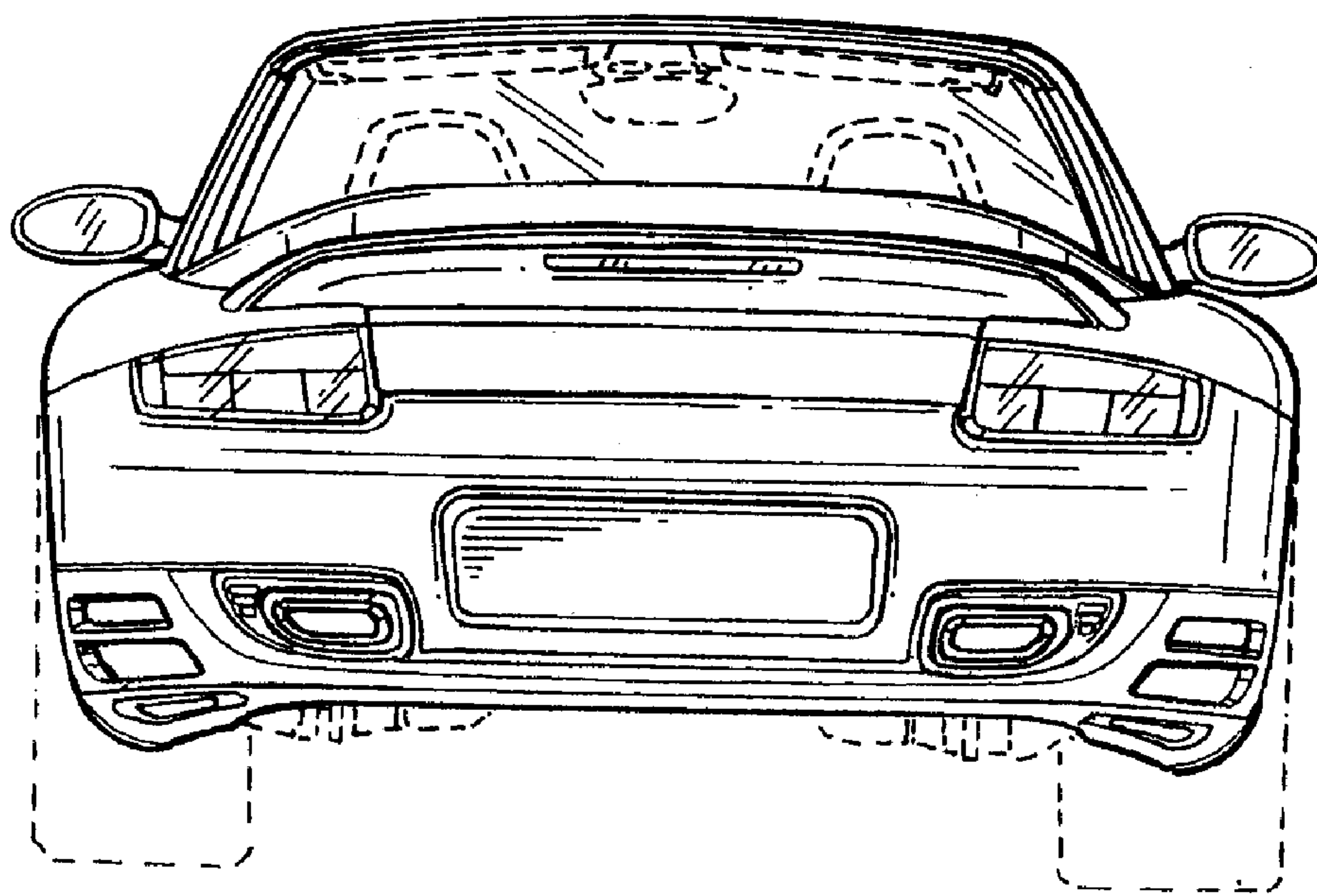

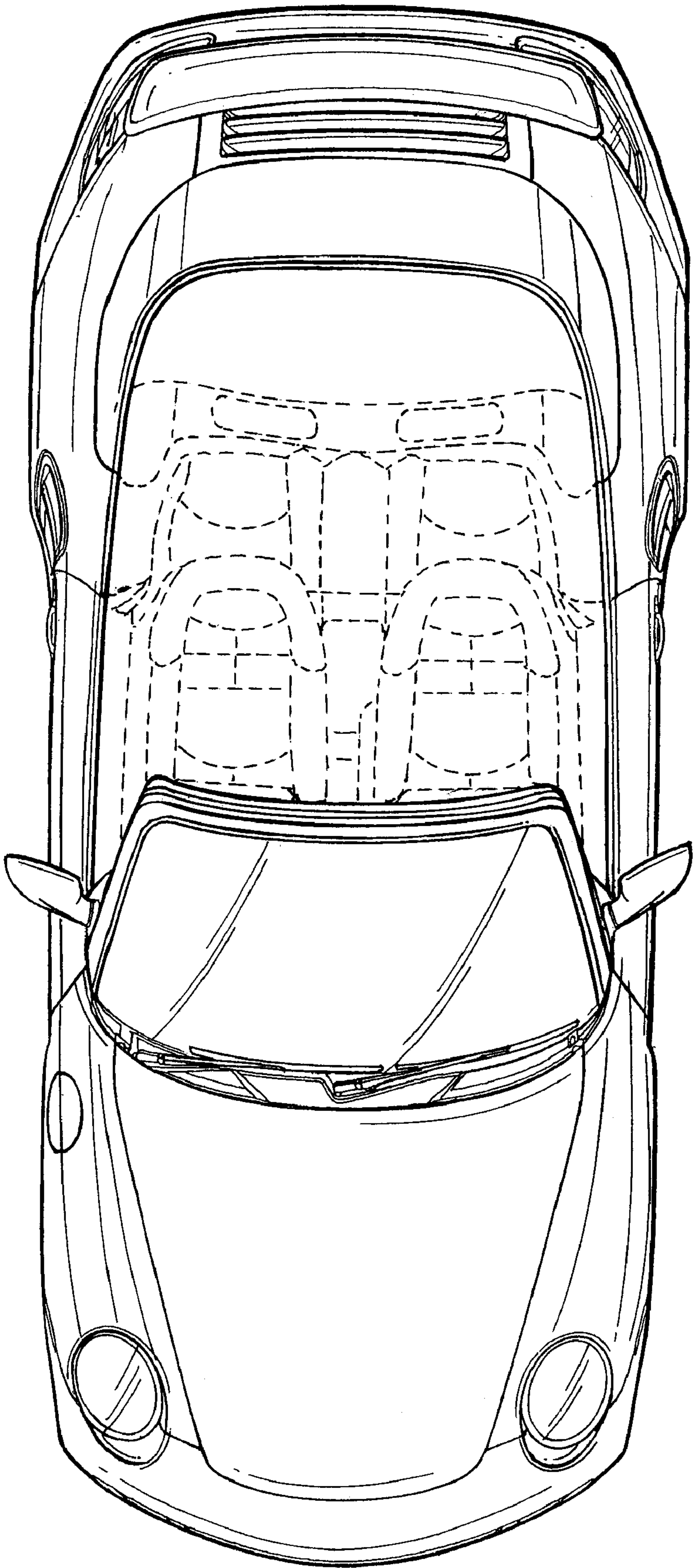

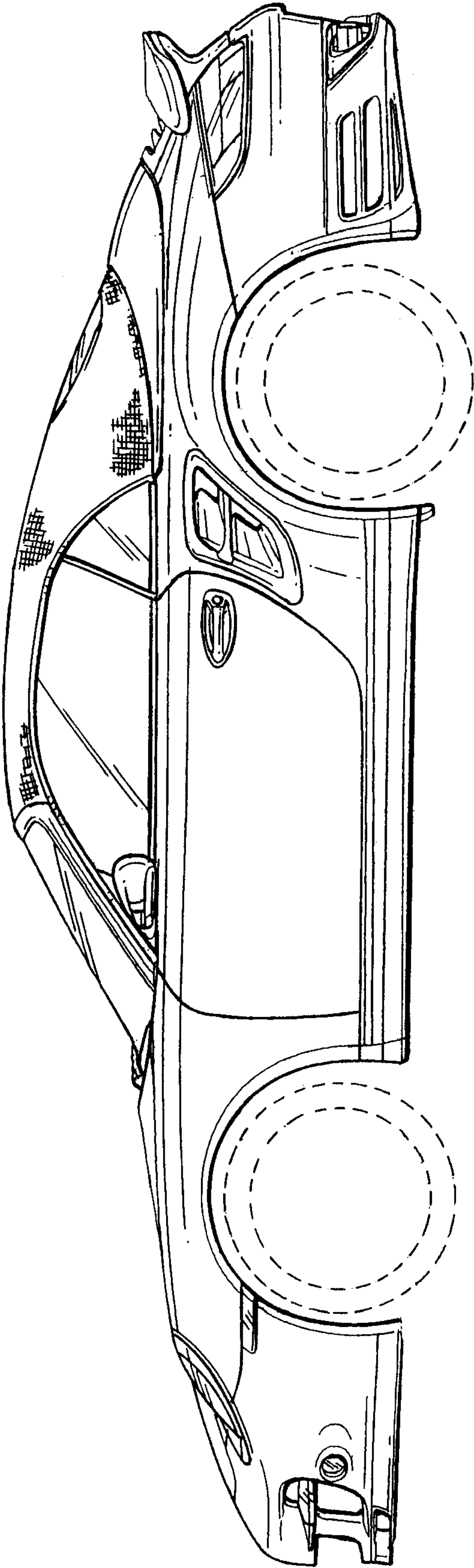

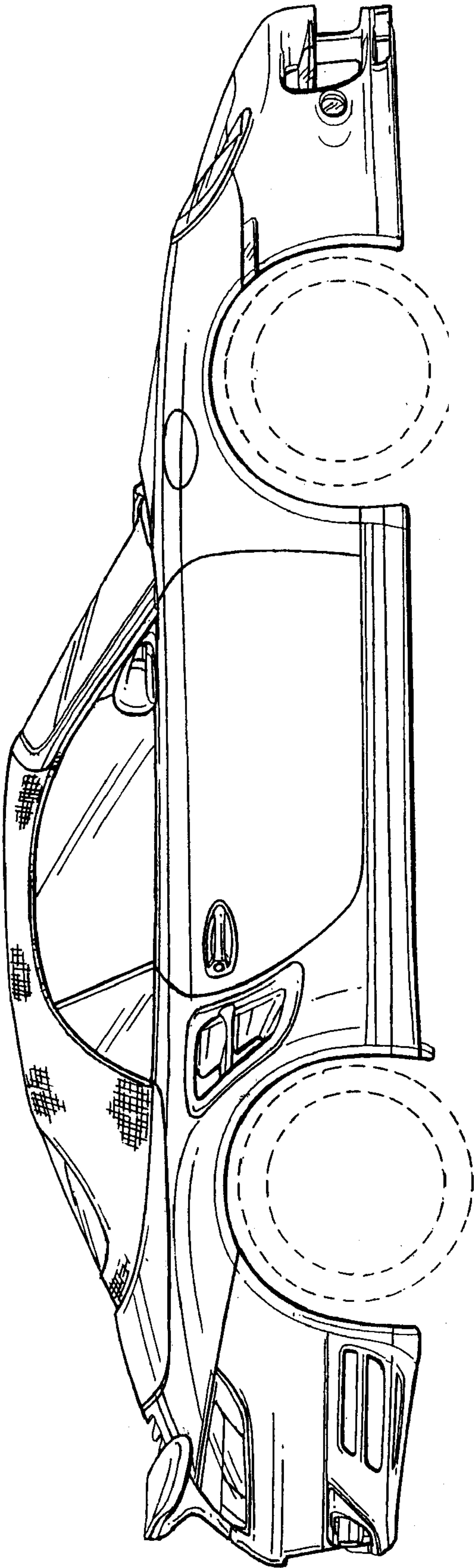

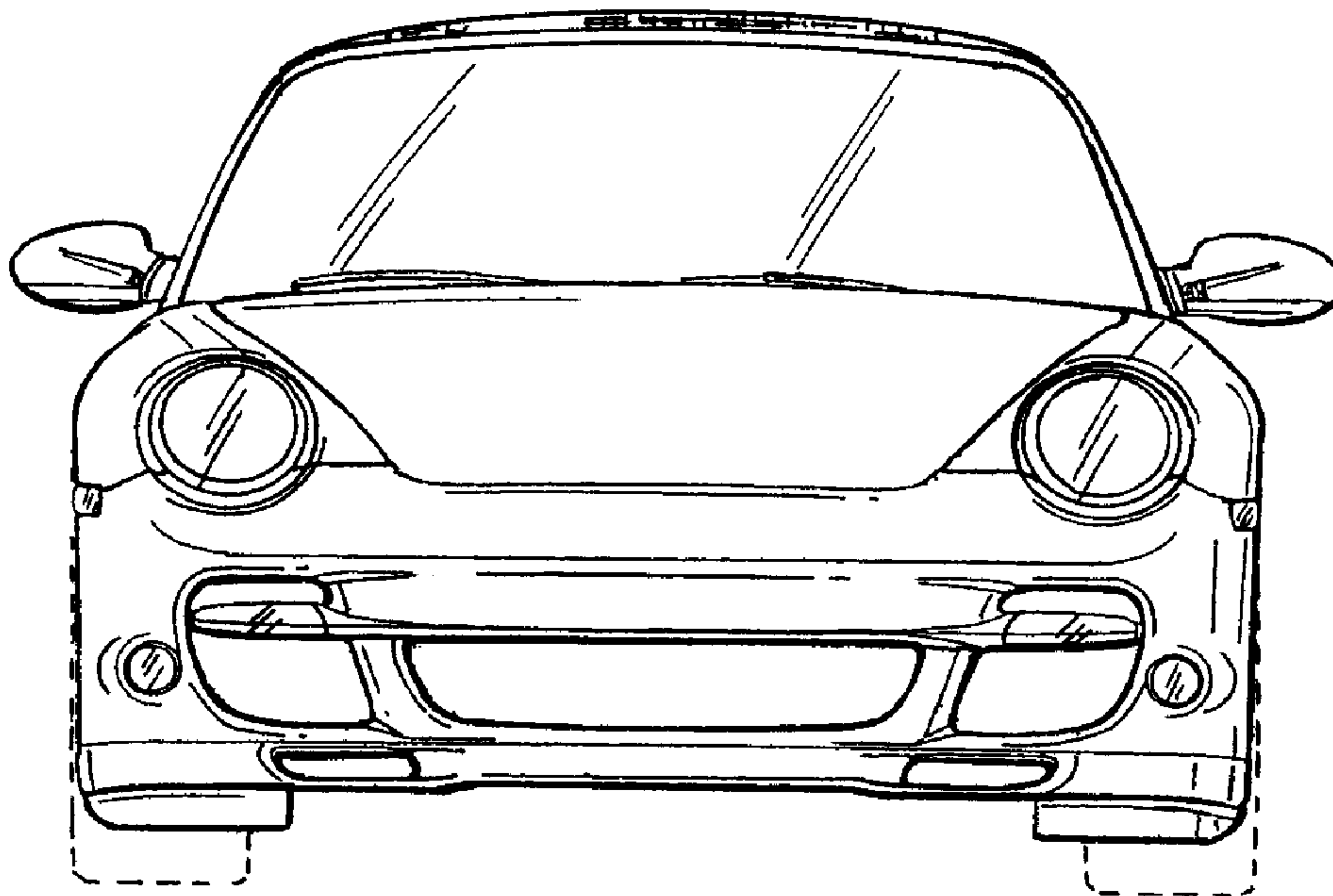

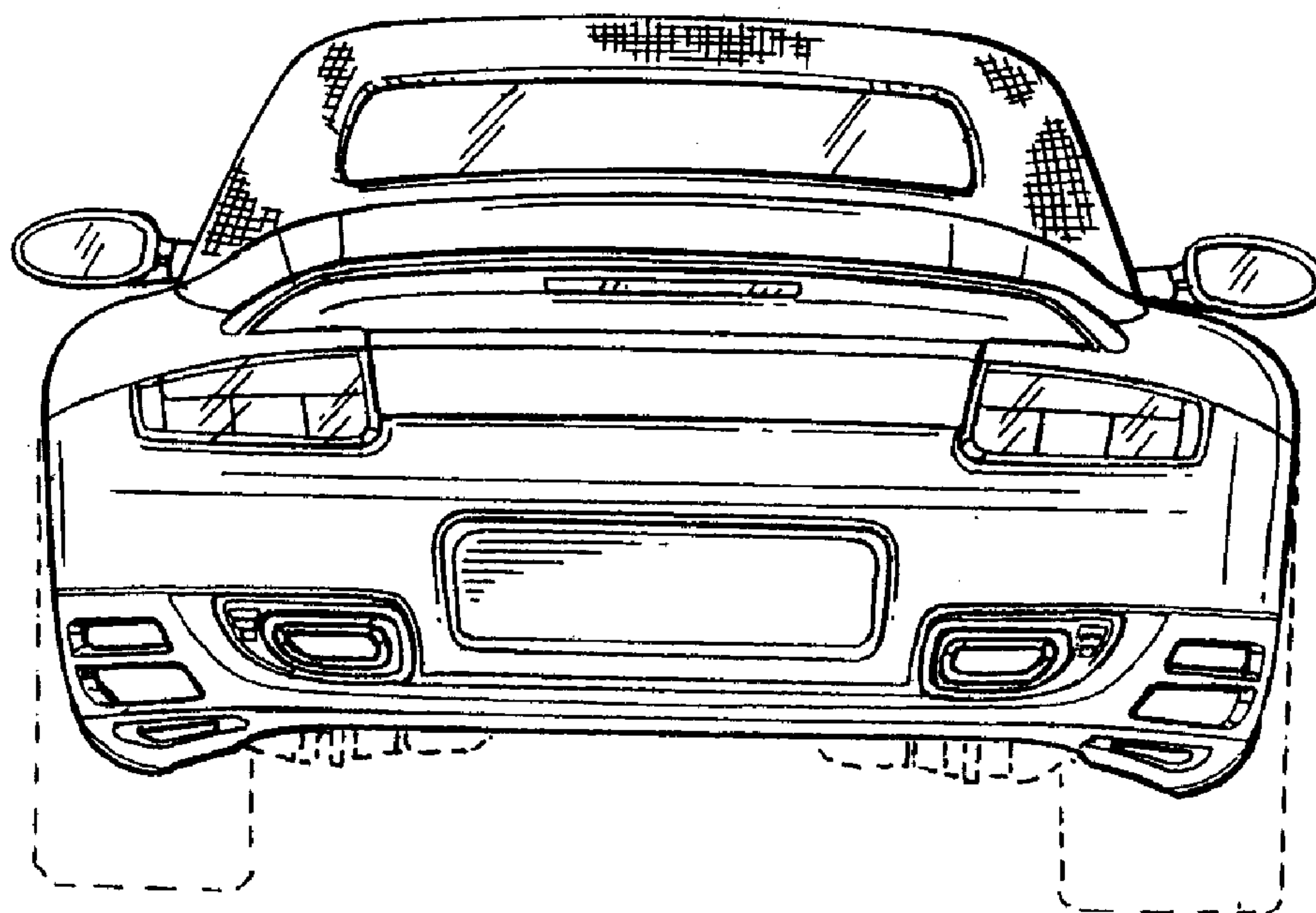

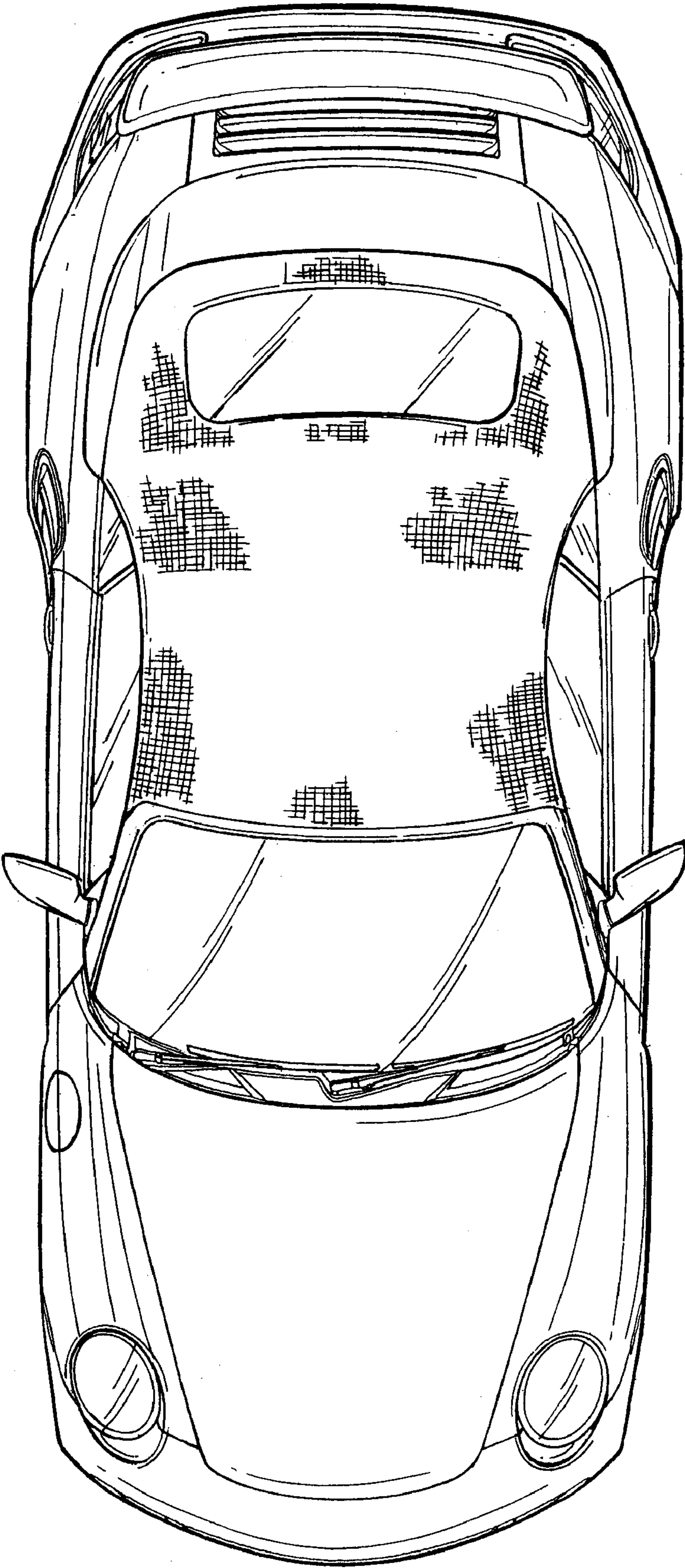
