DESCRIPTION

FIG. 1 is a top, front and right side perspective view of an embodiment of a portable media player in accordance with the present design;

FIG. 4 is a left side elevational view of the portable media player of FIG. 1;

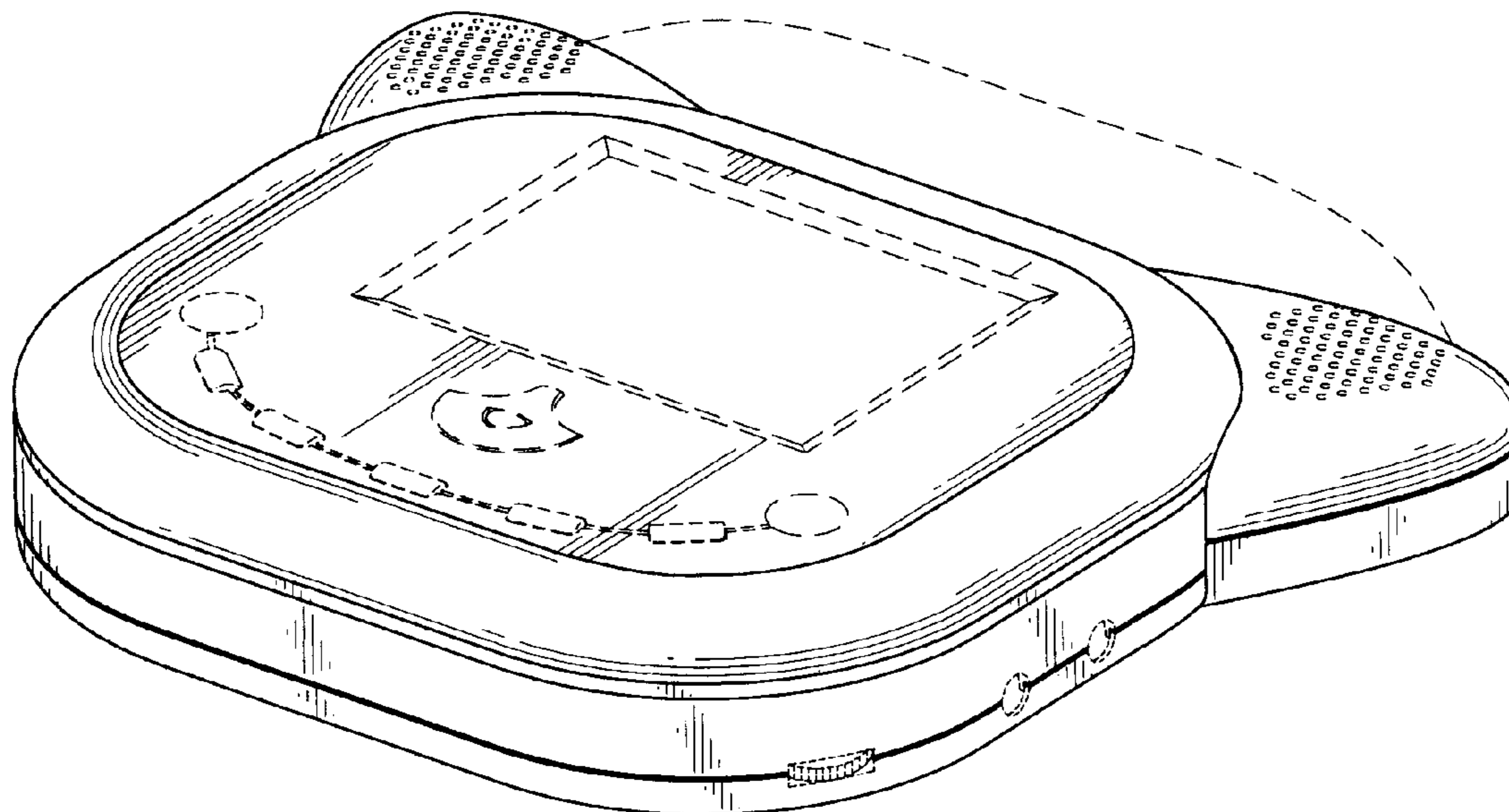
FIG. 5 is a right side elevational view of the portable media player of FIG. 1;

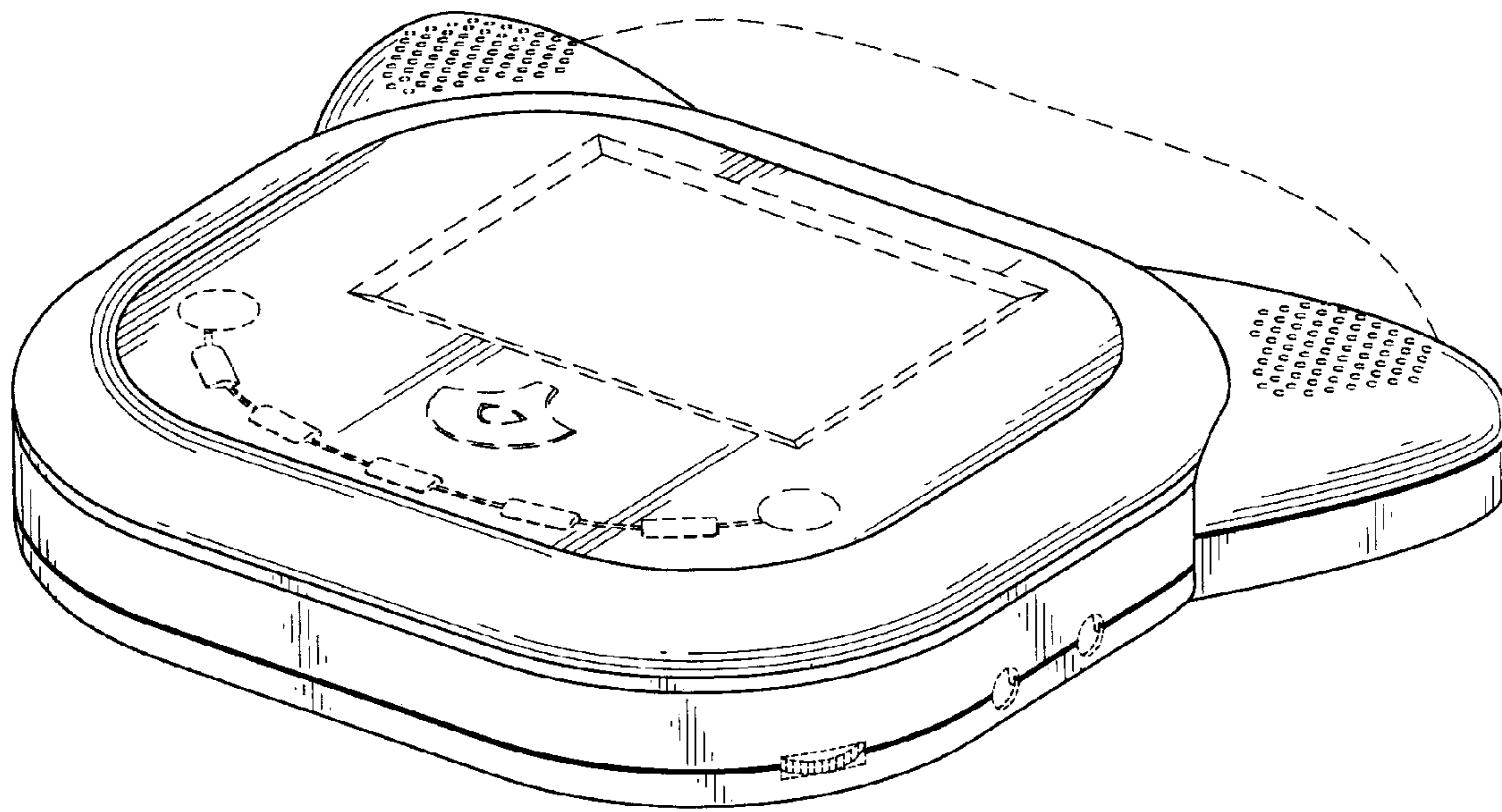

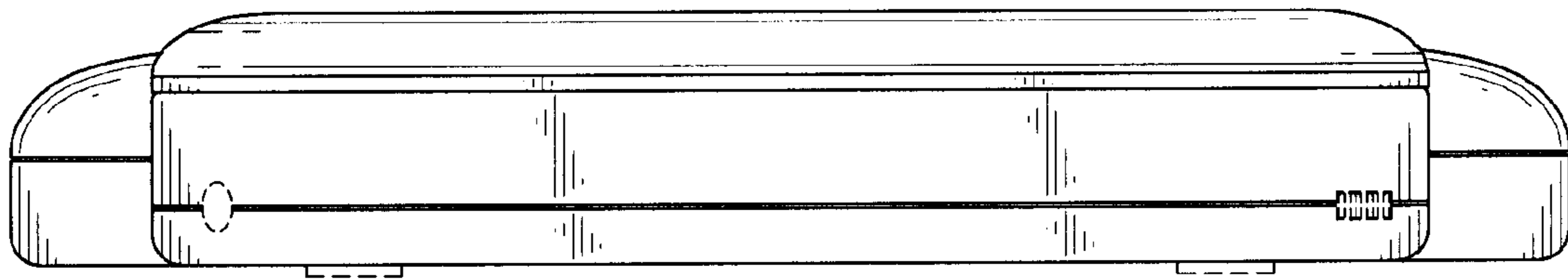

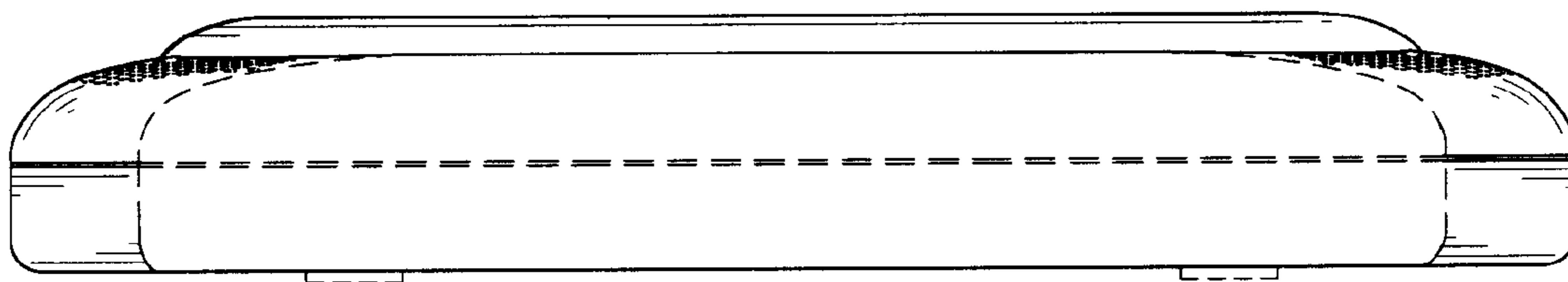

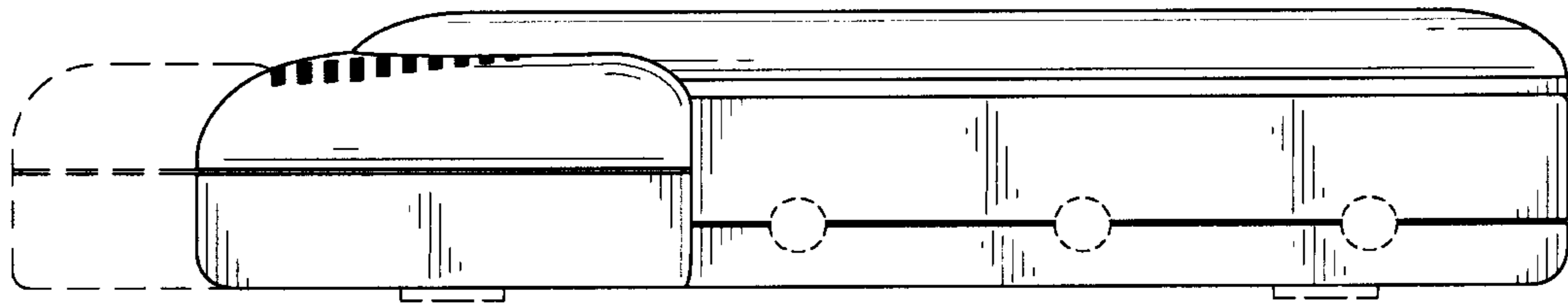

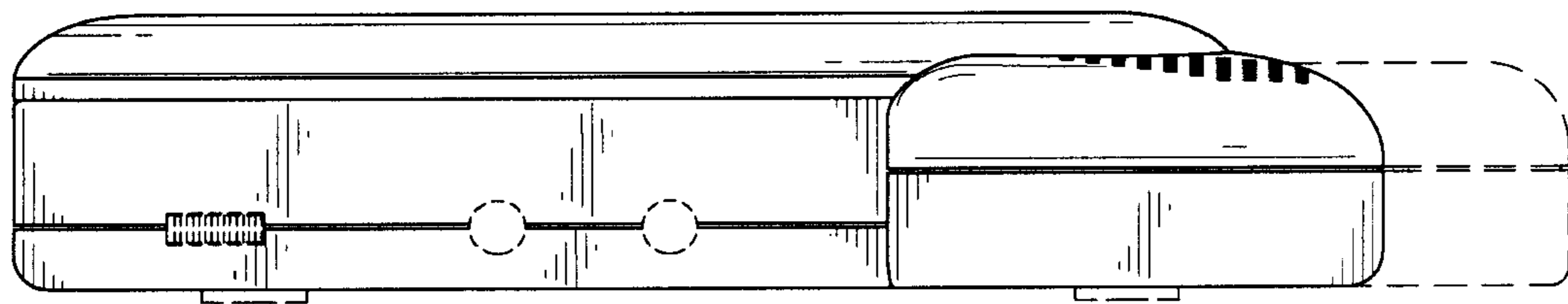

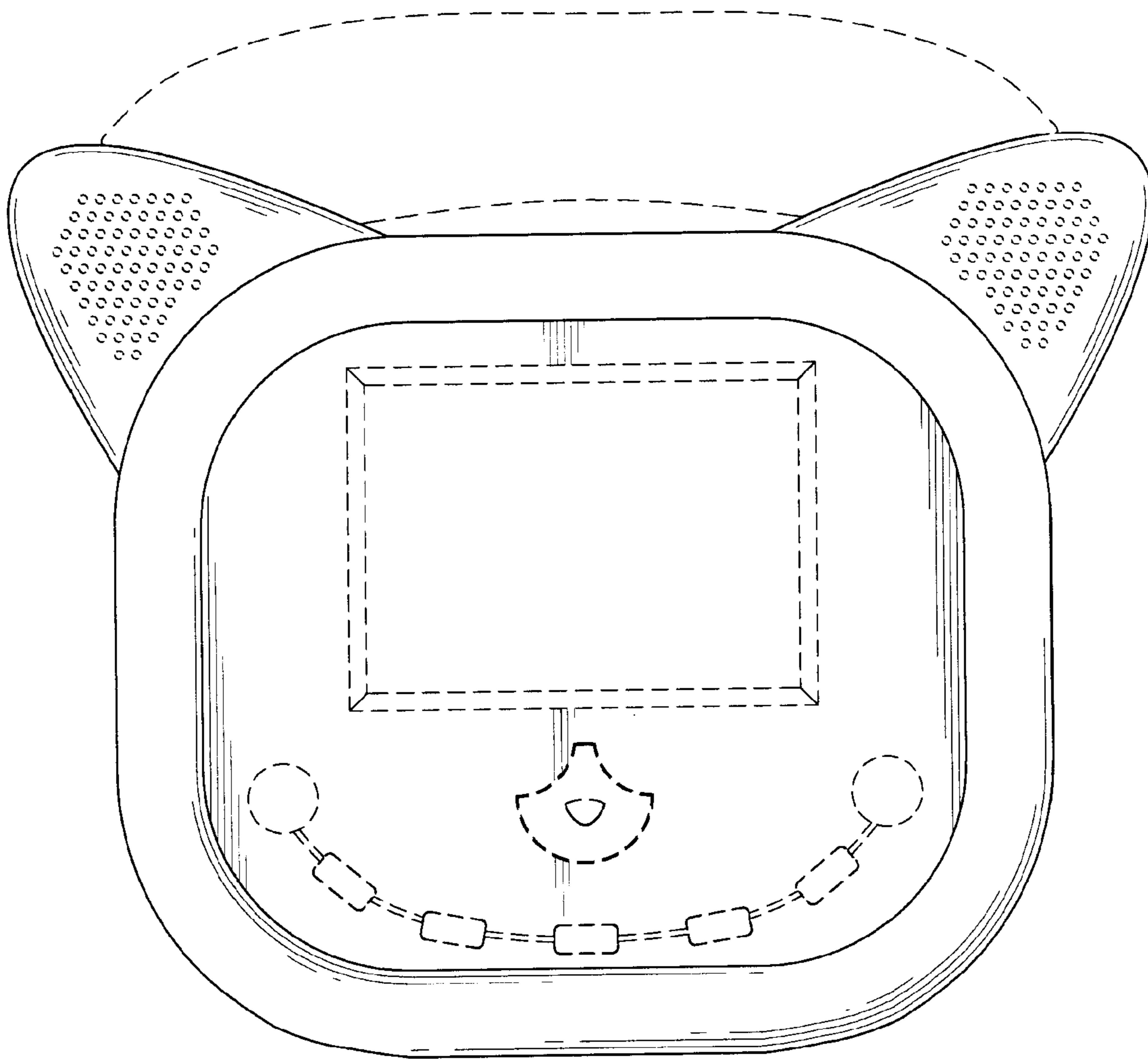

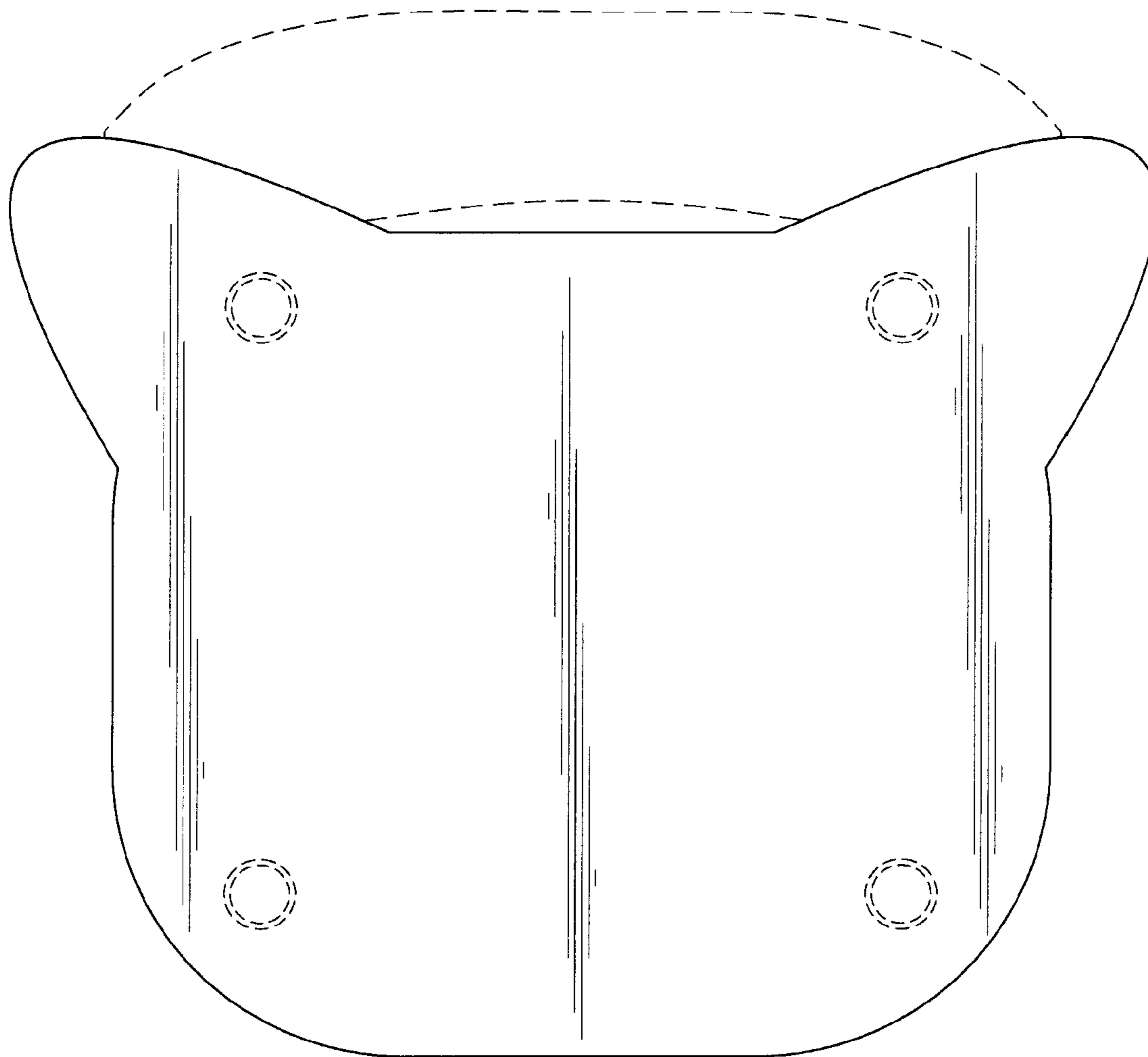
