(57) **CLAIM**

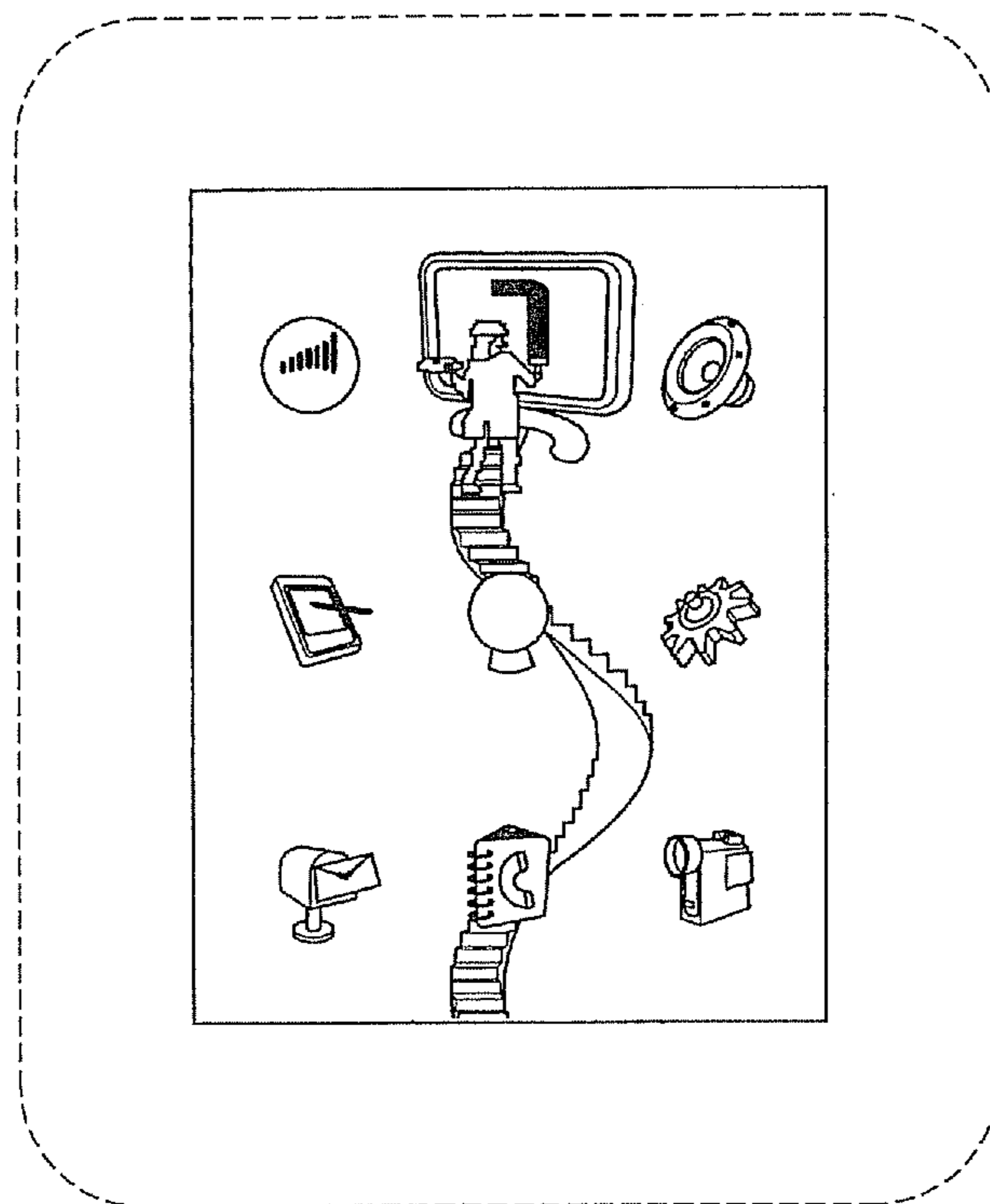
We claim, the ornamental design for a set of icons for display screen, as shown and described.
