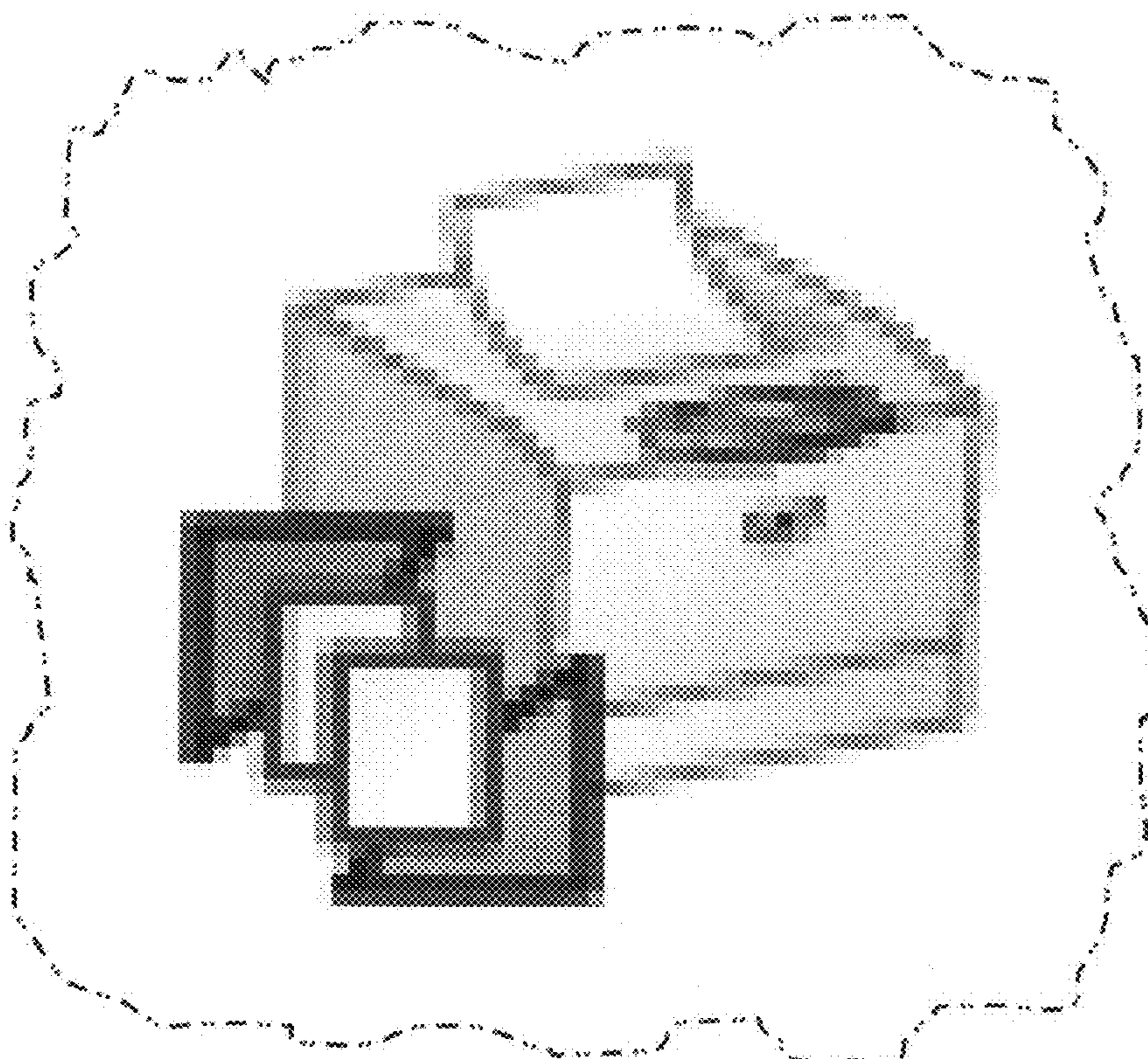
The ornamental design for an resource management application icon for a display screen, as shown and described.

**DESCRIPTION**

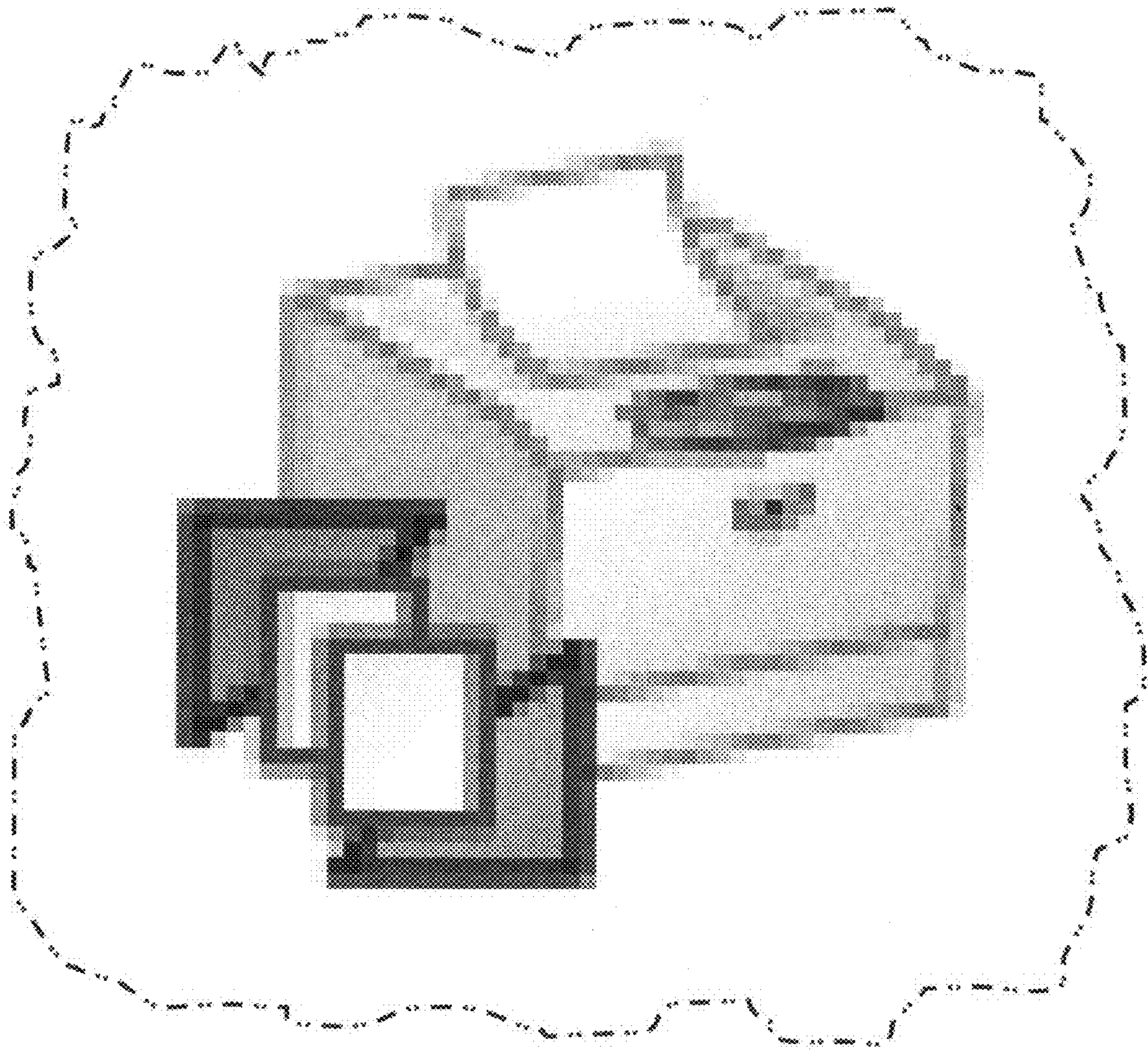
The FIGURE is a front view of the resource management application icon for a display screen showing the design in accordance with the present invention.
