The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is an orthographic bottom plan view of a portion of a golf club head, embodying the inventive design.

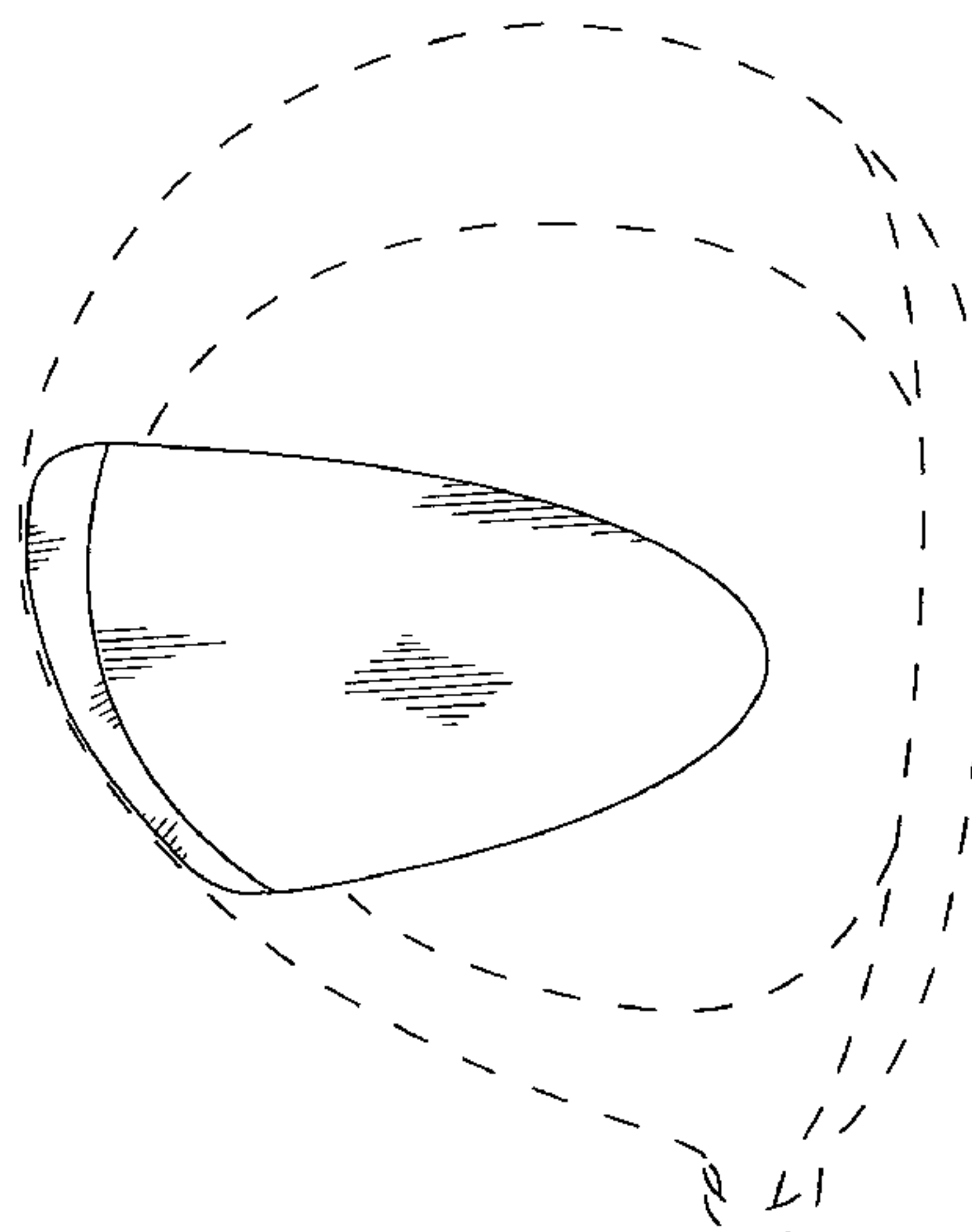
FIG. 2 is a bottom perspective view thereof.

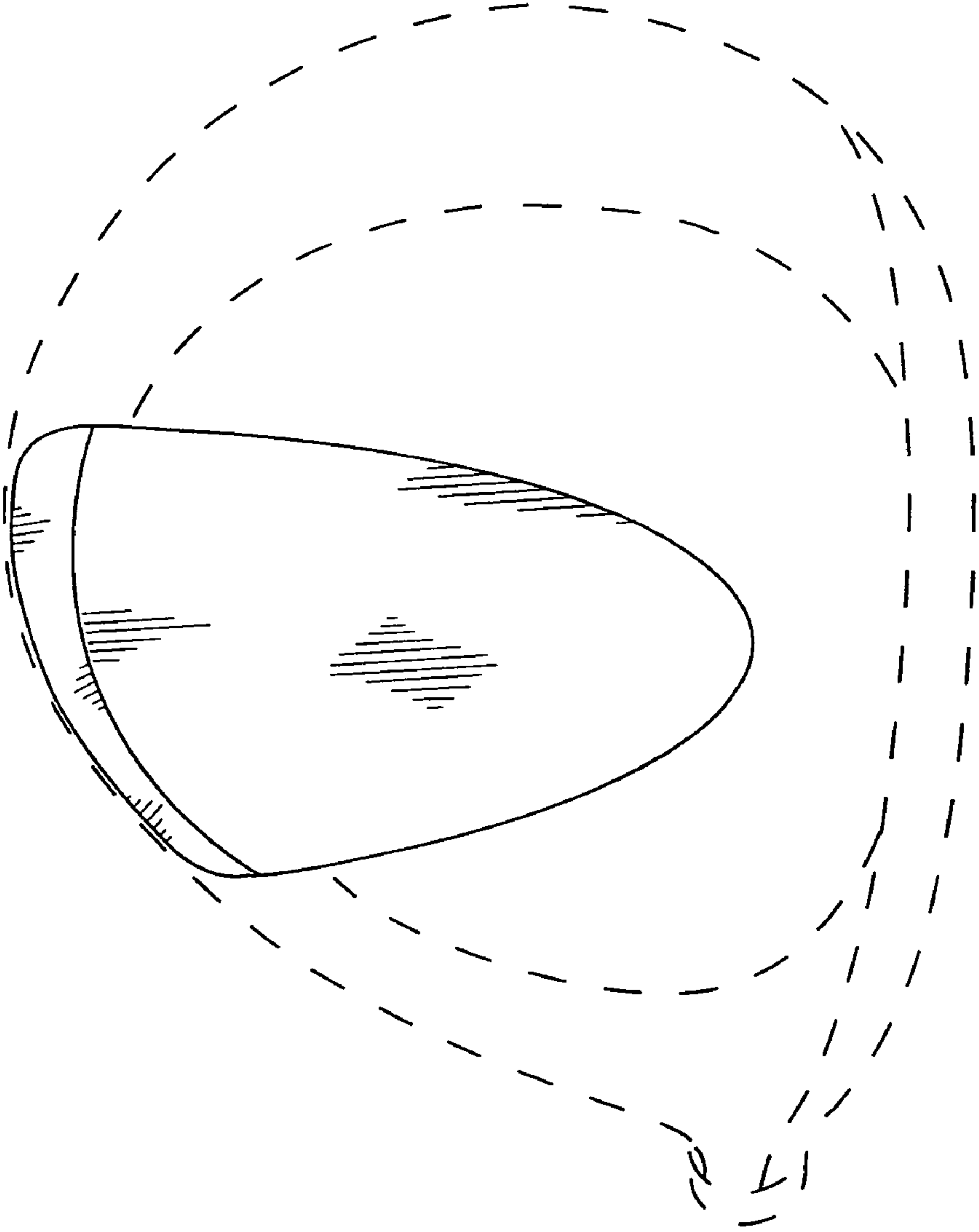

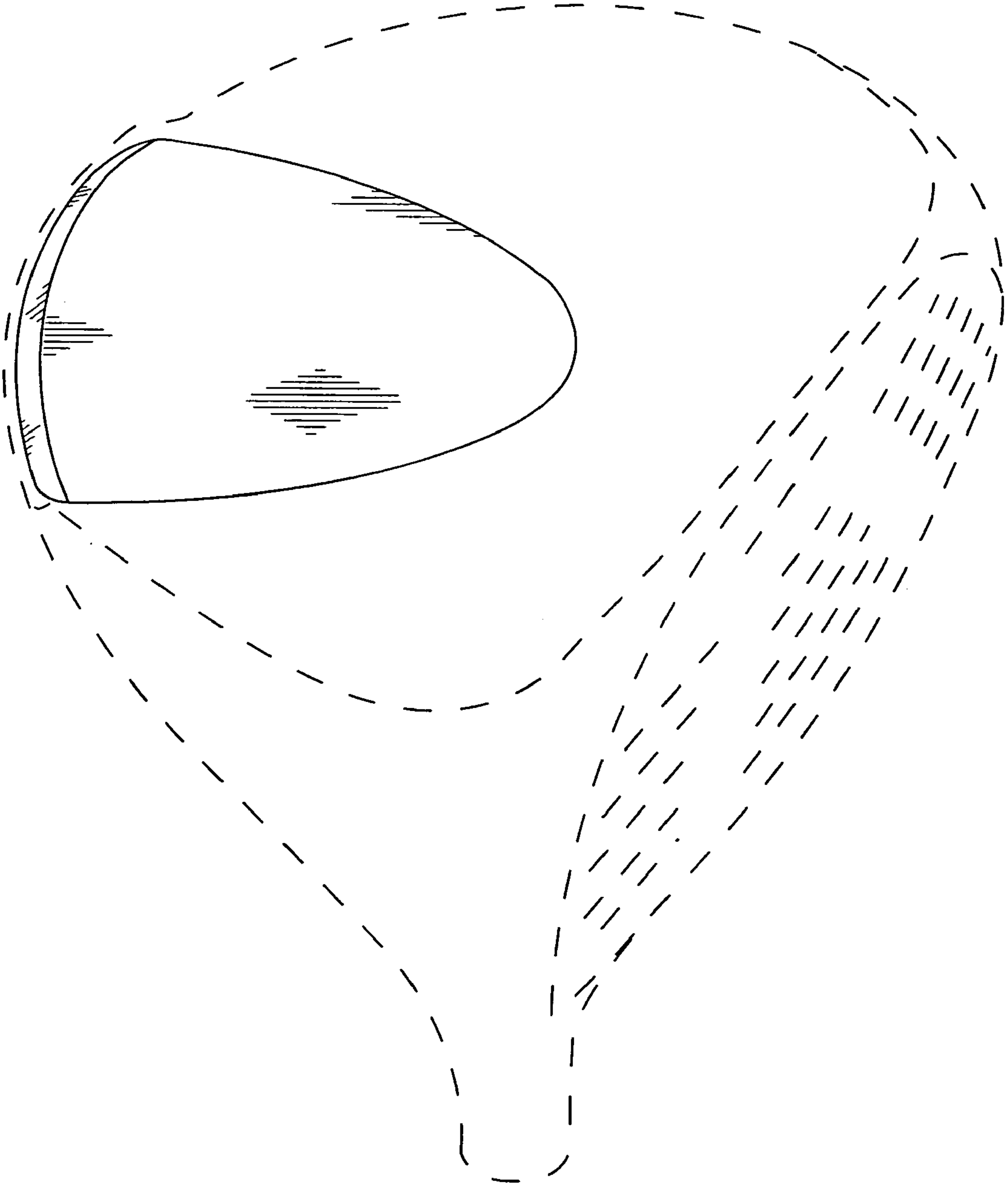

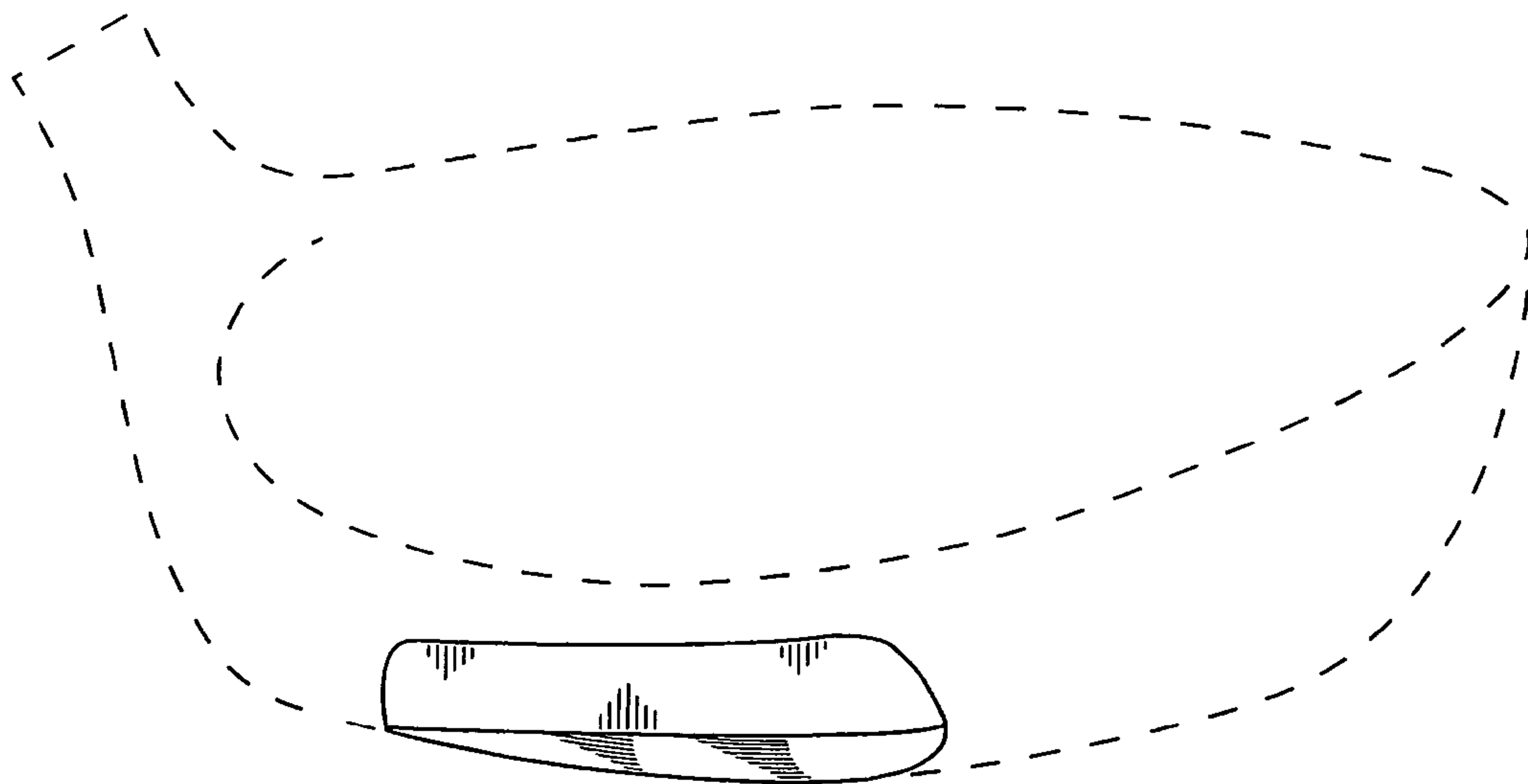

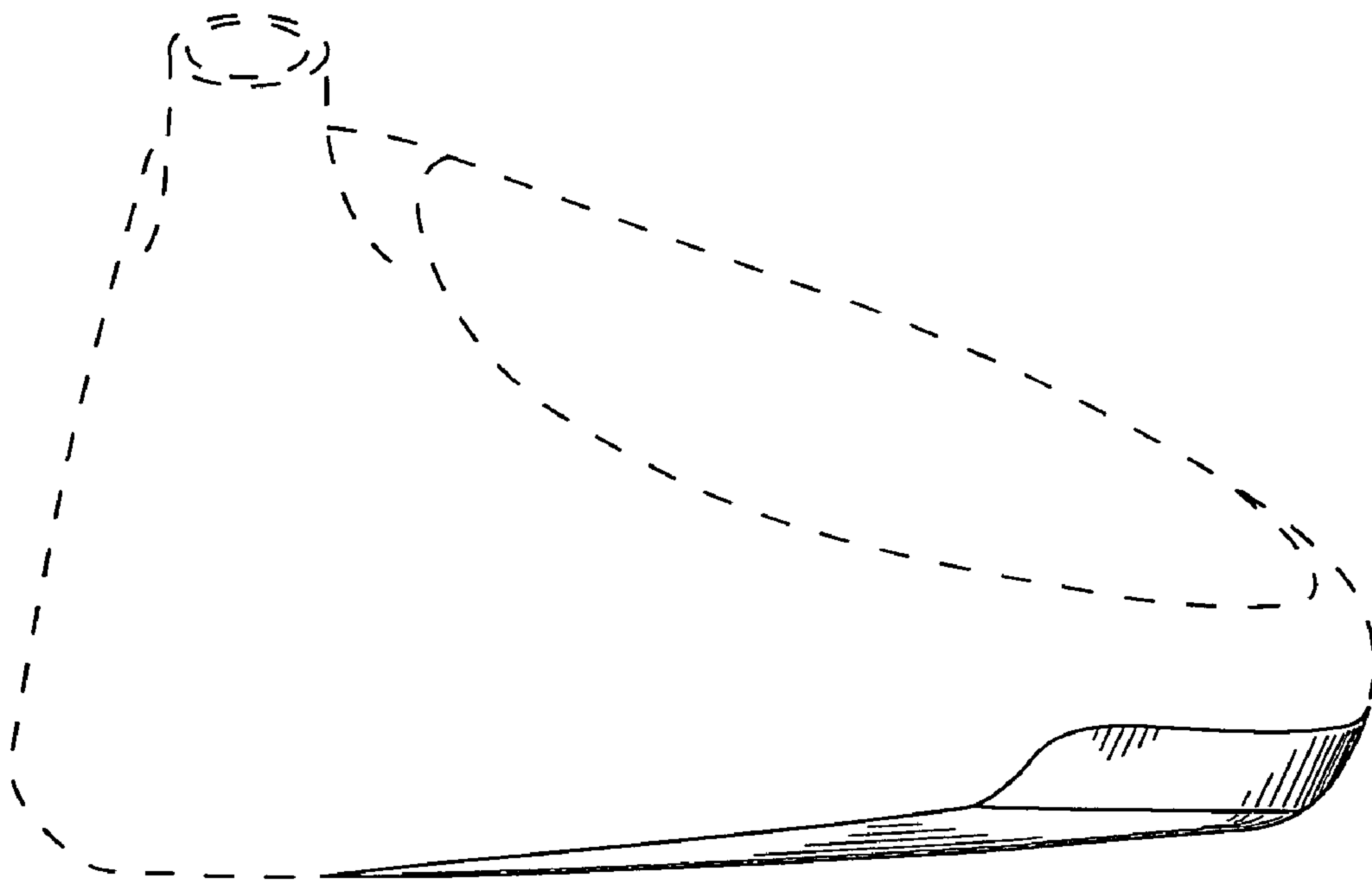
