(57) CLAIM

The ornamental design for a wall mounted medical device holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a wall mounted medical device holder embodying our new design with screw holes and a surface feature represented in dotted lines for illustrative purposes;

FIG. 2 is a right side view of the wall mounted medical device holder showing in FIG. 1;

FIG. 3 is a left side view of the wall mounted medical device holder;

FIG. 4 is a front view thereof with additional surface features dotted for illustrative purposes;


FIG. 5 is a back view thereof with additional surface features dotted for illustrative purposes;


FIG. 6 is a top view thereof; and,









