FIG. 2 is front view of the baby bottle shown in FIG. 1;

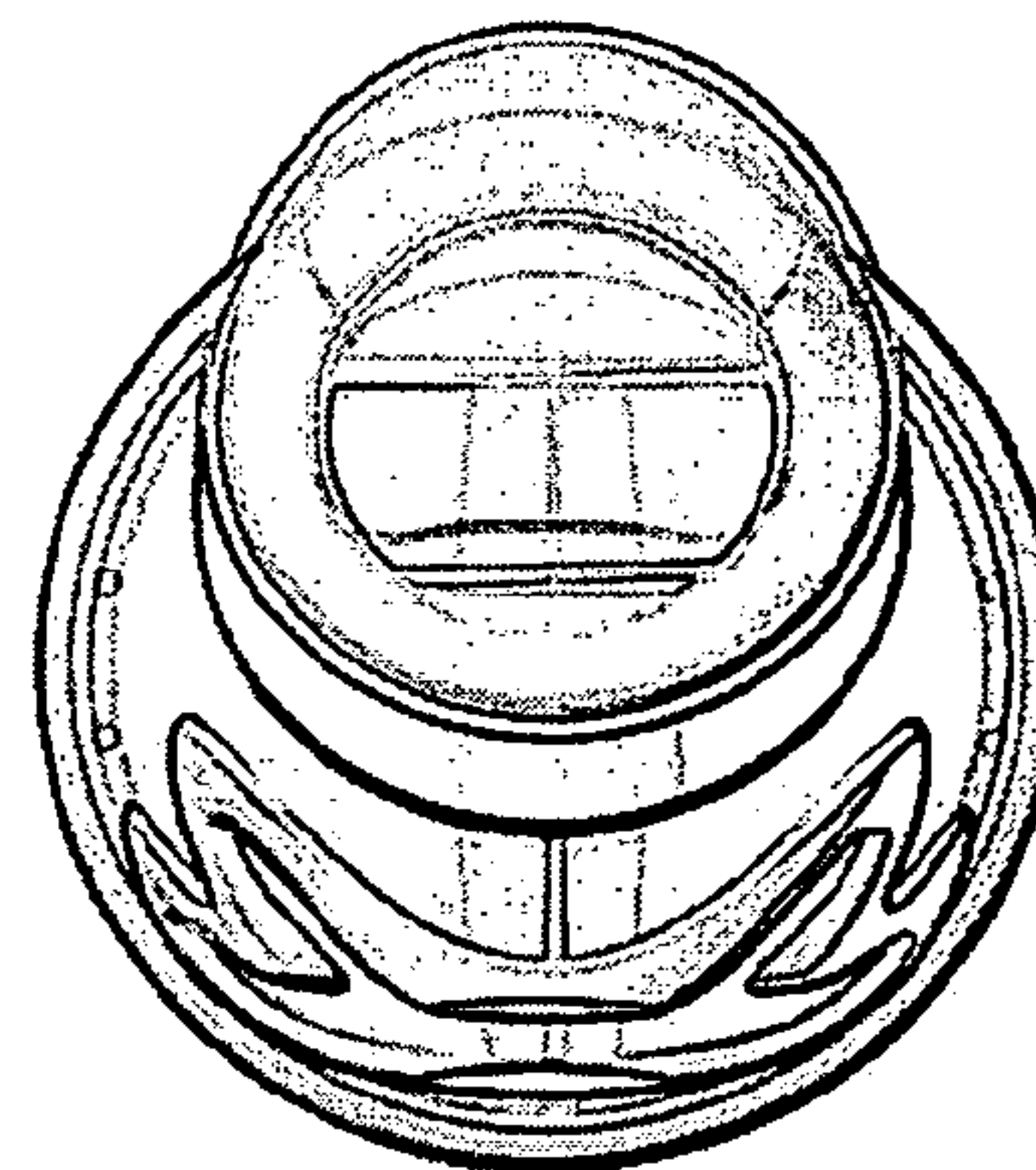
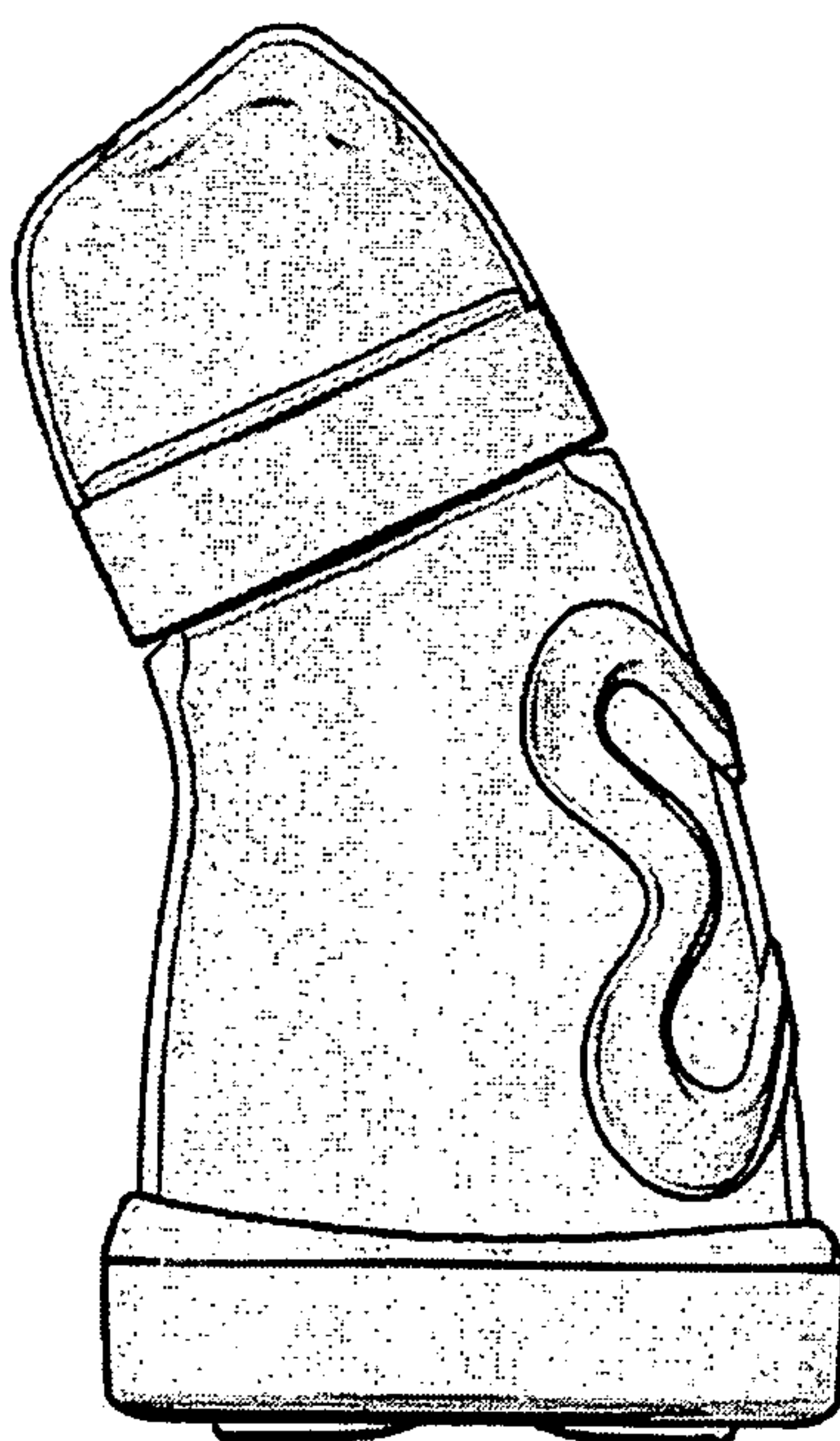
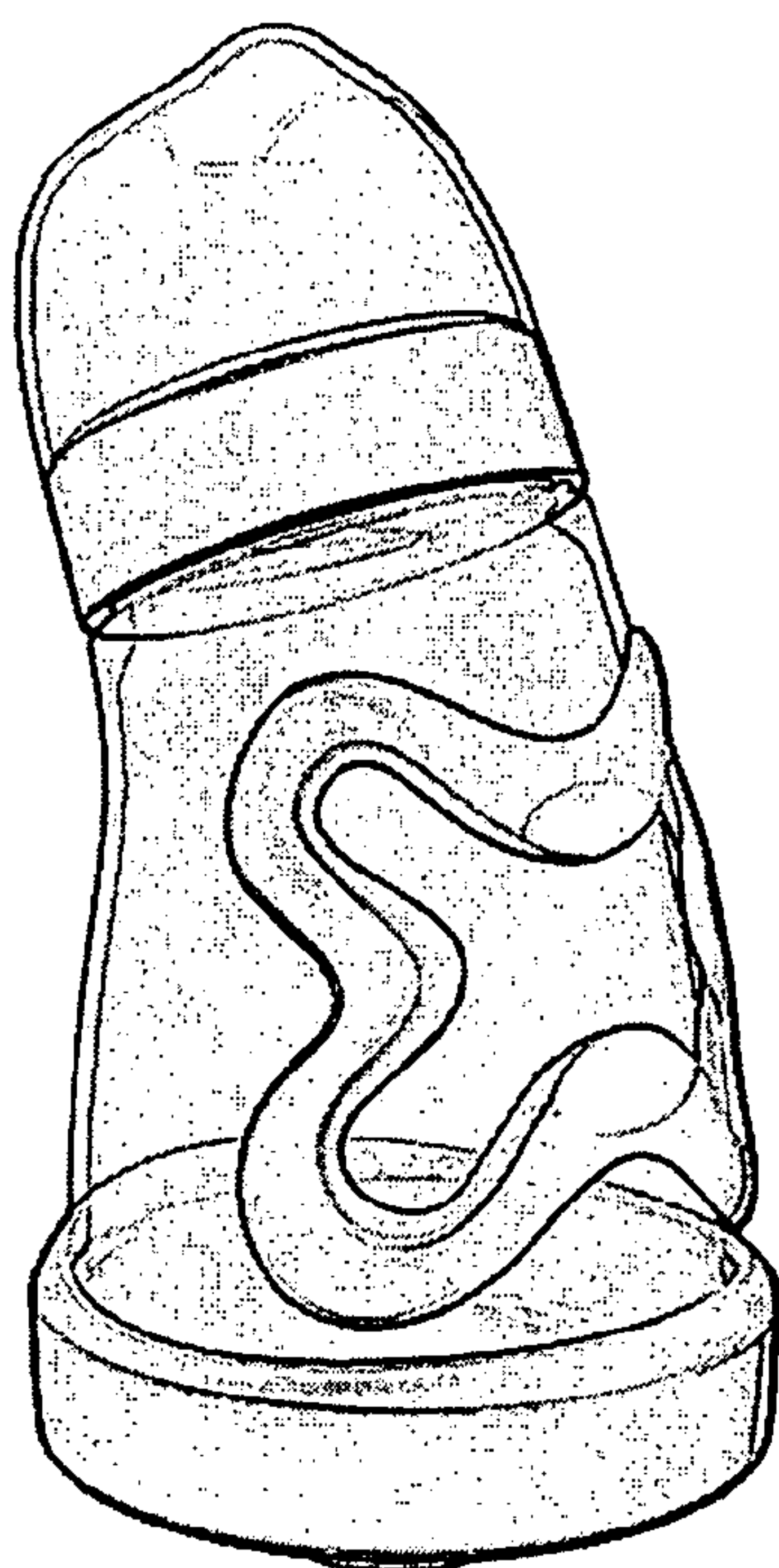
FIG. 3 is a back view of the baby bottle shown in FIG. 1;

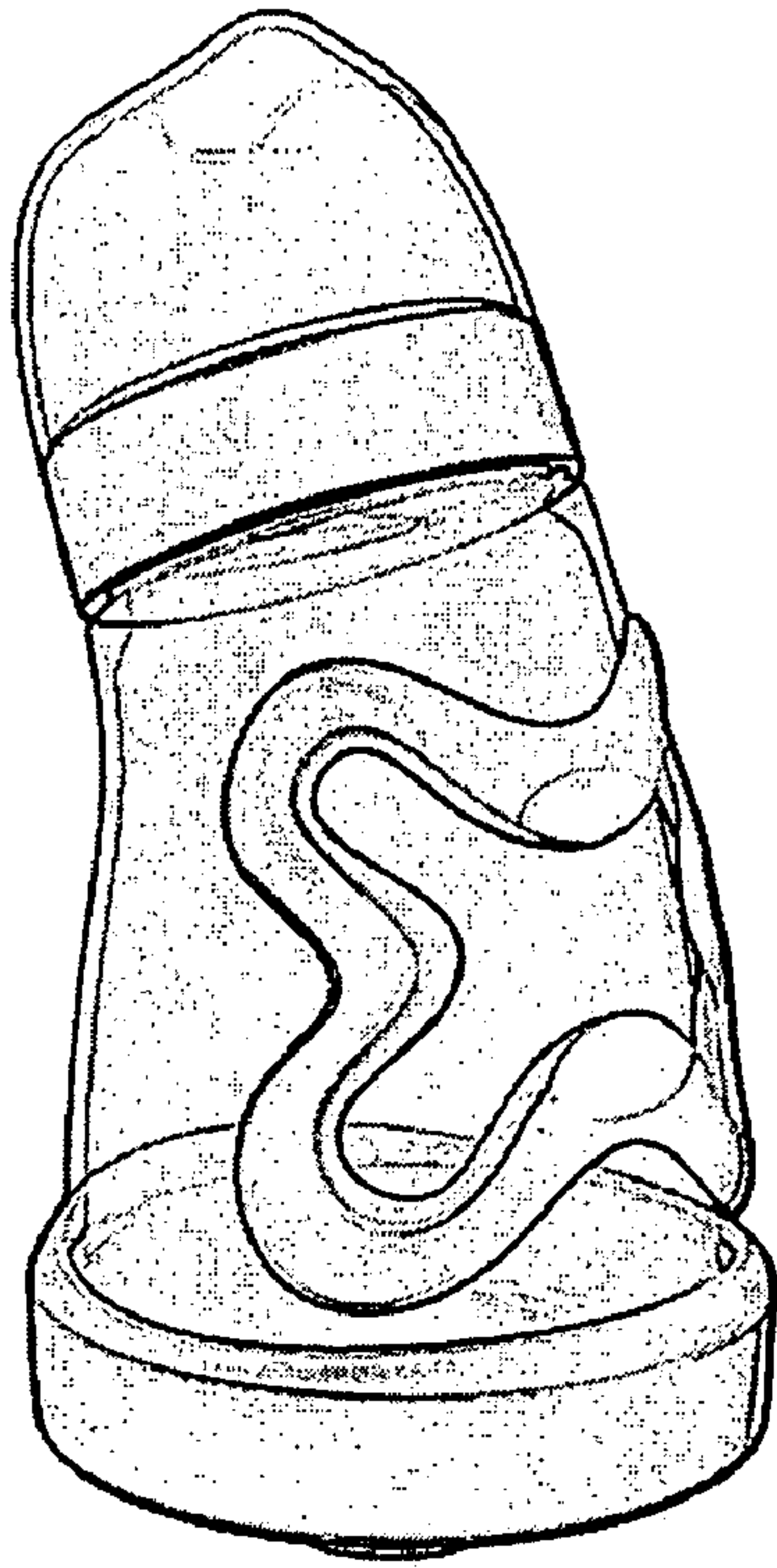

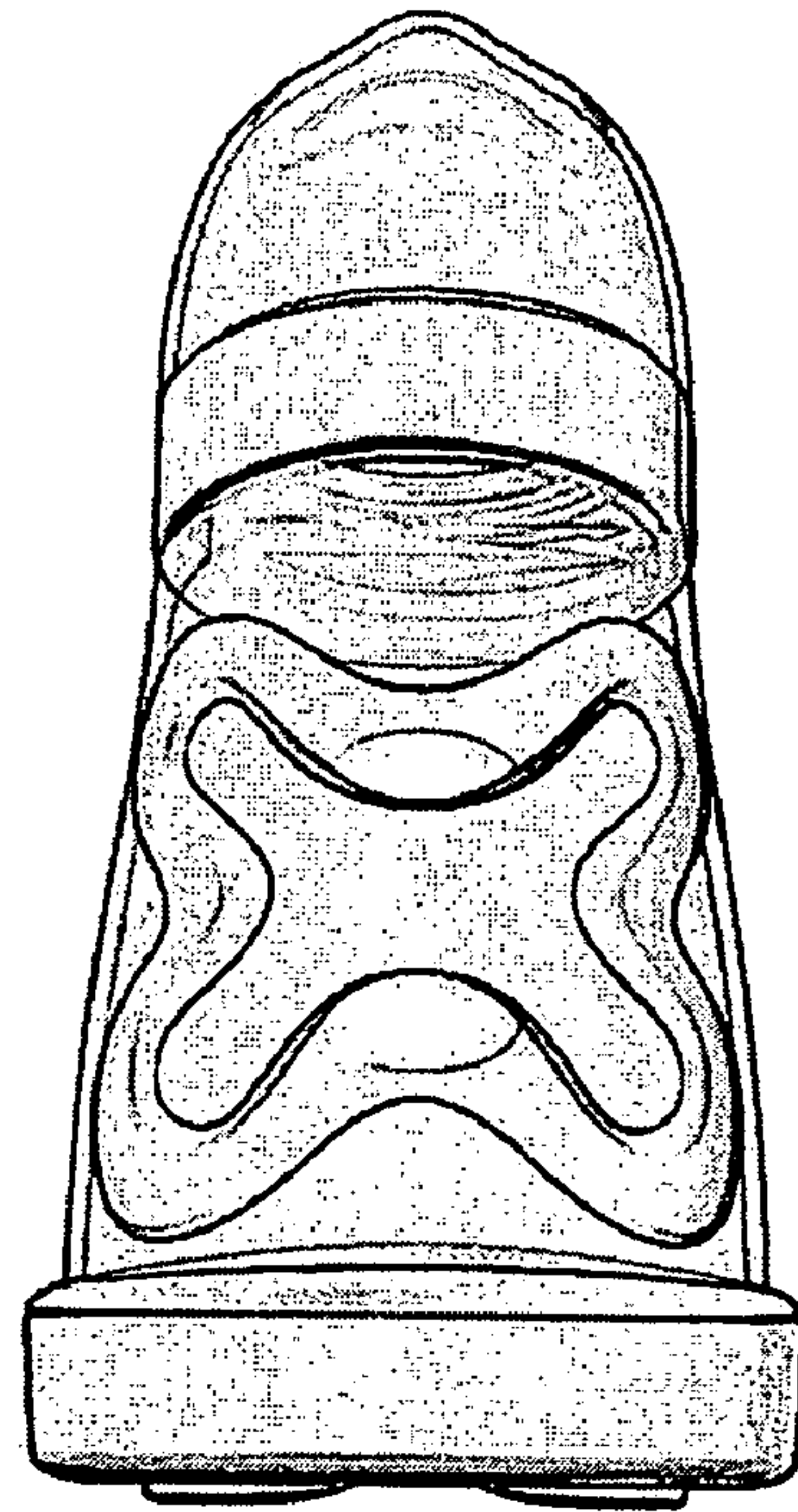

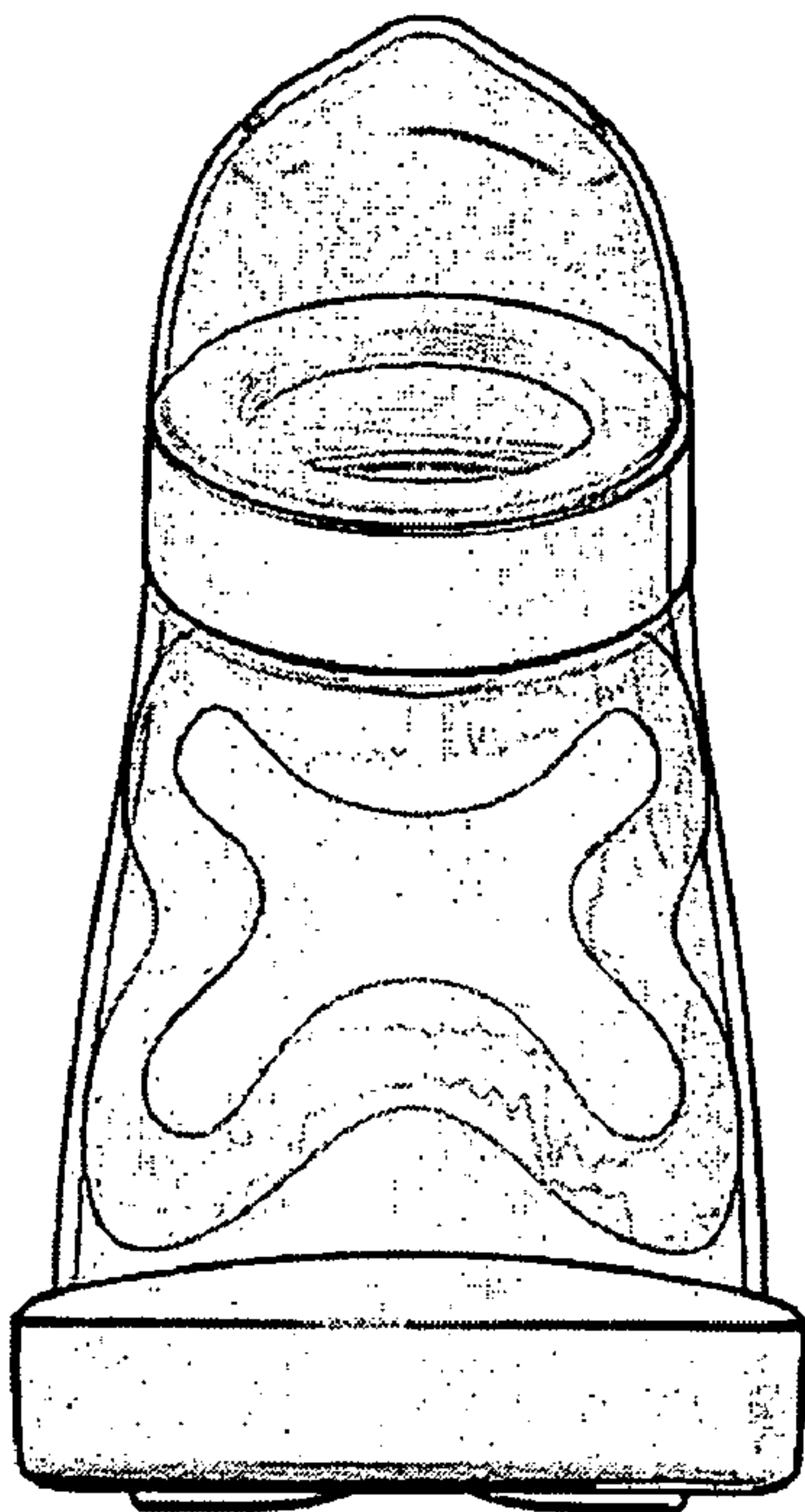

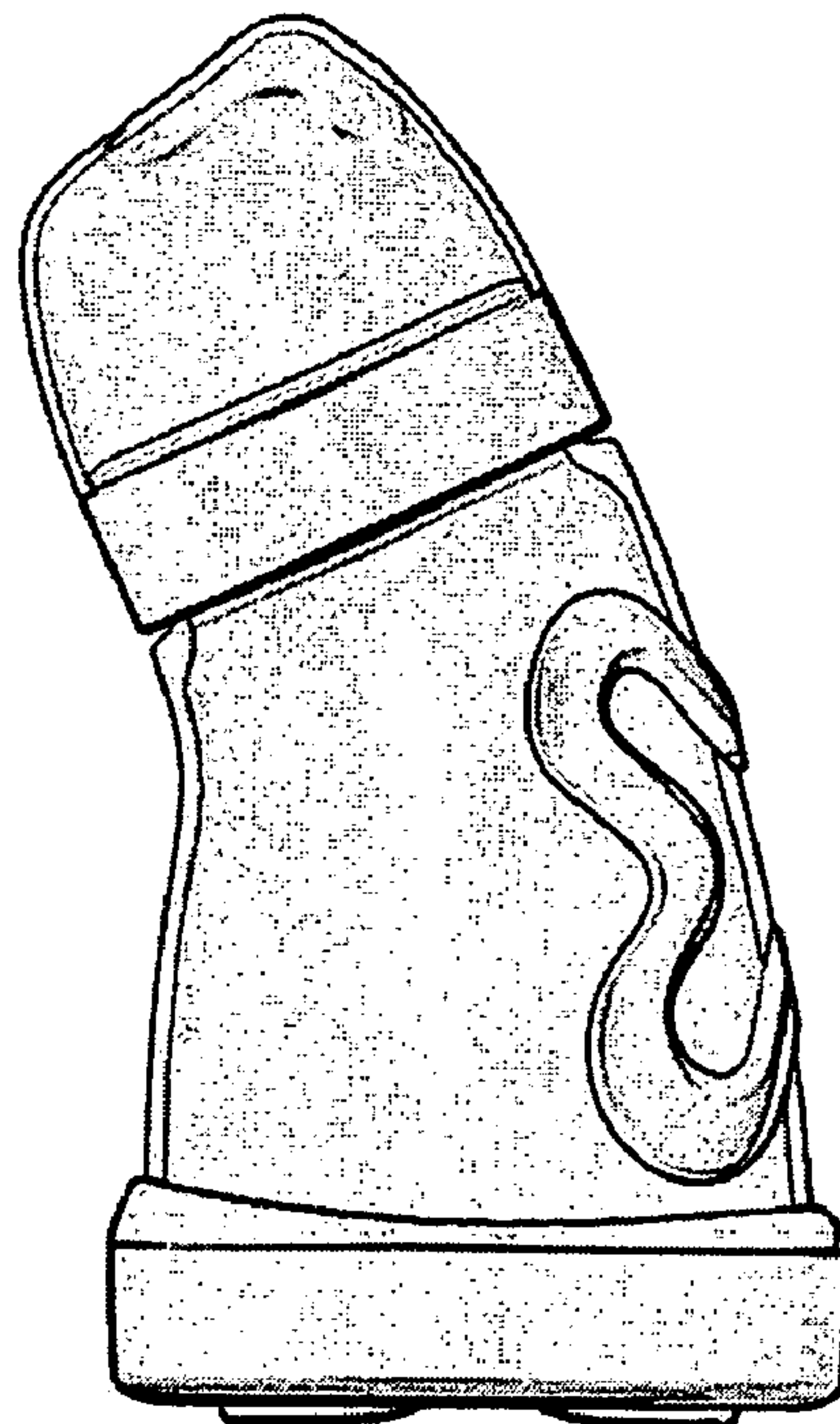

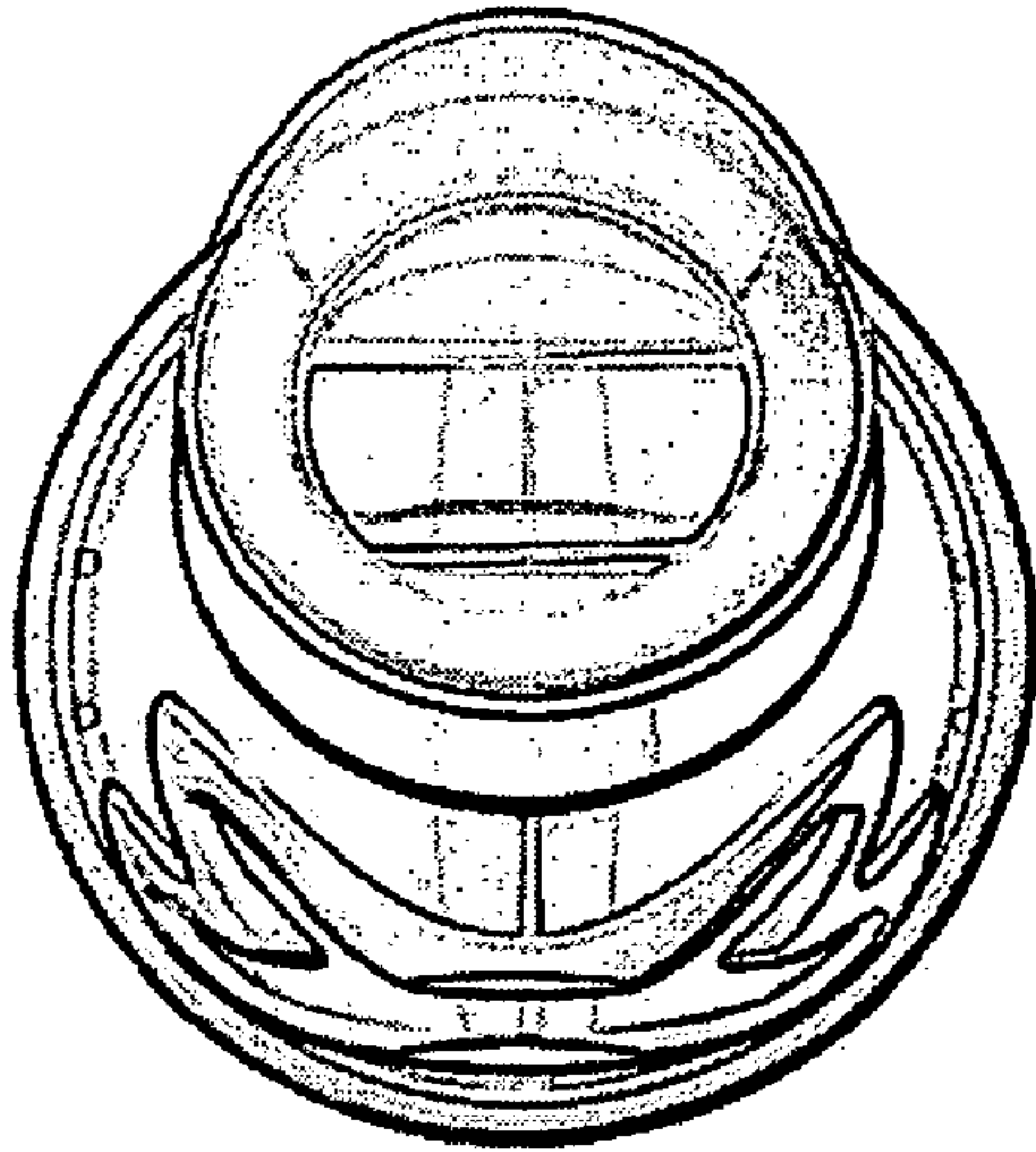

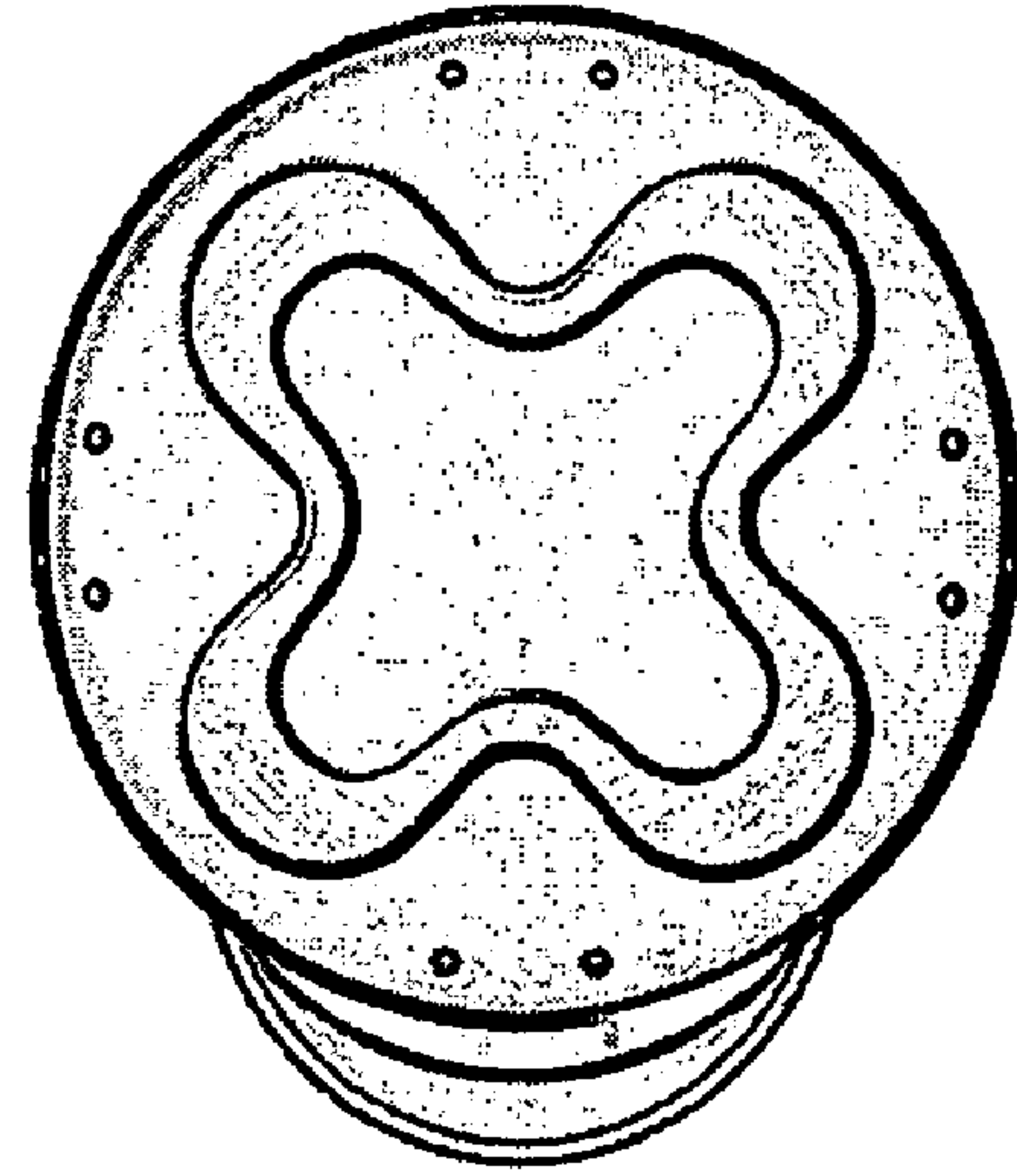
