**DESCRIPTION**

FIG. 1 is a perspective view of a hand pruner showing our new design with handles retracted;  
FIG. 2 is a left-side elevational view of the hand pruner of FIG. 1;  
FIG. 3 is a right-side elevational view of the hand pruner of FIGS. 1 and 2;  
FIG. 4 is a top plan view of the hand pruner of FIGS. 1 to 3;  
FIG. 5 is a bottom plan view of the hand pruner of FIGS. 1 to 4;  
FIG. 6 is a front elevational view of the hand pruner of FIGS. 1 to 5;  
FIG. 7 is a rear elevational view of the hand pruner of FIGS. 1 to 6;  
FIG. 8 is a perspective view of the hand pruner of FIGS. 1 to 7 with the handles extended;  
FIG. 9 is a left-side elevational view of the hand pruner of FIG. 8;  
FIG. 10 is a right-side elevational view of the hand pruner of FIGS. 8 and 9;  
FIG. 11 is a top plan view of the hand pruner of FIGS. 8 to 10;  
FIG. 12 is a bottom plan view of the hand pruner of FIGS. 8 to 11;  
FIG. 13 is a front elevational view of the hand pruner of FIGS. 8 to 12; and,  
FIG. 14 is a rear elevational view of the hand pruner of FIGS. 8 to 13.

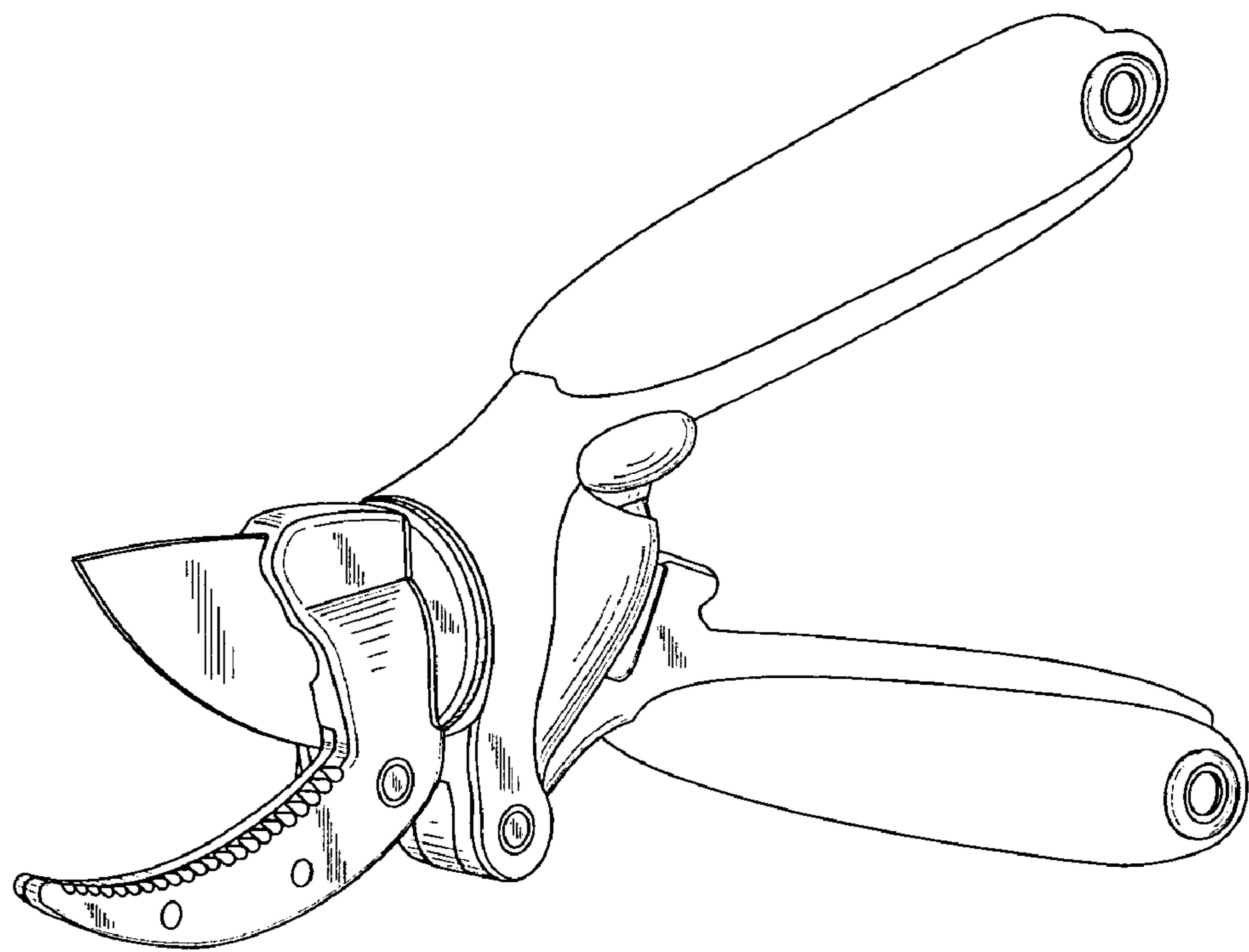

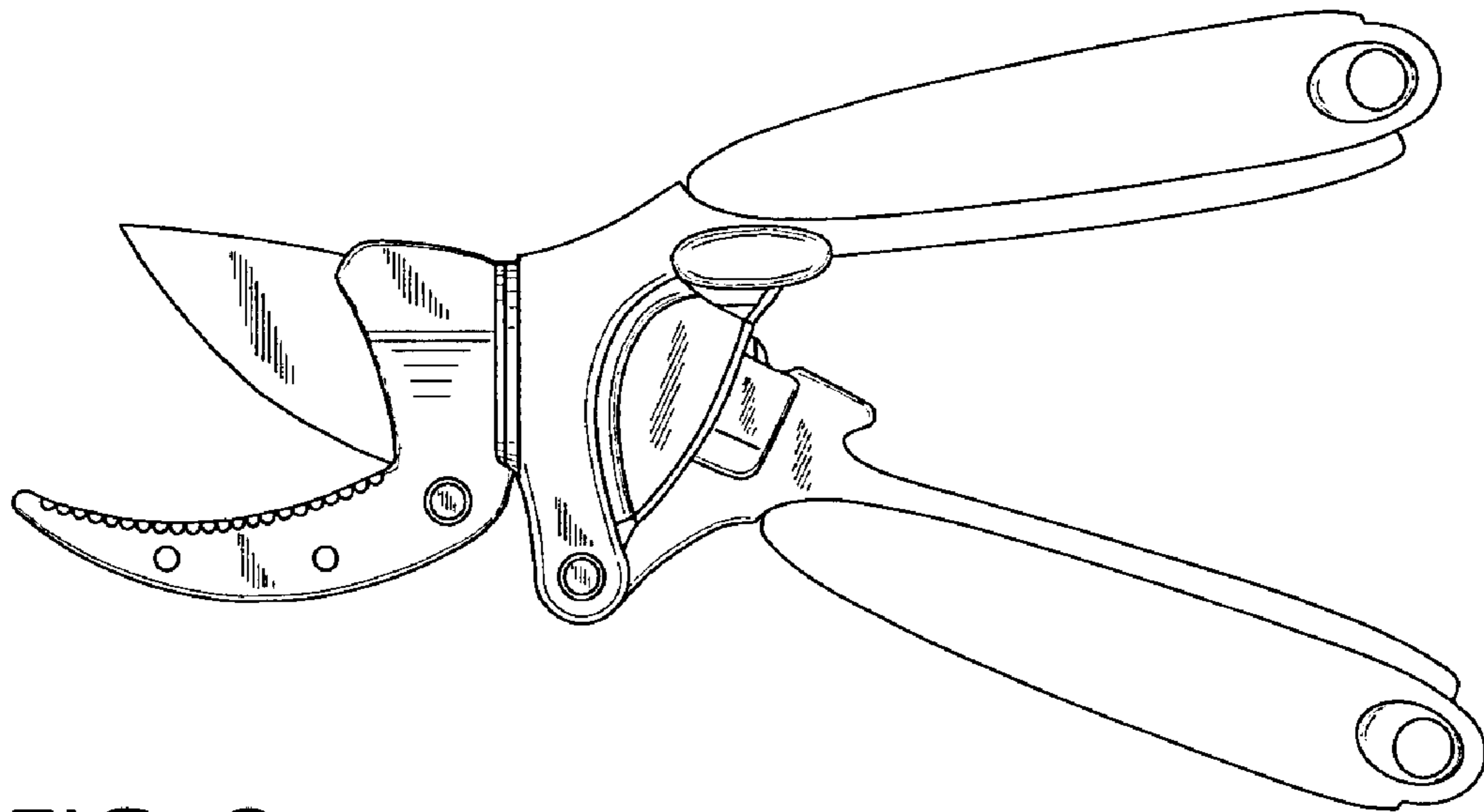

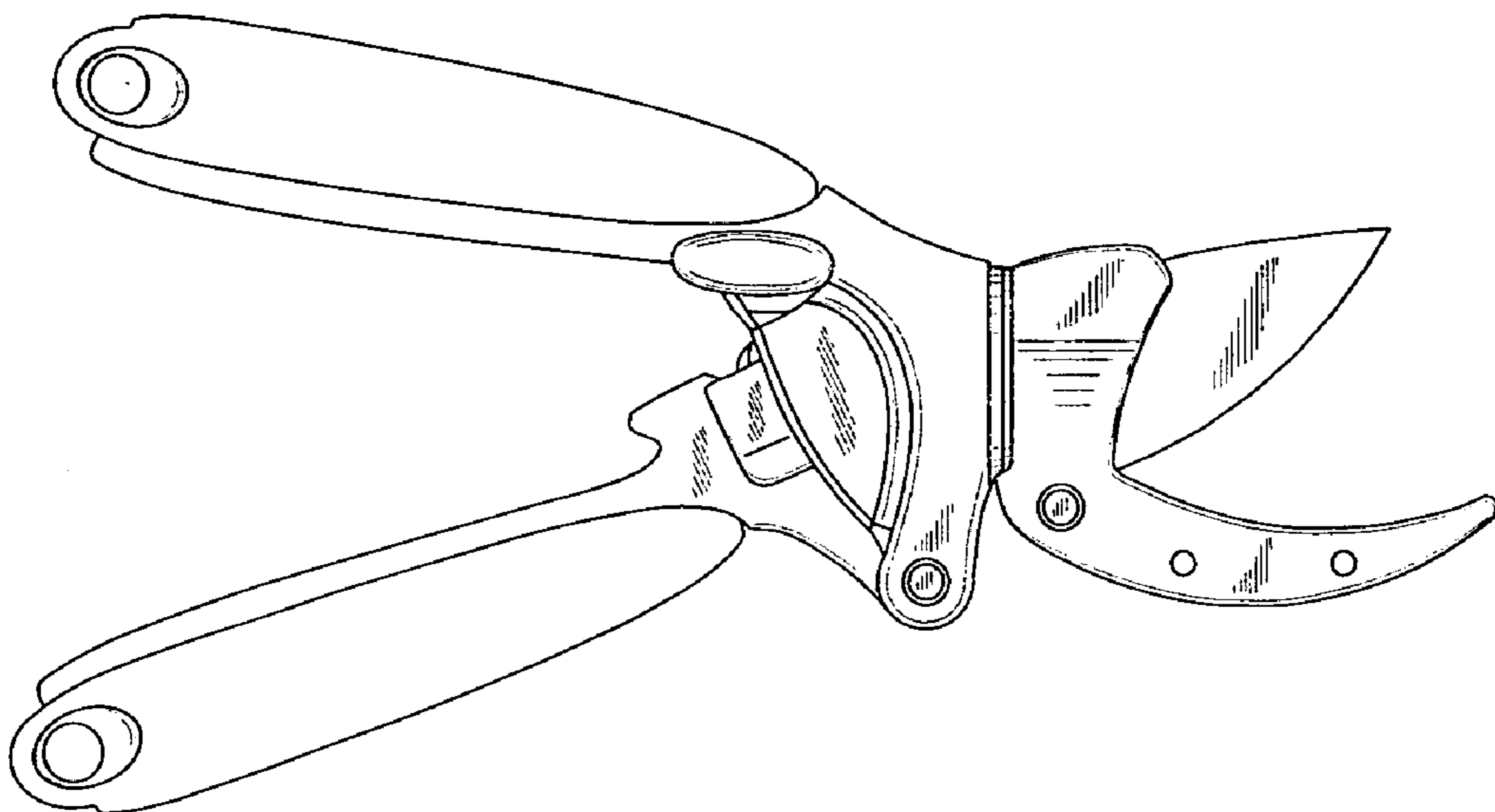

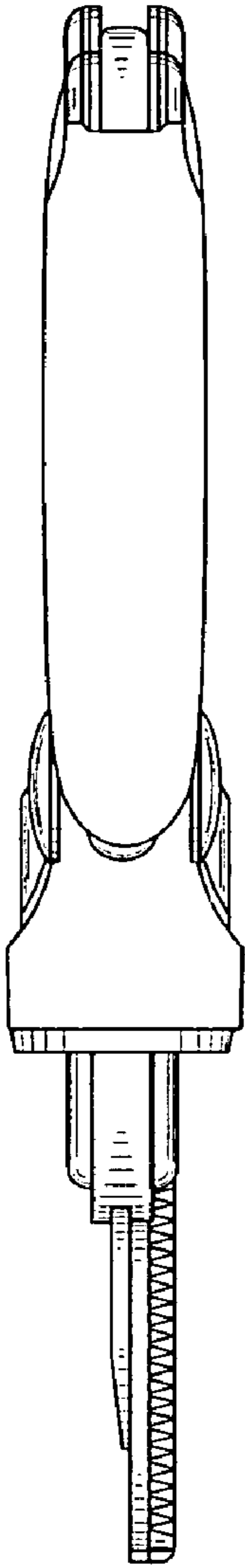

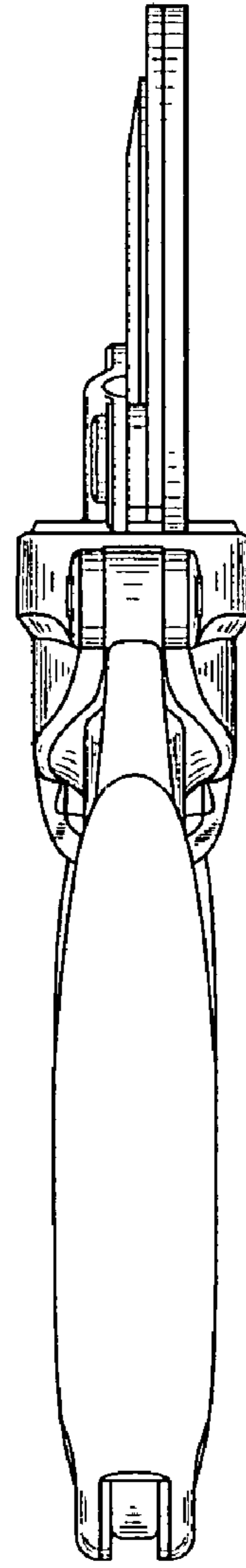

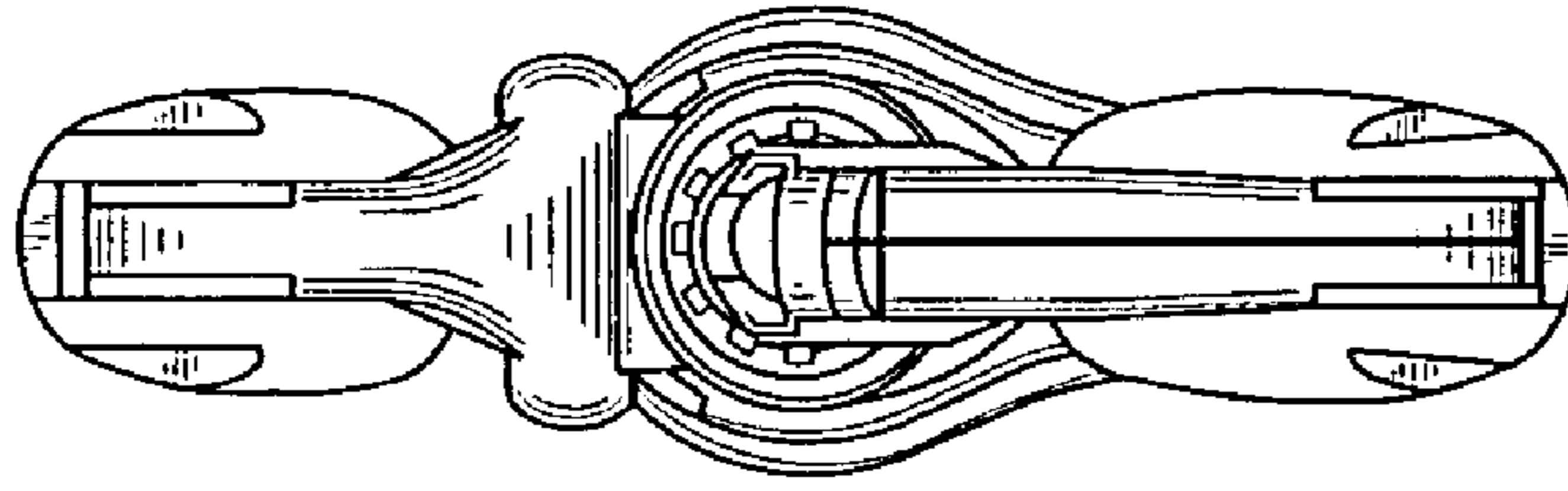

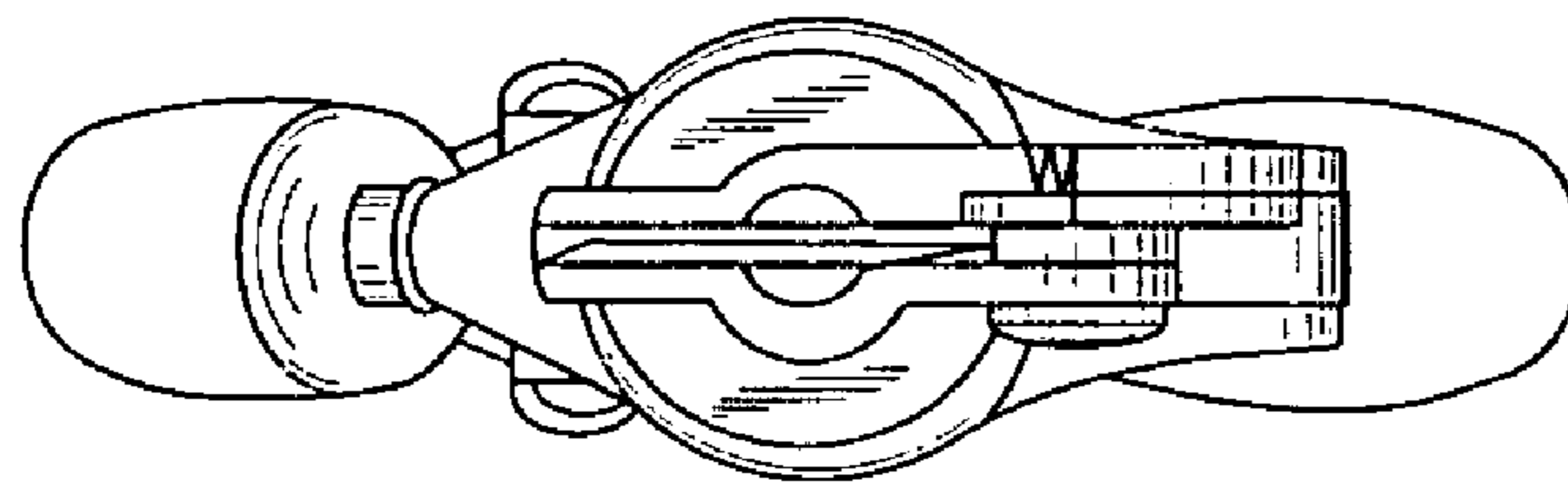

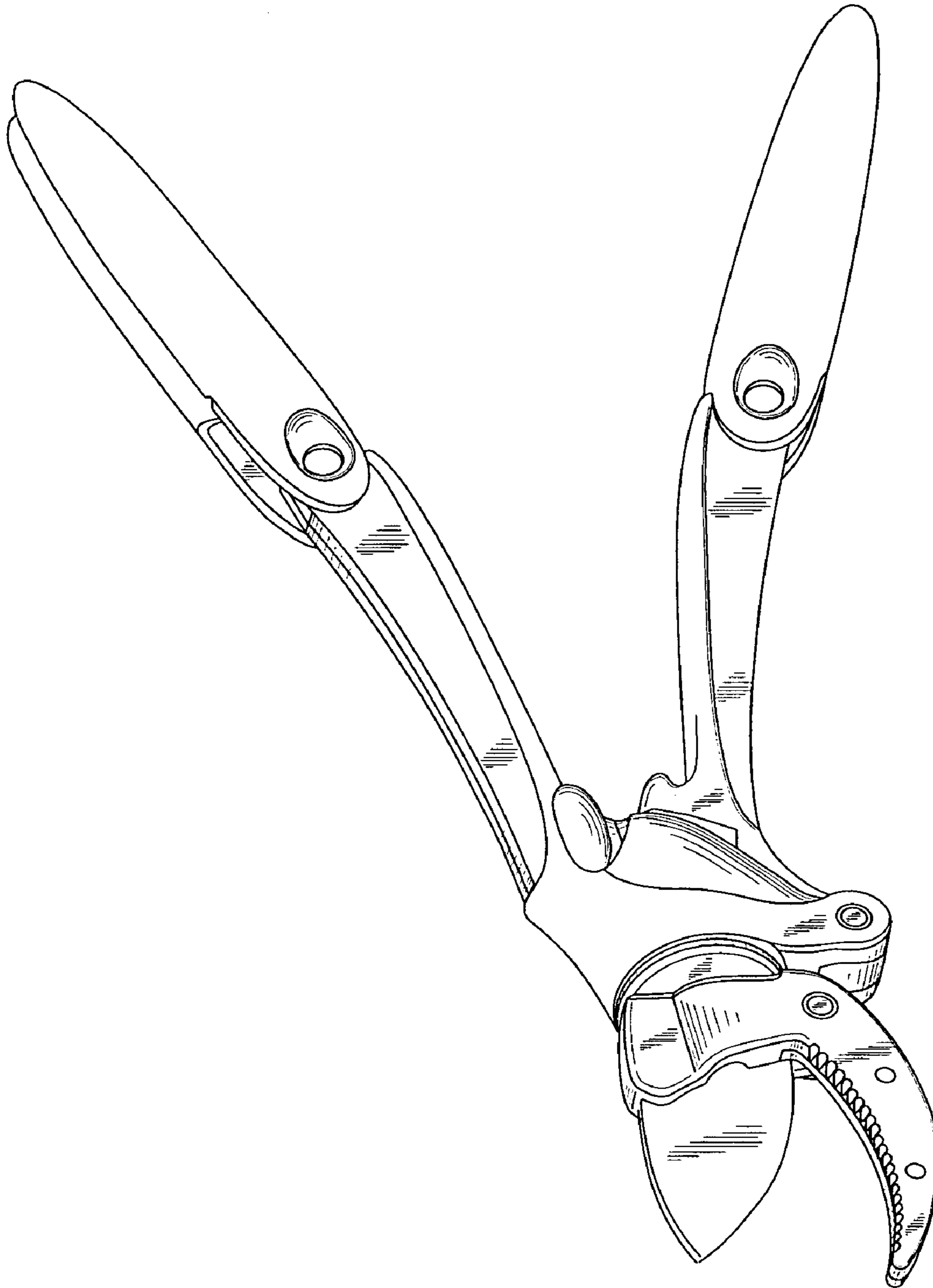

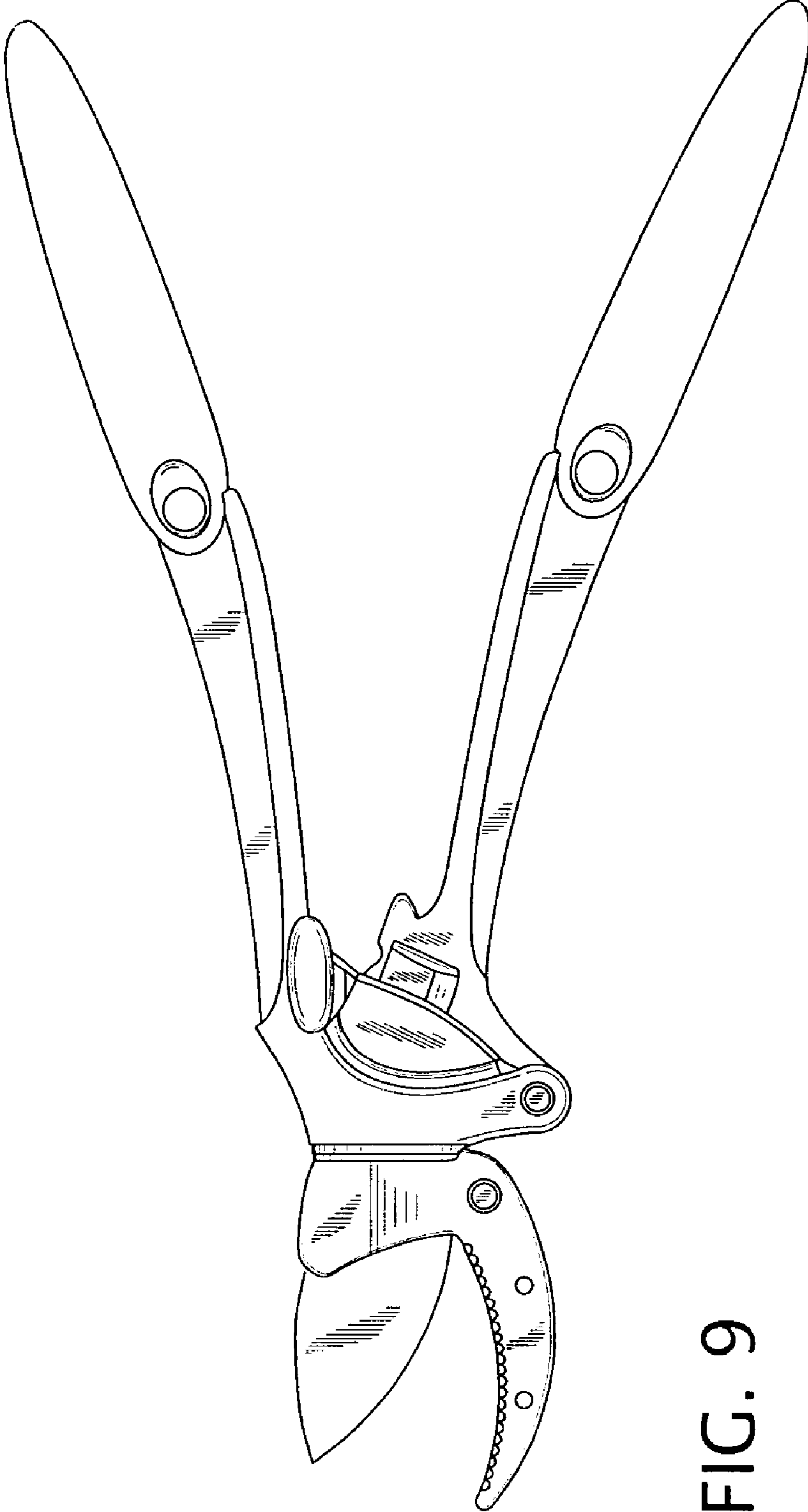

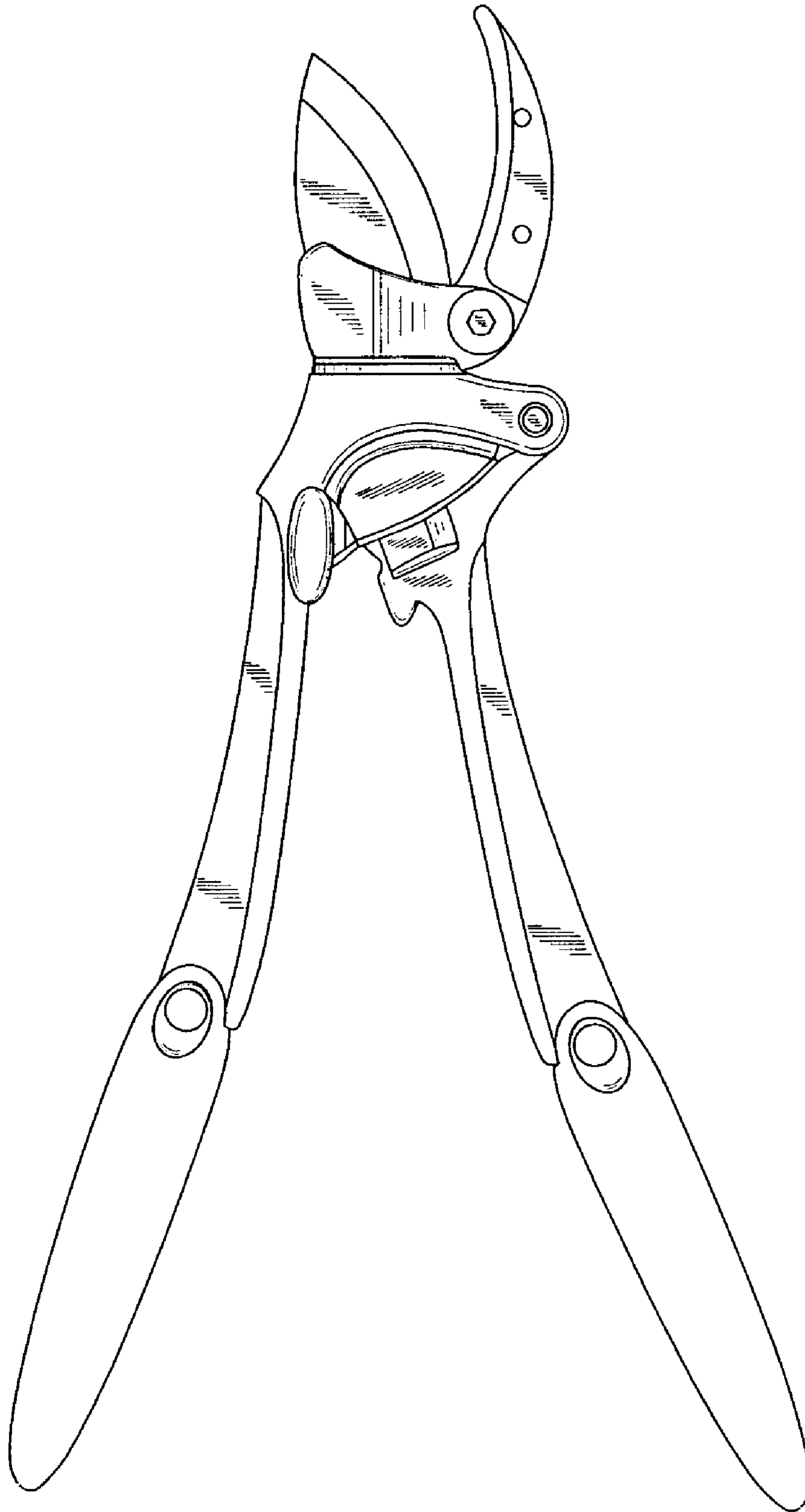

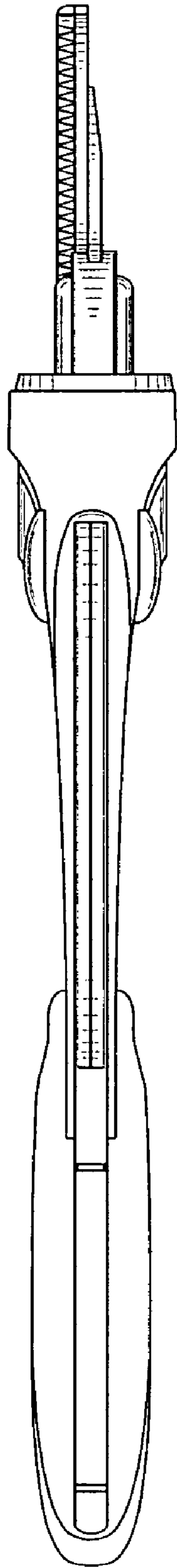

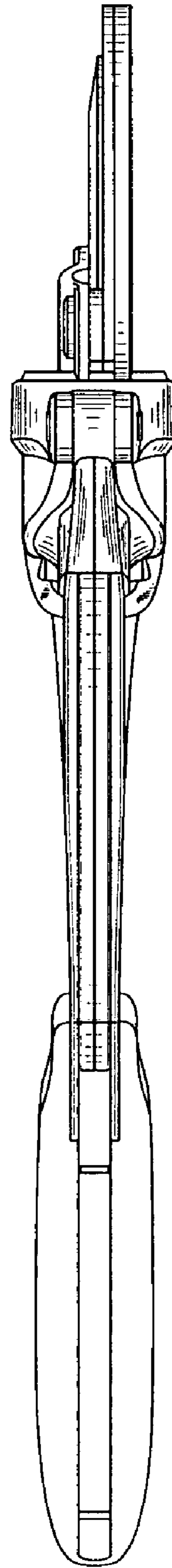

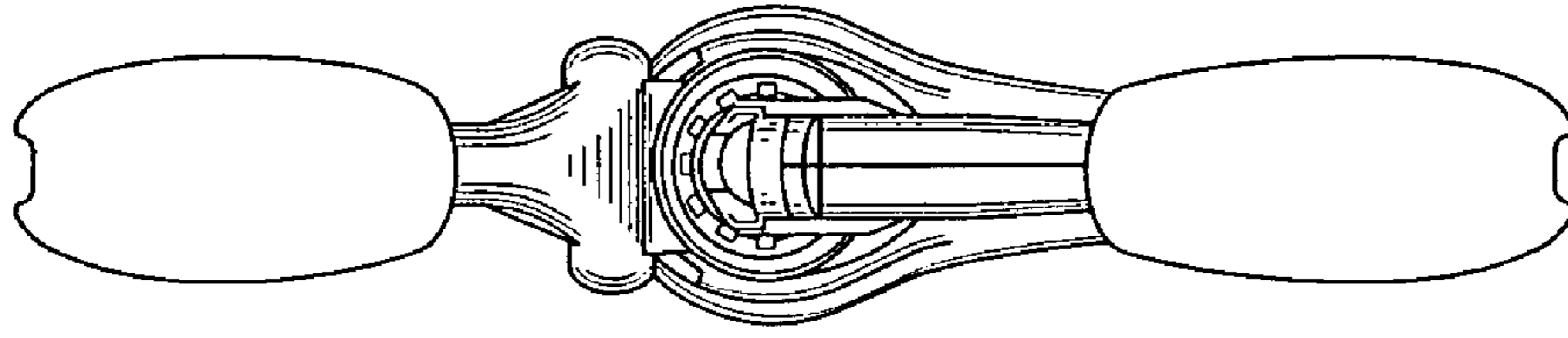

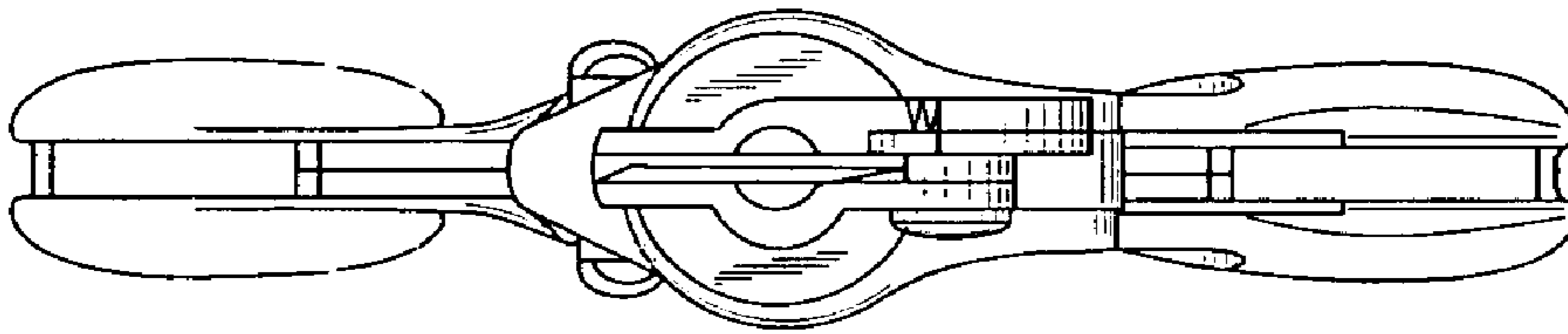
