(57) **CLAIM**

The ornamental design for a hand-held vegetation trimmer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hand-held vegetation trimmer in combination with a shear blade assembly;

FIG. 2 is a front perspective view of a hand-held vegetation trimmer in combination with a shrubber blade assembly;

FIG. 3 is a front perspective view of a hand-held vegetation trimmer;

FIG. 4 is a left side view of a hand-held vegetation trimmer;

FIG. 5 is a right side view of a hand-held vegetation trimmer;

FIG. 6 is a top view of a hand-held vegetation trimmer;

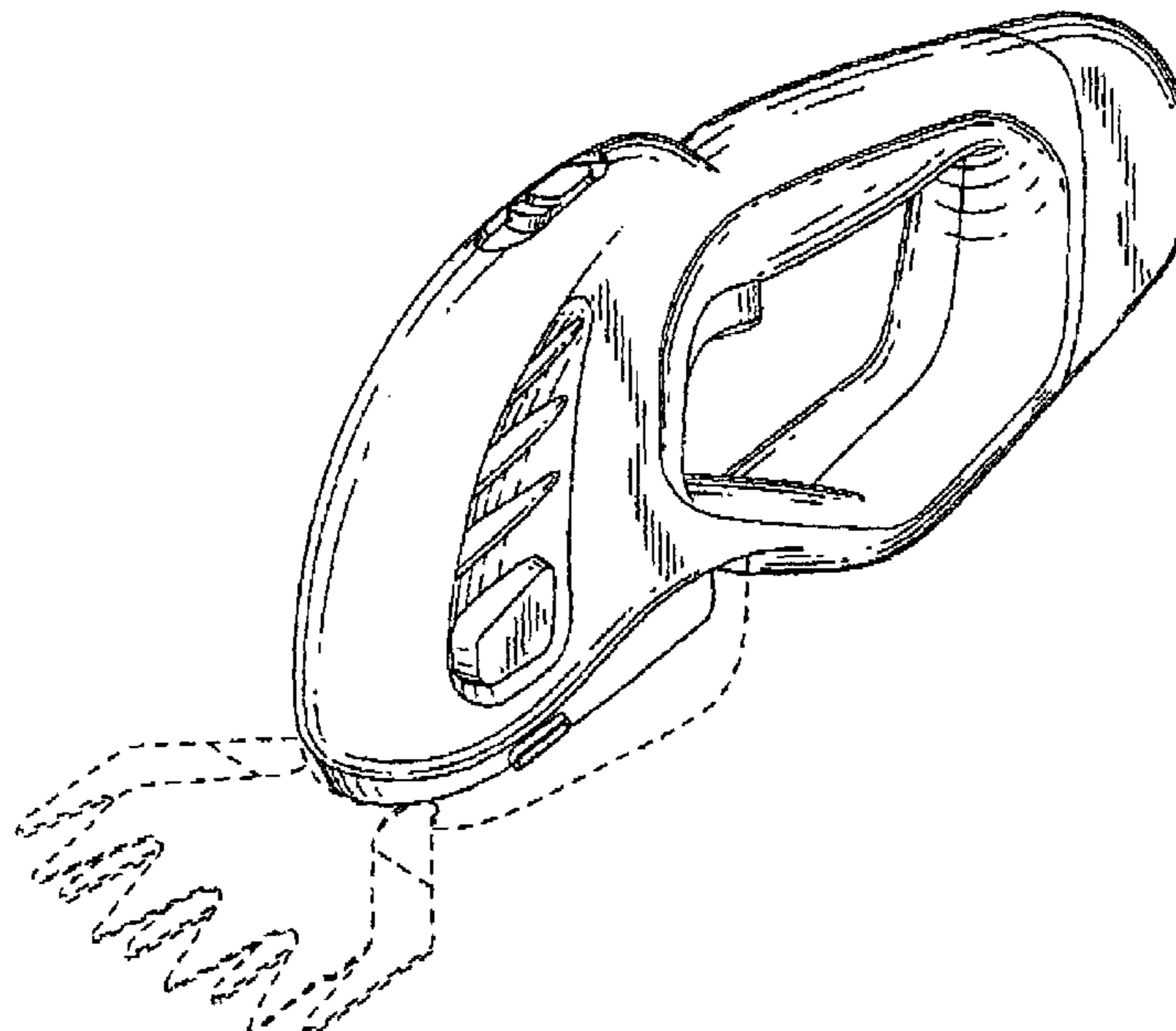
FIG. 7 is a bottom view of a hand-held vegetation trimmer;

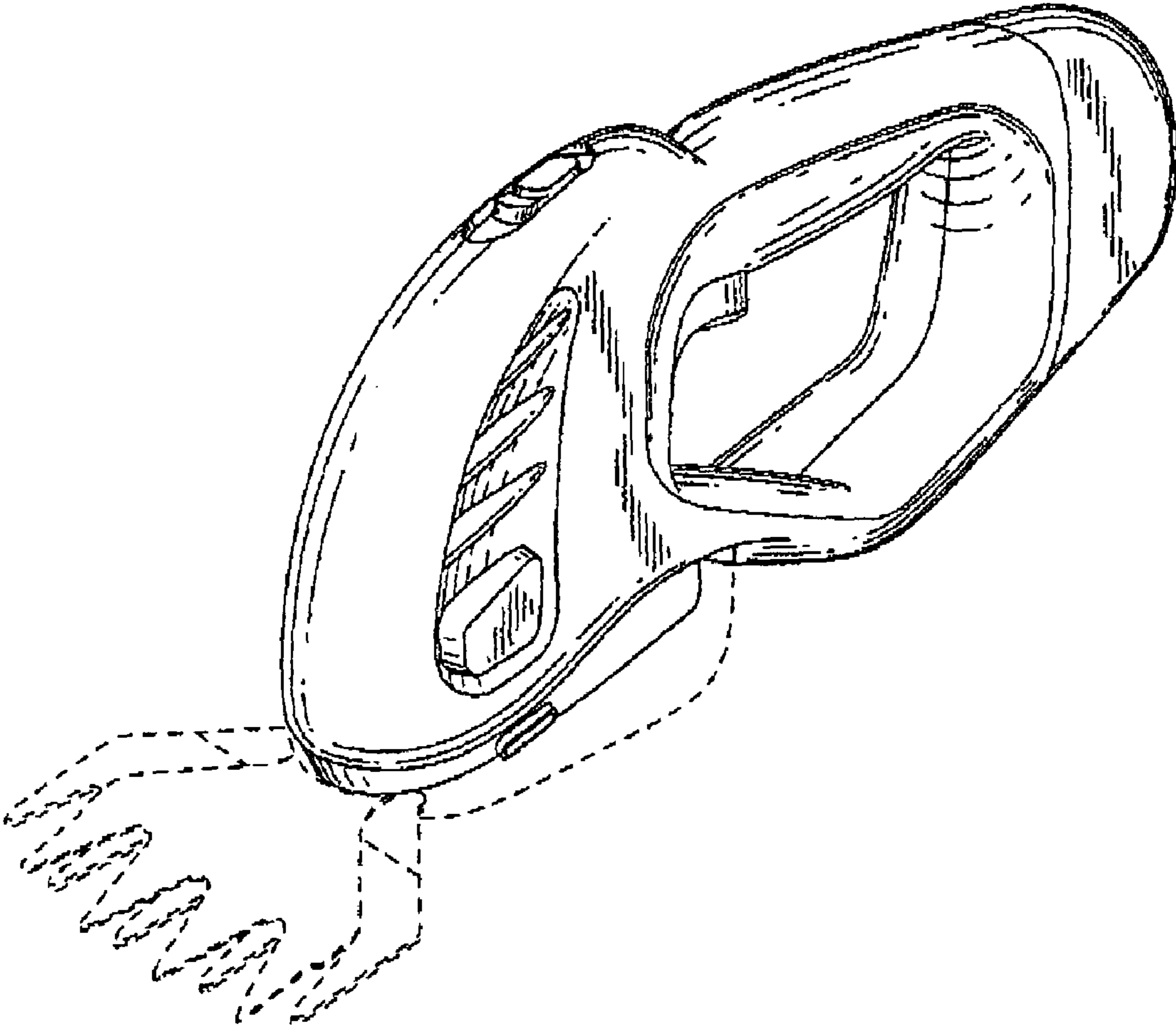

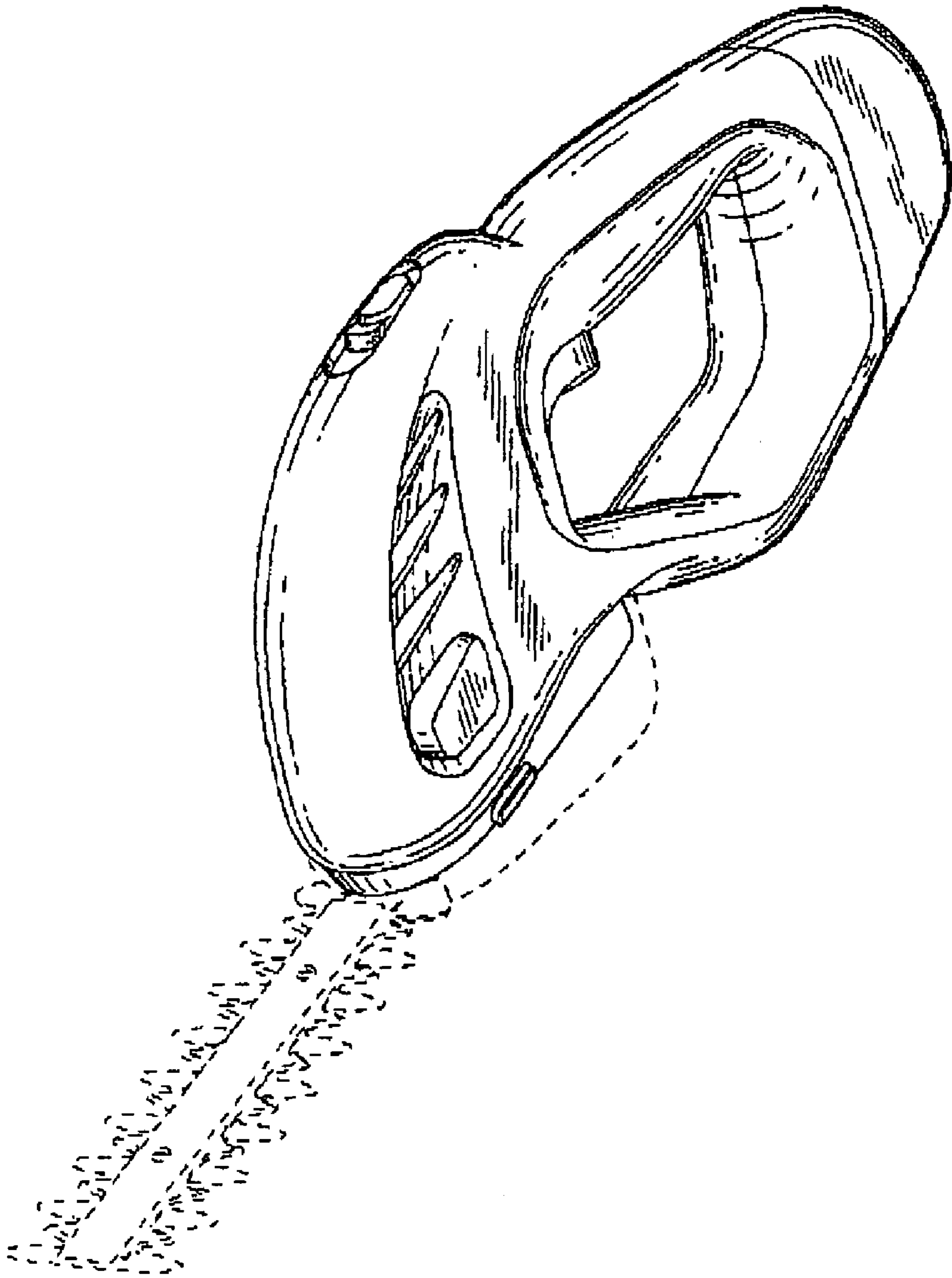

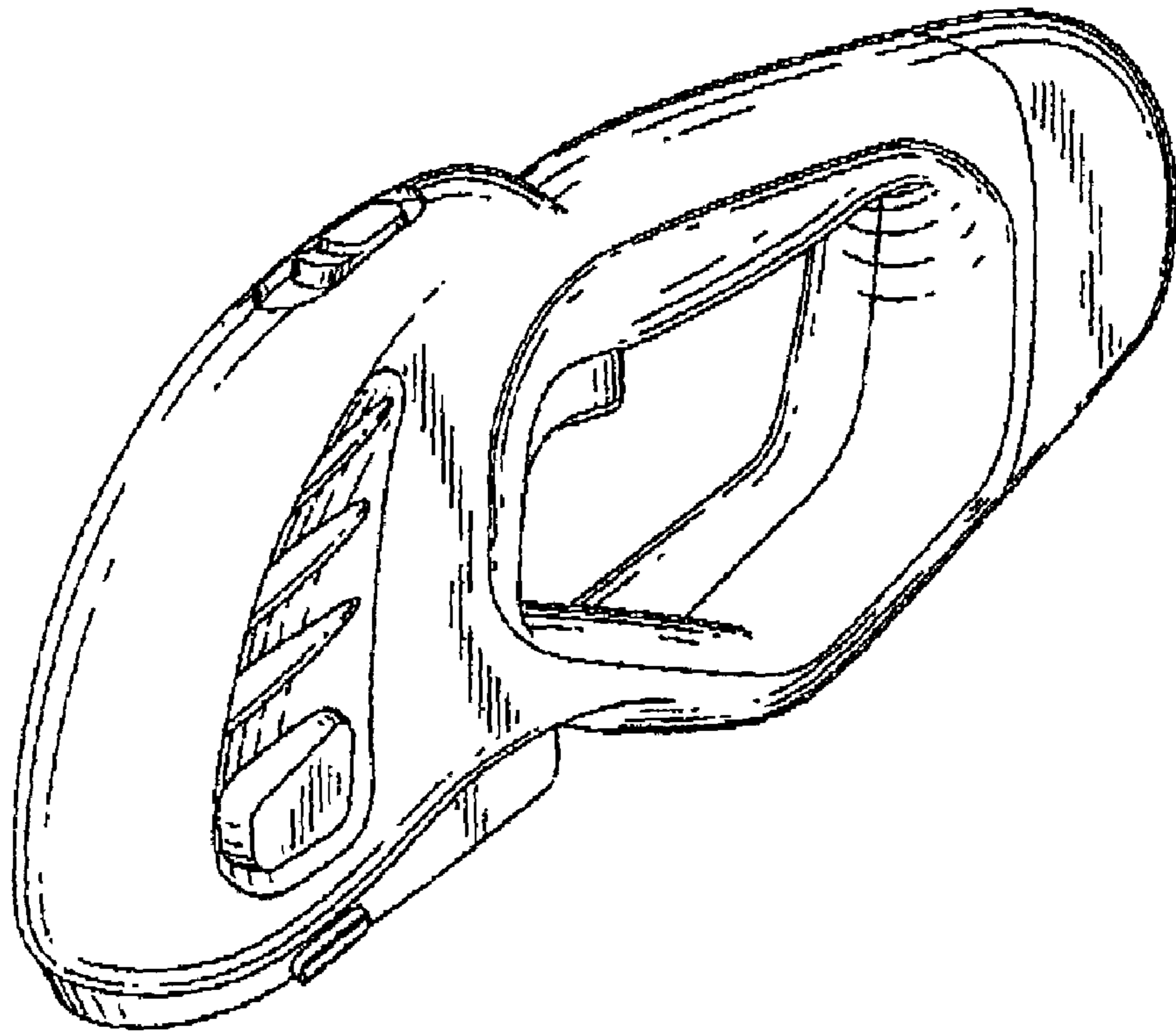

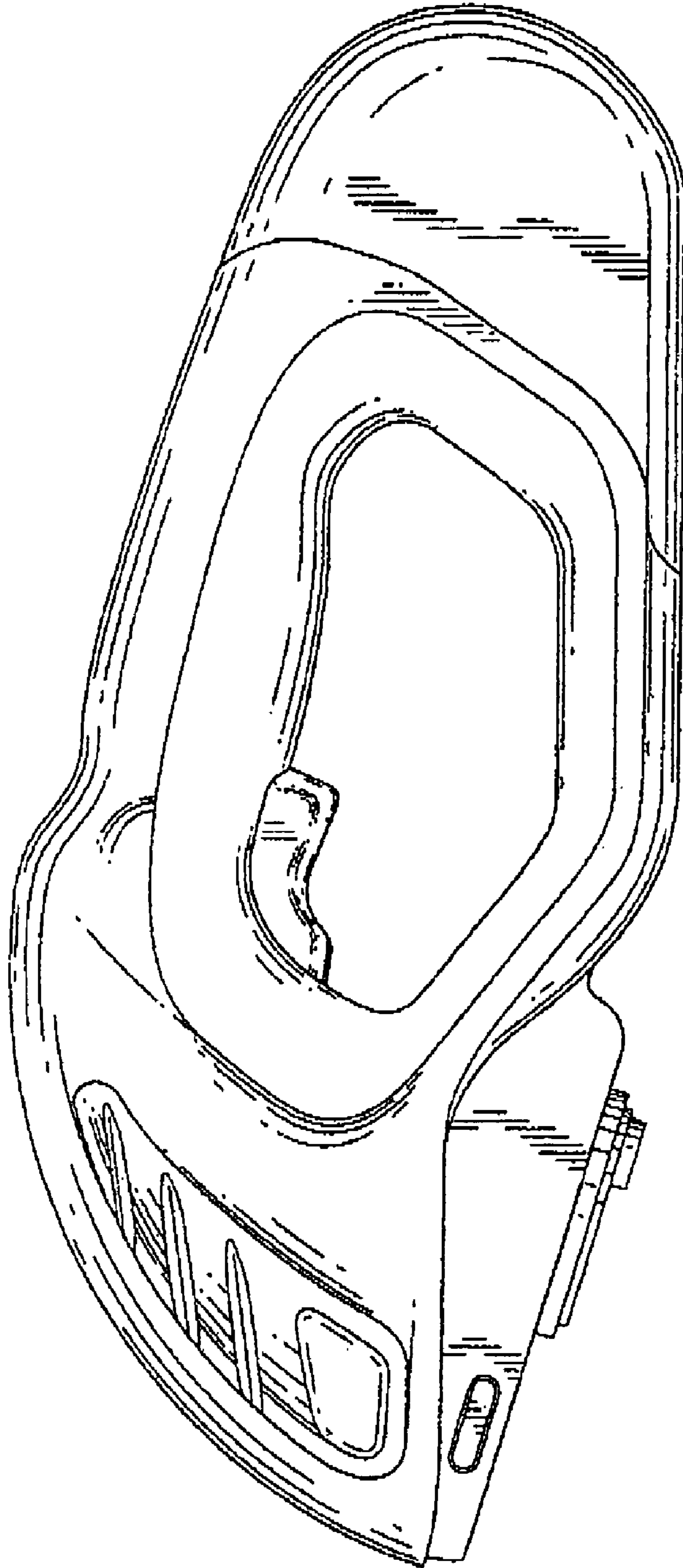

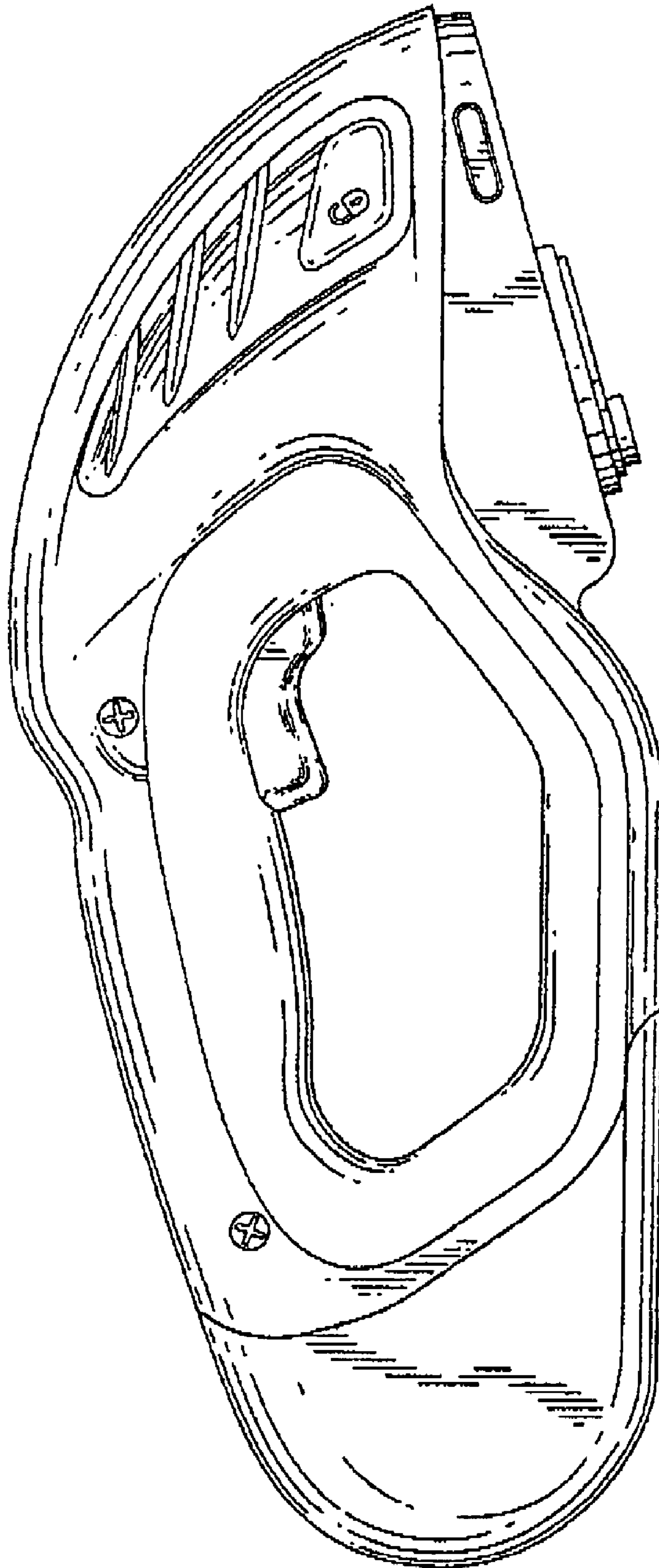

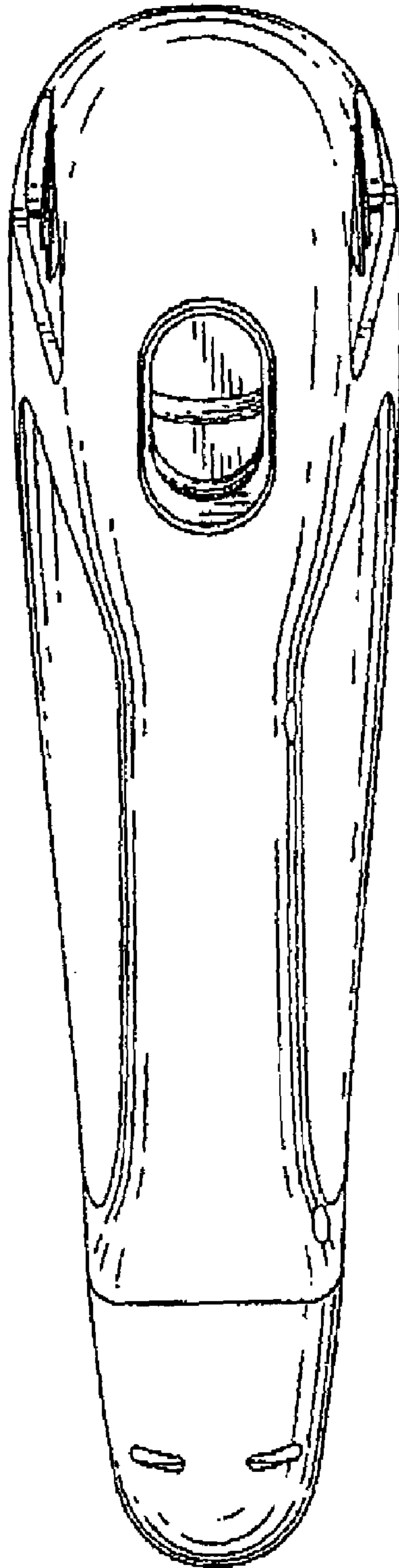

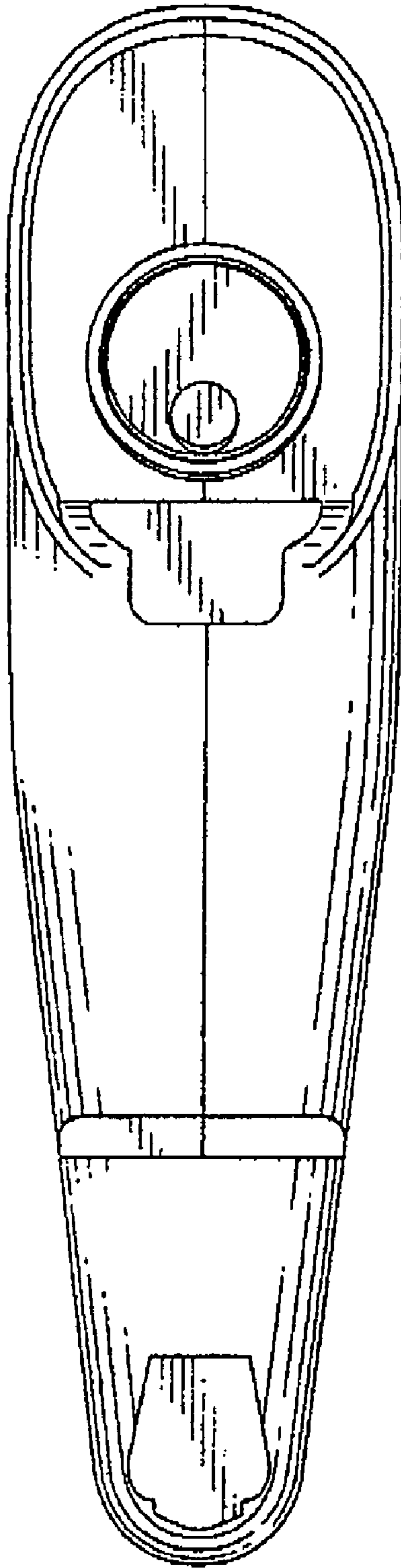

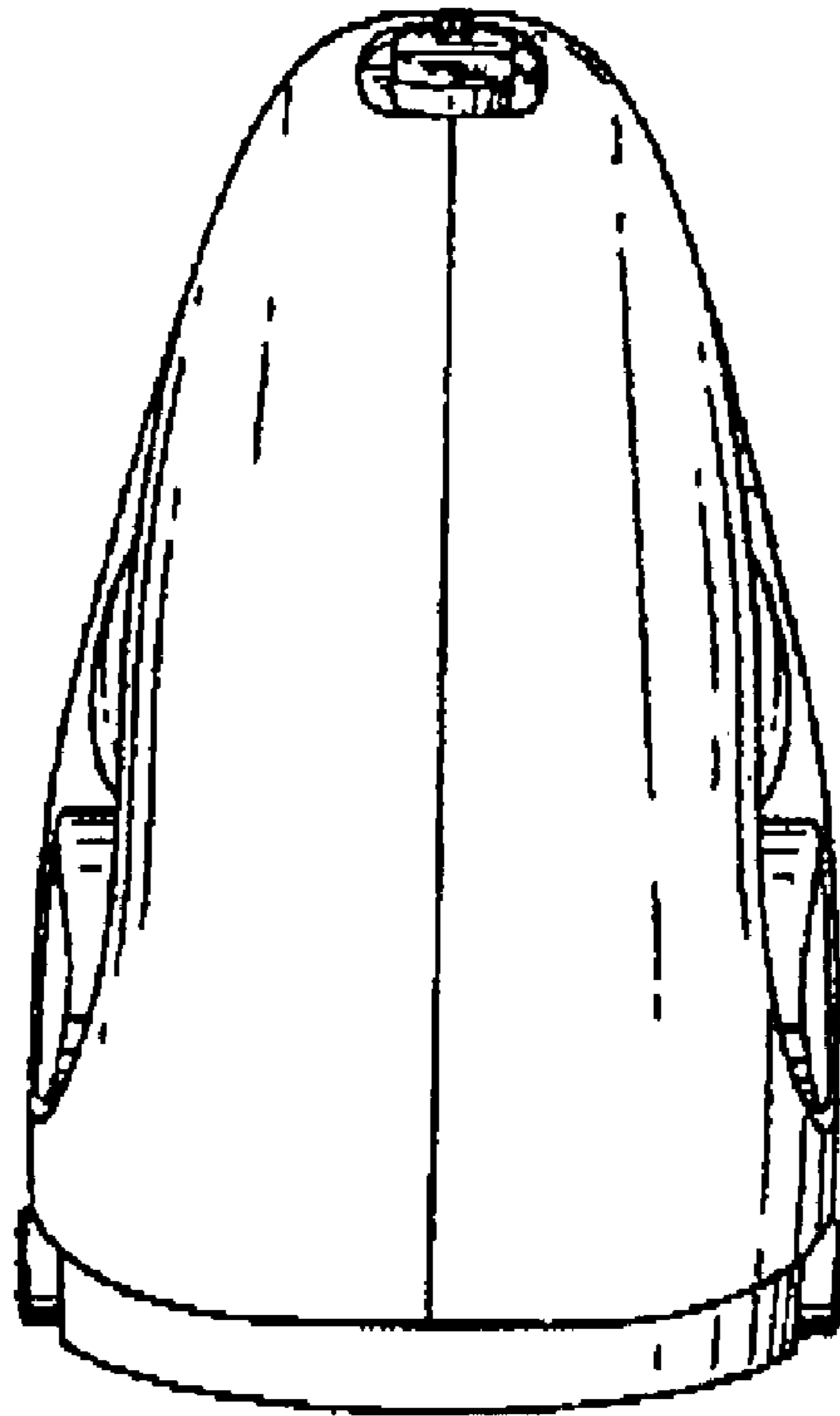

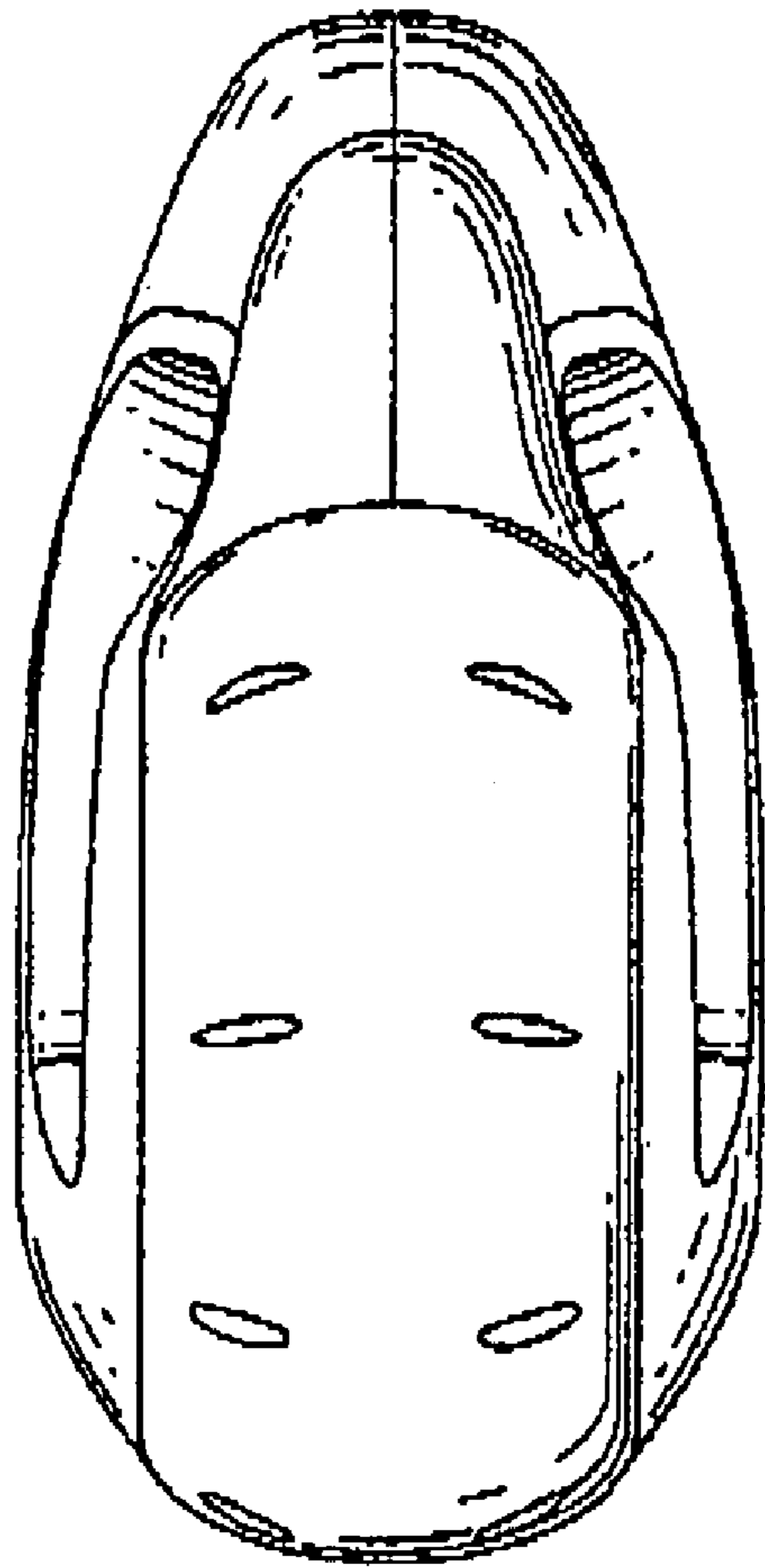
