The ornamental design for a beverage indicator sleeve for a cup, as shown and described.

DESCRIPTION

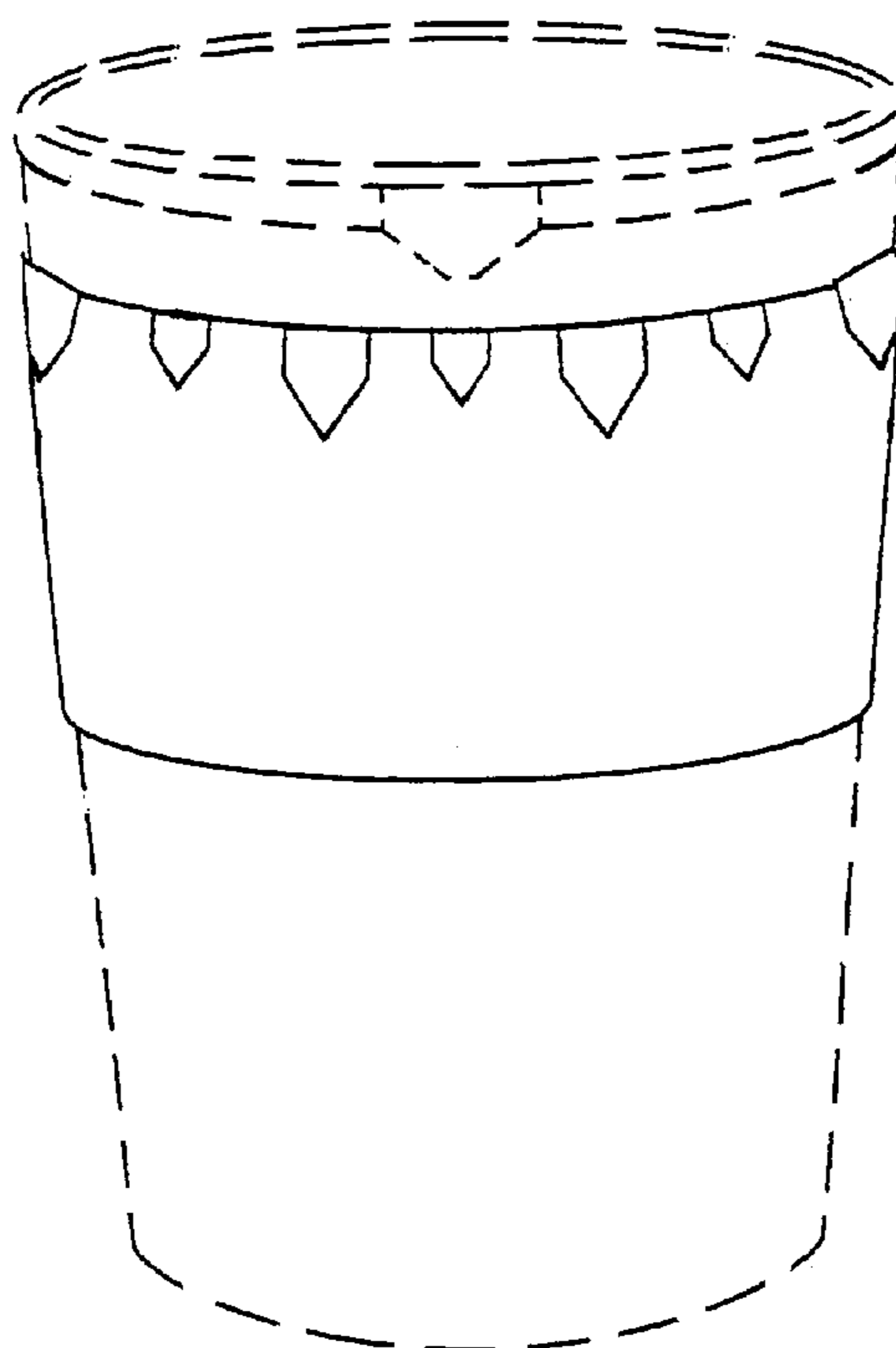
FIG. 1 is a elevational view illustrating a beverage indicator sleeve for a cup in accordance with the design;

FIG. 2 is a perspective view illustrating the beverage indicator sleeve for a cup of FIG. 1; and,

FIG. 3 is a perspective view of the beverage indicator sleeve for a cup shown in FIGS. 1 and 2, assembled on a cup and a lid.

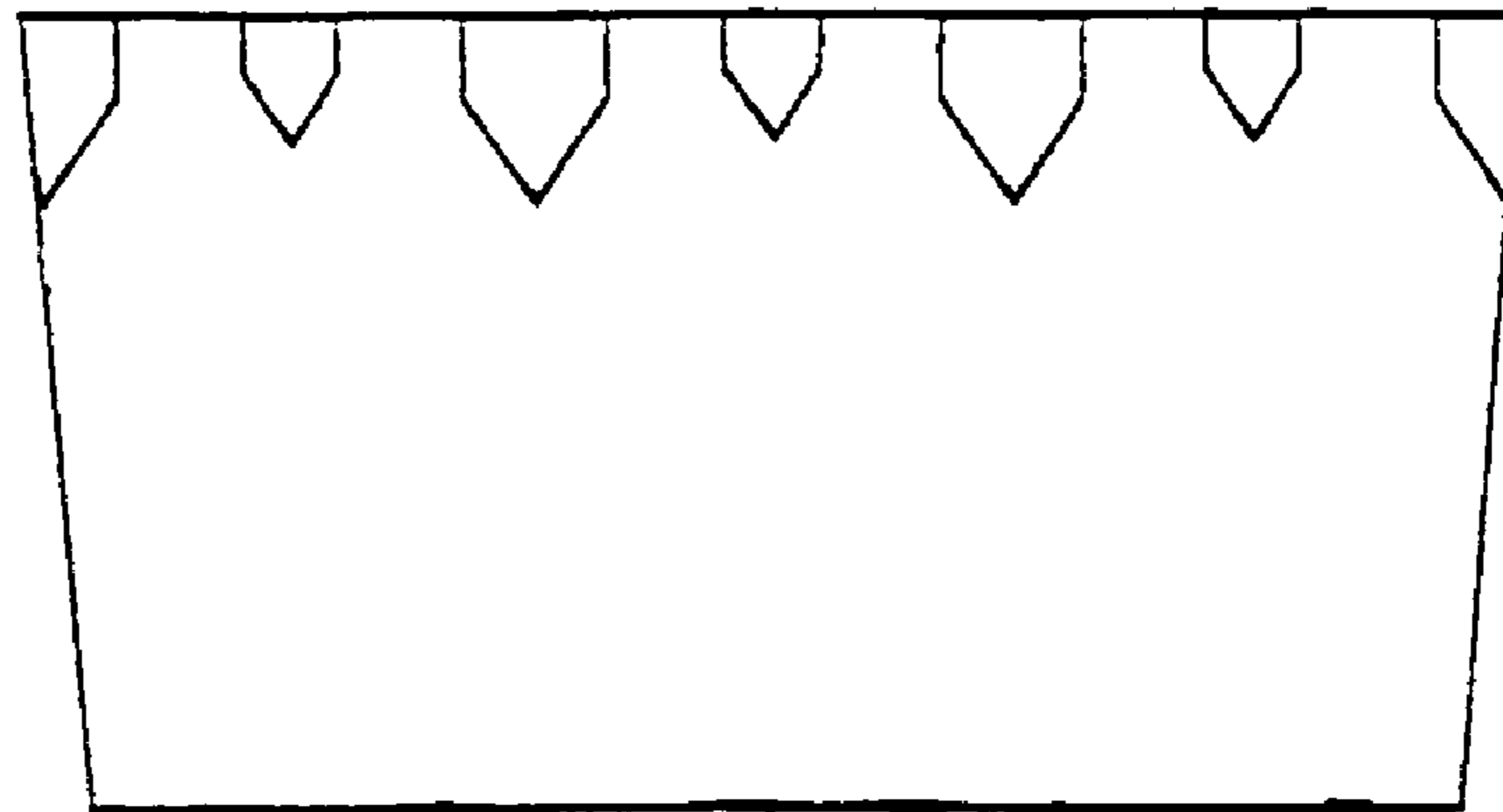

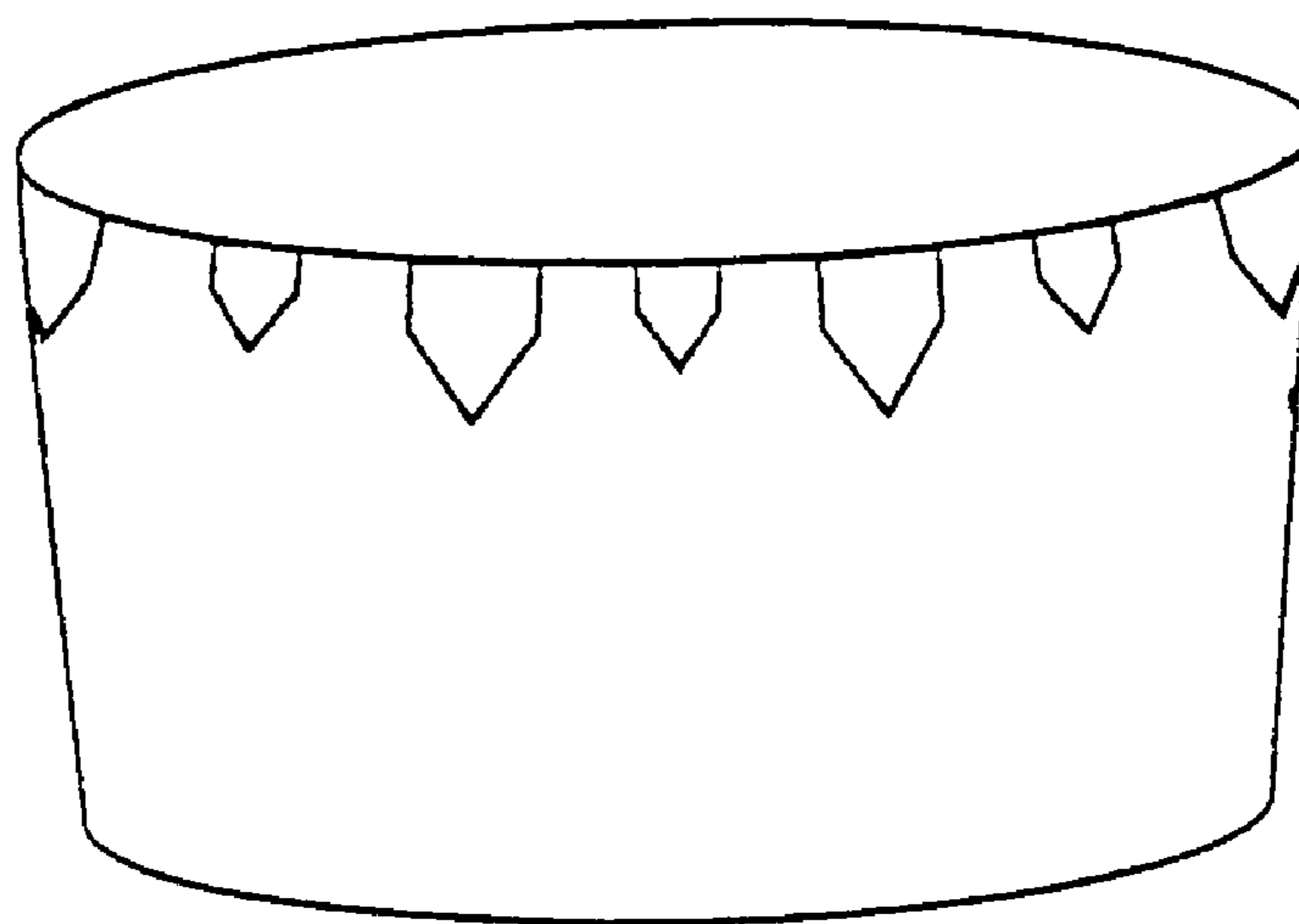

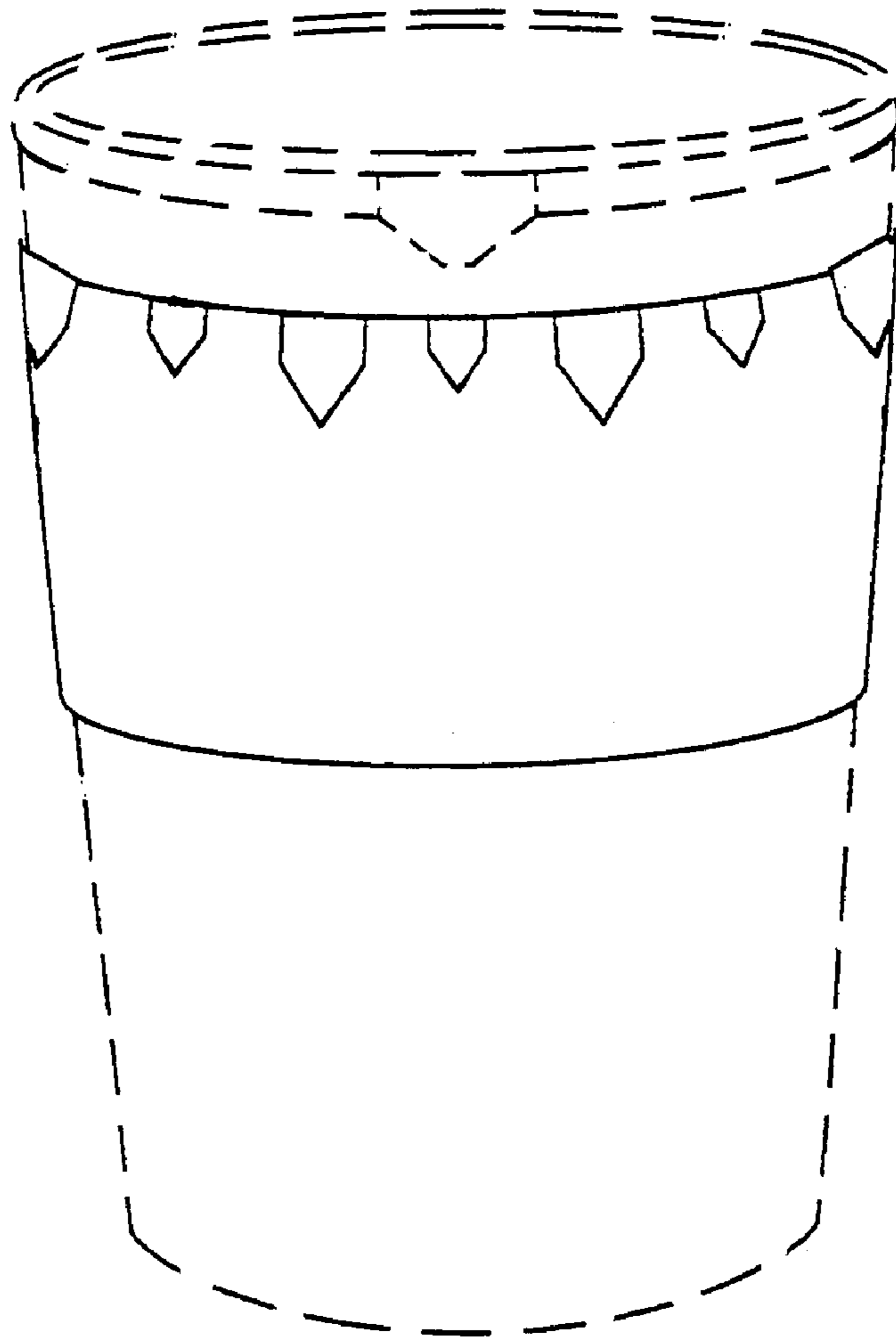
